(57) **CLAIM**

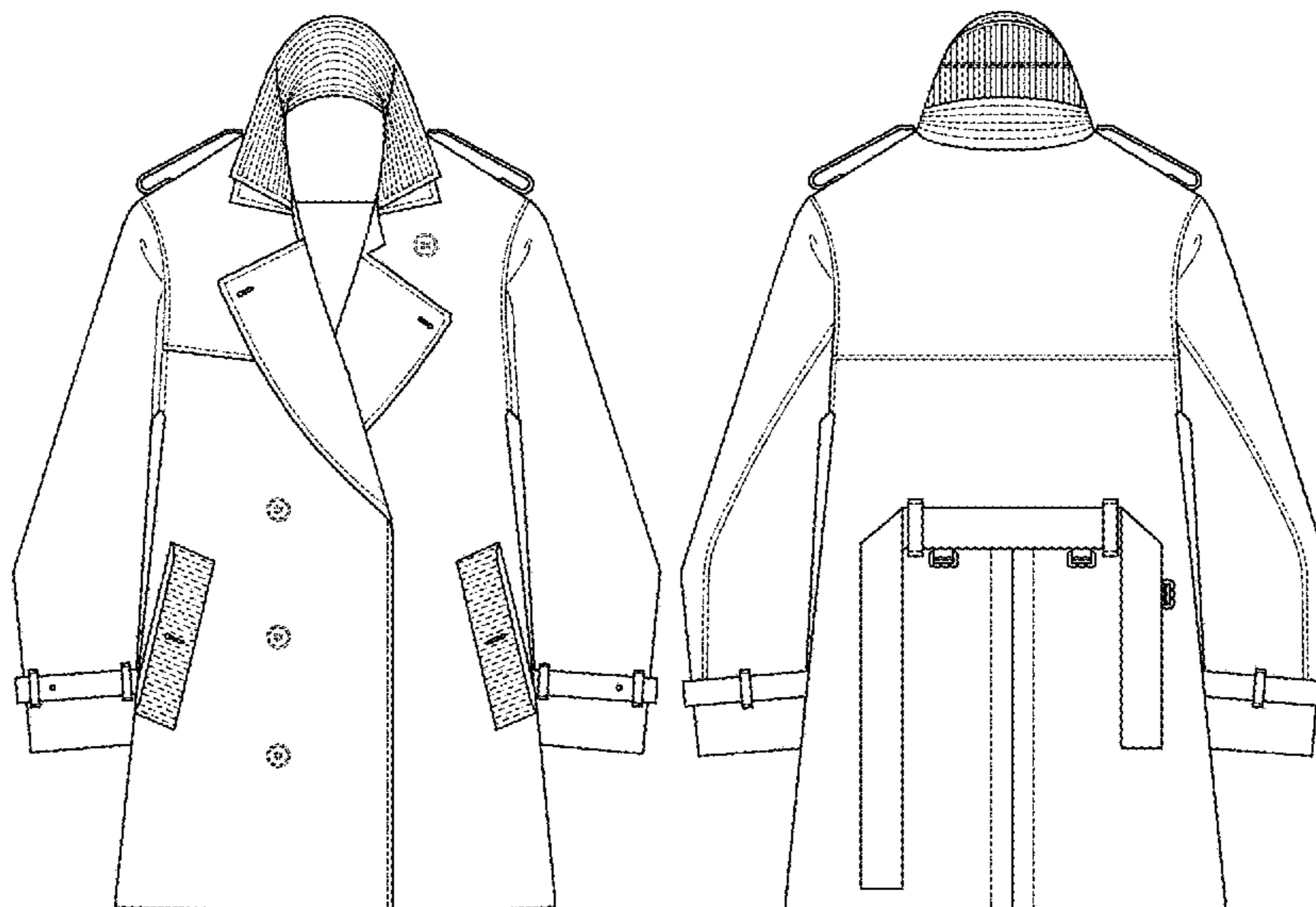
The ornamental design for a coat, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a coat, and further depicting a collar in an upward position;
 FIG. 2 is a front elevational view of the coat shown in FIG. 1;
 FIG. 3 is a left side elevational view of the coat shown in FIG. 1;
 FIG. 4 is a rear elevational view of the coat shown in FIG. 1;
 FIG. 5 is a right side elevational view of the coat shown in FIG. 1;

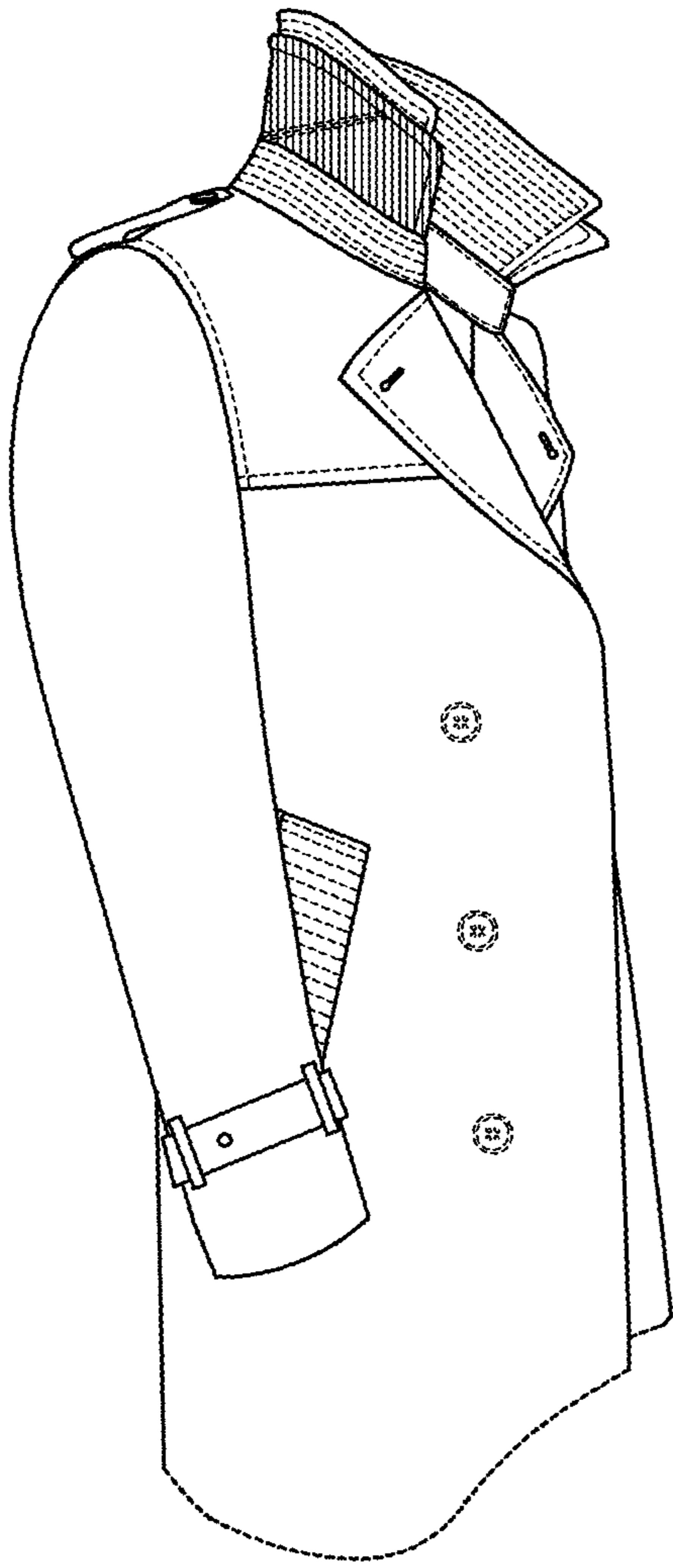

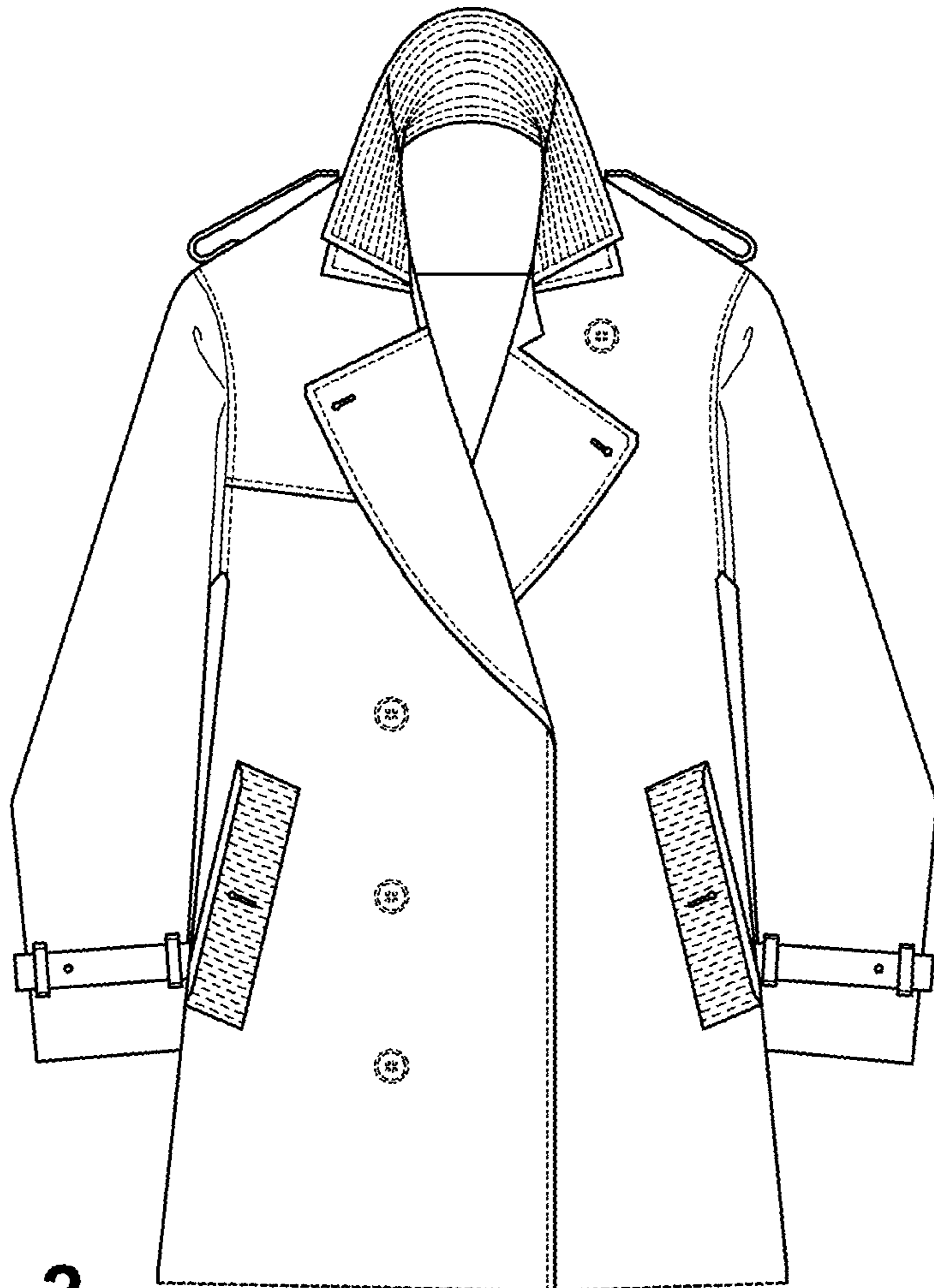

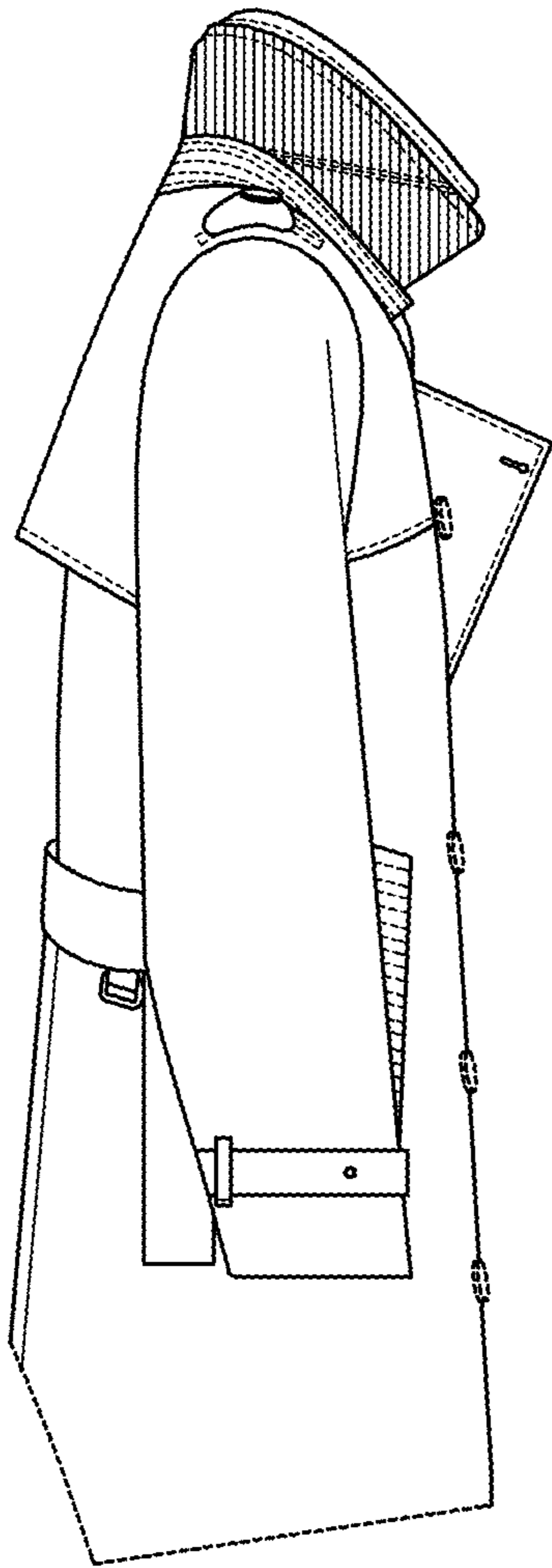

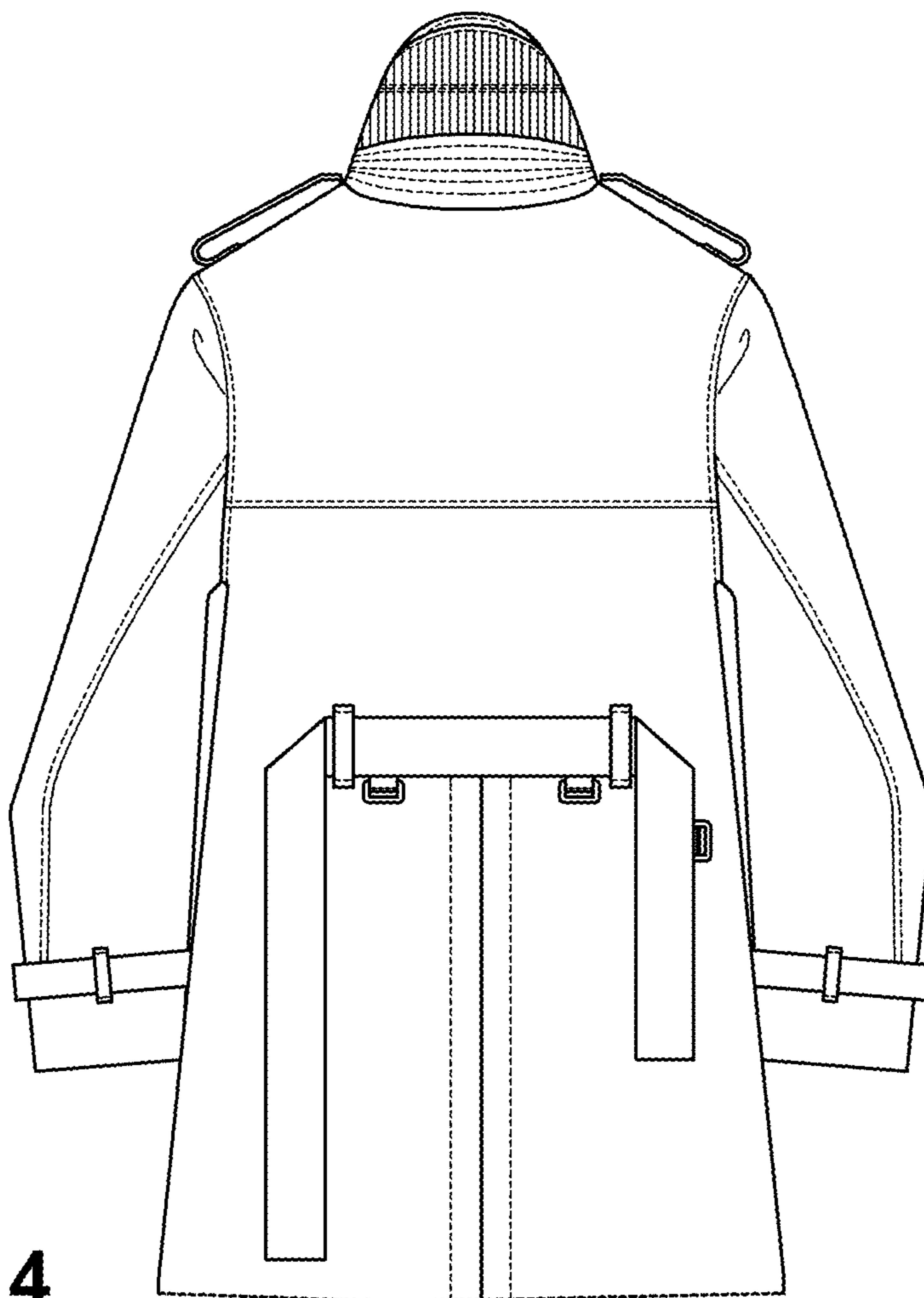

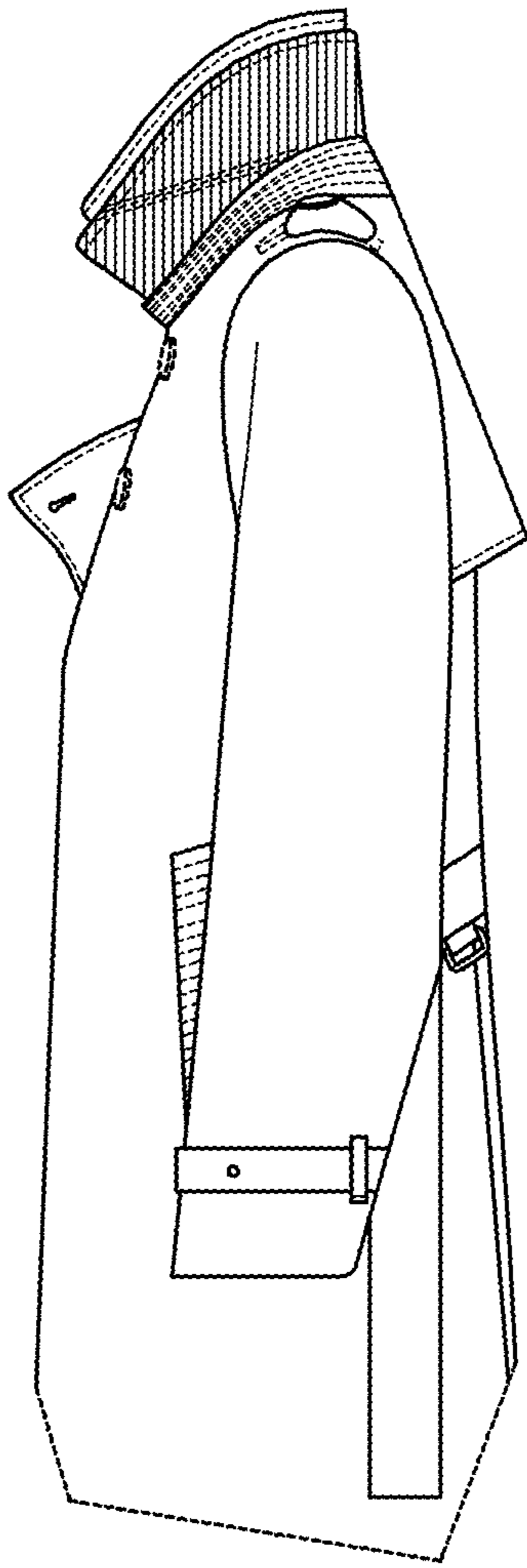

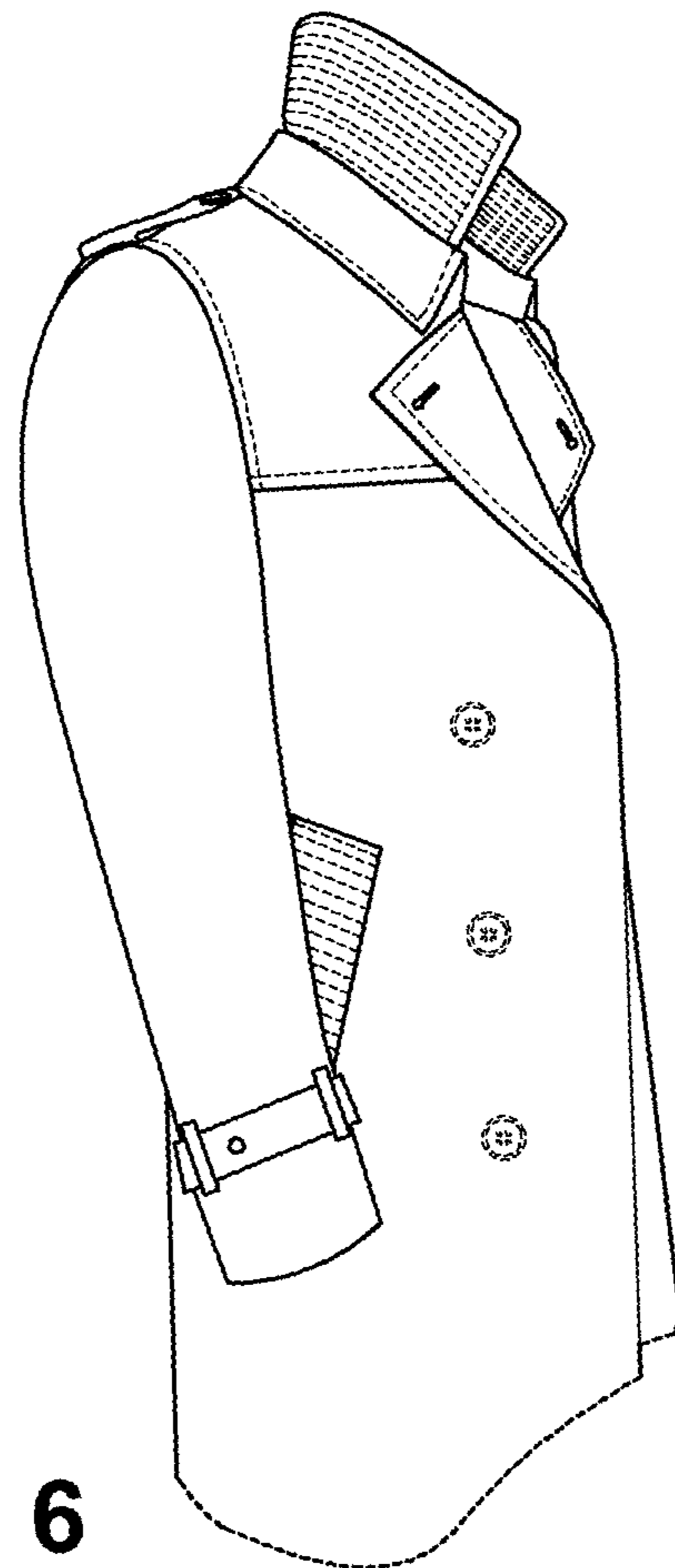

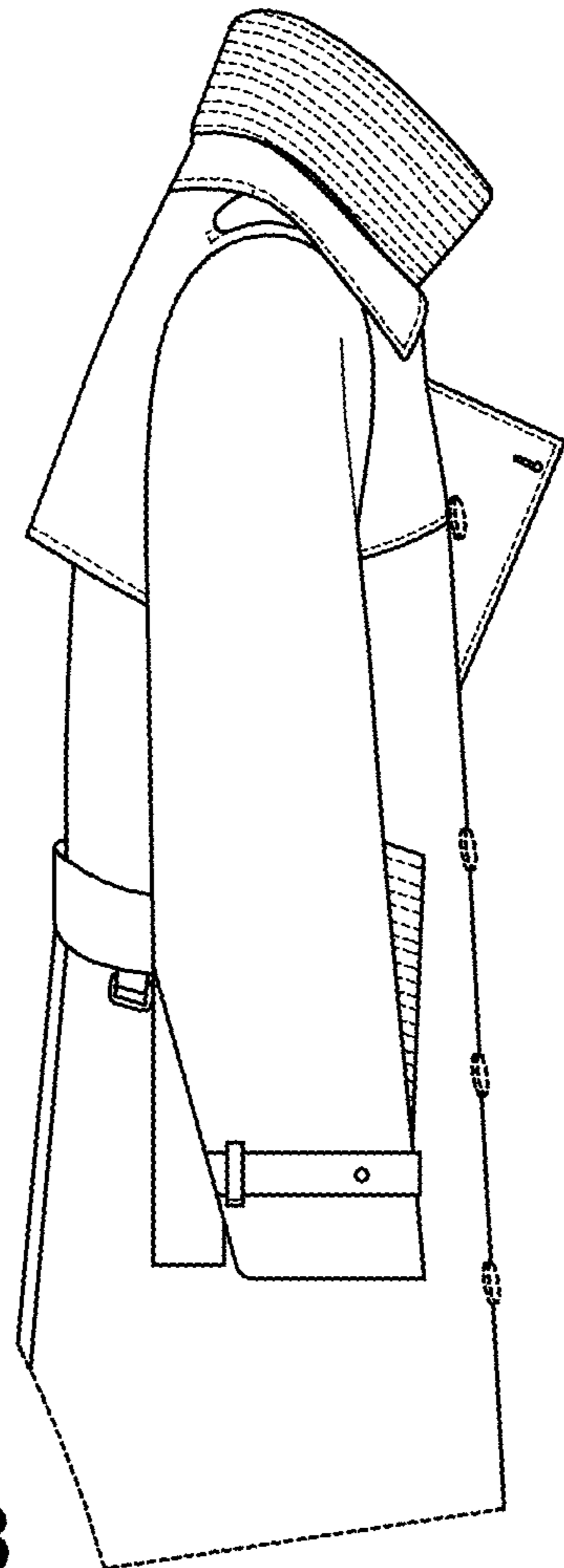

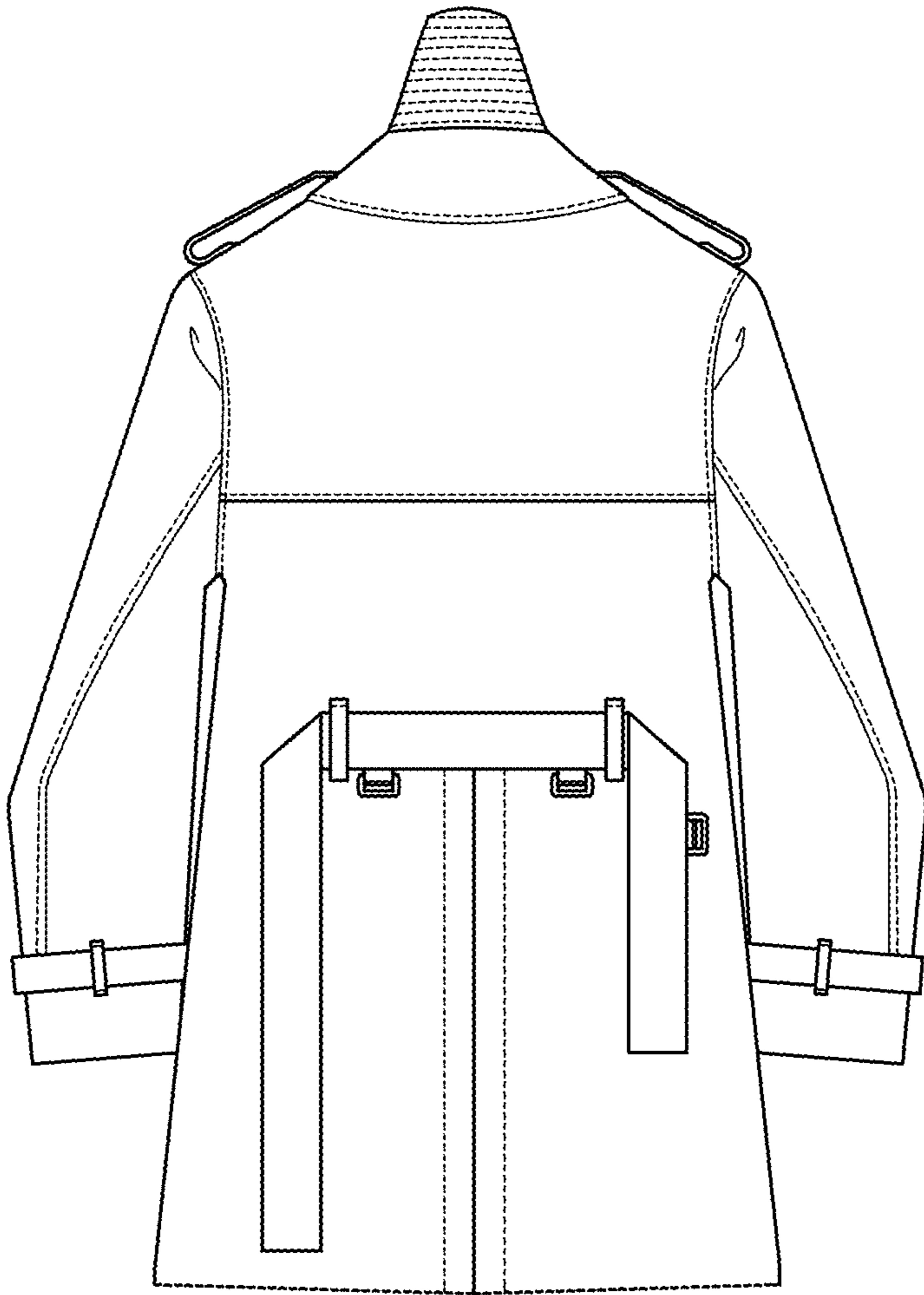

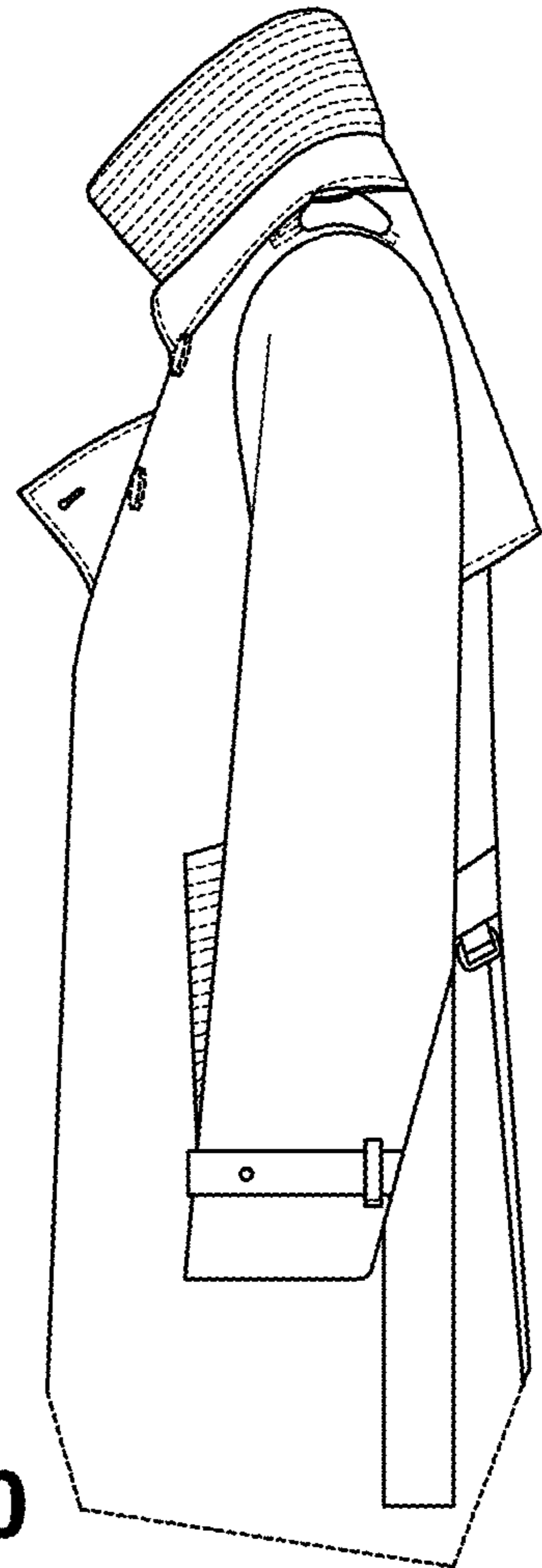
