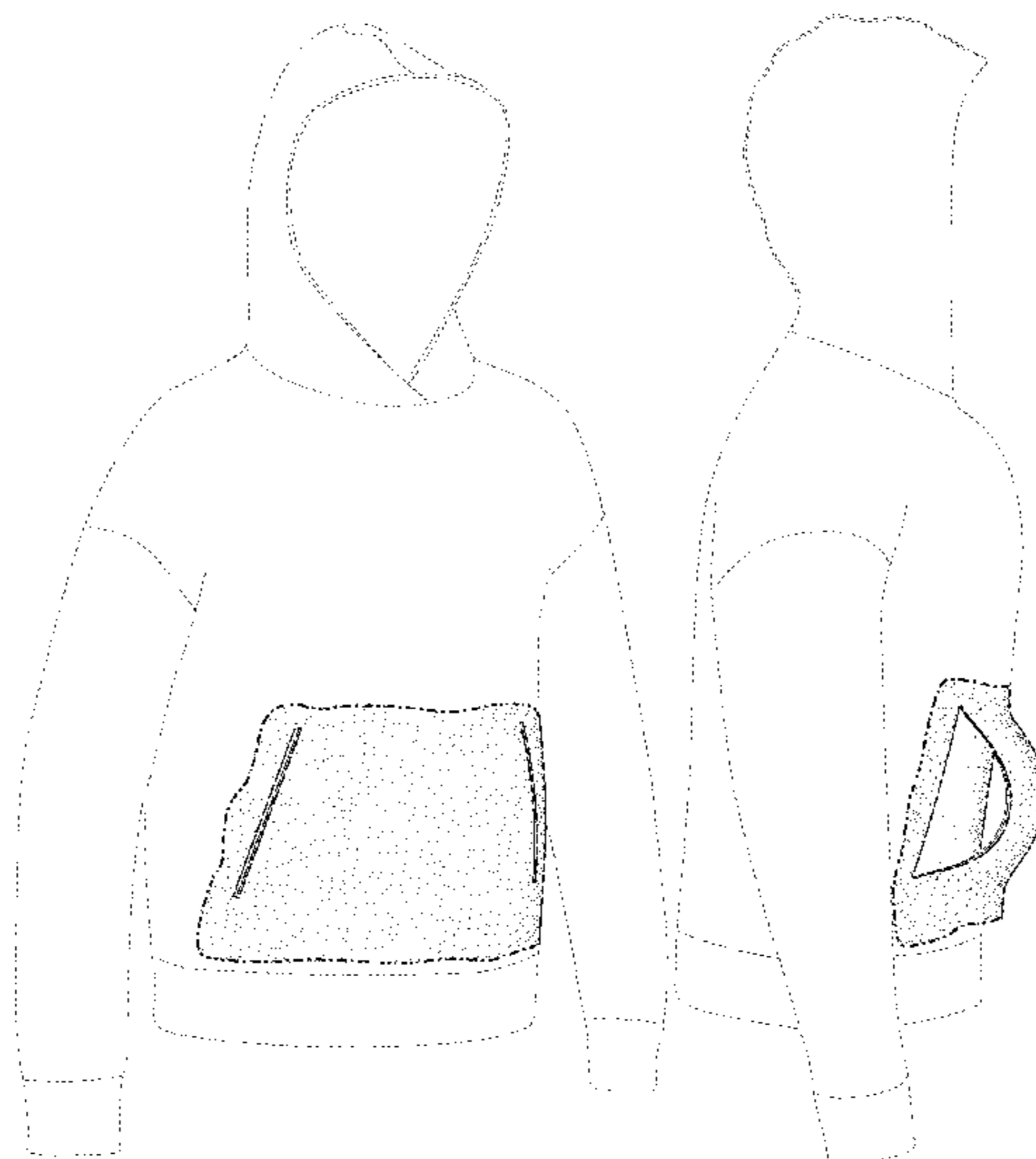
(57) **CLAIM**

We claim the ornamental design for a hoodie, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a hoodie, showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a front perspective view thereof, shown with the pocket partially flared open;  
FIG. 6 is a left side view thereof, shown with the pocket partially flared open;  
FIG. 7 is a right side view thereof, shown with the pocket partially flared open; and,  
FIG. 8 is a left side view thereof, shown with the pocket flared open.  
The dot-dot-dash broken lines adjacent to the shaded area represent unclaimed boundaries of the claimed design. The remainder of the broken lines depict portions of the hoodie and form no part of the claimed design.

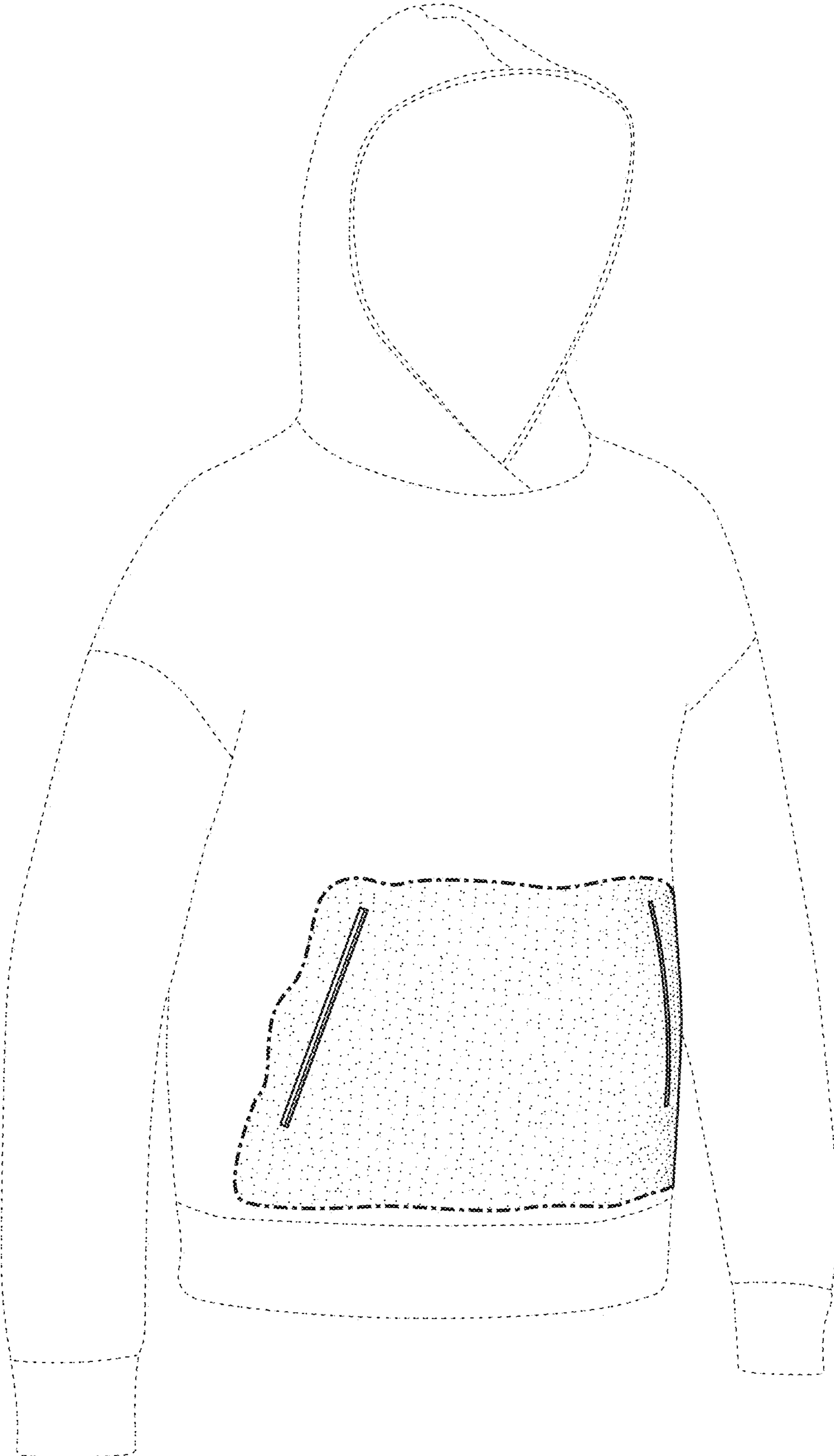

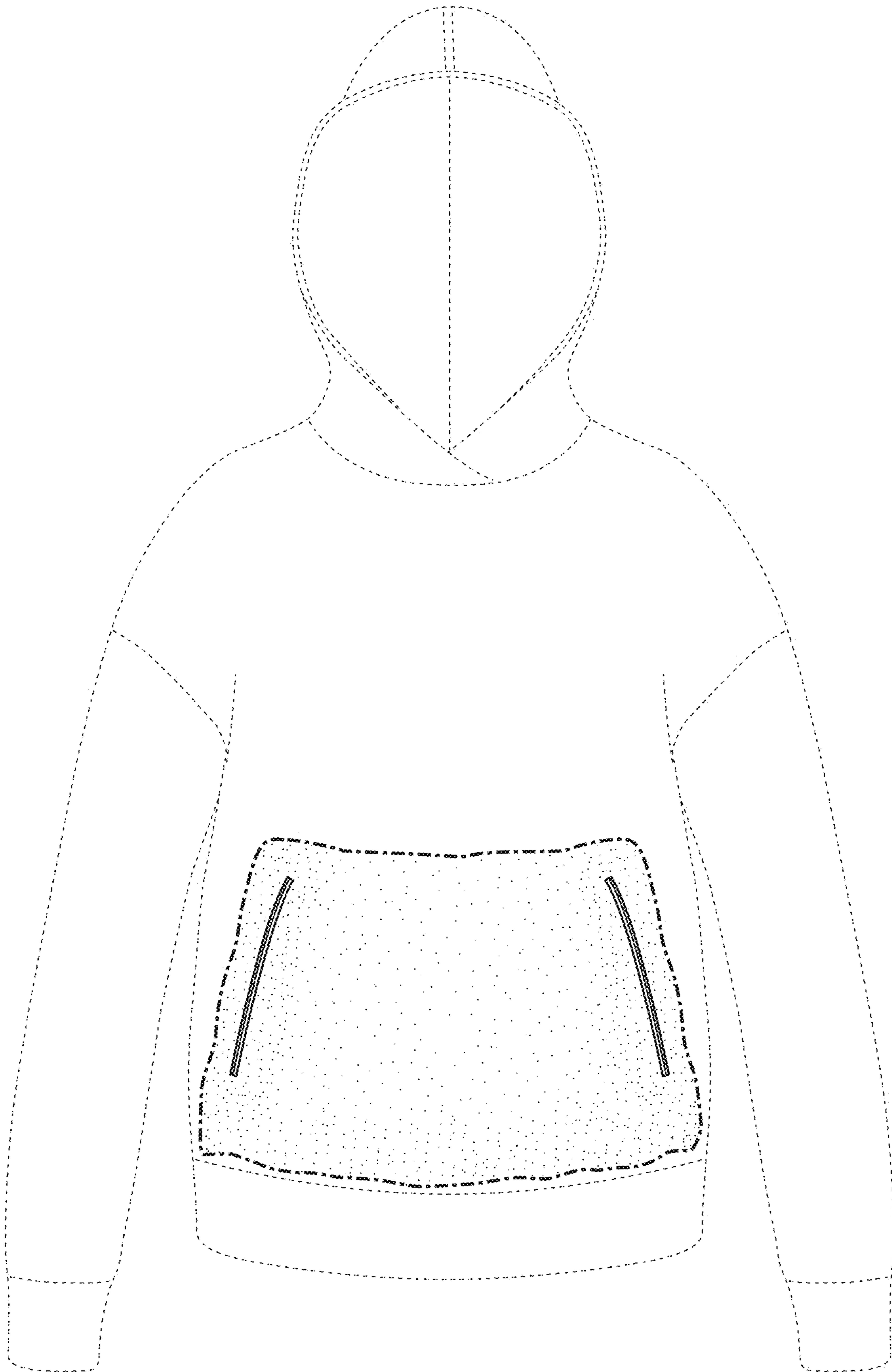

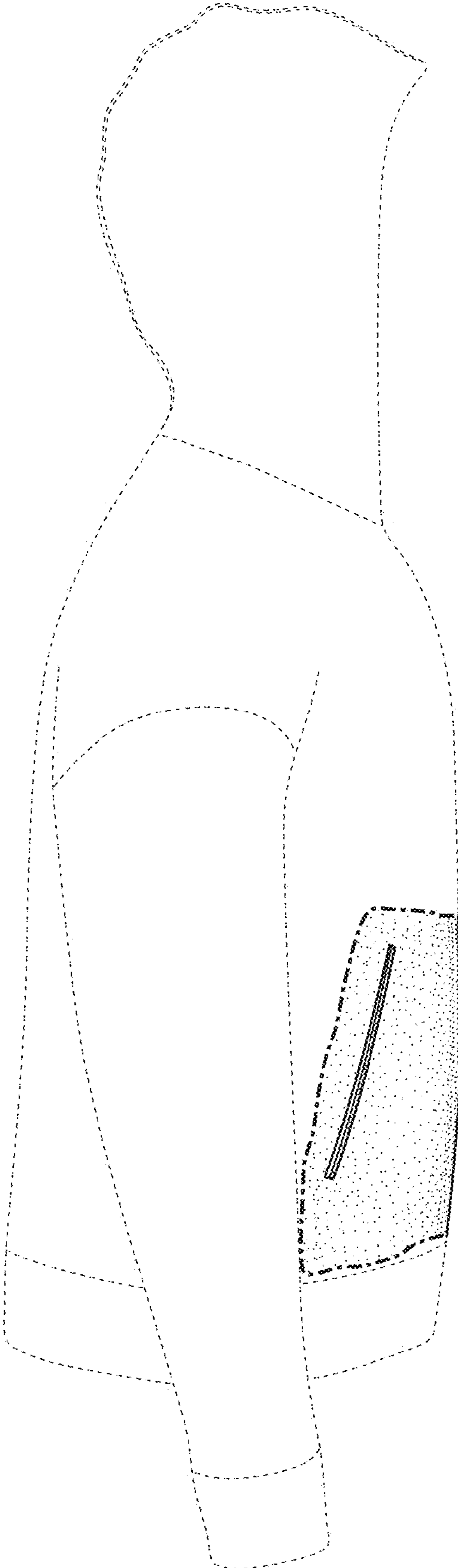

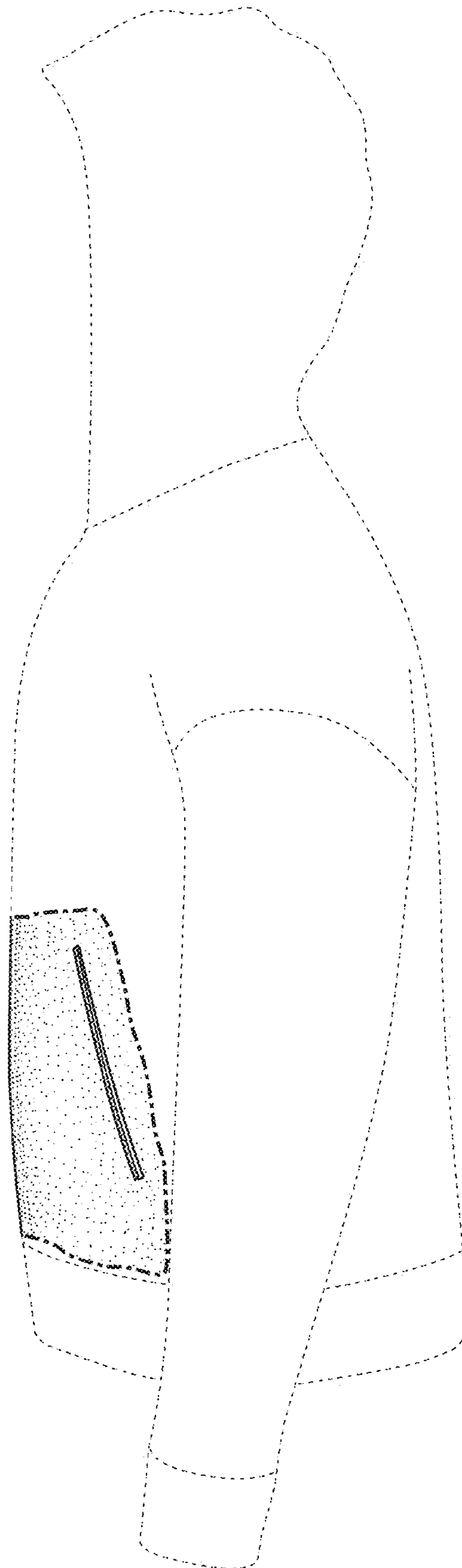

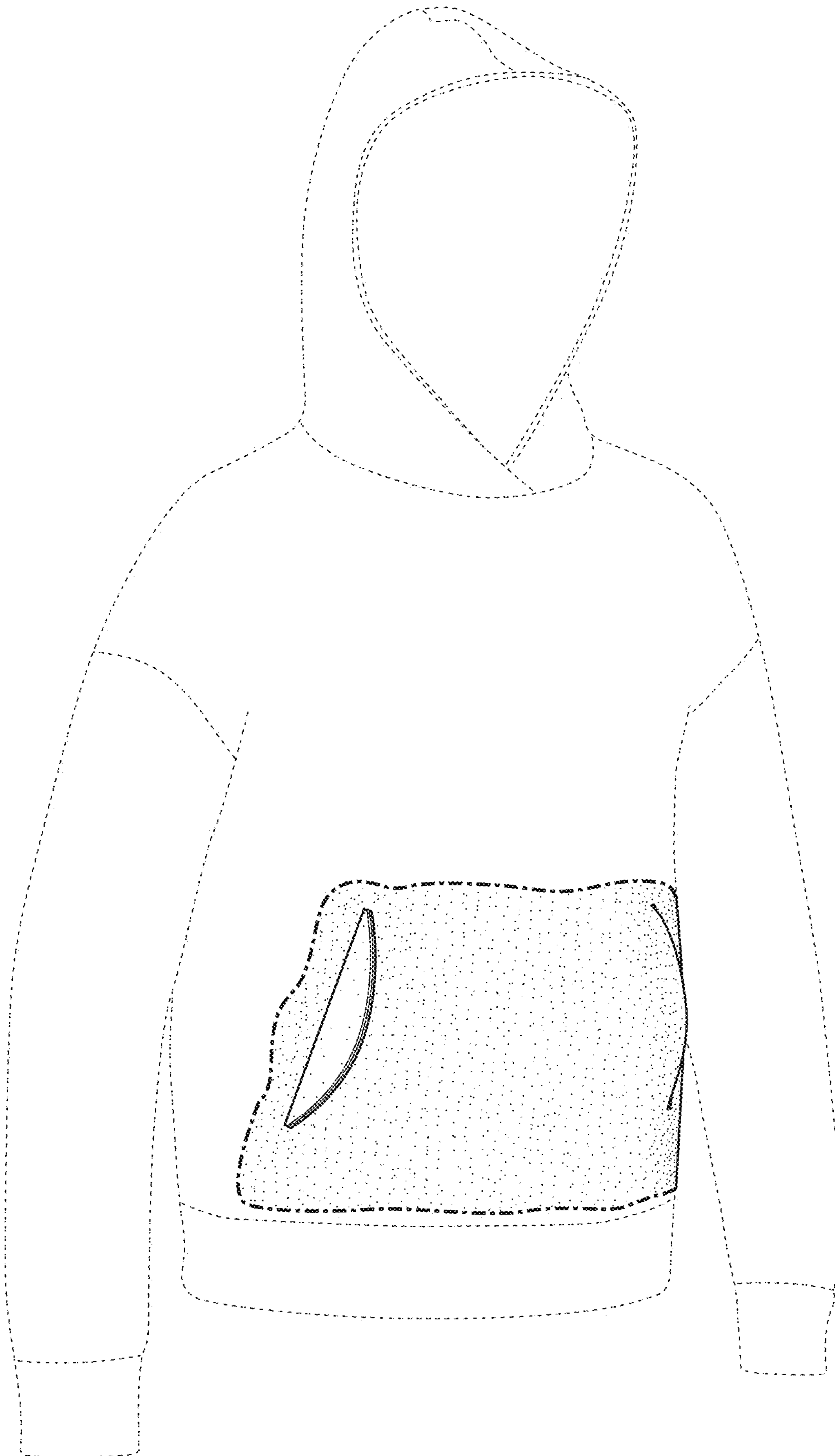

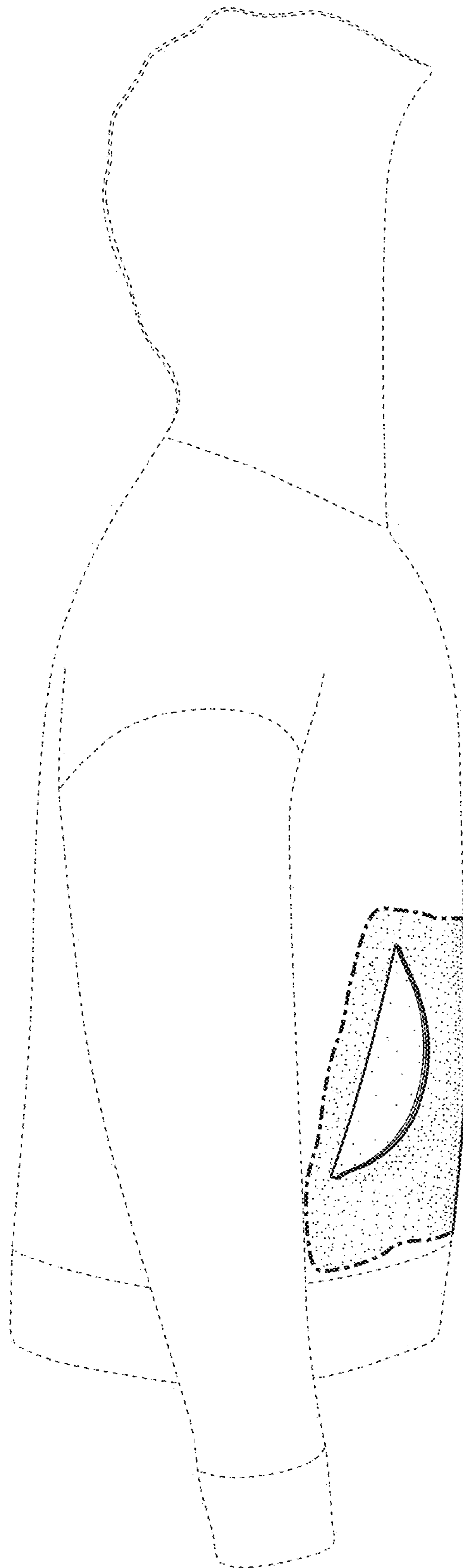

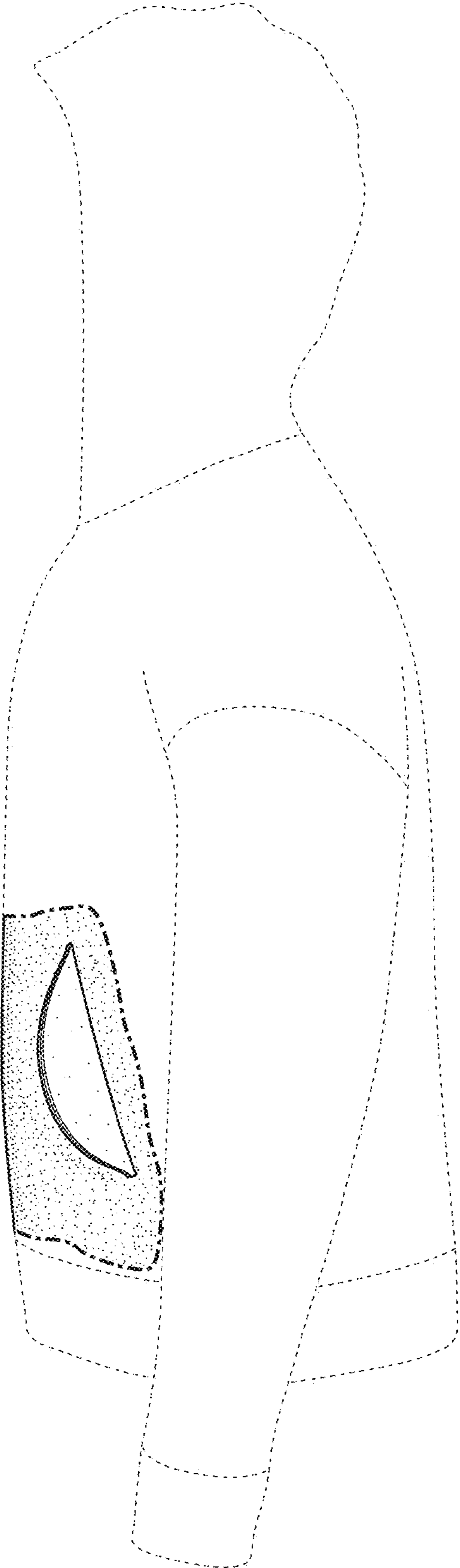

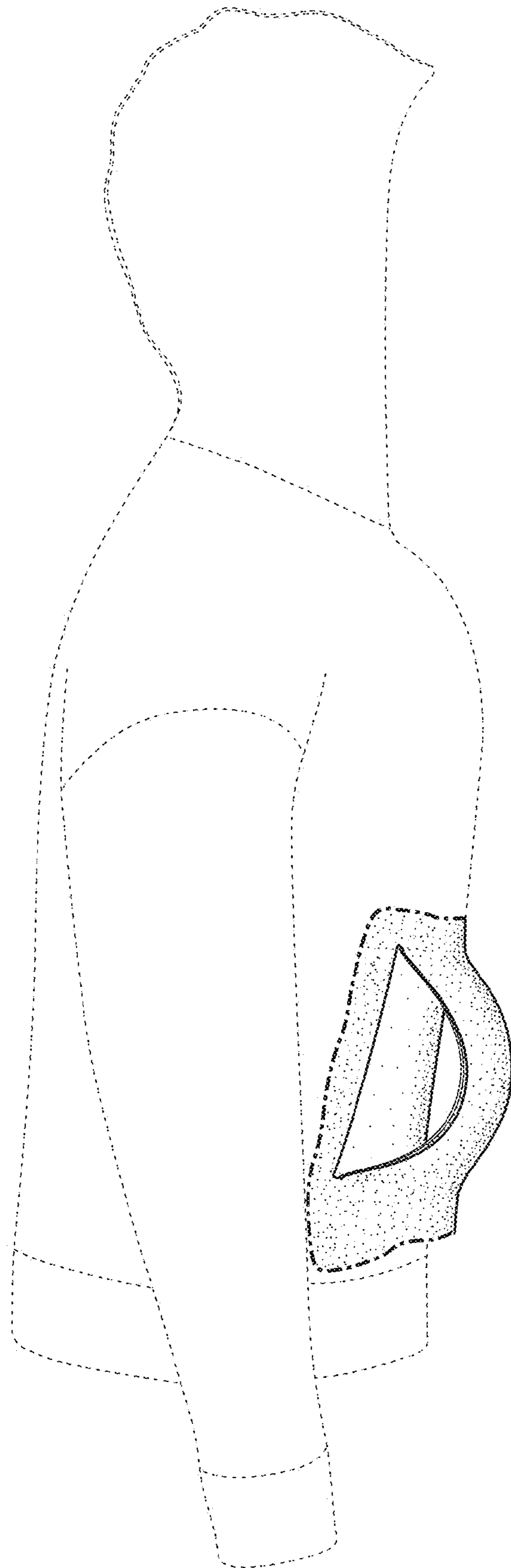
