FIG. 1 is a rear perspective view of a shoe, showing my new design;

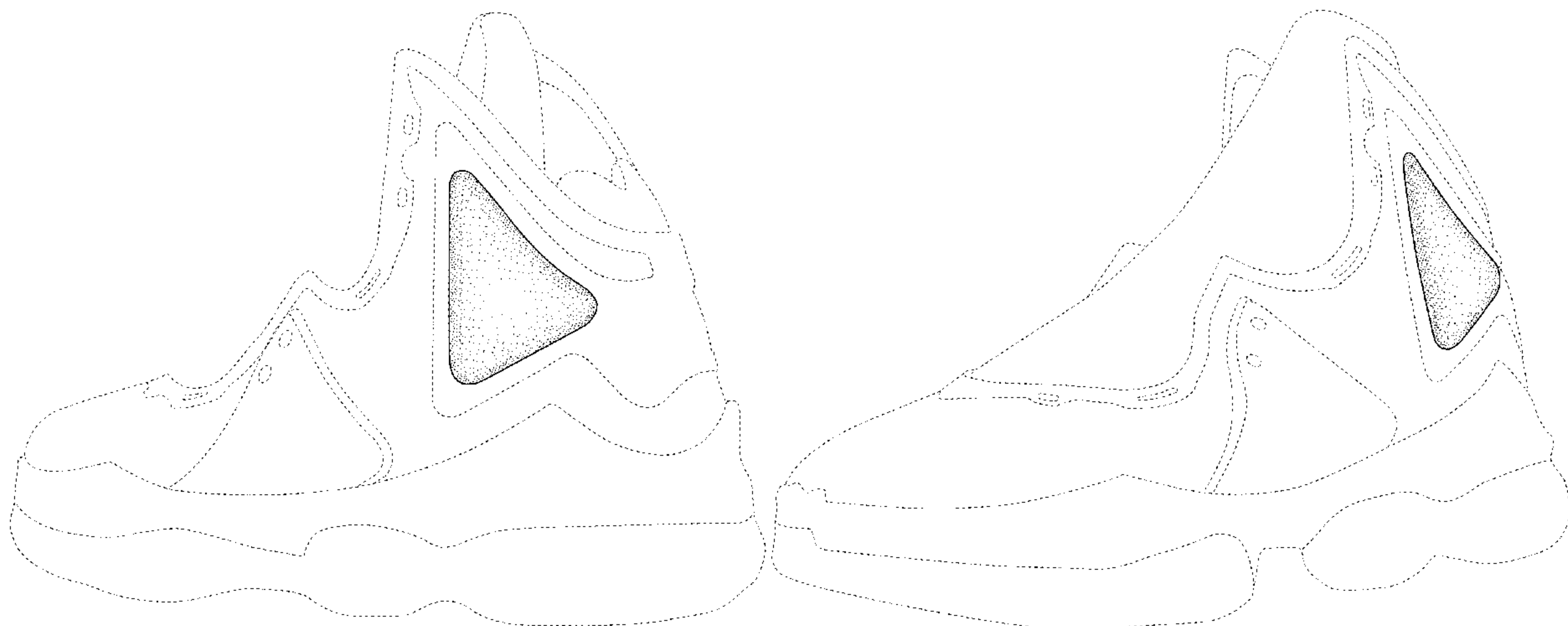
FIG. 2 is a right side view thereof;

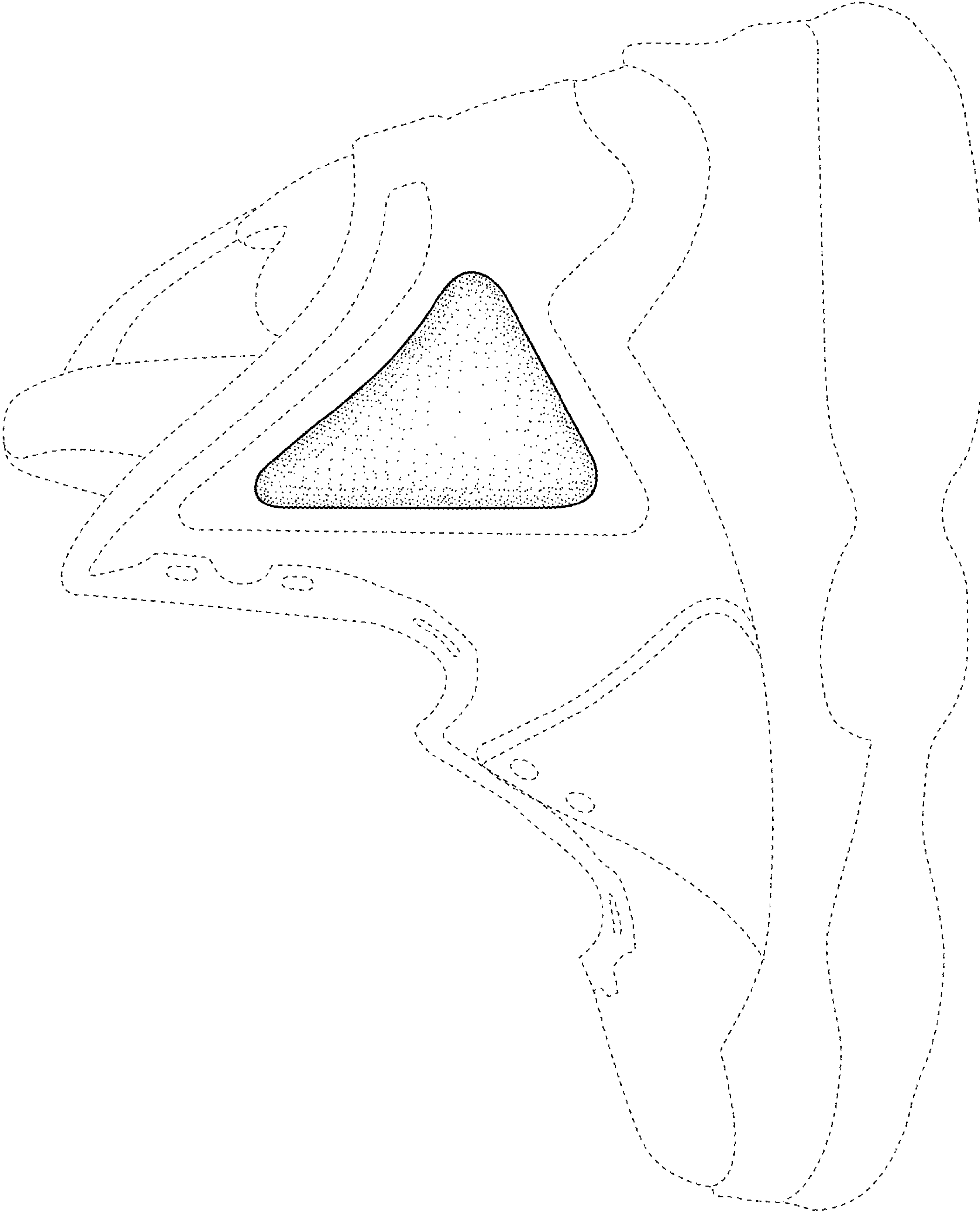

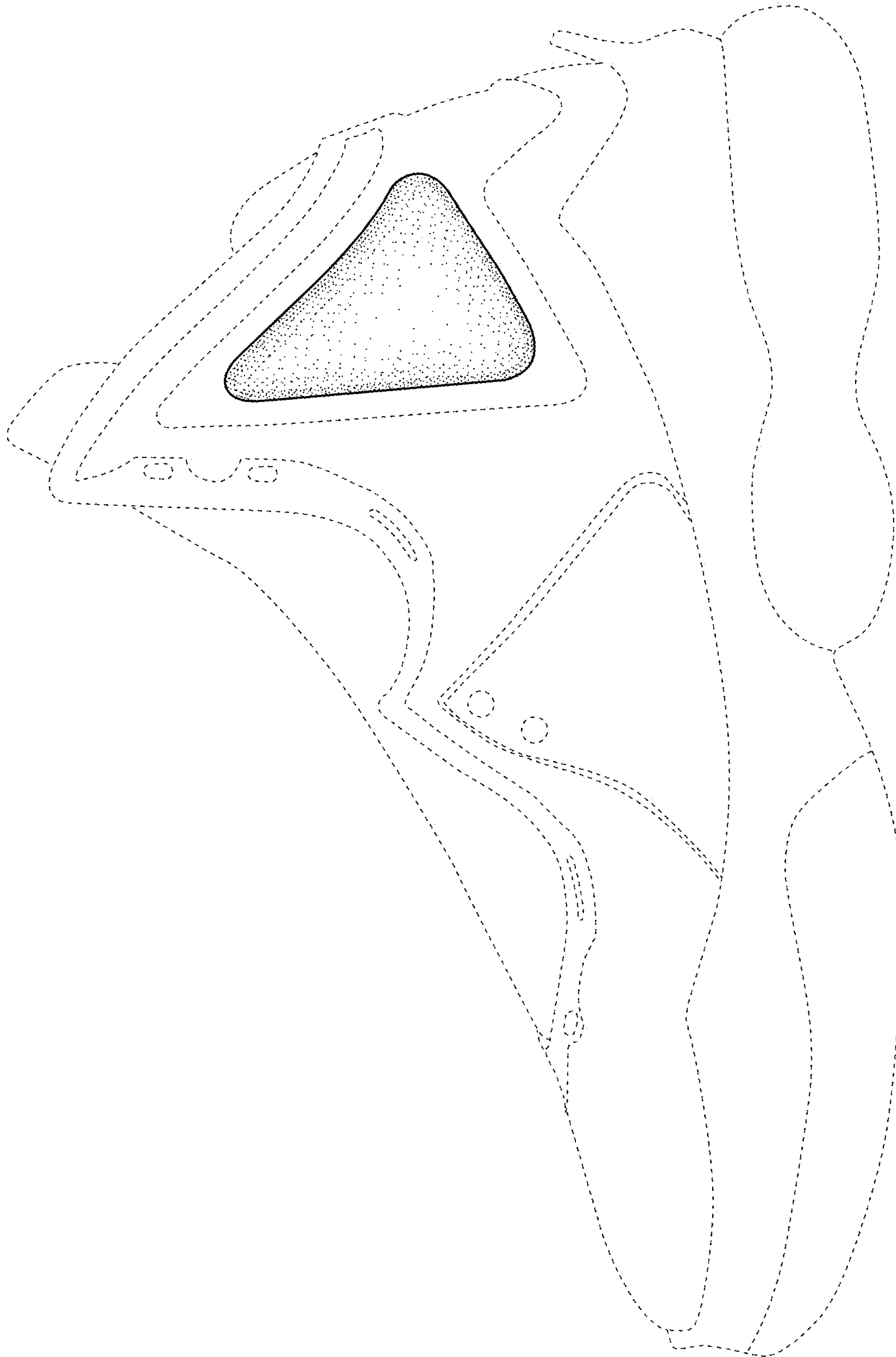

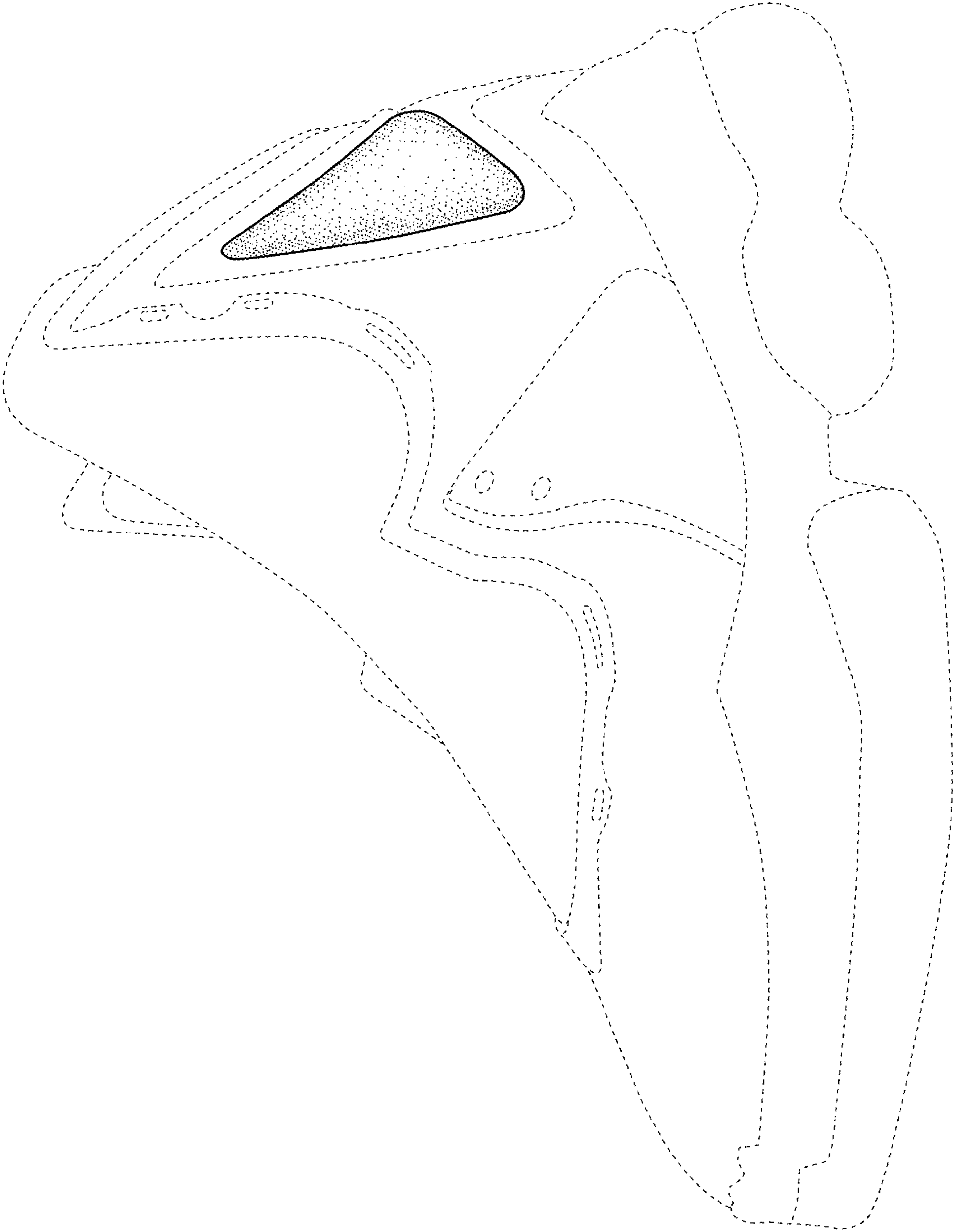

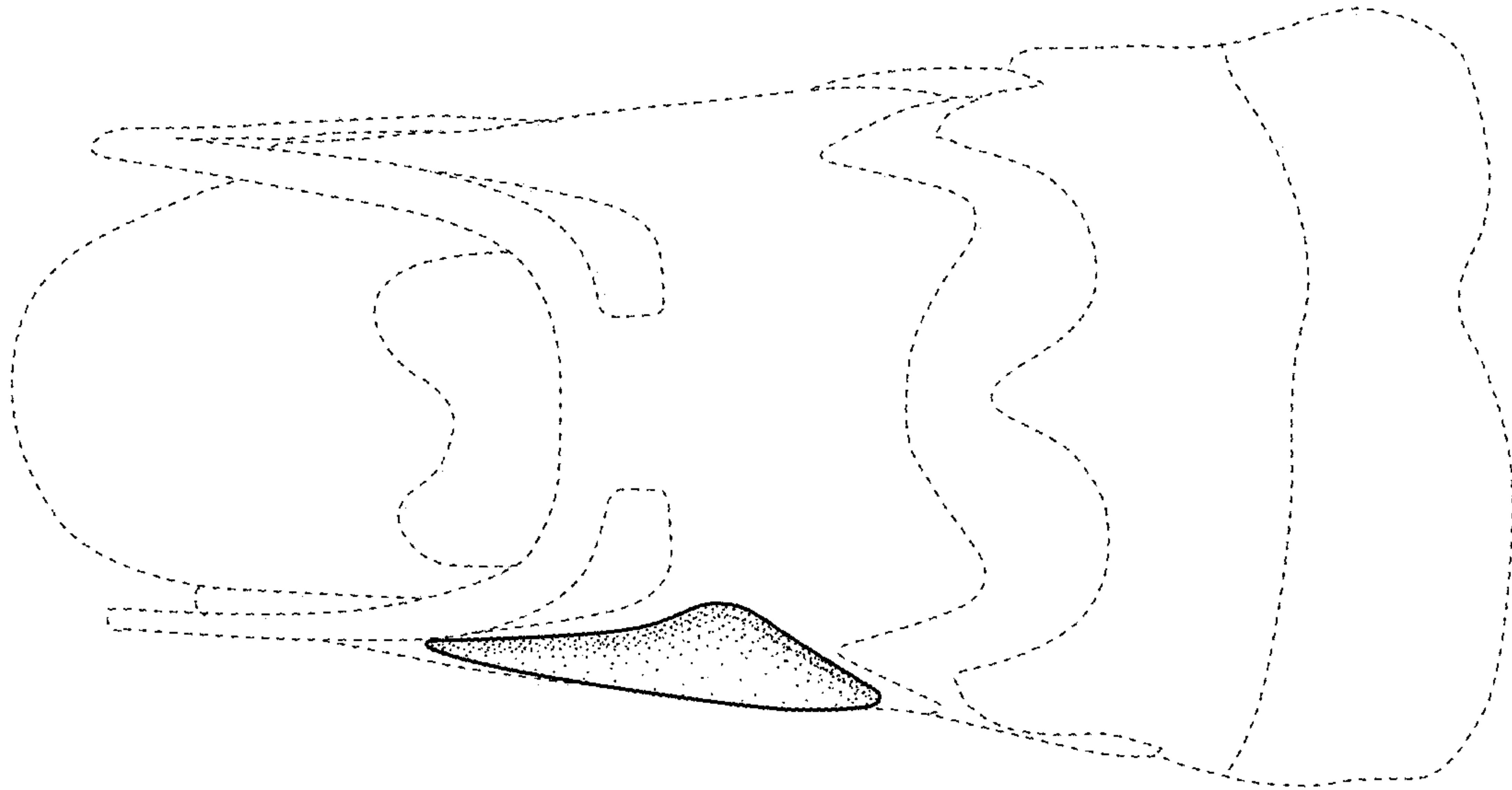
