The ornamental design for a bag, as shown and described.

**DESCRIPTION**

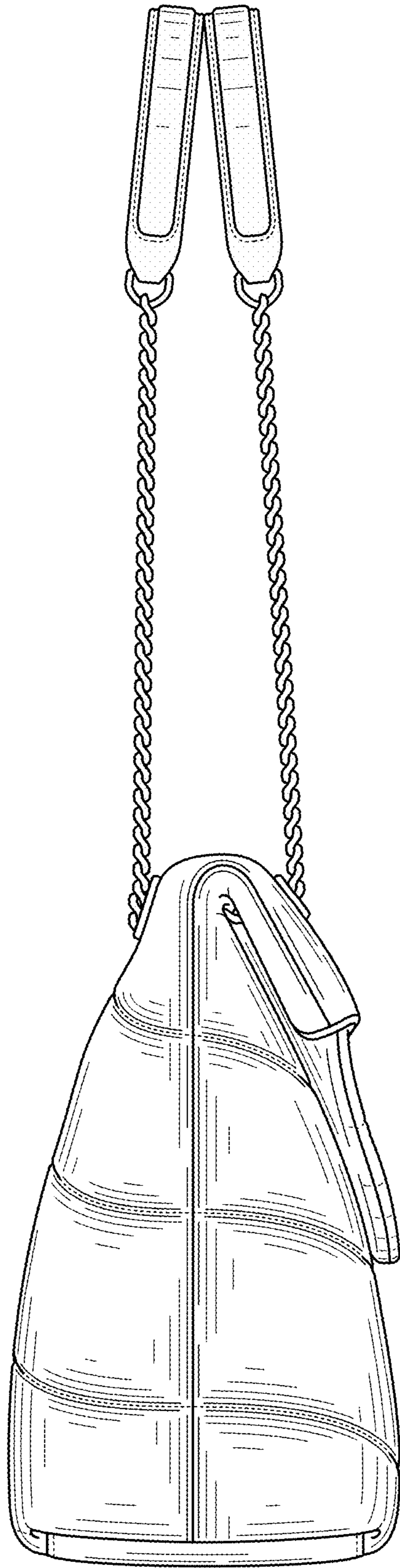

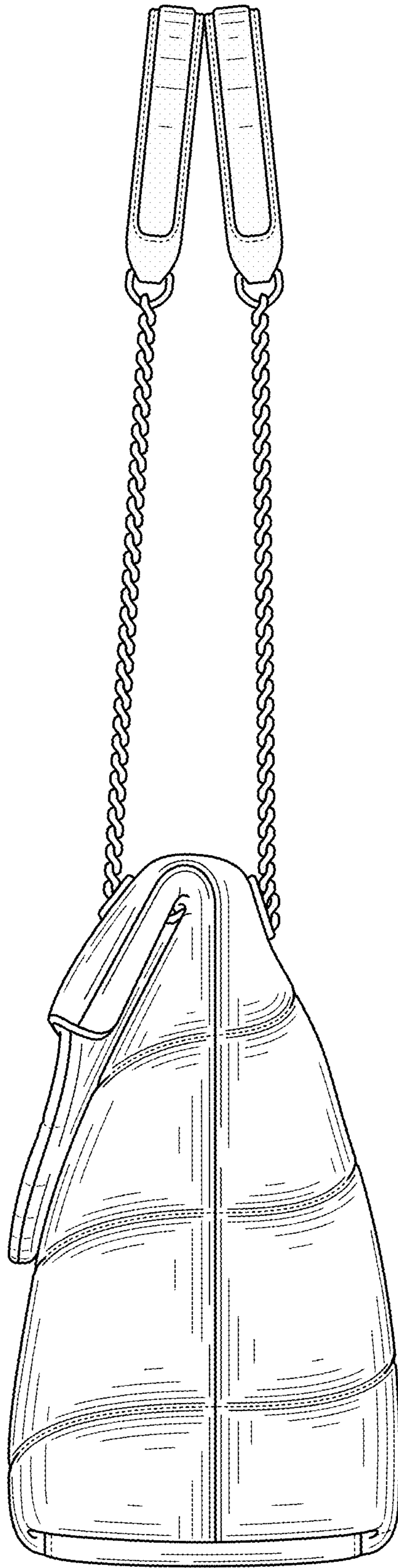

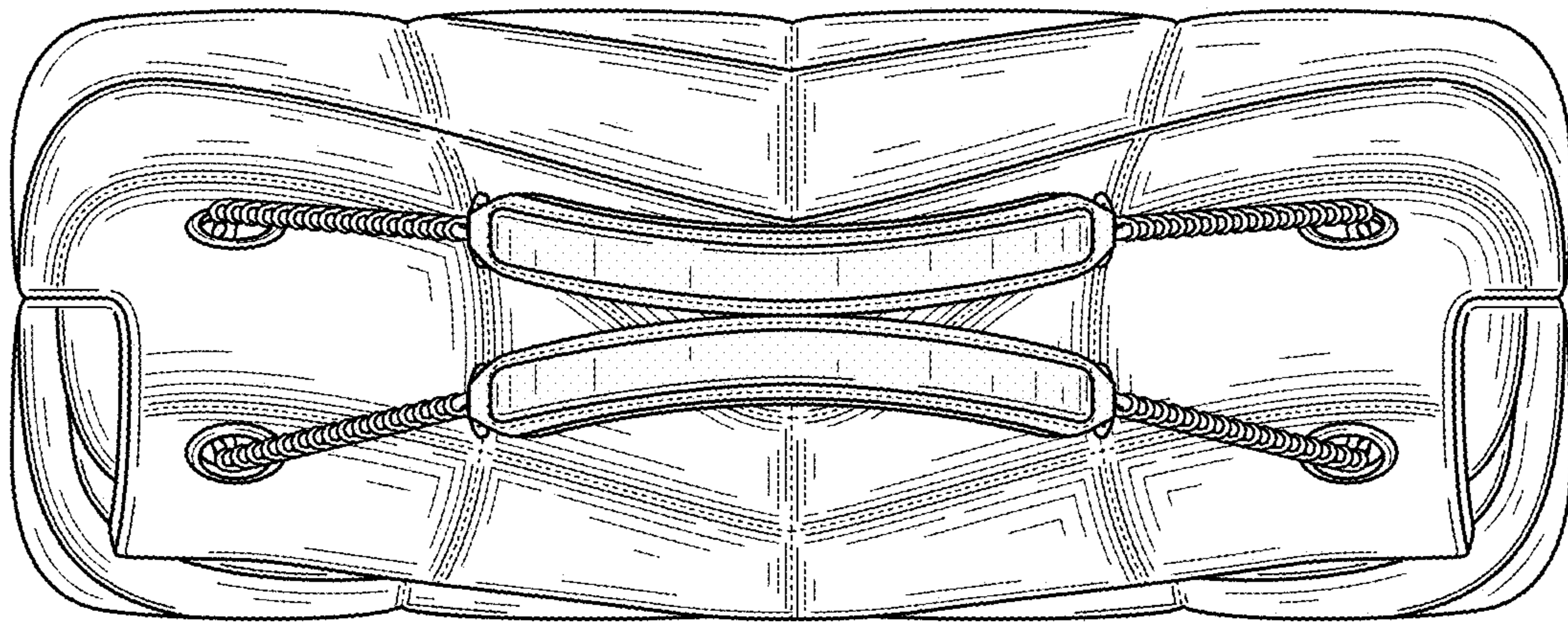

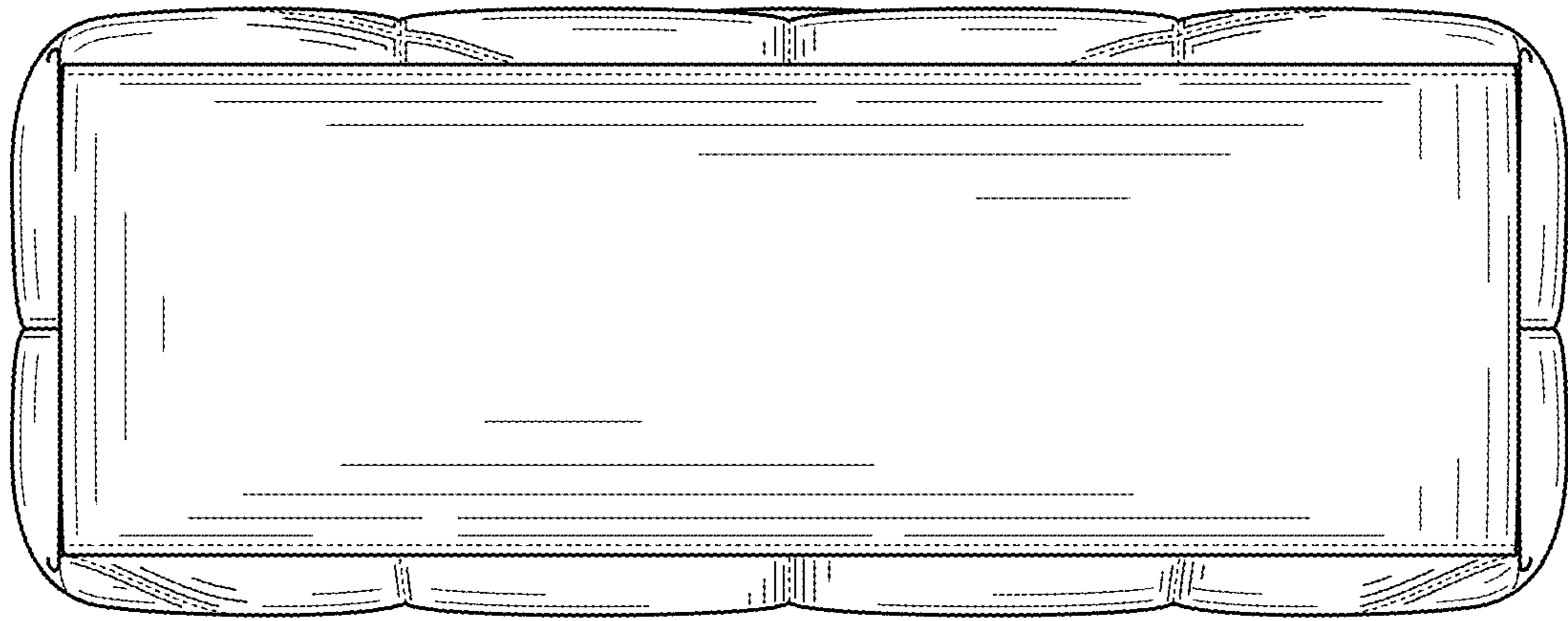

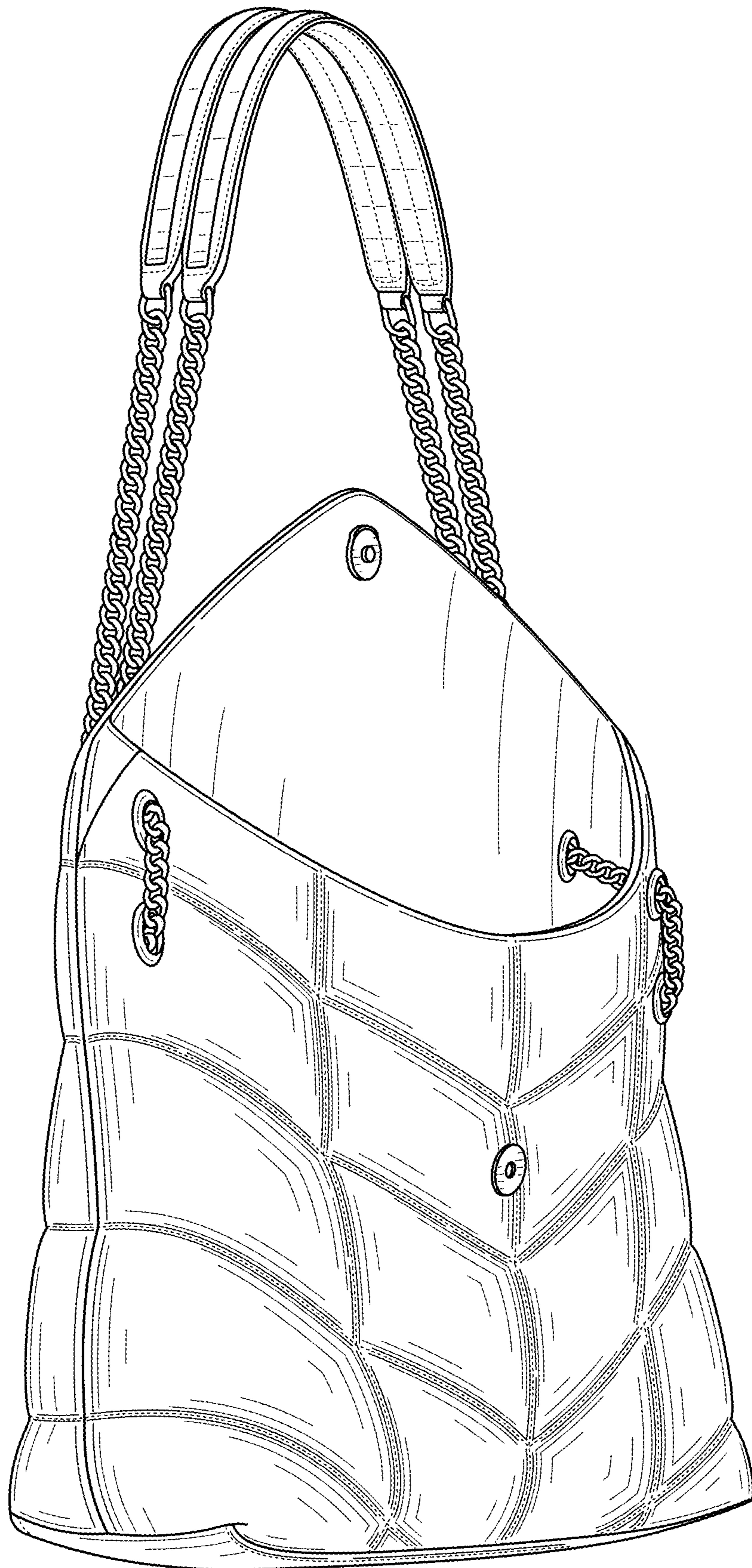

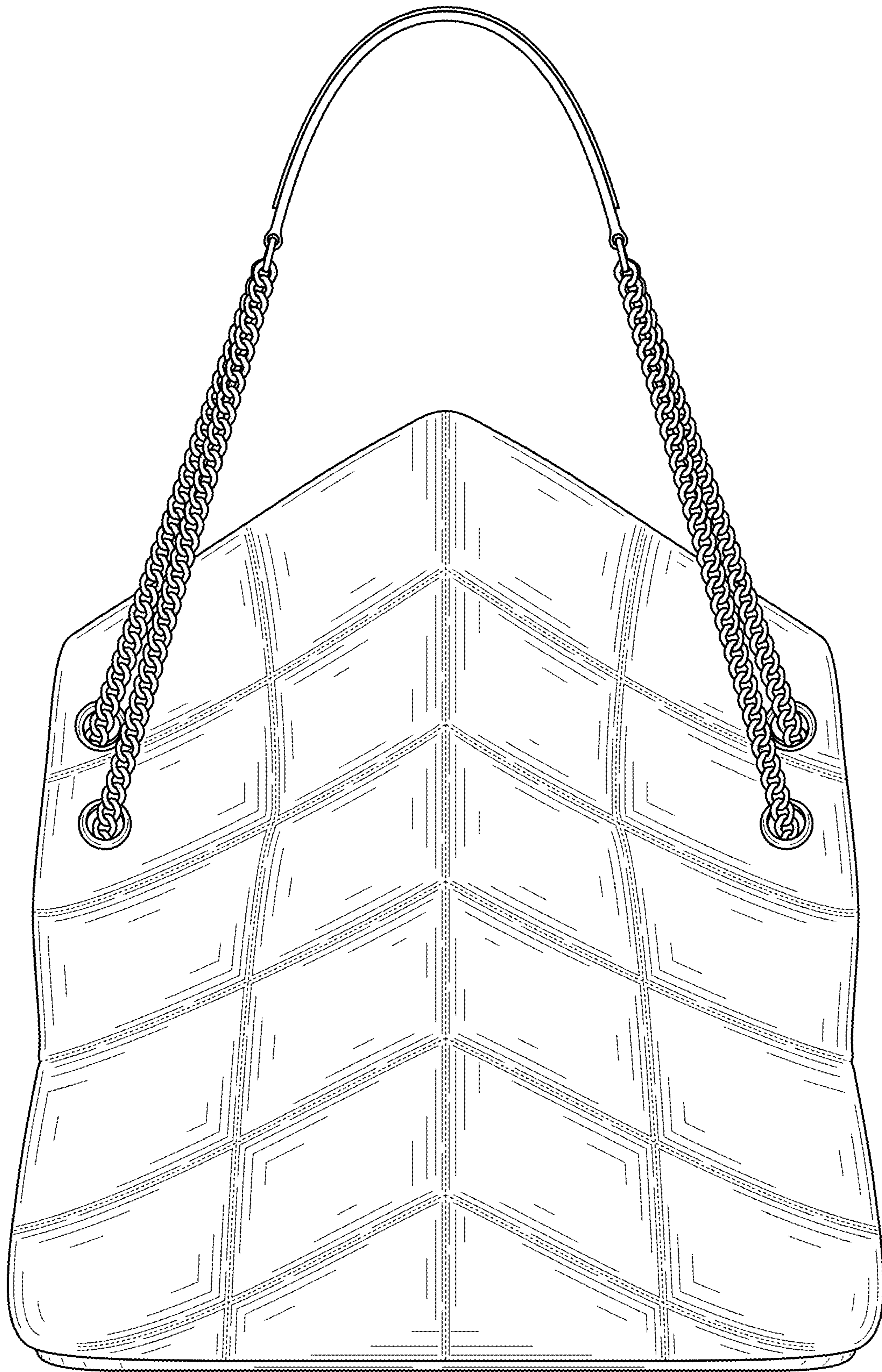

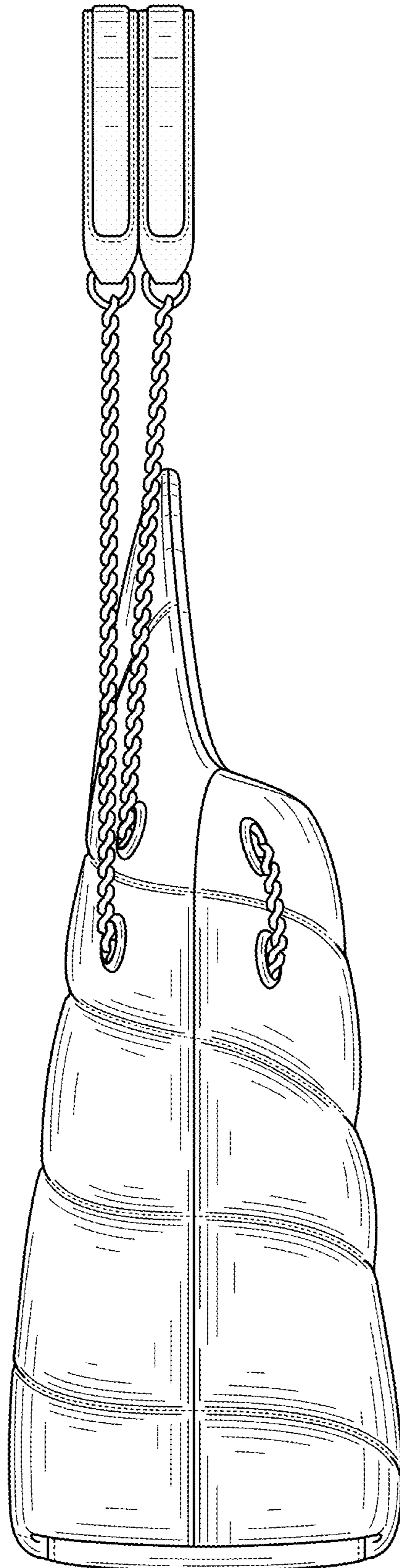

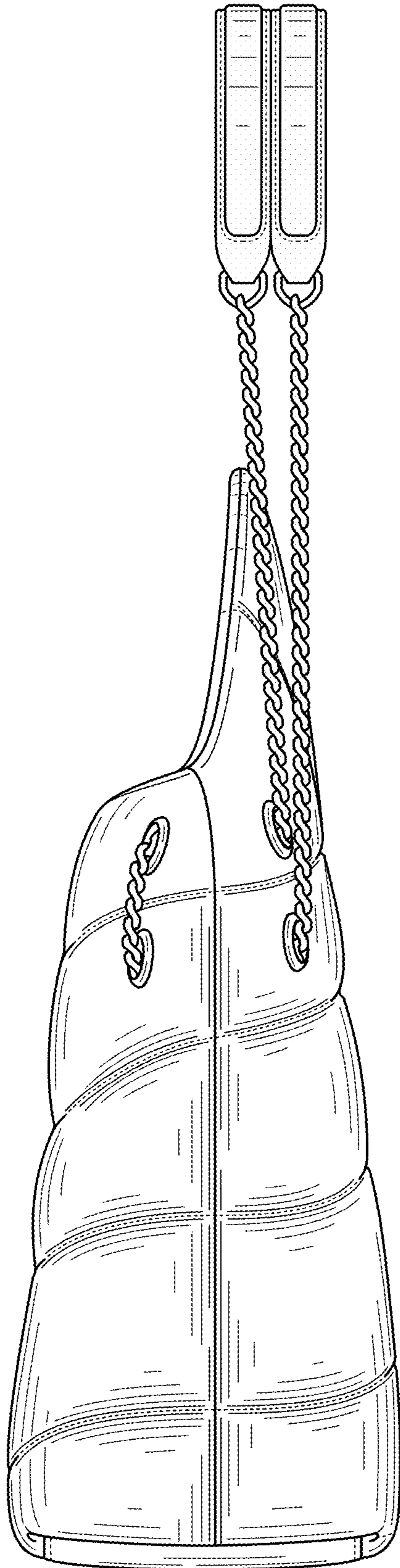

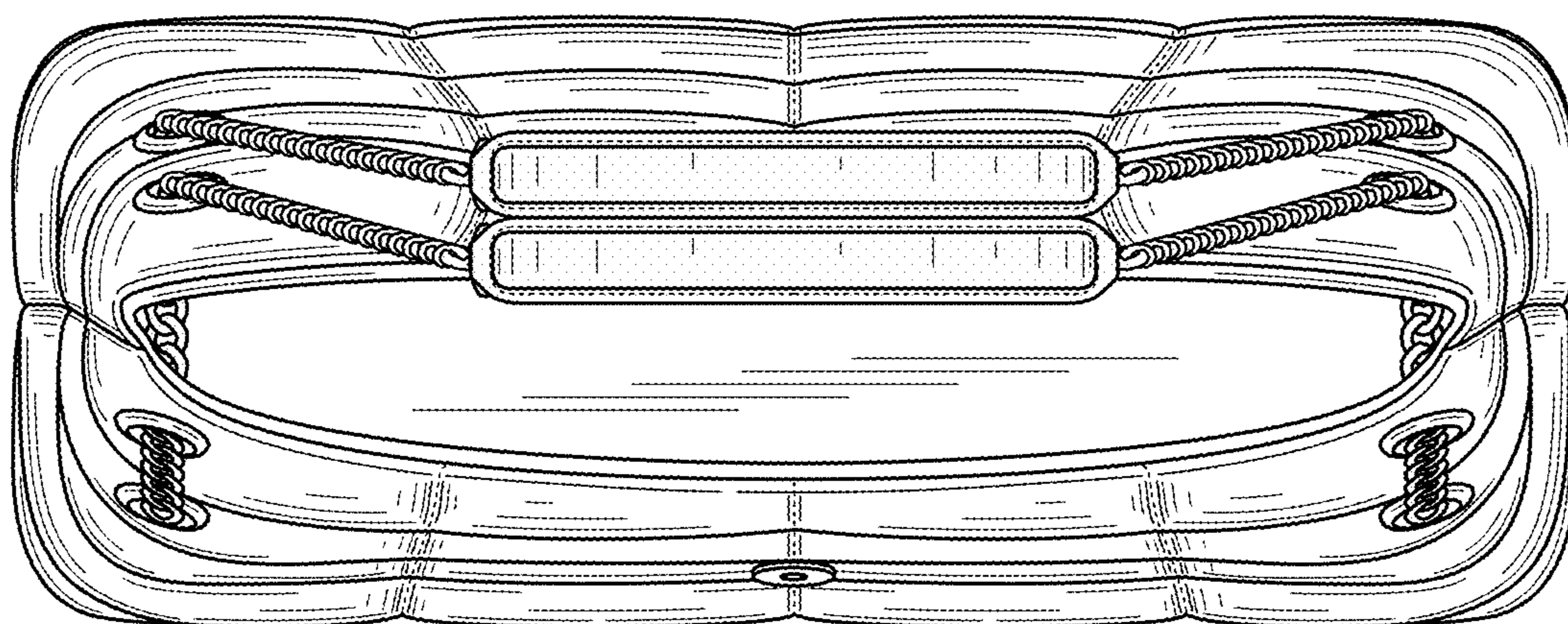
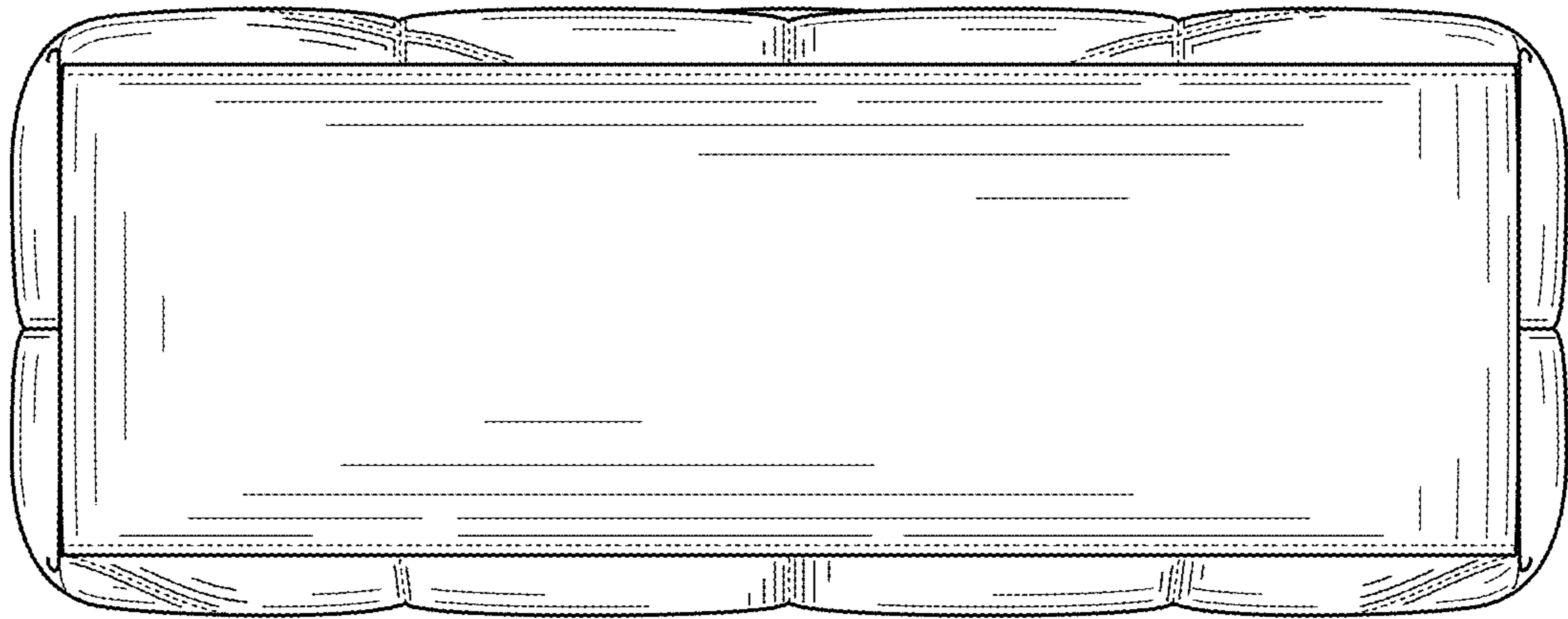
