**DESCRIPTION**

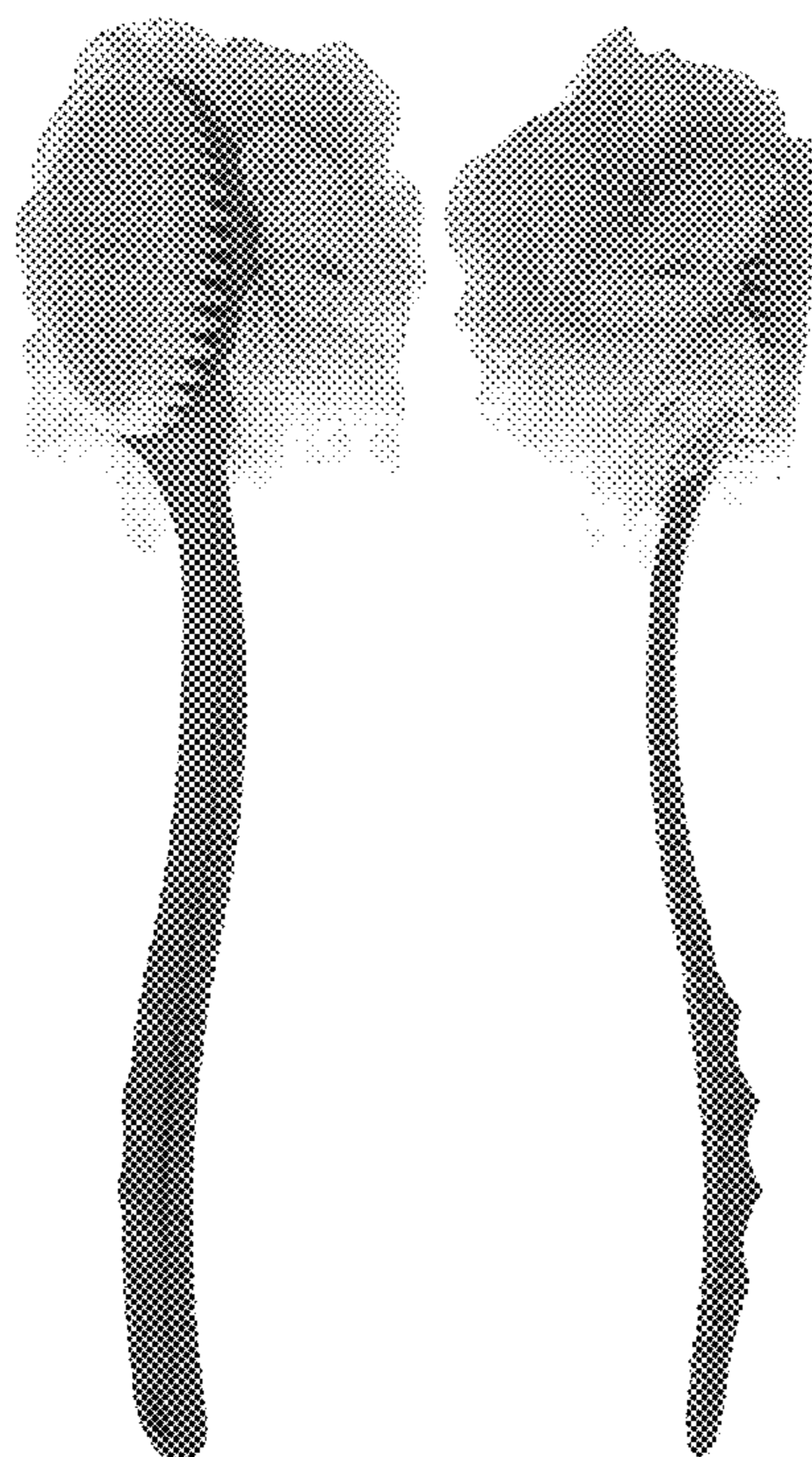
FIG. 1 is a perspective view of a bath brush showing my new design;

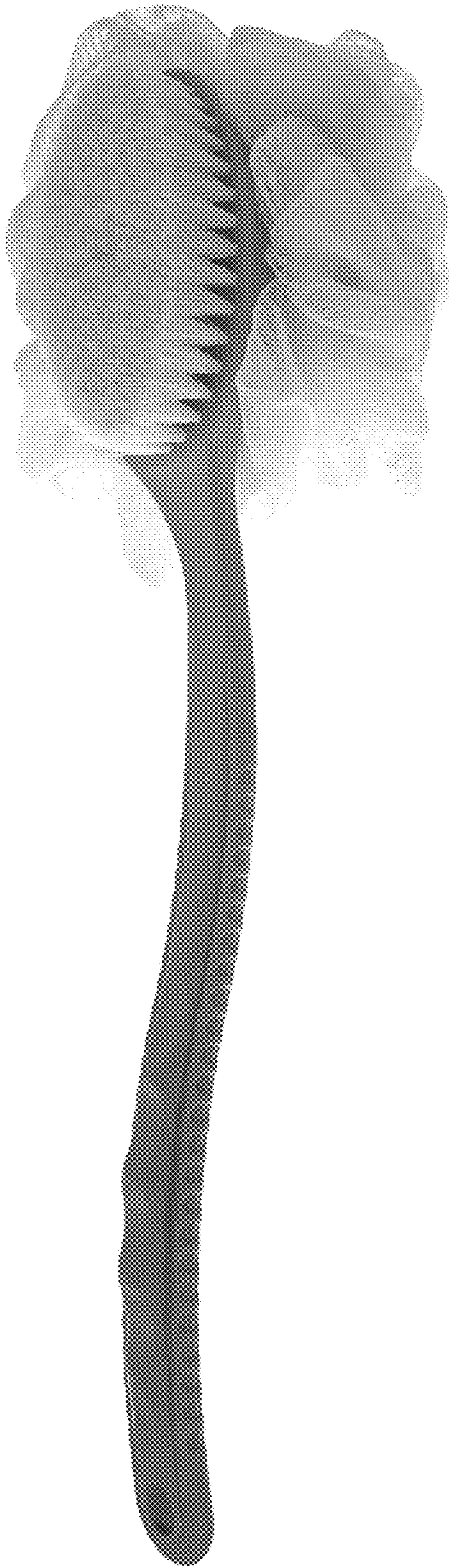

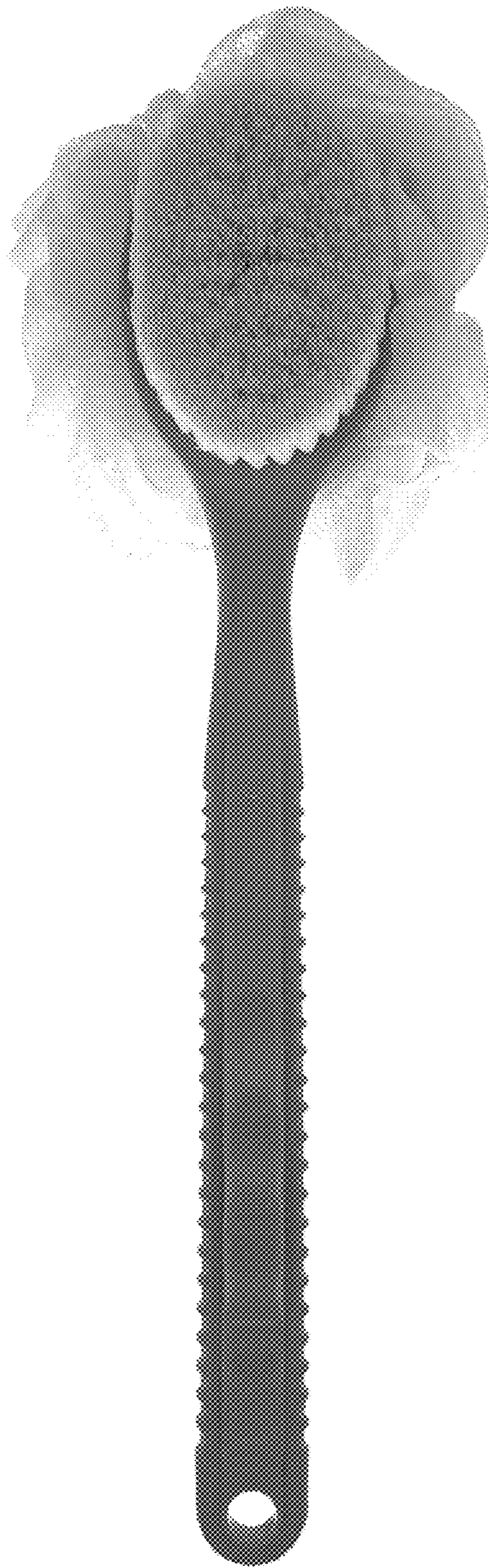

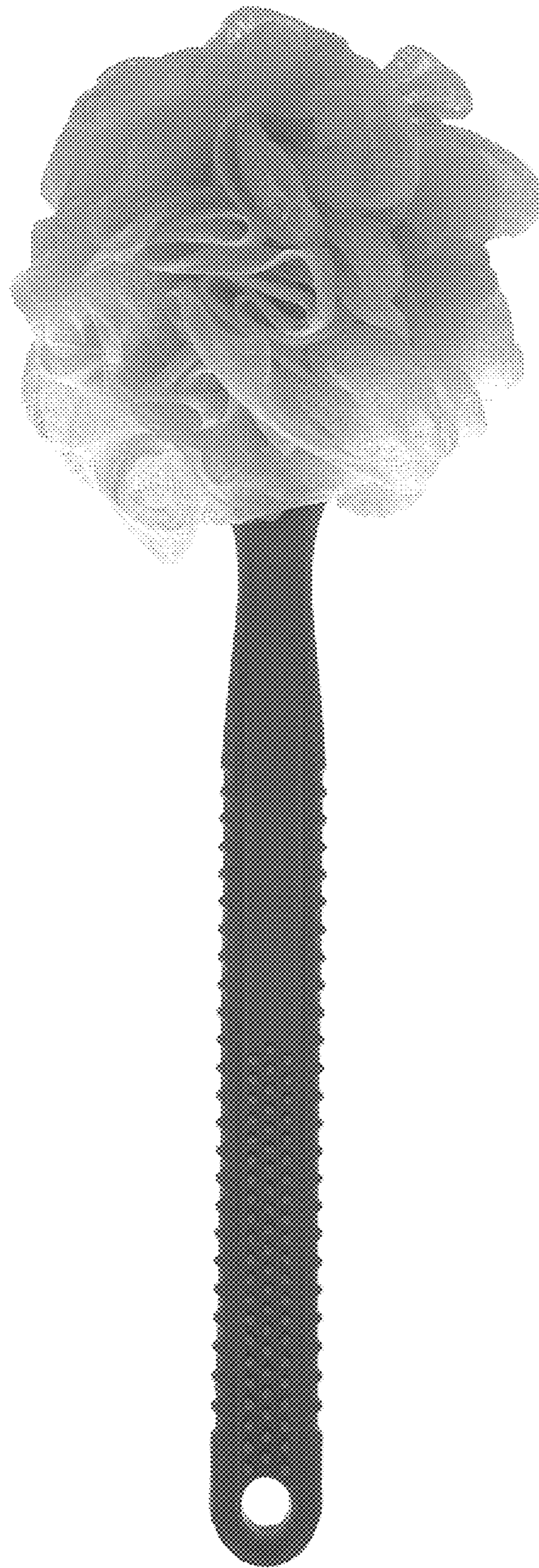

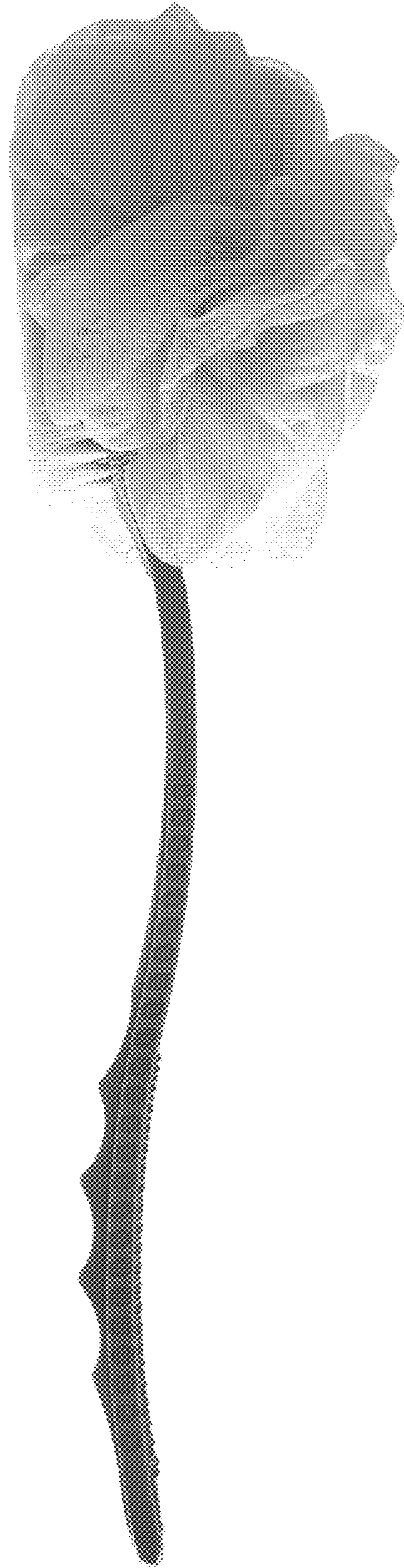

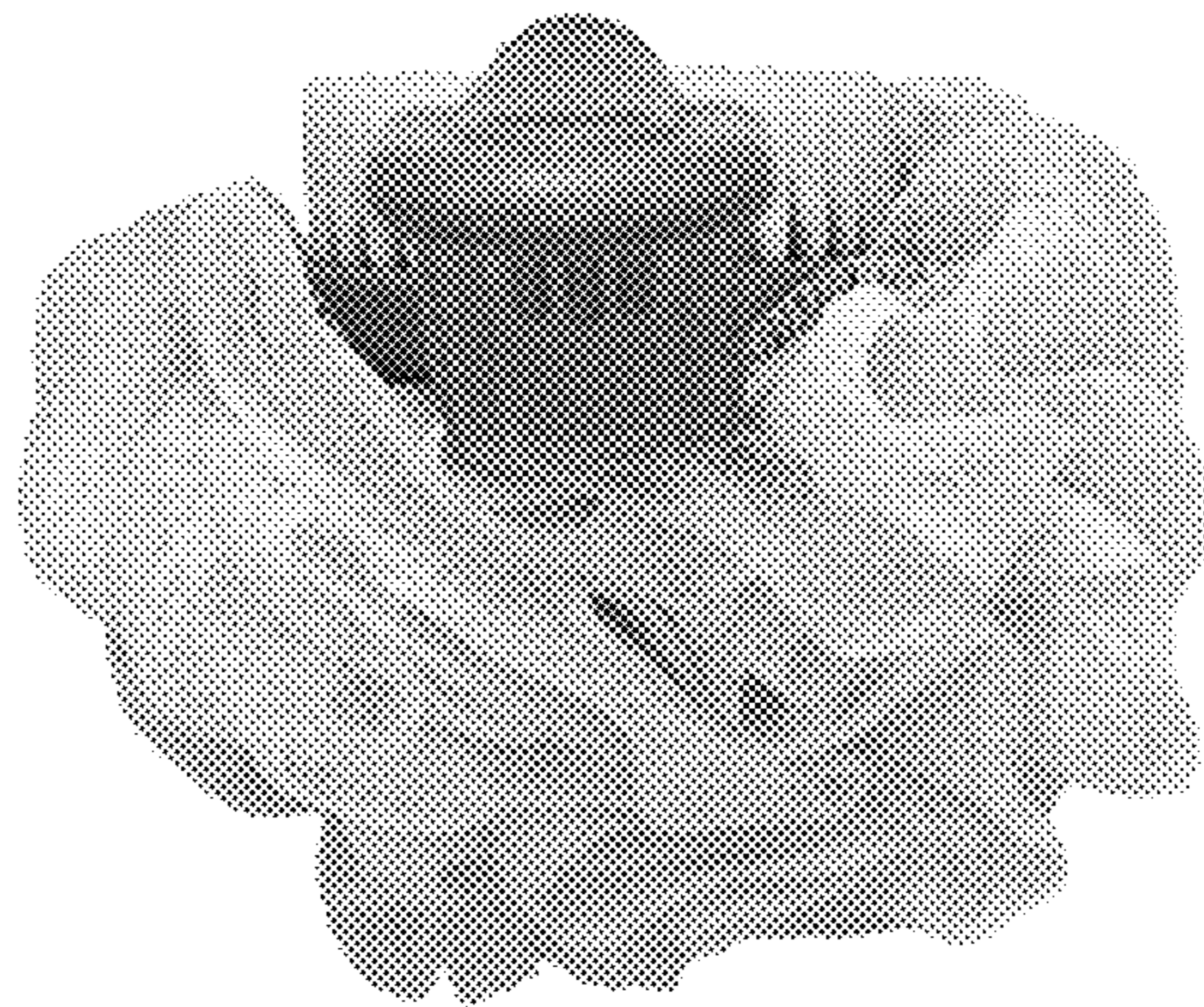
