(57) **CLAIM**

The ornamental design for a camera-equipped display shelf, as shown and described.

**DESCRIPTION**

FIG. 1 is a reduced-scale front, right side, top perspective view of a camera-equipped display shelf showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is an enlarged cross-sectional view thereof, taken in the direction of line 8-8 of FIG. 6 (an internal mechanism is omitted).

The portions depicted by broken lines are for illustrative purpose only and form no part of the claimed design.

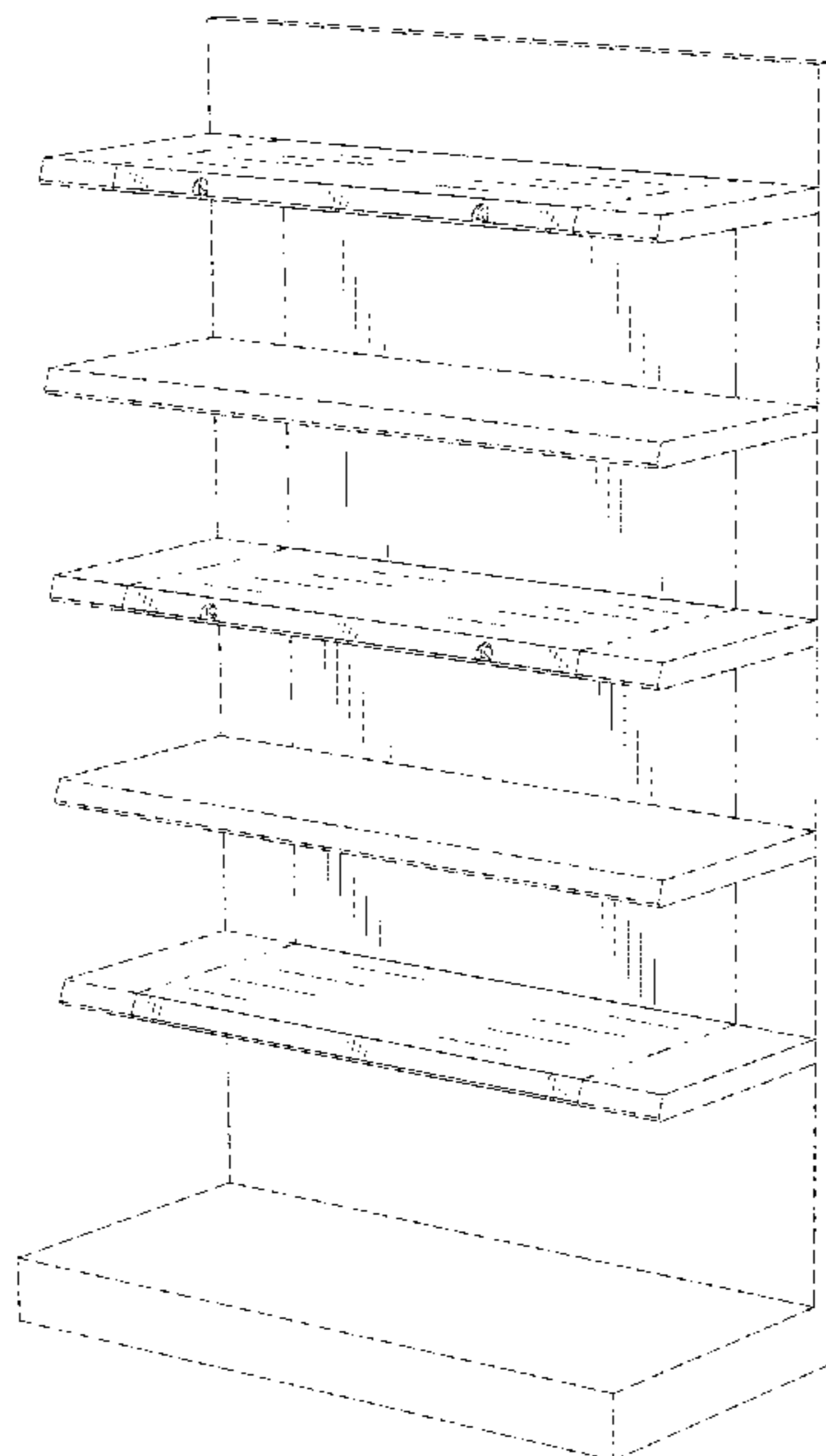
The long and short dashed lines illustrate a boundary of claimed design and unclaimed ones.

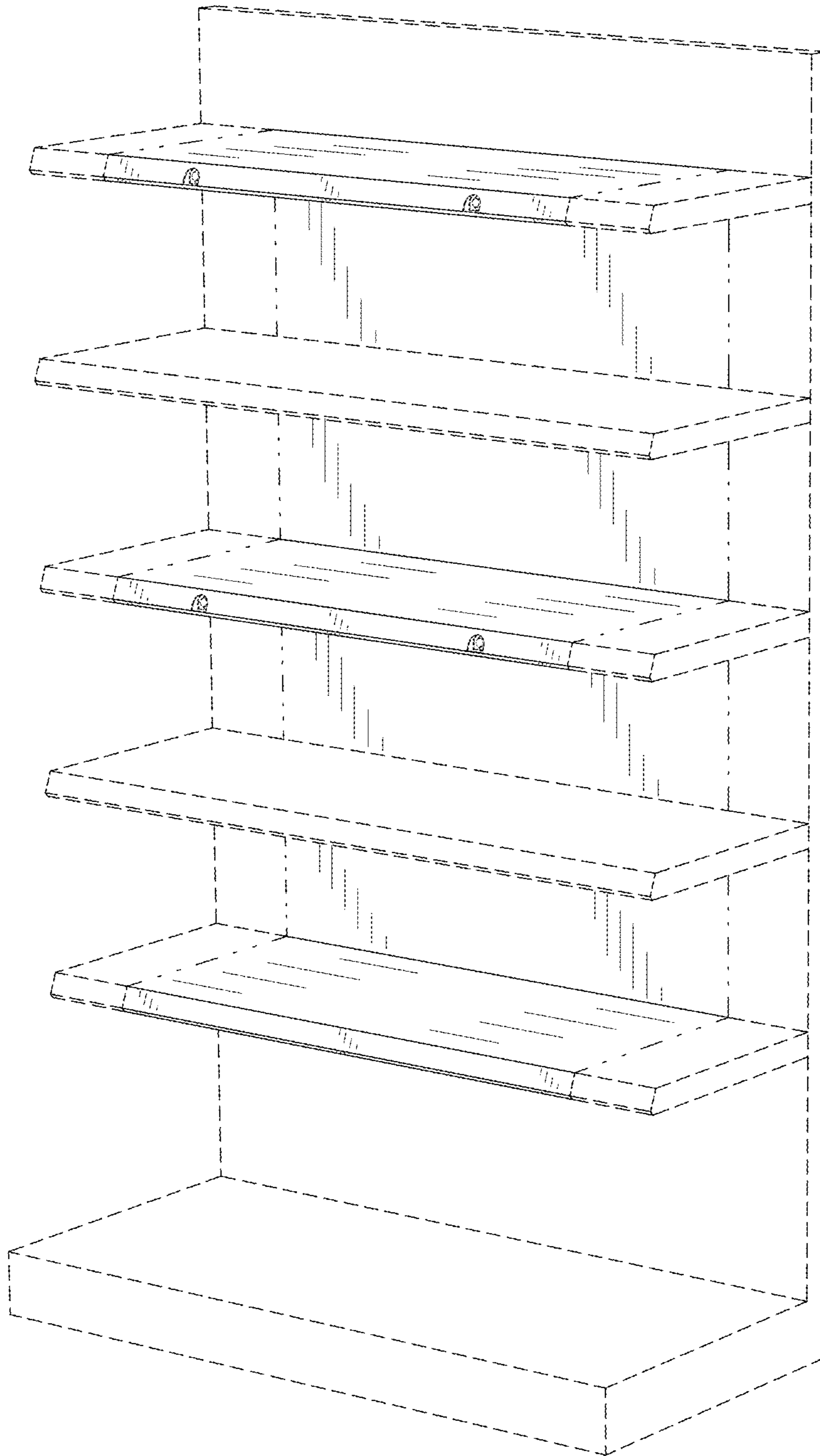

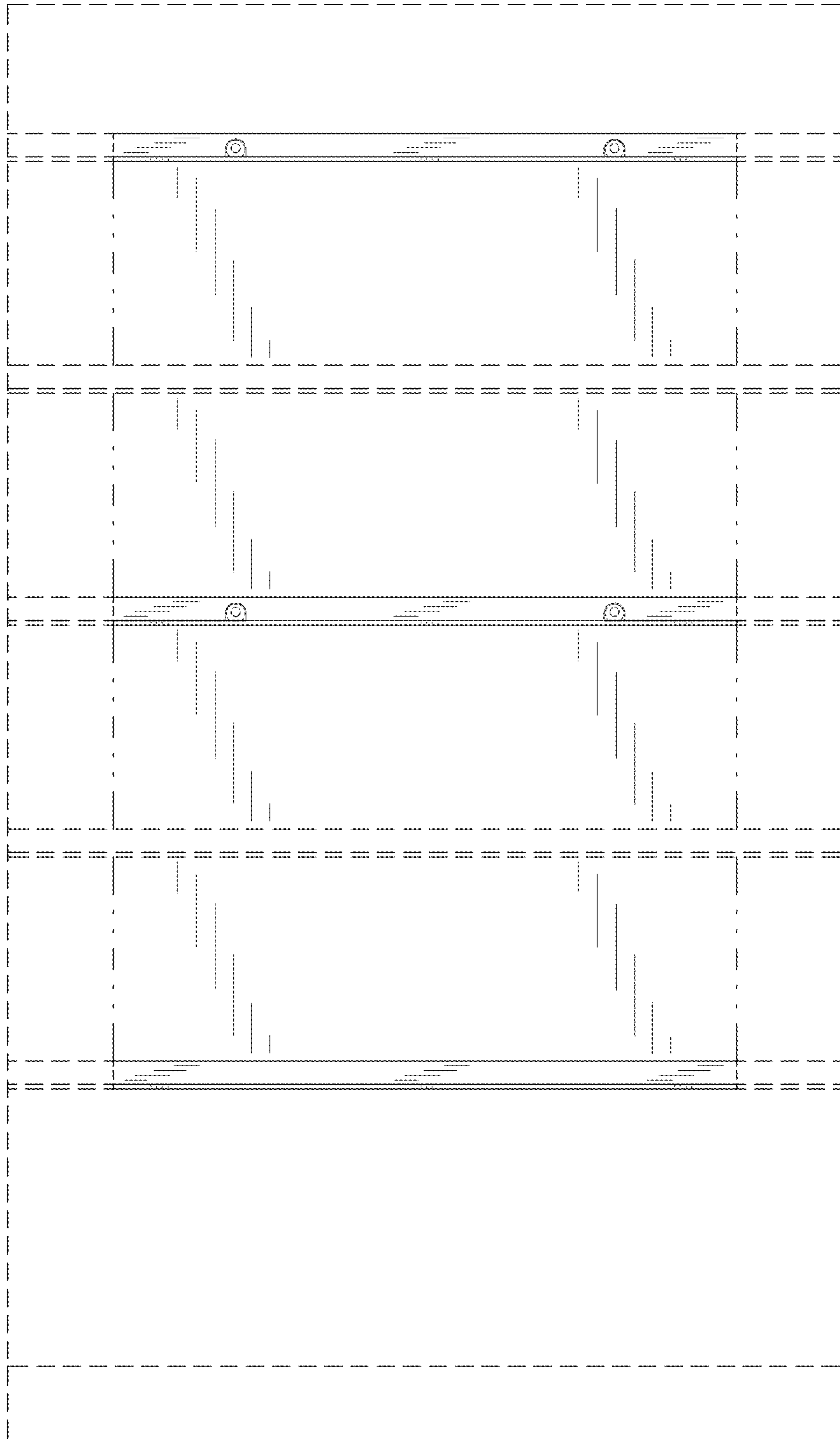

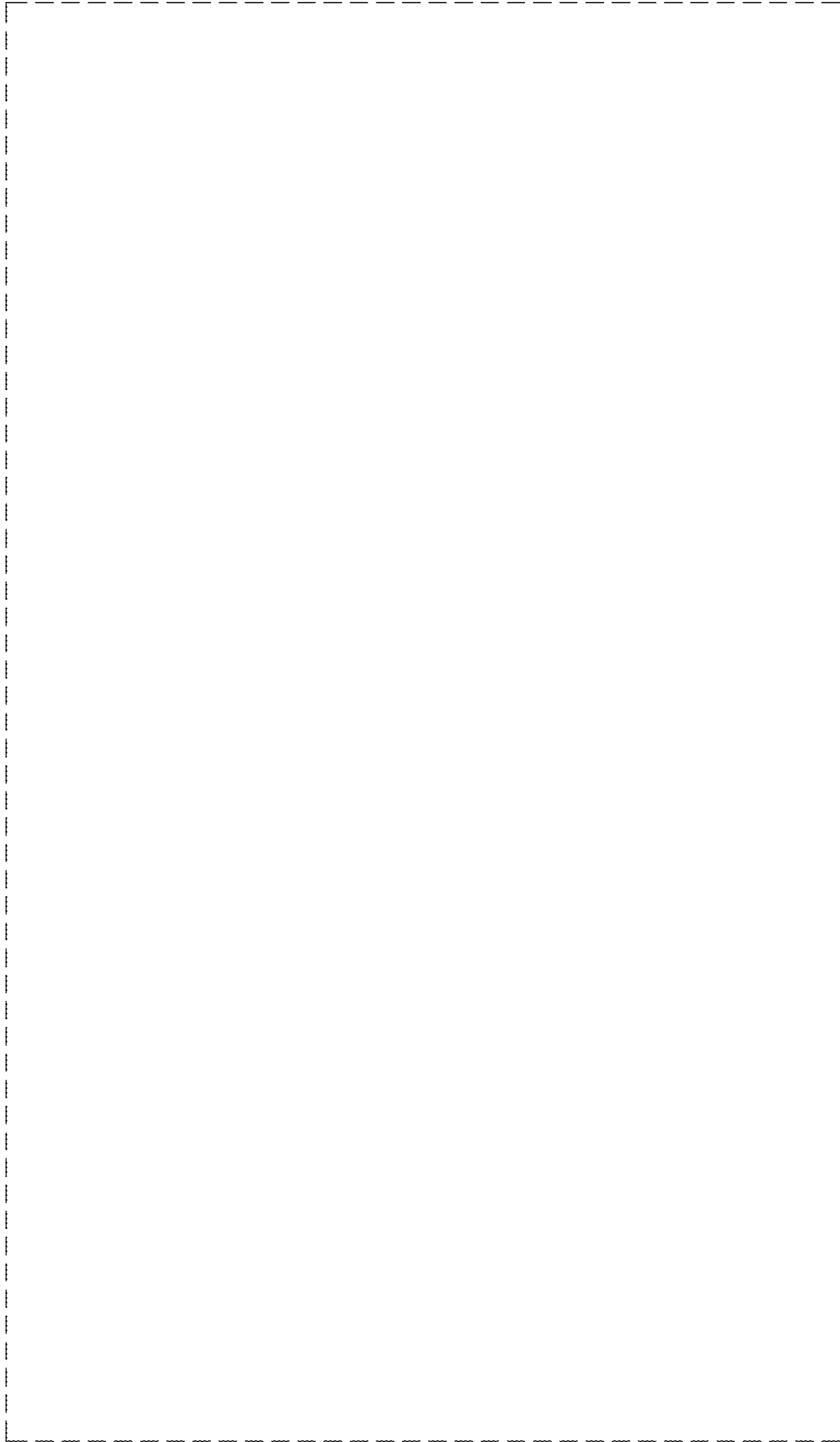

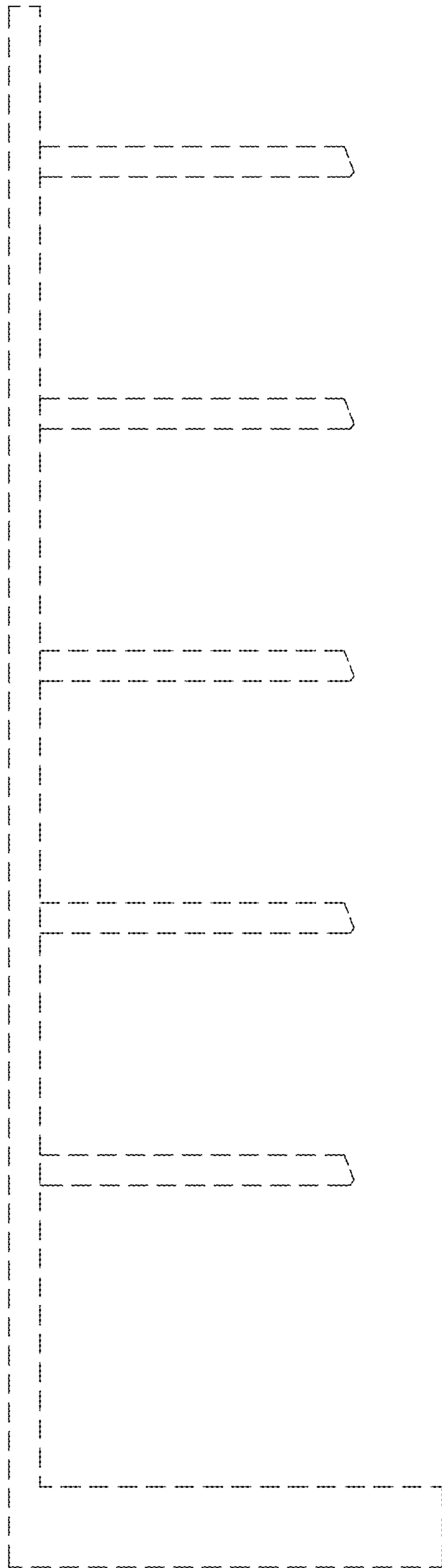

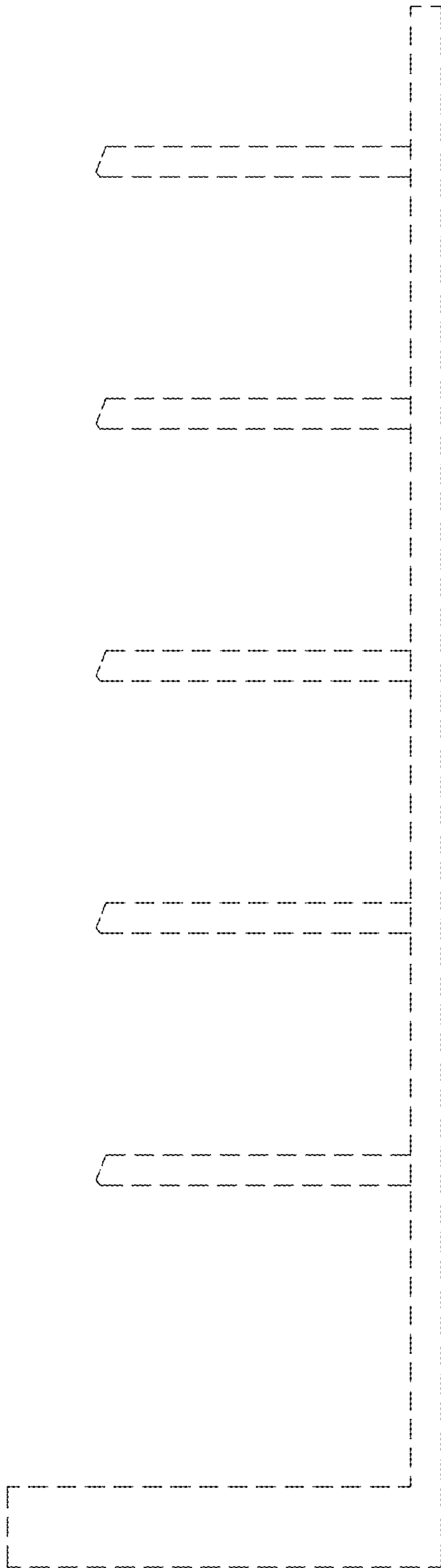

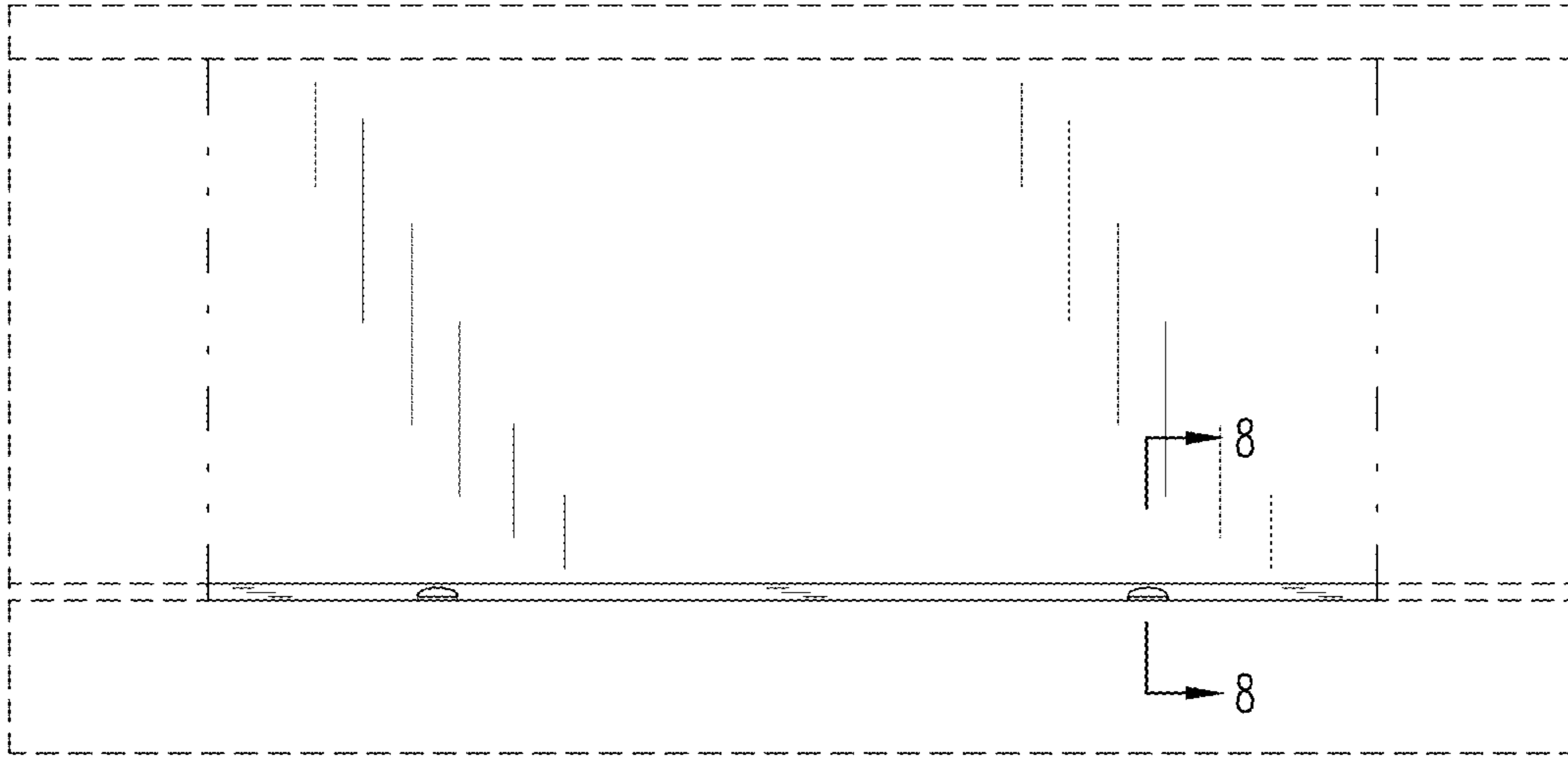

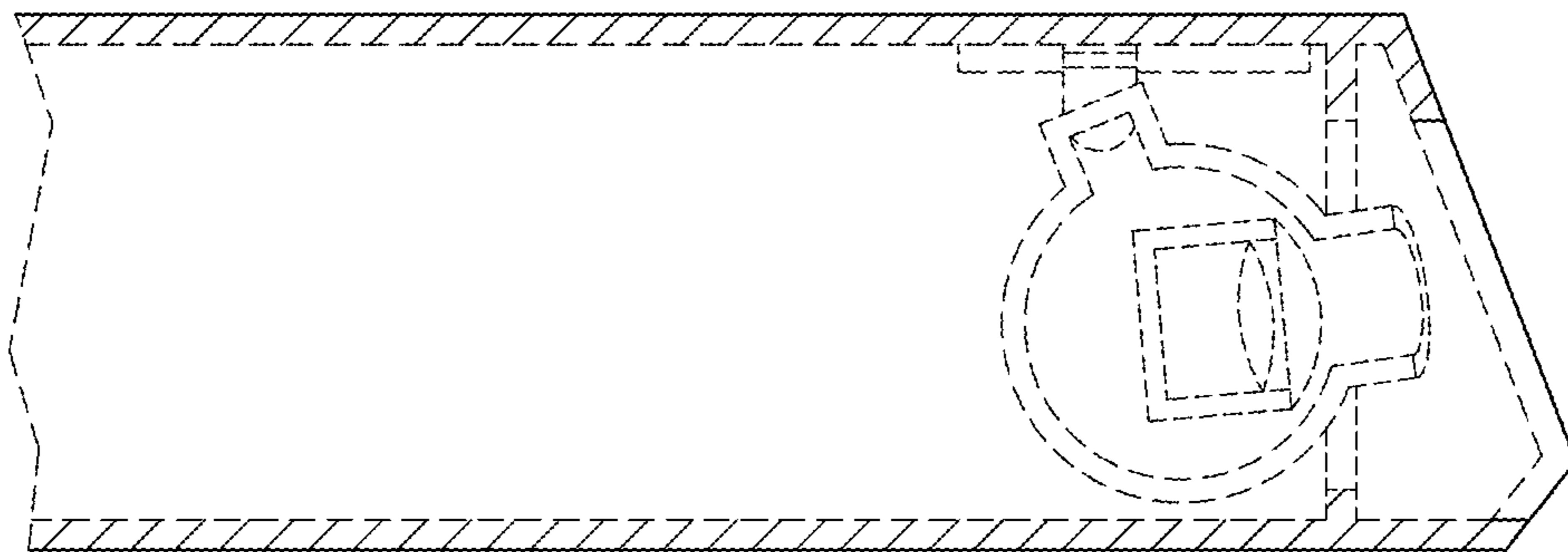
