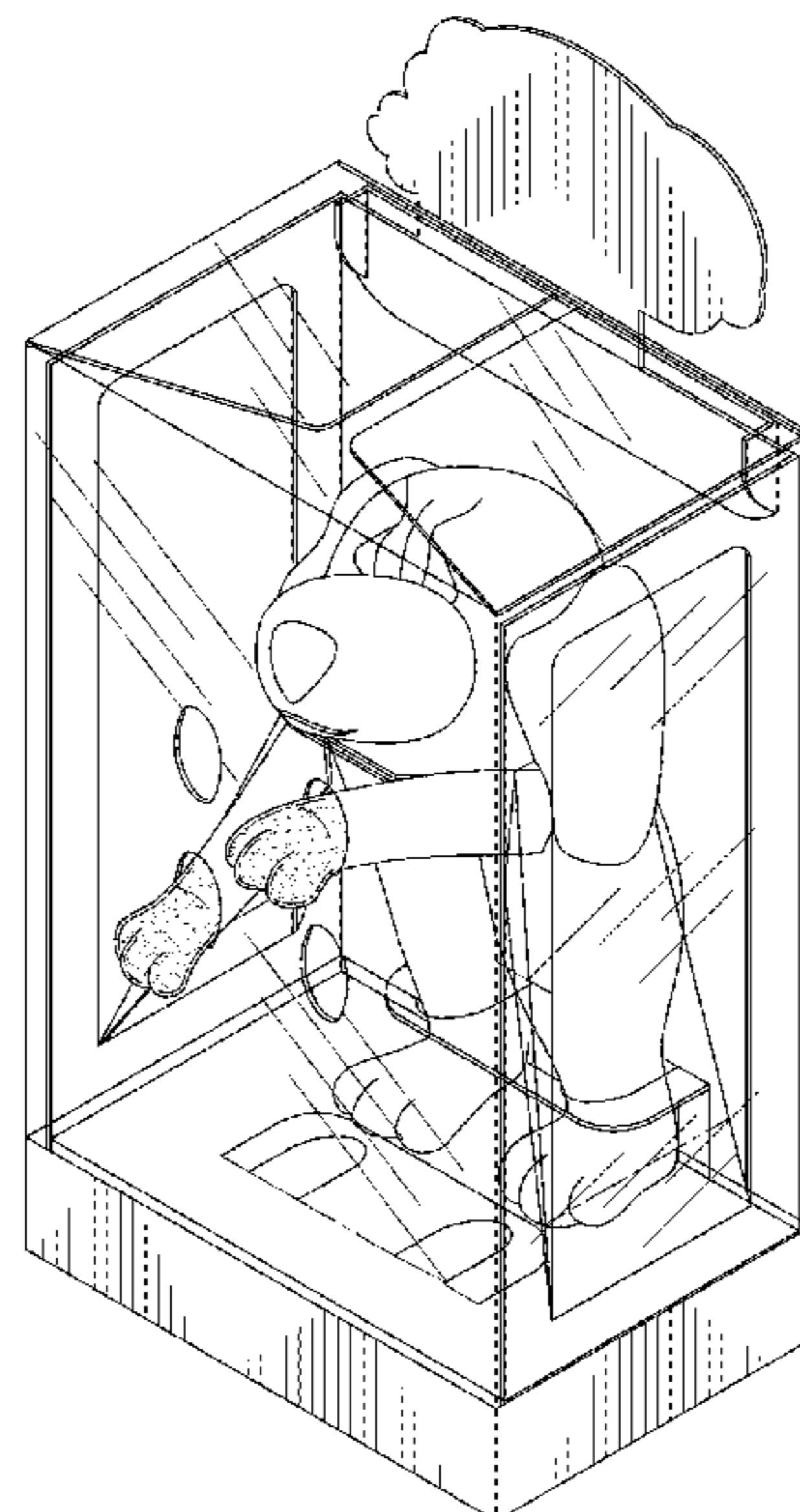
(57) **CLAIM**

I claim the ornamental design for the packaging with plush animal, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of my packaging with plush animal showing my new design;
 FIG. 2 is a front side elevational view thereof;

 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a back side elevational view thereof;

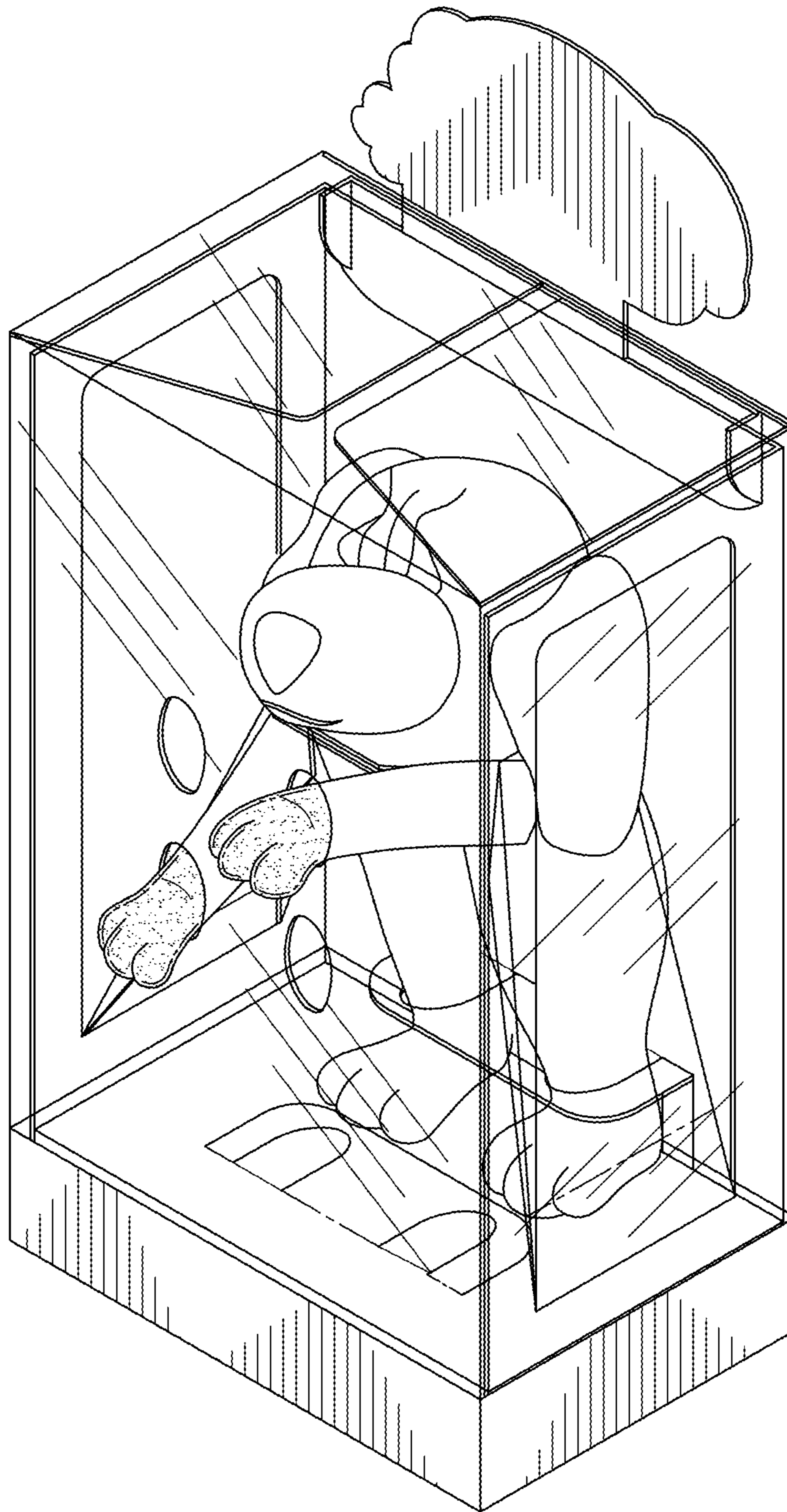

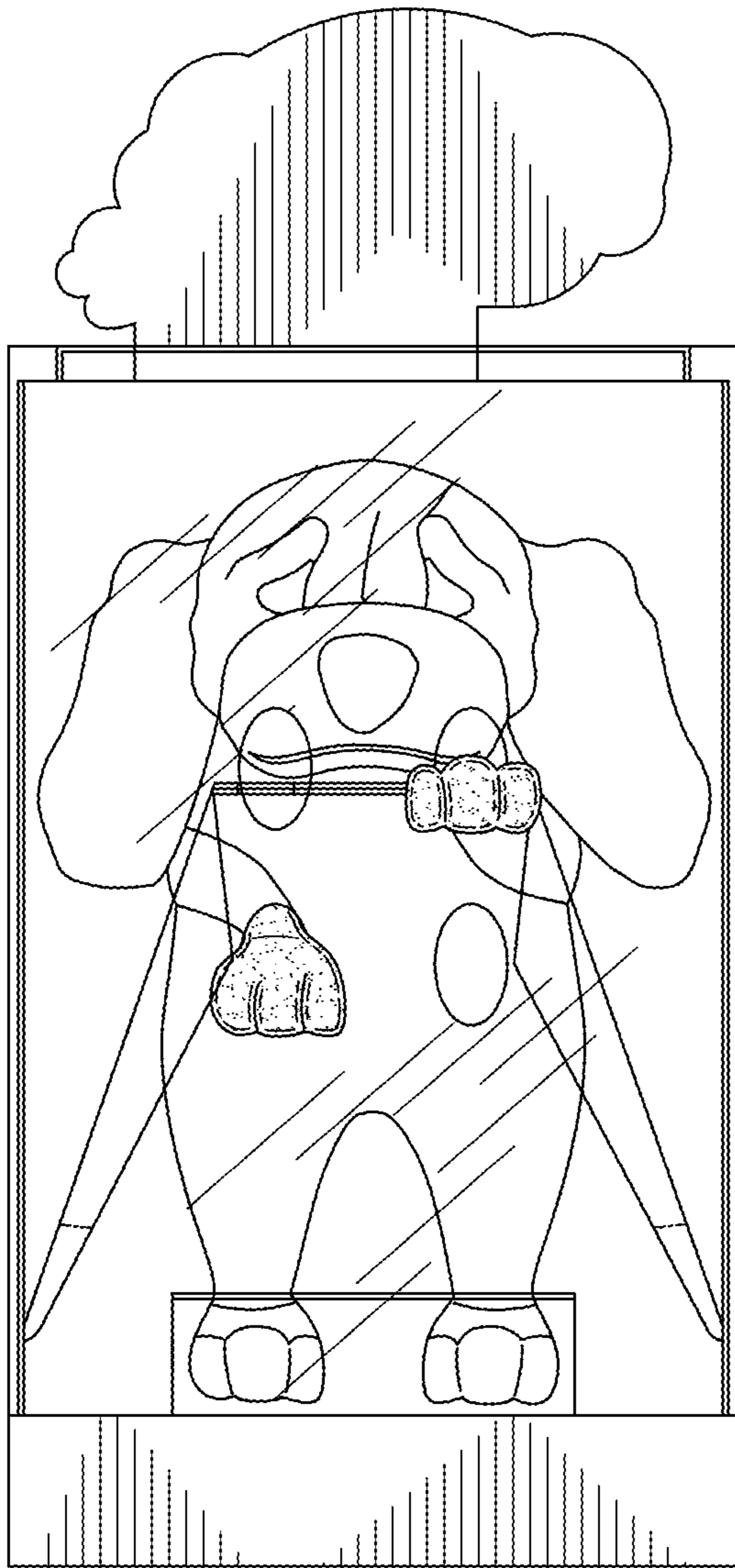

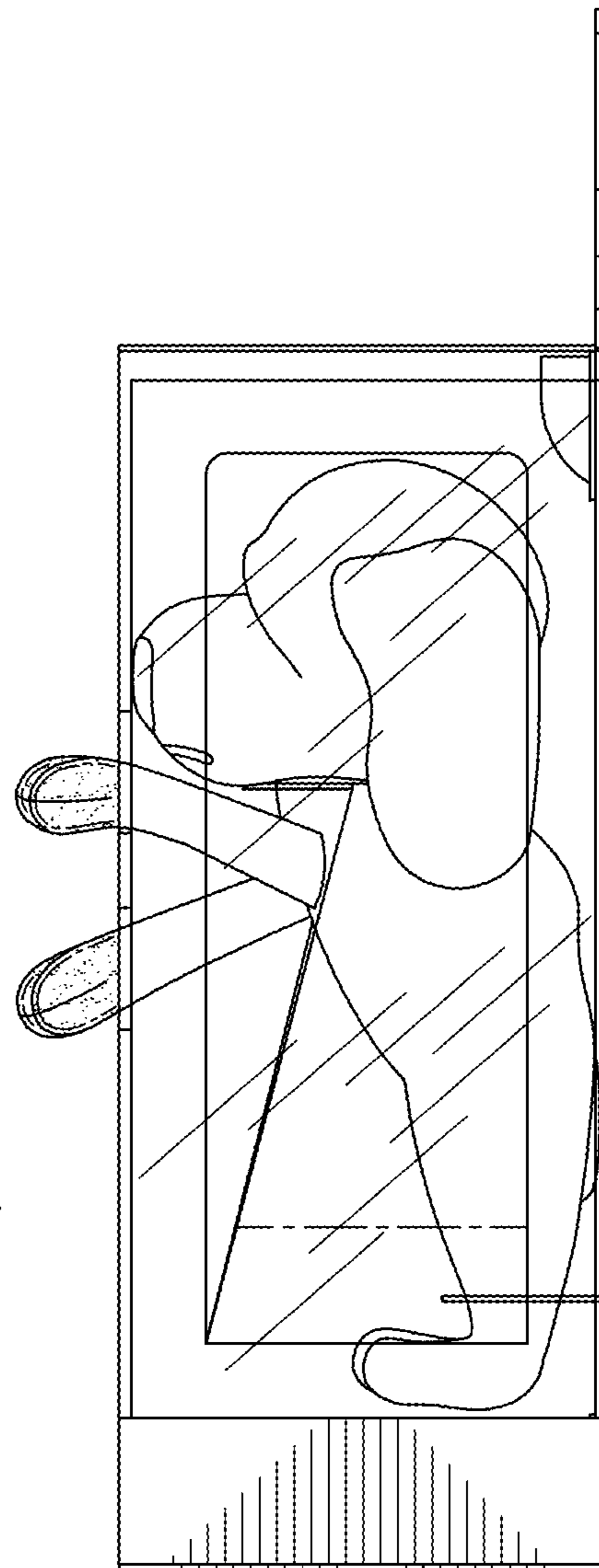

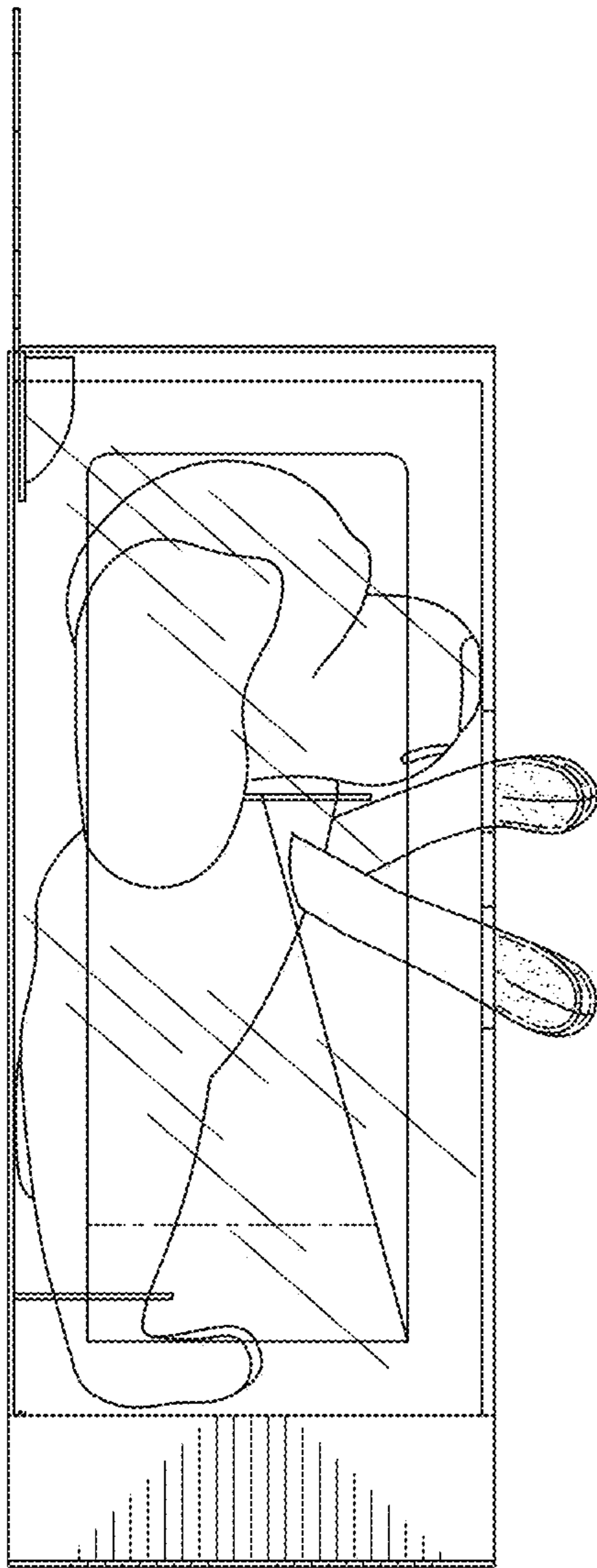

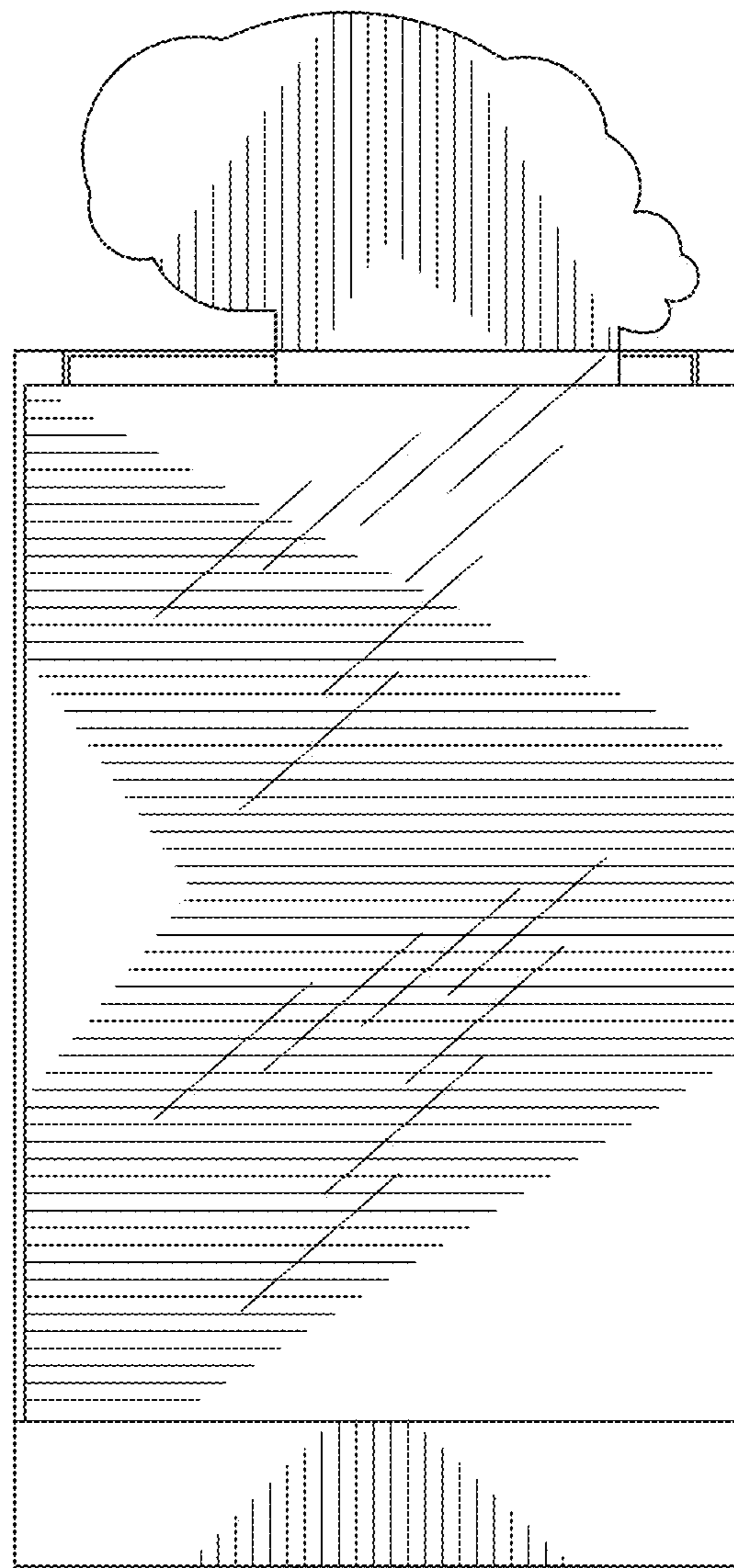

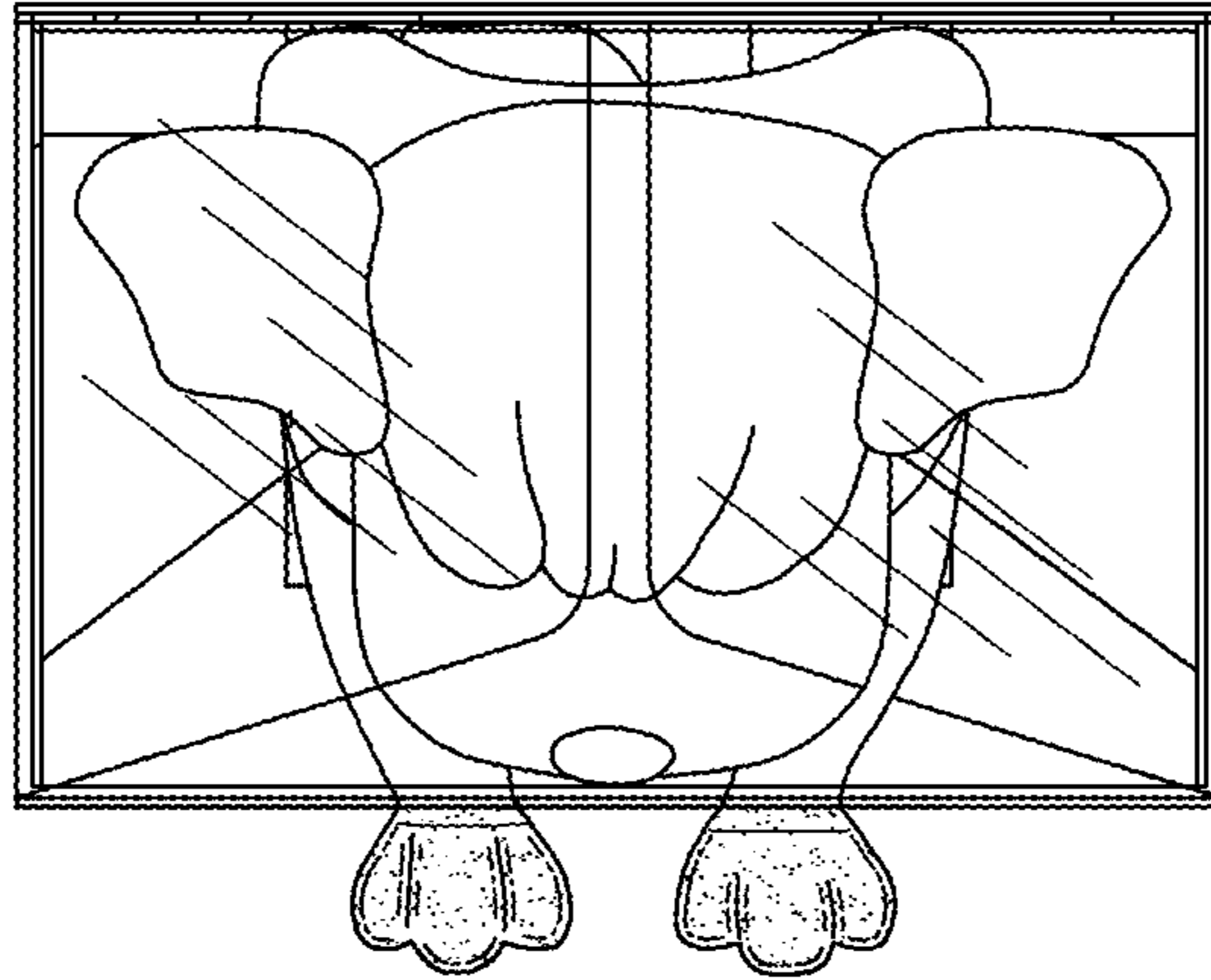

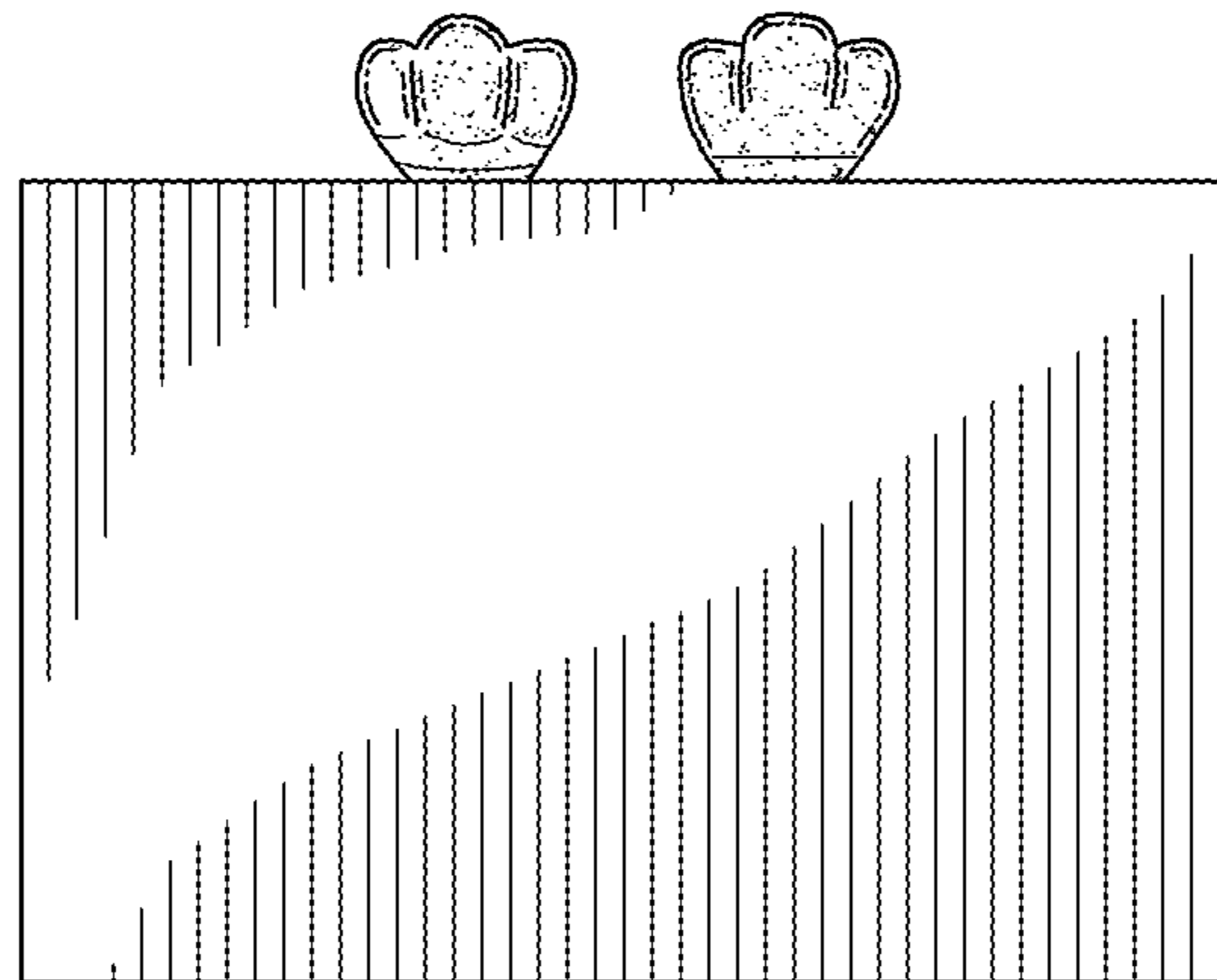

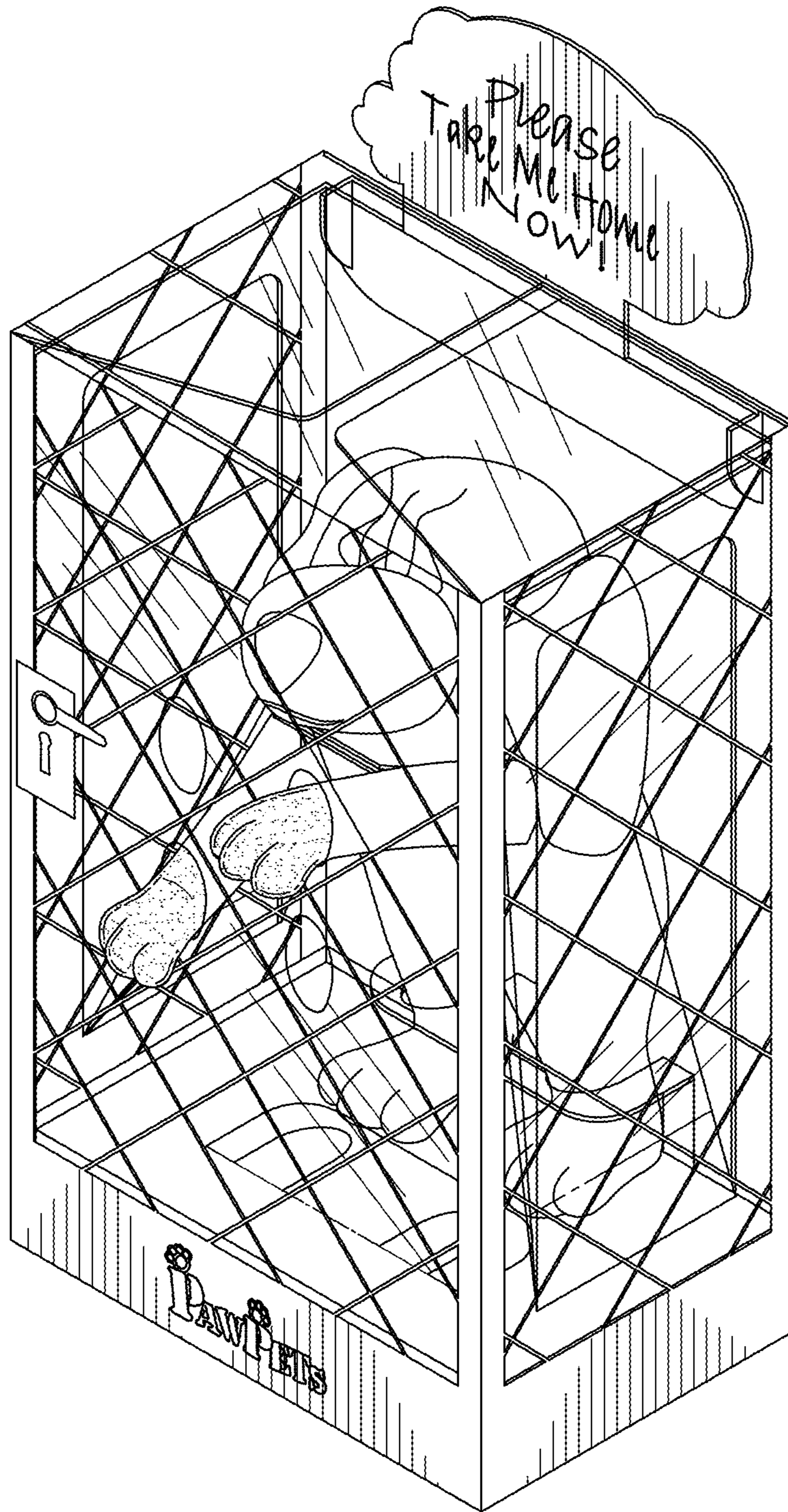

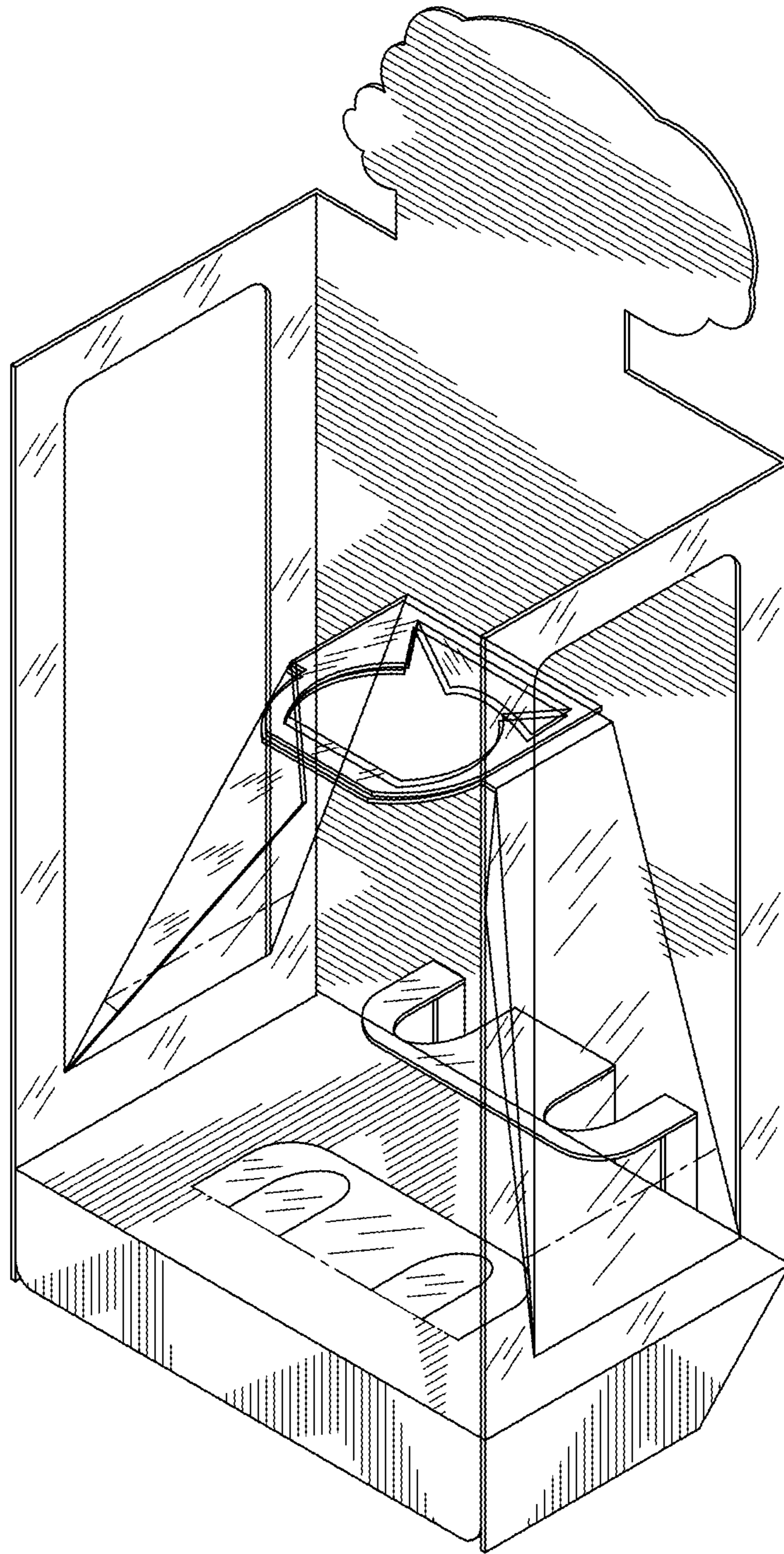

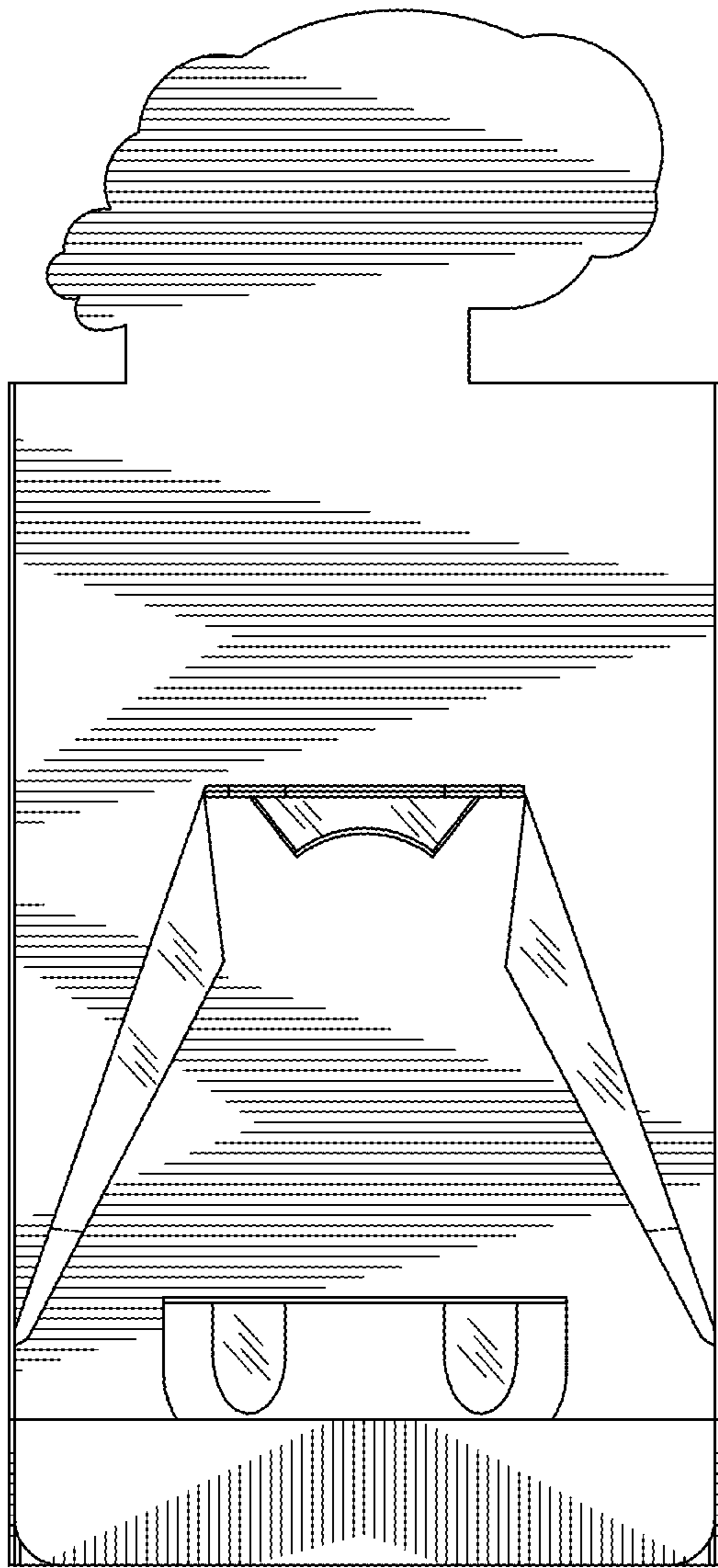

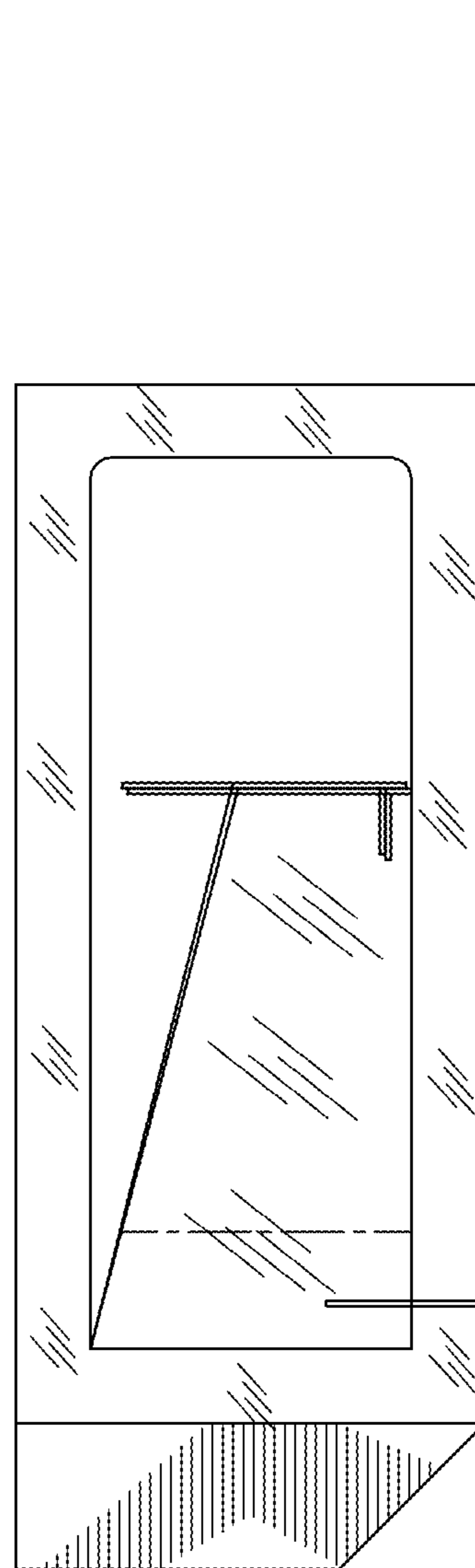

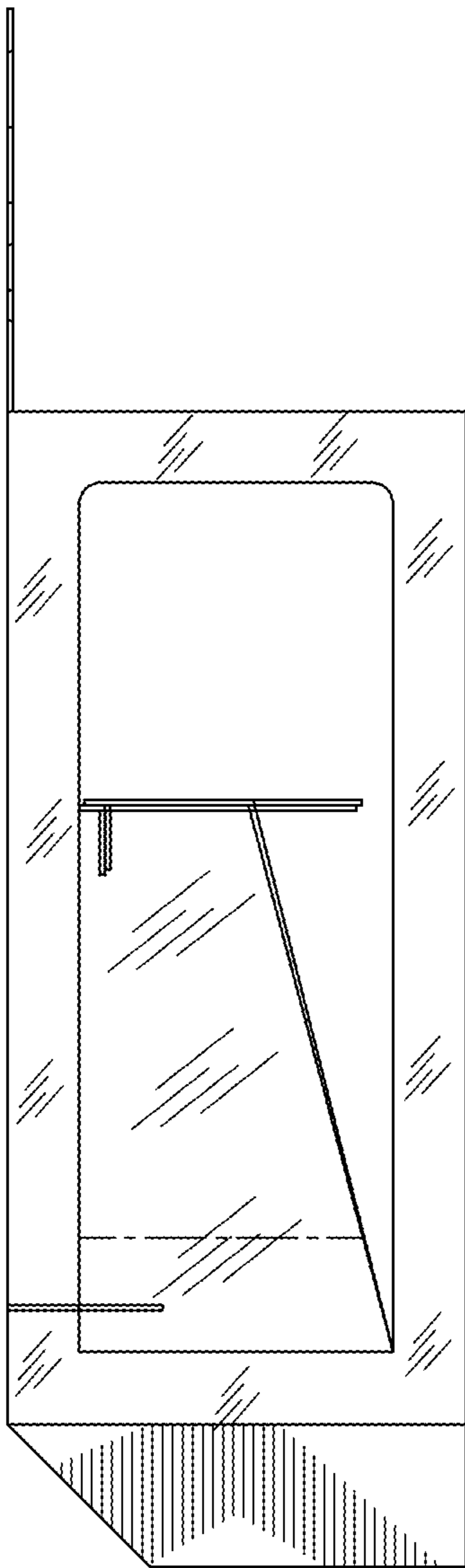
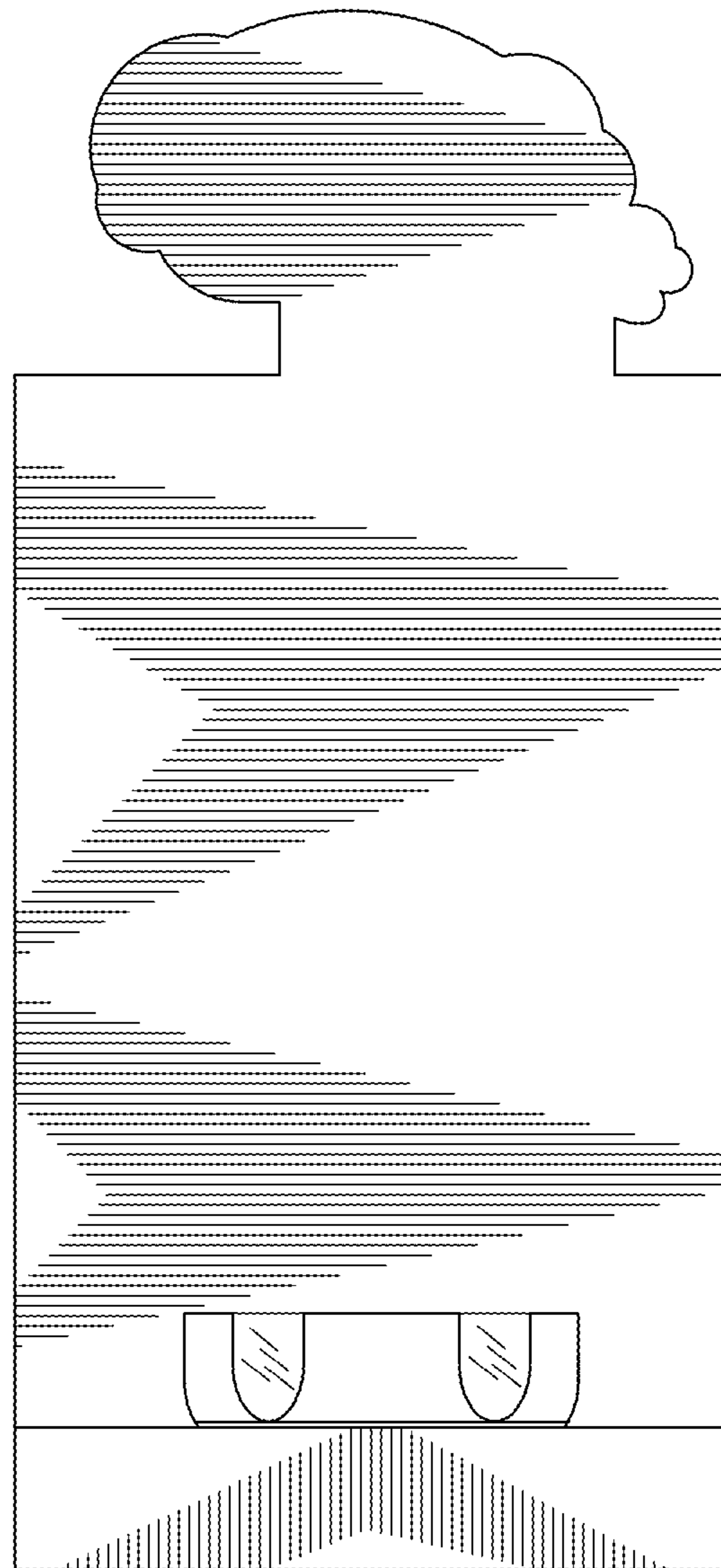

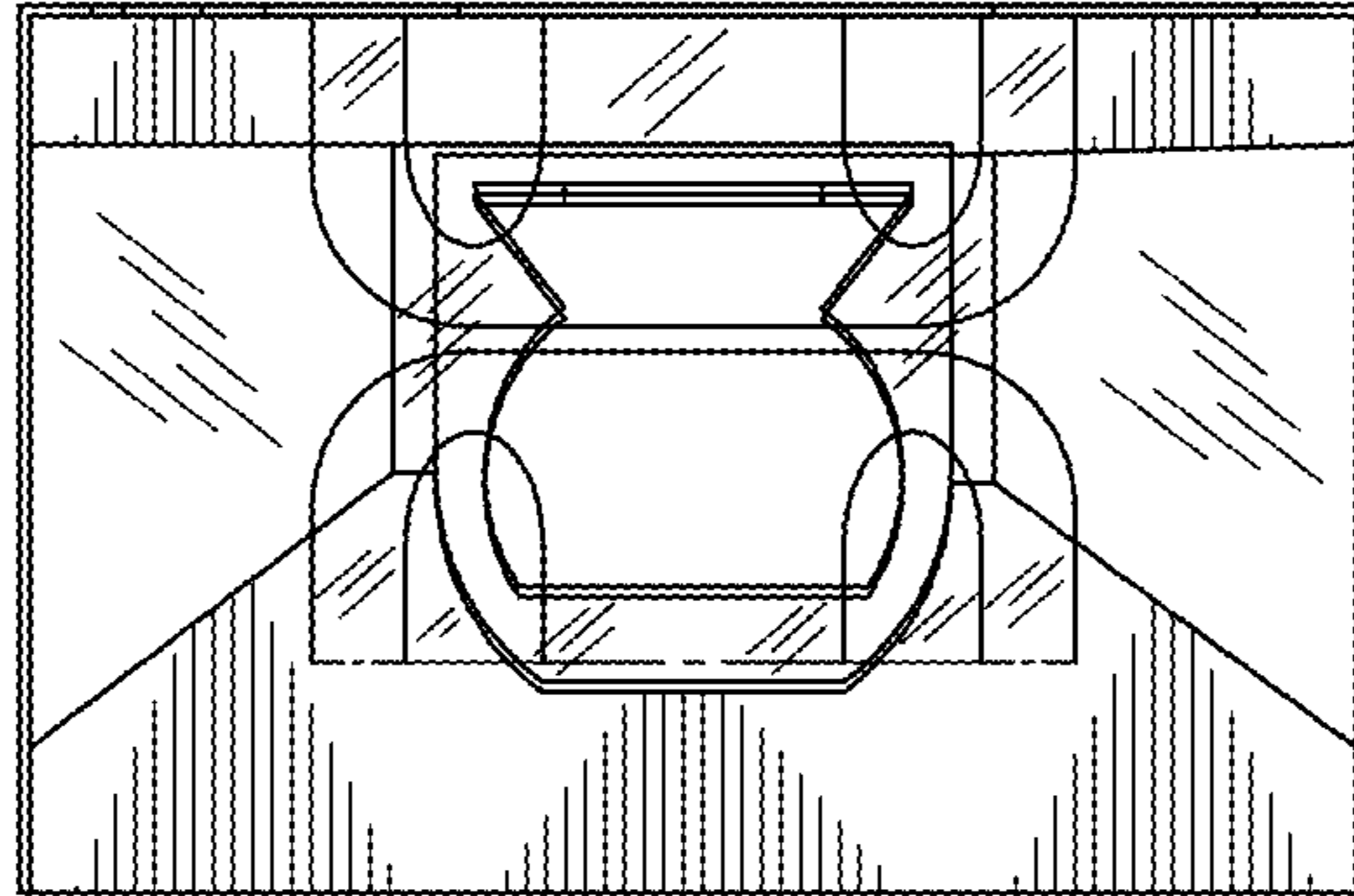

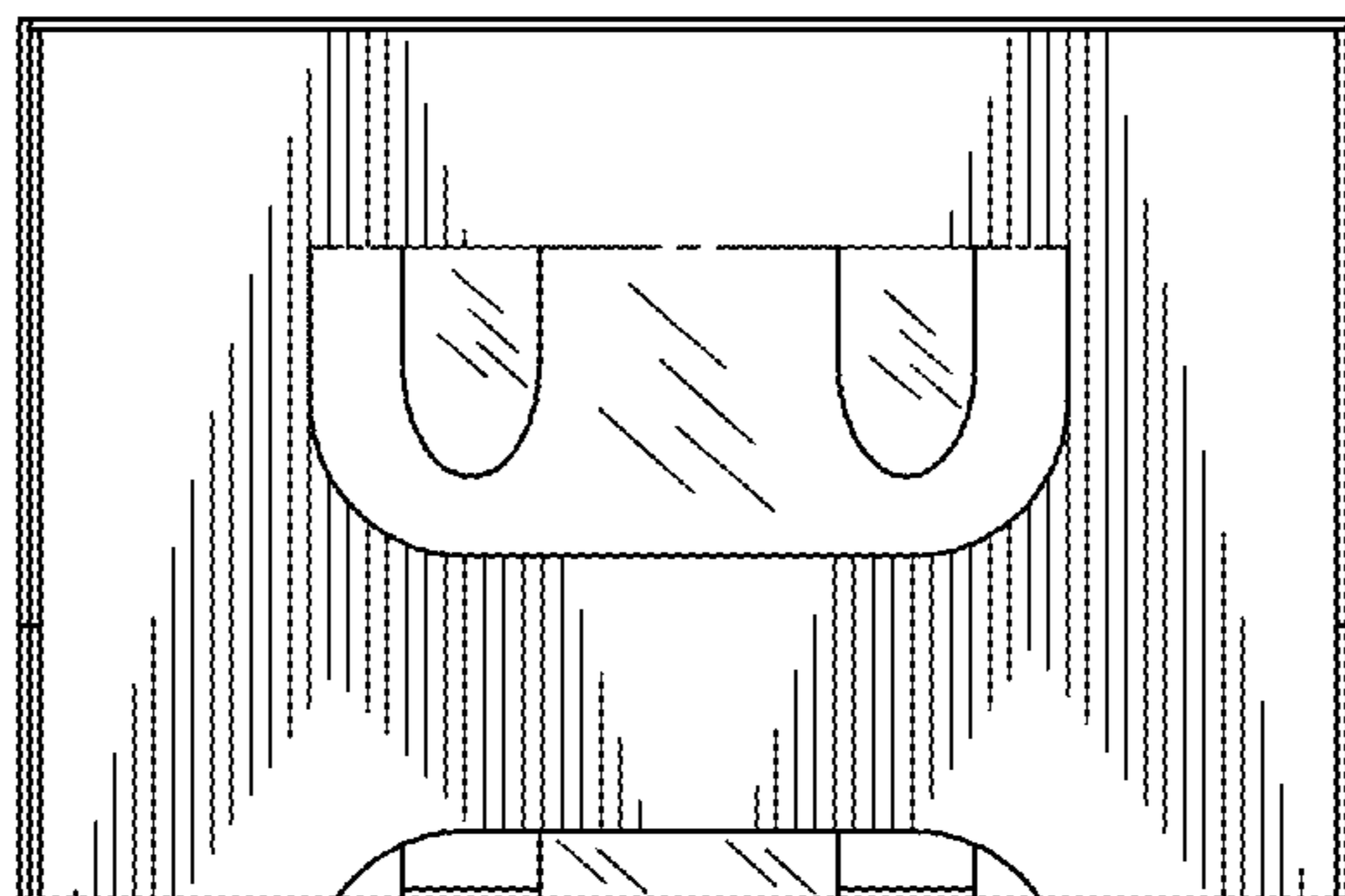
