The broken lines in the drawings represent portions of the jewelry component that form no part of the claimed design.

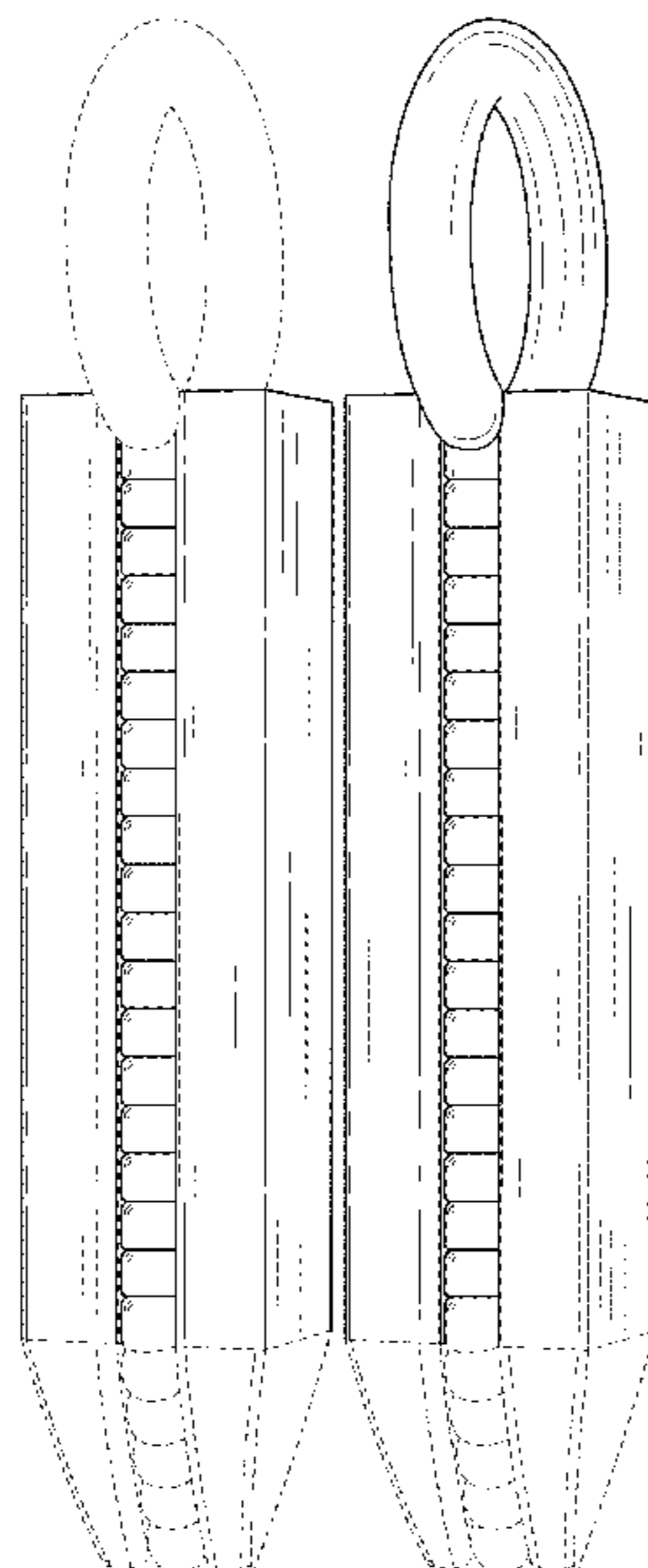

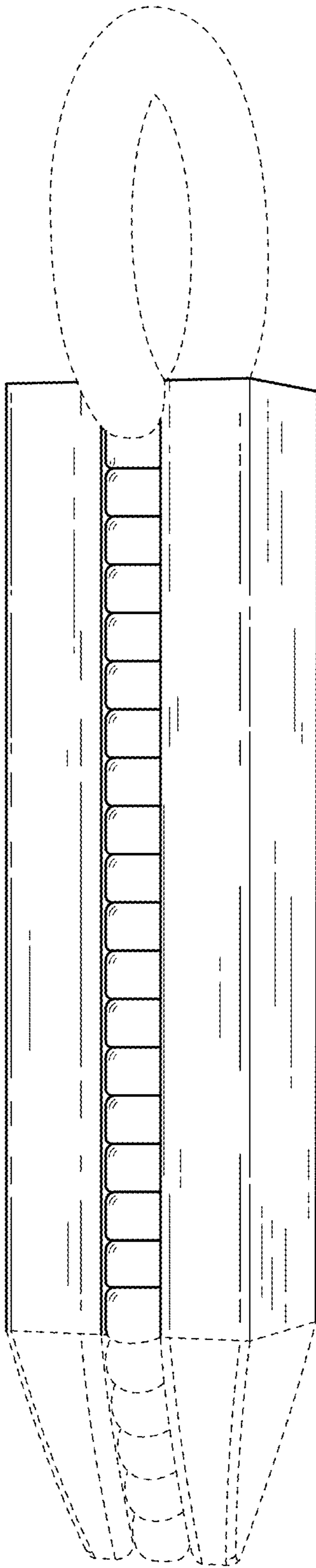

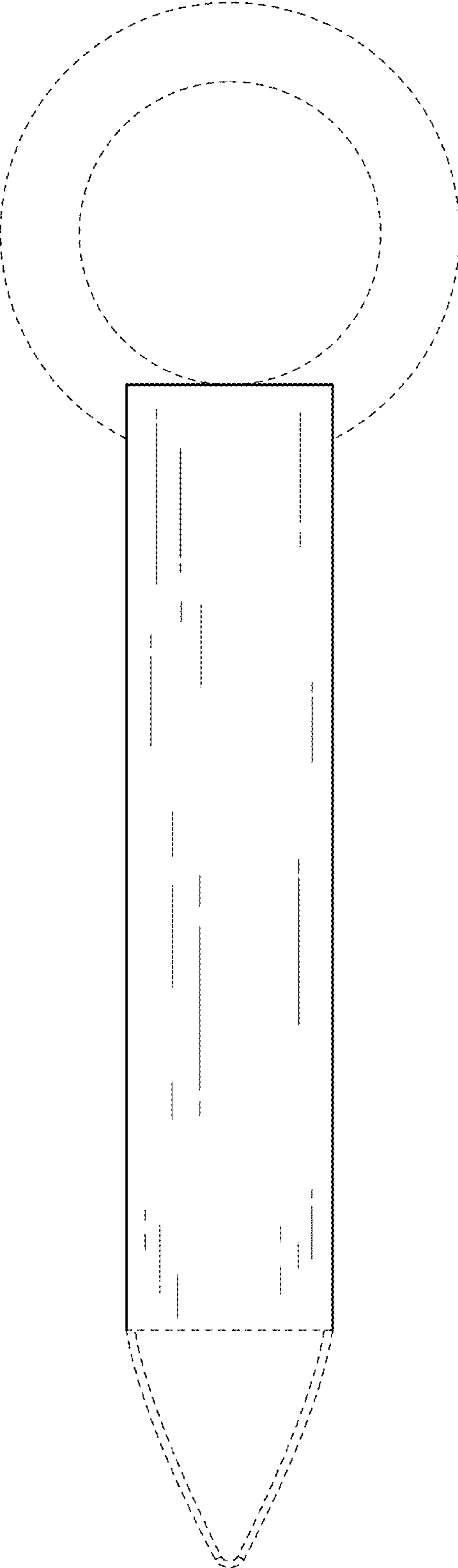

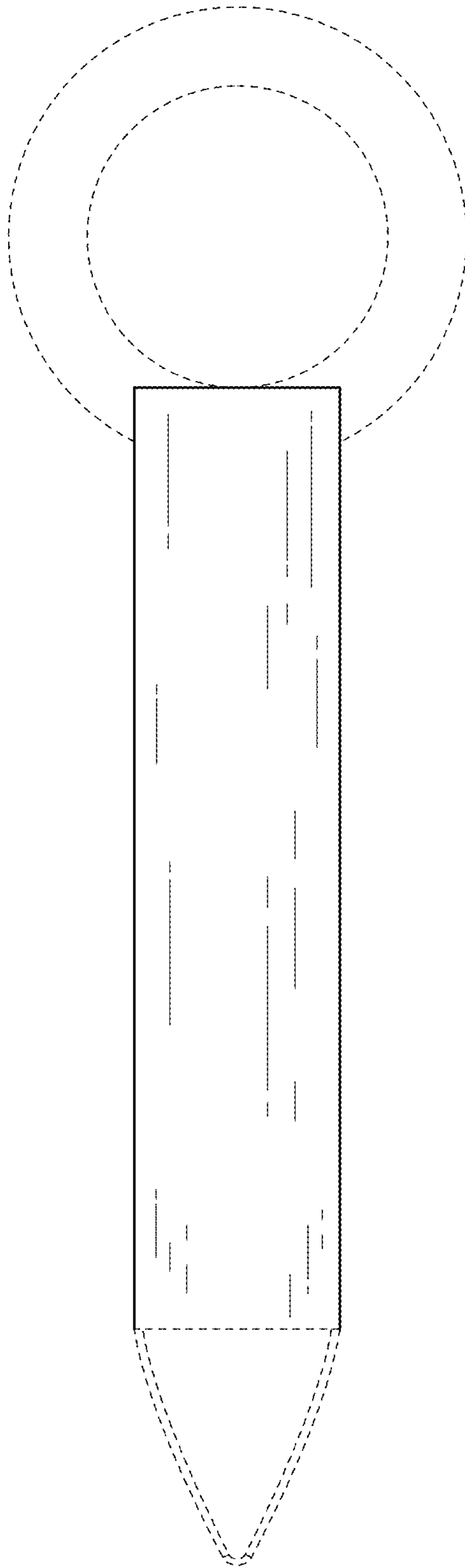

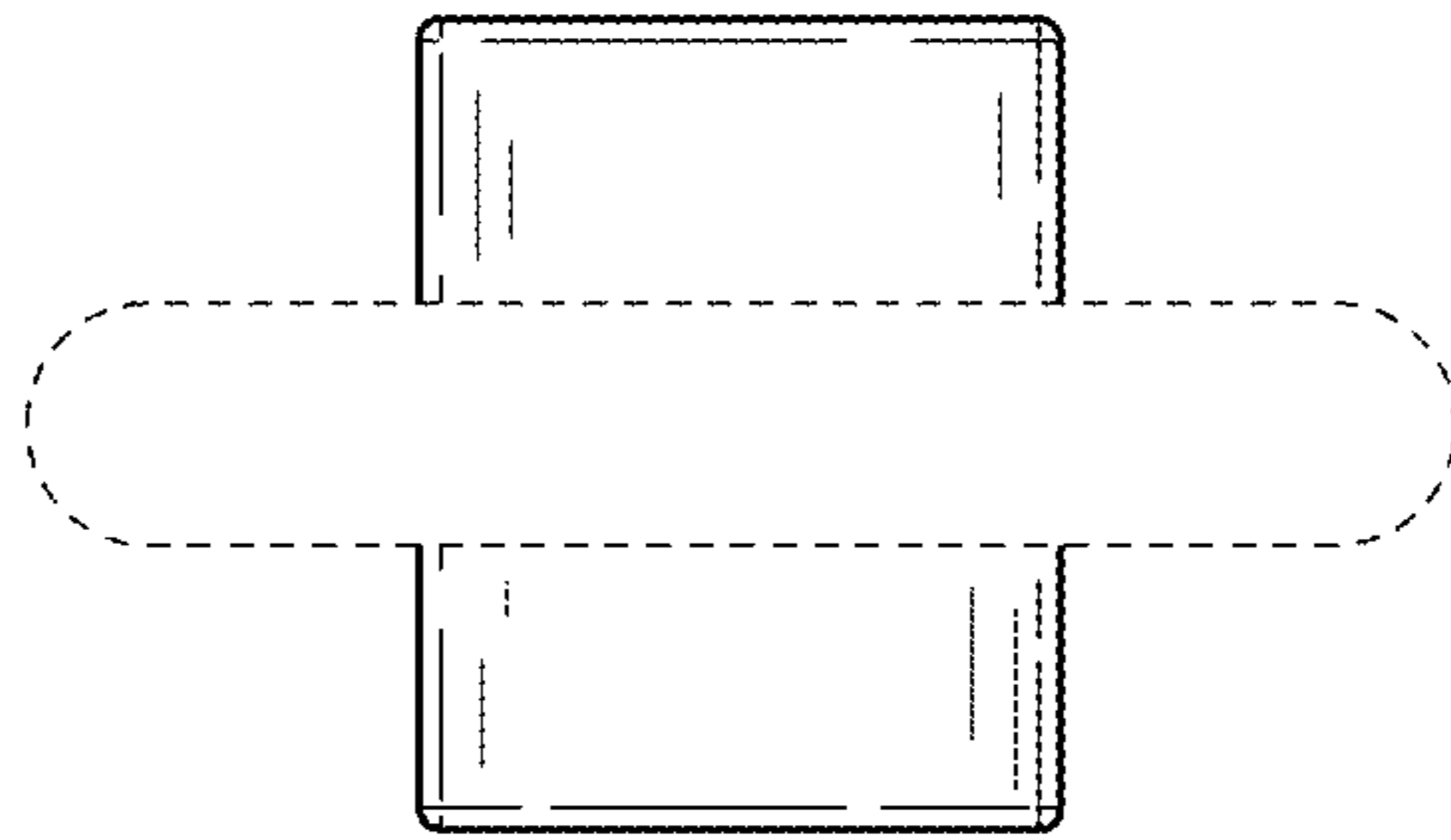

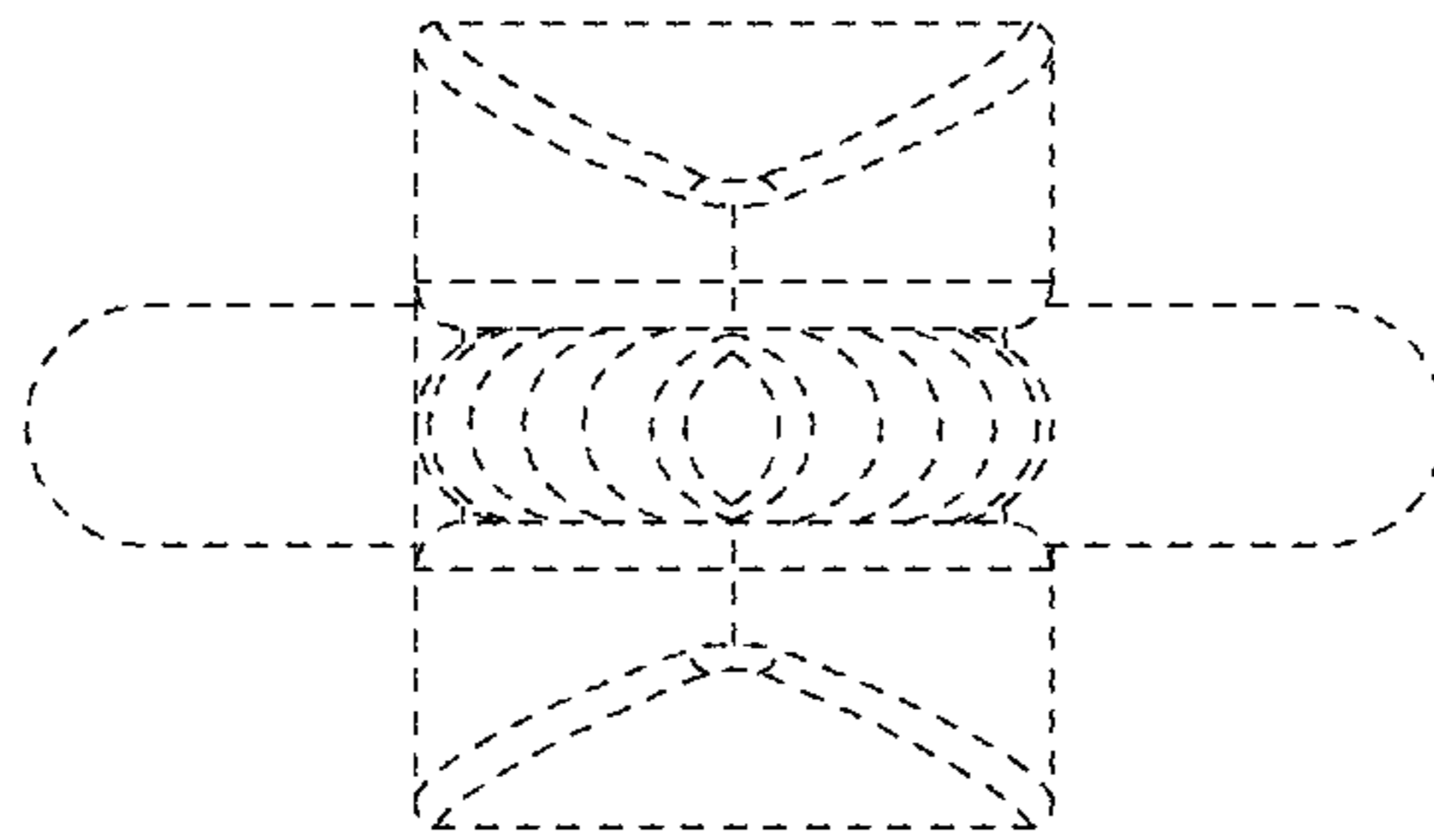

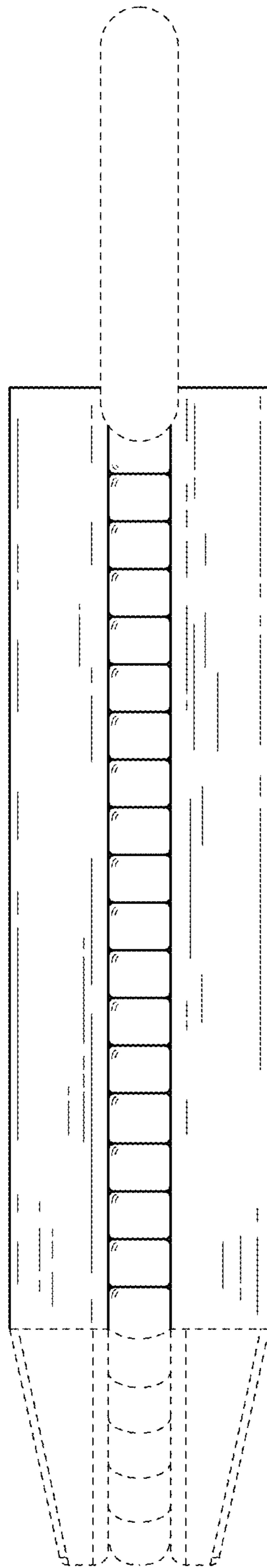

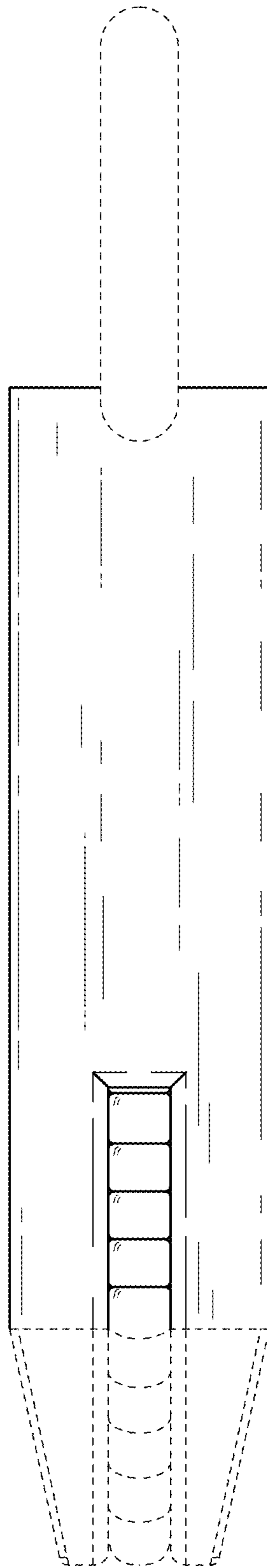

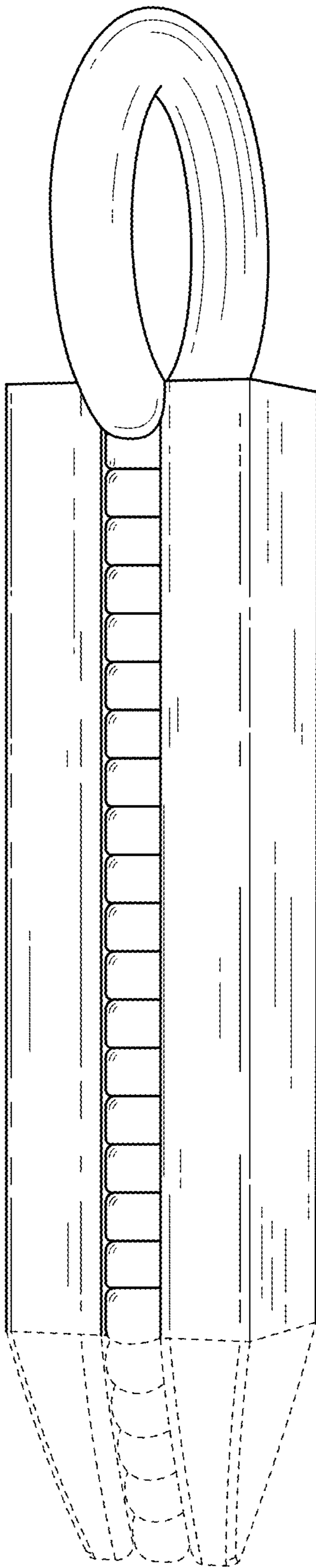

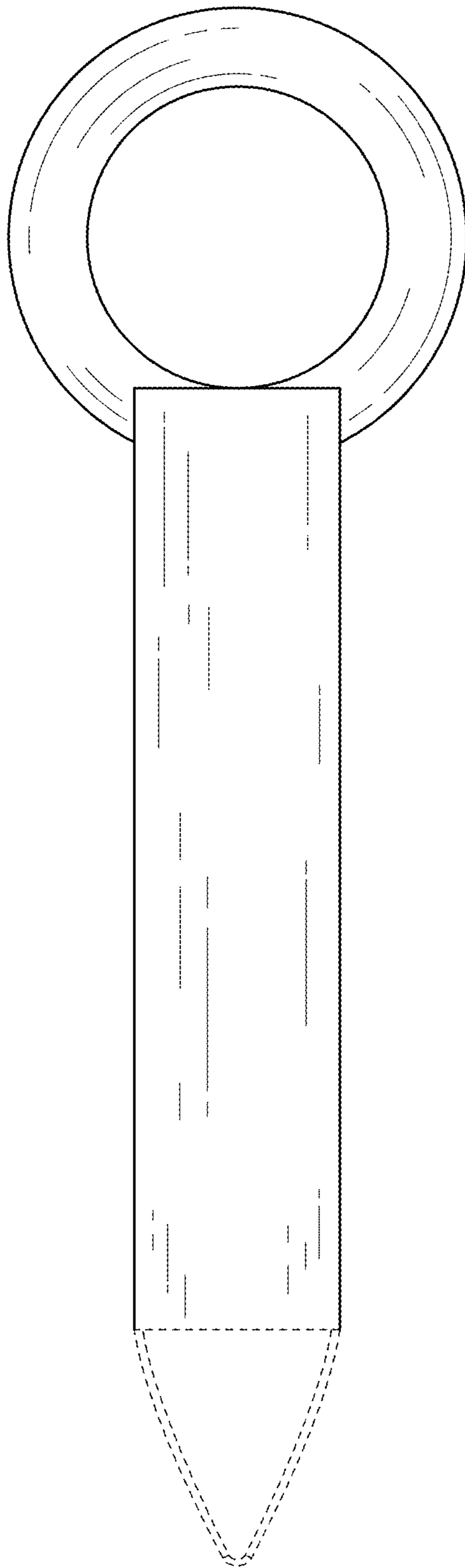

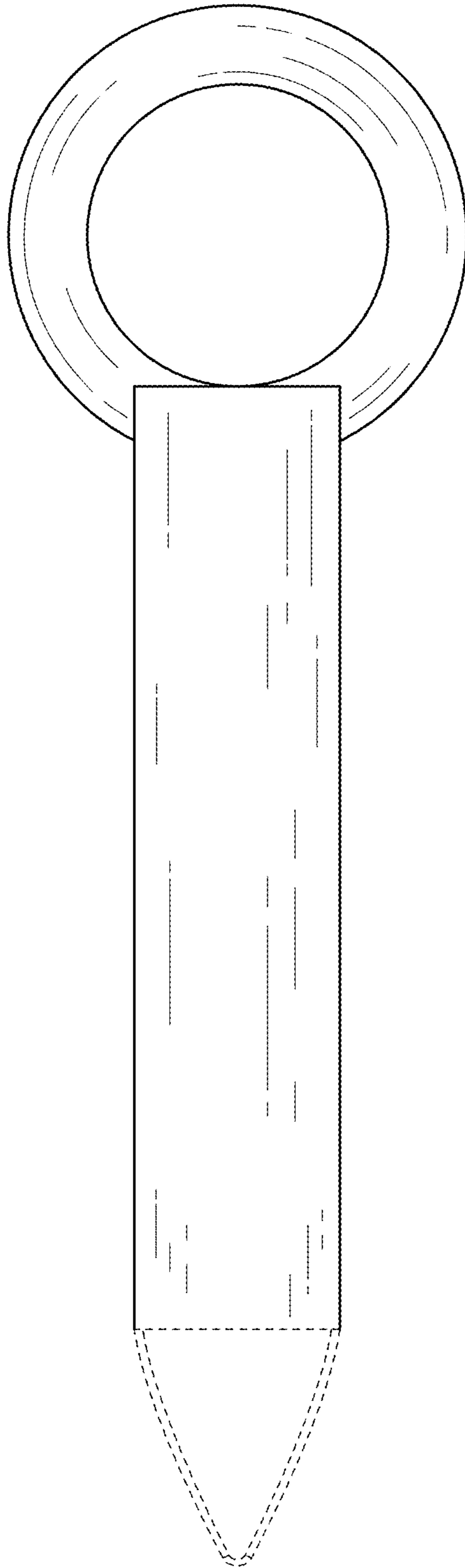

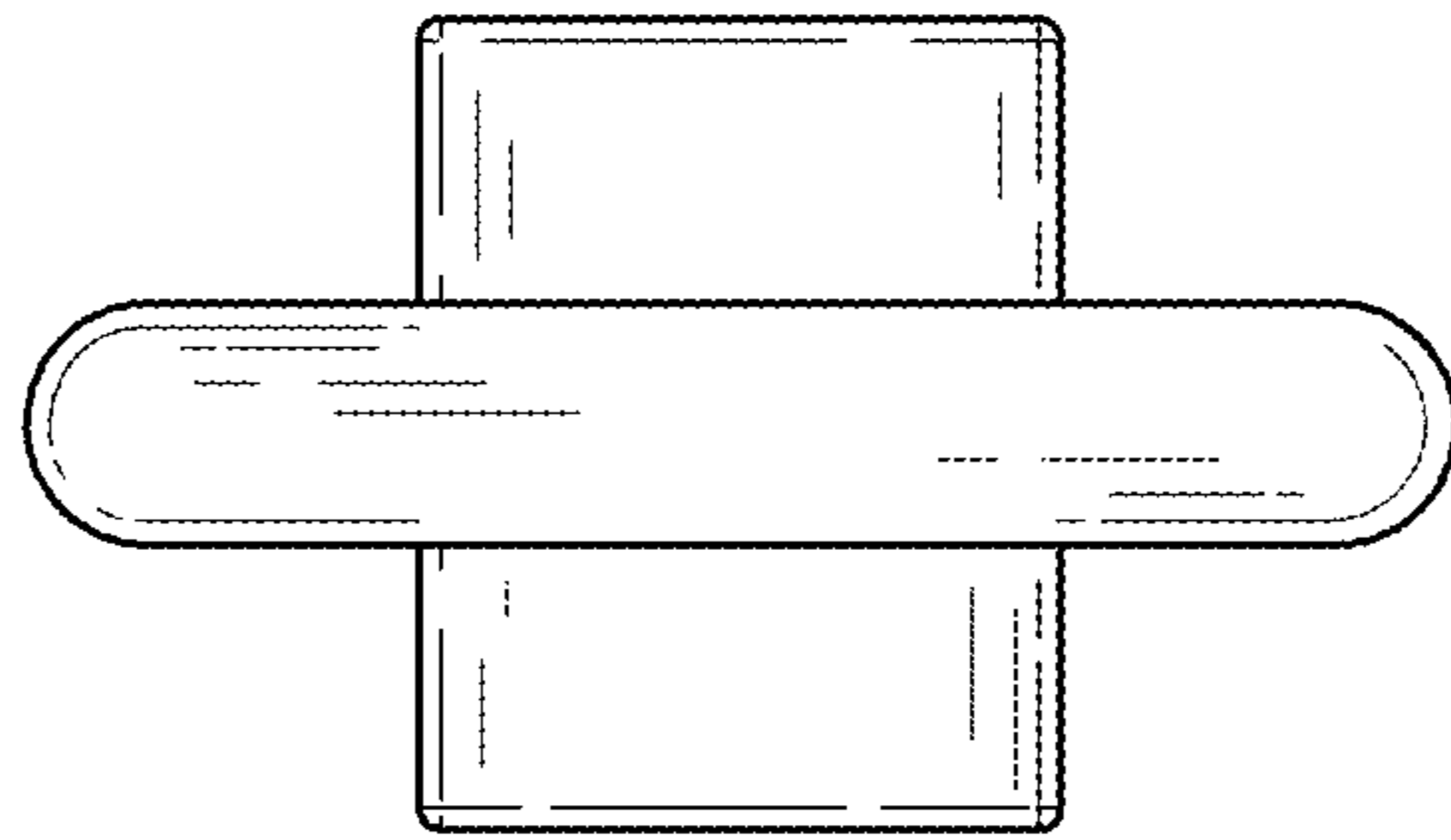

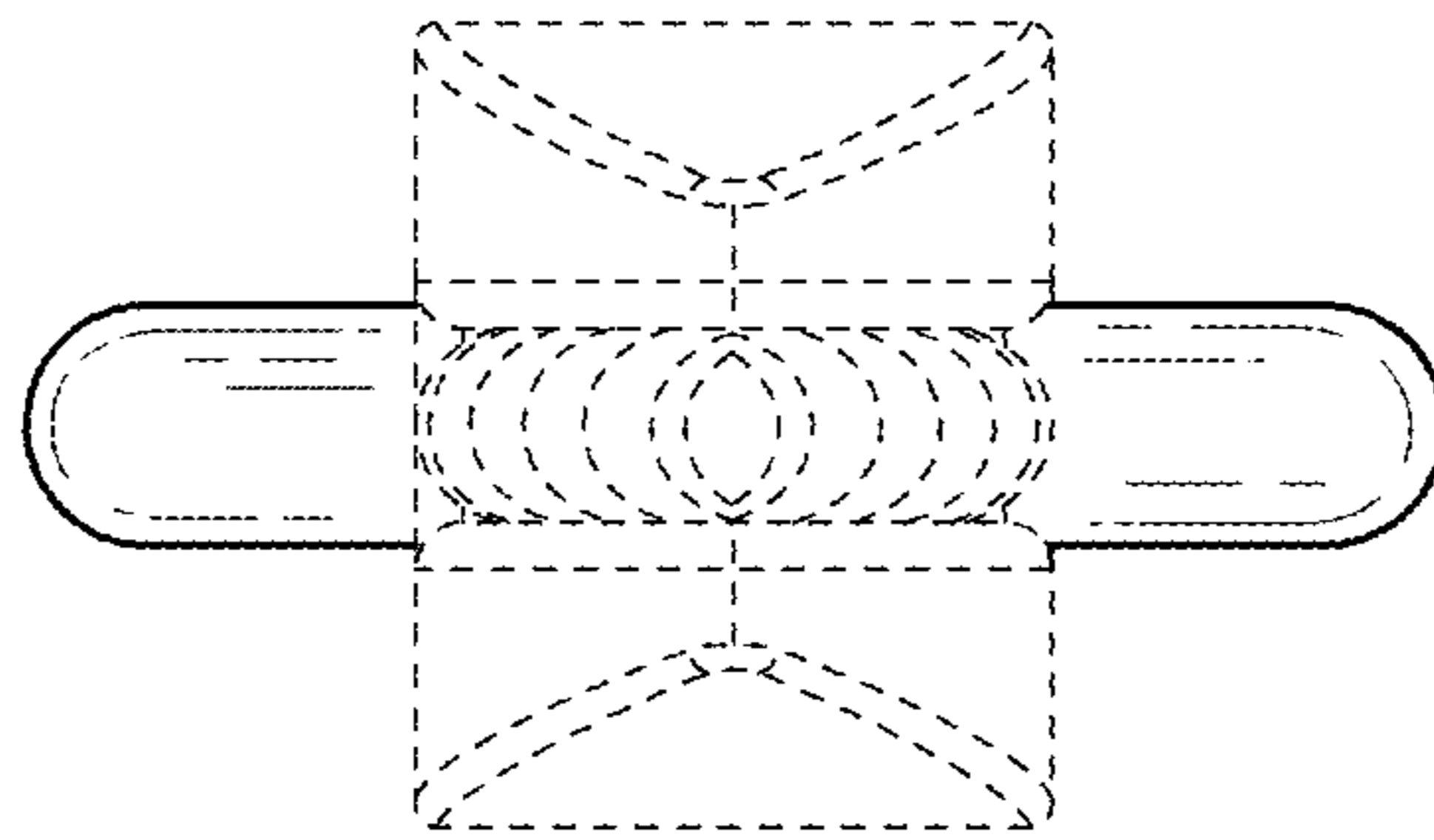

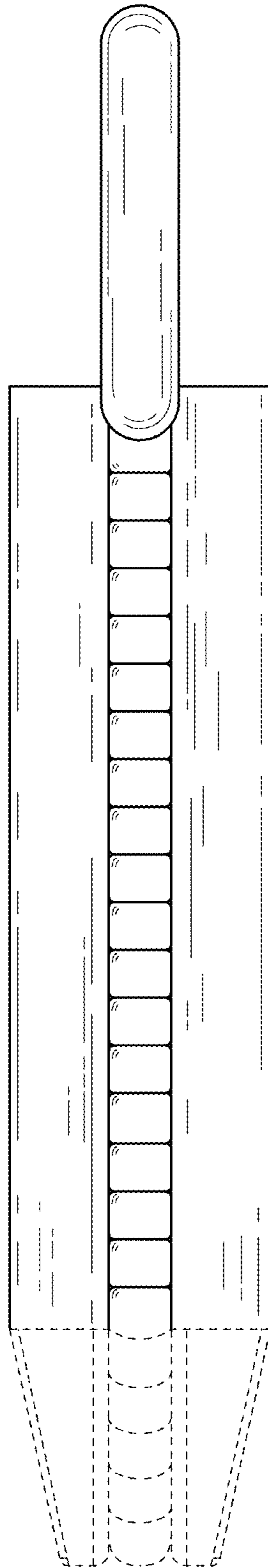

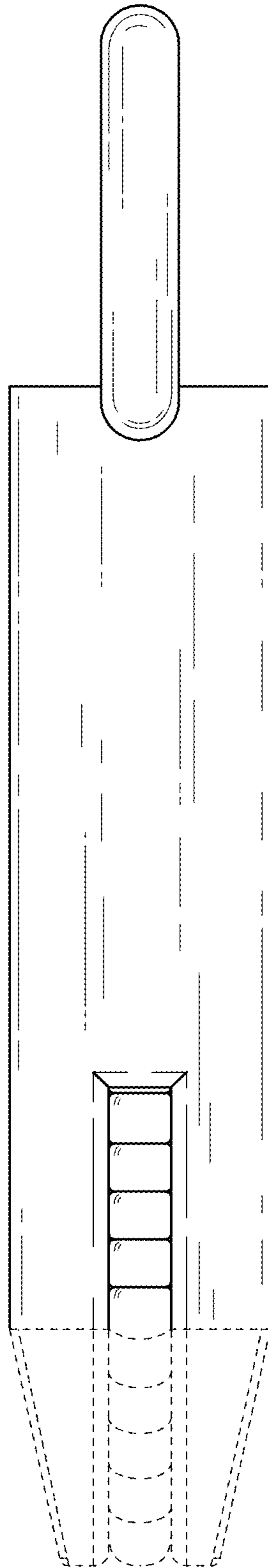
