(57) **CLAIM**

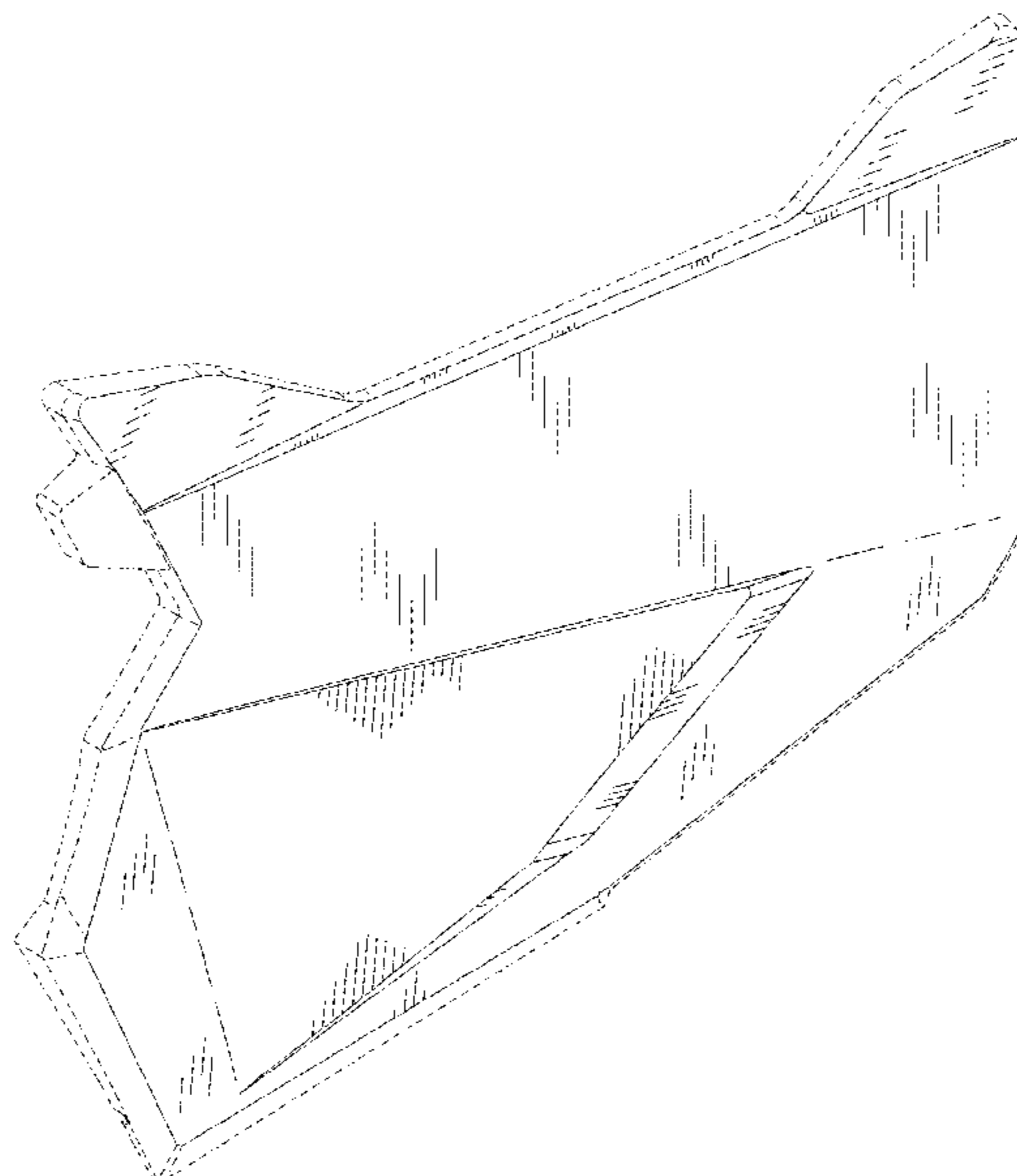
We claim the ornamental design for a door for an off-road vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a door for an off-road vehicle of the present application;
FIG. 2 is an exterior side view of the door of FIG. 1;
FIG. 3 is an interior side view of the door of FIG. 1;
FIG. 4 is a top view of the door of FIG. 1;
FIG. 5 is a bottom view of the door of FIG. 1;
FIG. 6 is a front view of the door of FIG. 1; and,
FIG. 7 is a rear view of the door of FIG. 1.
The portions of the door for an off-road vehicle shown in broken lines form no part of the claimed design.

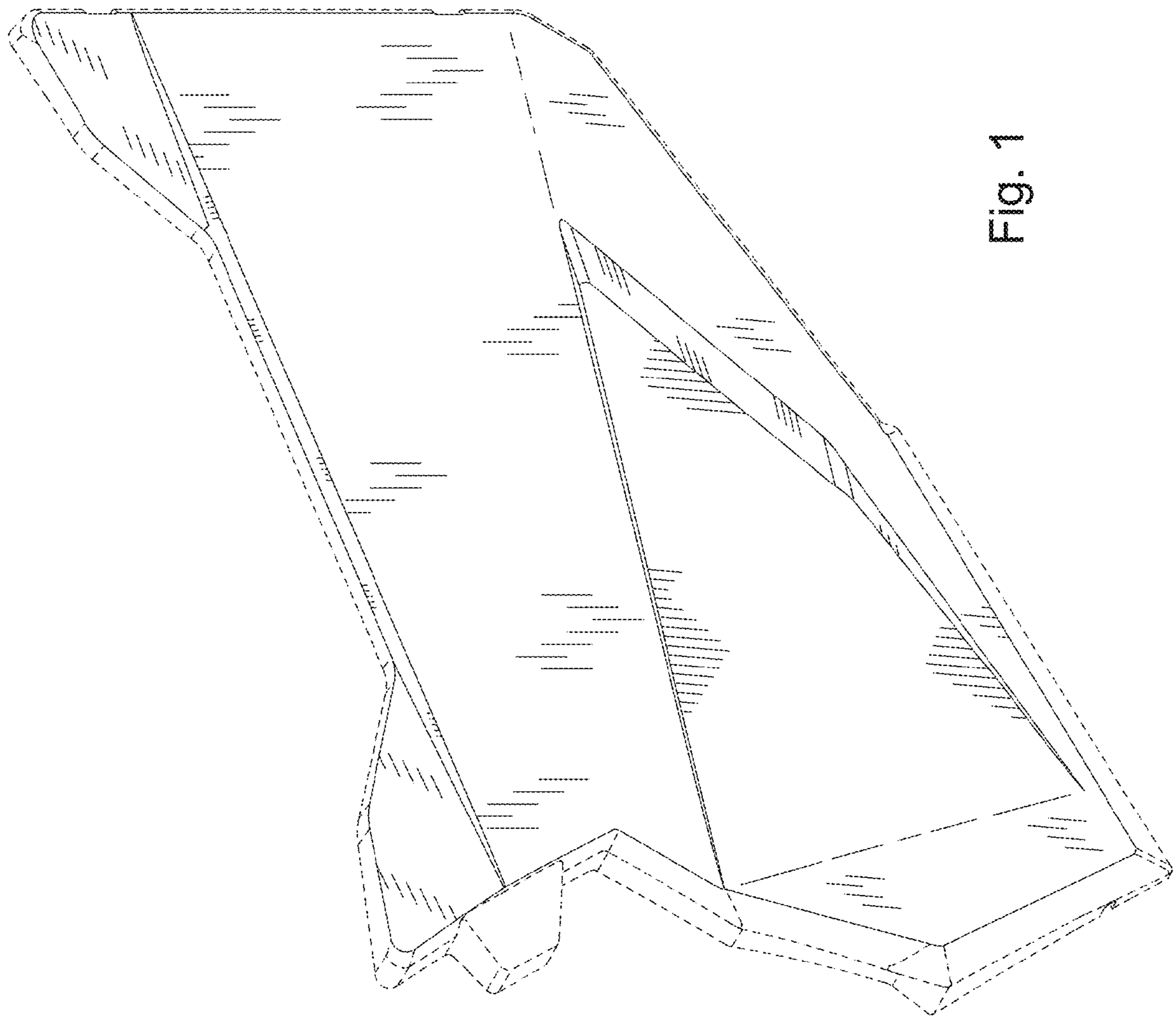

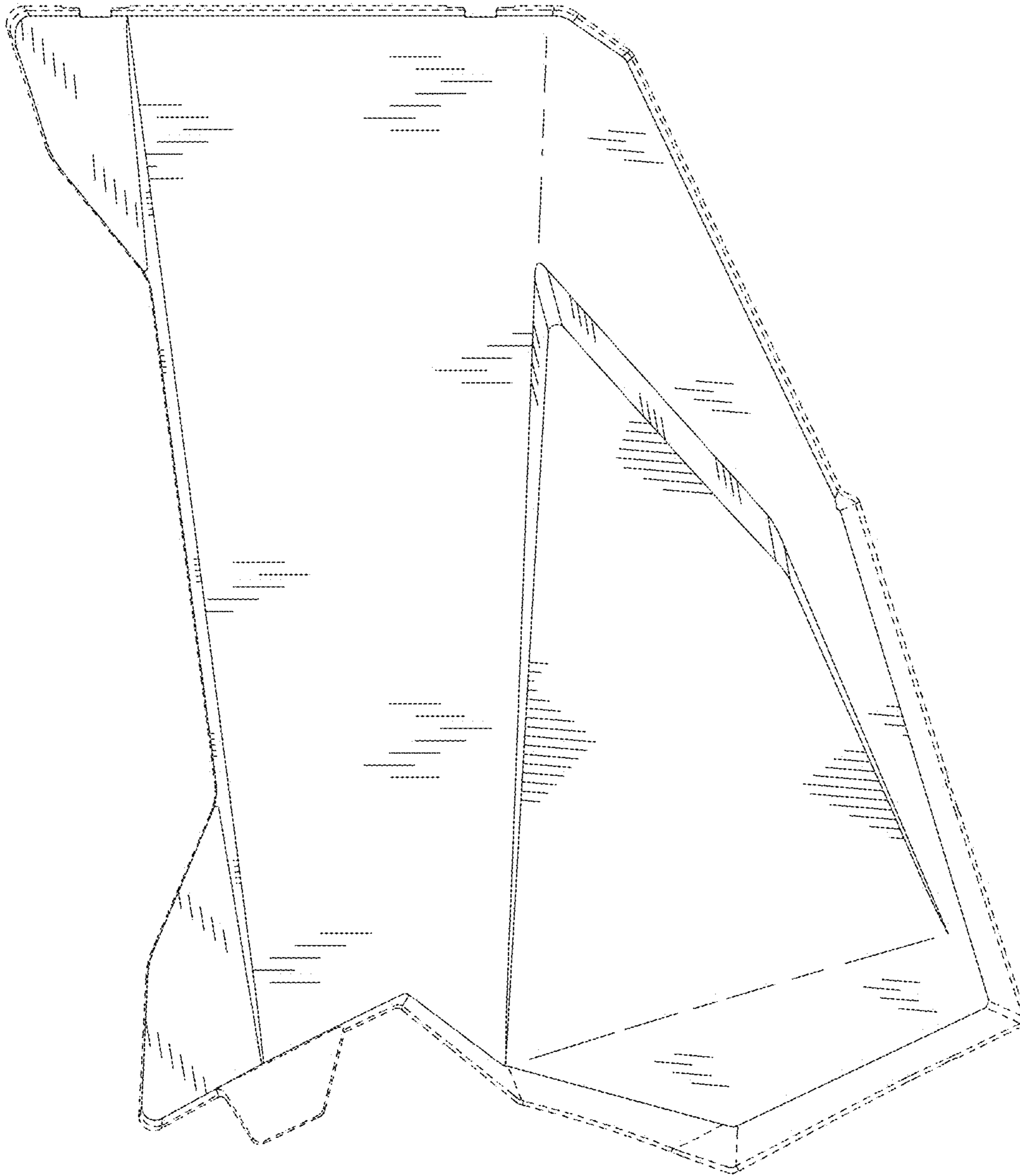

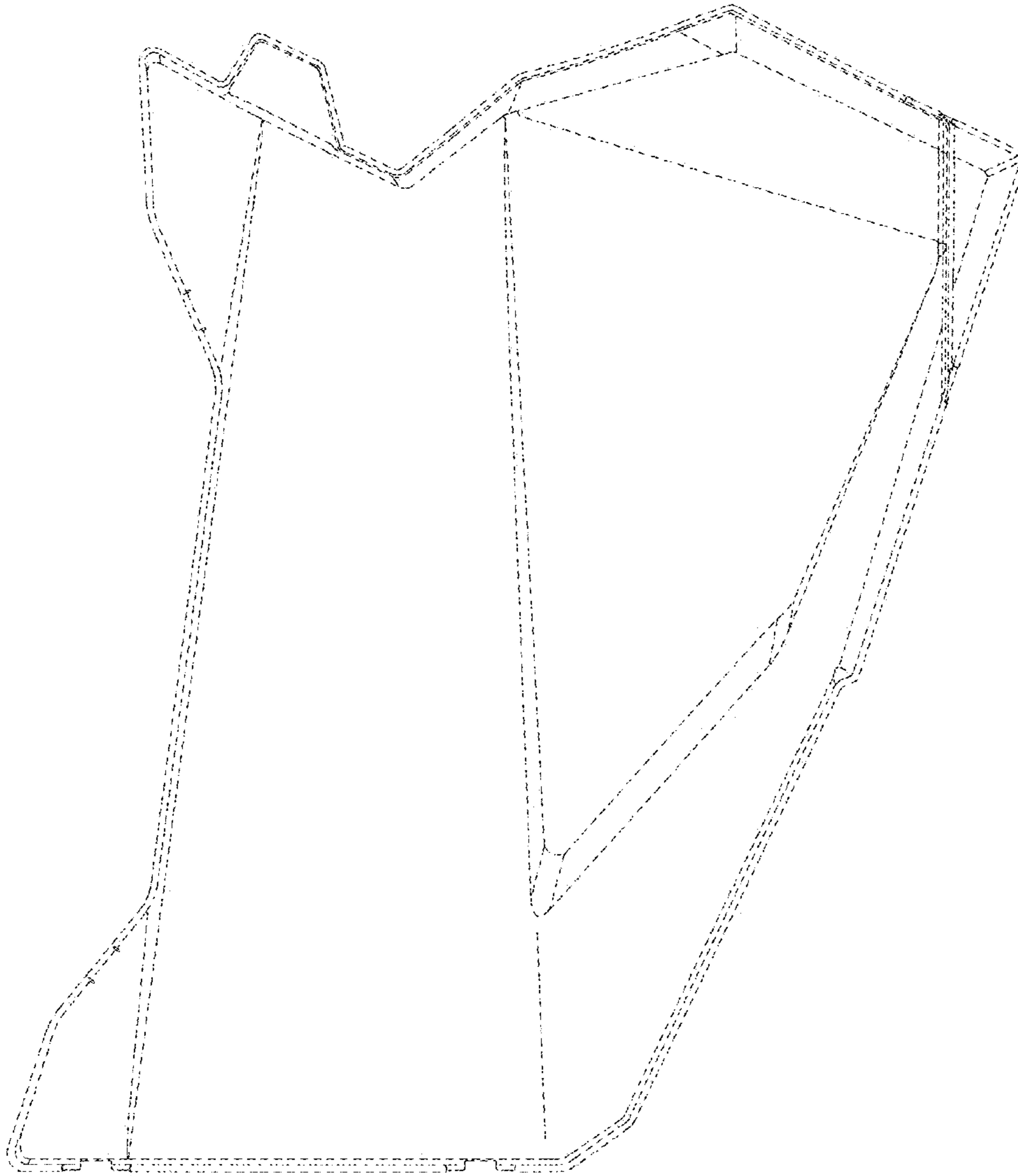

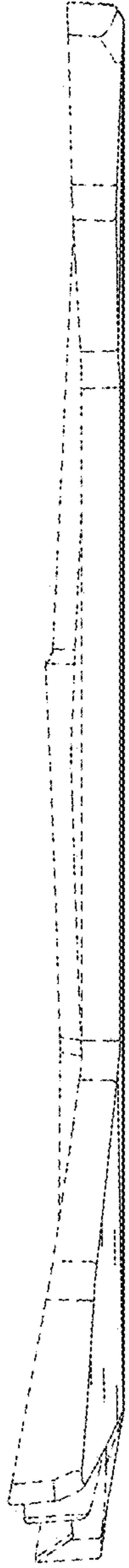

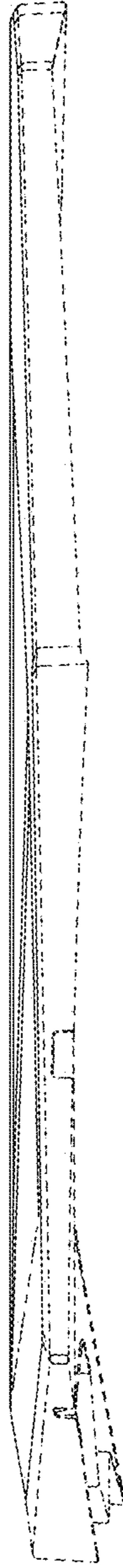

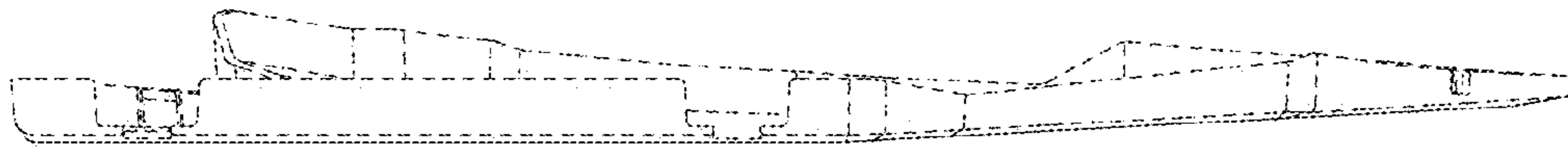

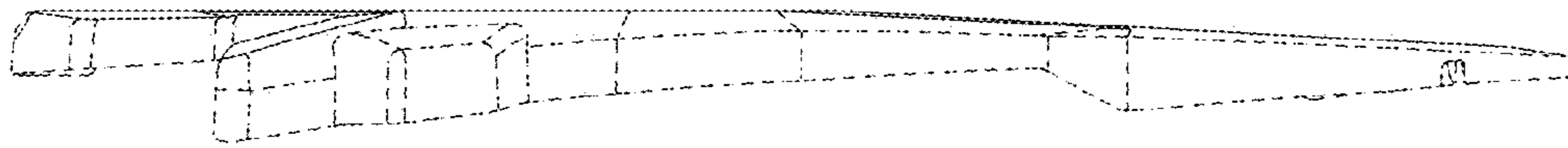
