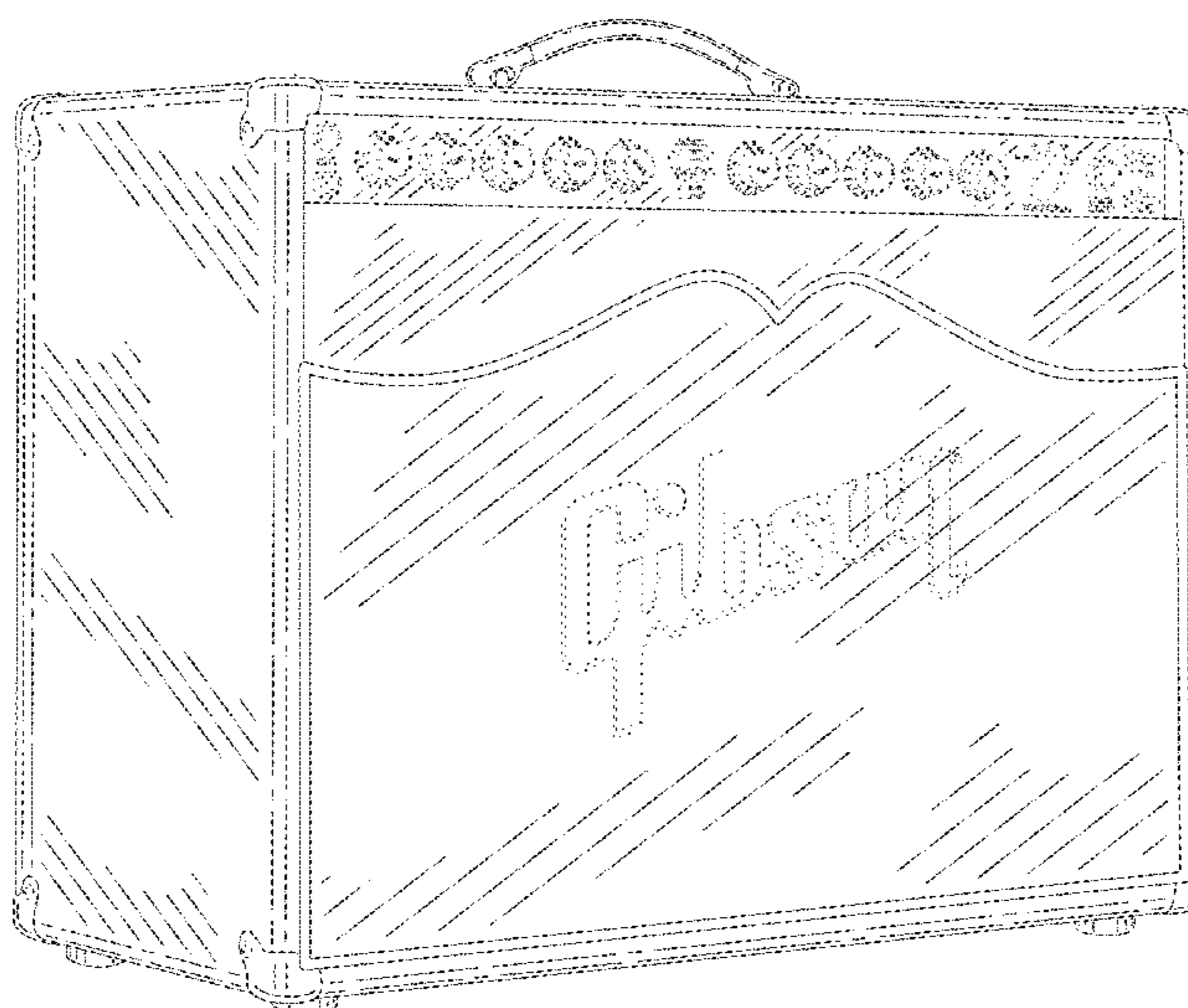
(57) **CLAIM**

What is claimed is the ornamental design for an amplifier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an amplifier;
 FIG. 2 is a right side view of the amplifier;
 FIG. 3 is a left side view of the amplifier;
 FIG. 4 is a front view of the amplifier;
 FIG. 5 is a back view of the amplifier;
 FIG. 6 is a top view of the amplifier; and,
 FIG. 7 is a bottom view of the amplifier.
 The broken lines shown in the figures depict the portions of the amplifier that form no part of the claimed design.

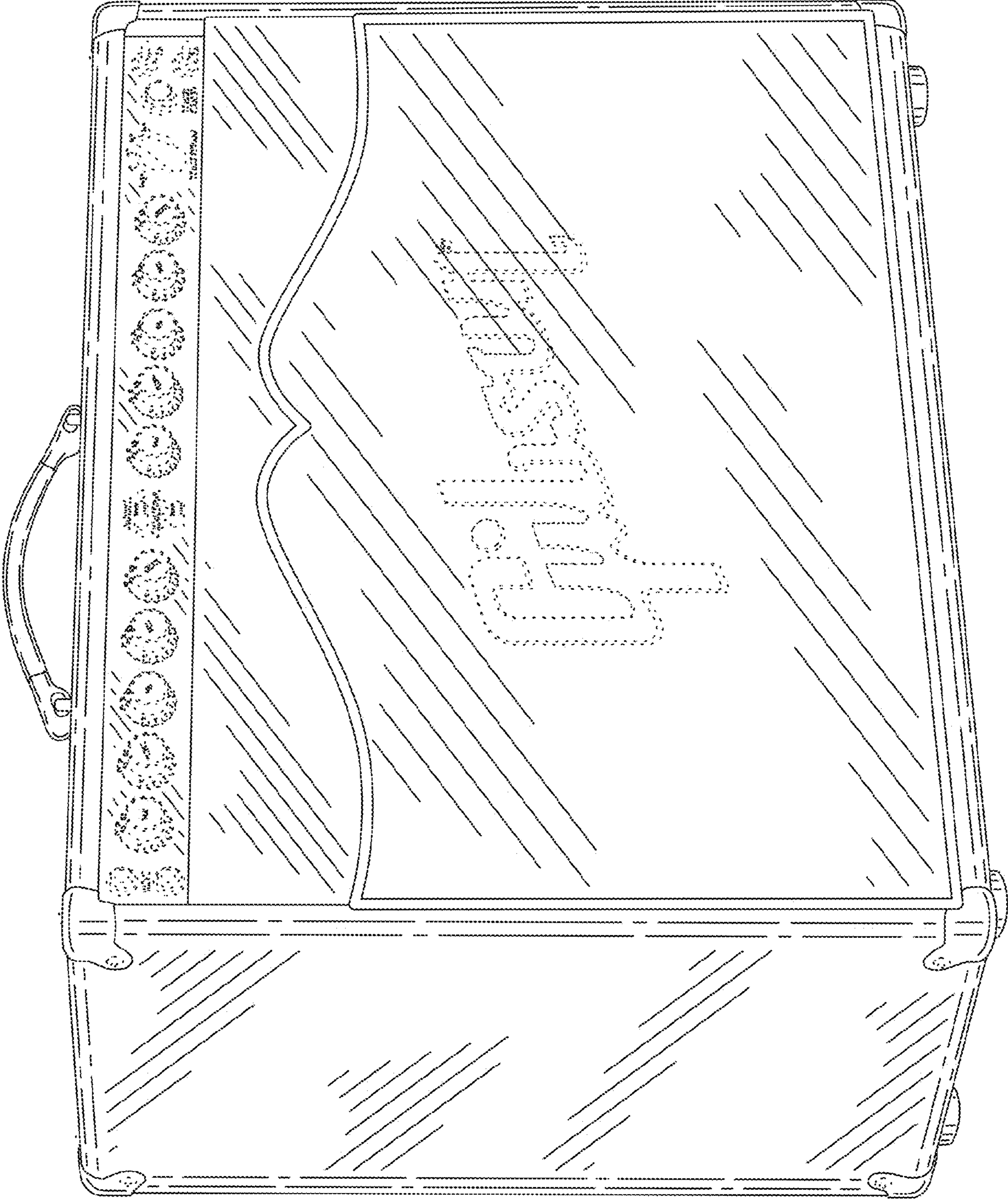

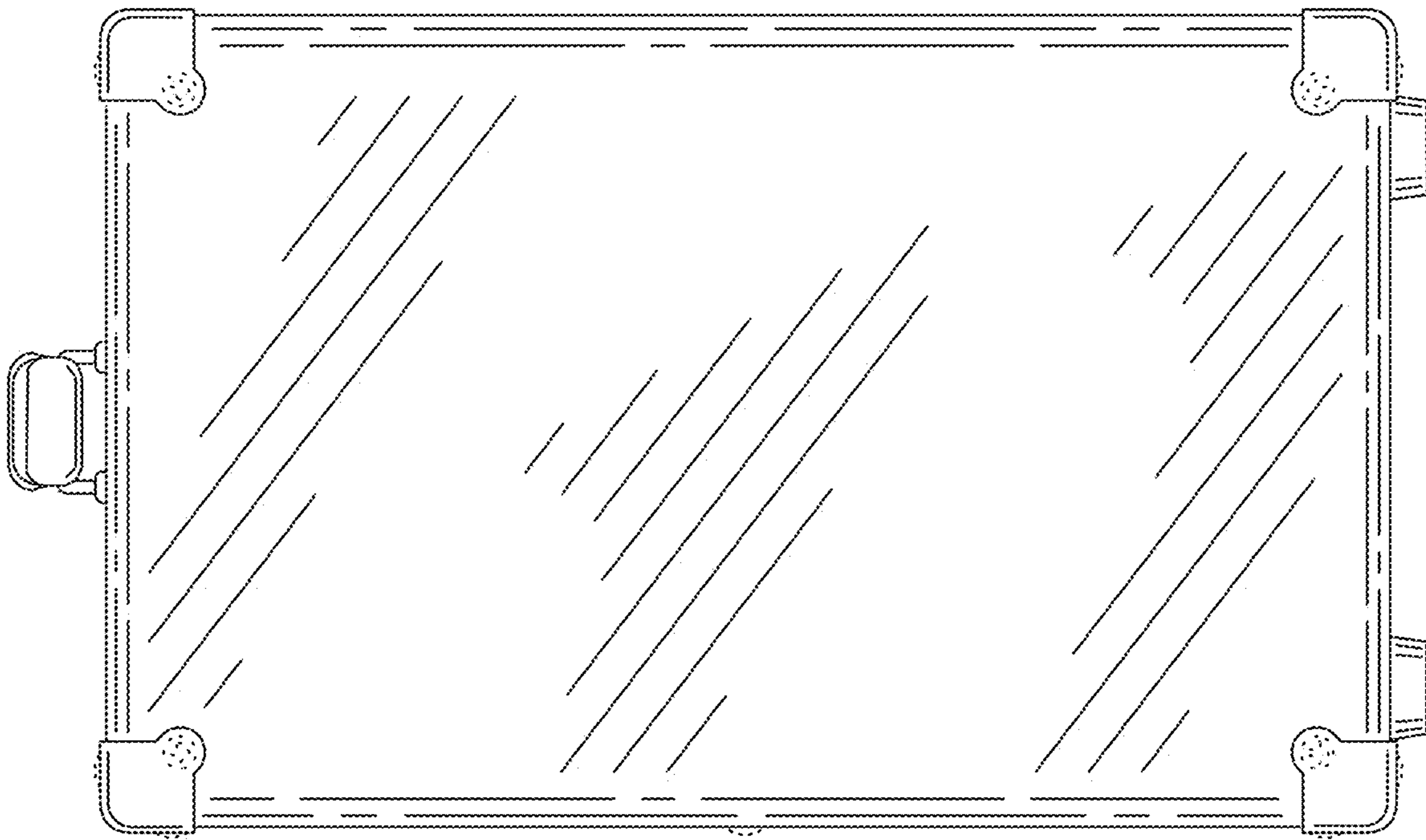

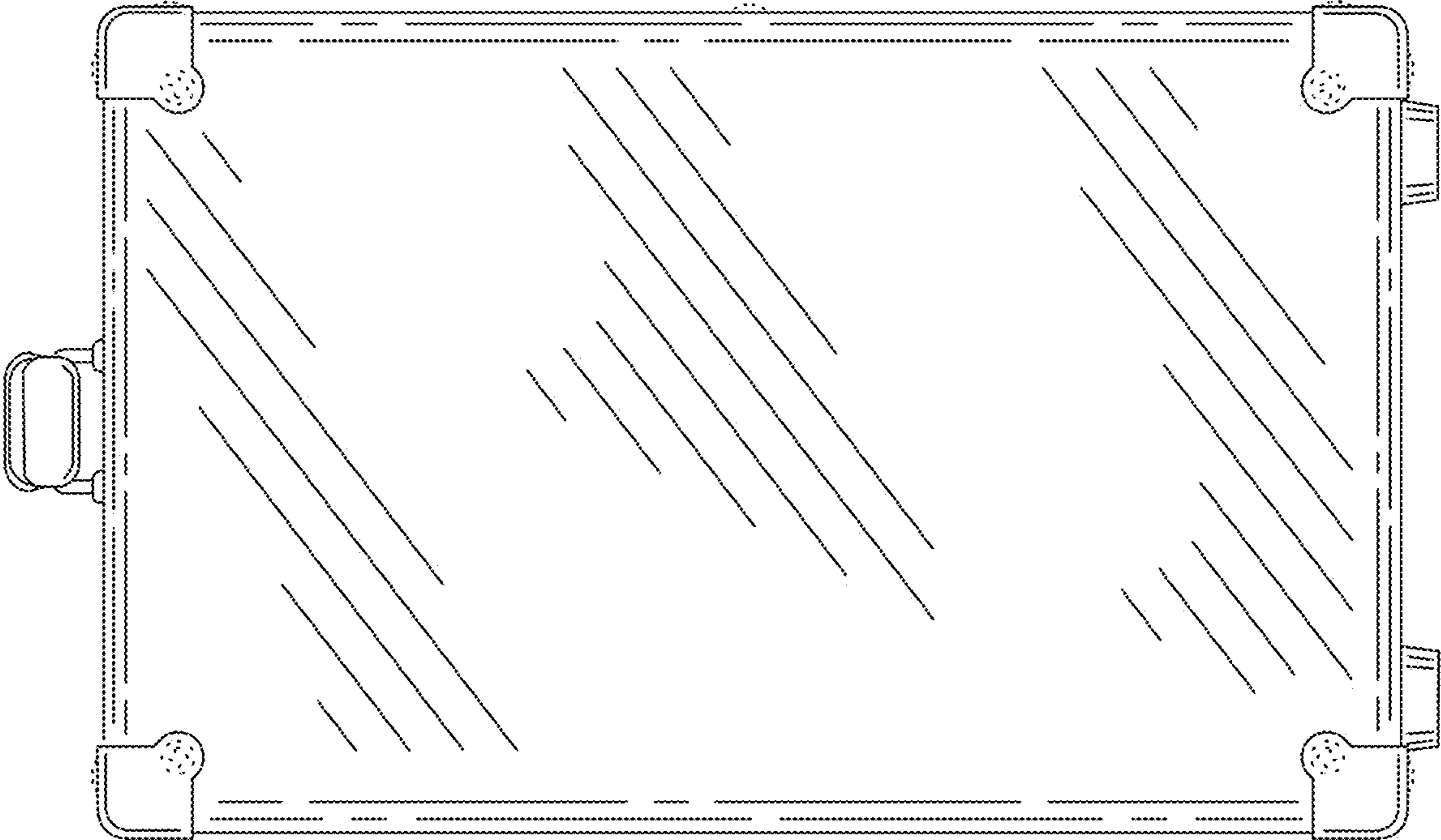

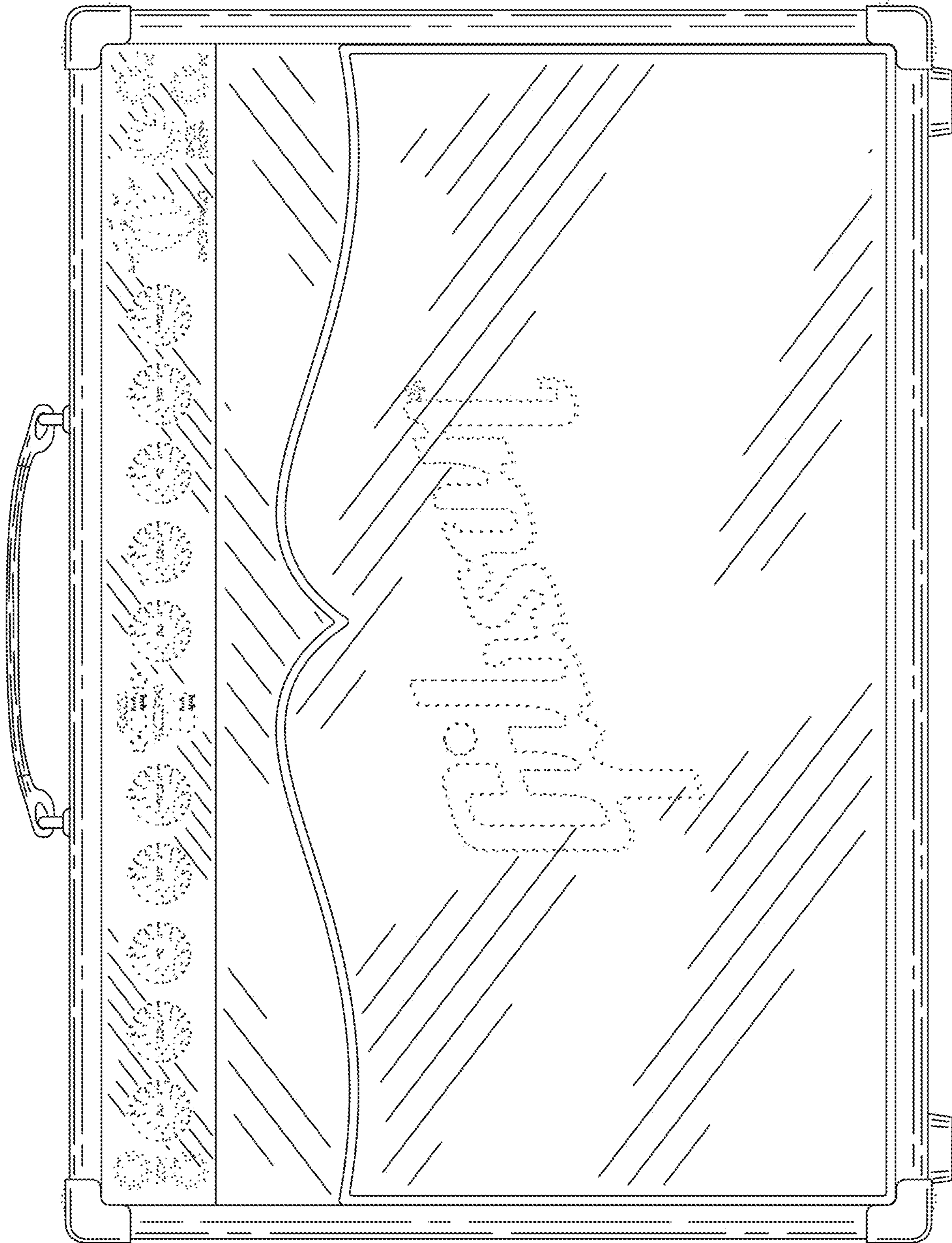

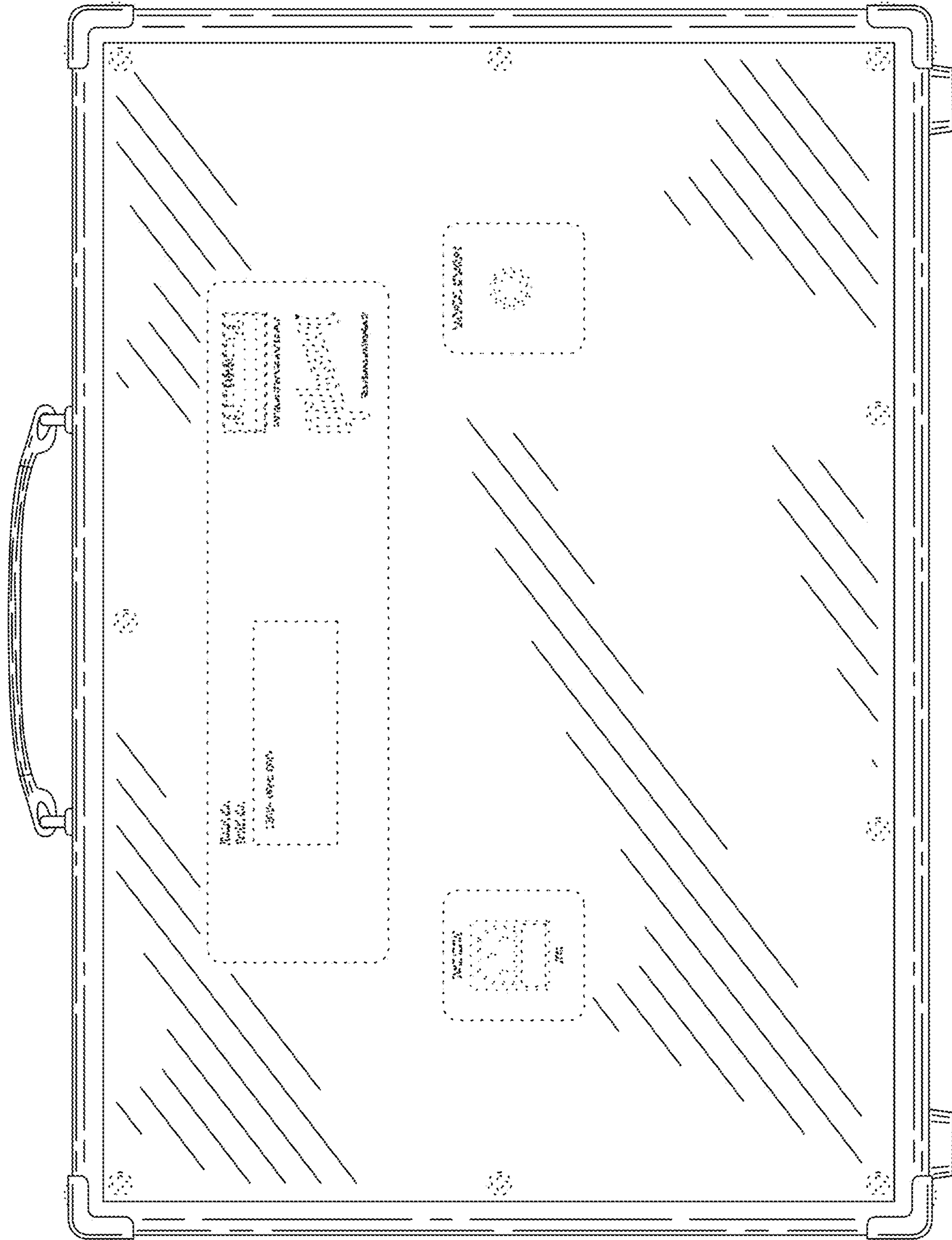

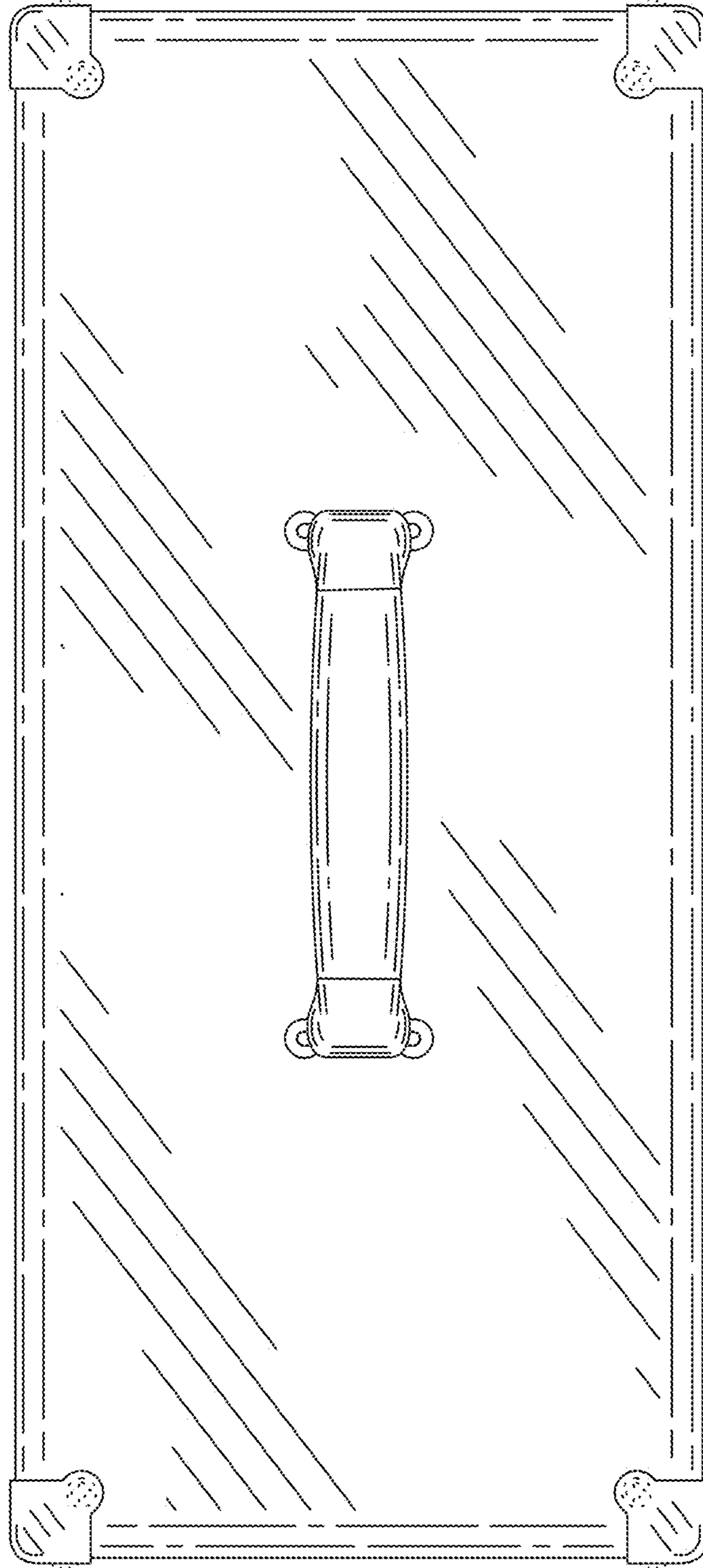

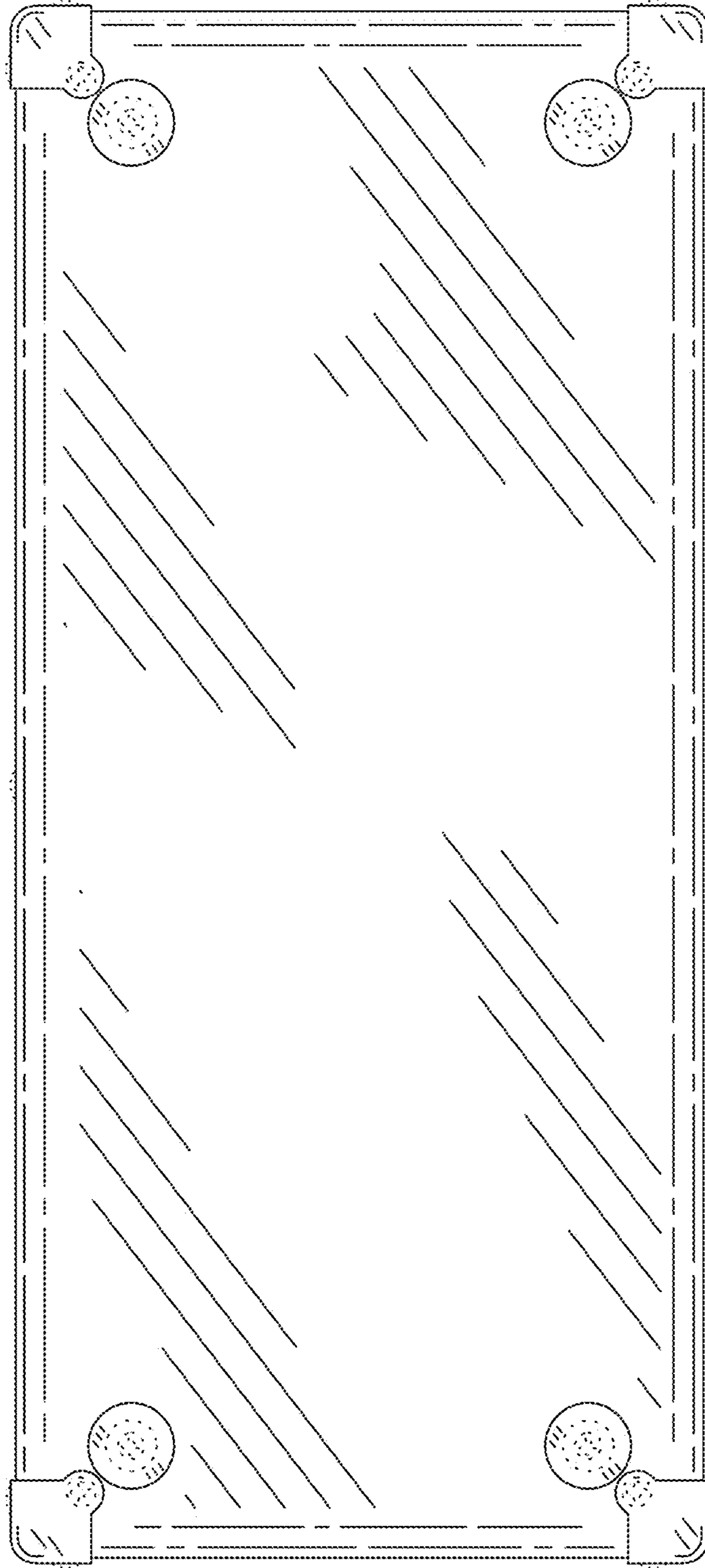
