DESCRIPTION

FIG. 1 is a front perspective view of a decorative panel showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is an enlarged view of the portion 8 delineated in FIG. 1;

FIG. 9 is an enlarged view of the portion 9 delineated in FIG. 2;

FIG. 10 is an enlarged view of the portion 10 delineated in FIG. 4; and,

FIG. 11 is an enlarged view of the portion 11 delineated in FIG. 6.
















