The ornamental design for a display screen or portion thereof with a computer icon, as shown and described.

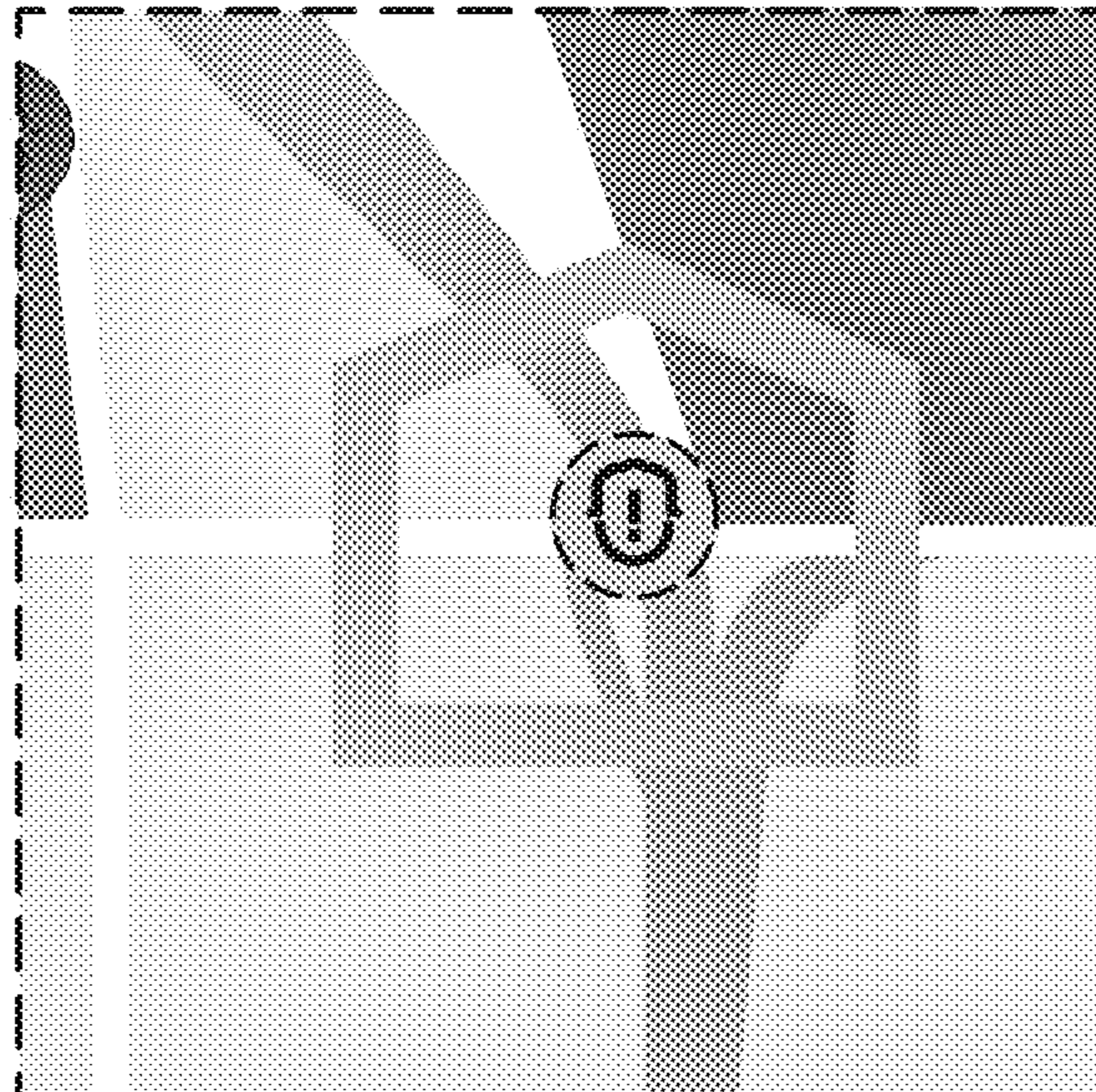
DESCRIPTION
