(57) **CLAIM**

The ornamental design for an accessory for spinning top toy, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the accessory for spinning top toy, showing the new design;

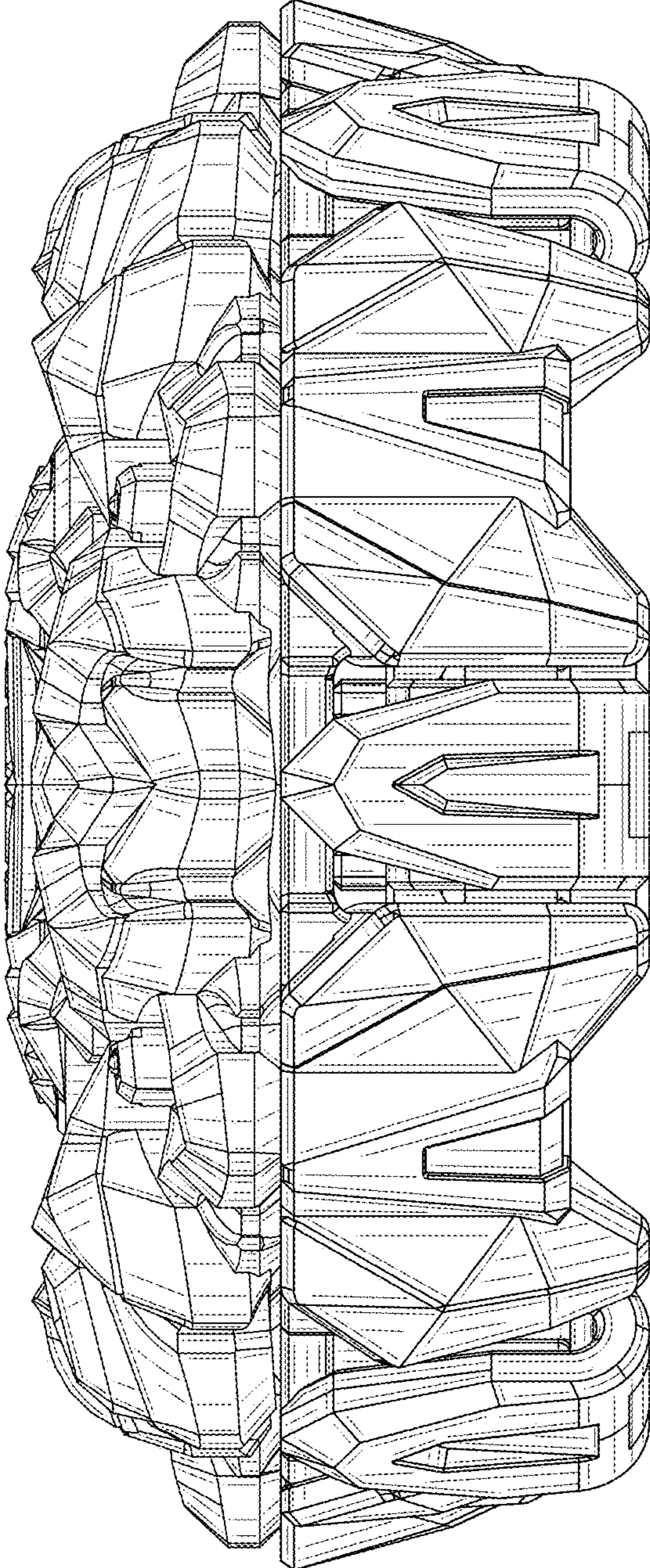

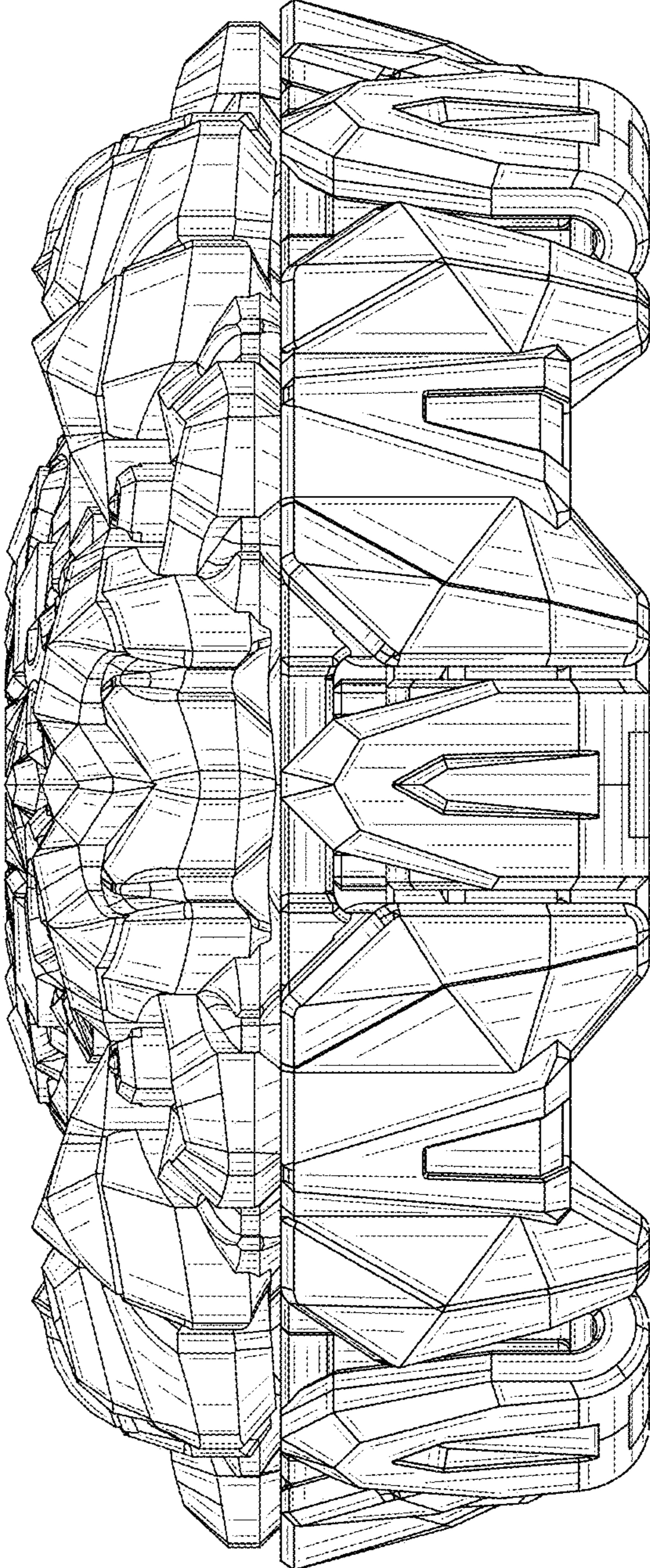

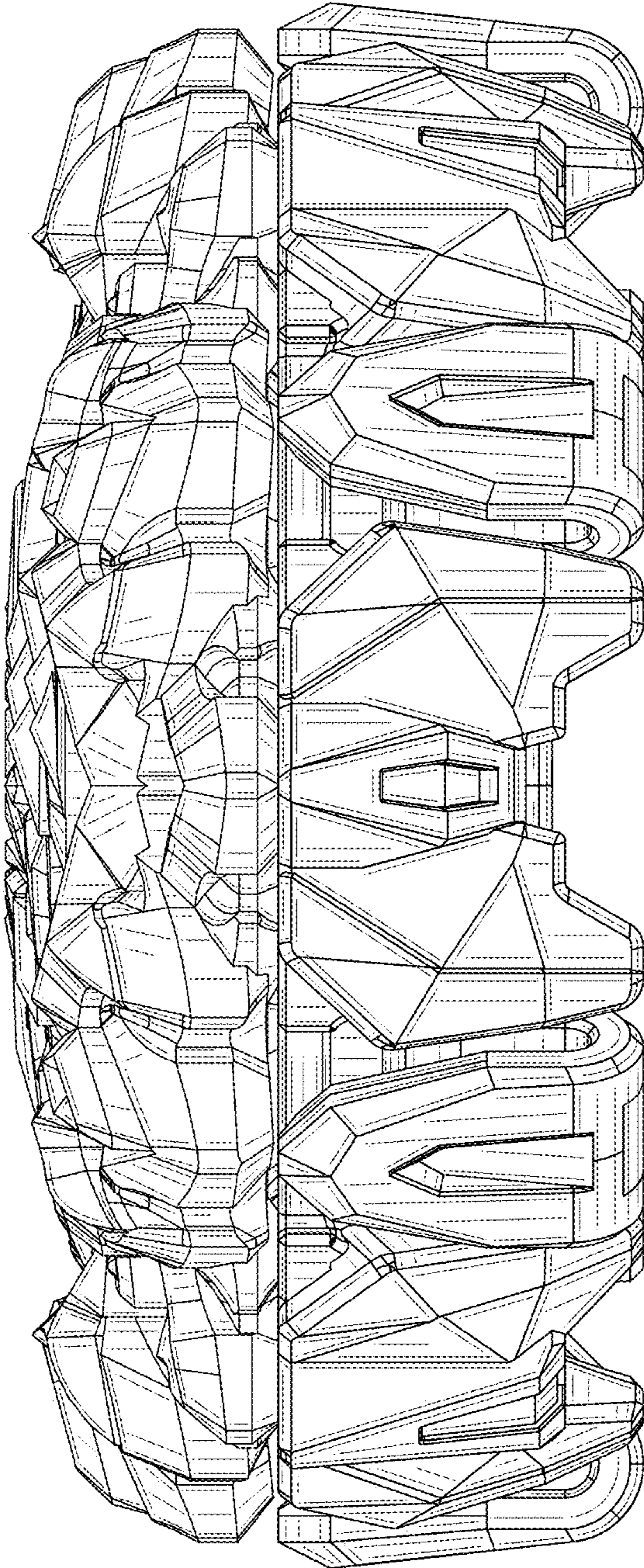

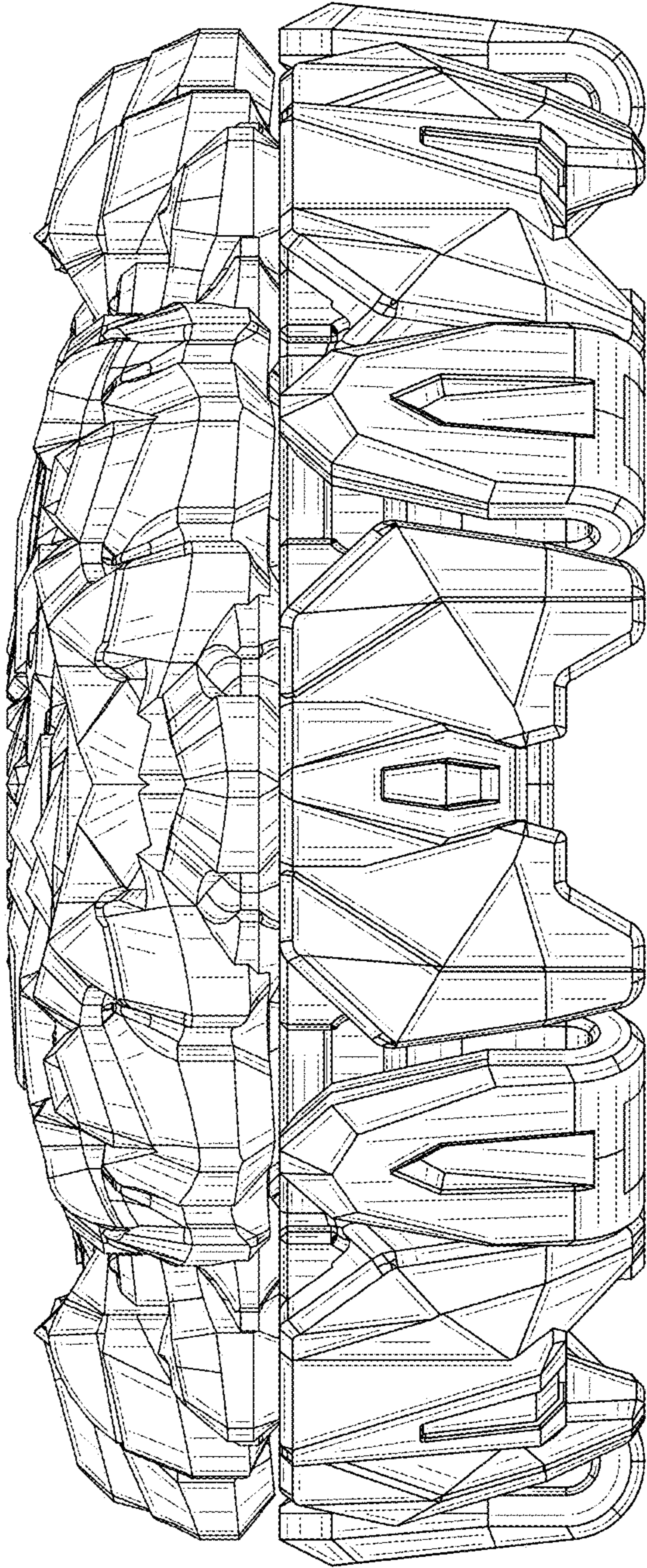

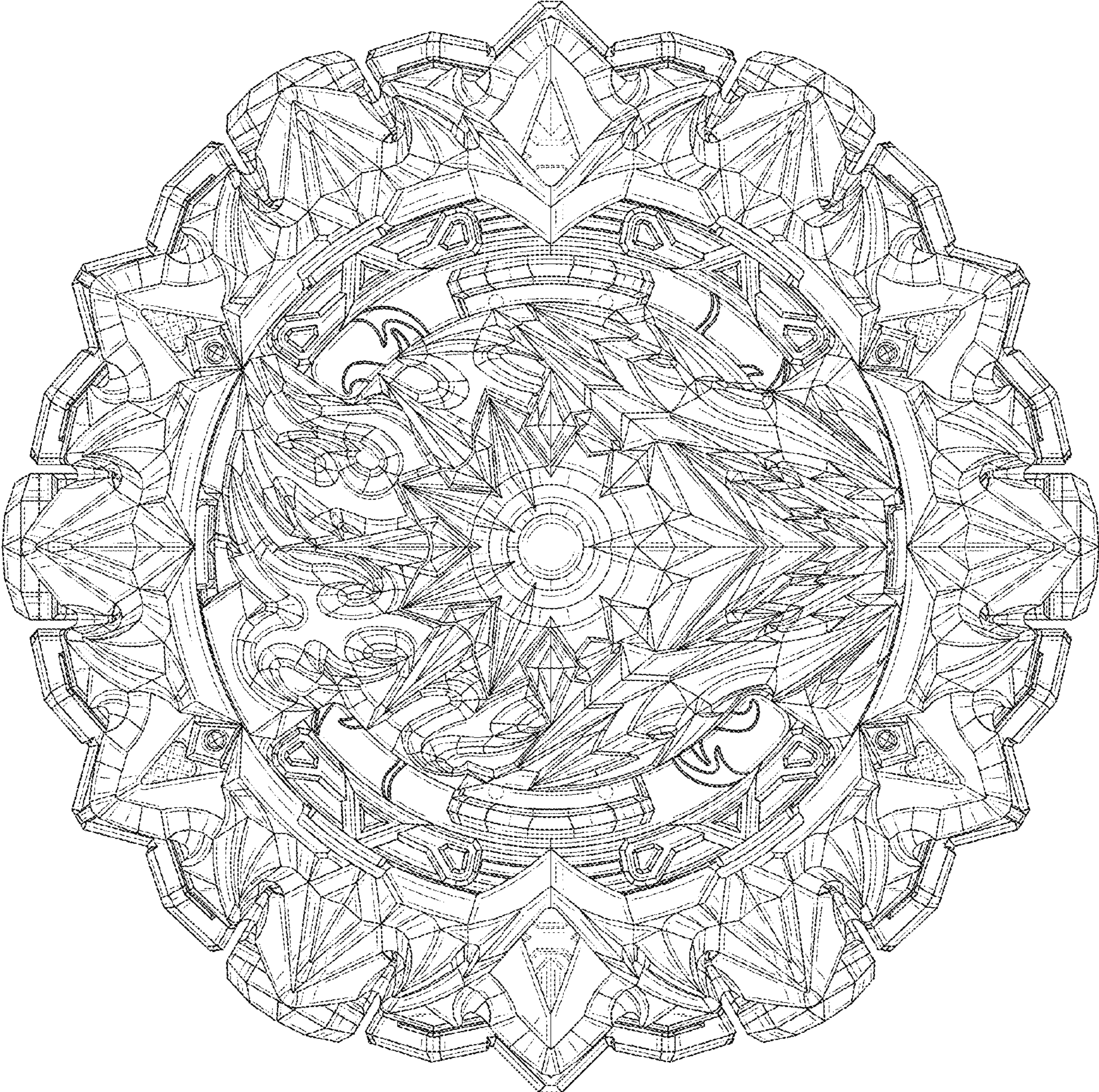

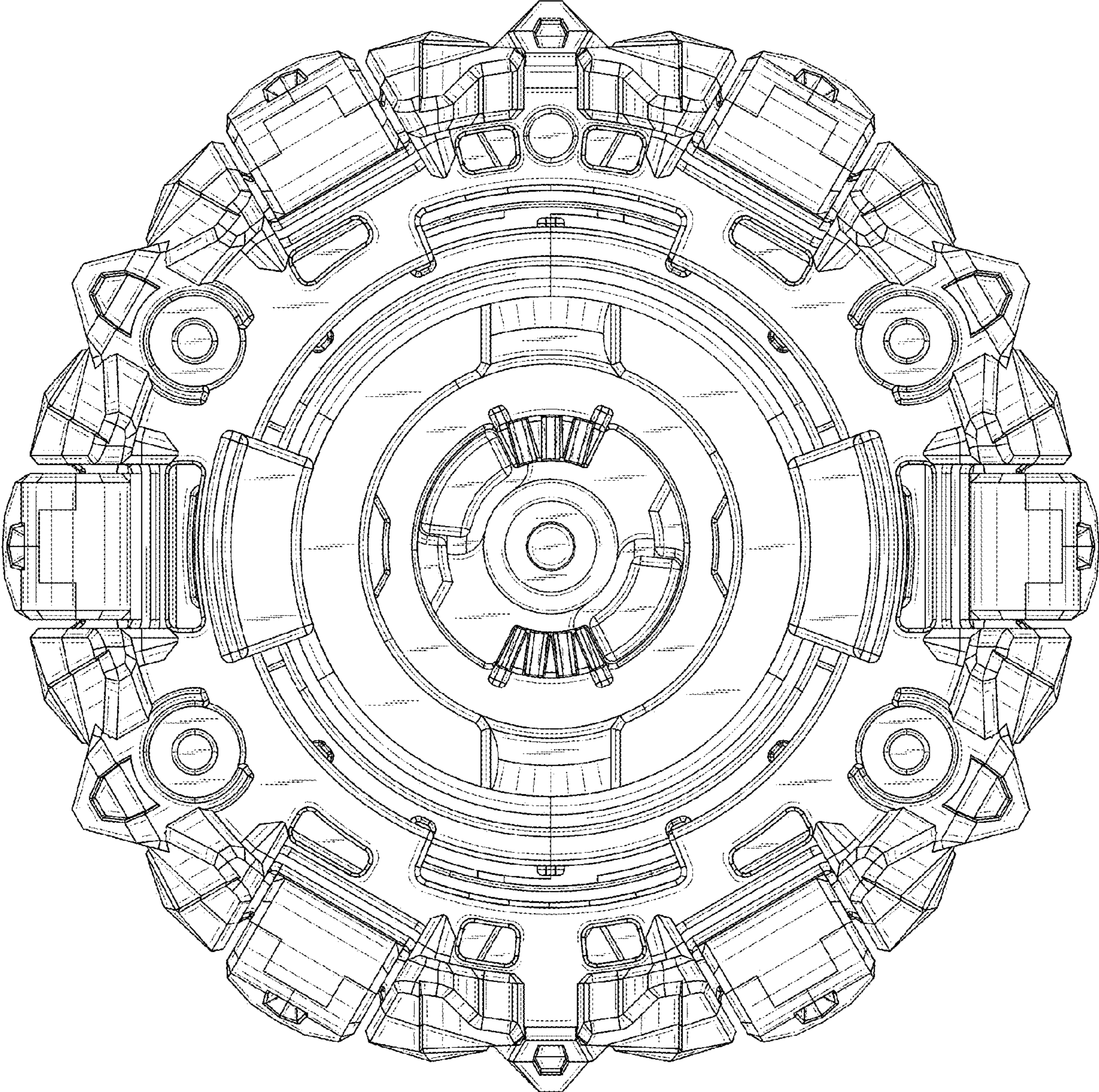

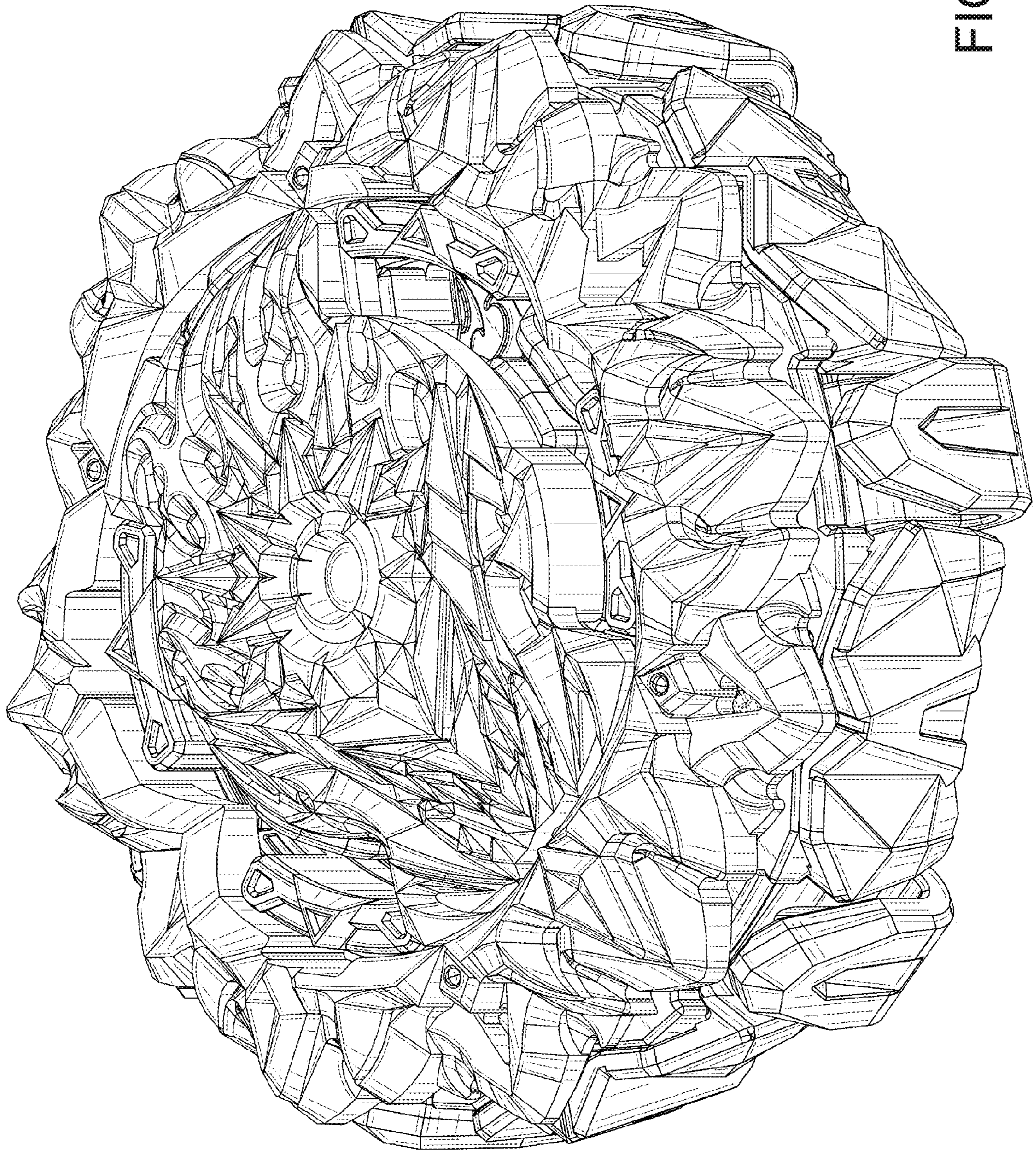

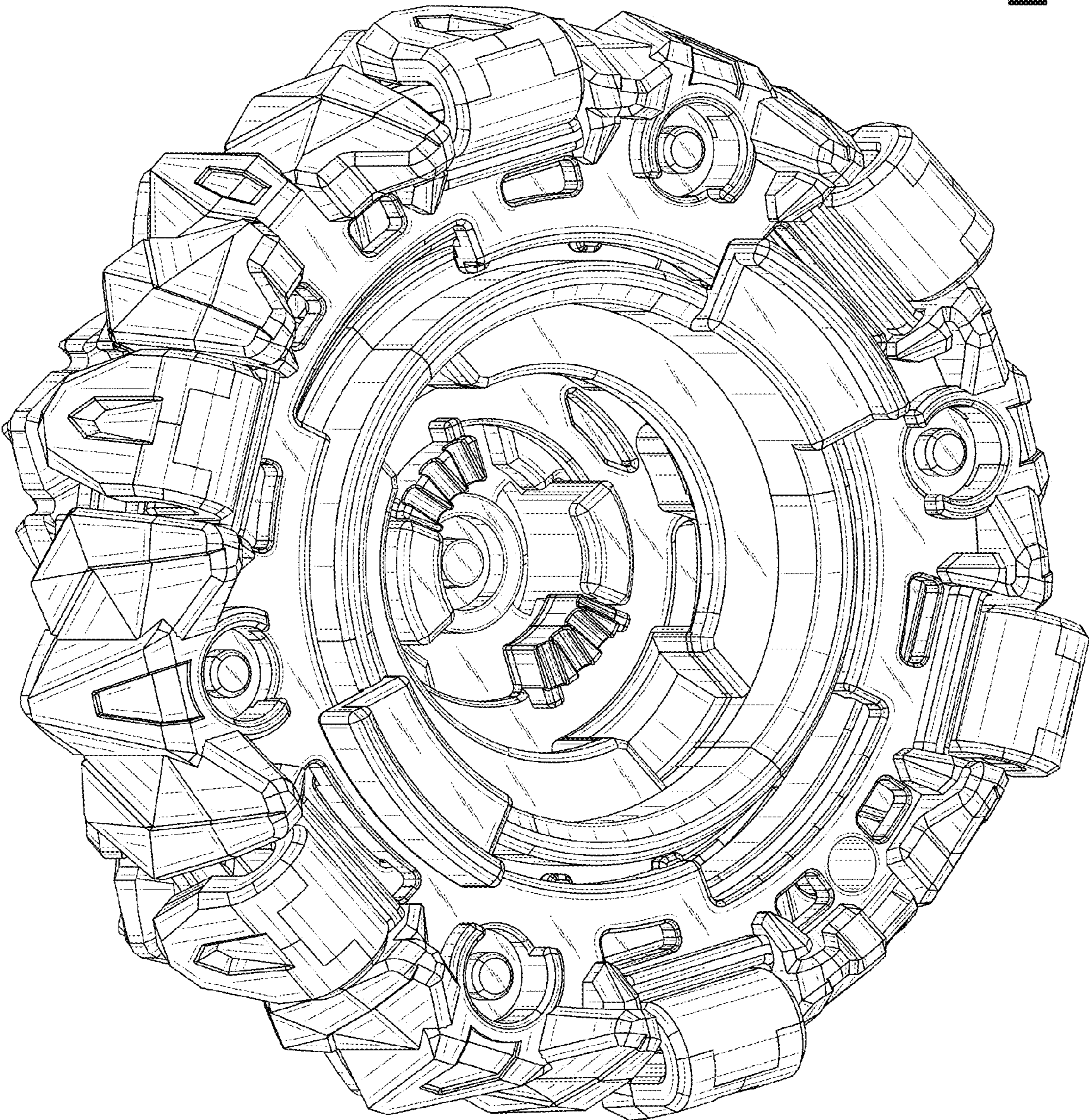

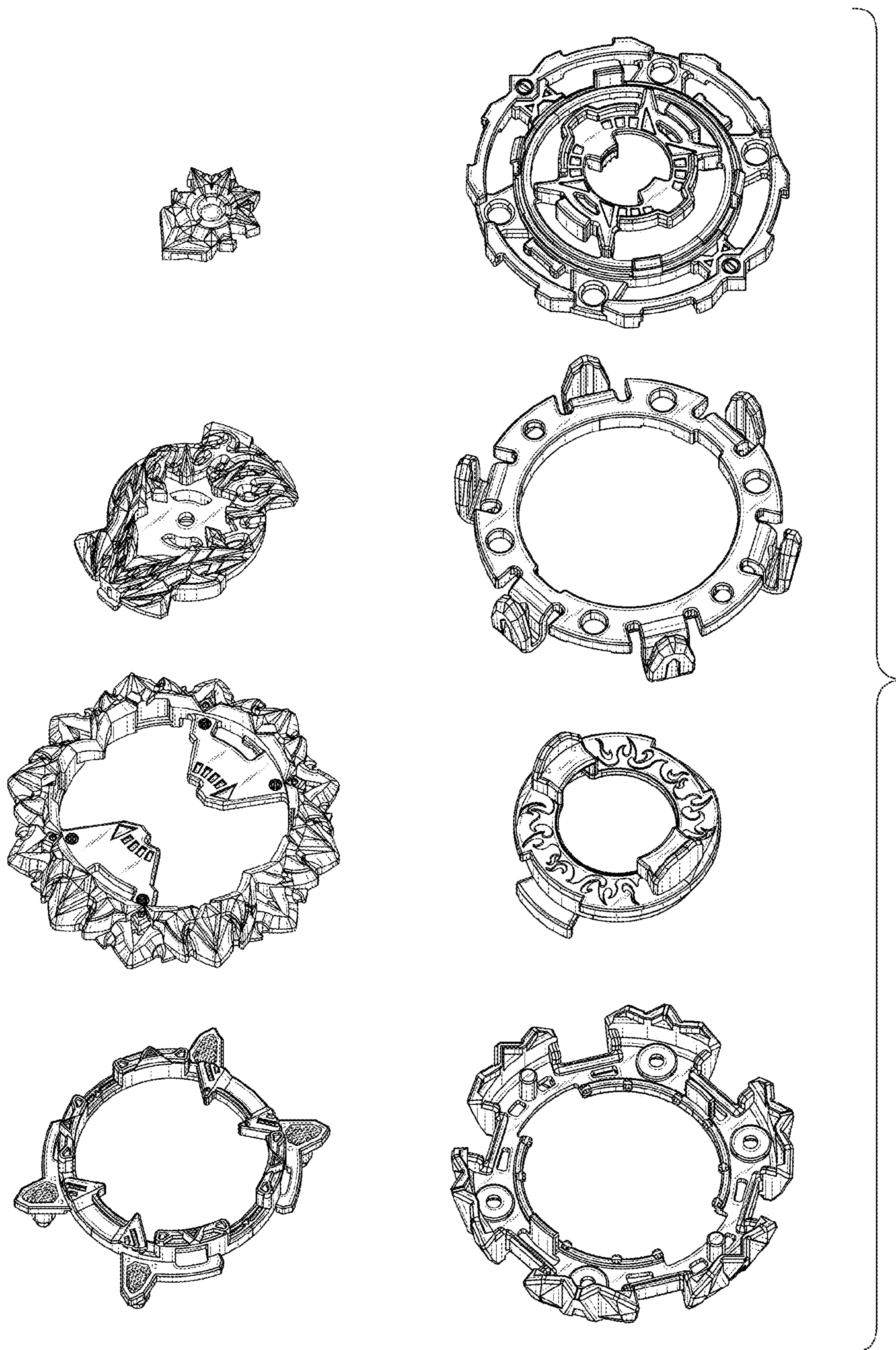

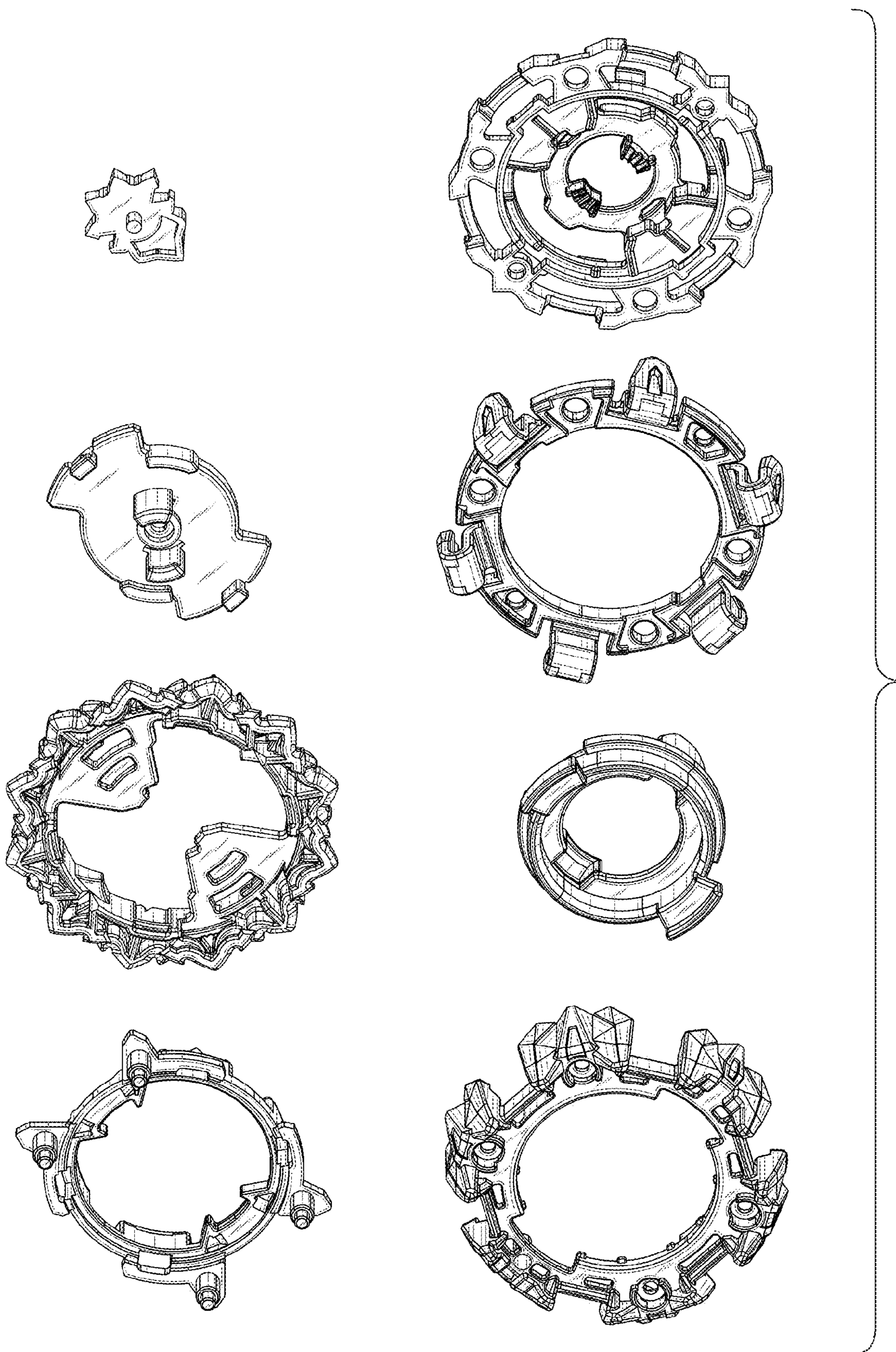
