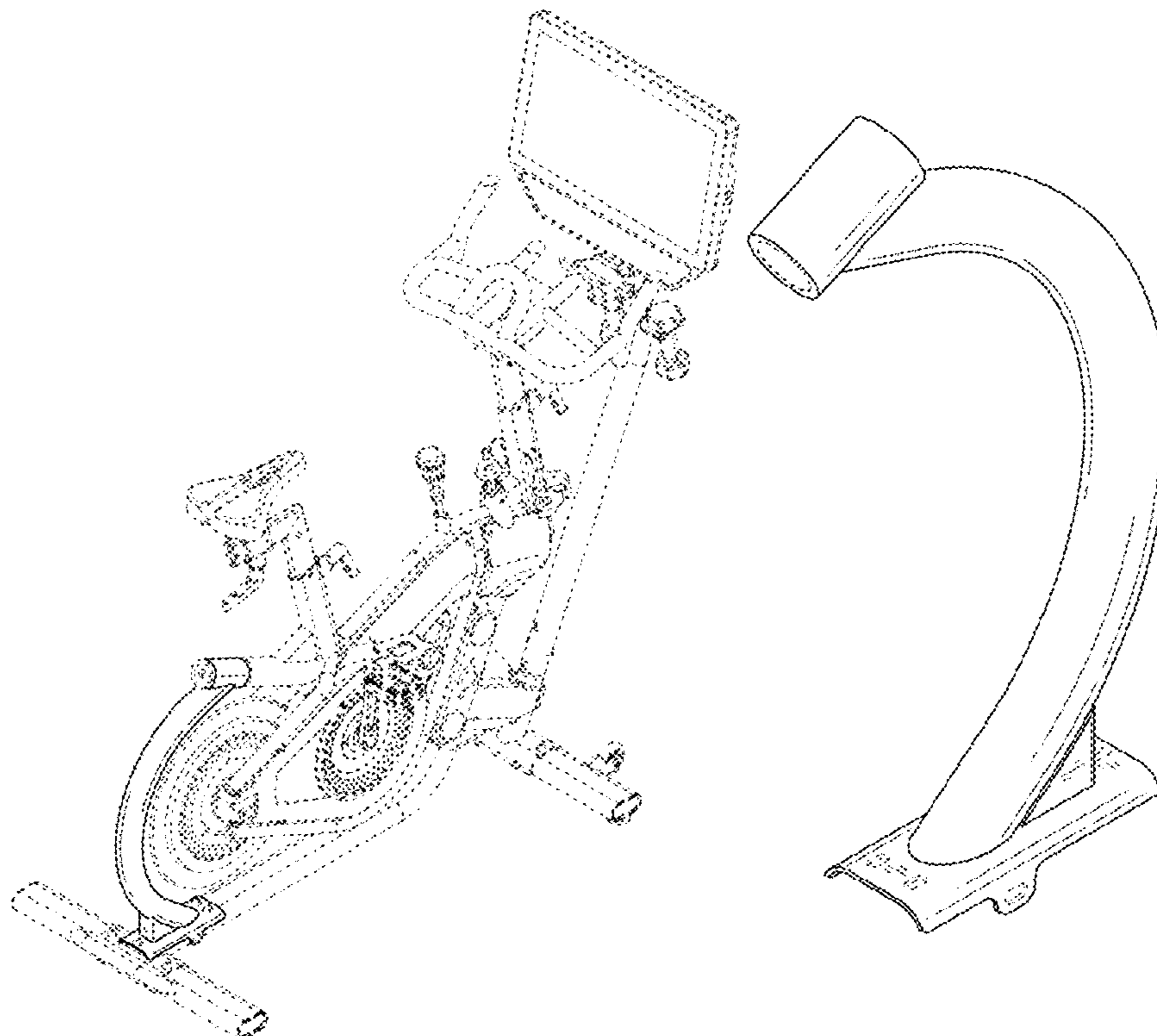
(57) **CLAIM**

The ornamental design for a frame member of a stationary bike, as shown and described.

DESCRIPTION

FIG. 1 shows a front isometric view of a frame member of a stationary bike in accordance with the present design. FIG. 2 shows a rear isometric view thereof. FIG. 3 shows an enlarged front isometric view thereof. FIG. 4 shows an enlarged rear isometric view thereof. FIG. 5 shows a left side view thereof. FIG. 6 shows a right side view thereof. FIG. 7 shows a front view thereof. FIG. 8 shows a rear view thereof. FIG. 9 shows a top view thereof; and, FIG. 10 shows a bottom view thereof. The broken lines represent environment that forms no part of the claimed design.

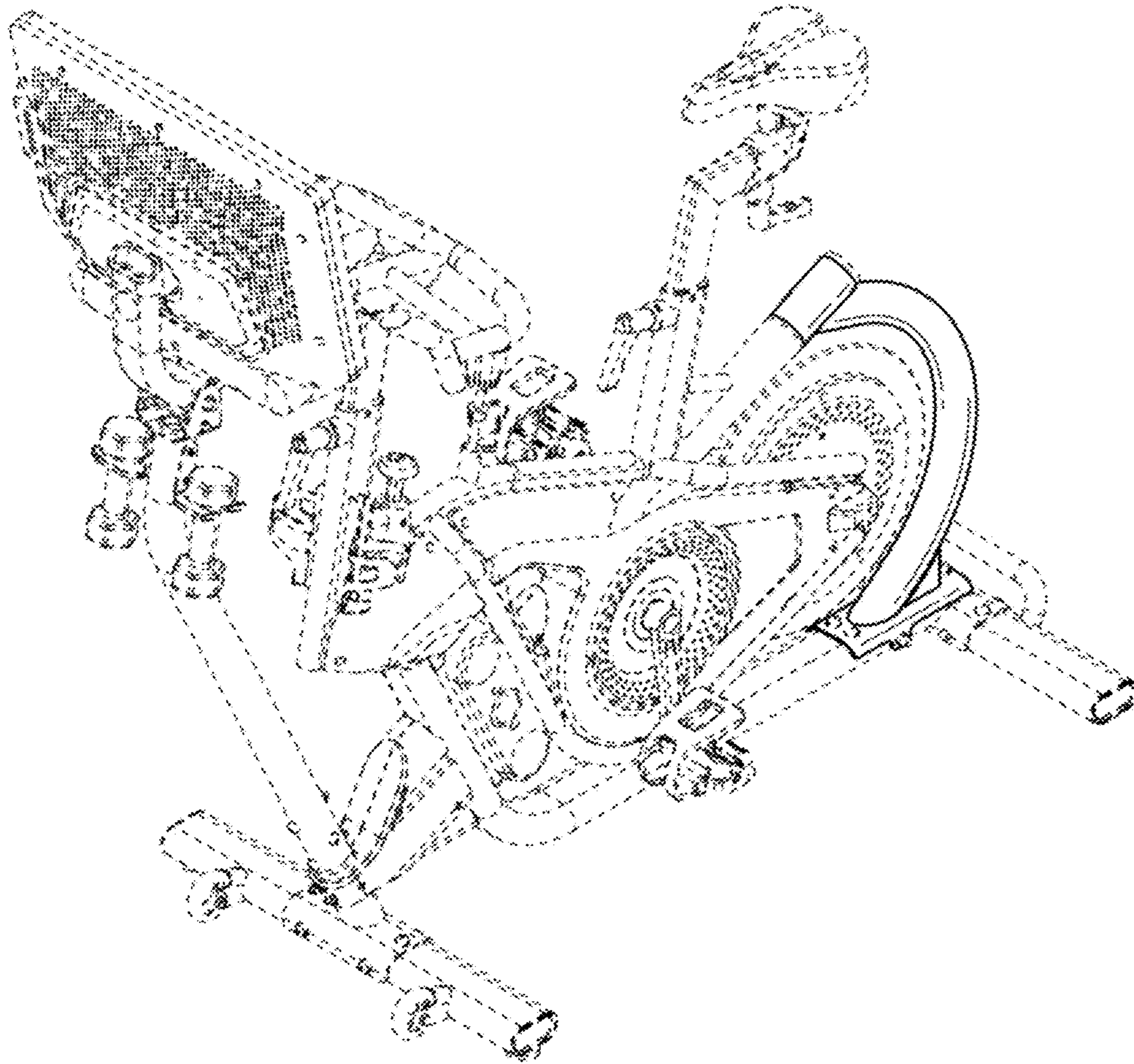

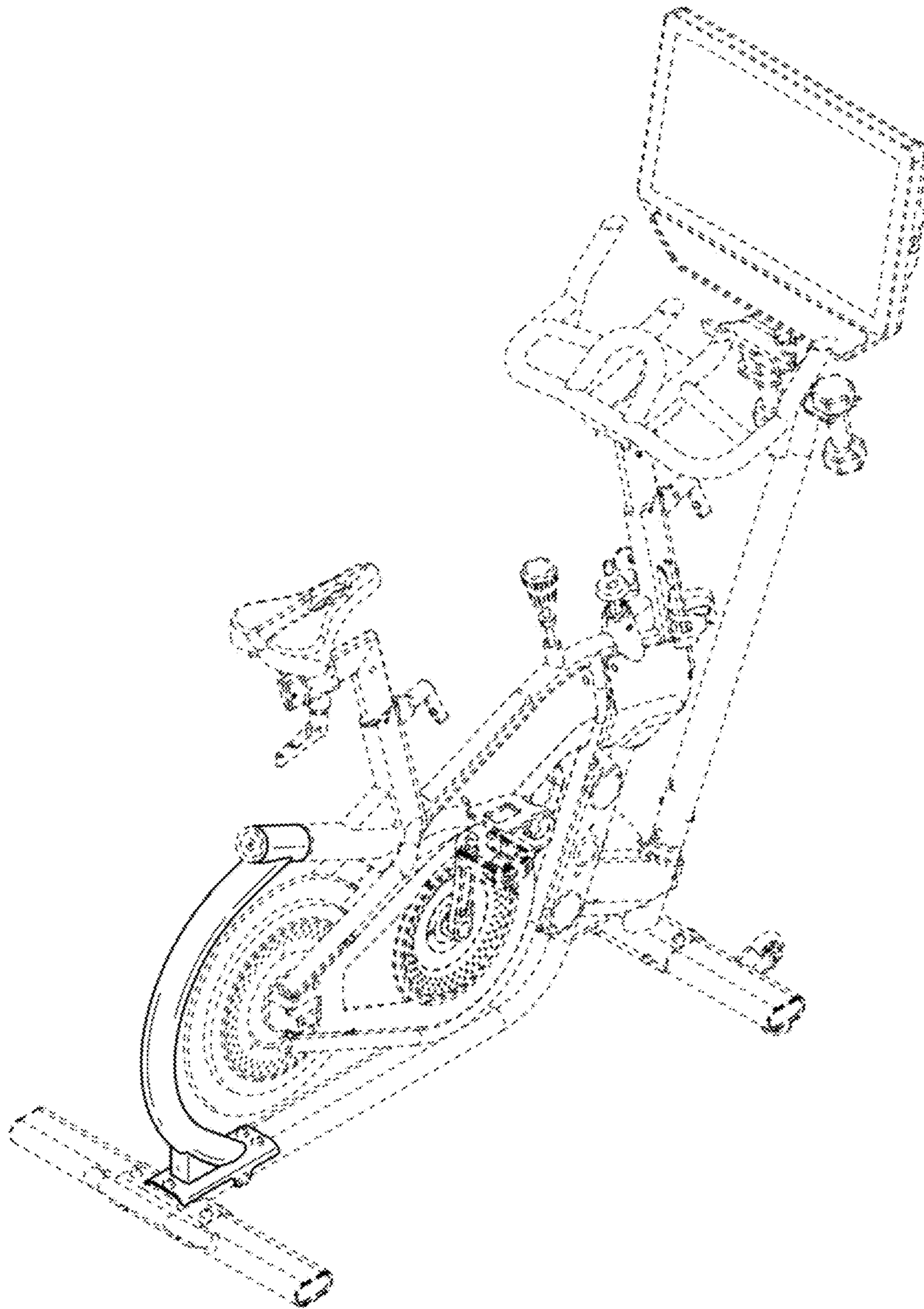

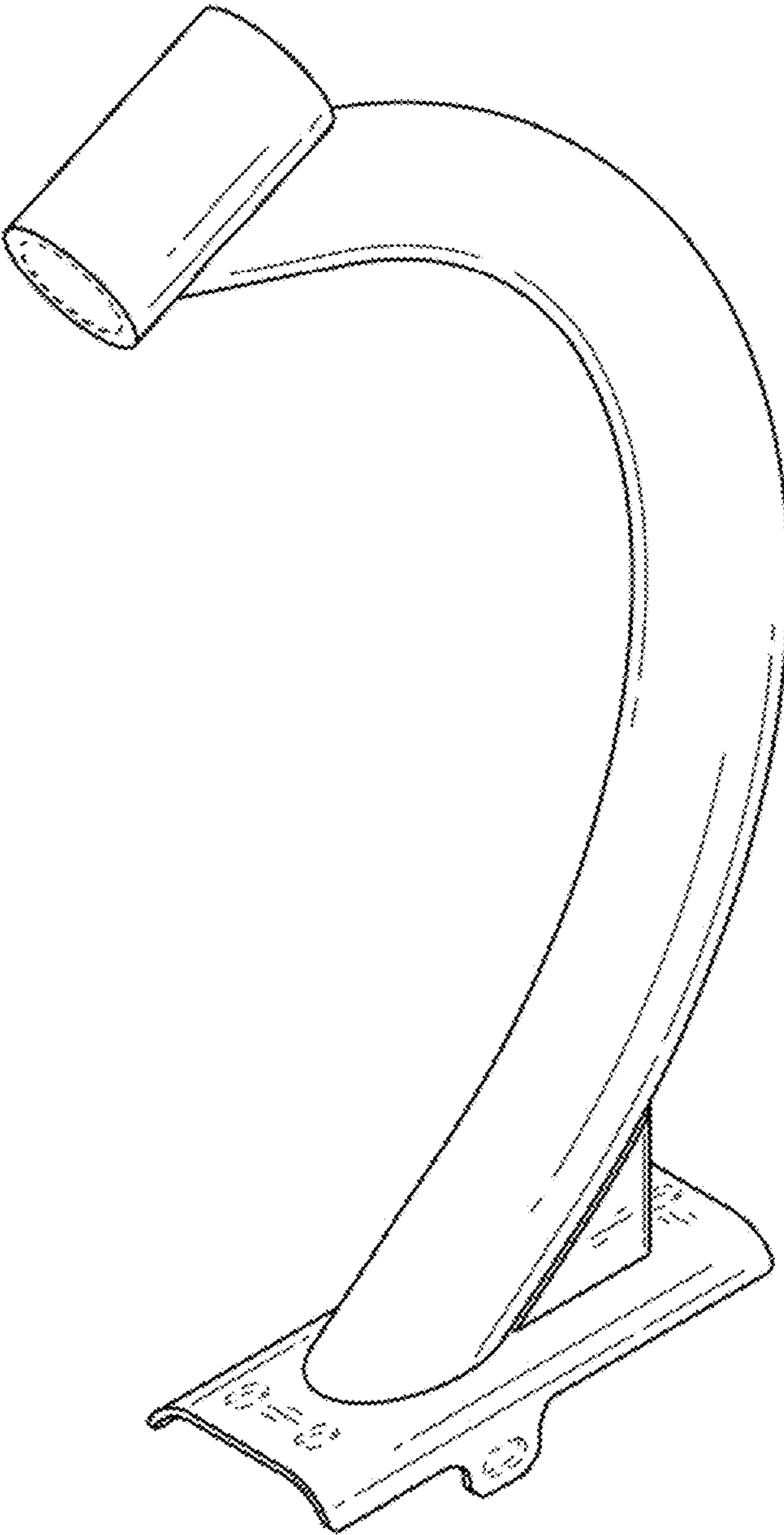

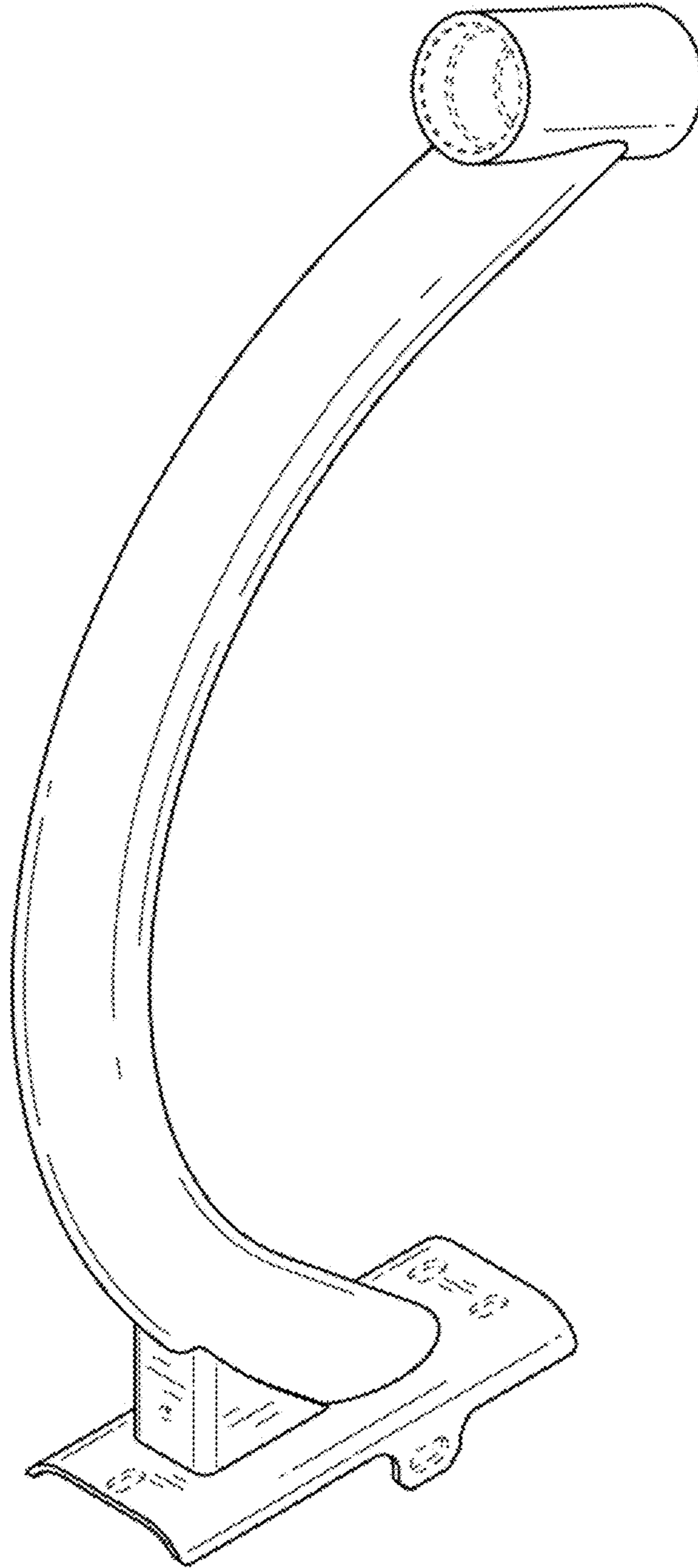

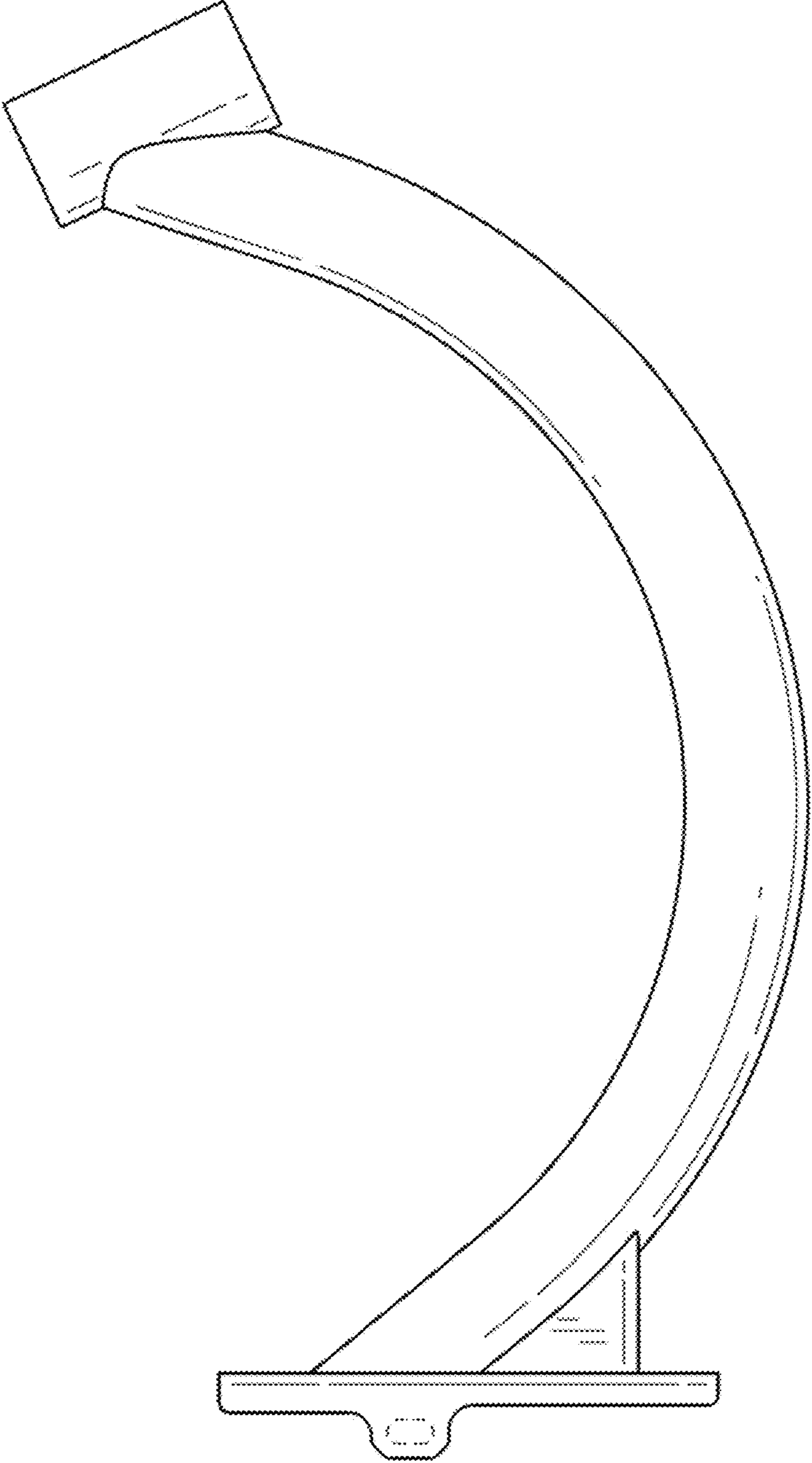

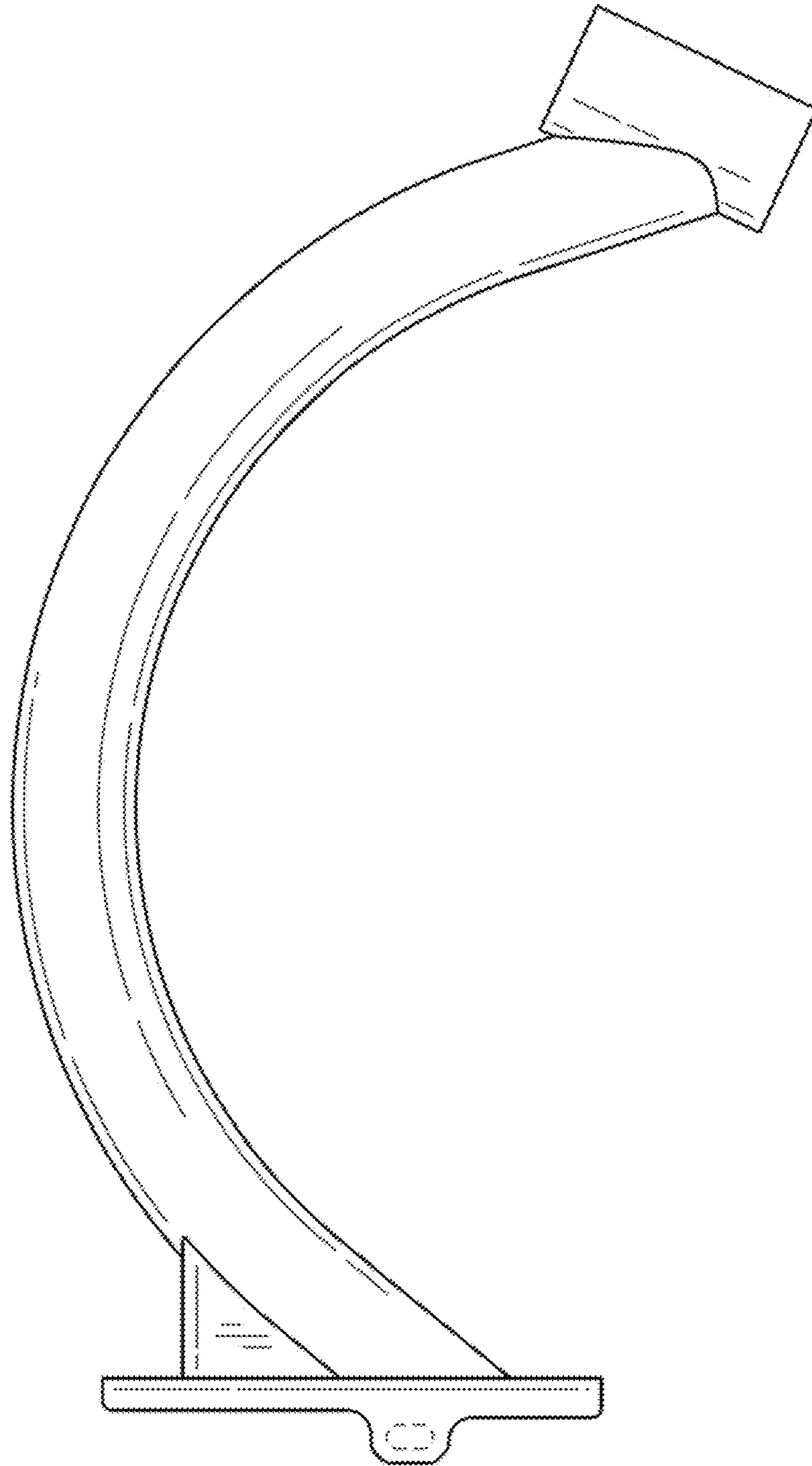

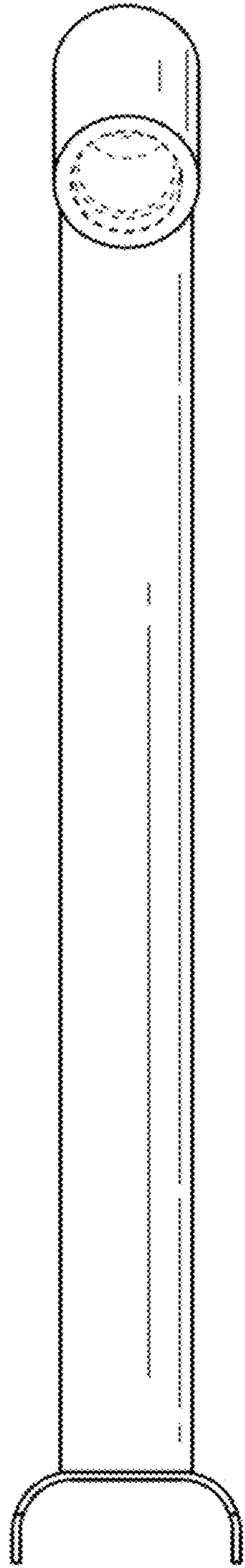

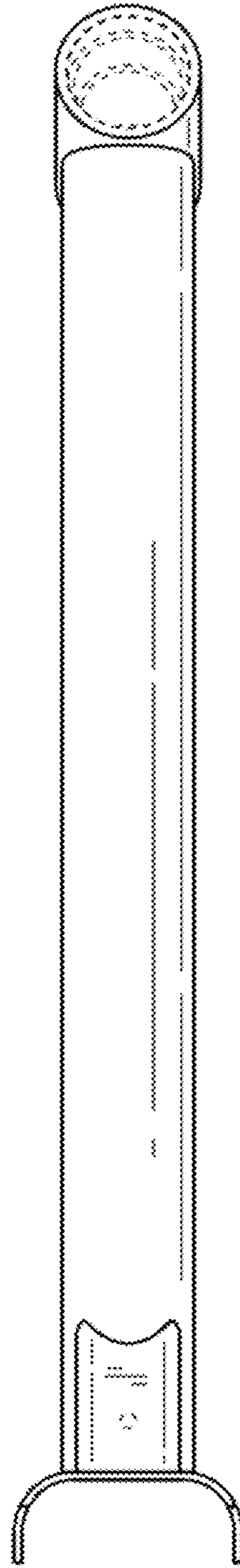

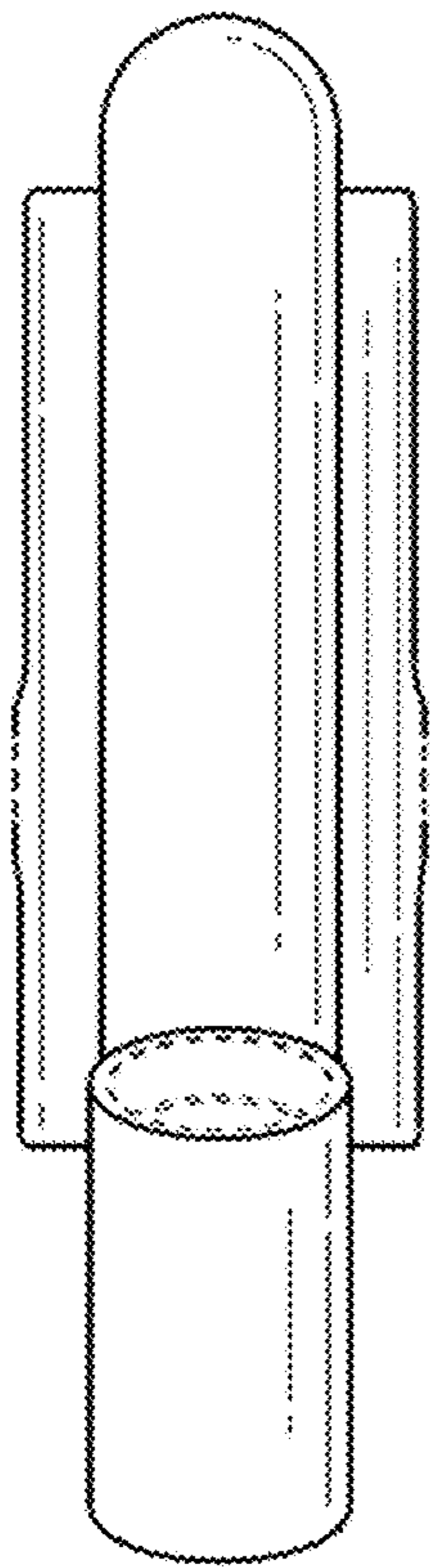

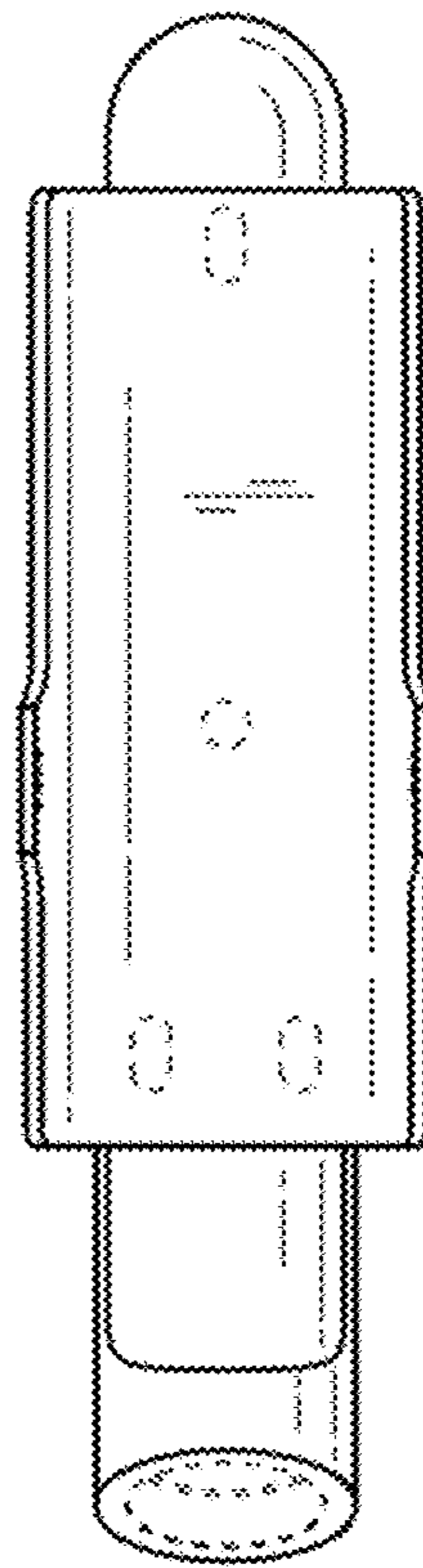
