The ornamental design for a ball, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the ball embodying the new design;

FIG. 2 is a right side view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a bottom thereof;

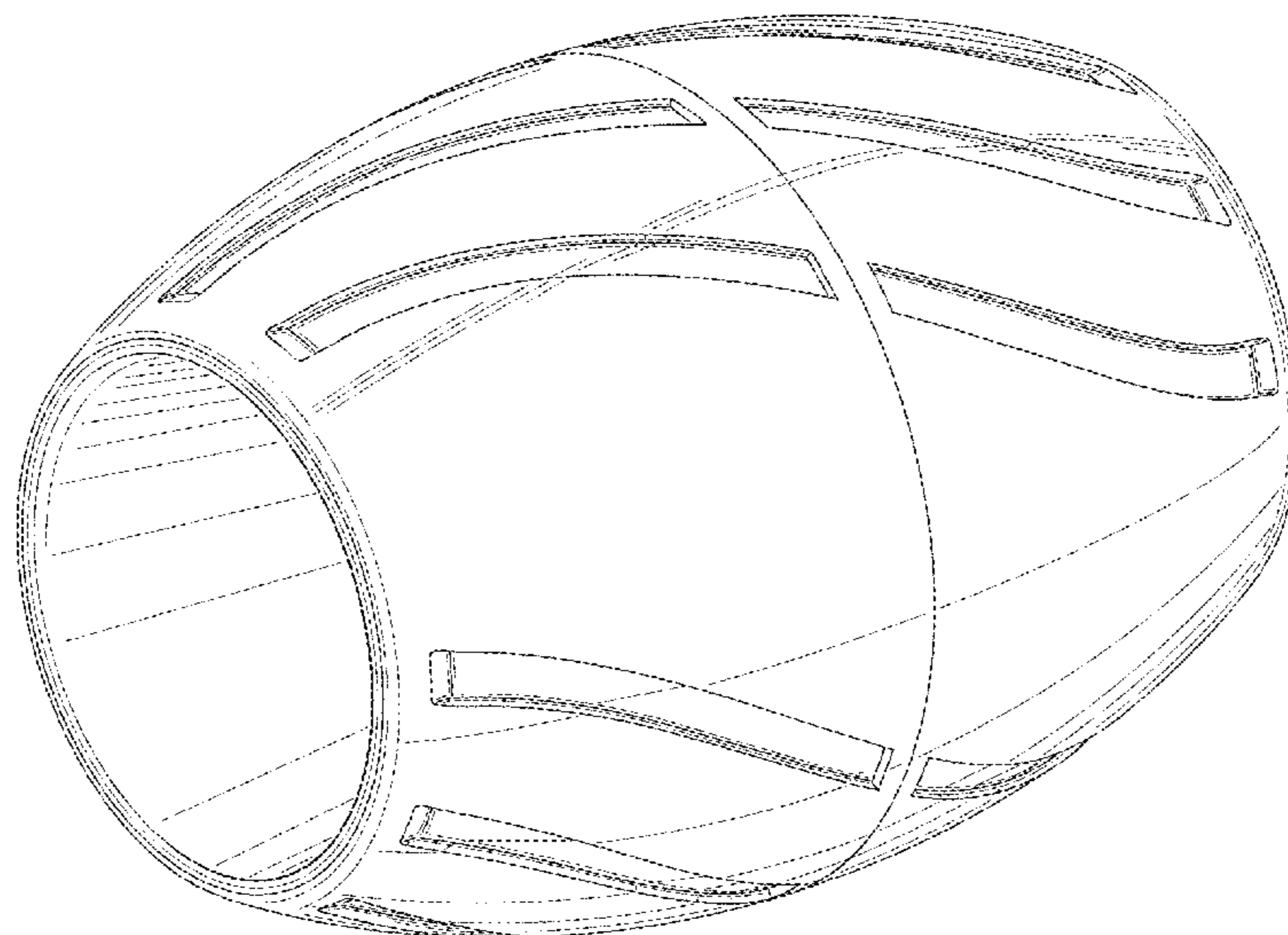
FIG. 6 is a front view thereof;

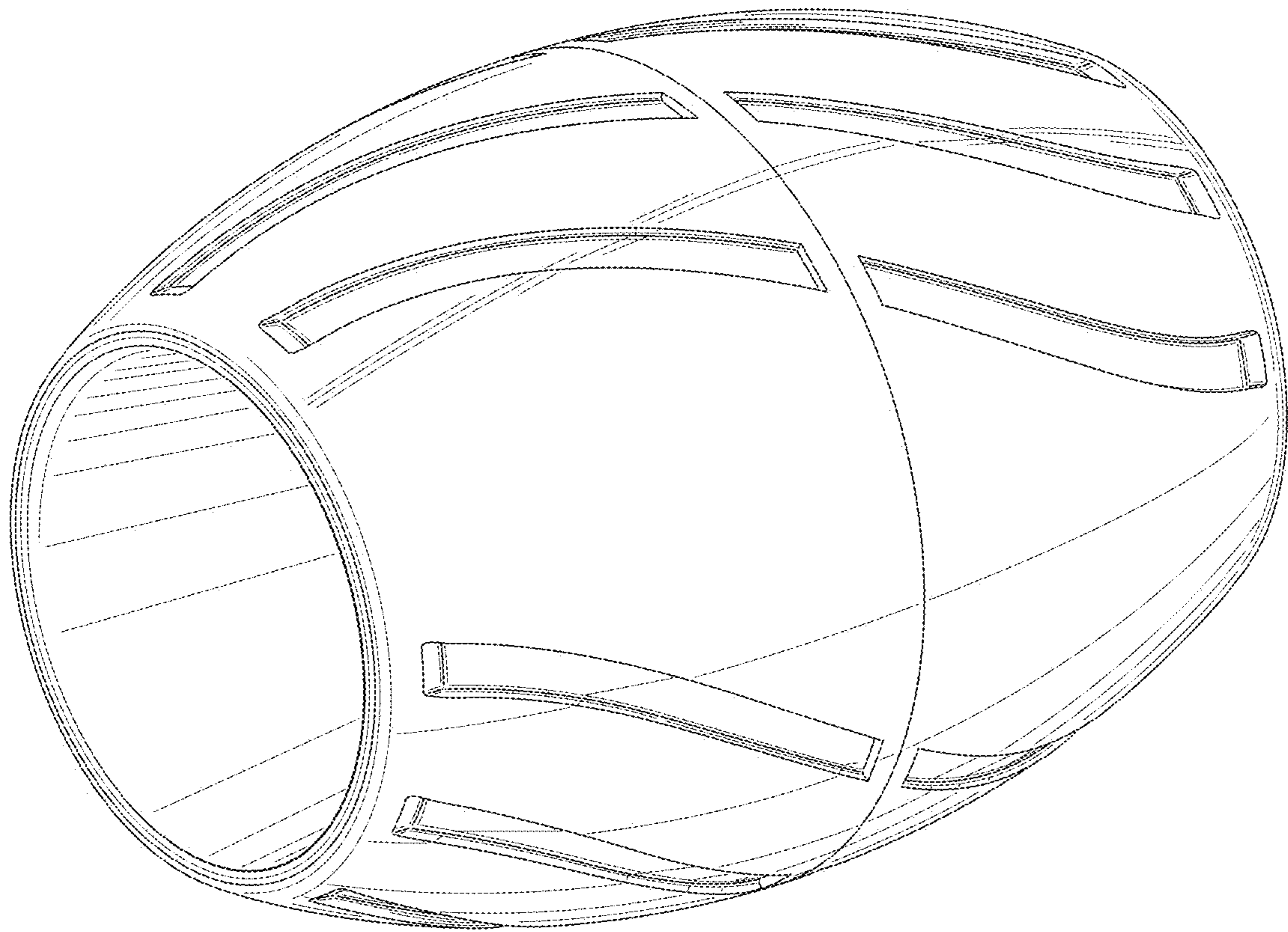

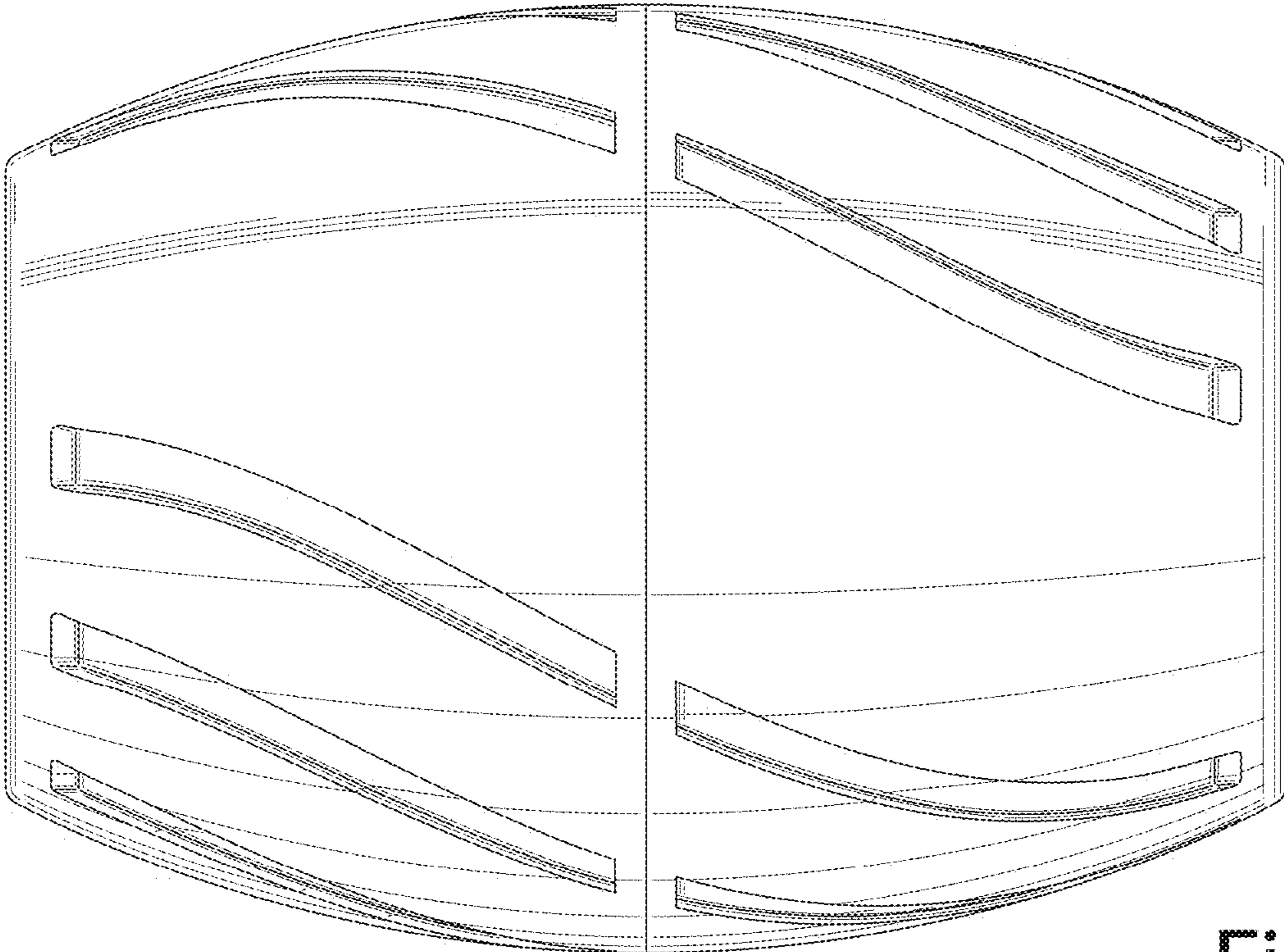

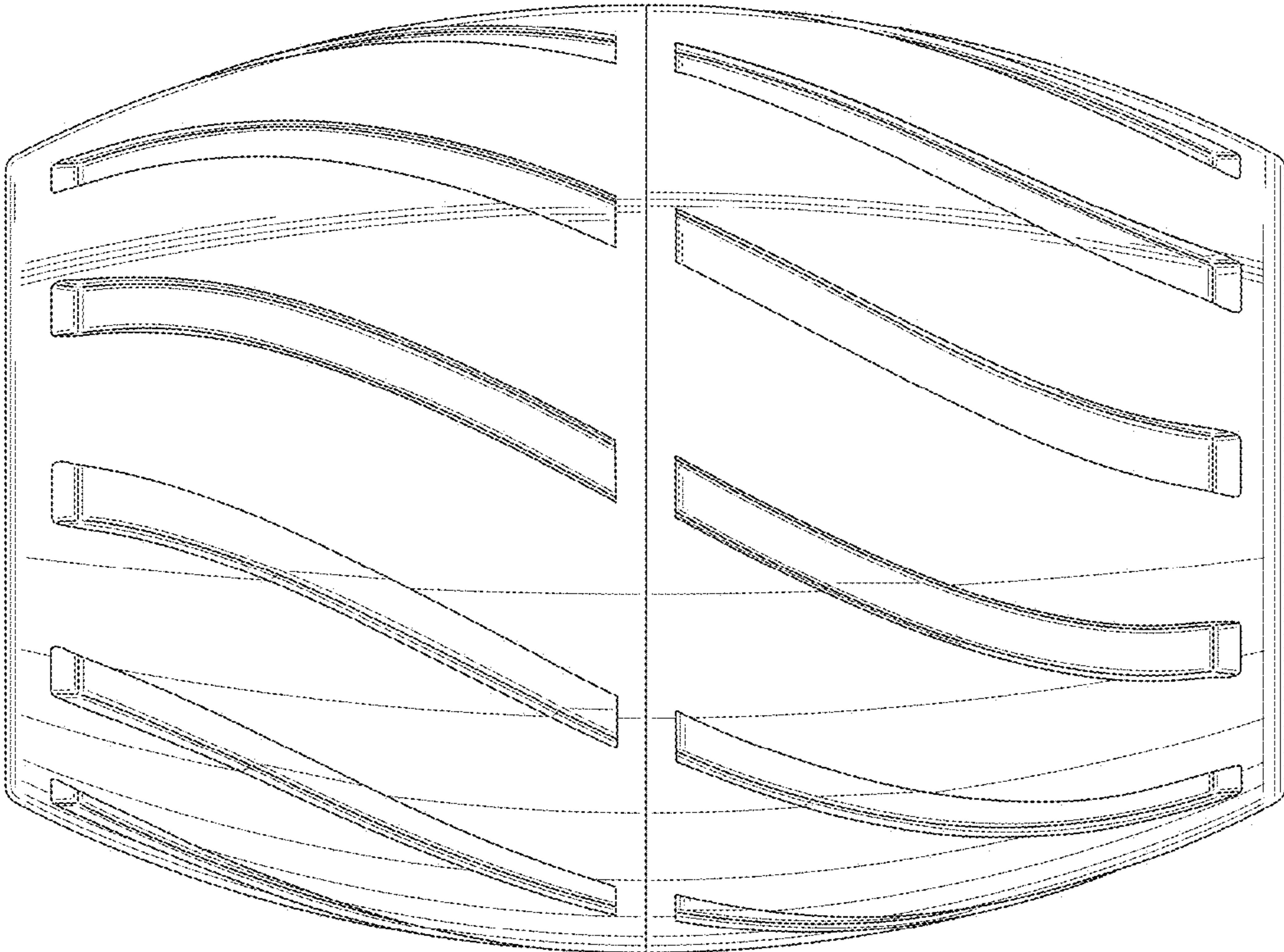

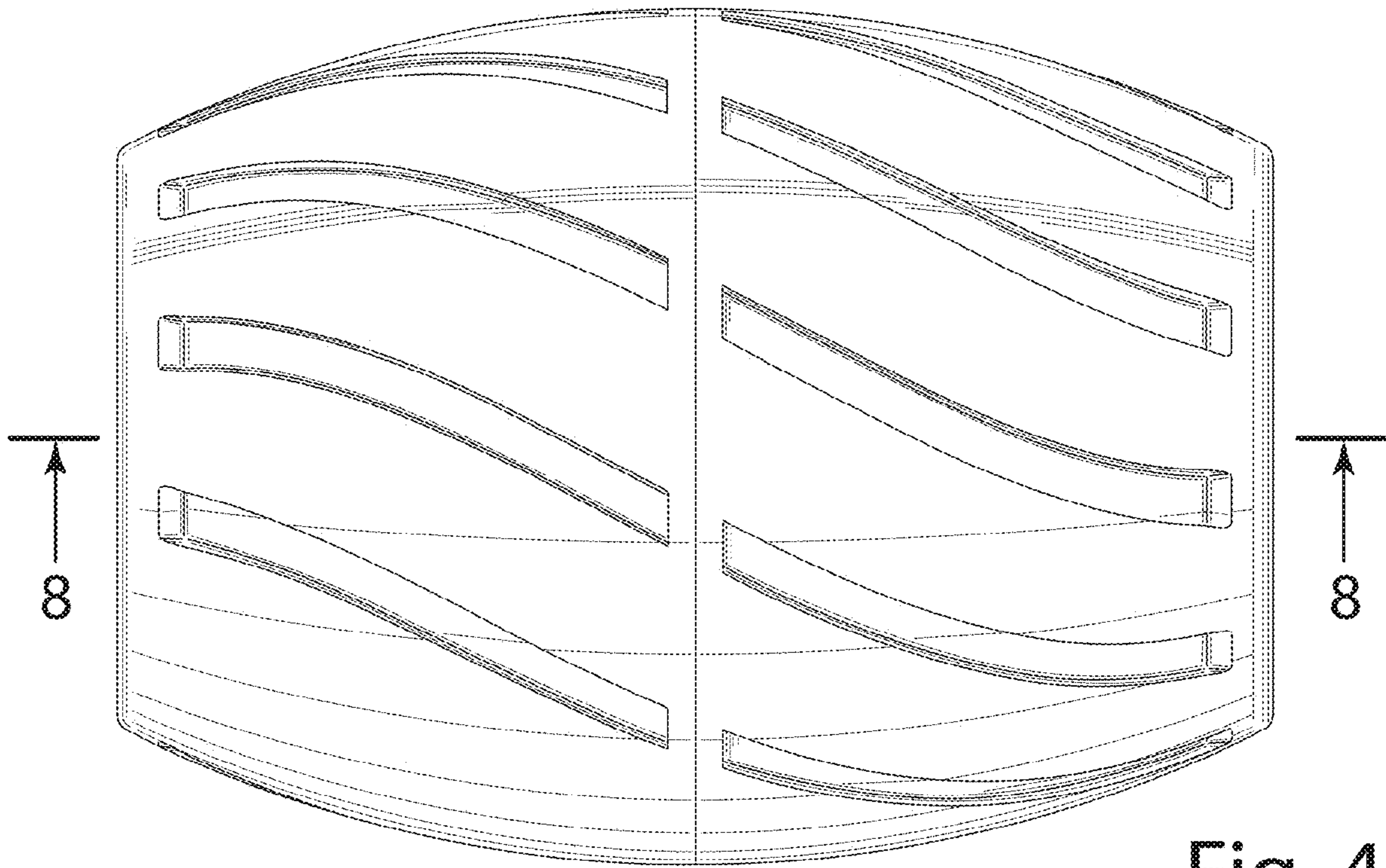

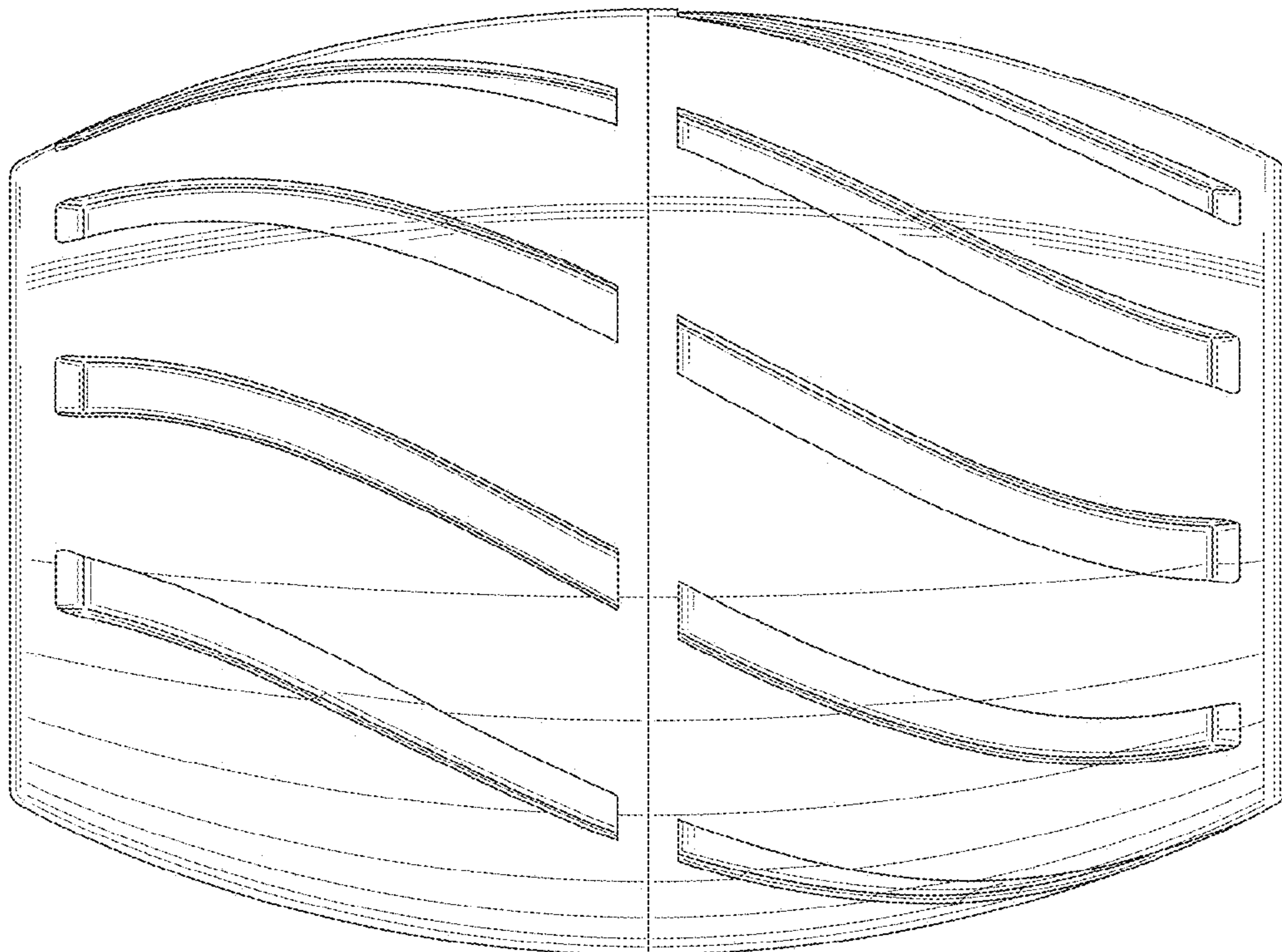

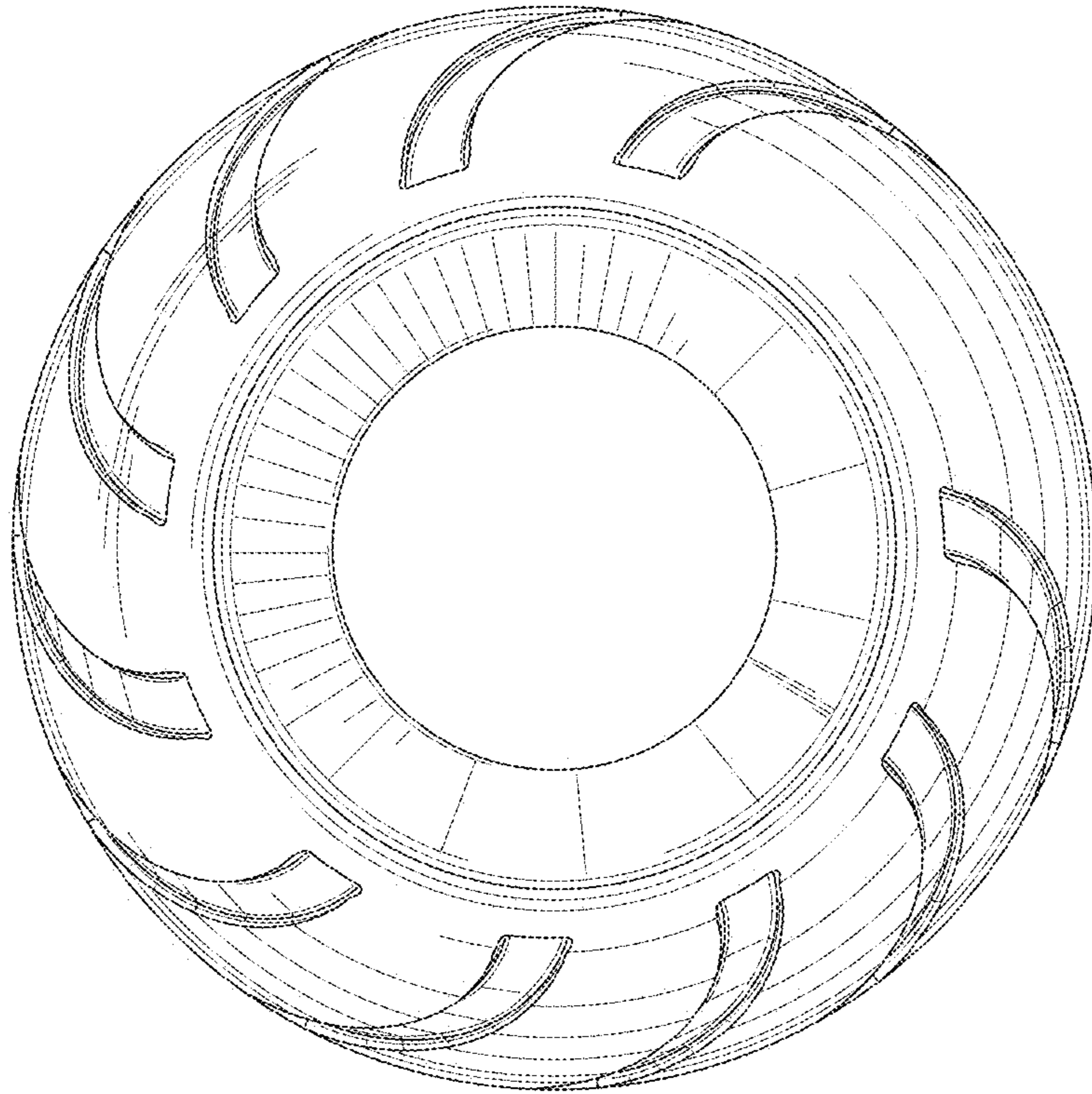

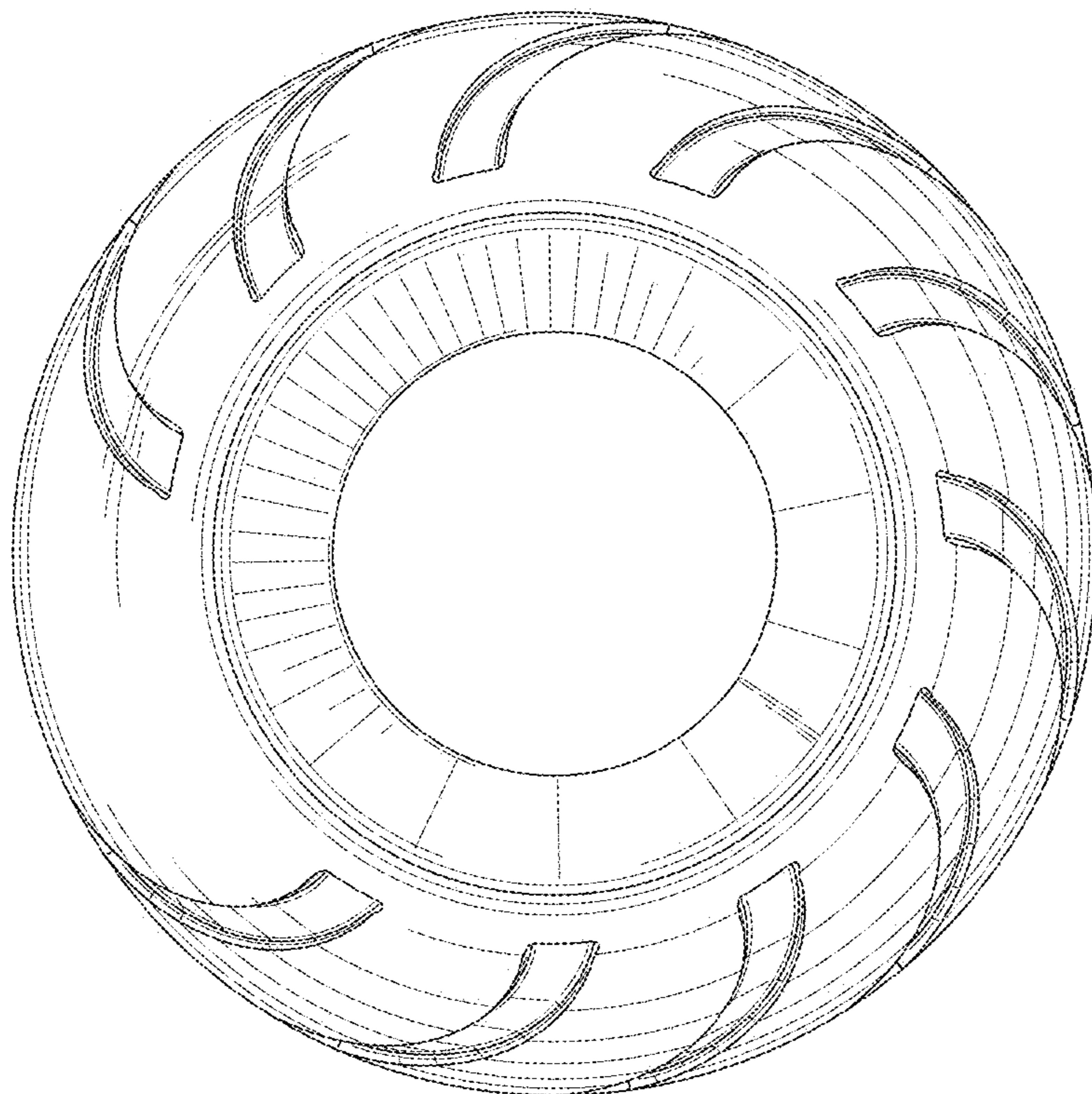

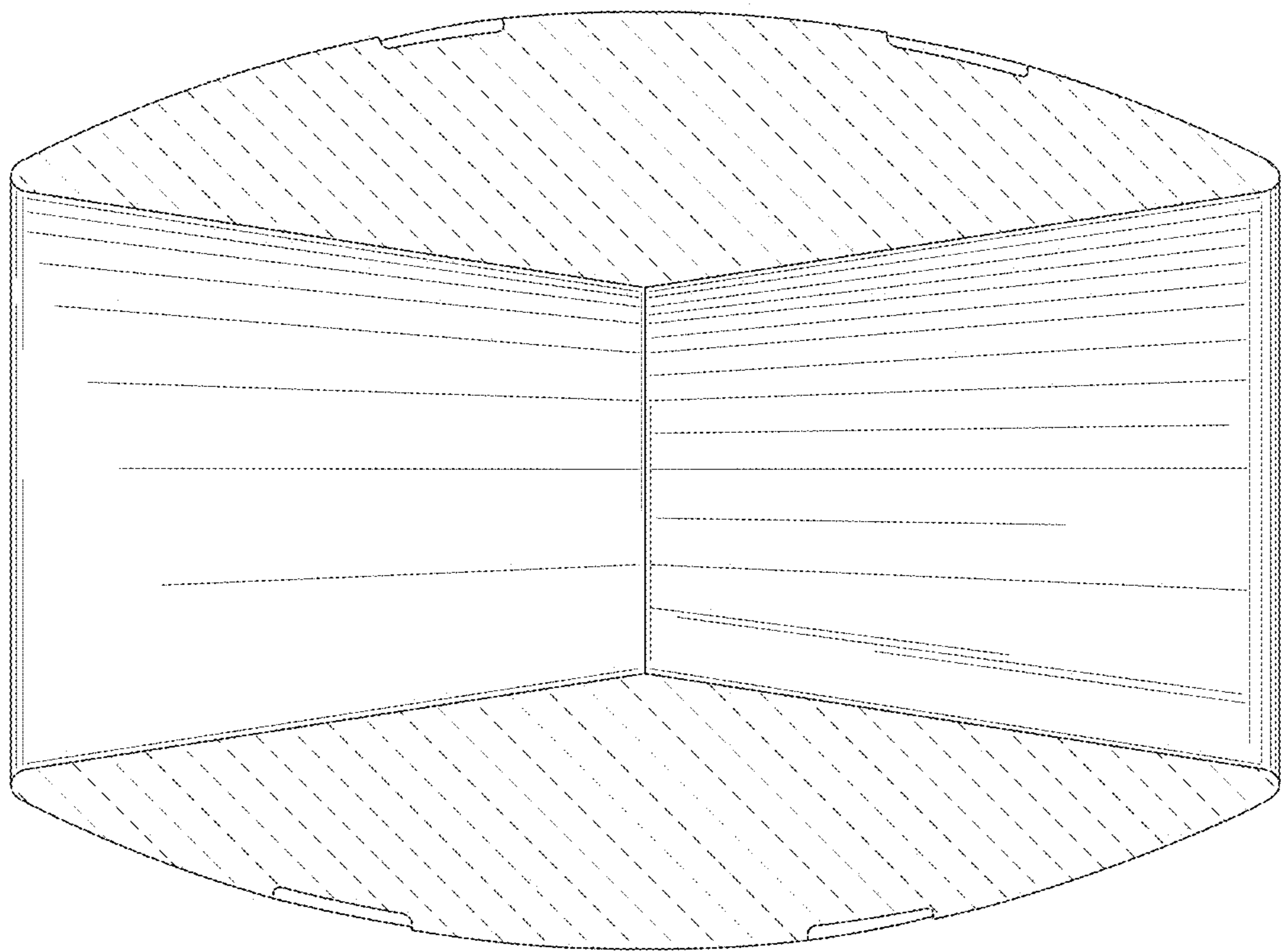
