FIG. 5 is a top side view thereof;

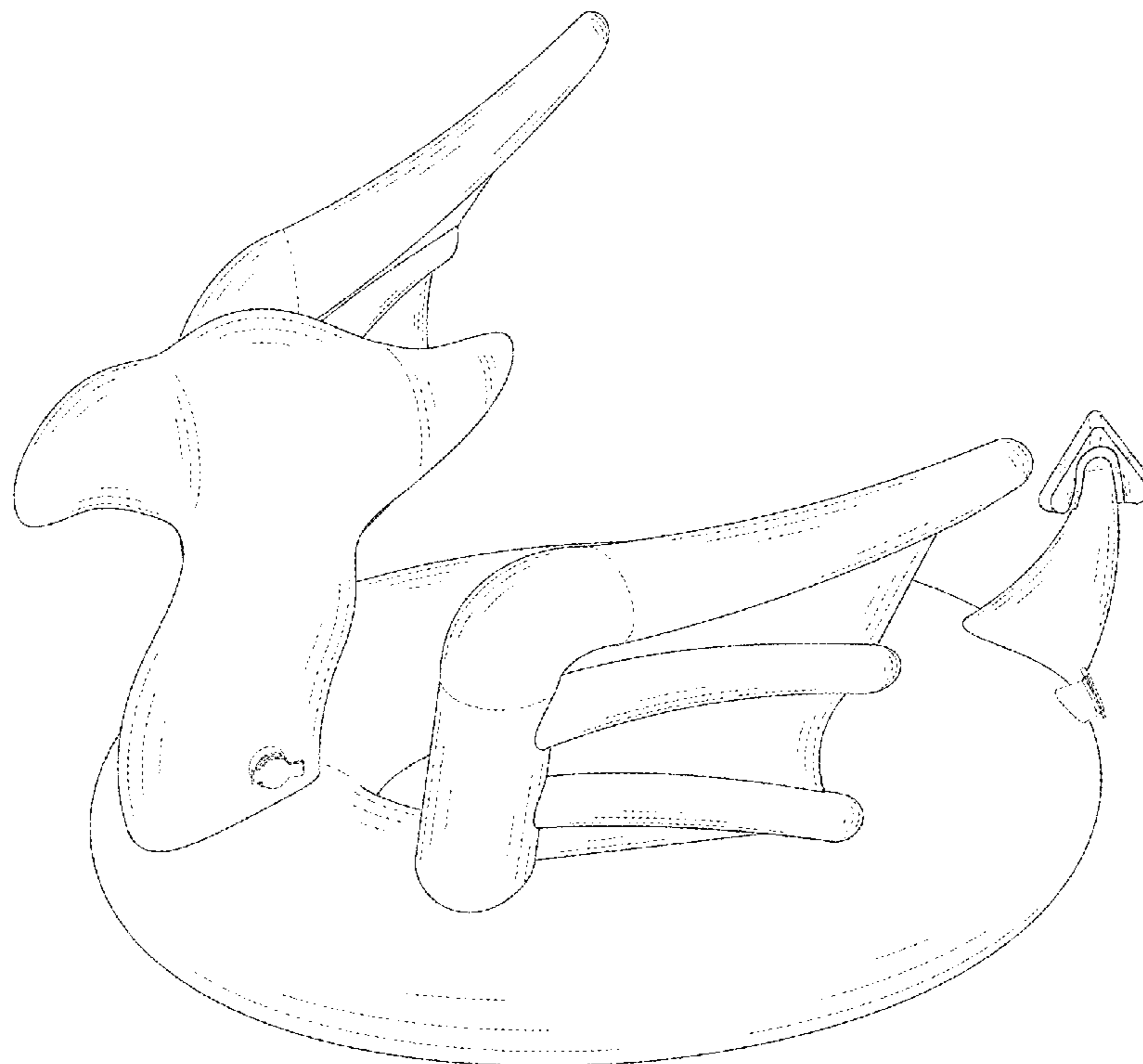
FIG. 6 is a bottom plan view thereof;

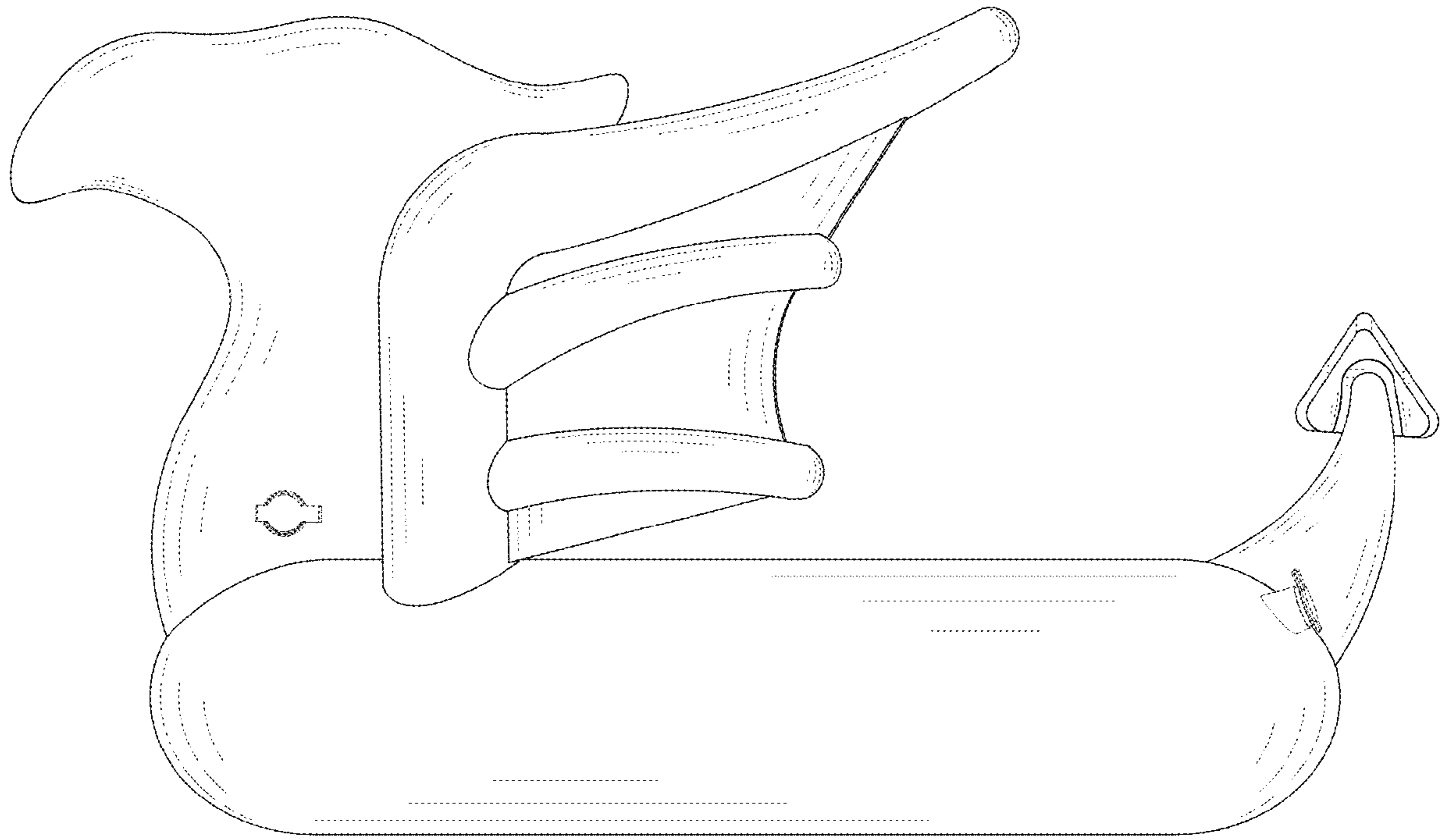
FIG. 7 is a perspective view of a swimming ring showing my new design; and,

FIG. 8 is another perspective view thereof.

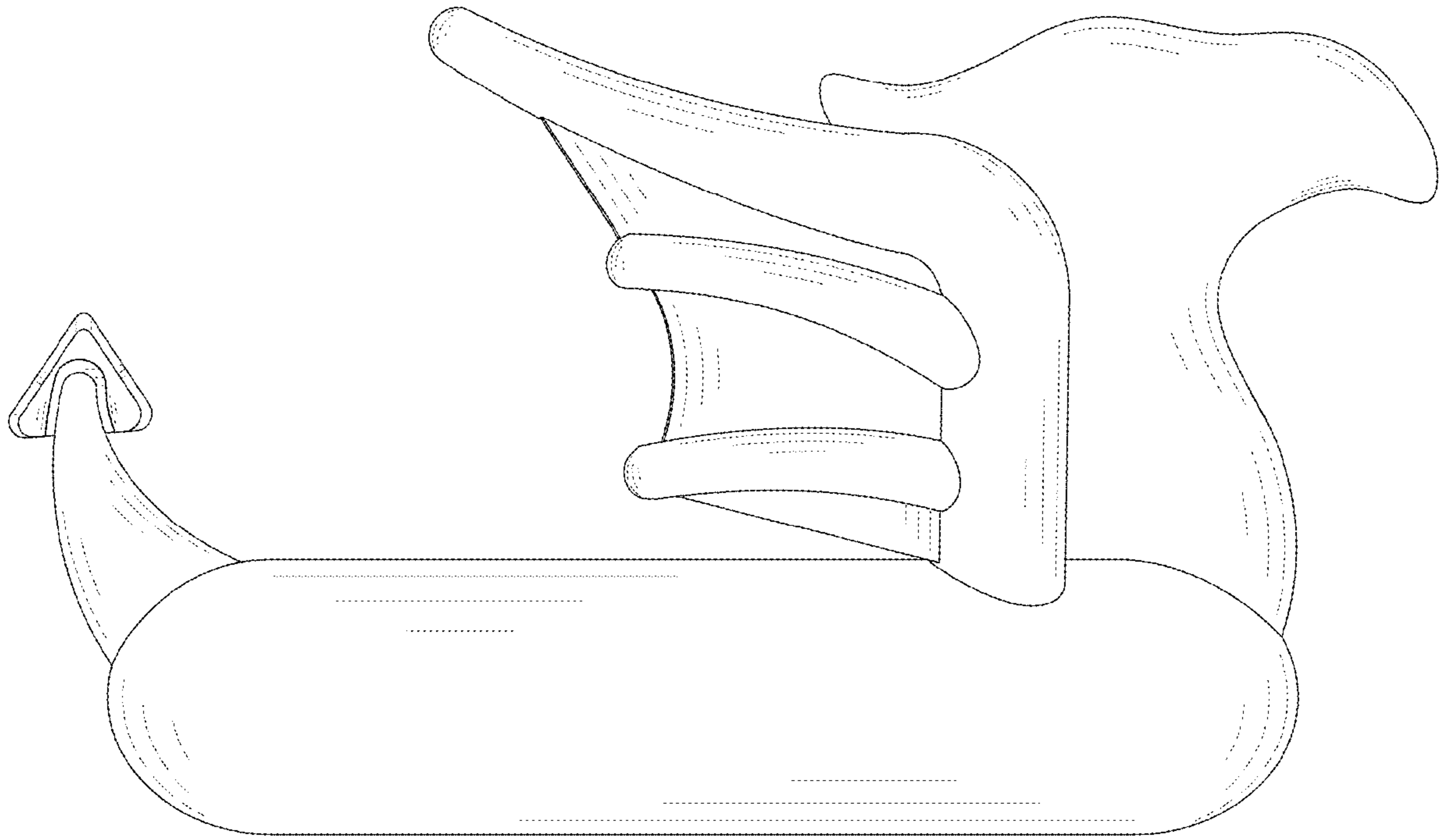
The broken lines in the figures are for the purposes of illustrating portions of the swimming ring, which form no part of the claimed design.

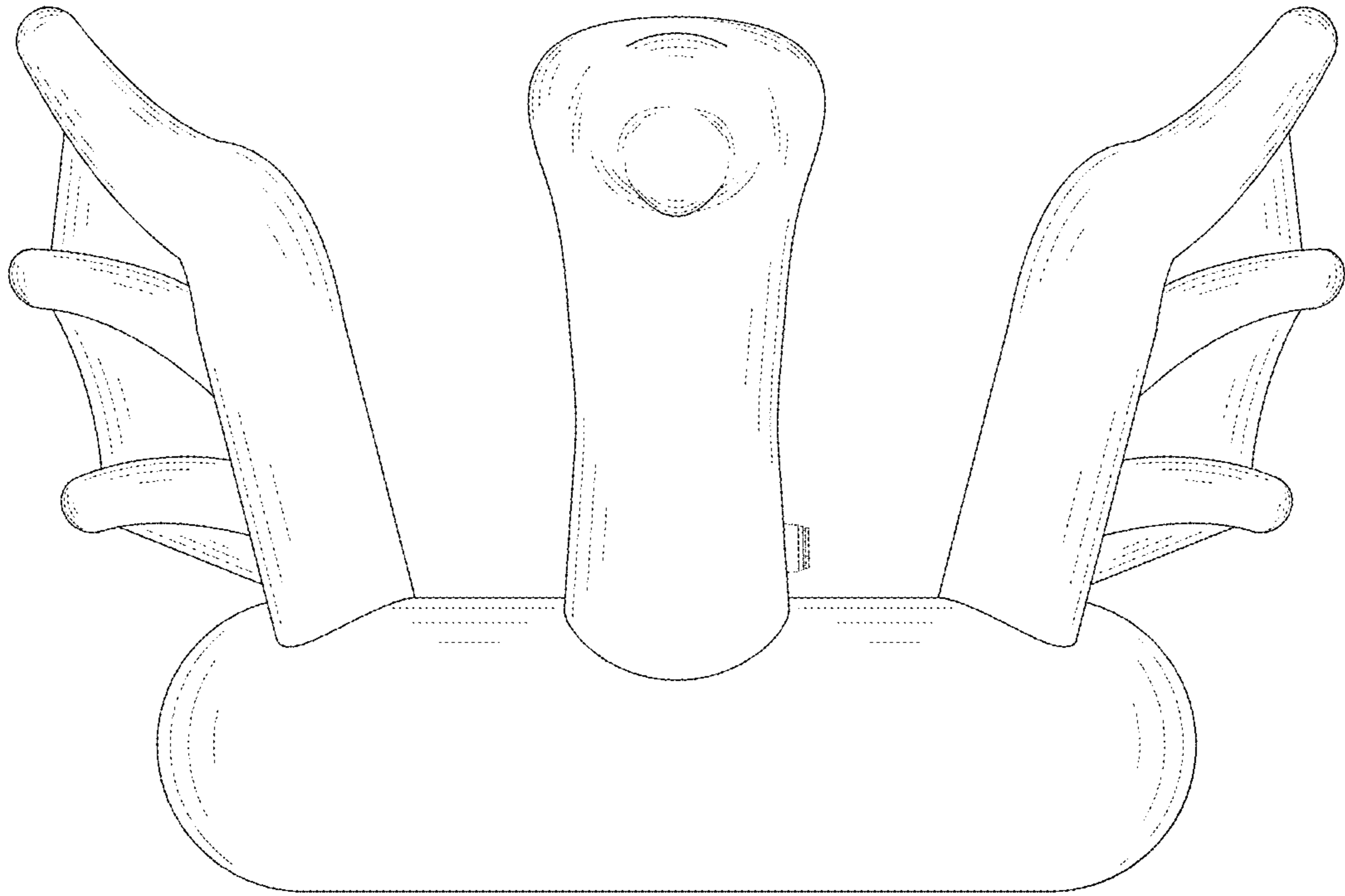




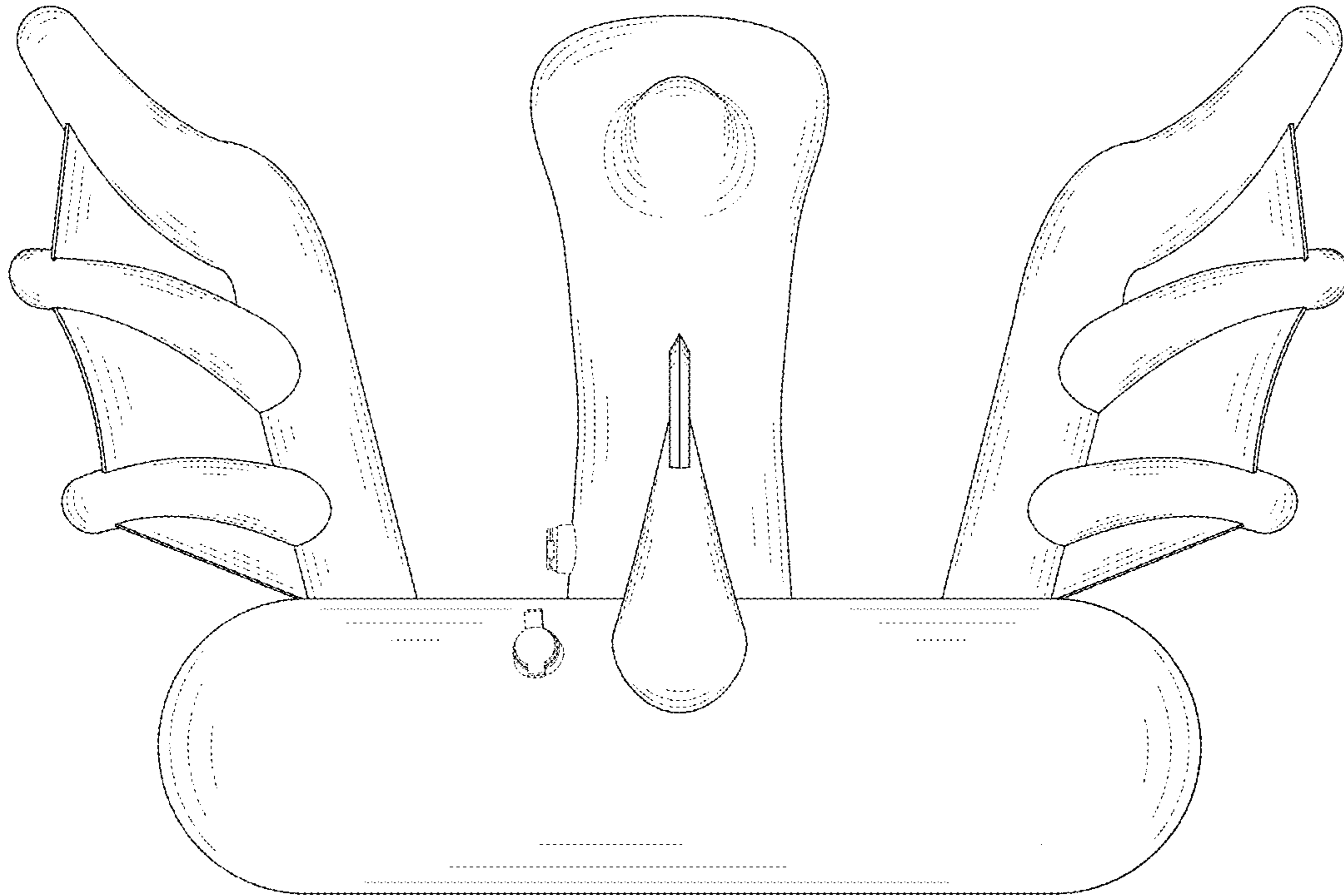

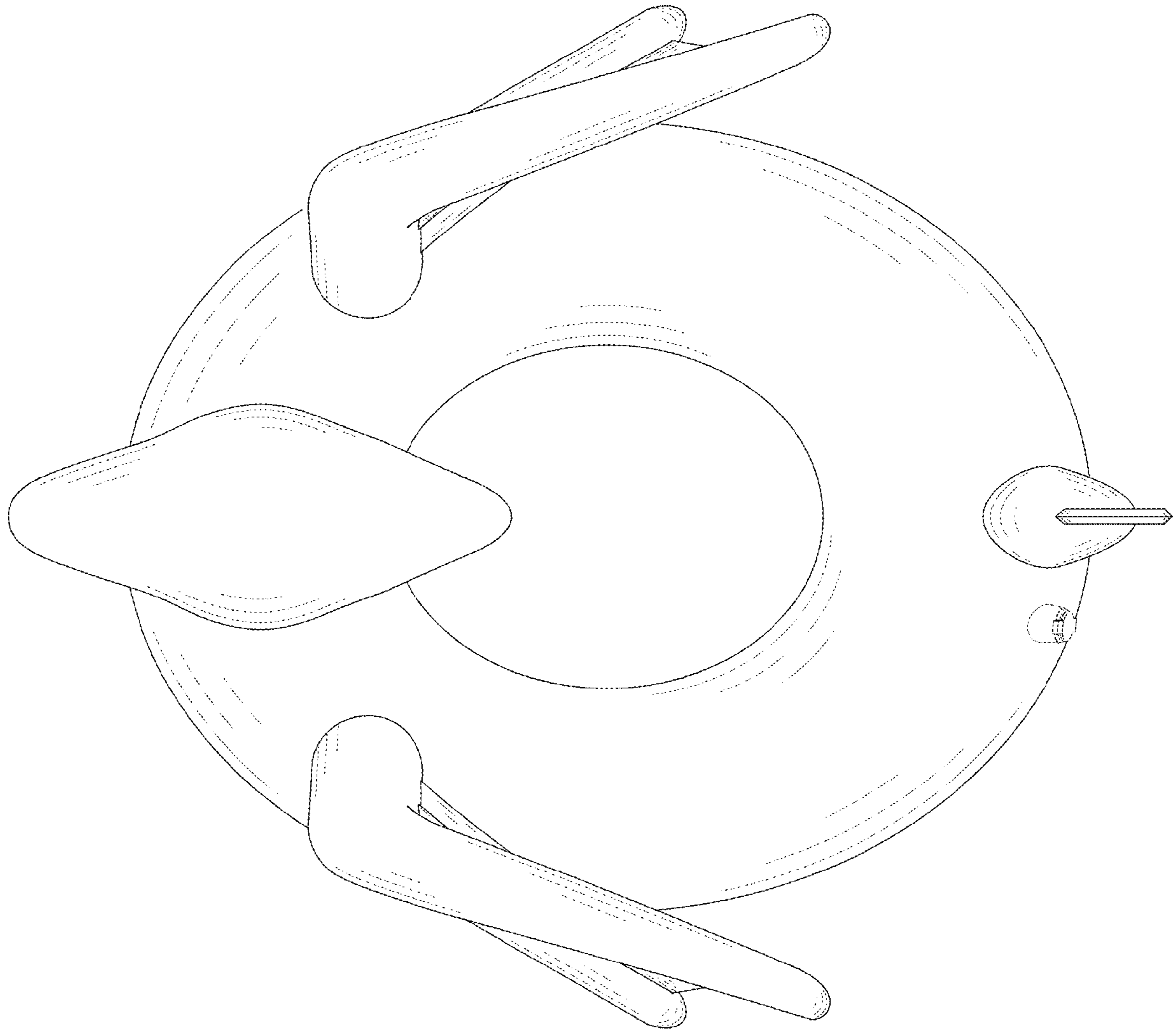

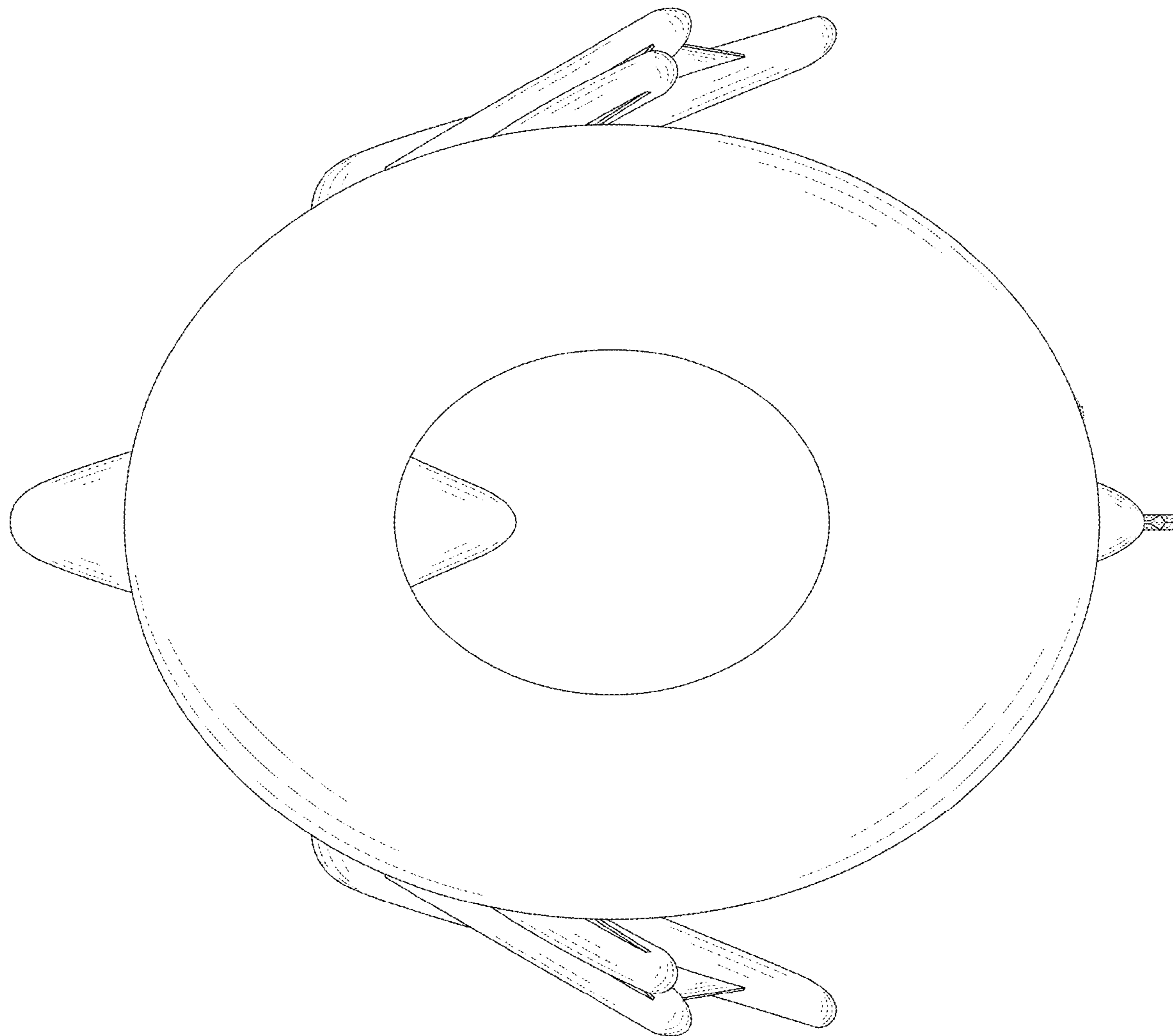

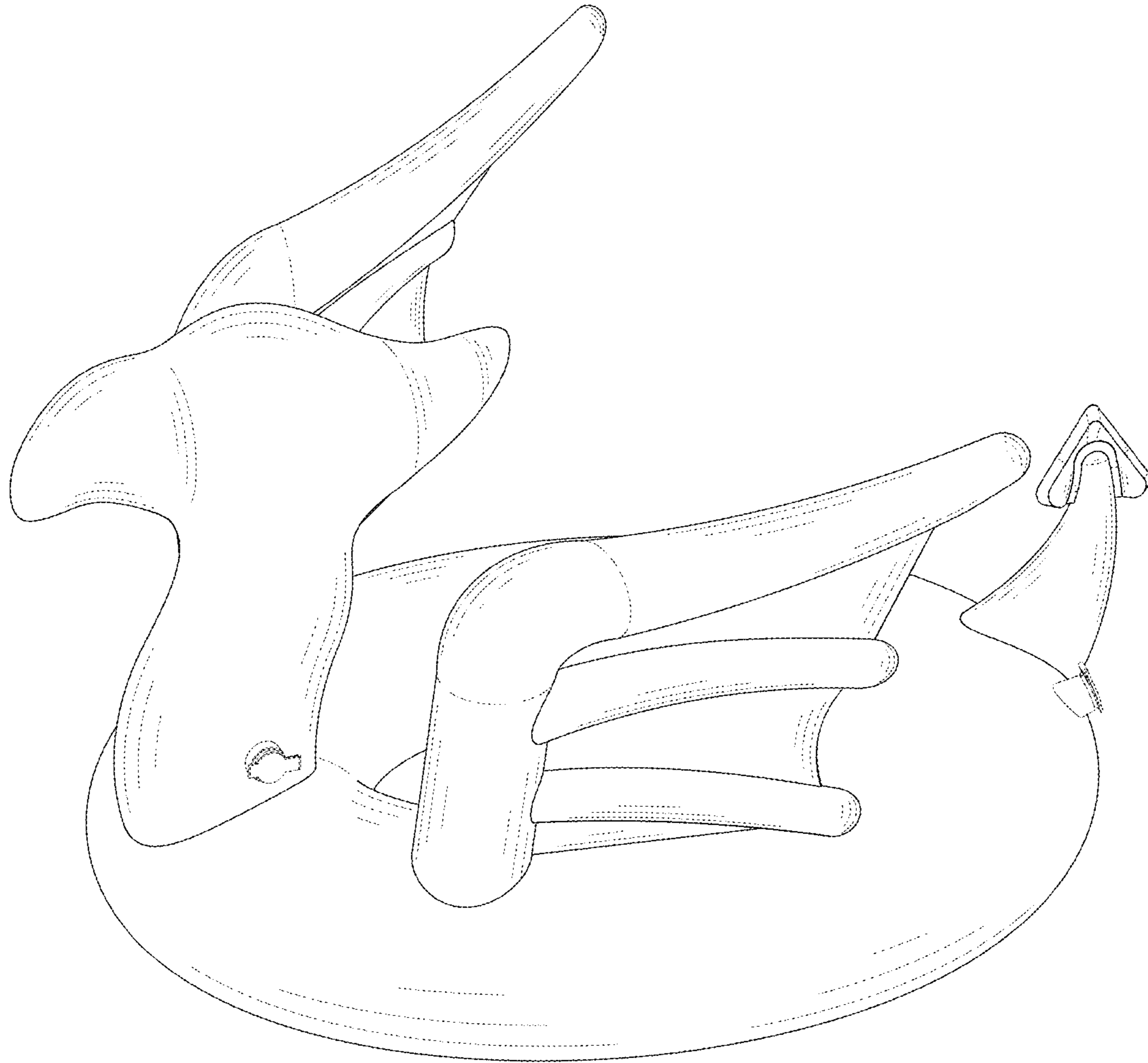
