FIG. 8 is a bottom plan view thereof.

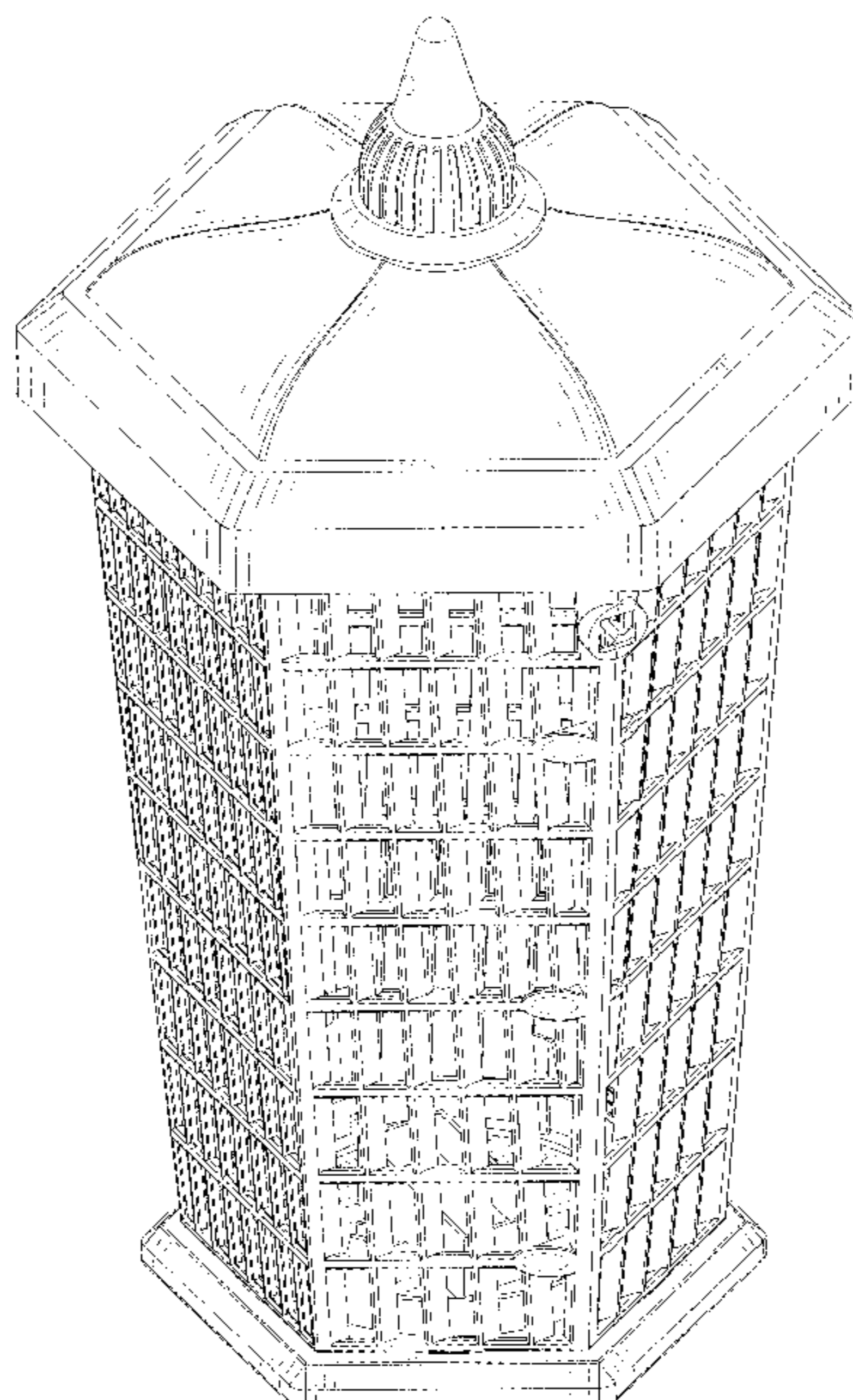
The broken lines in the drawings are for the purpose of illustrating portions of the mosquito killing lamp that form no part of the claimed design.

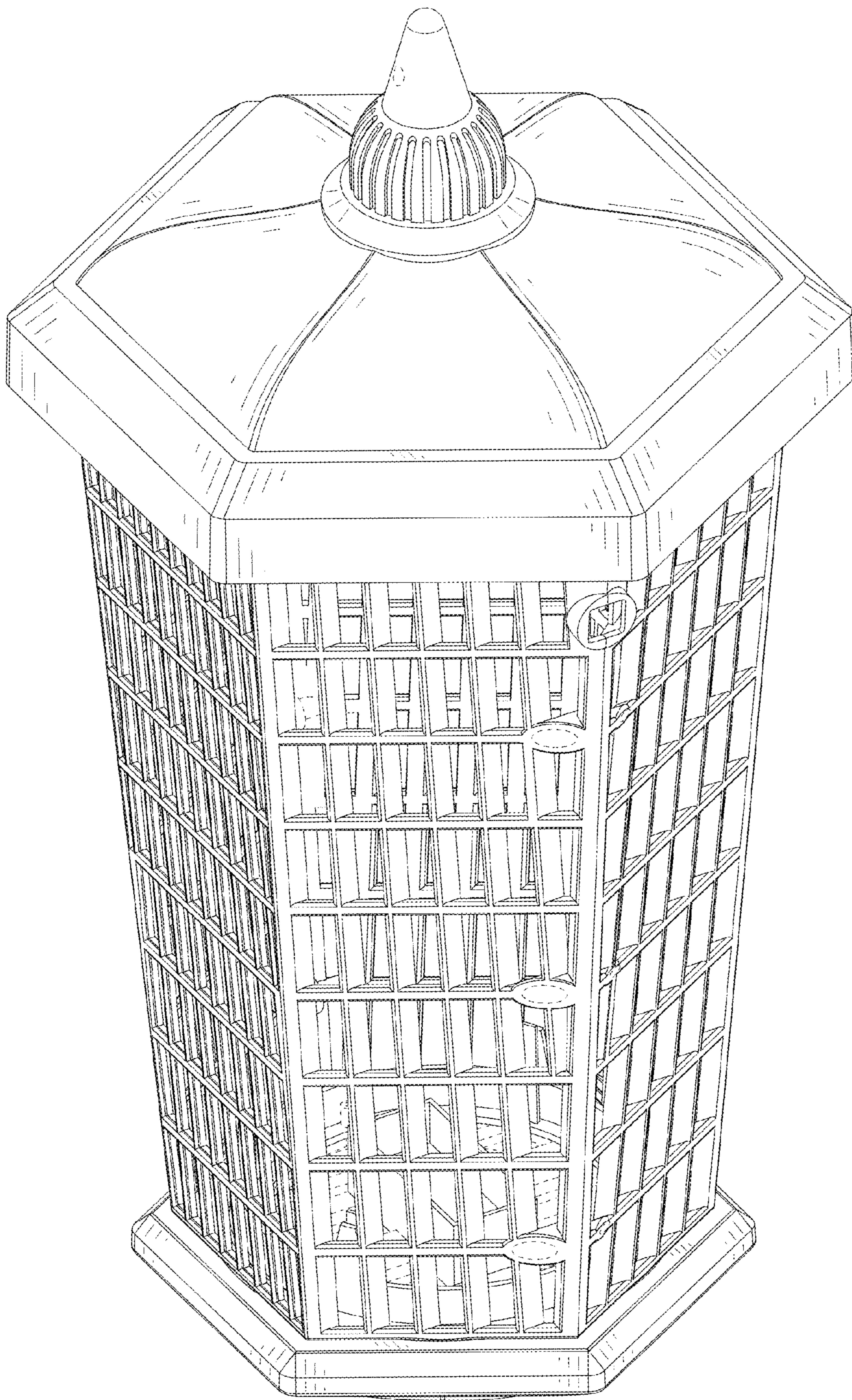

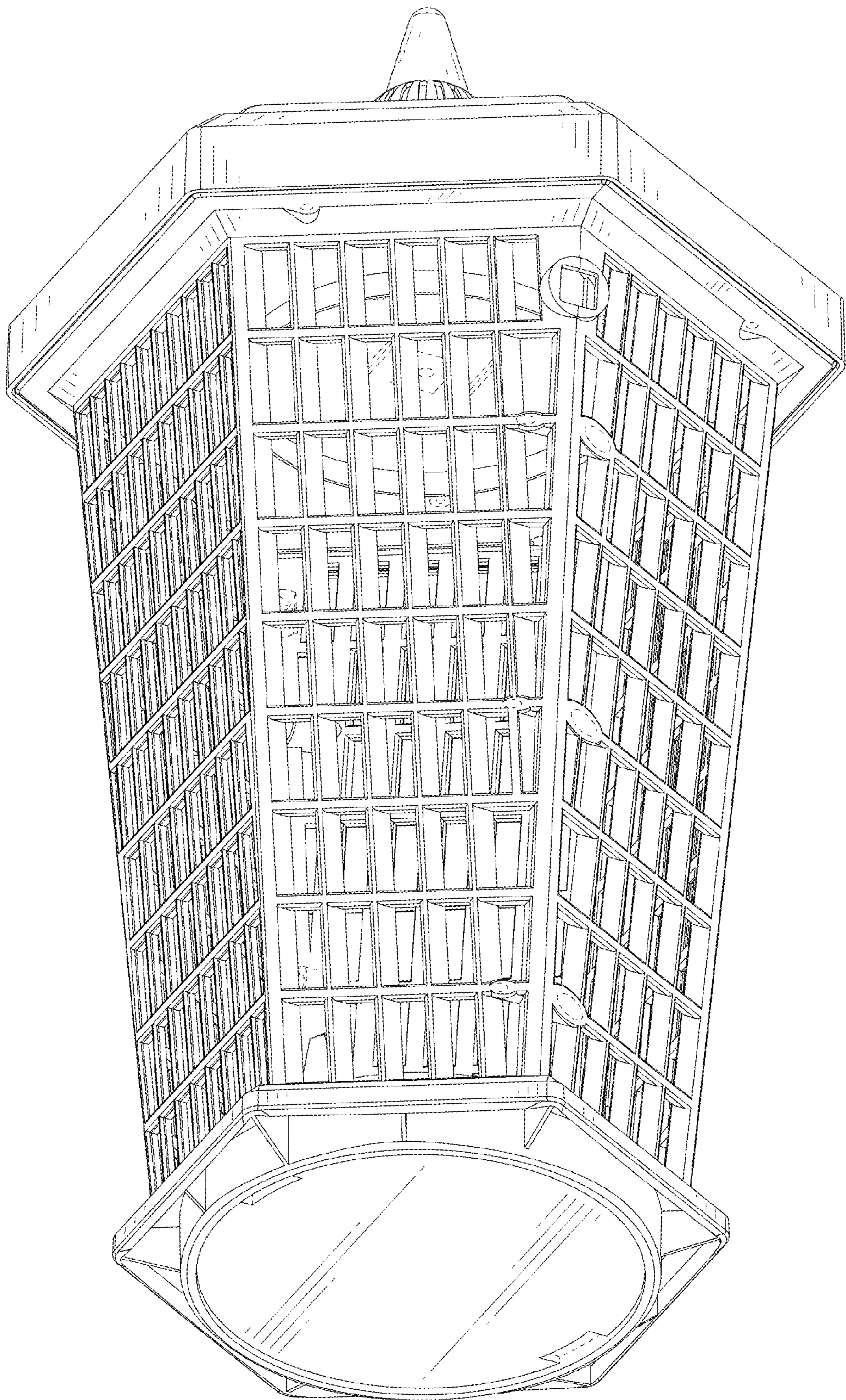

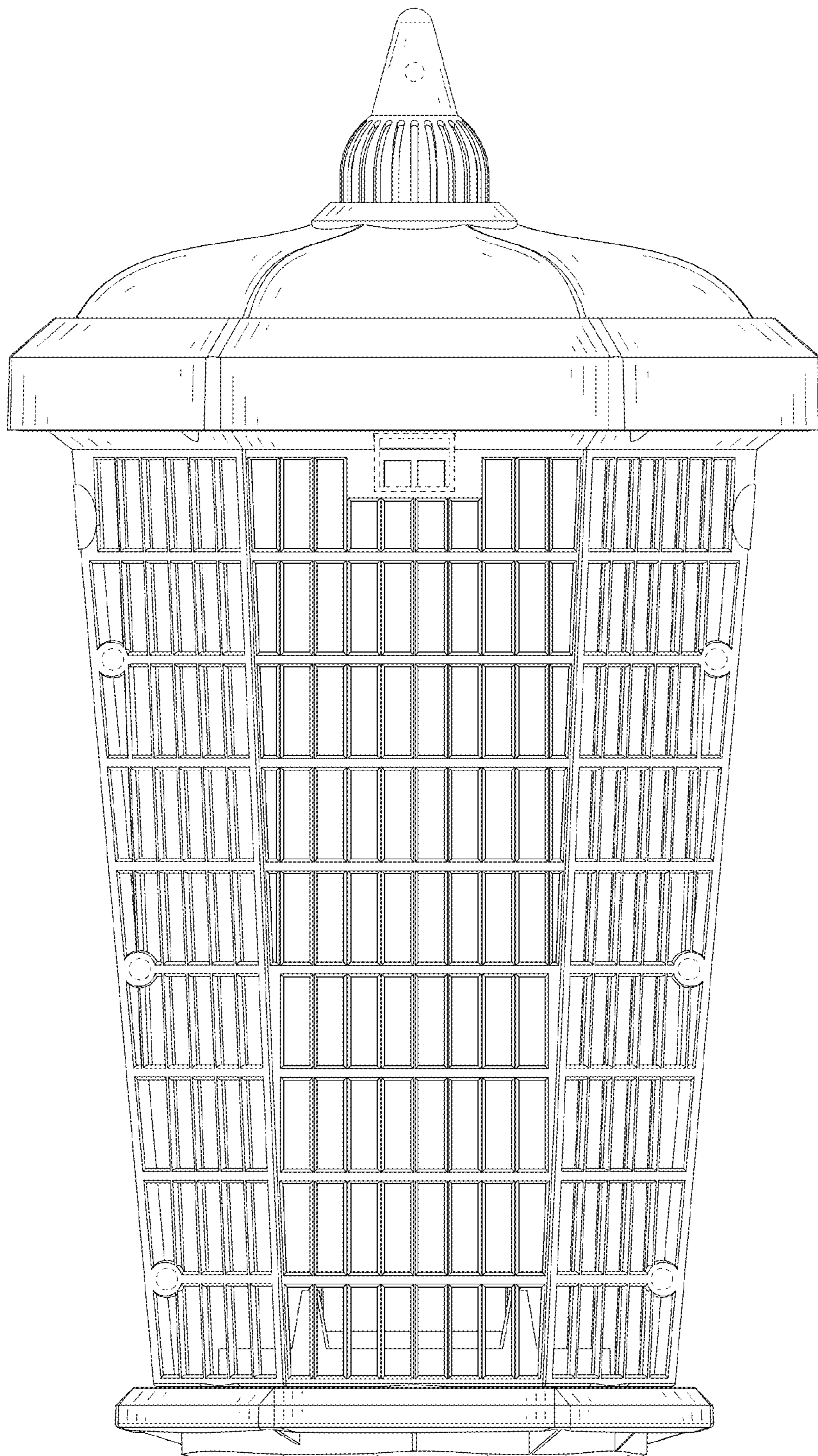

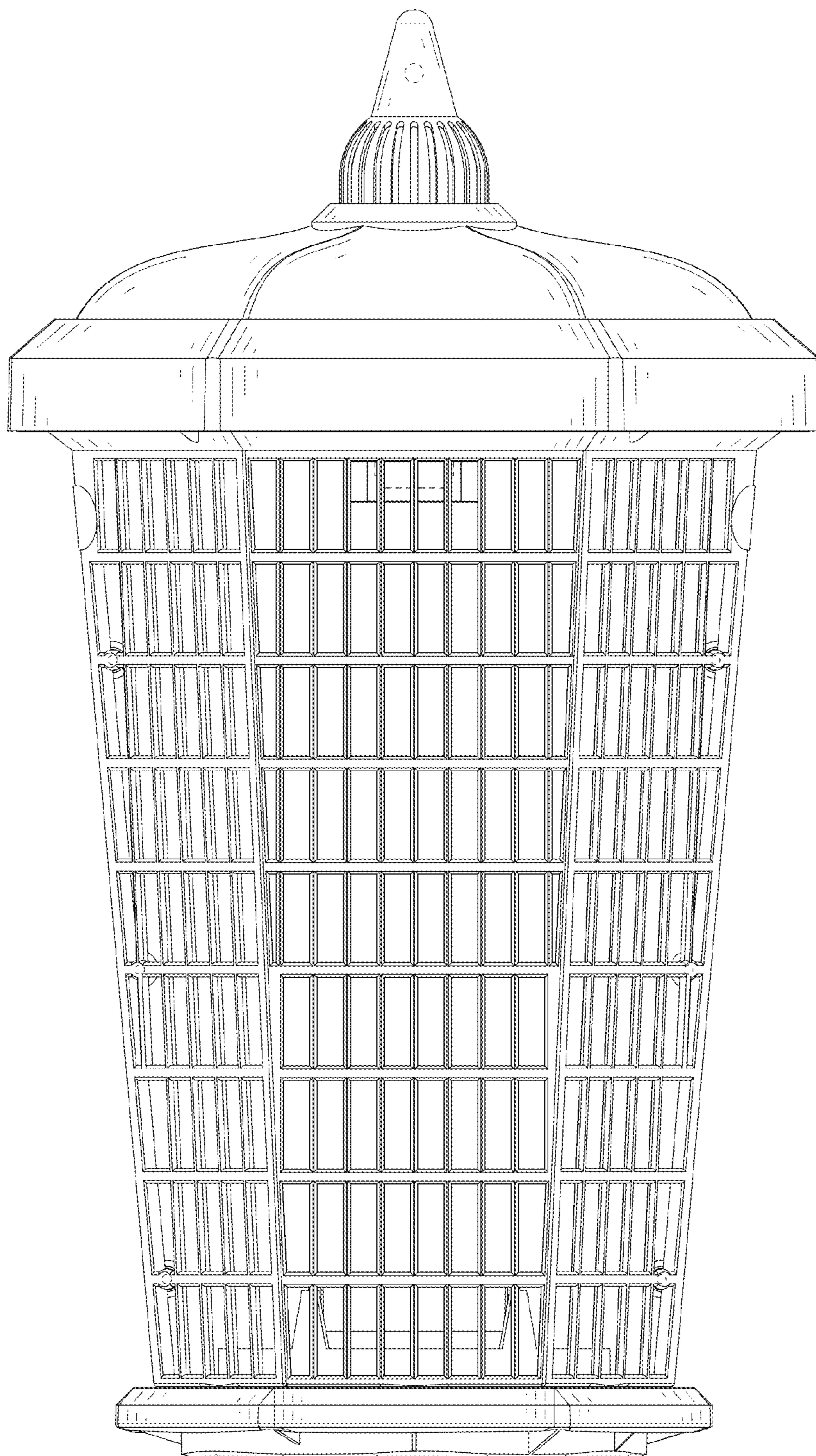

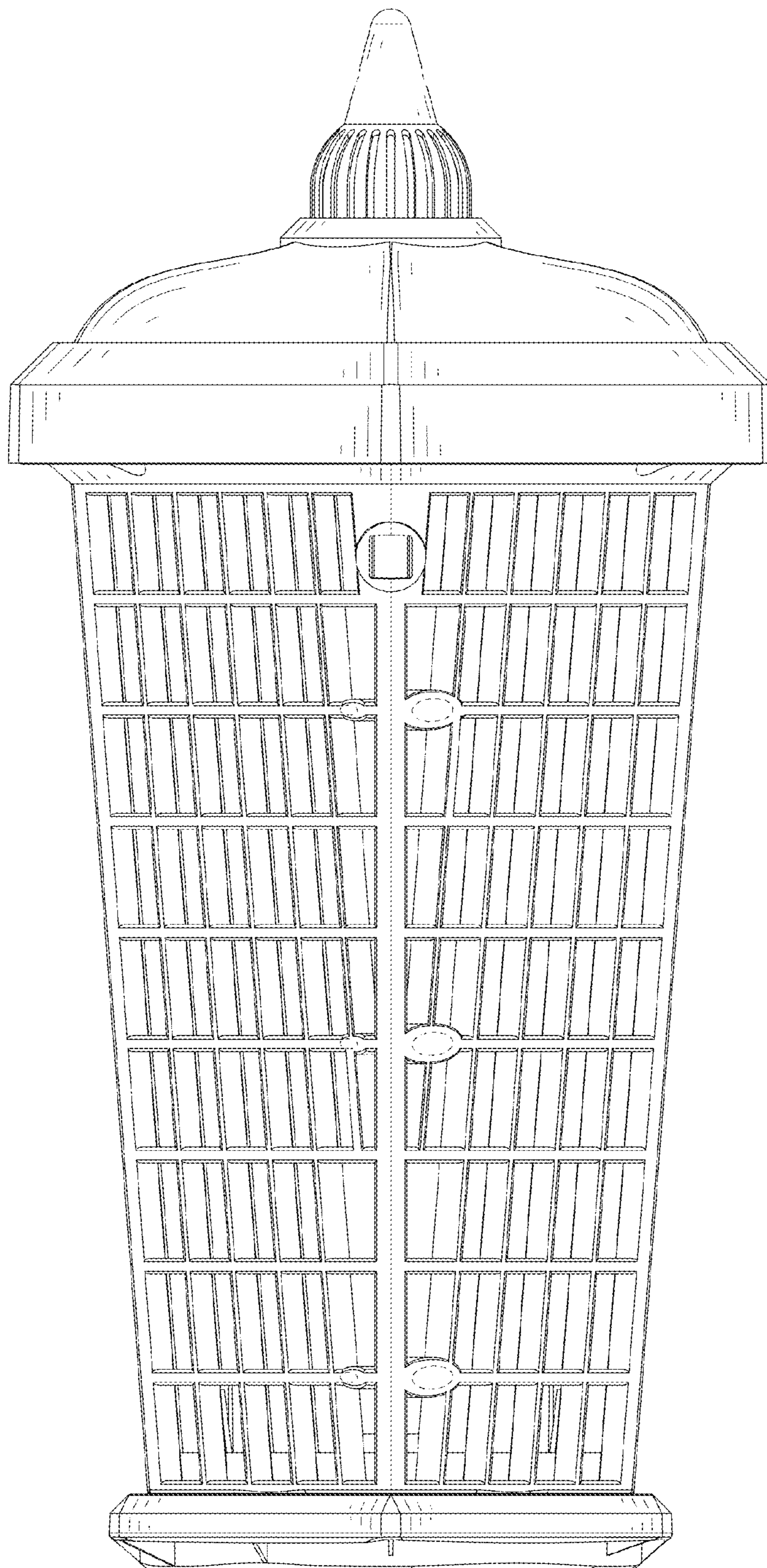

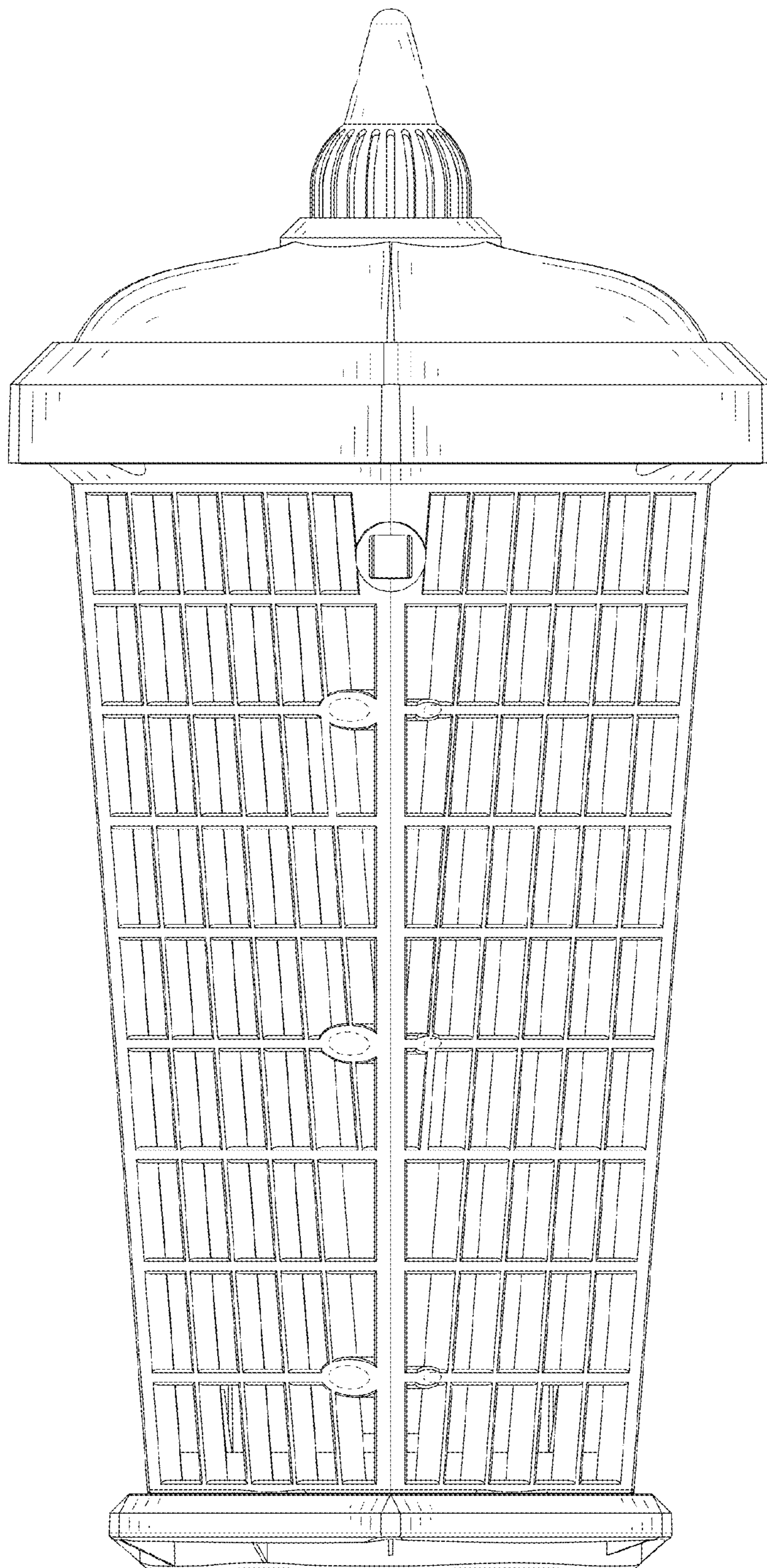

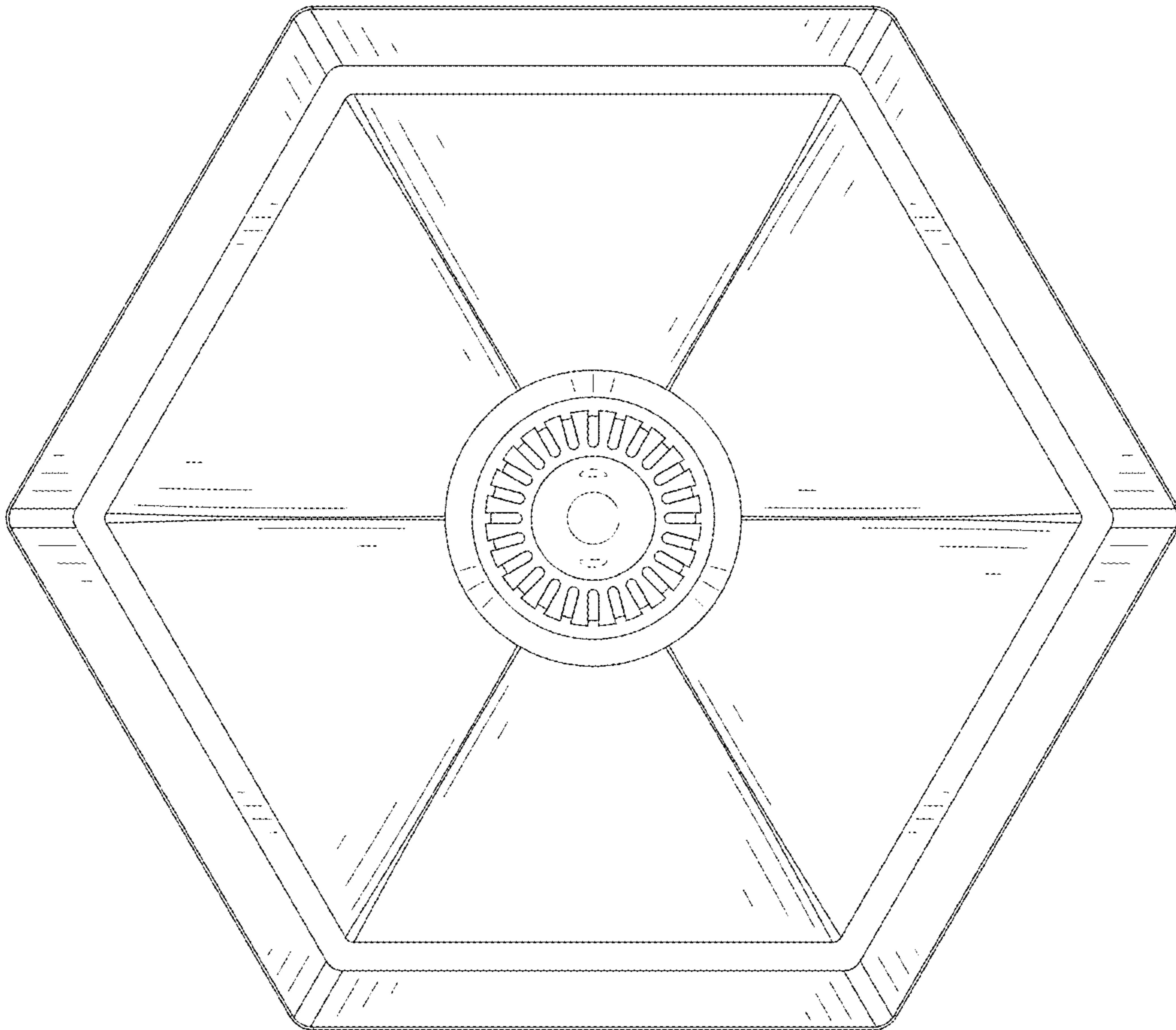

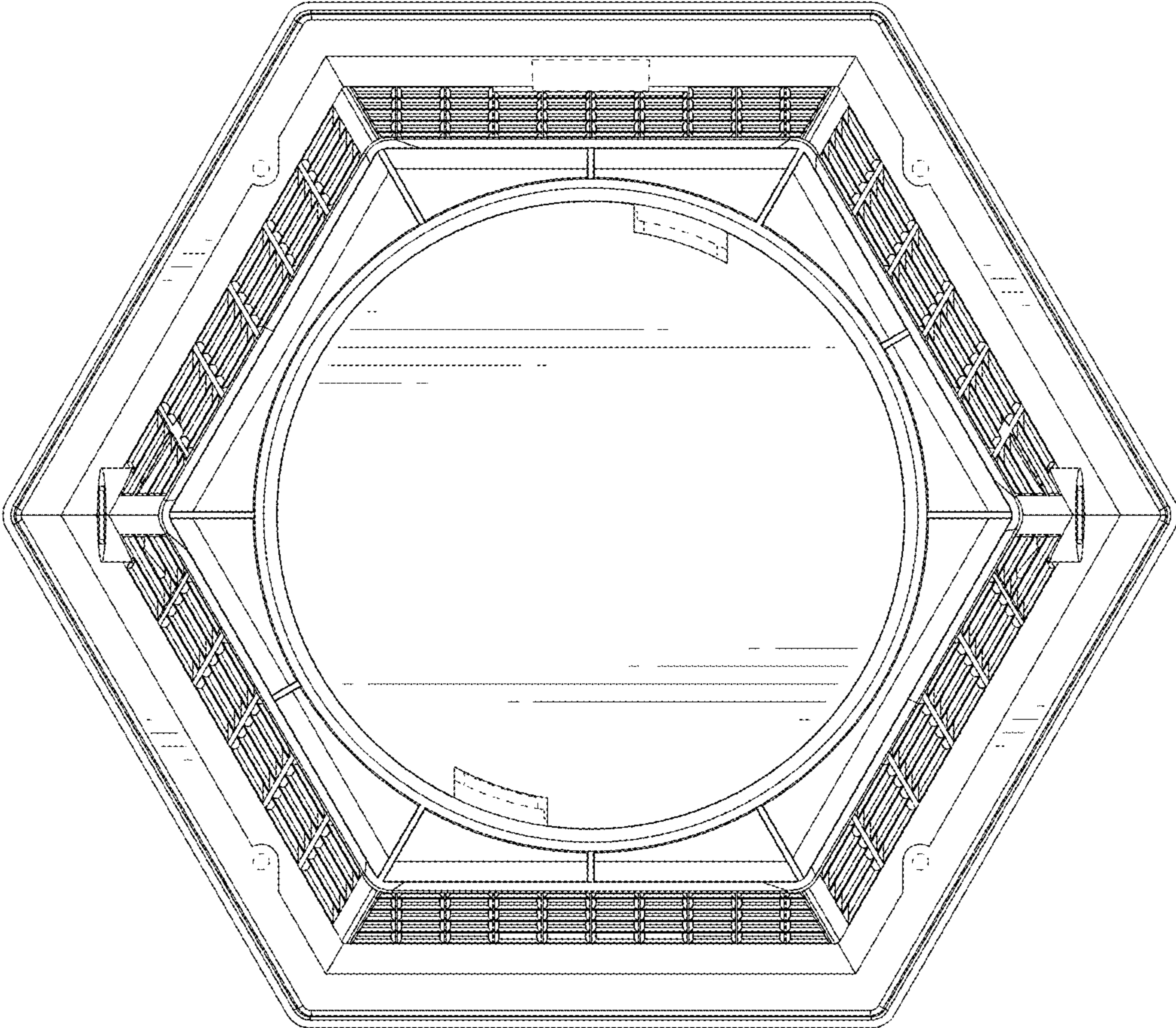
