FIG. 11 is a side elevational view of the clip of FIG. 7, and,

FIG. 12 is a side elevational view of the clip of FIG. 7, from the other side to that of FIG. 11.

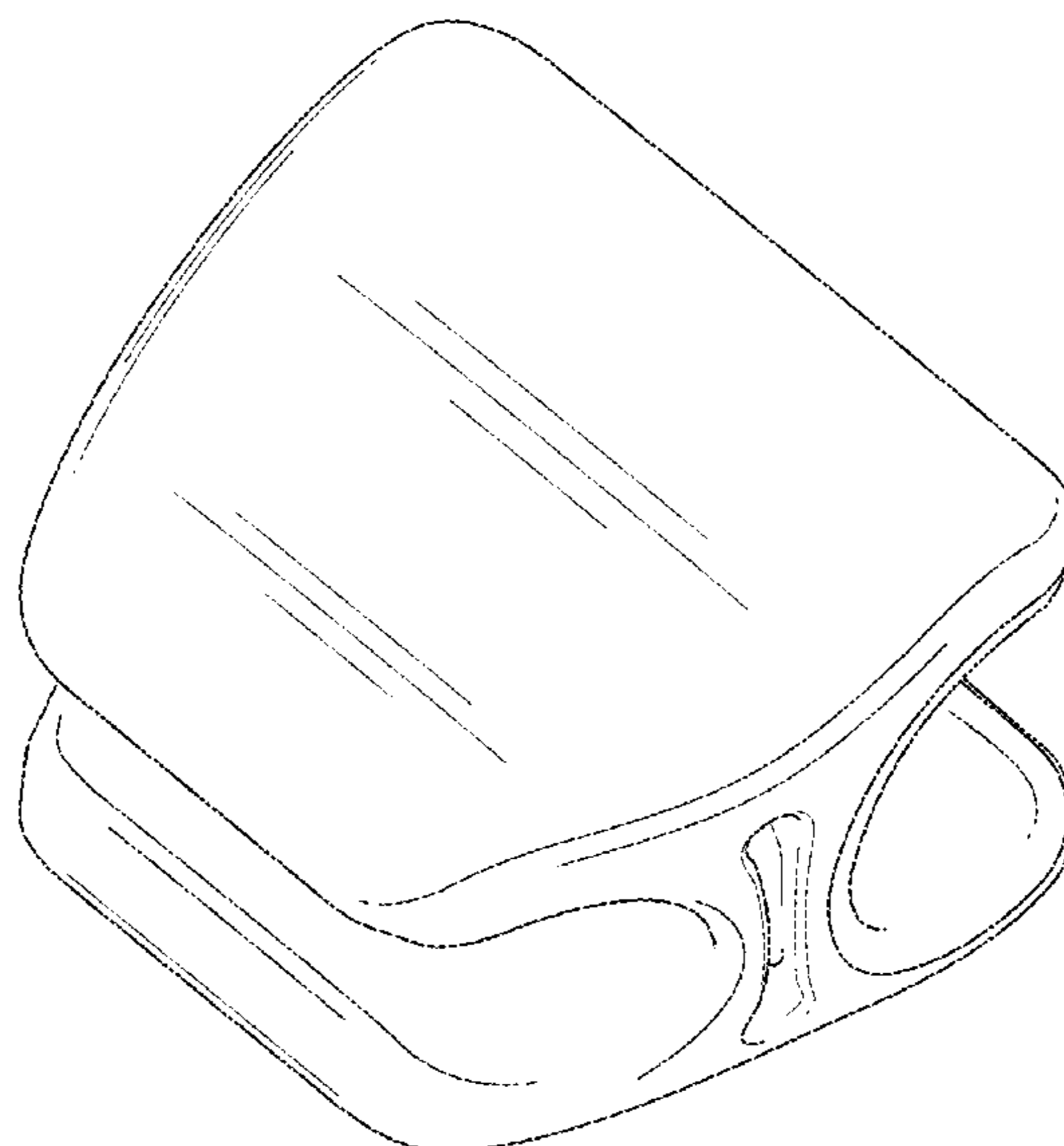

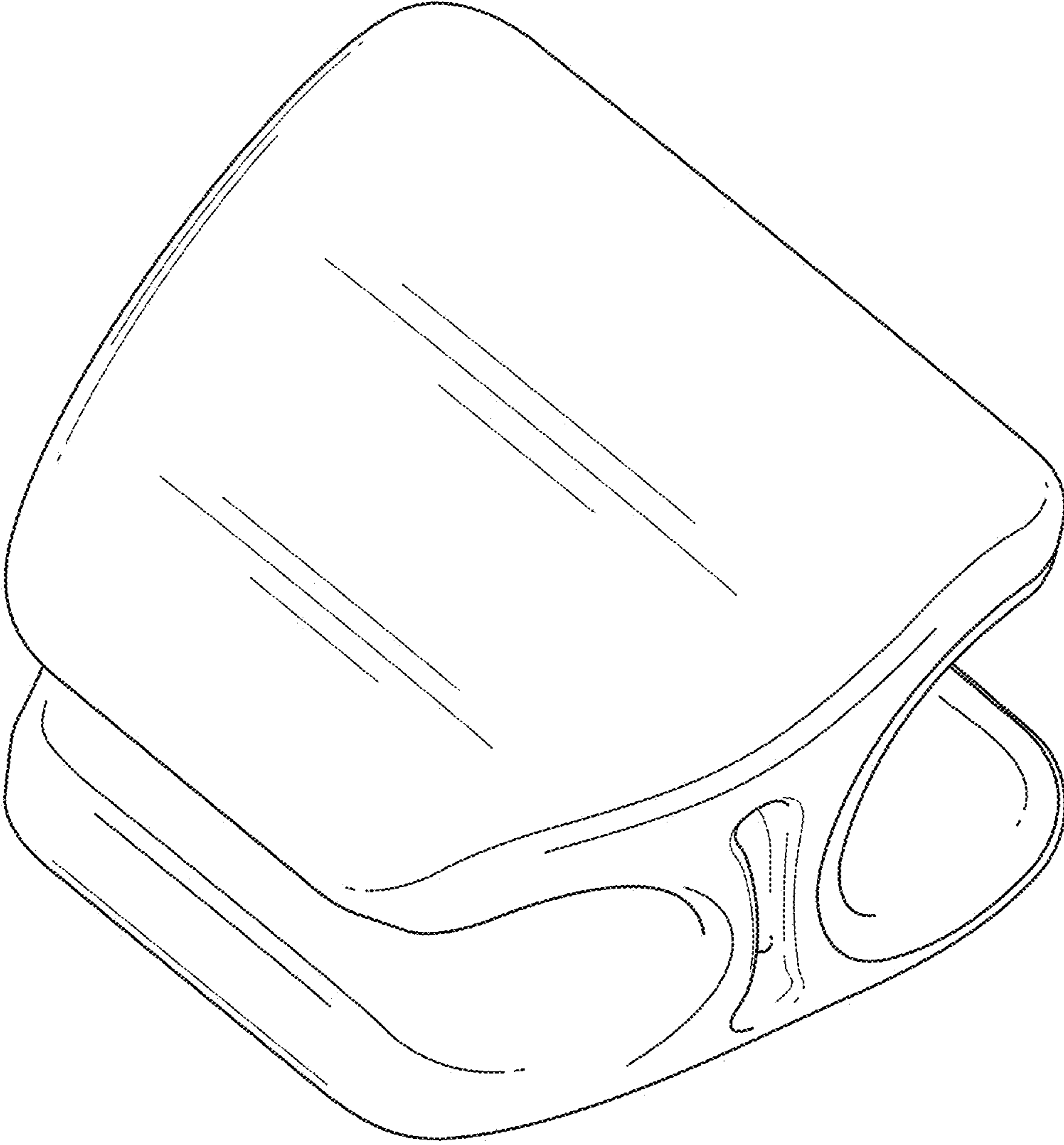

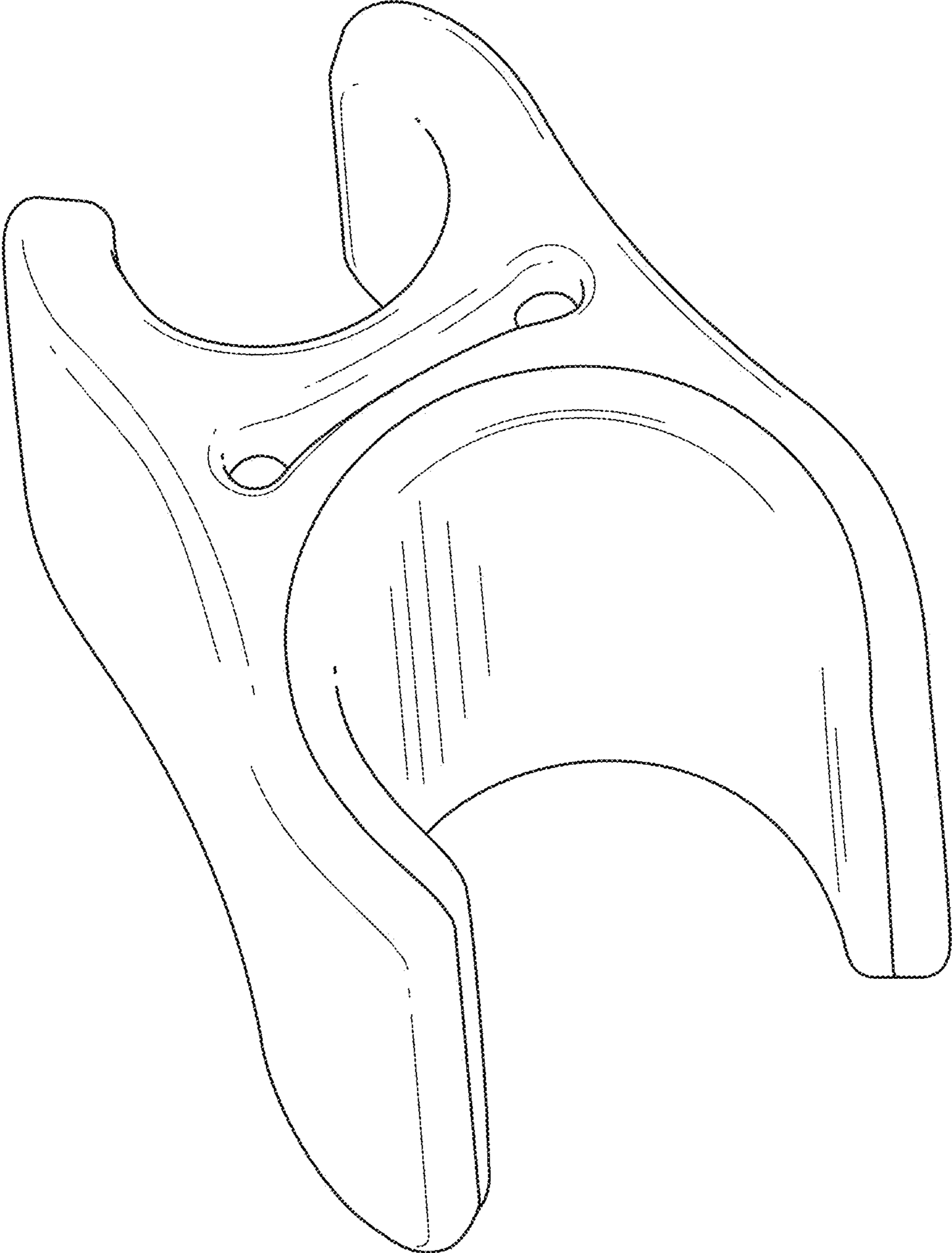

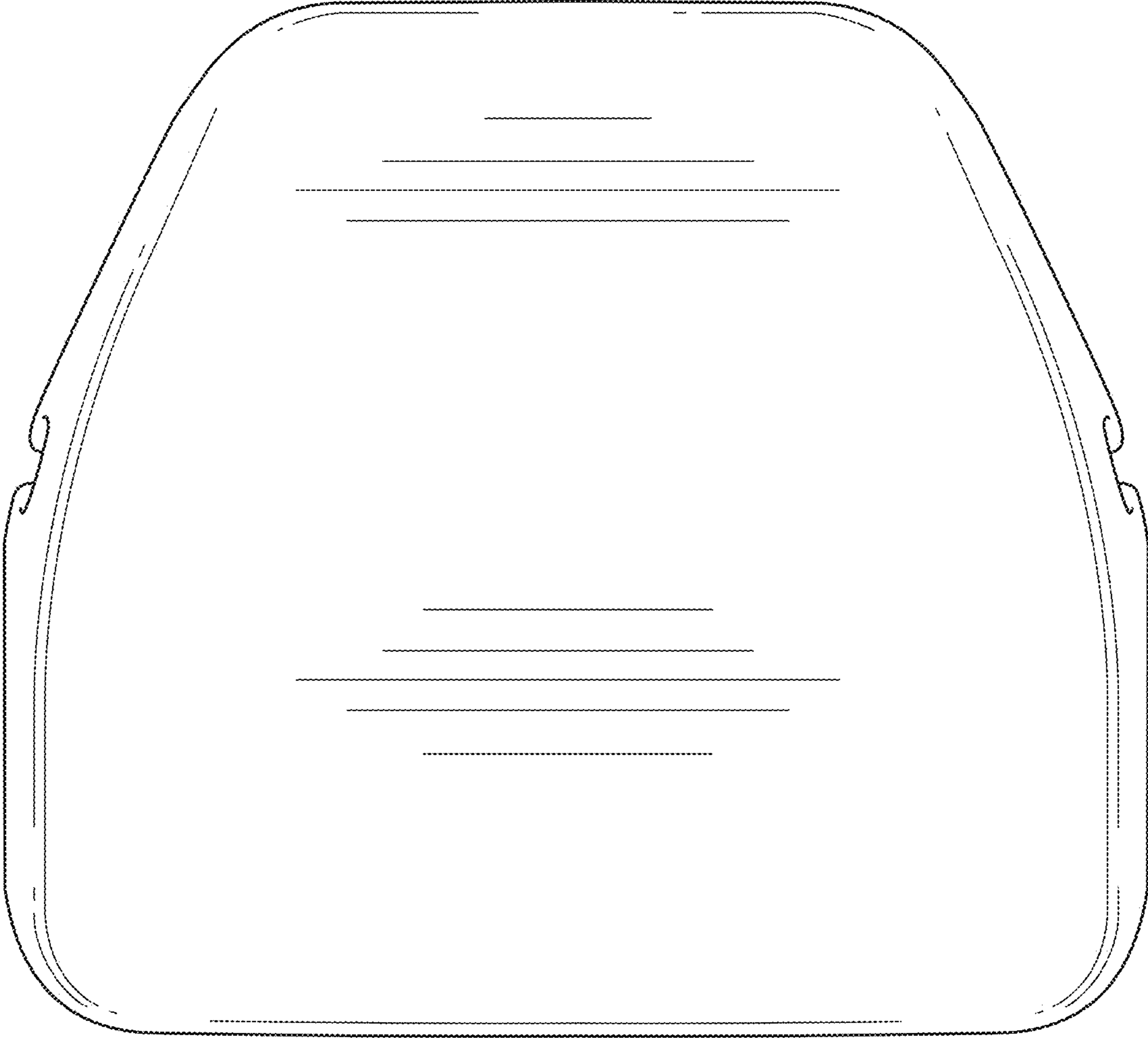

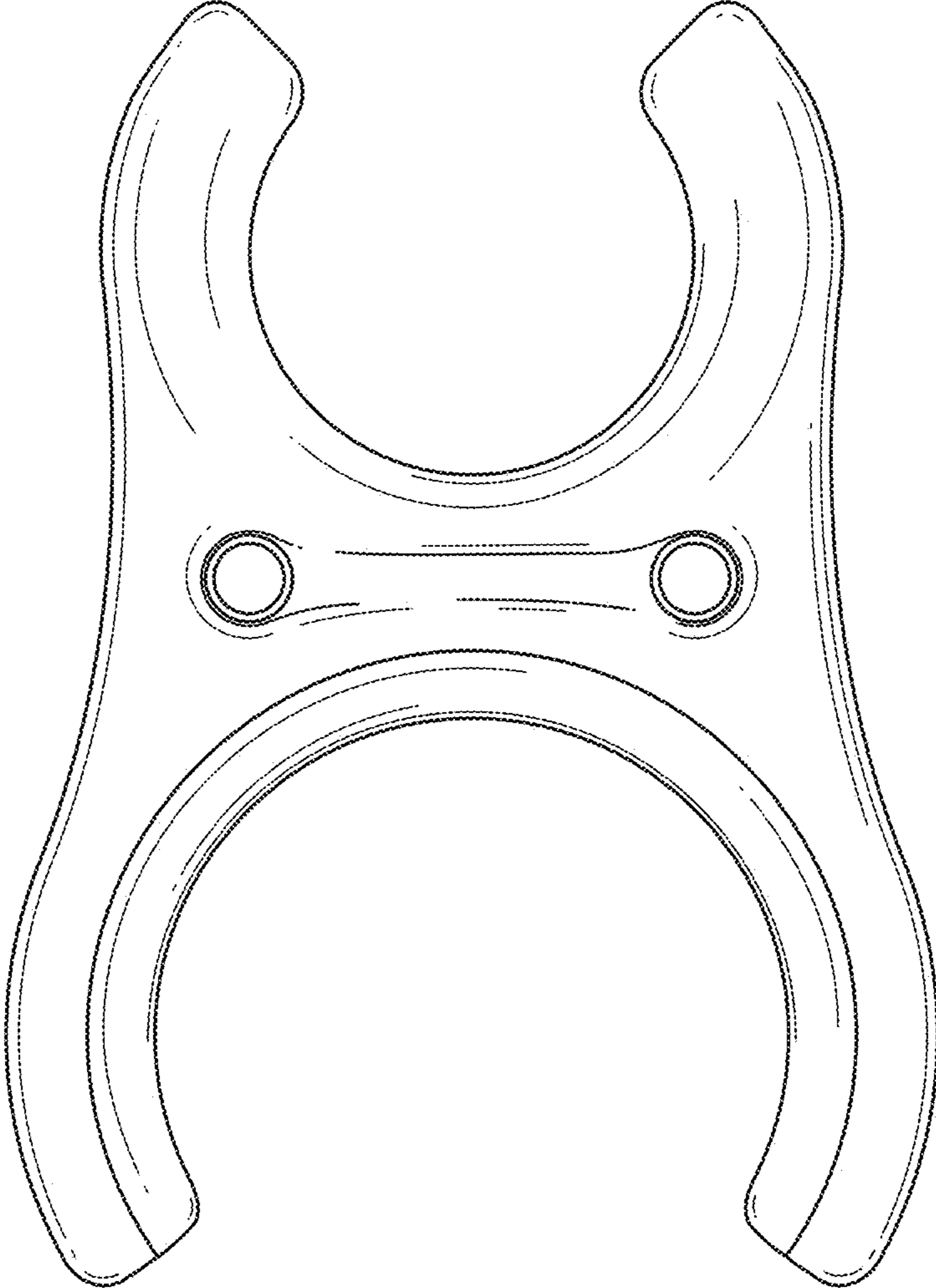

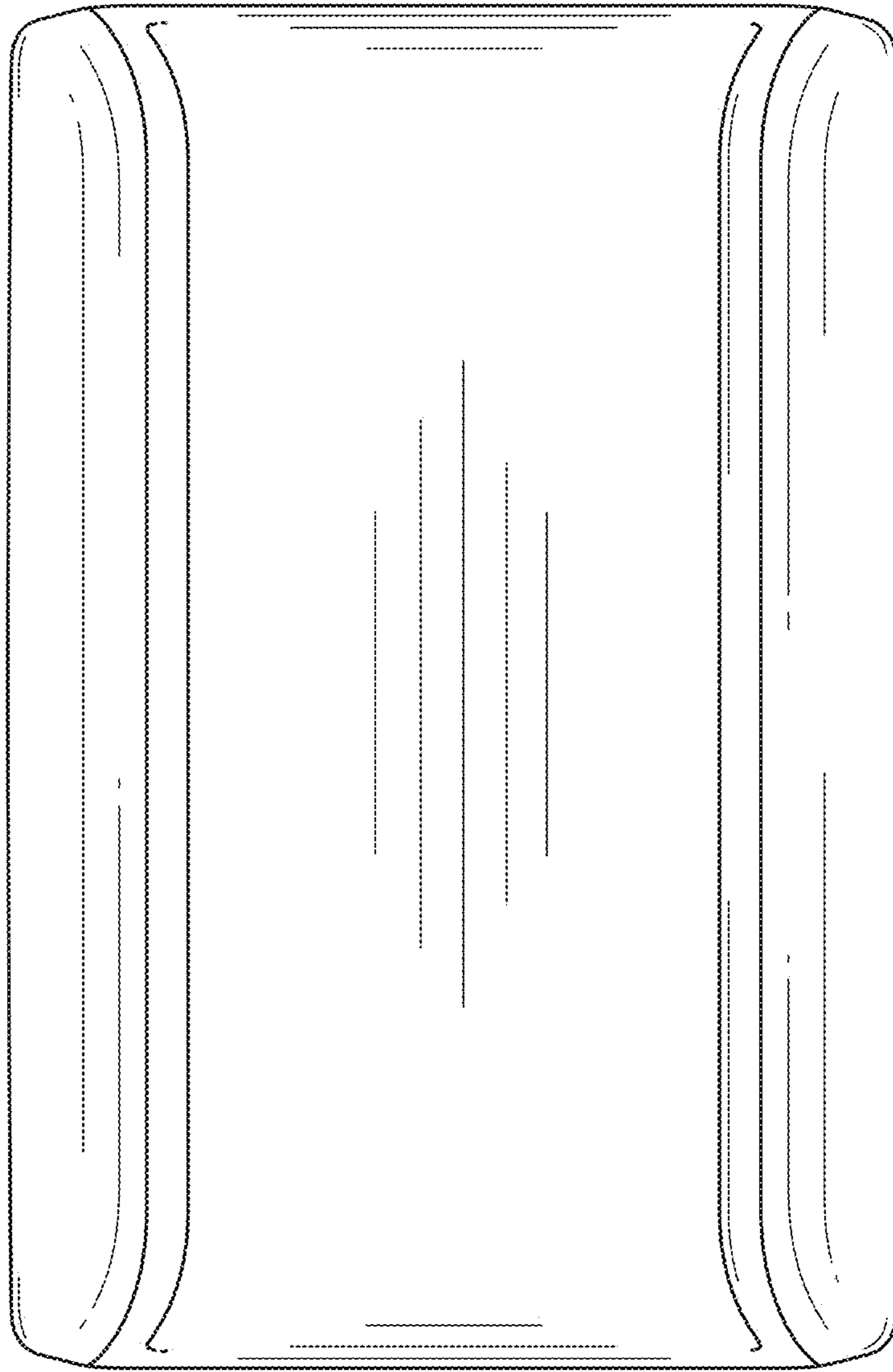

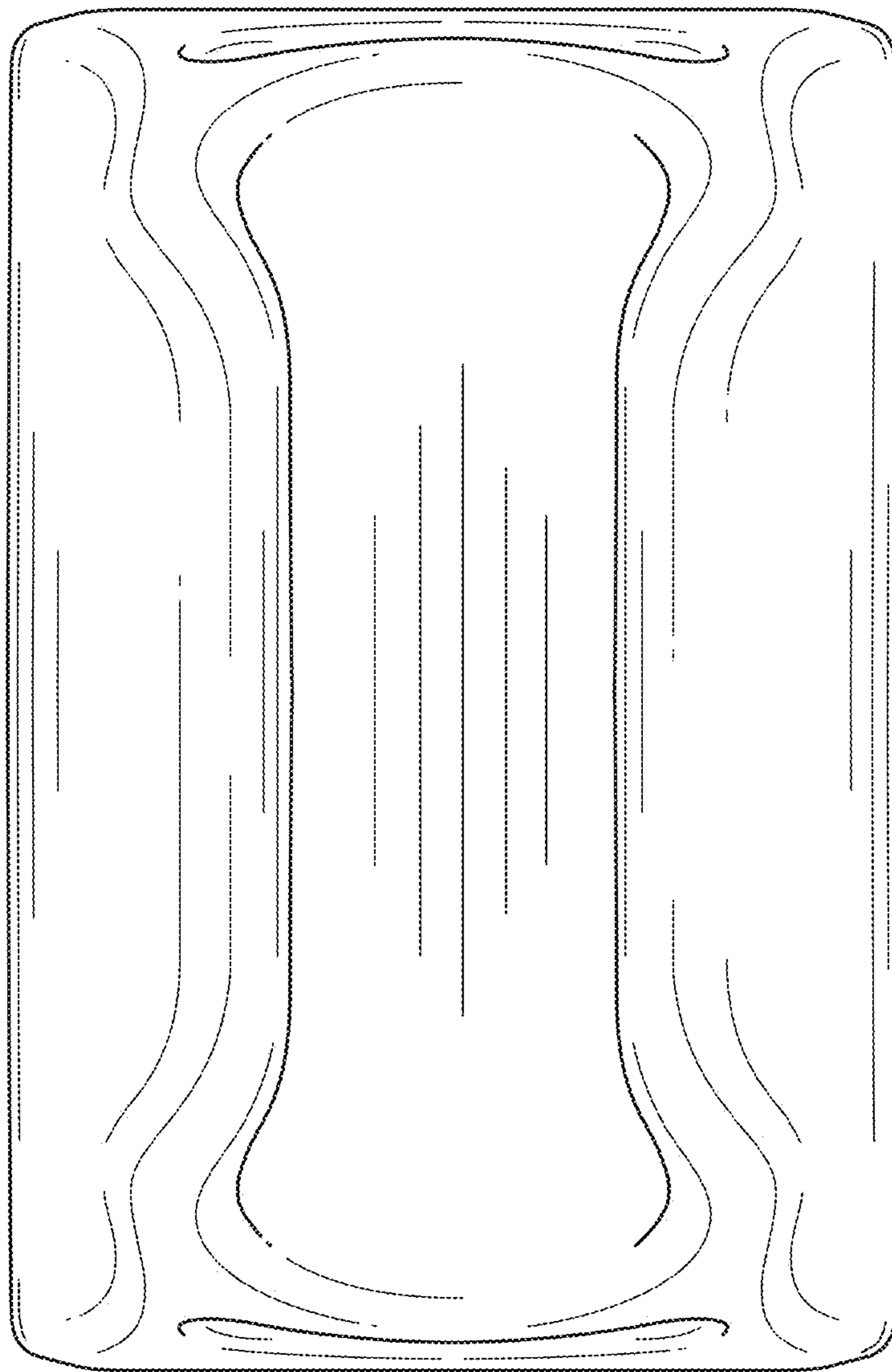

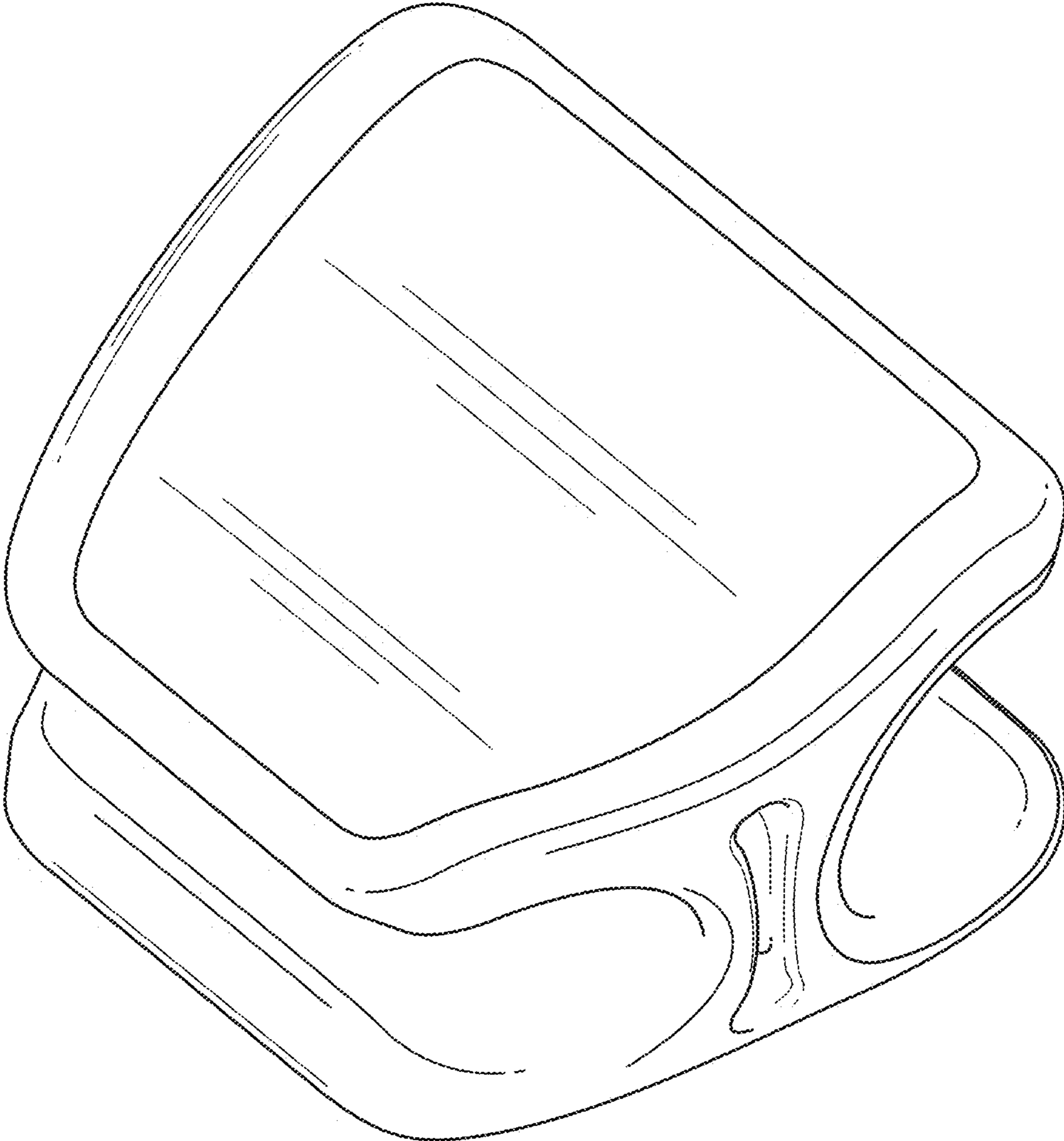

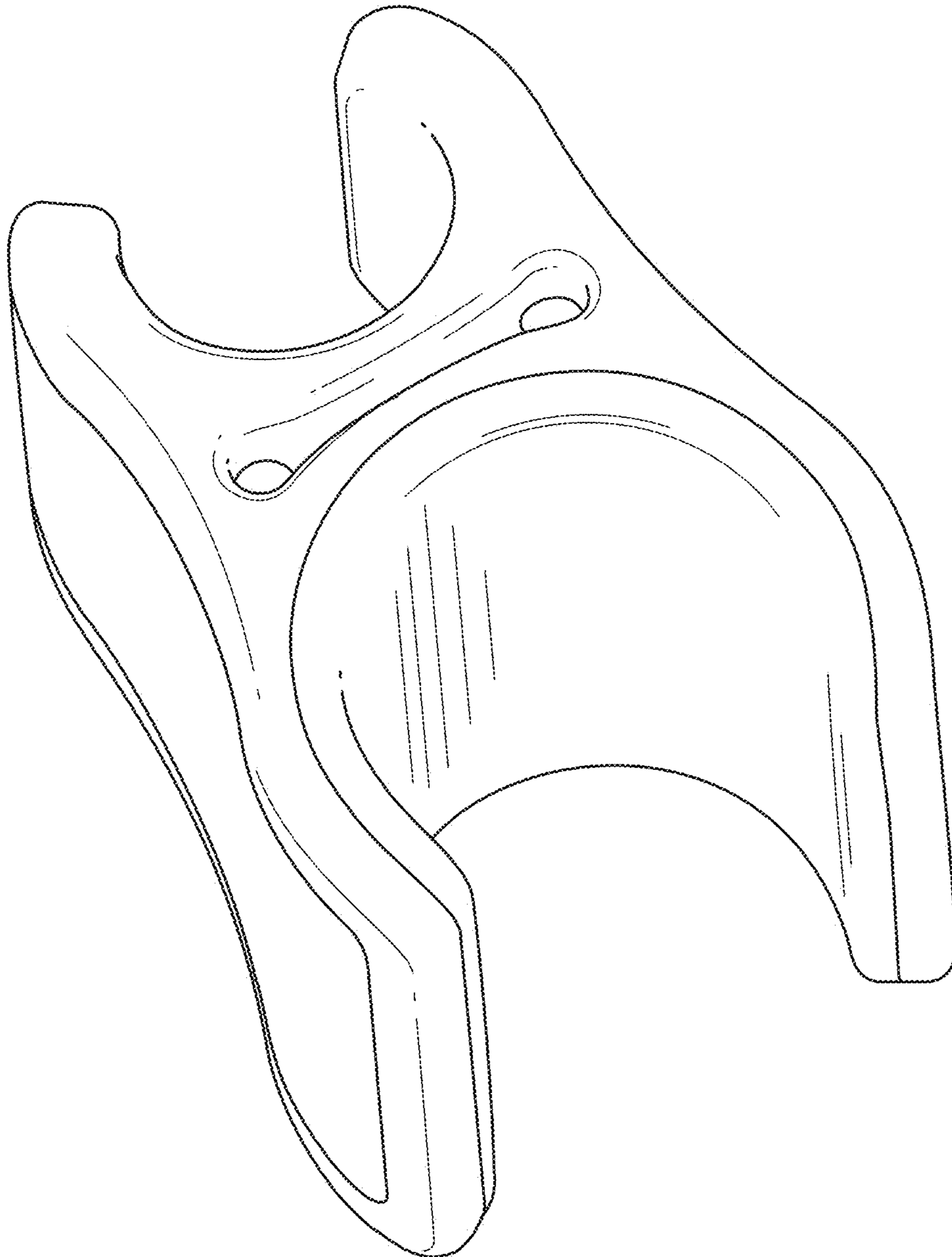

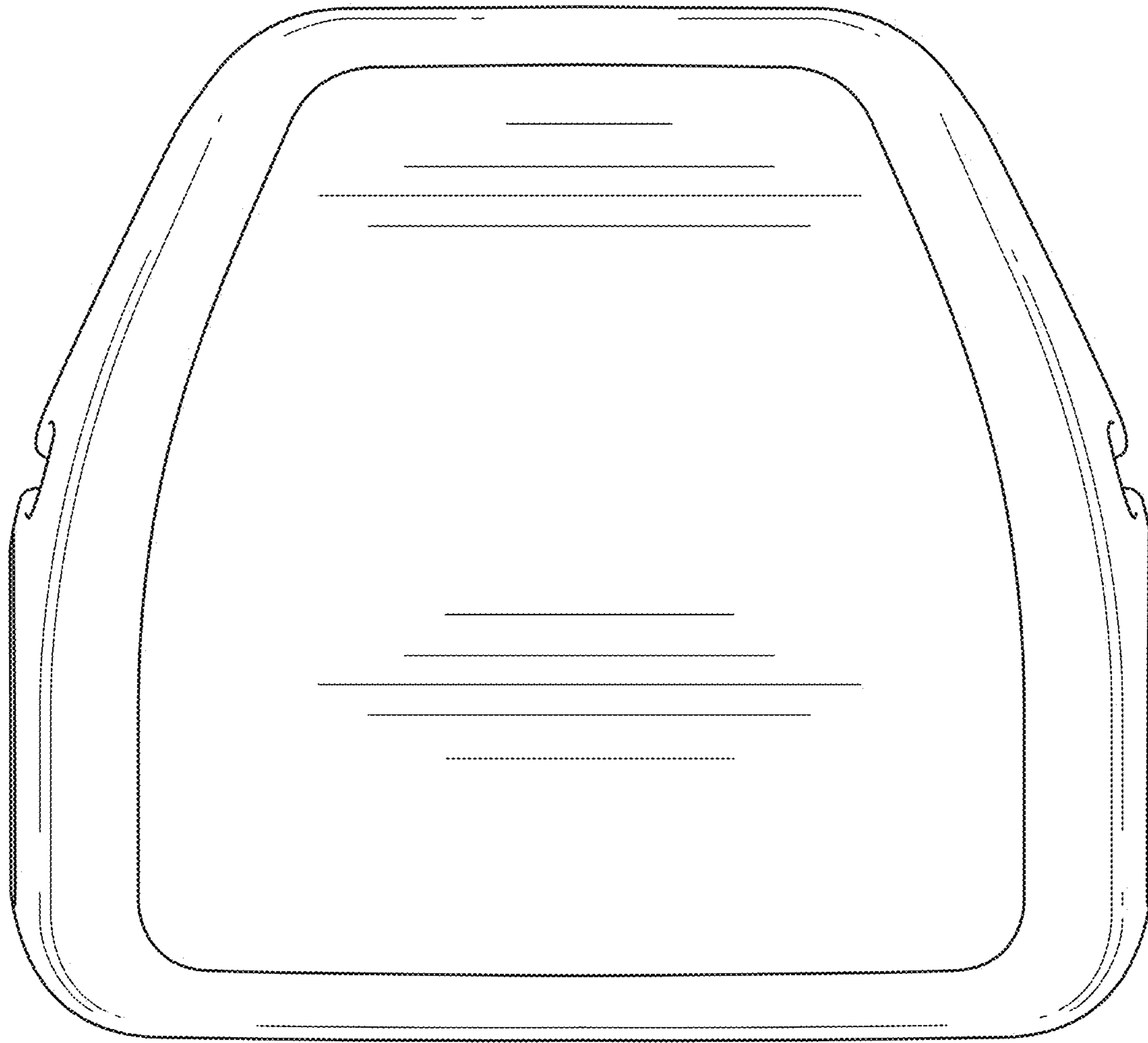

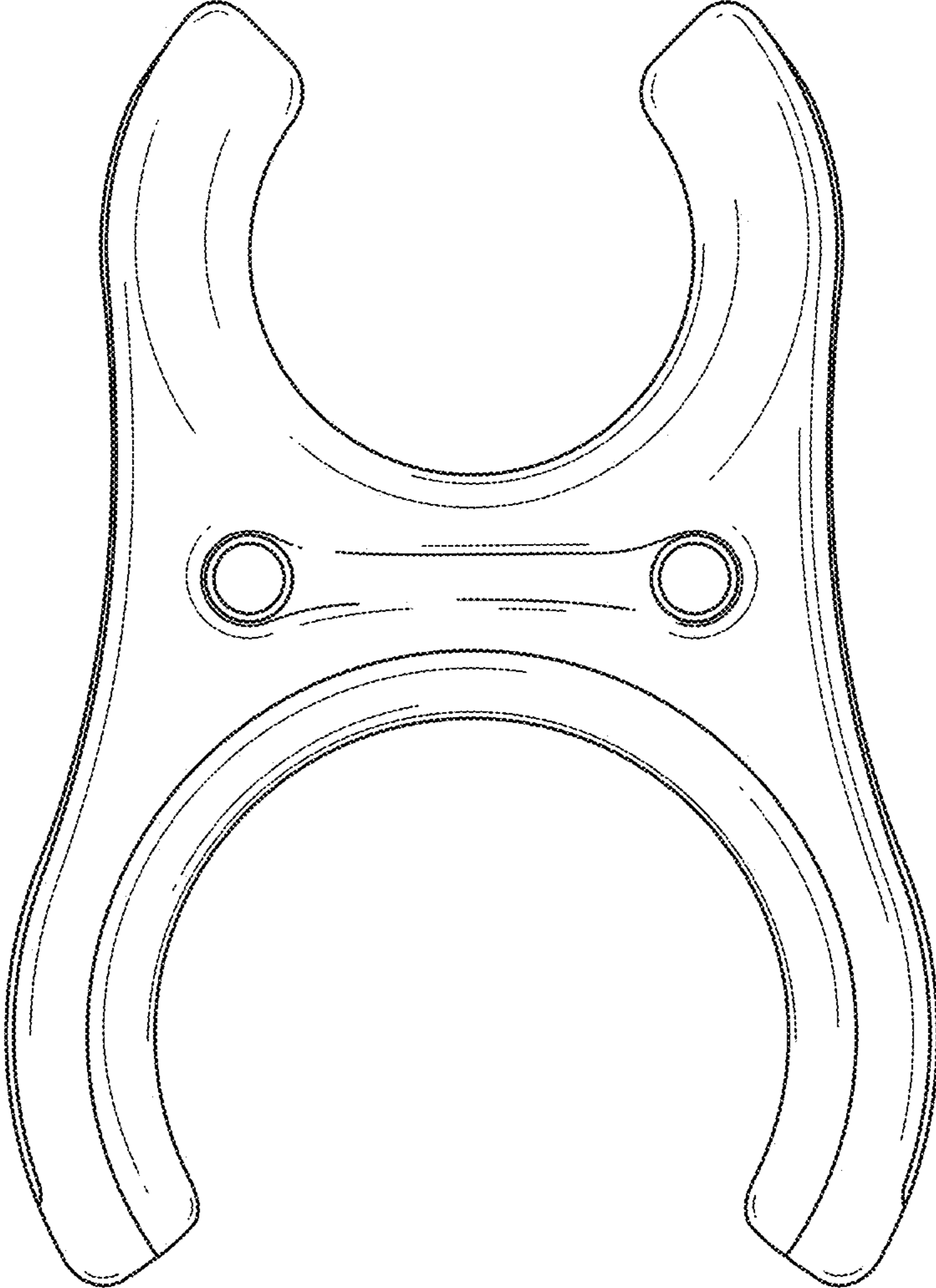

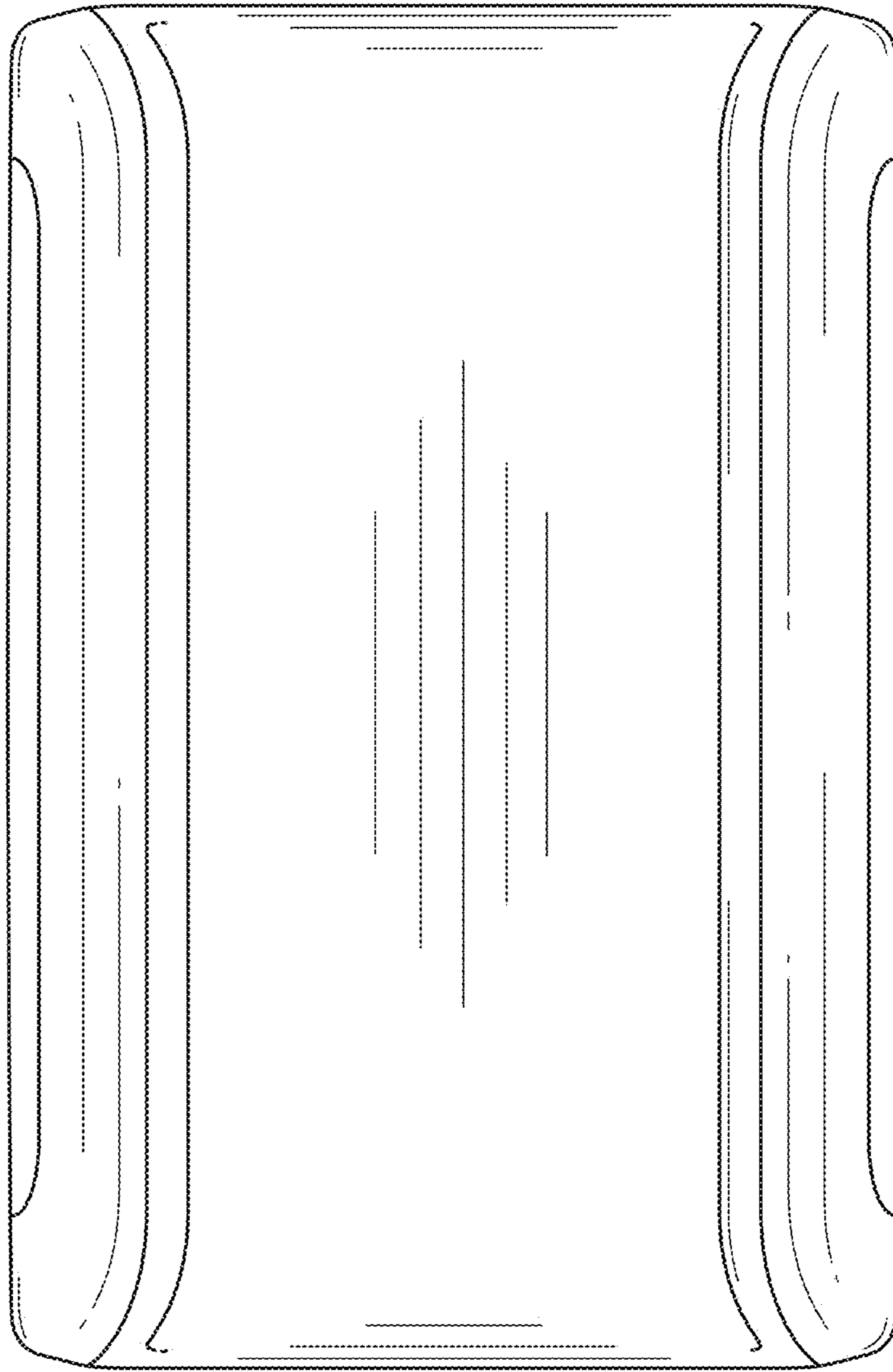

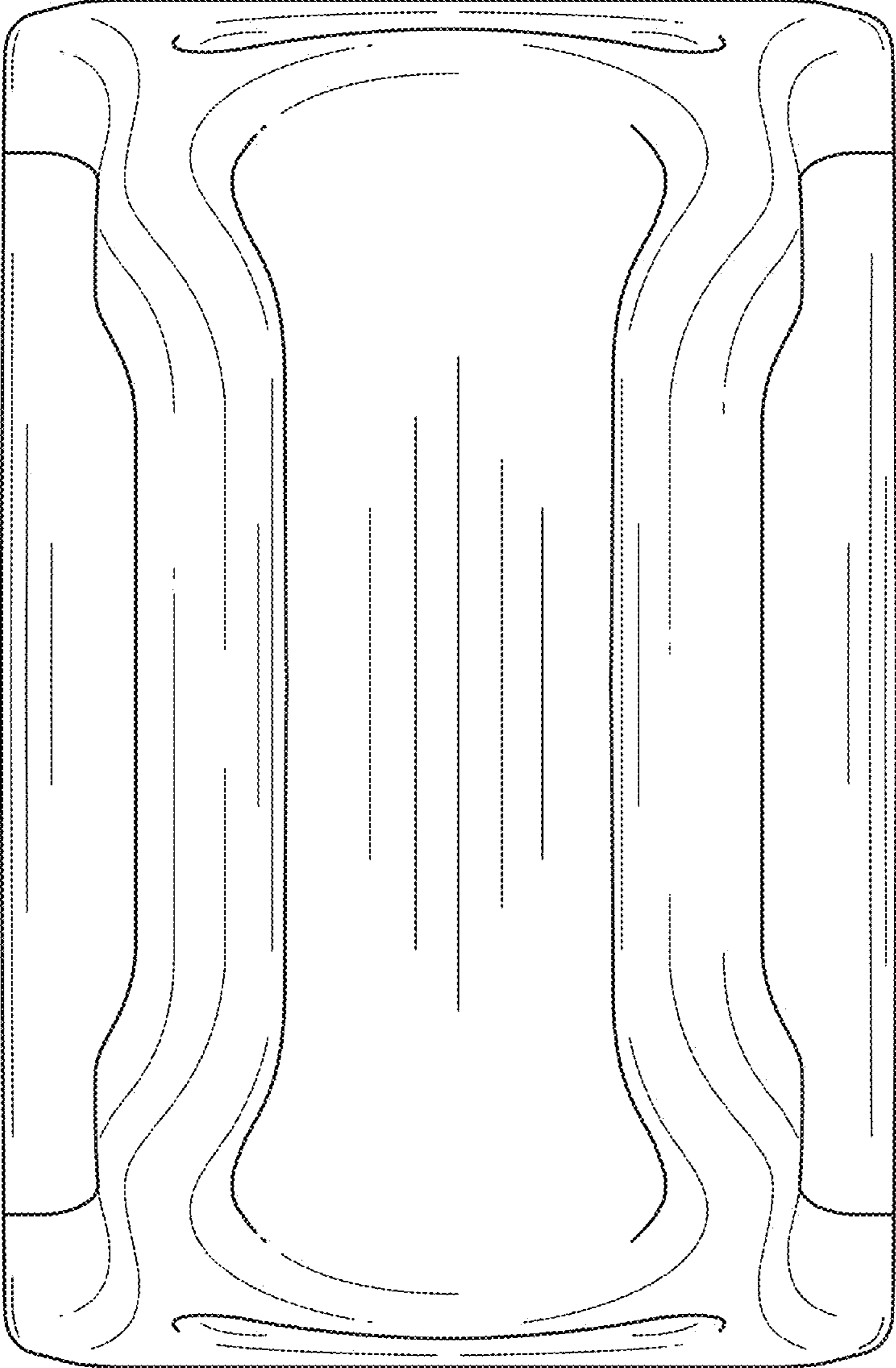
