(57) **CLAIM**

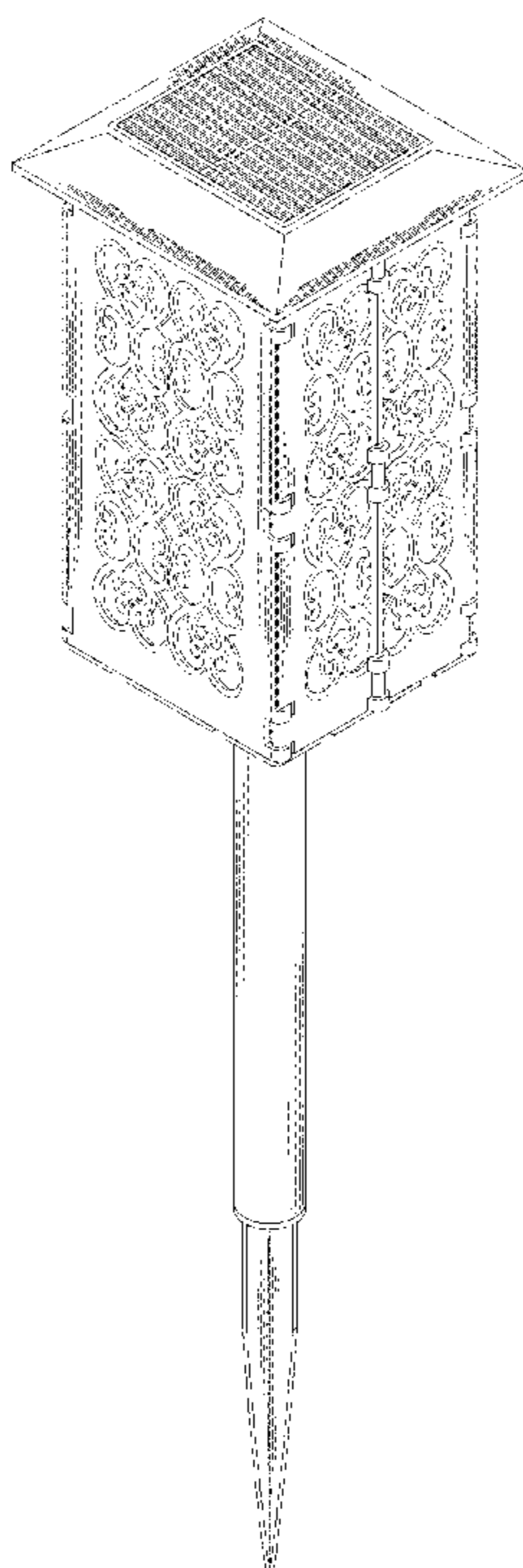
The ornamental design for a solar folding ground light, as shown and described.

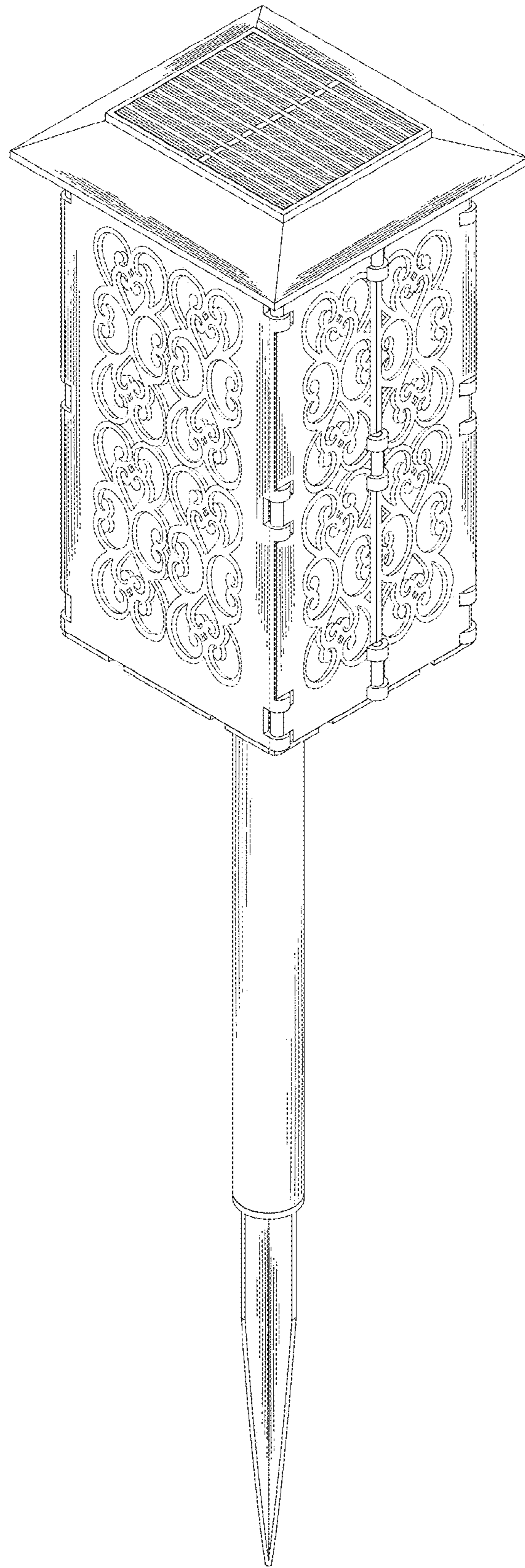

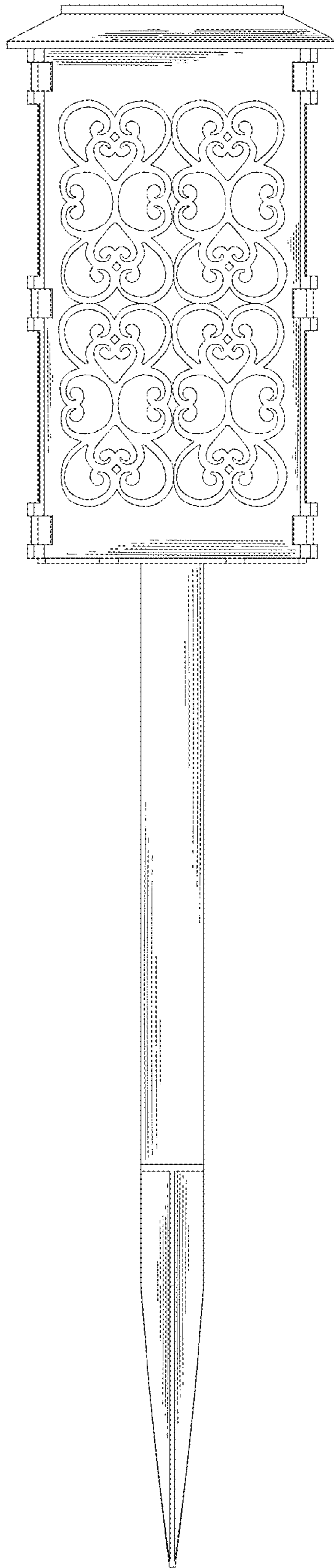

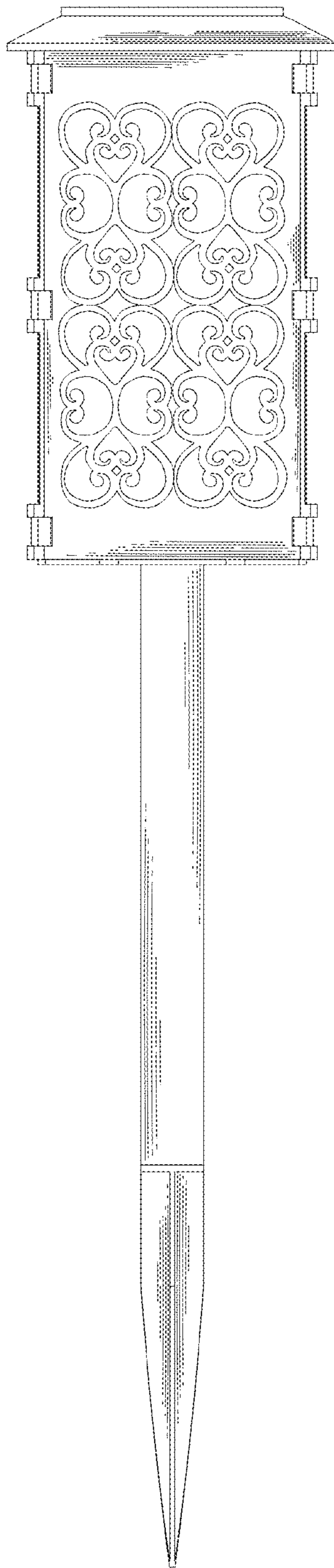

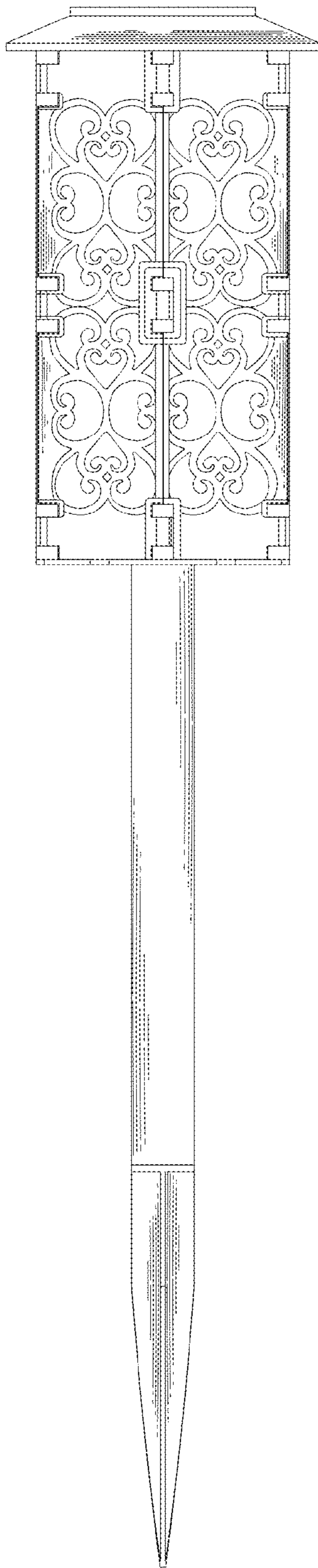

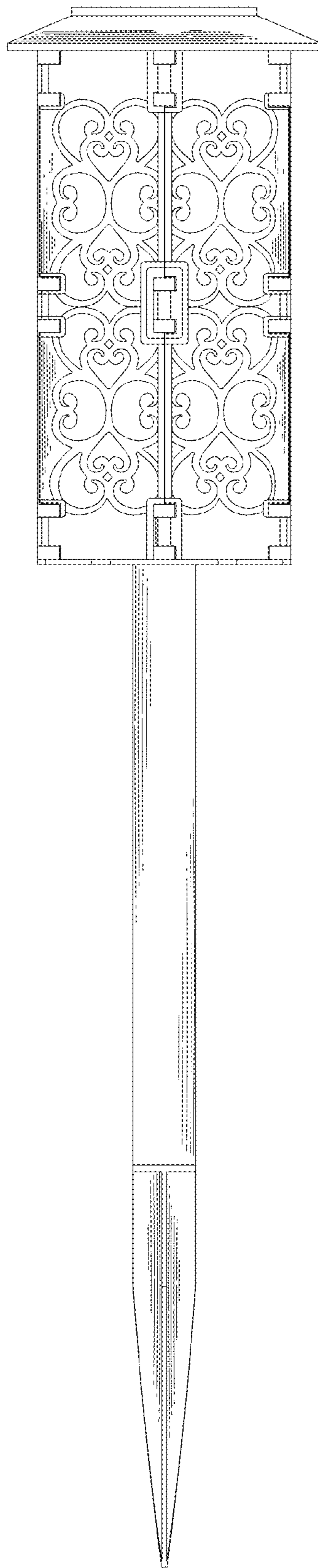

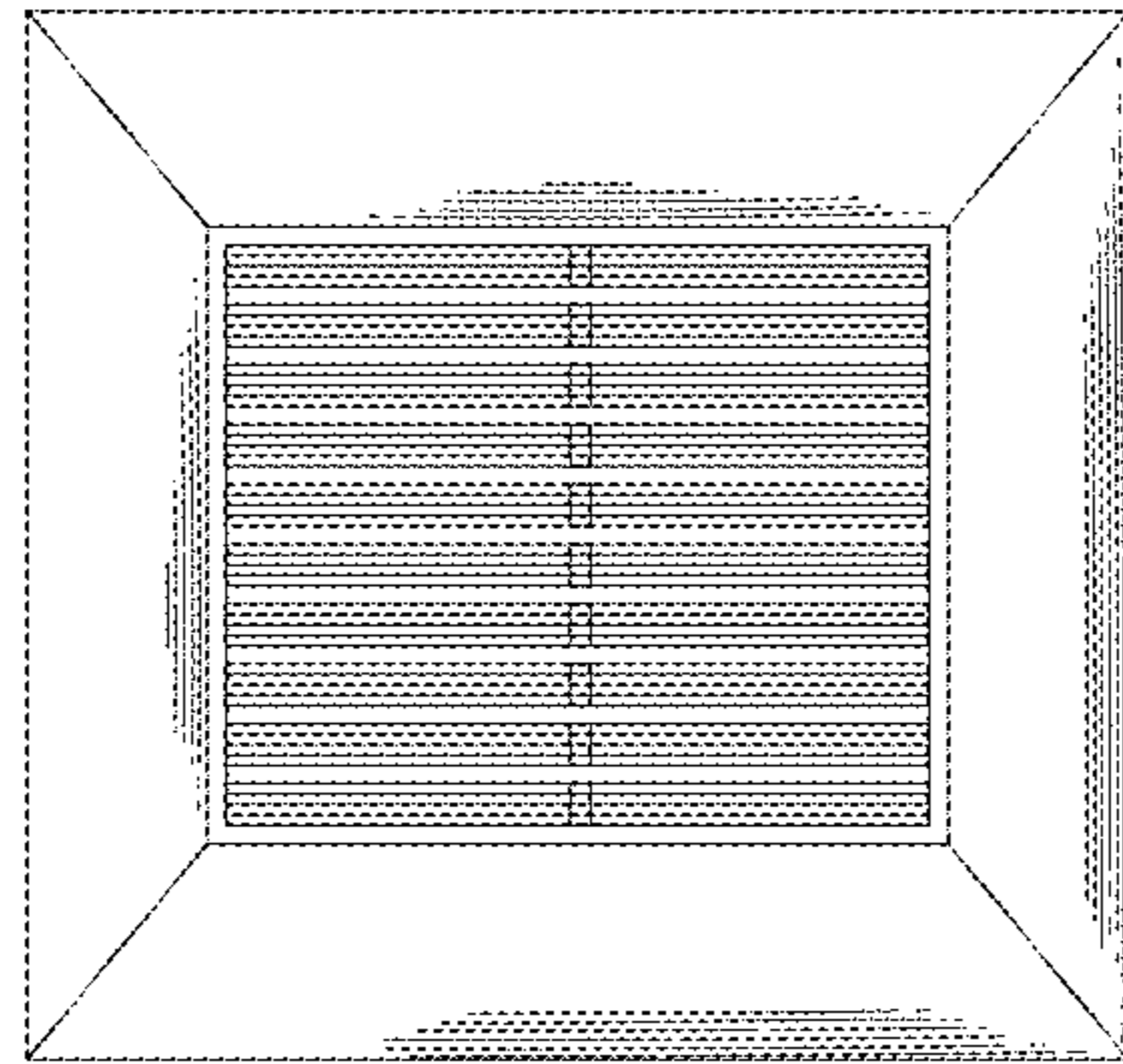

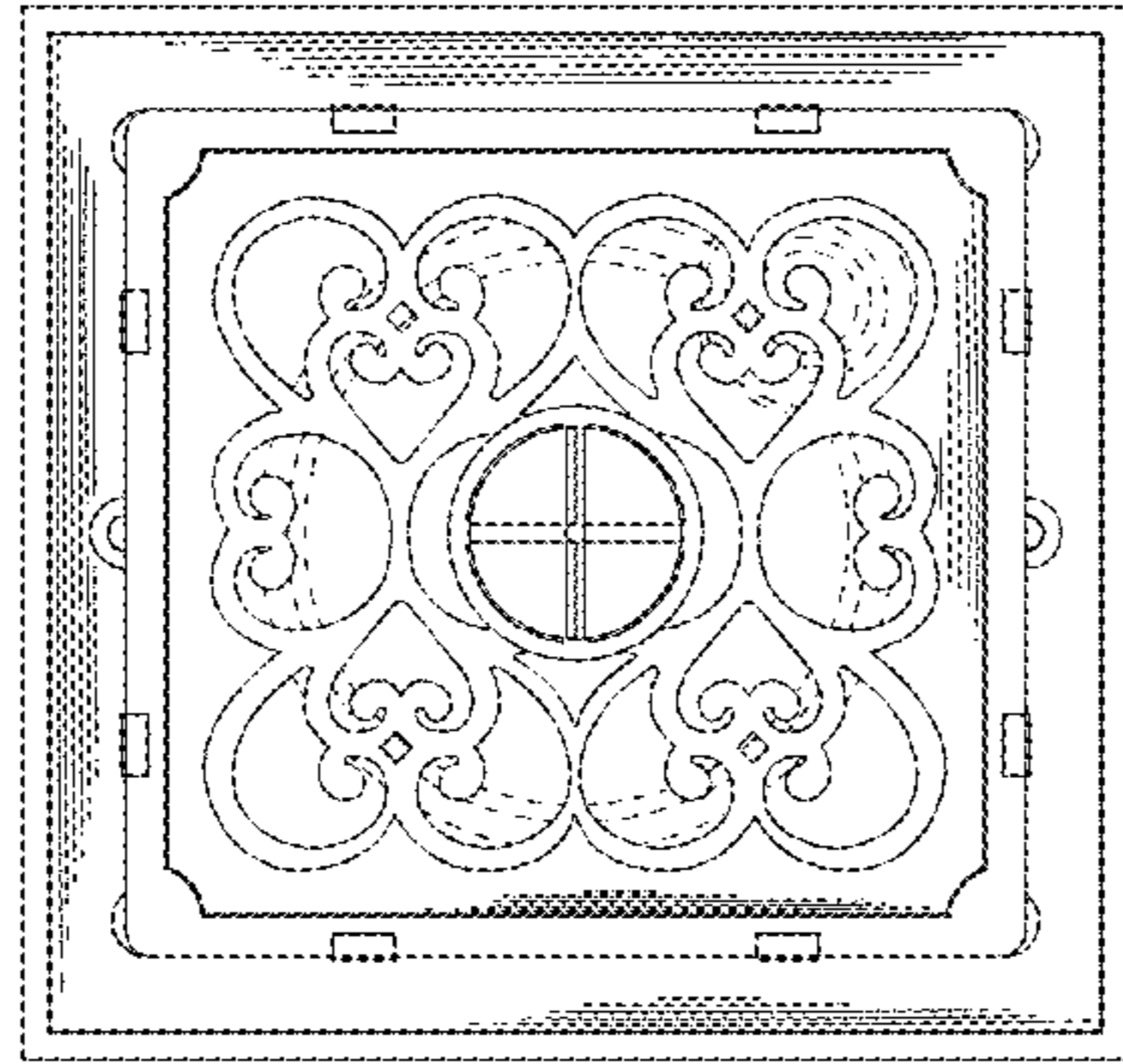
