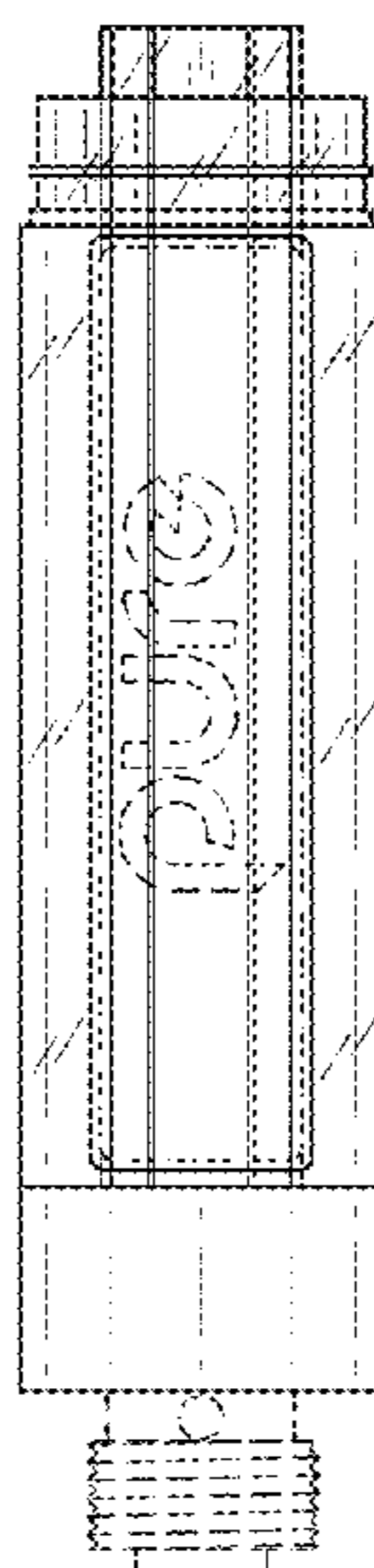
(57) **CLAIM**

The ornamental design for a mouthpiece for a vaping device,
as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a mouthpiece
for a vaping device;
FIG. 2 is a rear view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a perspective view thereof;
FIG. 5 is a front view of a second embodiment of a
mouthpiece for a vaping device;
FIG. 6 is a rear view thereof;
FIG. 7 is a top view thereof; and,
FIG. 8 is a perspective view thereof.
In FIGS. 1, 2, 4-6, and 8, the broken lines at the bottom of
drawing in each Figure depict portions of the mouthpiece for
a vaping device that form no part of the claimed design. In
FIGS. 1 and 5, the broken lines of the letters and the broken
line surrounding the letters depict exemplary environmental
structure and form no part of the design to be patented. In
FIGS. 1-4, the oblique lines are transparent.

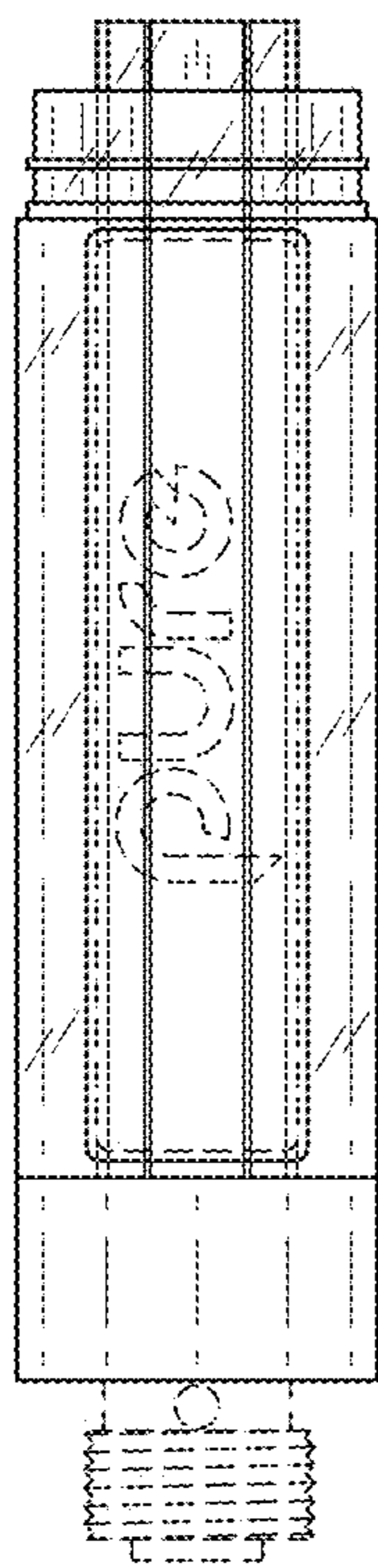

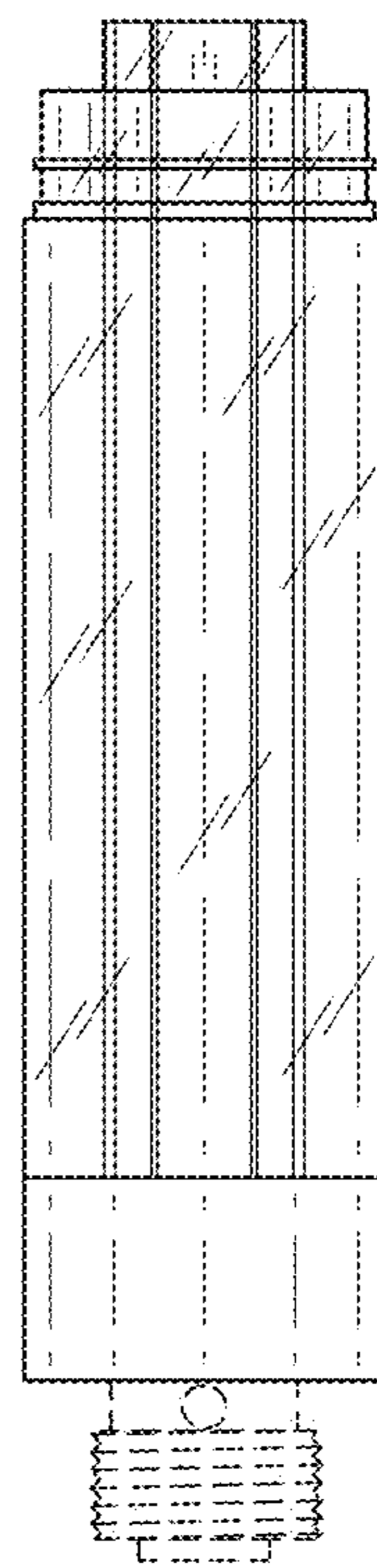

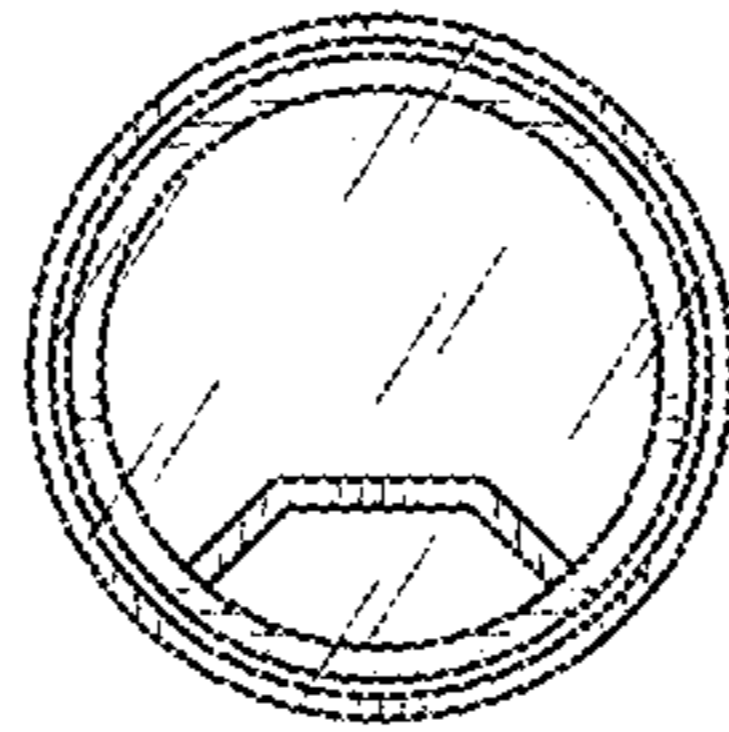

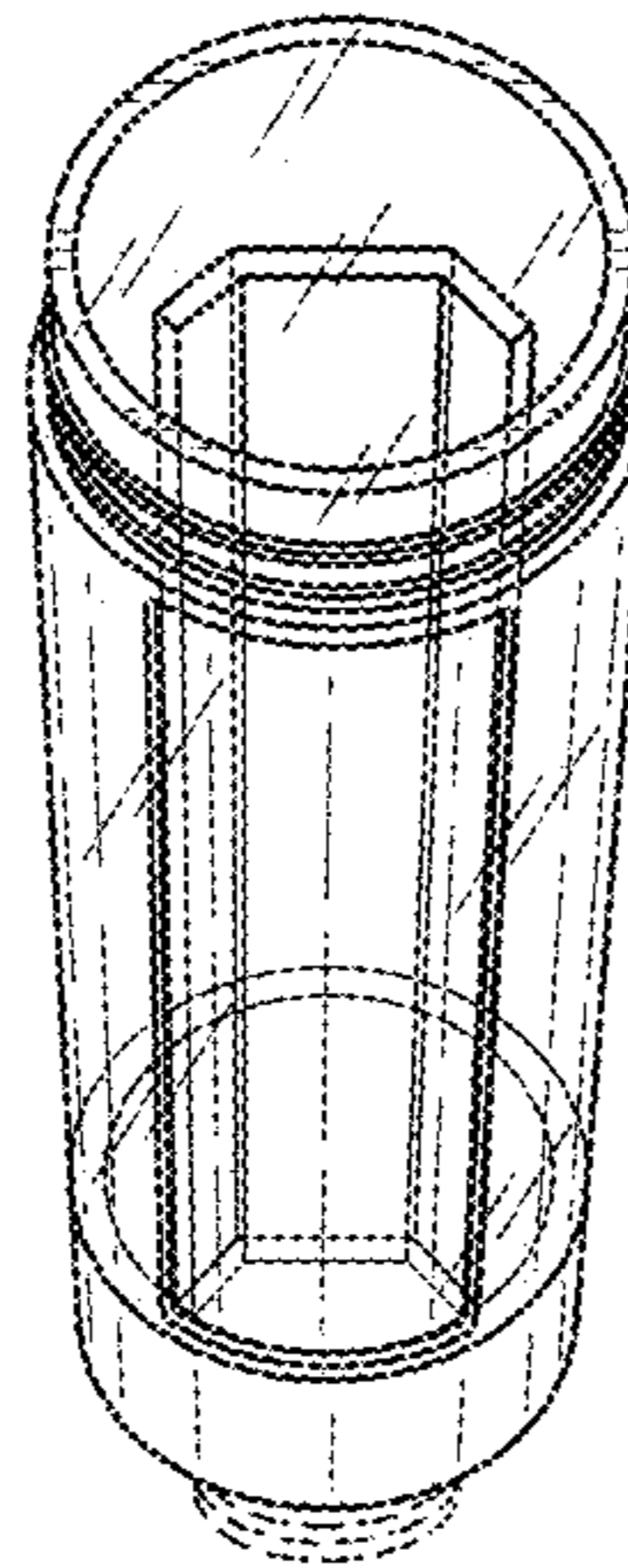

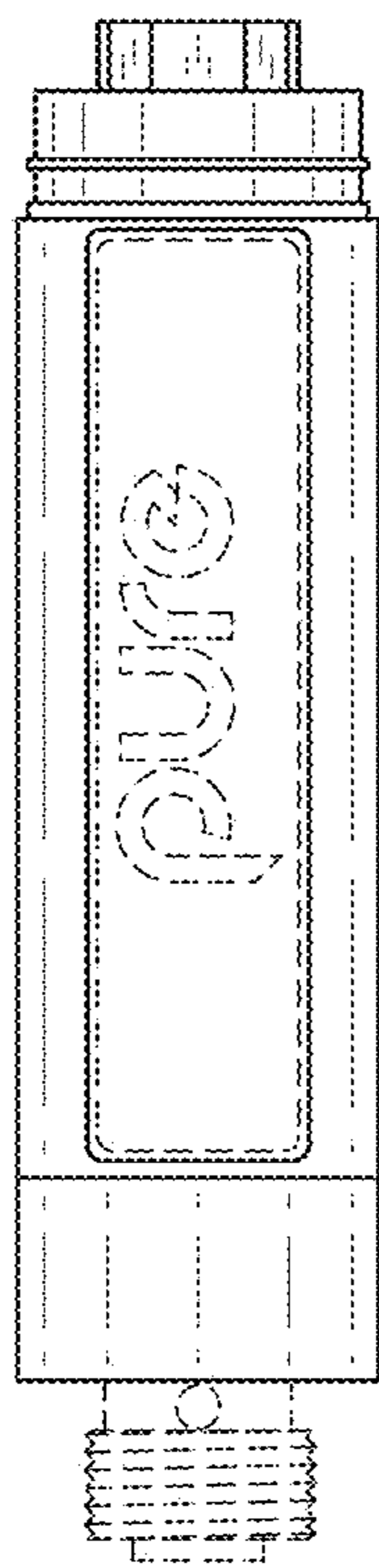

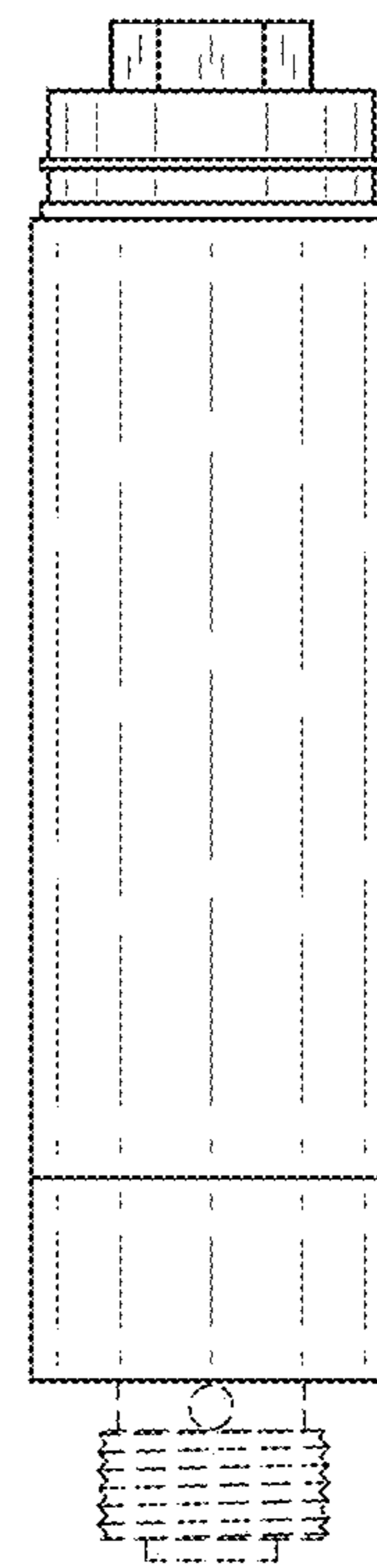

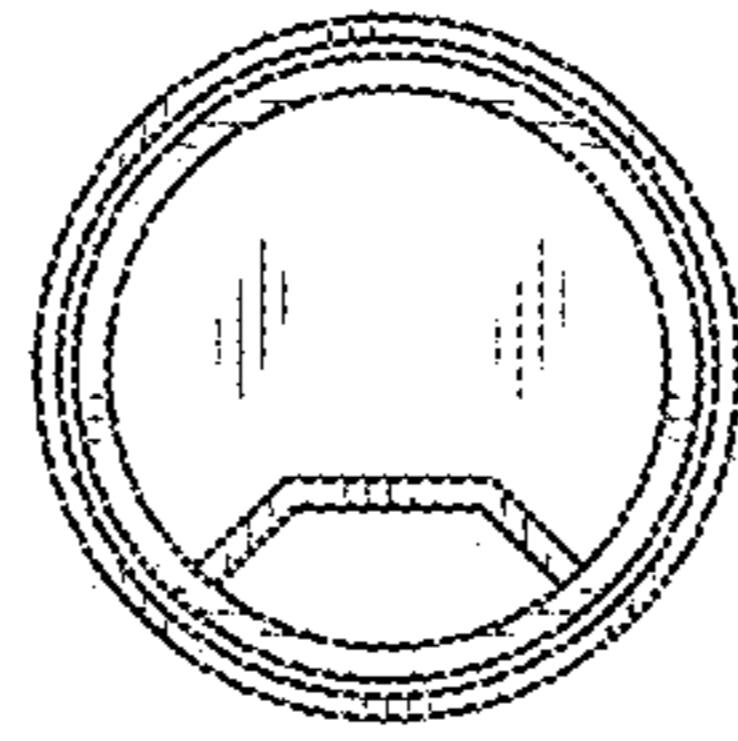

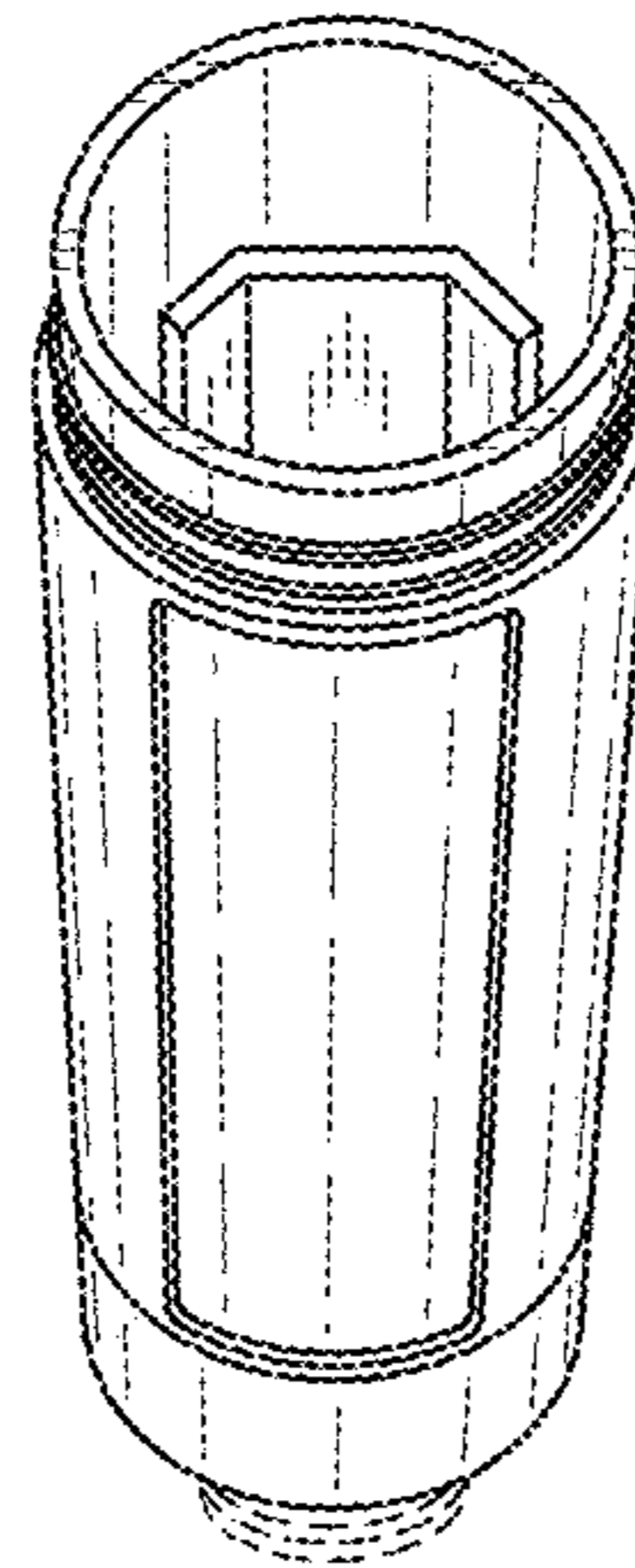
