DESCRIPTION

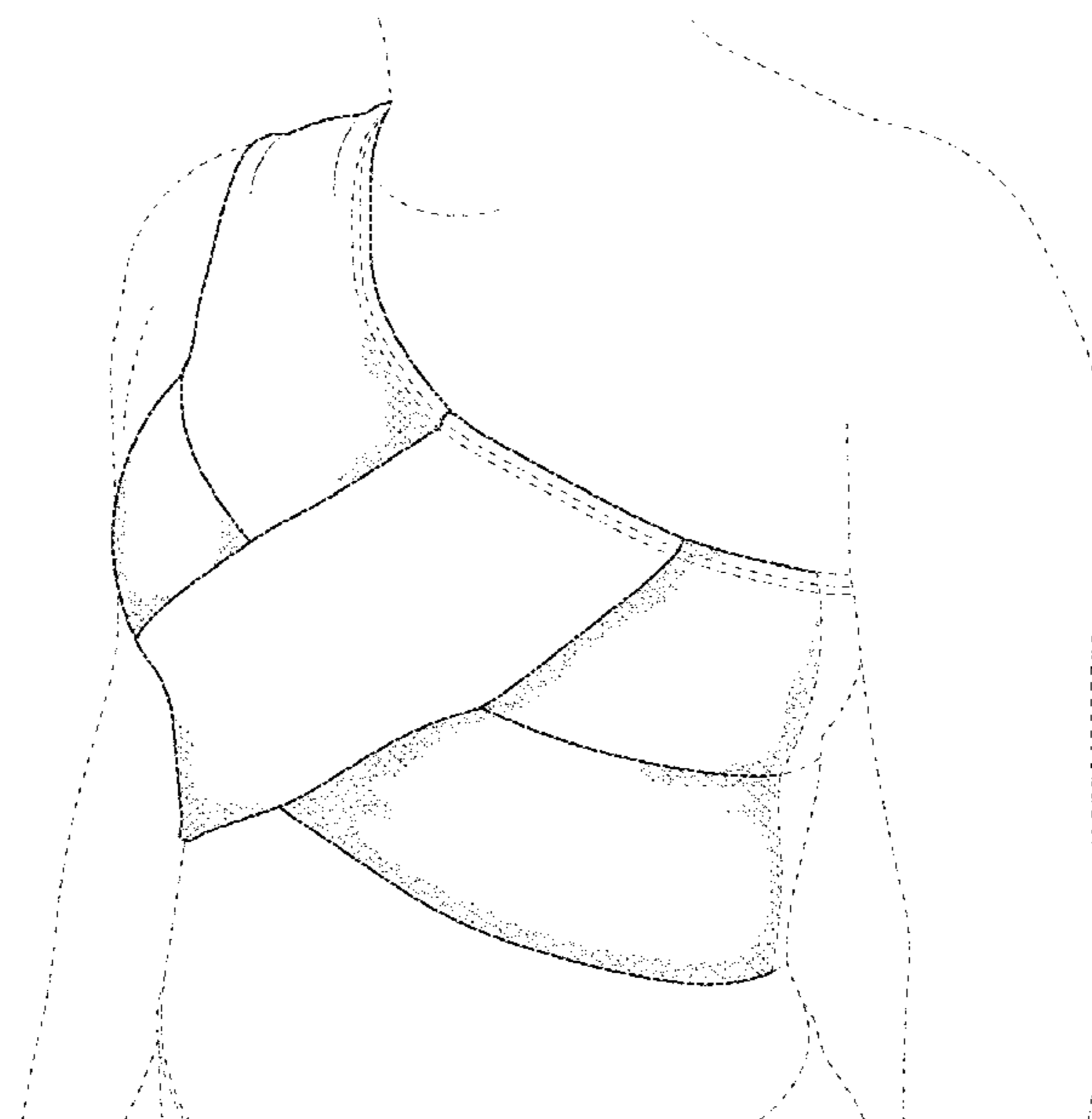

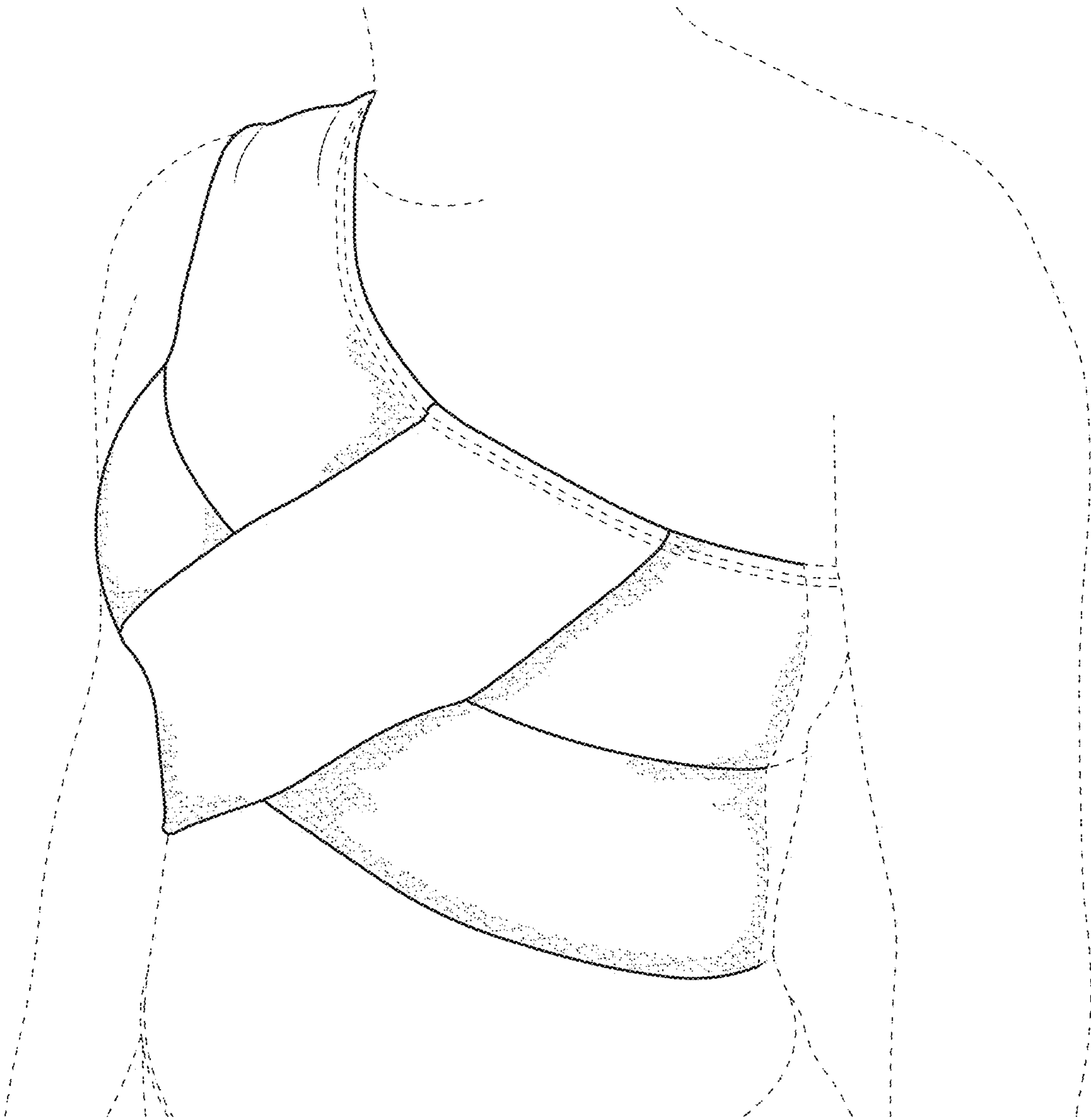

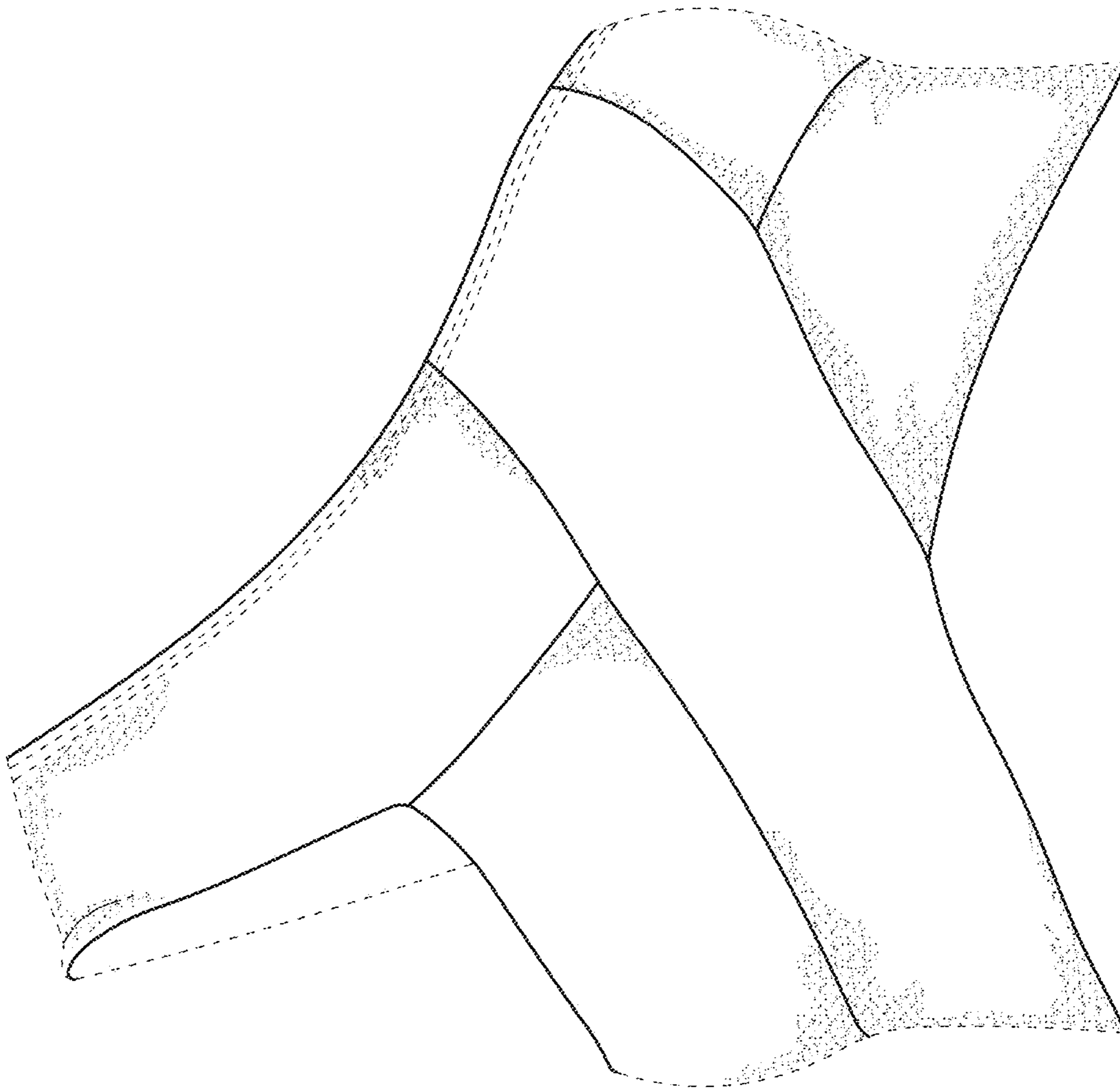

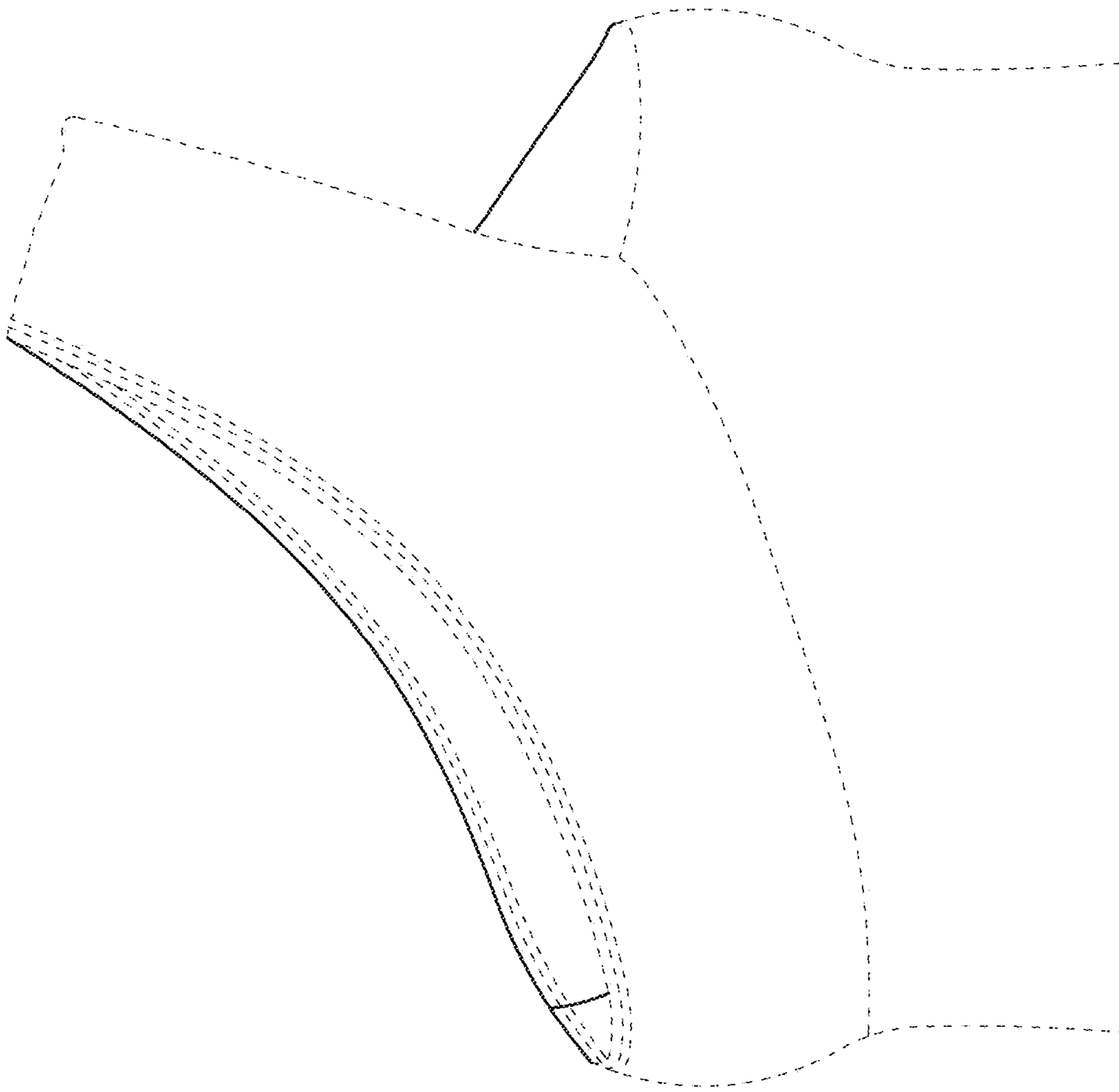

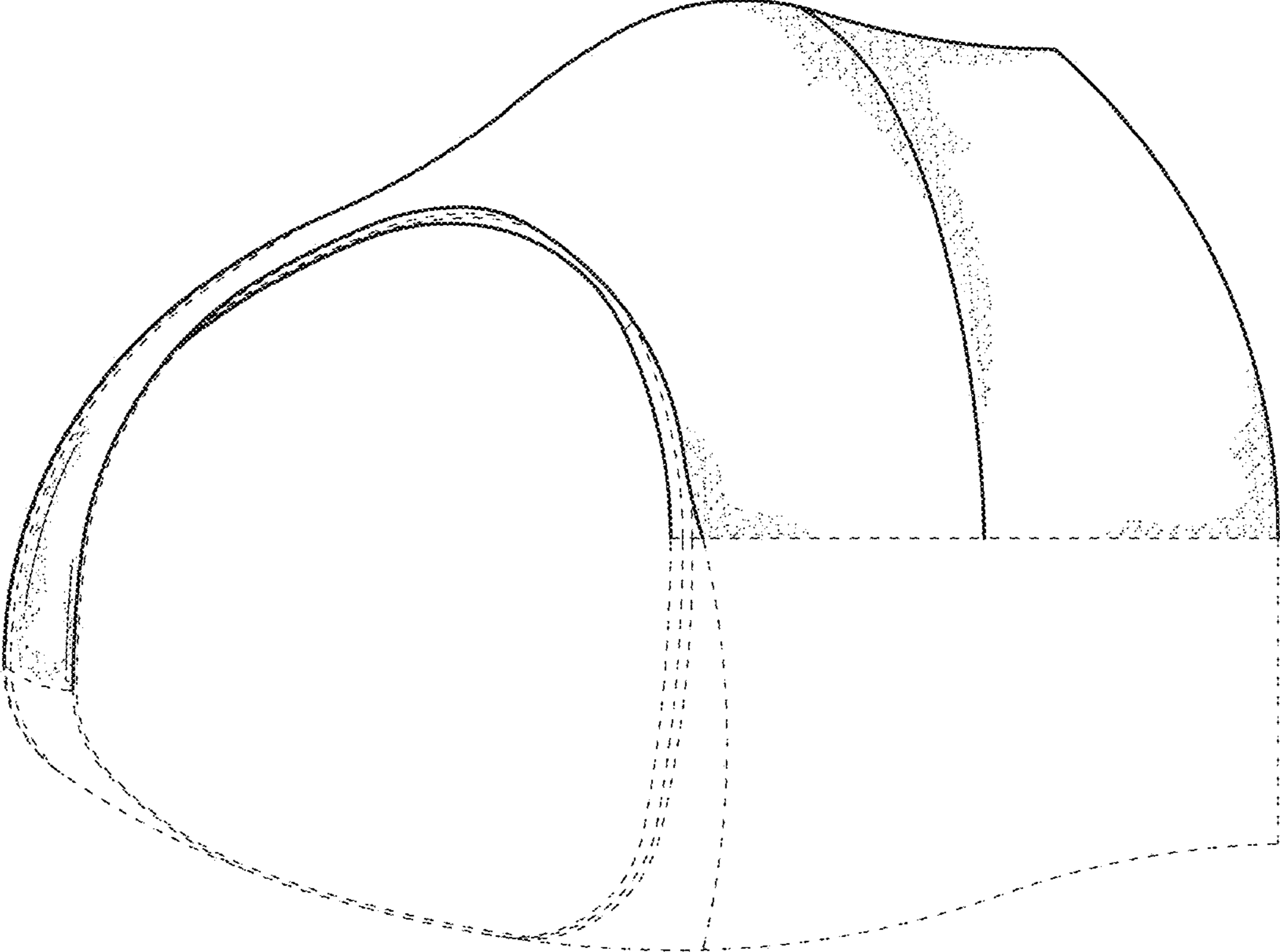

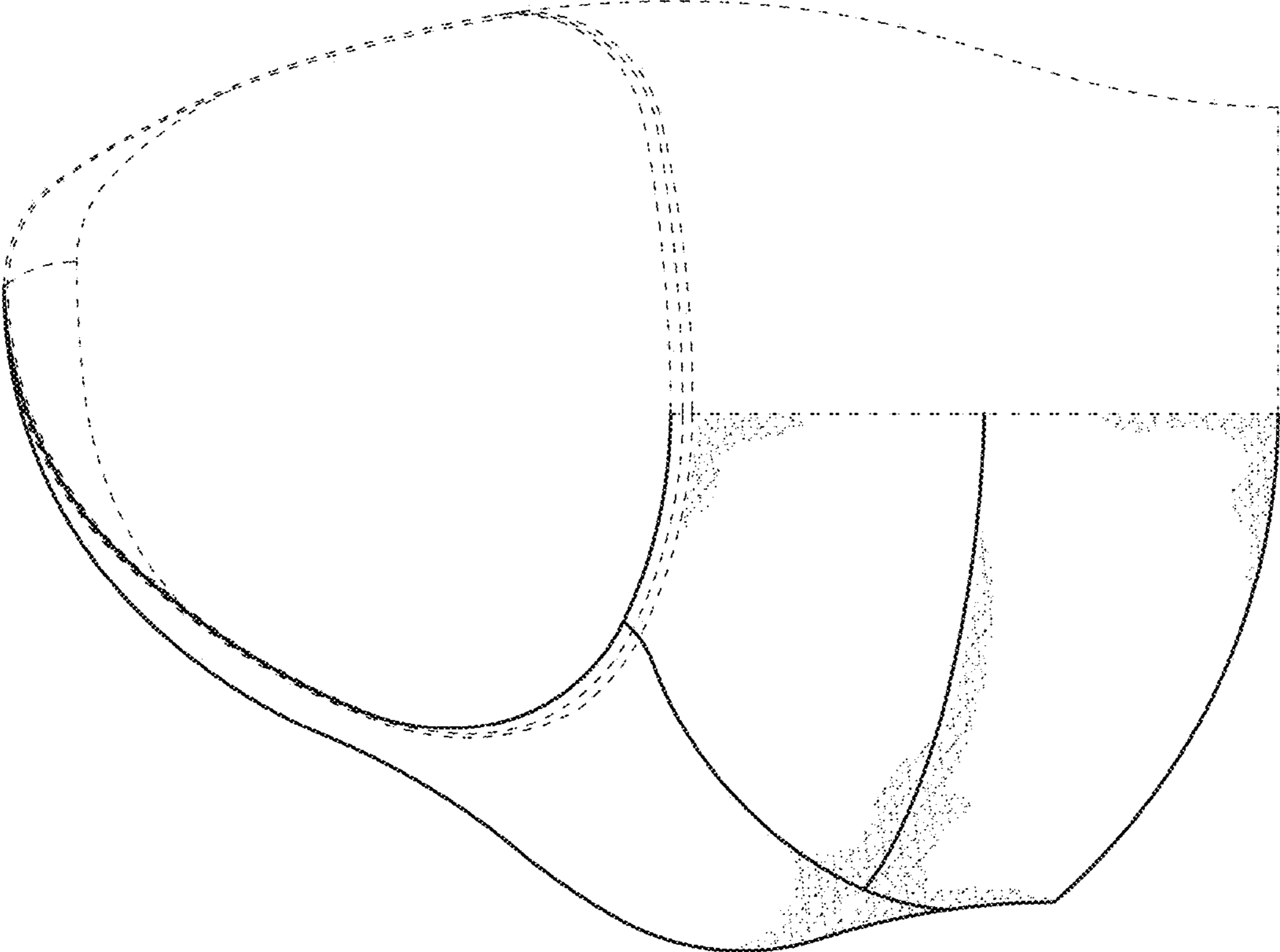

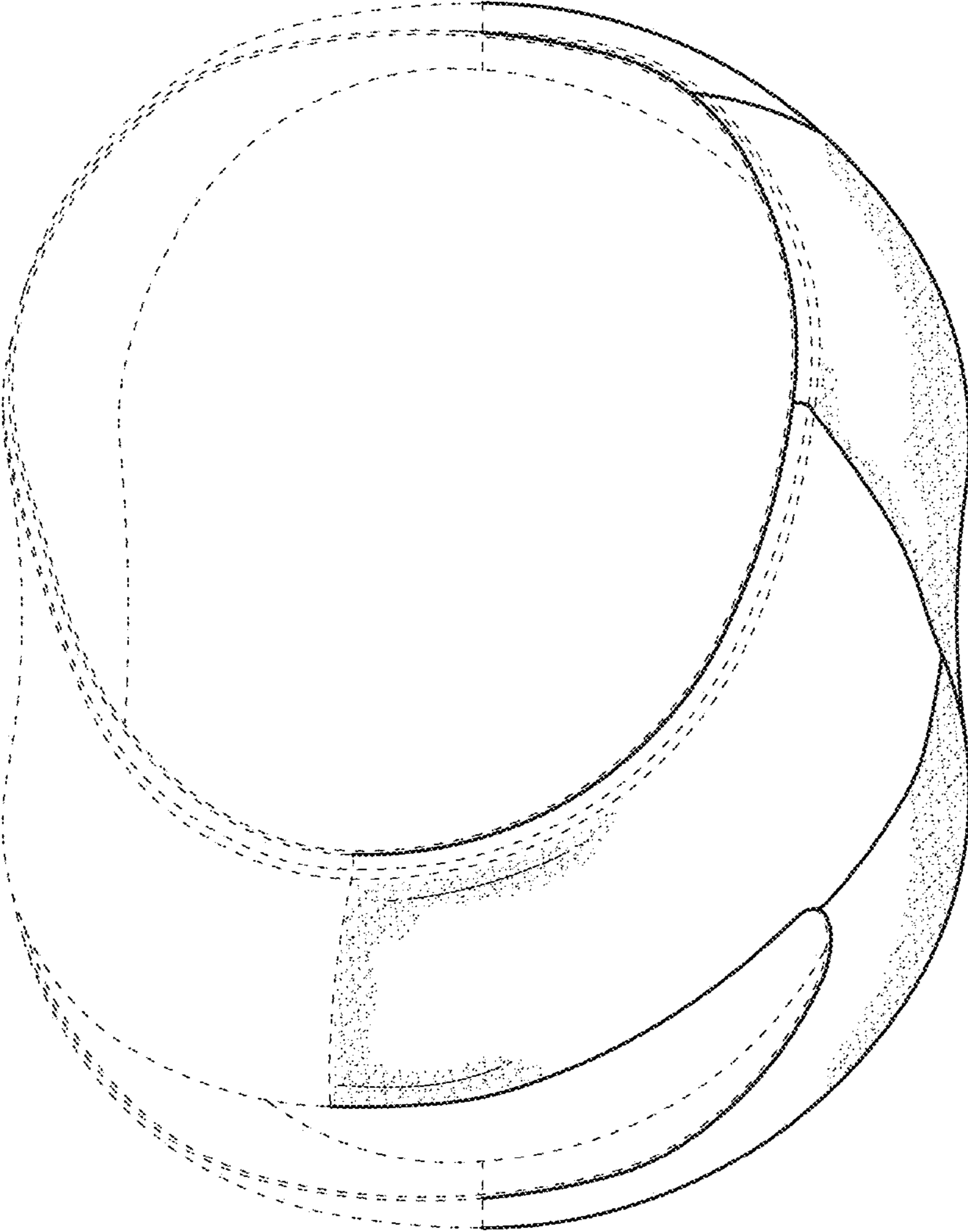

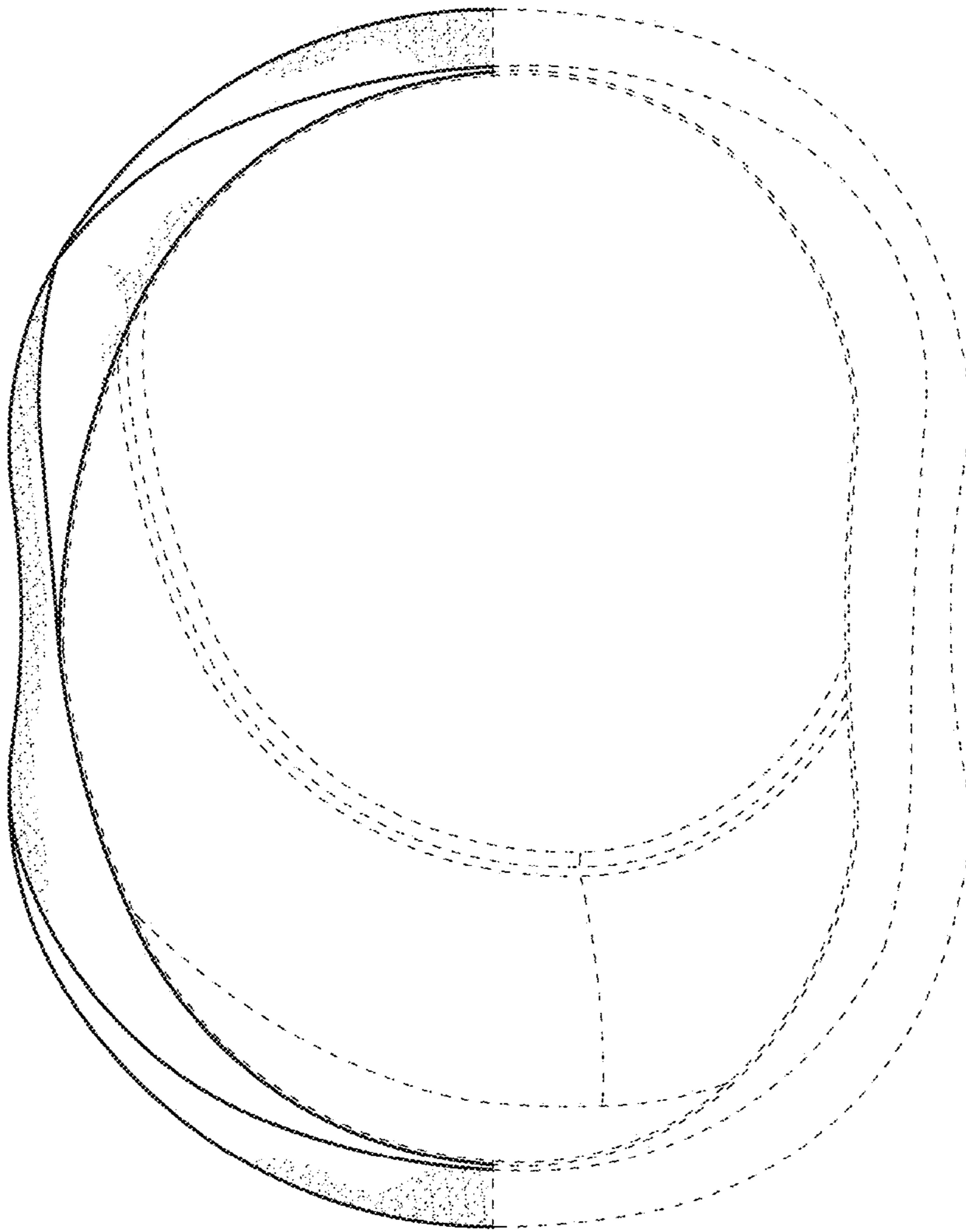

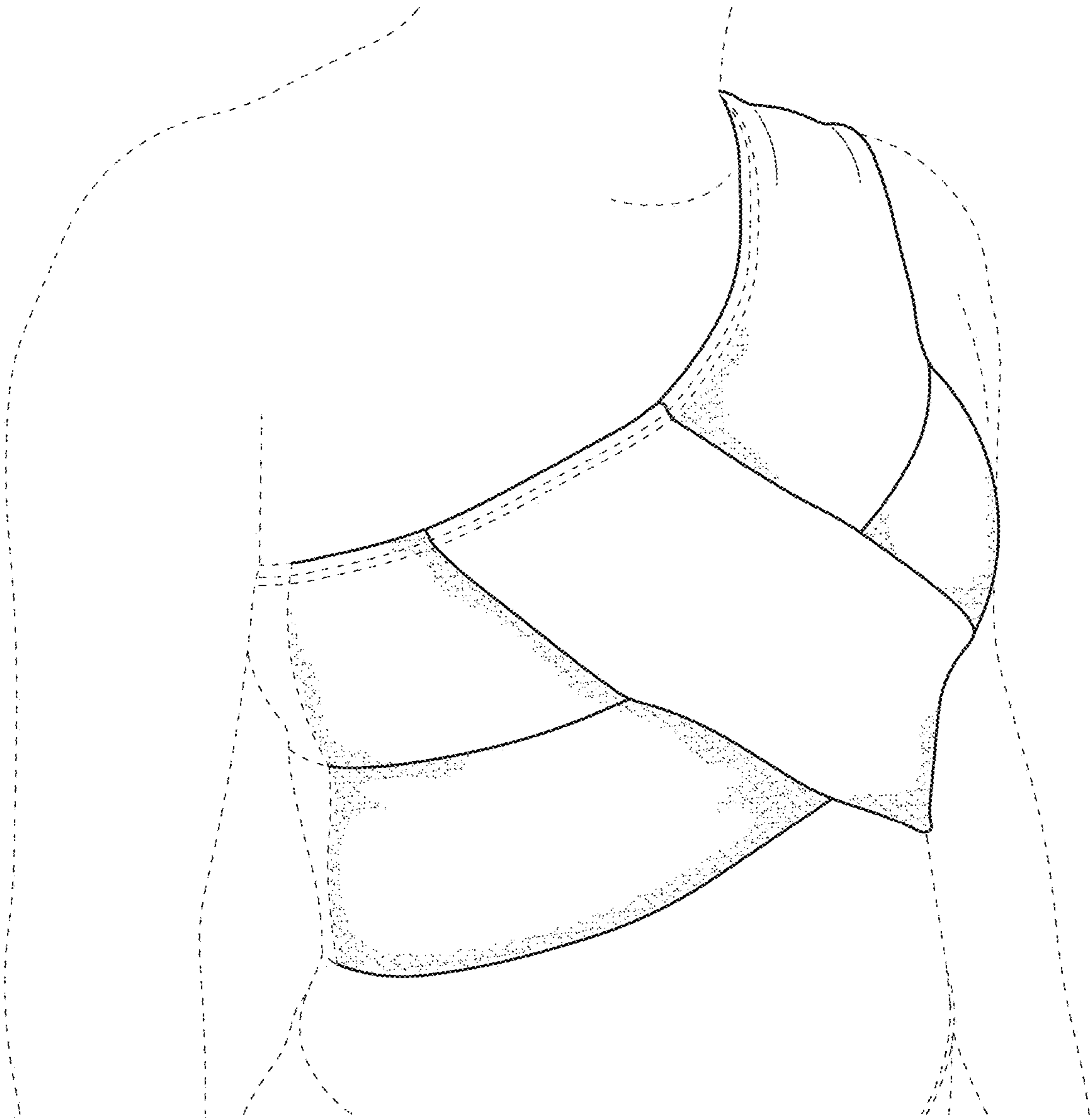

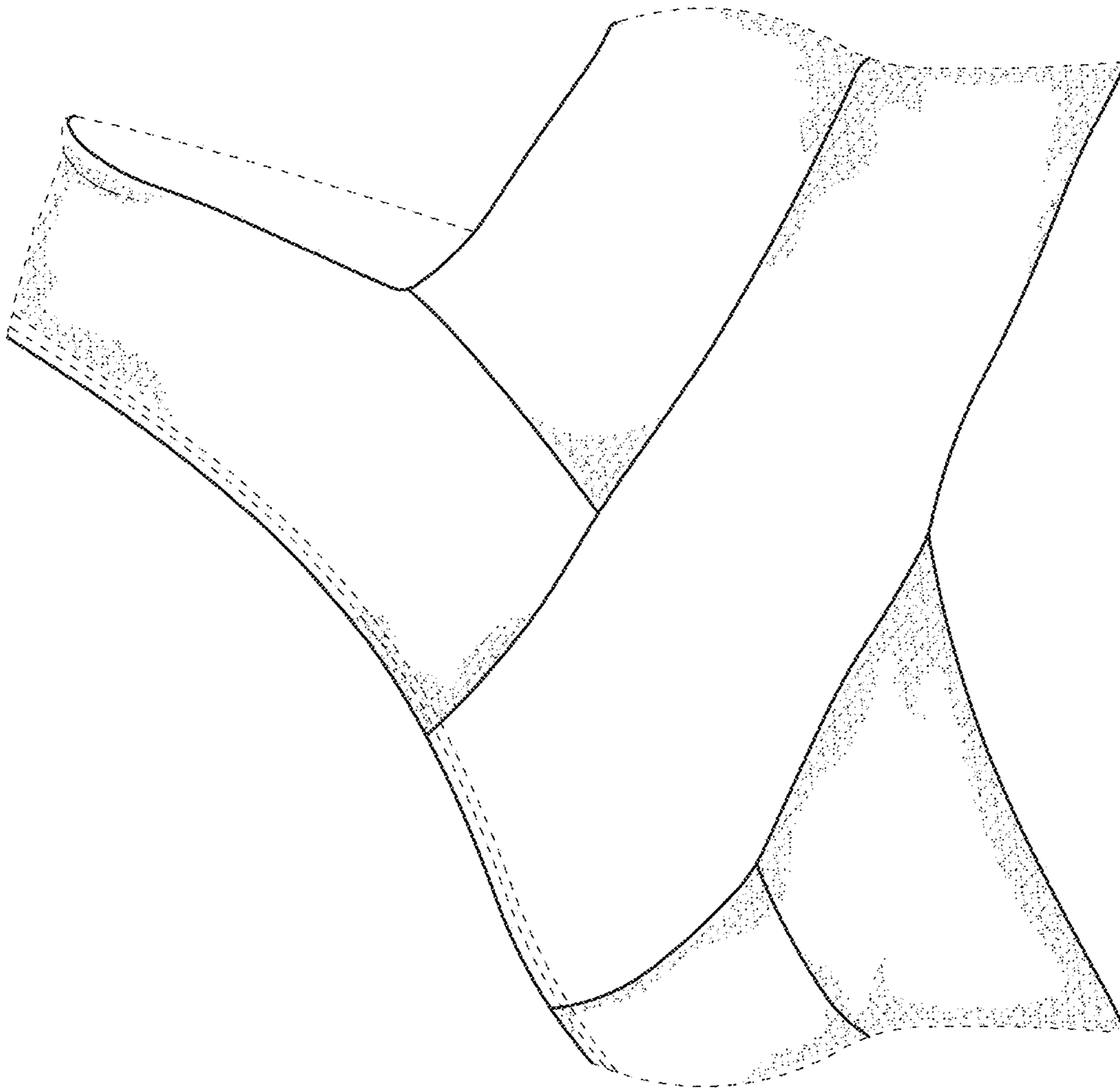

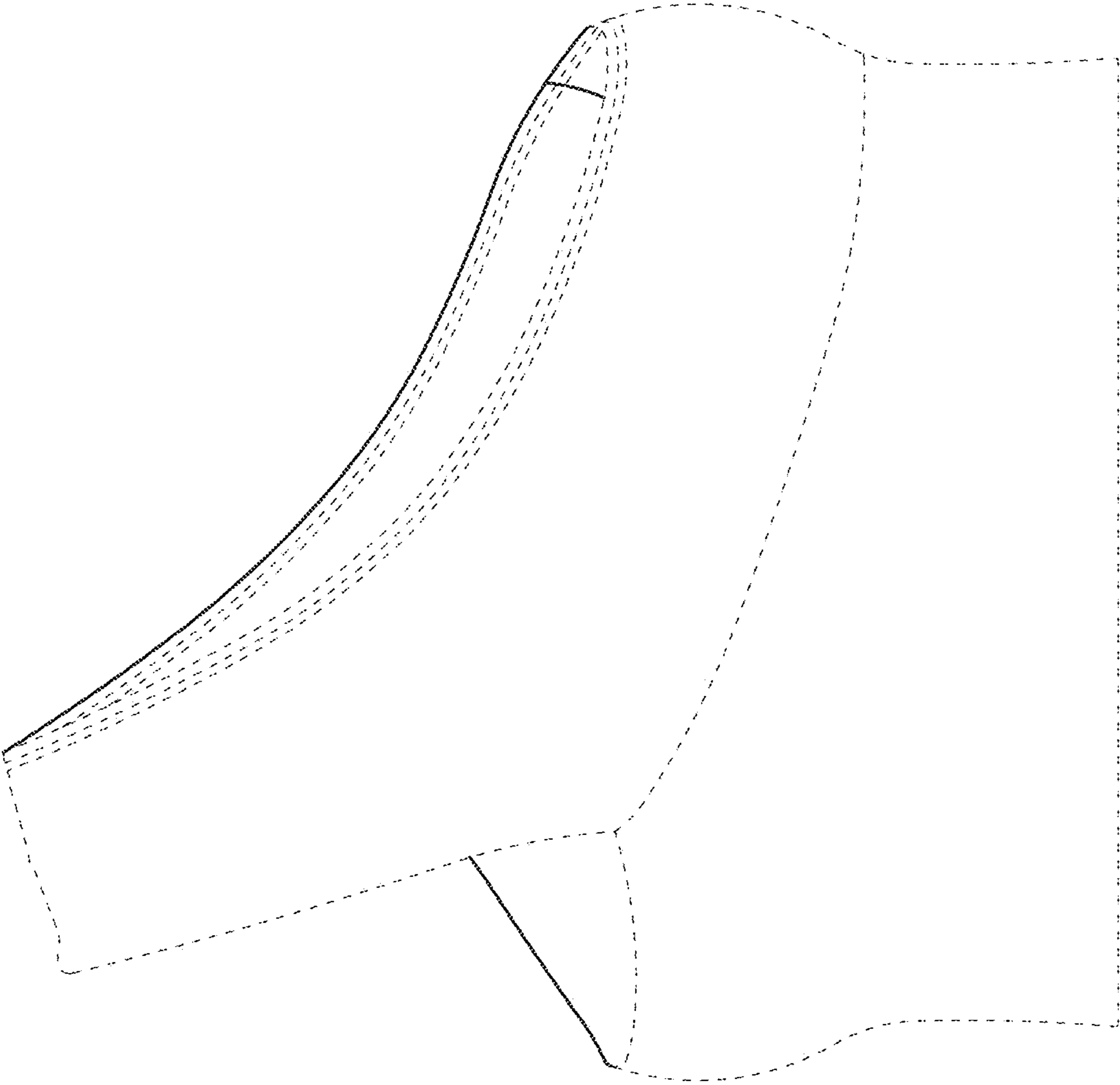

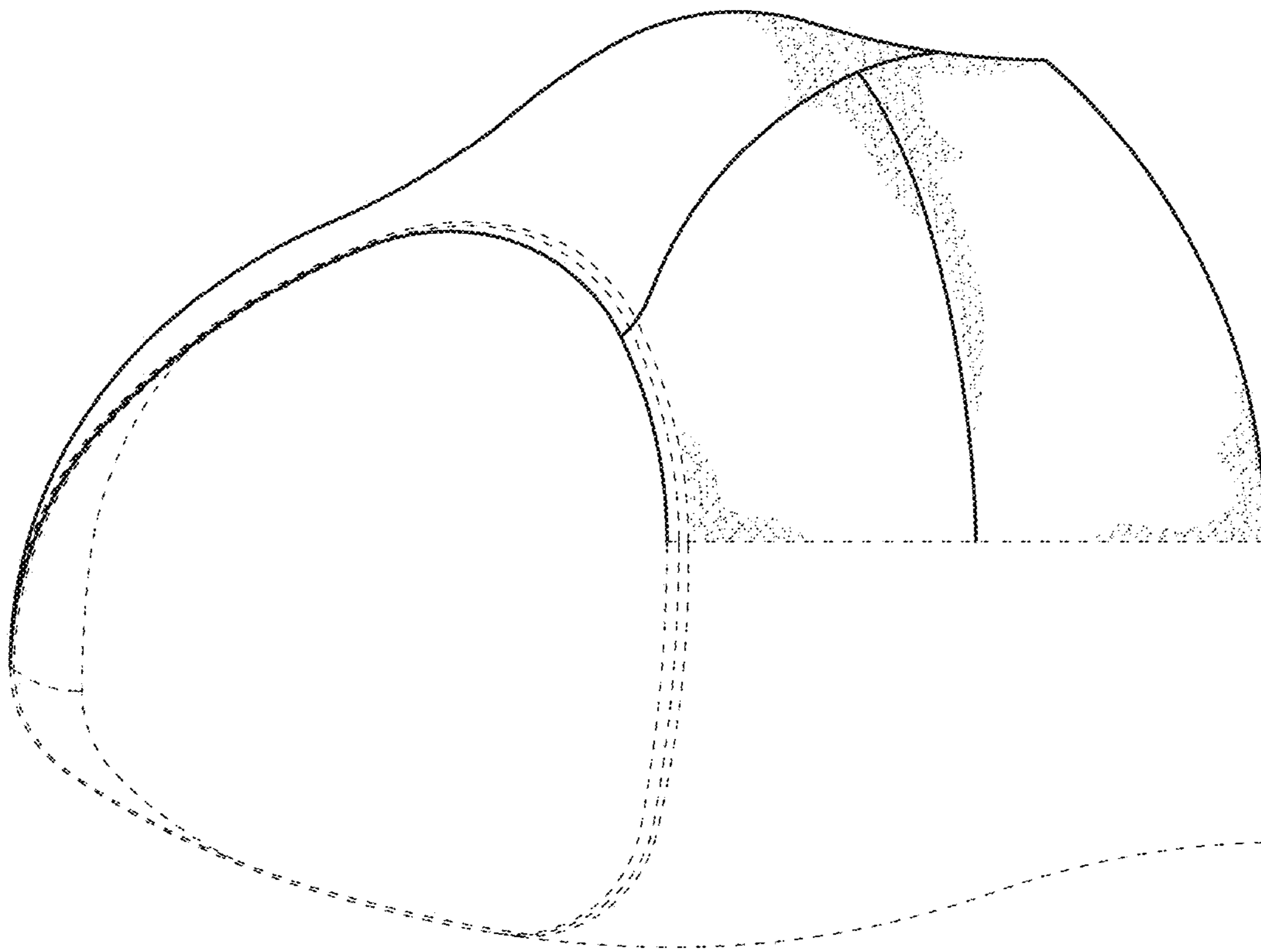

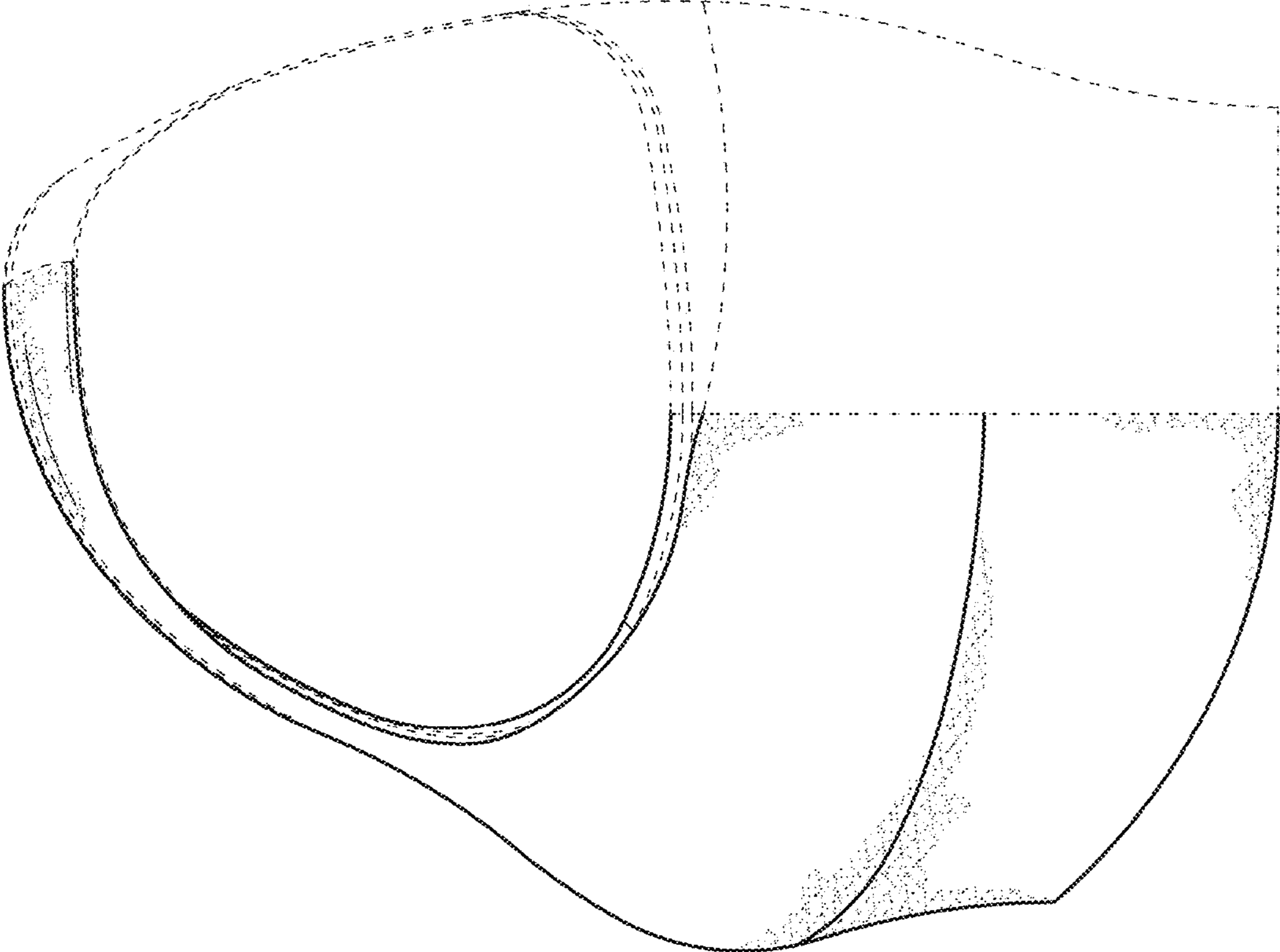

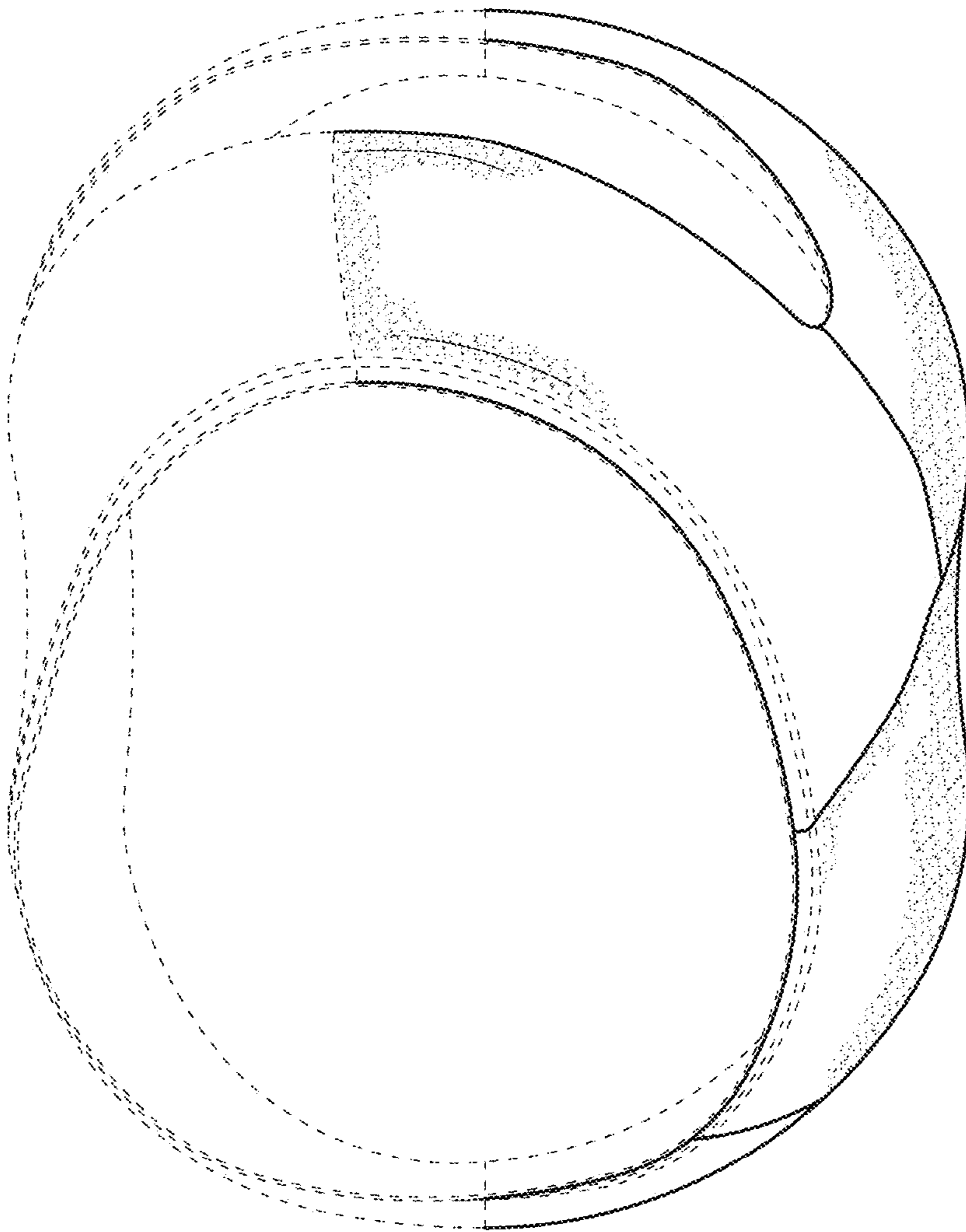

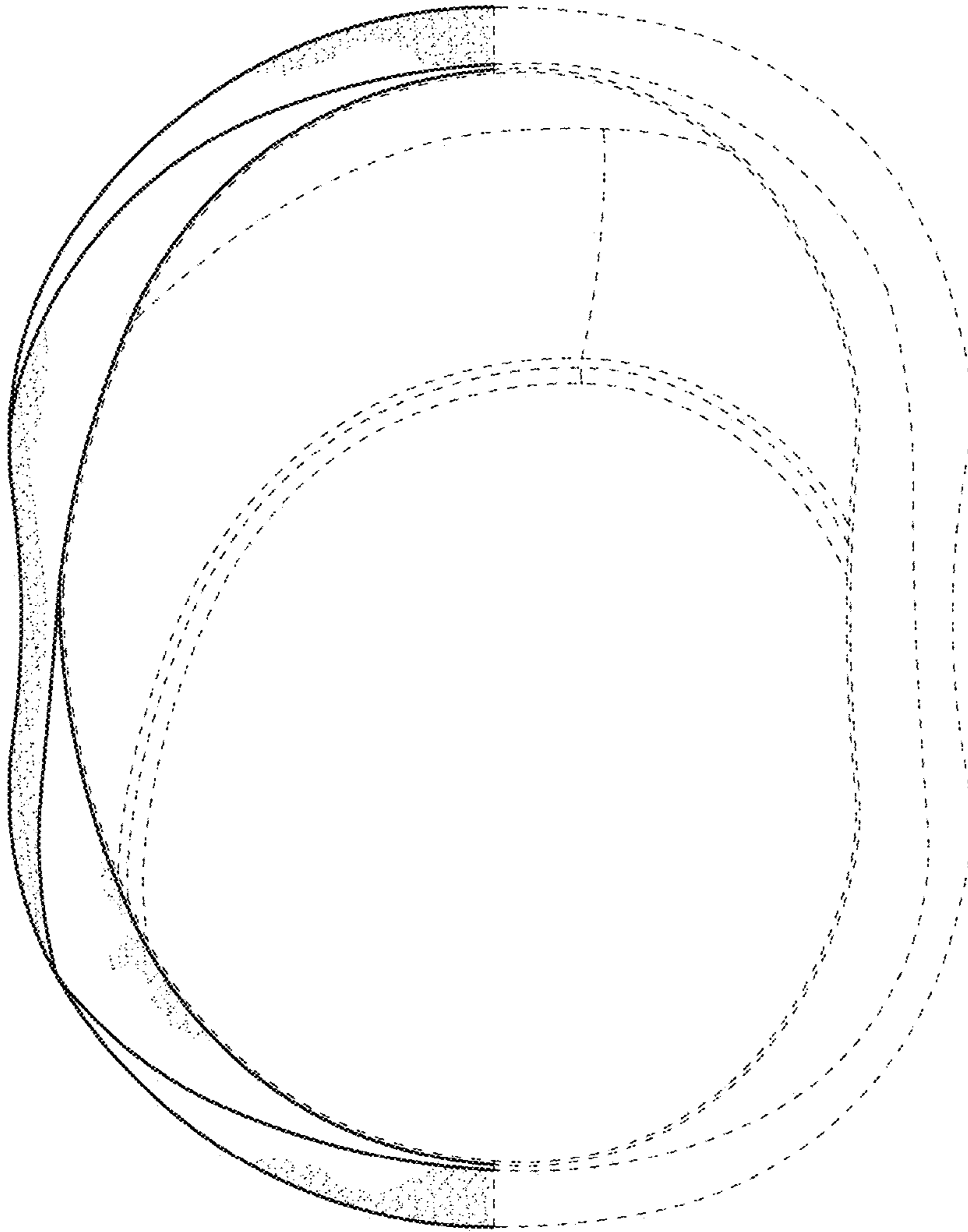
