(57) **CLAIM**

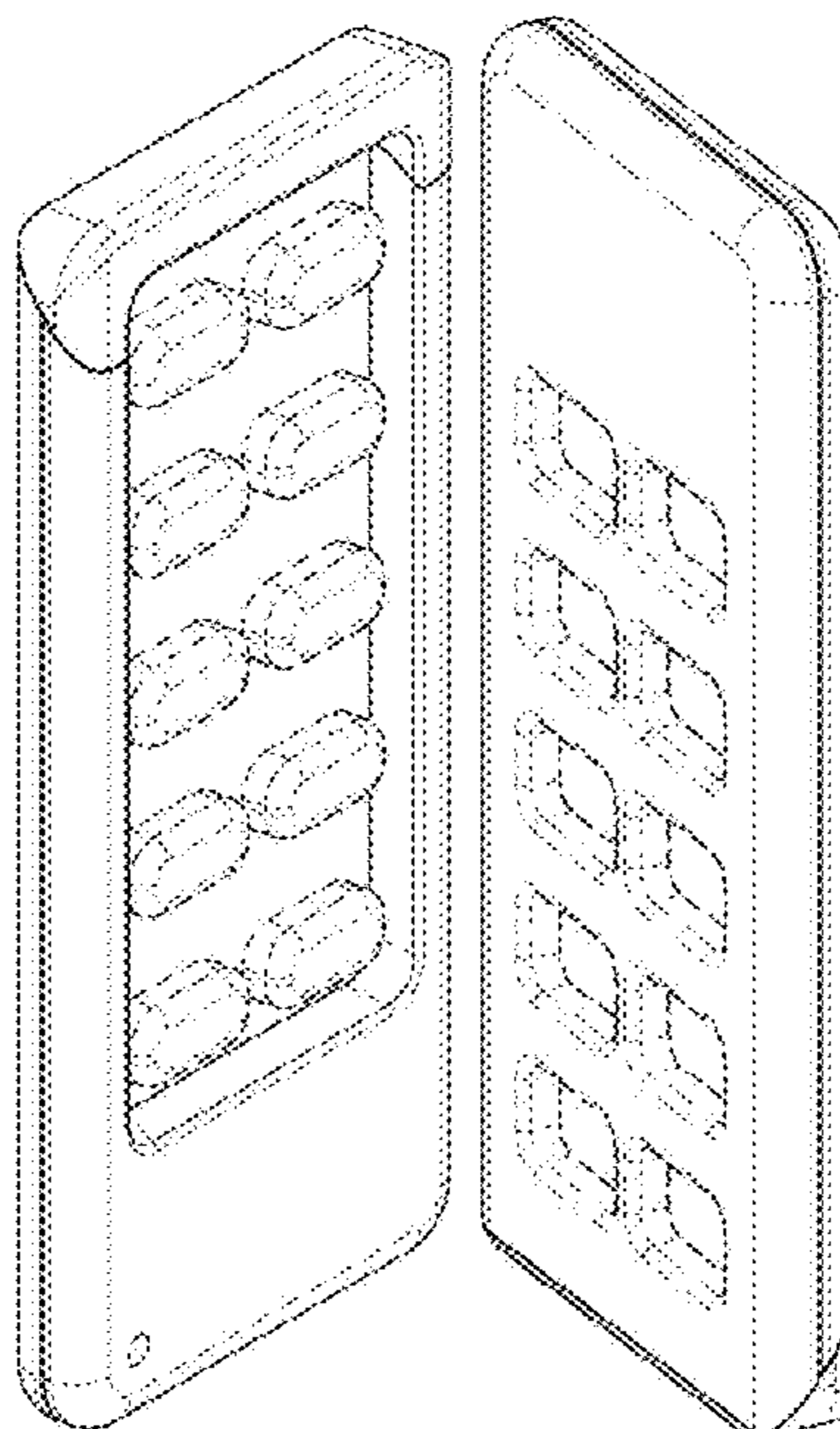
The ornamental design for a pill dispenser, as shown and described.

DESCRIPTION

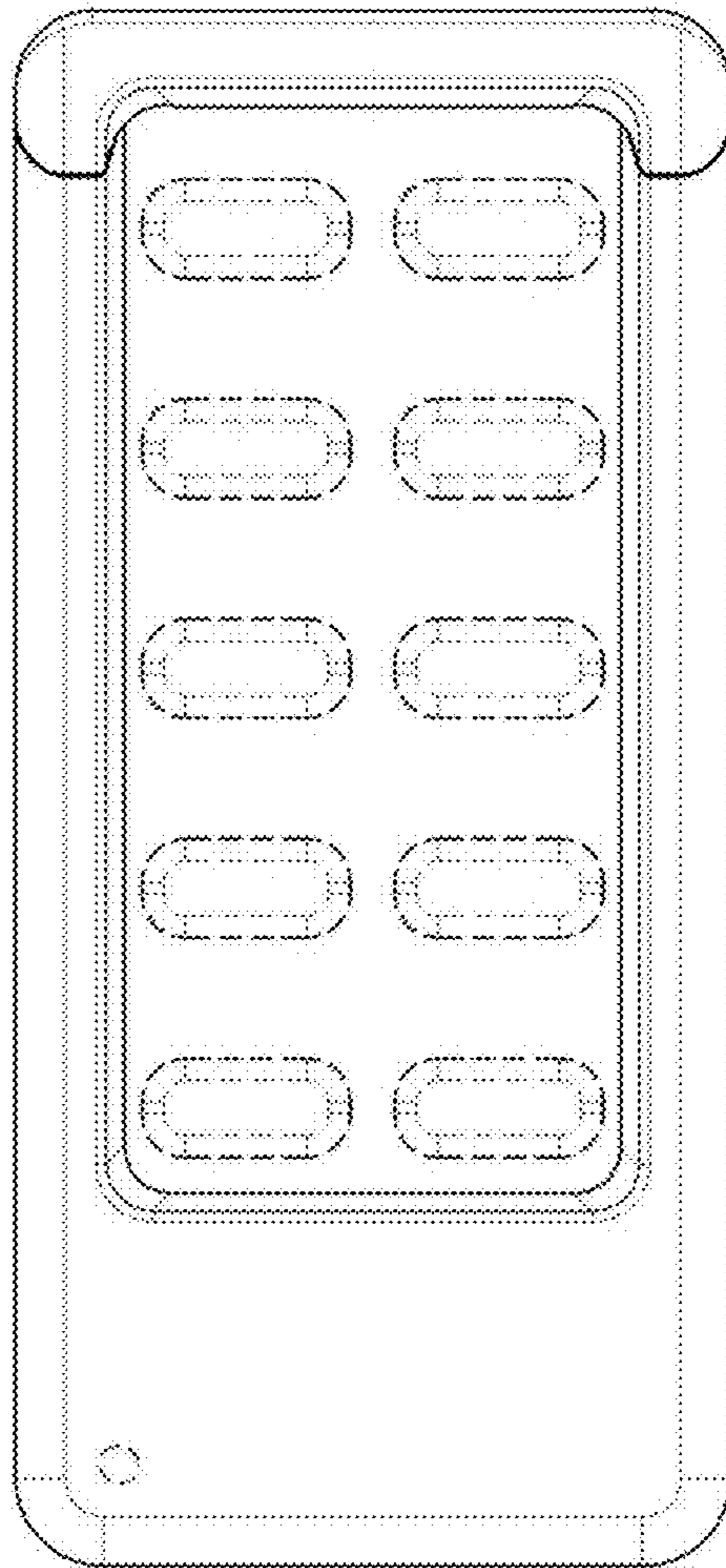
1. Pill dispenser
1.1 is a front elevation view of a pill dispenser embodying my new design;
1.2 is a left side elevation view thereof;
1.3 is a rear elevation view thereof;
1.4 is a right side elevation view thereof;
1.5 is a top plan view thereof;
1.6 is a bottom plan view thereof;
1.7 is a front perspective view thereof; and
1.8 is a rear perspective view thereof.

The broken lines in the reproductions illustrate portions of the pill dispenser other than packaging that form no part of the claimed design.

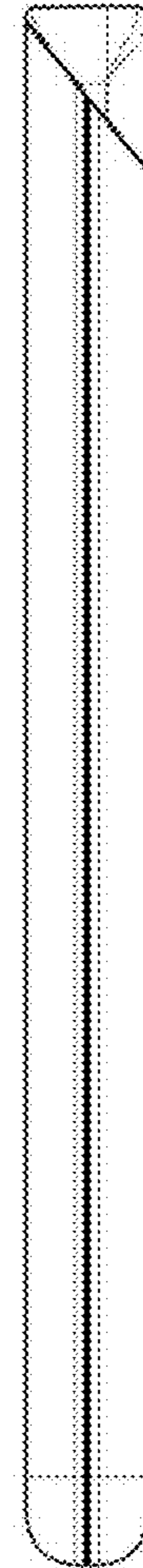

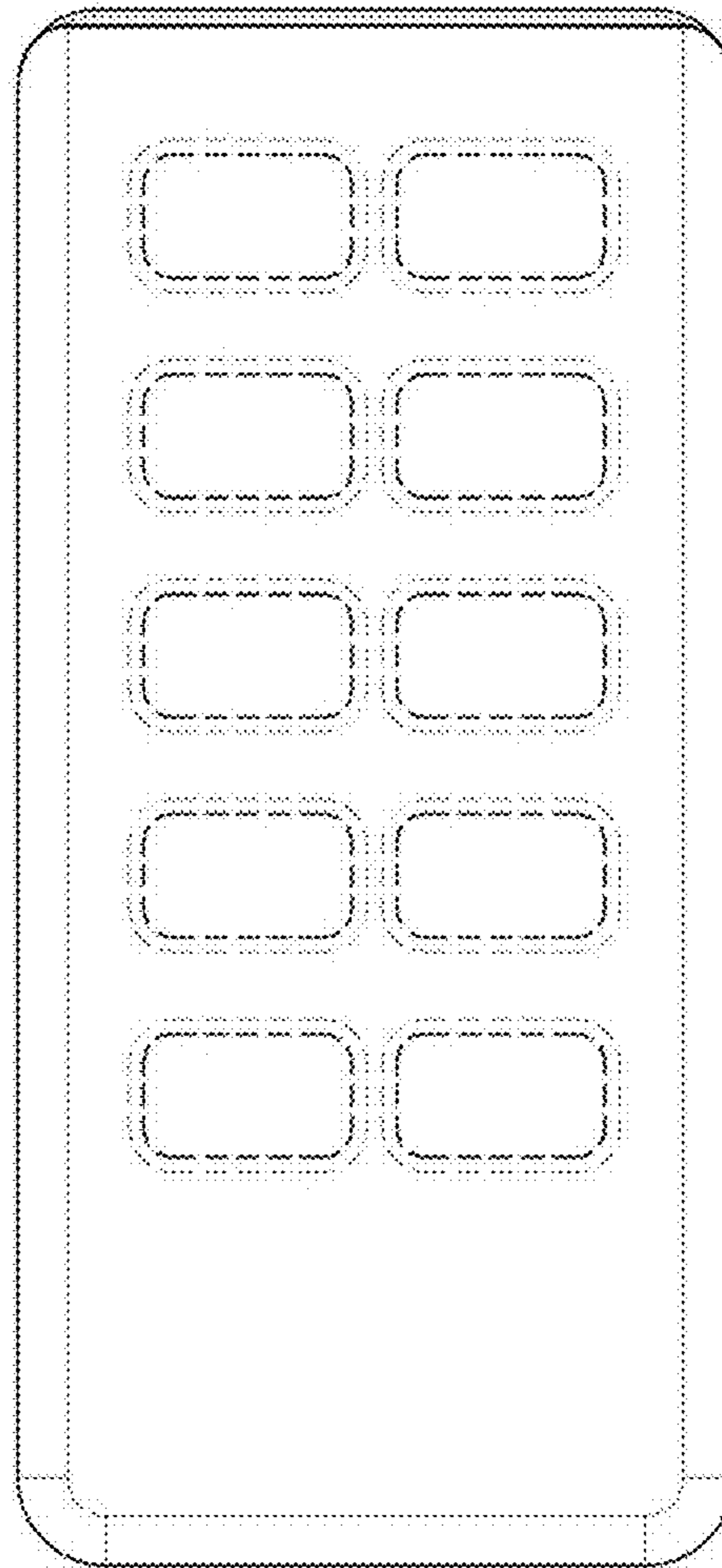

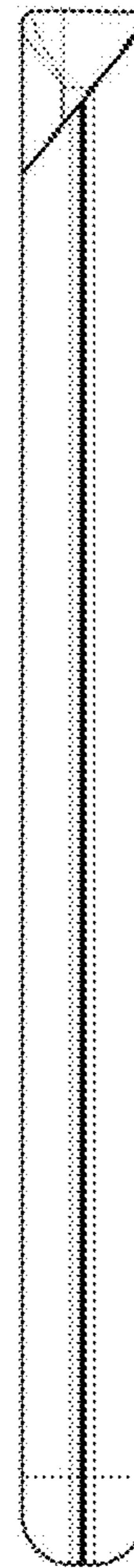

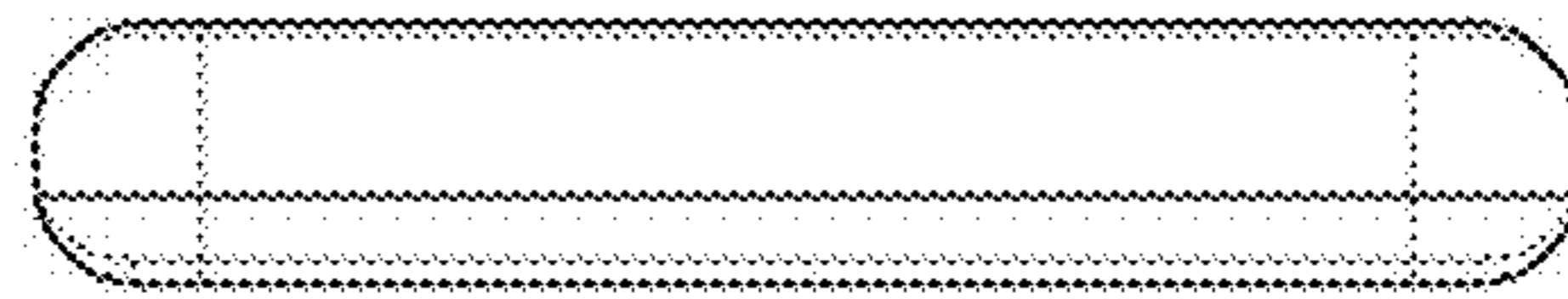

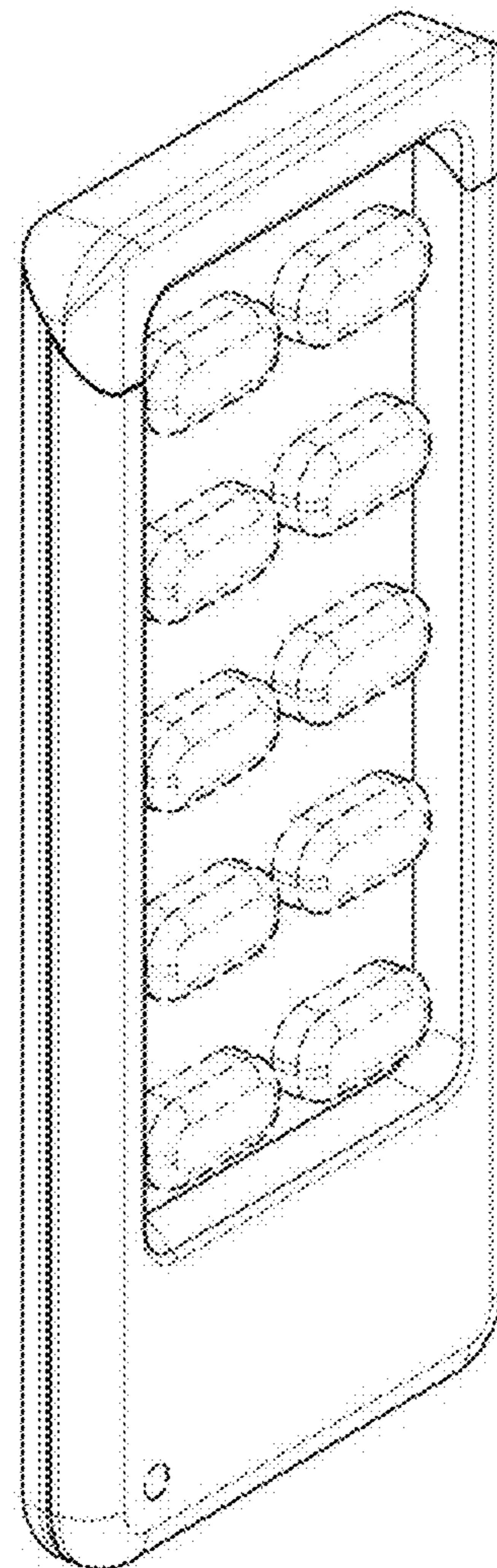
