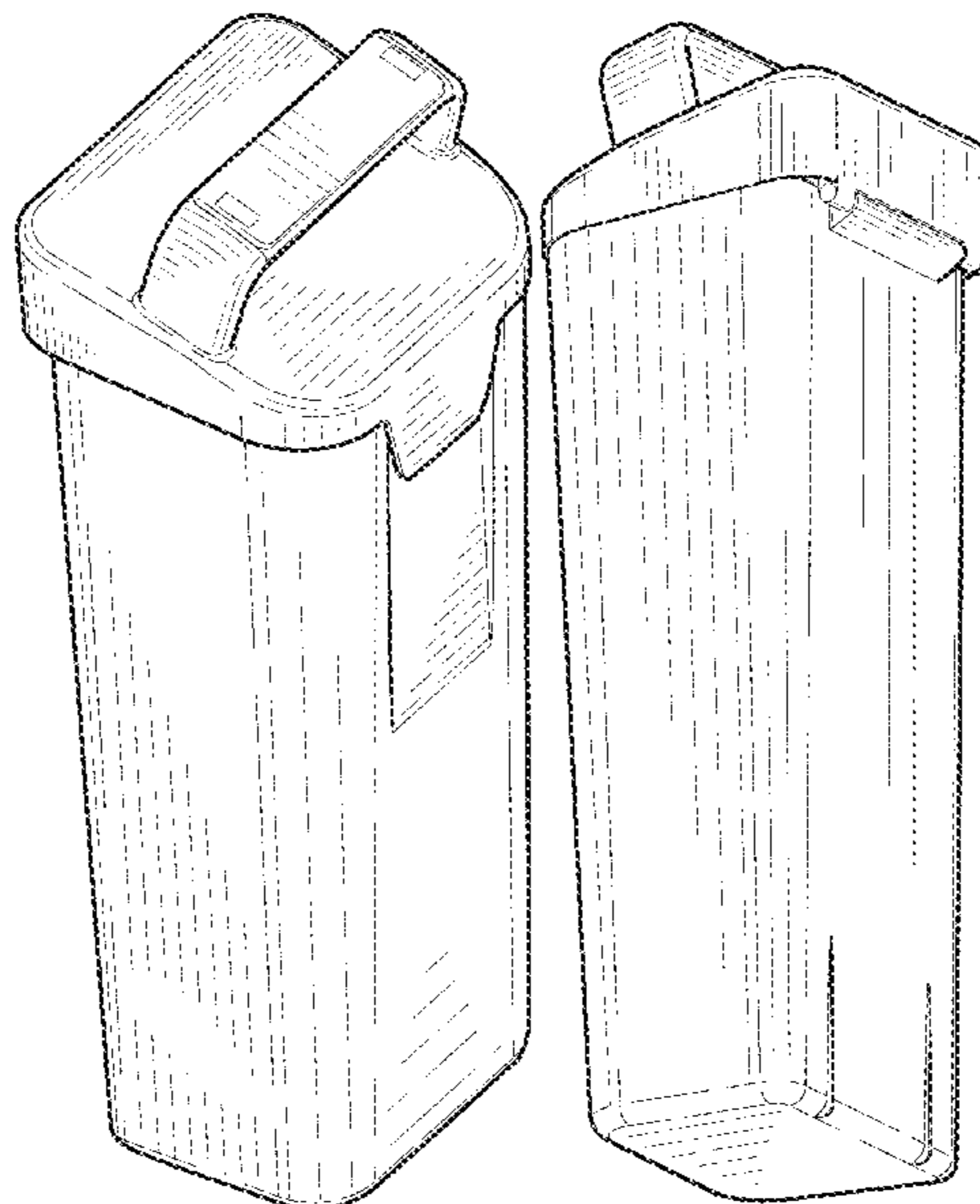
(57) **CLAIM**

We claim the ornamental design for a canister, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of the canister; FIG. 2 is a second perspective view of the canister; FIGS. 3 and 4 are further perspective views of the canister; FIG. 5 is a front view of the canister; FIG. 6 is a rear view of the canister; FIG. 7 is a top view of the canister; and, FIG. 8 is a bottom view of the canister. In the drawings, the broken lines show portions of a canister that form no part of the claim.

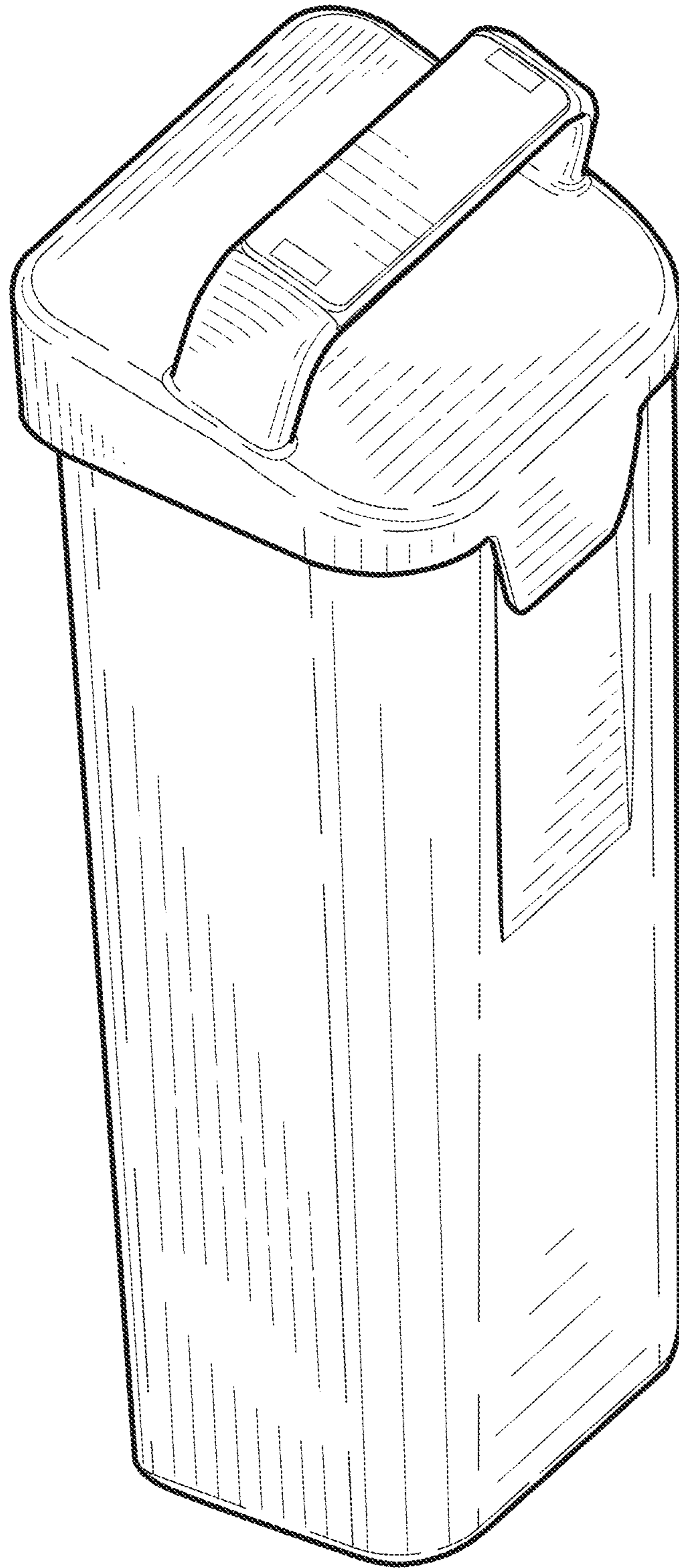

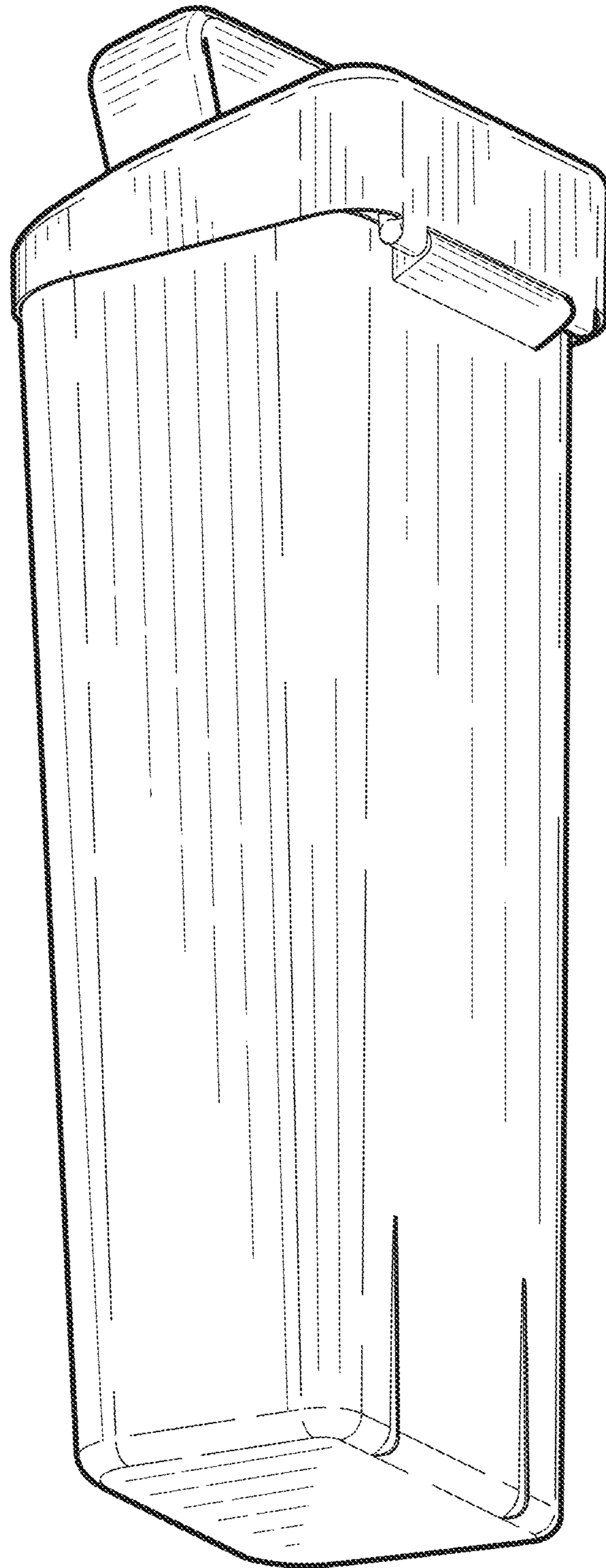

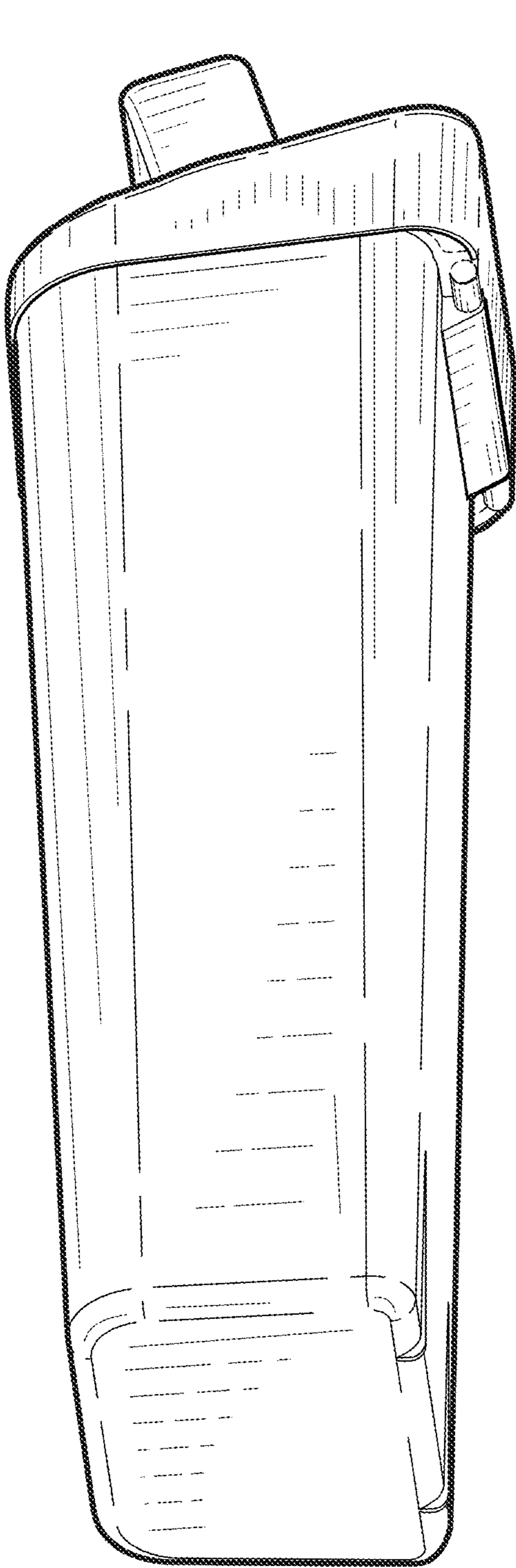

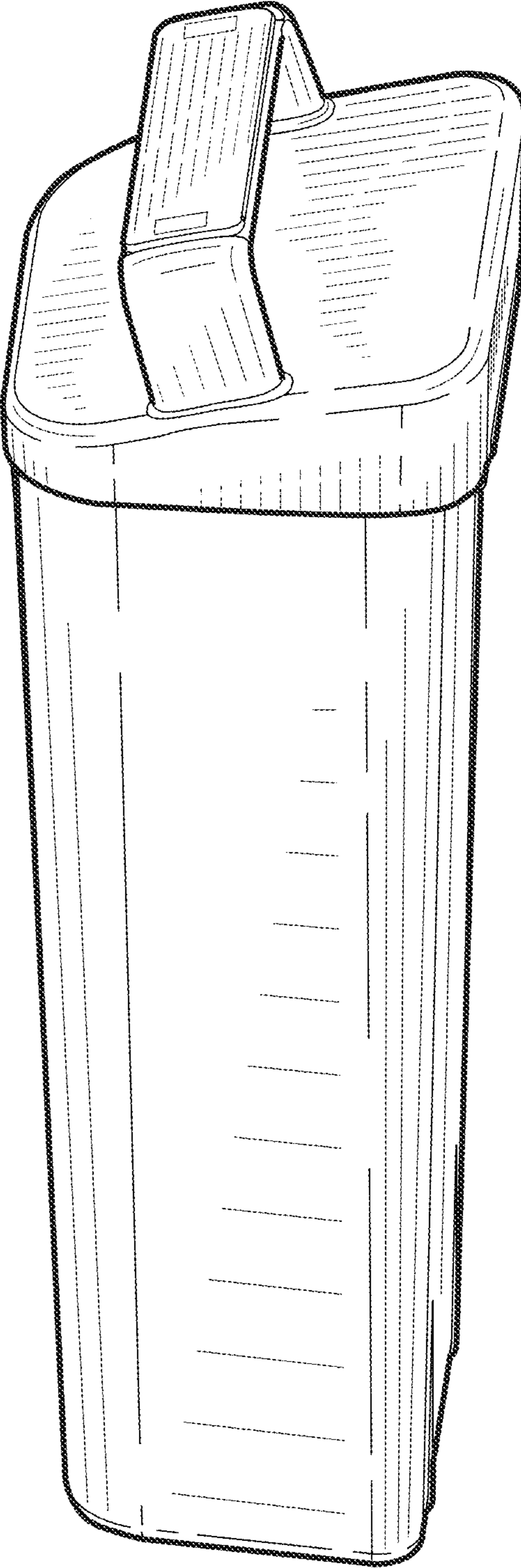

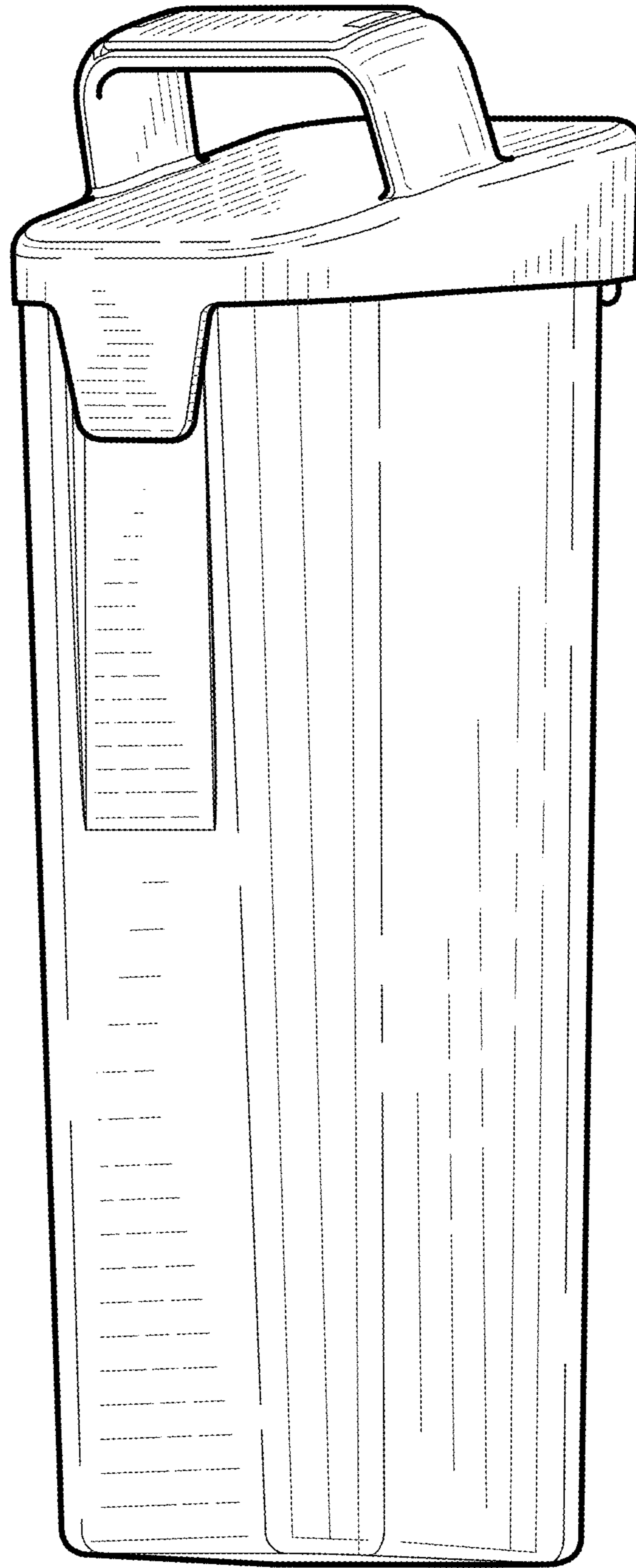

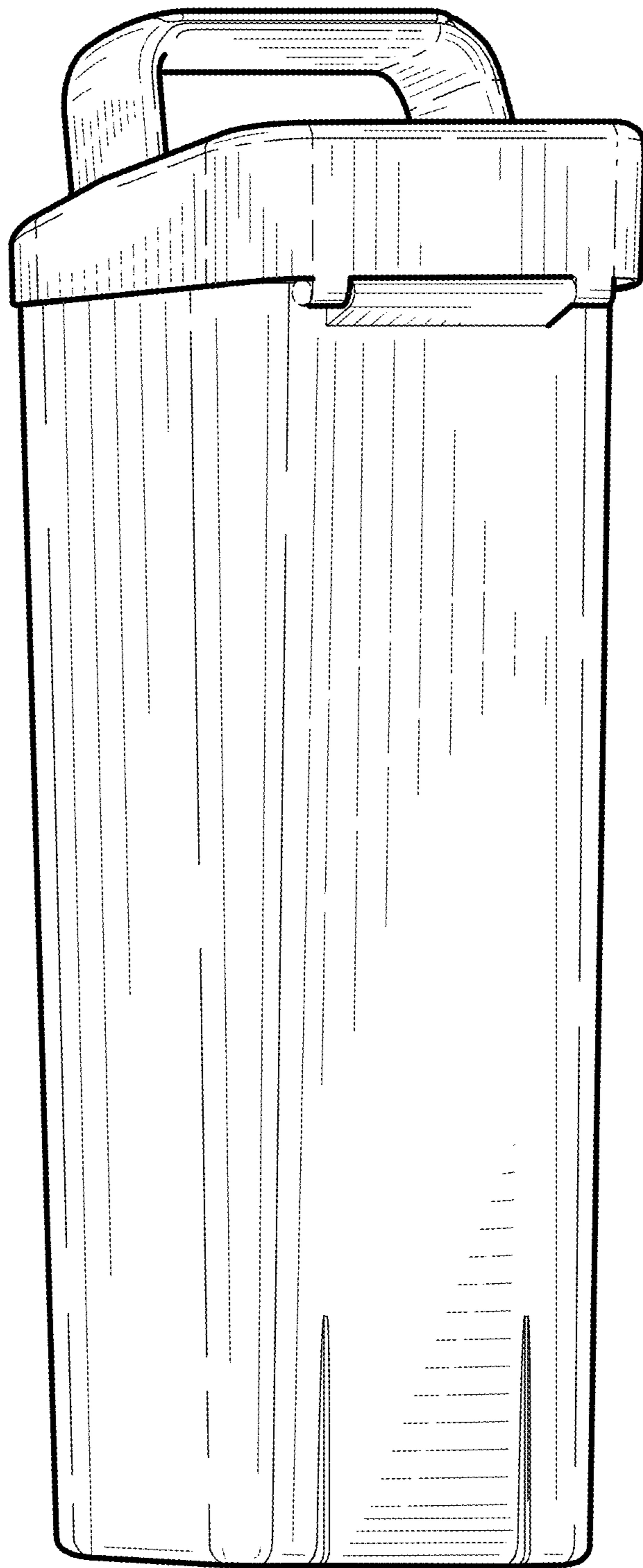

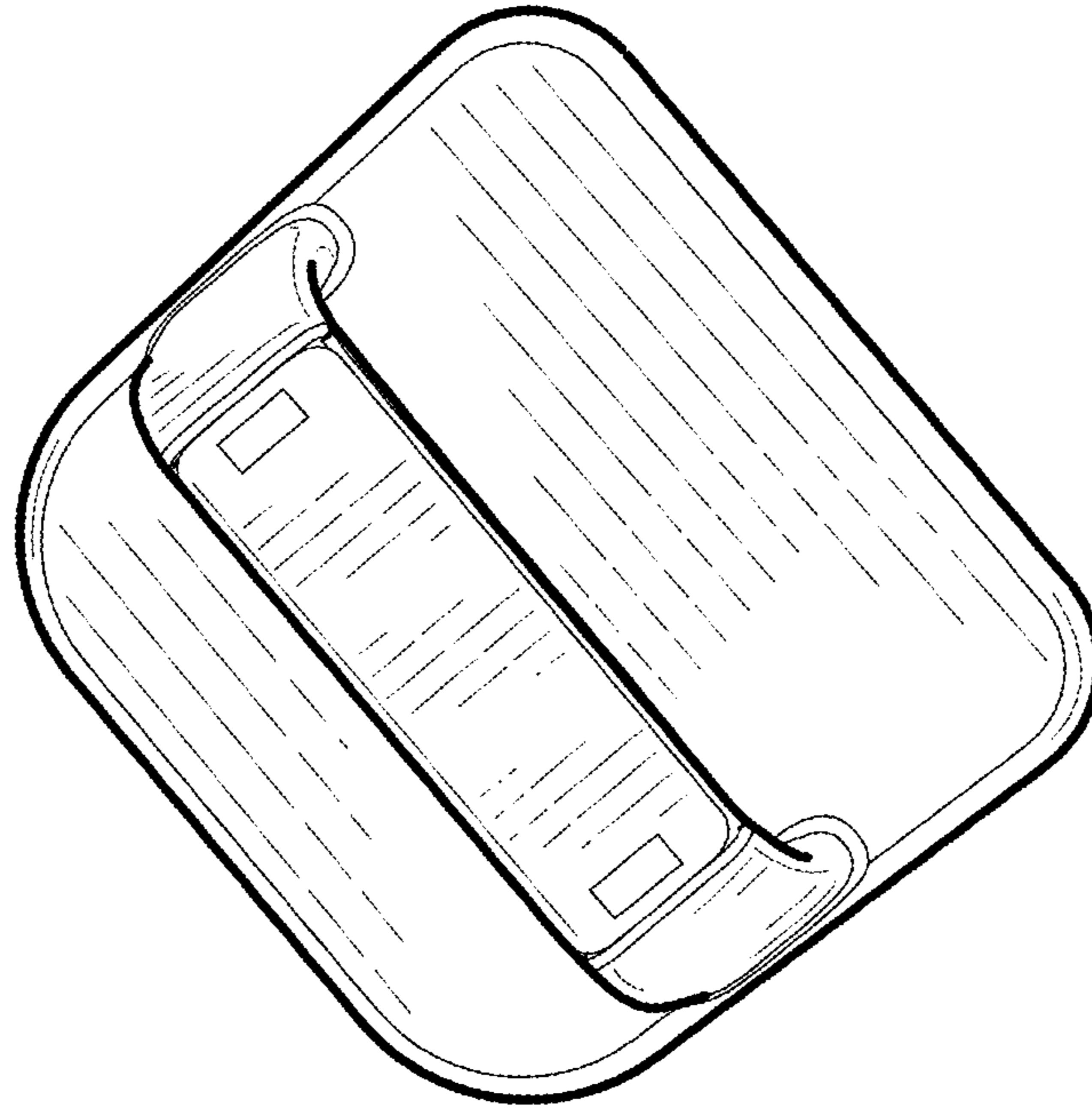

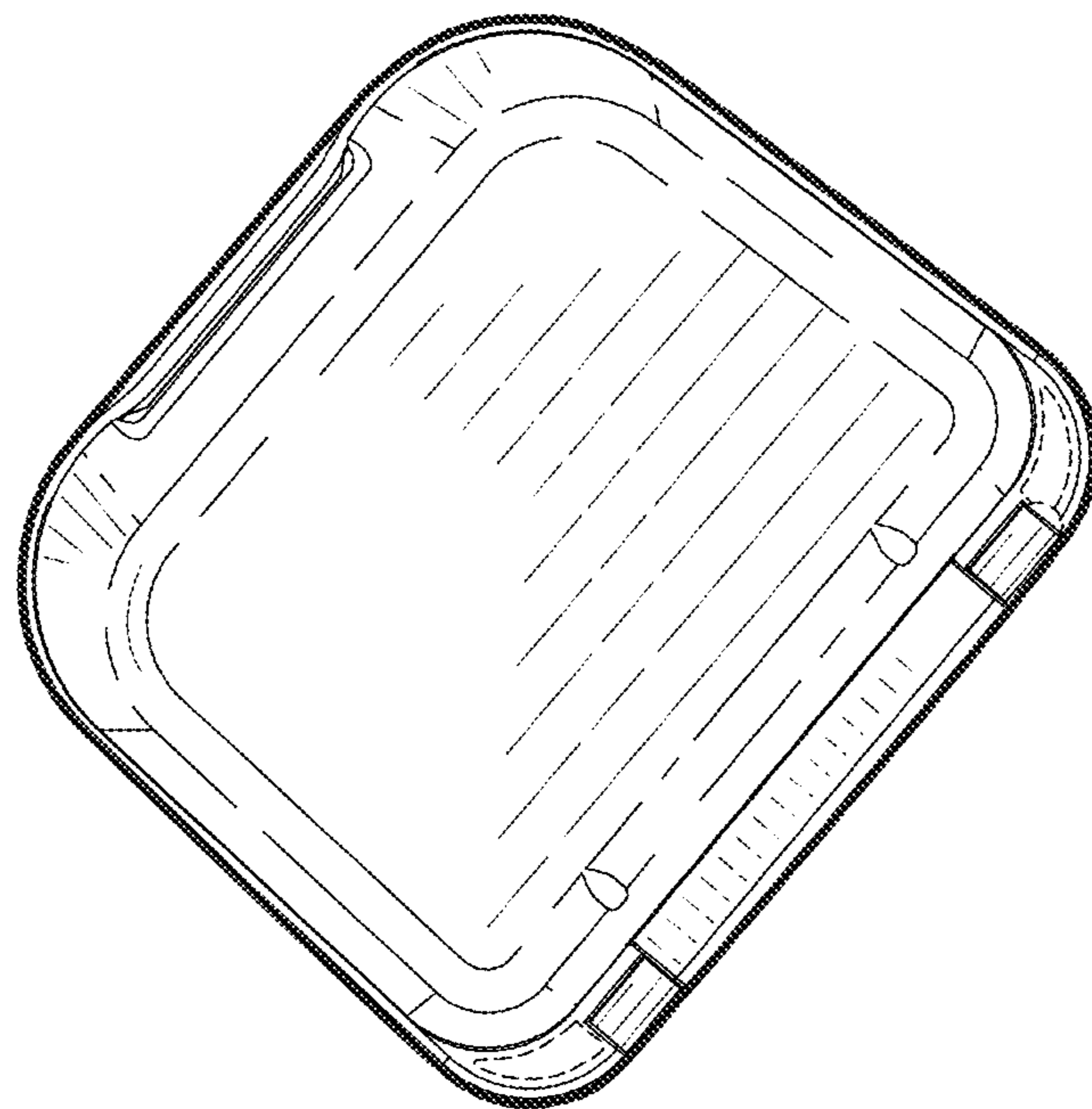
