DESCRIPTION

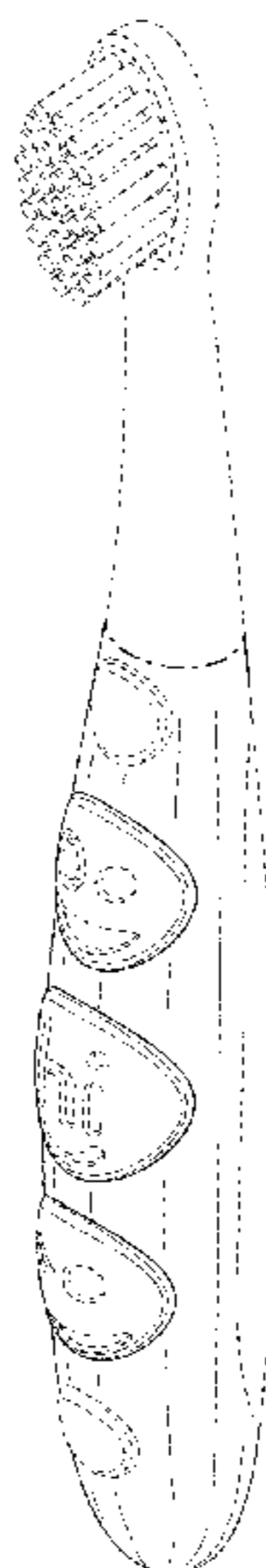
FIG. 1 is a front perspective view of an oral care implement showing the new design;

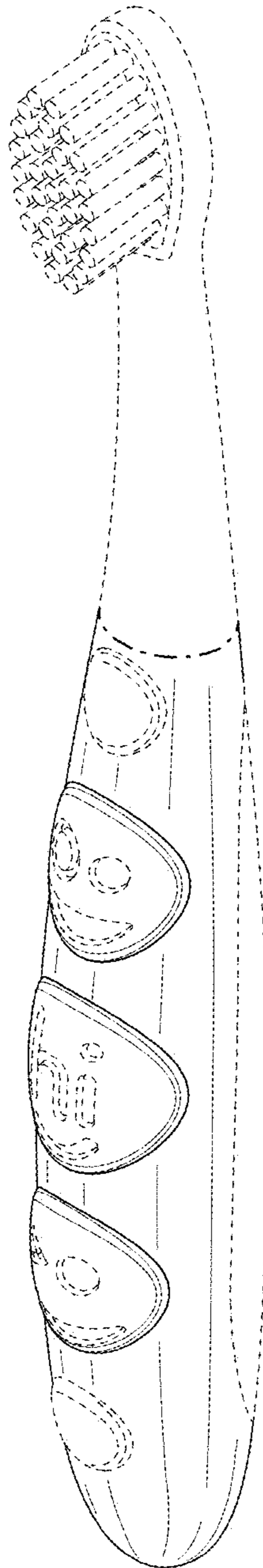

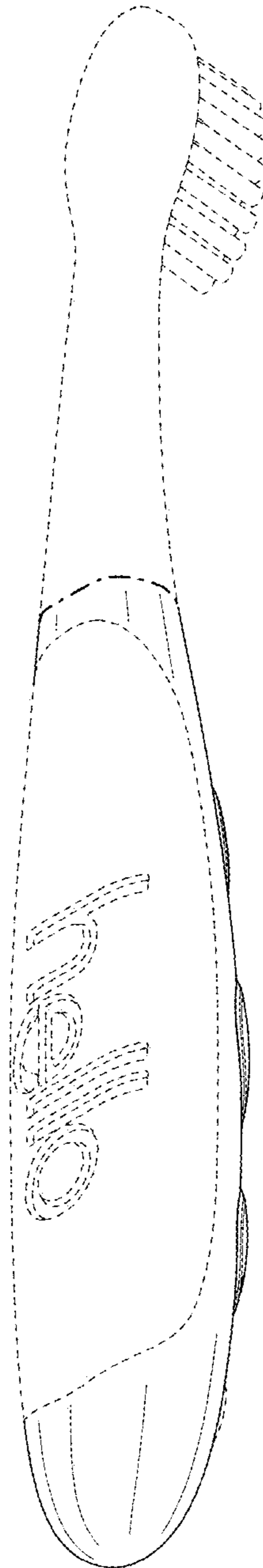

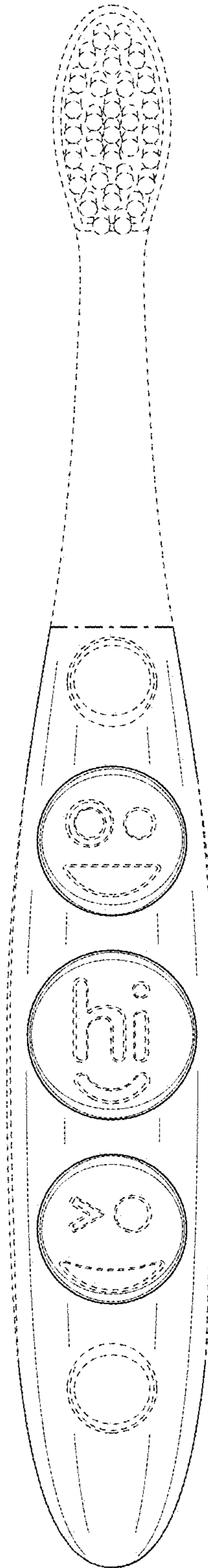

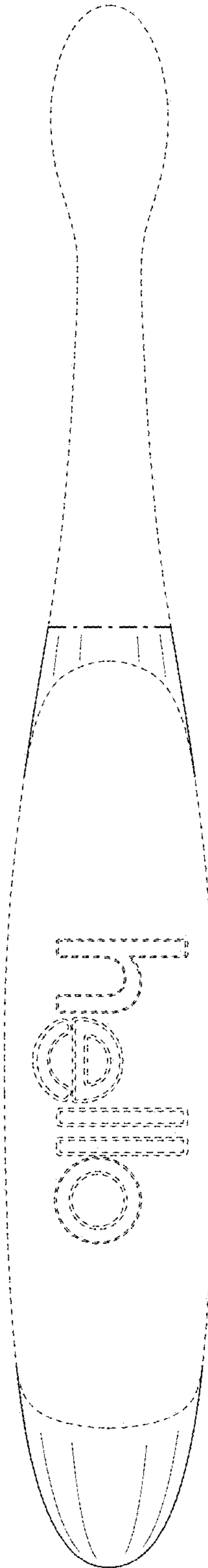

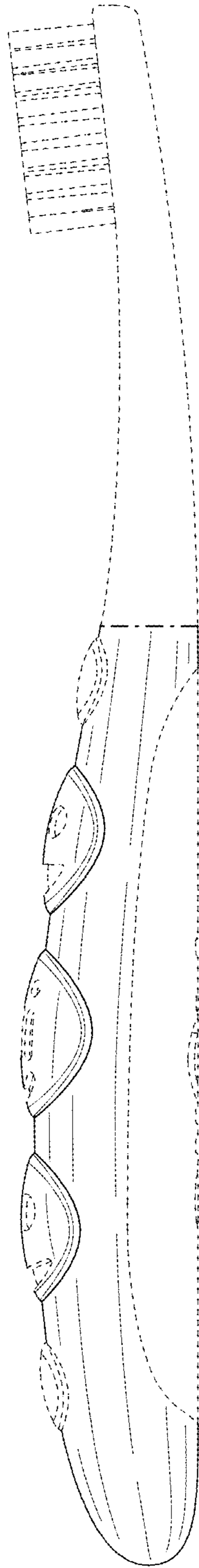

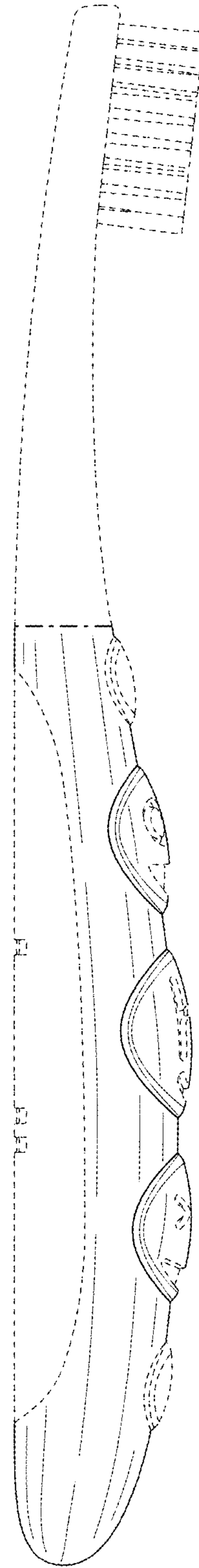

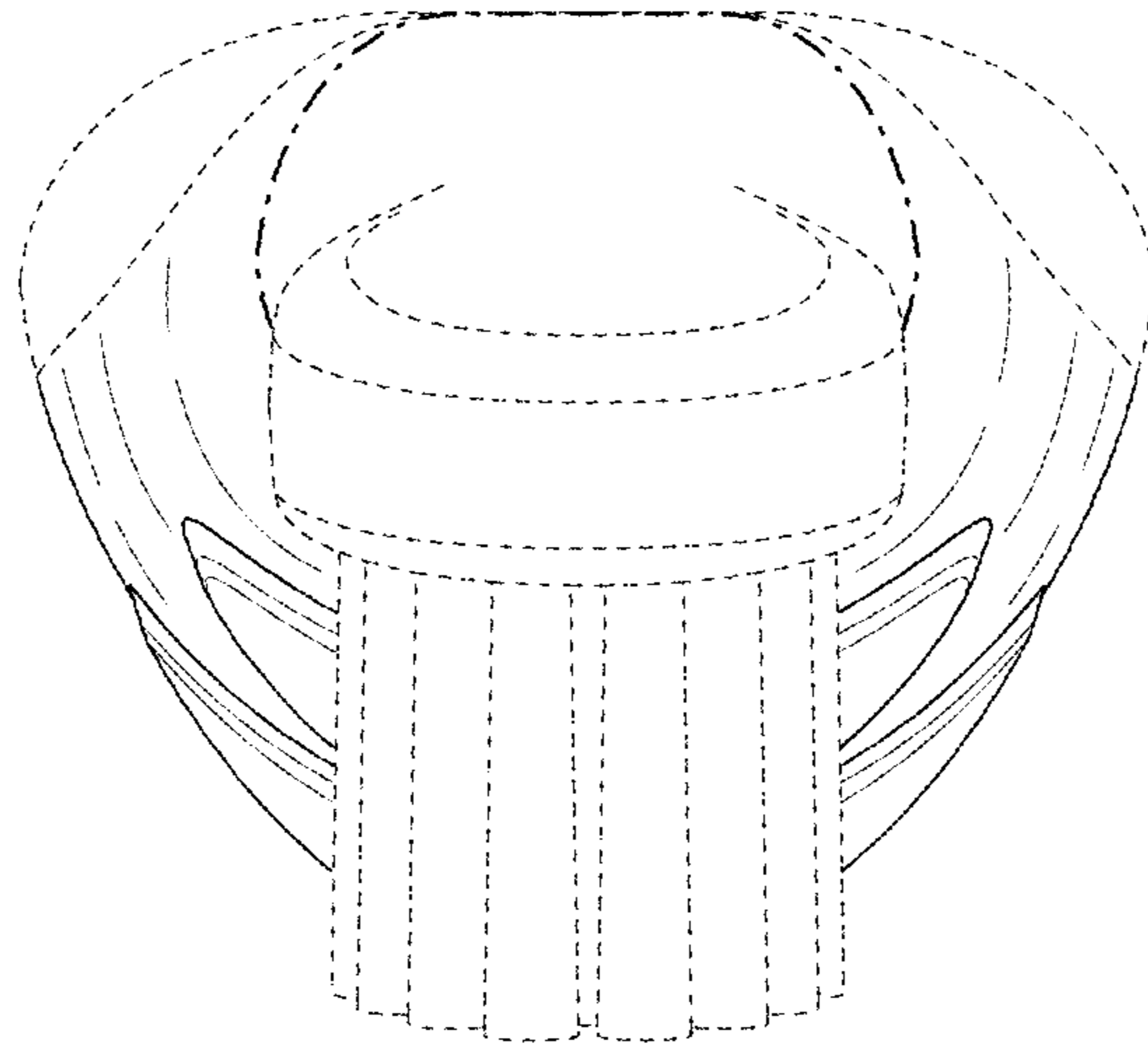

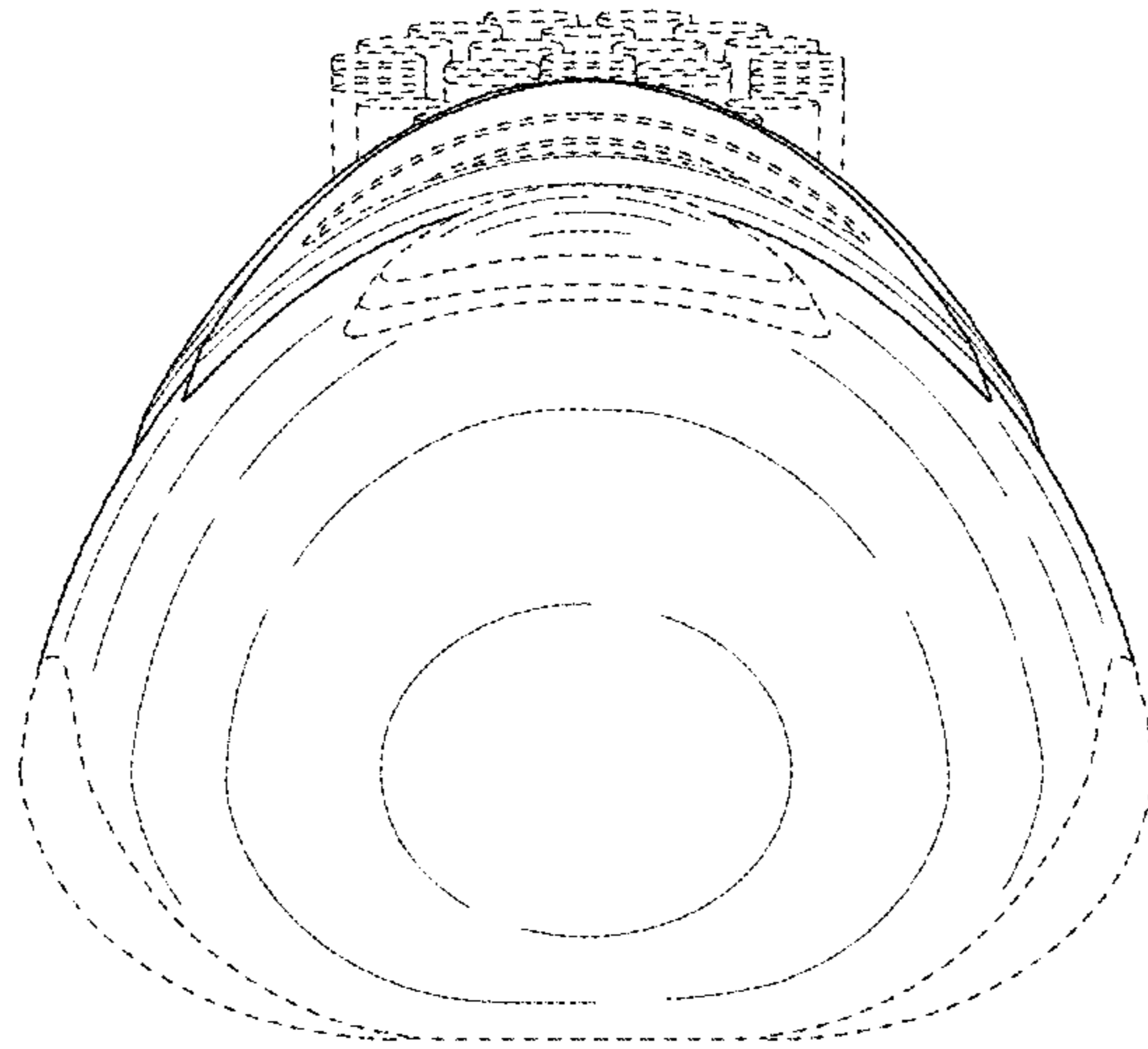
