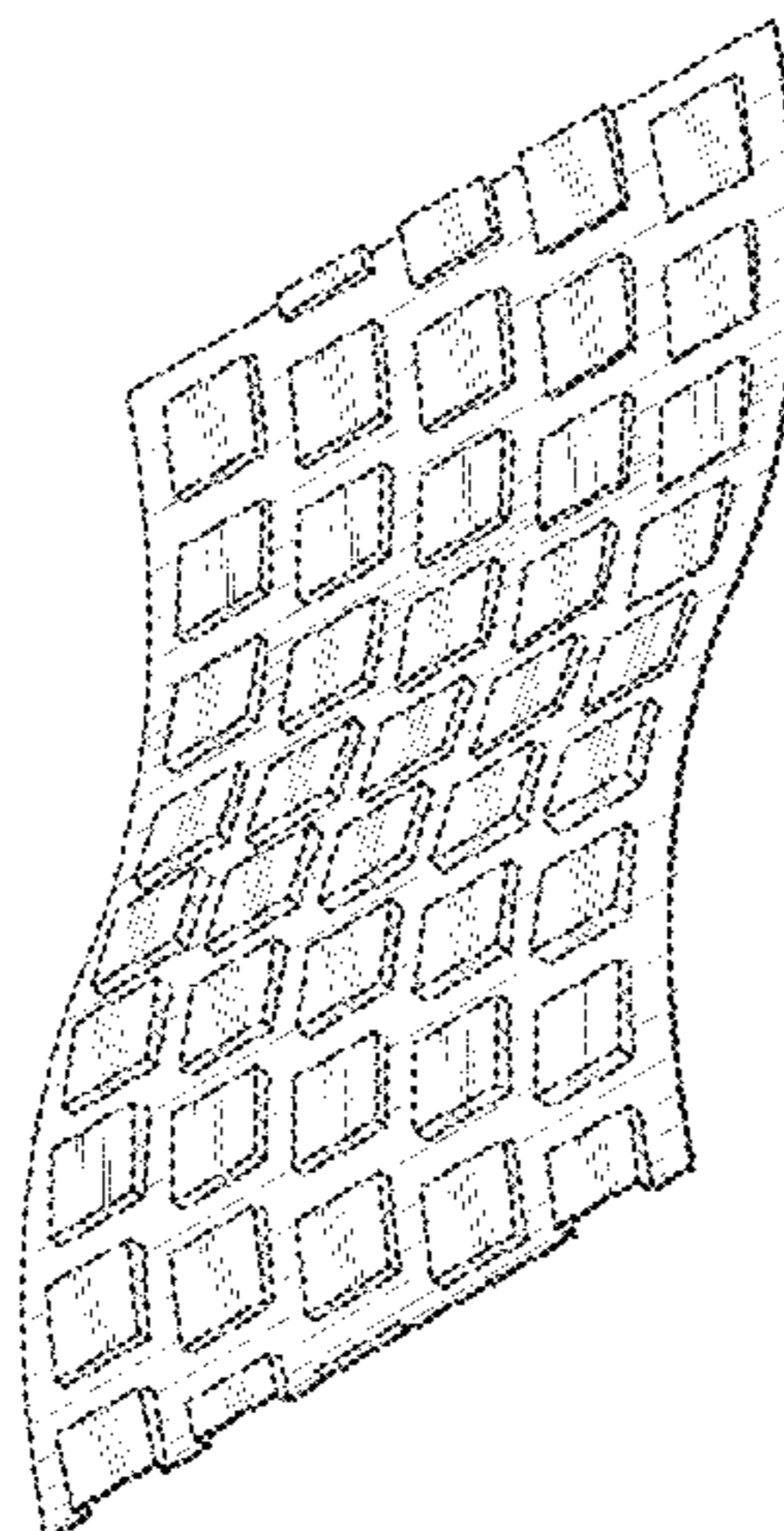
The ornamental design for an embossed non-woven material, as shown and described.

**DESCRIPTION**

1. Embossed non-woven material  
Figure 1.1 is a front perspective view of an embossed non-woven material;  
Figure 1.2 is a rear perspective view of Figure 1.1;  
Figure 1.3 is a front view of Figure 1.1;  
Figure 1.4 is a rear view of Figure 1.1;  
Figure 1.5 is a right-side view taken along the line 5-5 in Figure 1.3; and  
Figure 1.6 is a right-side view taken along the line 6-6 in Figure 1.4.

The dot-dash broken lines shown in the drawings identify the direction of the cross-sectional views within Figures 1.3 and 1.4.

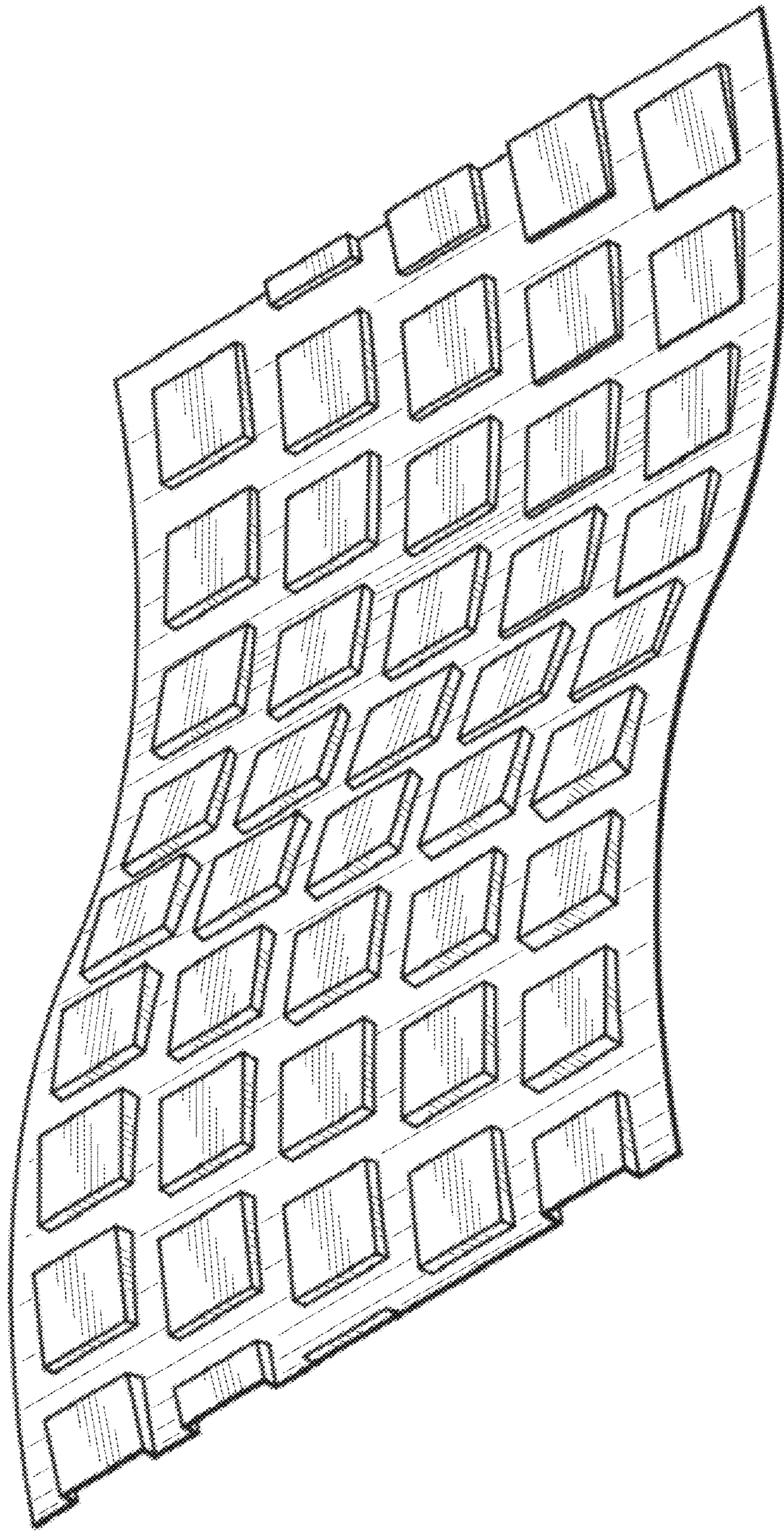

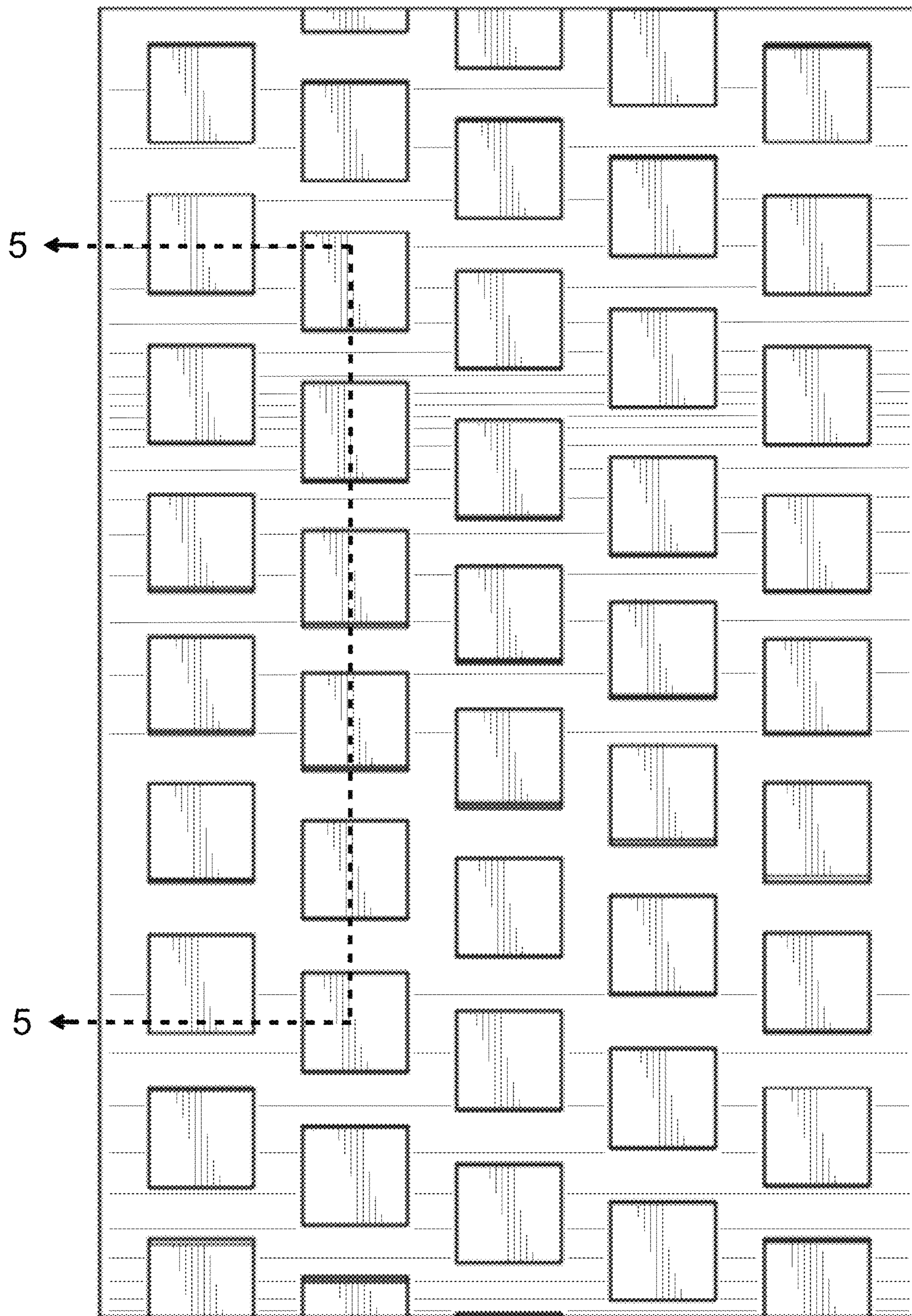

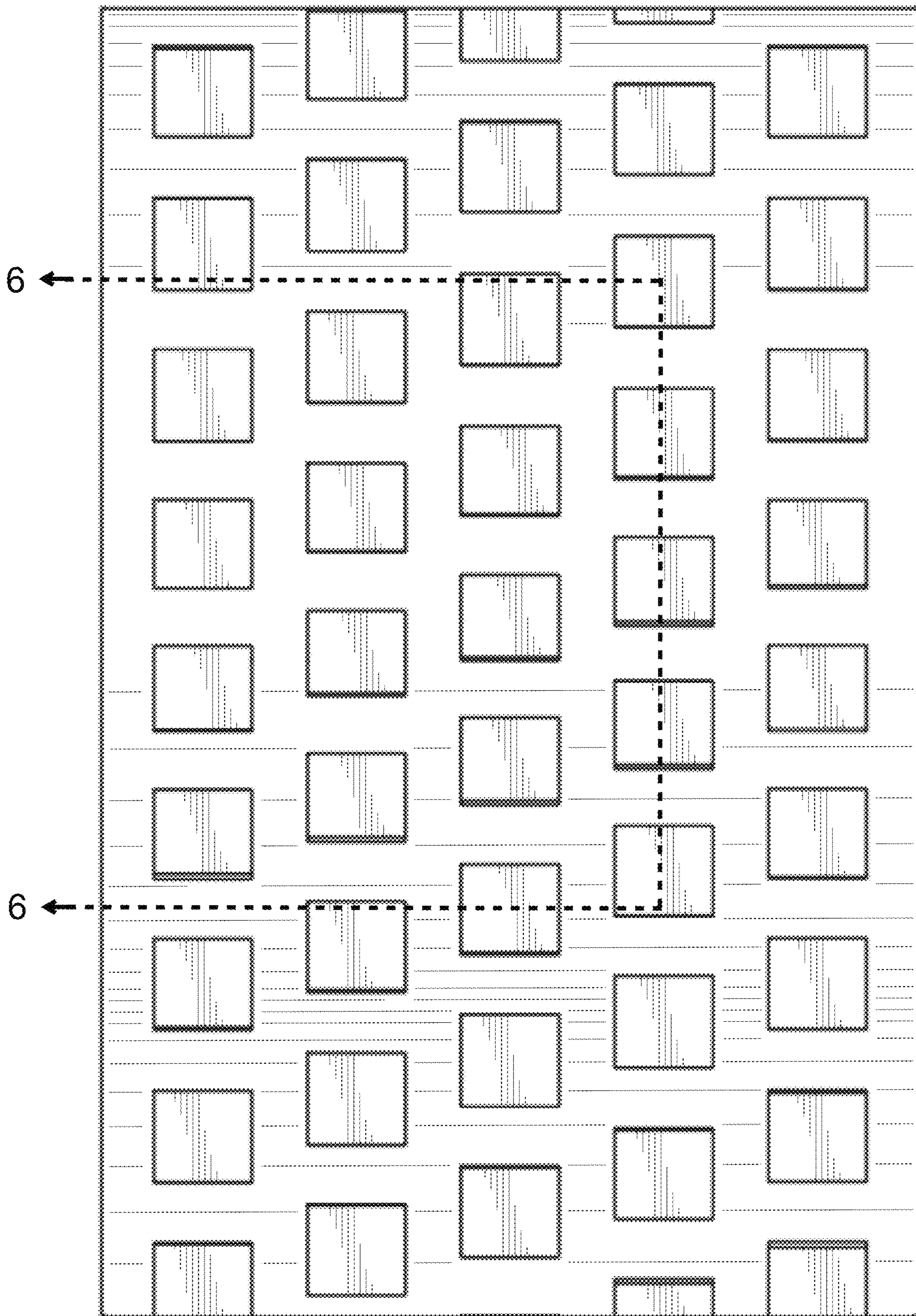

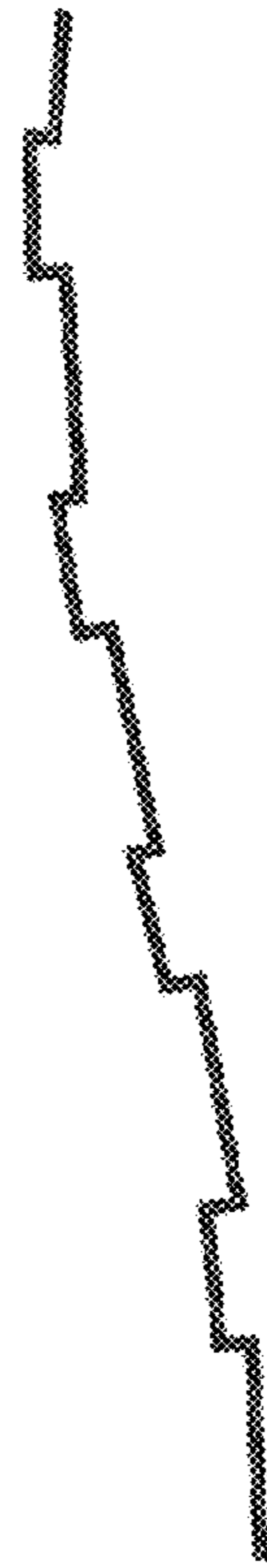
