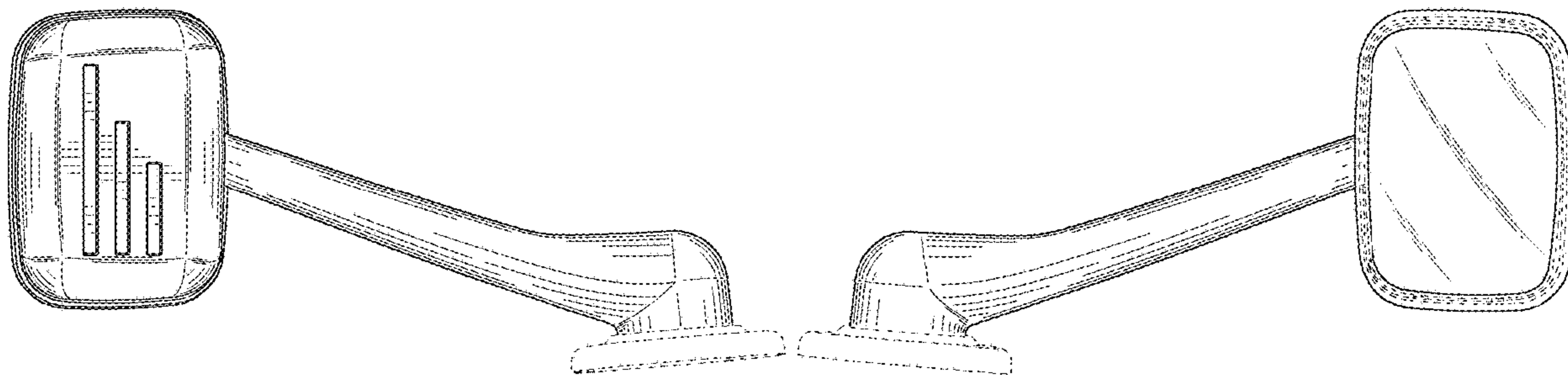
(57) **CLAIM**

The ornamental design for a vehicle rearview mirror, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a vehicle rearview mirror, showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left elevational view thereof; FIG. 5 is a right elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The evenly broken lines where present illustrate portions of the vehicle rearview mirror that form no part of the claimed design.

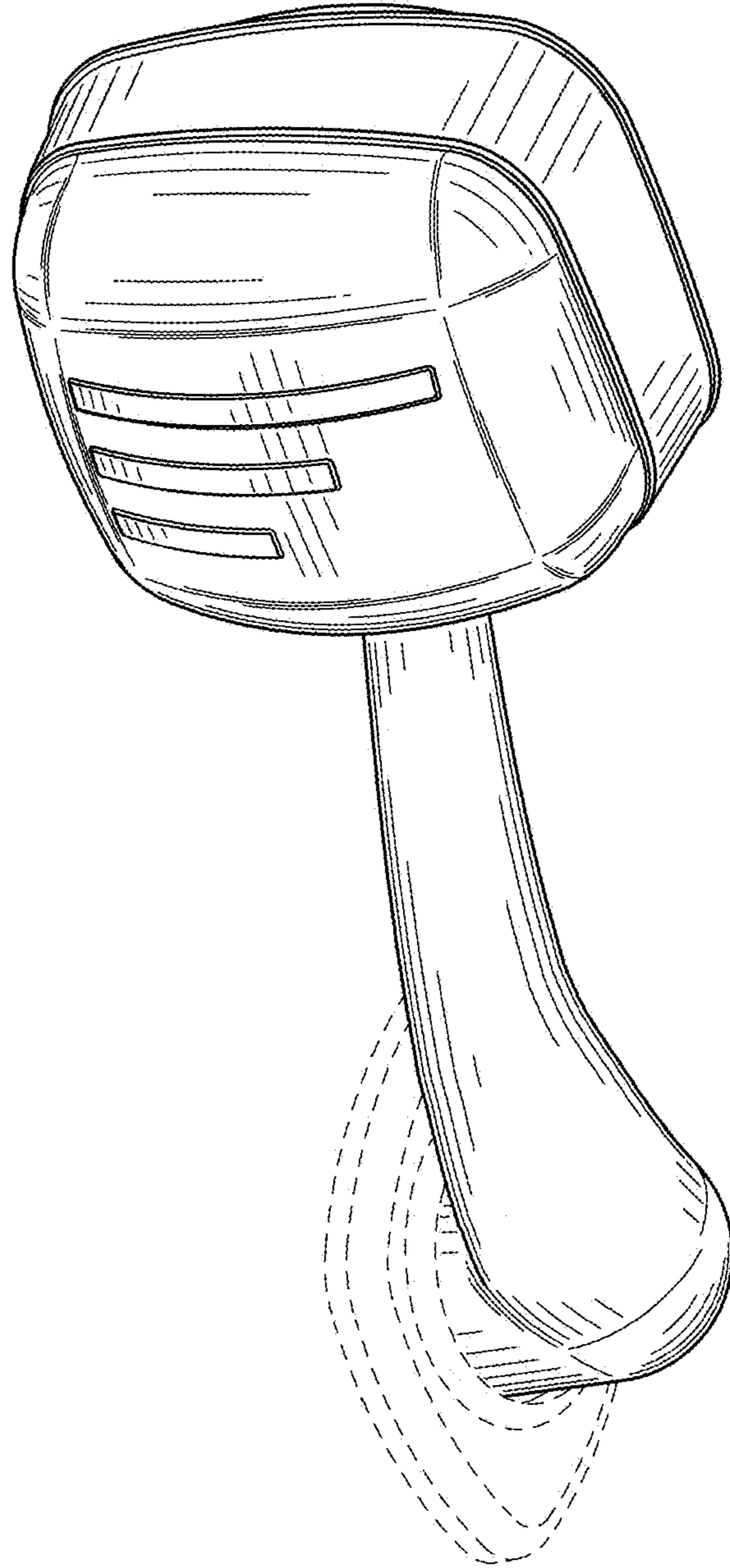

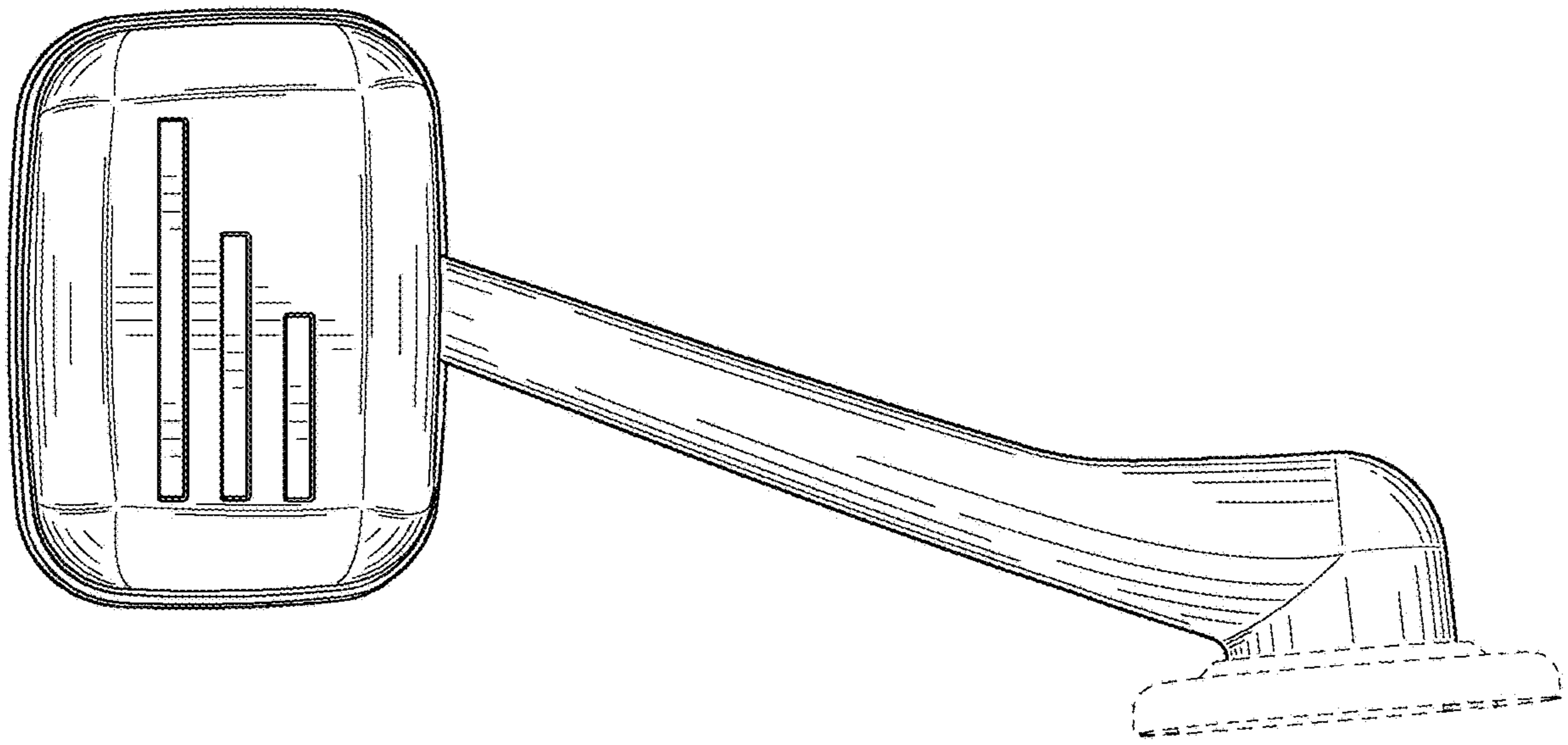

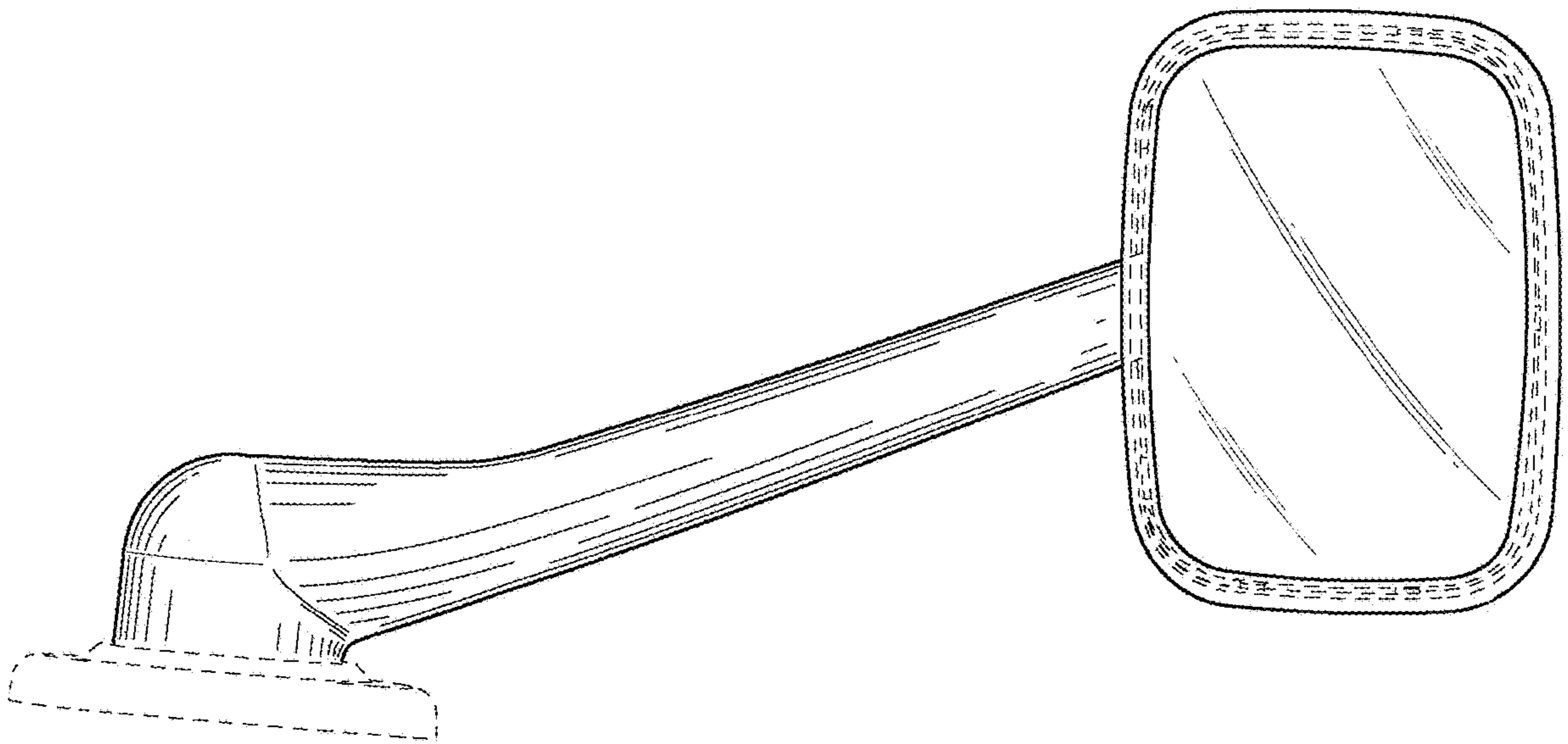

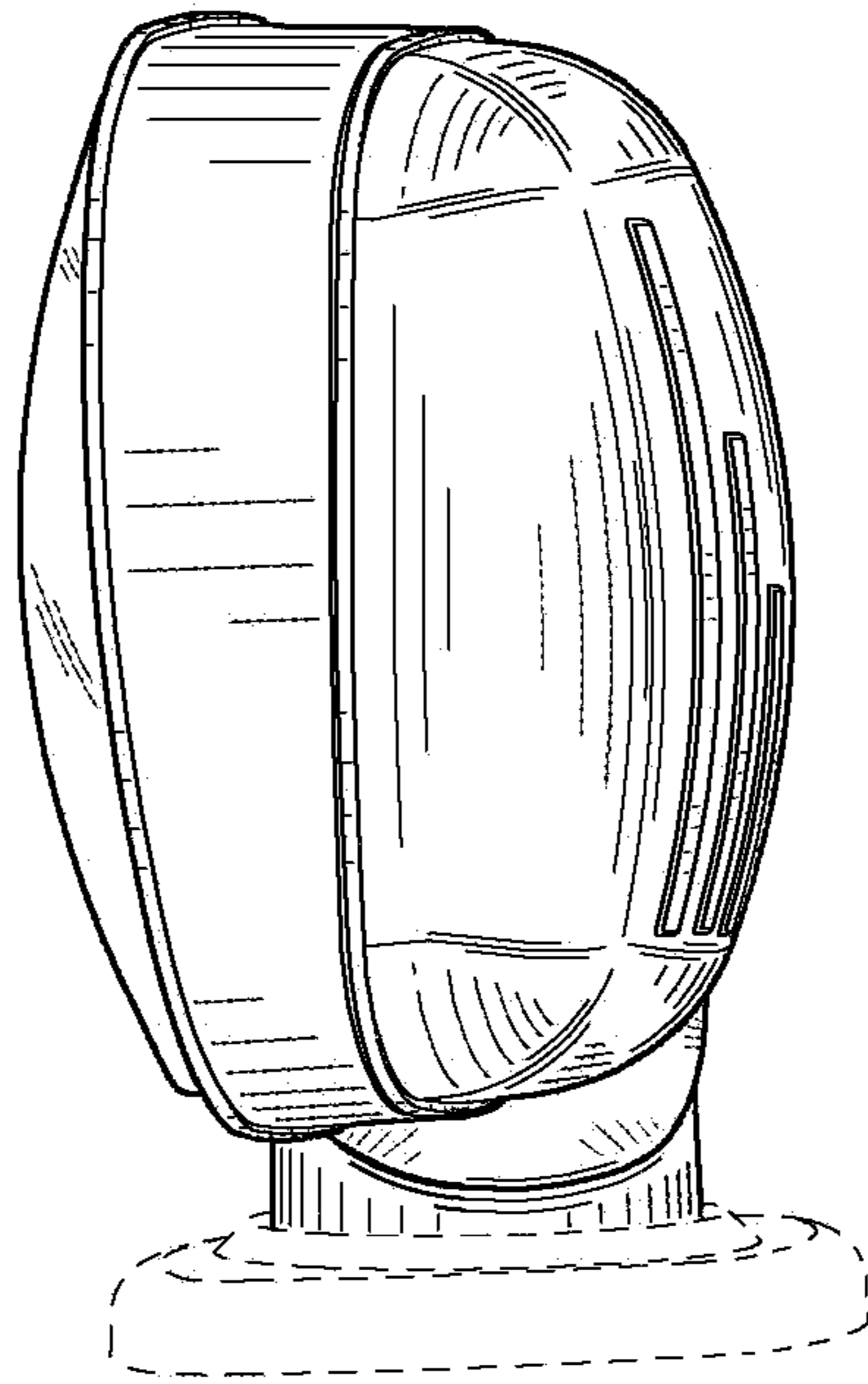

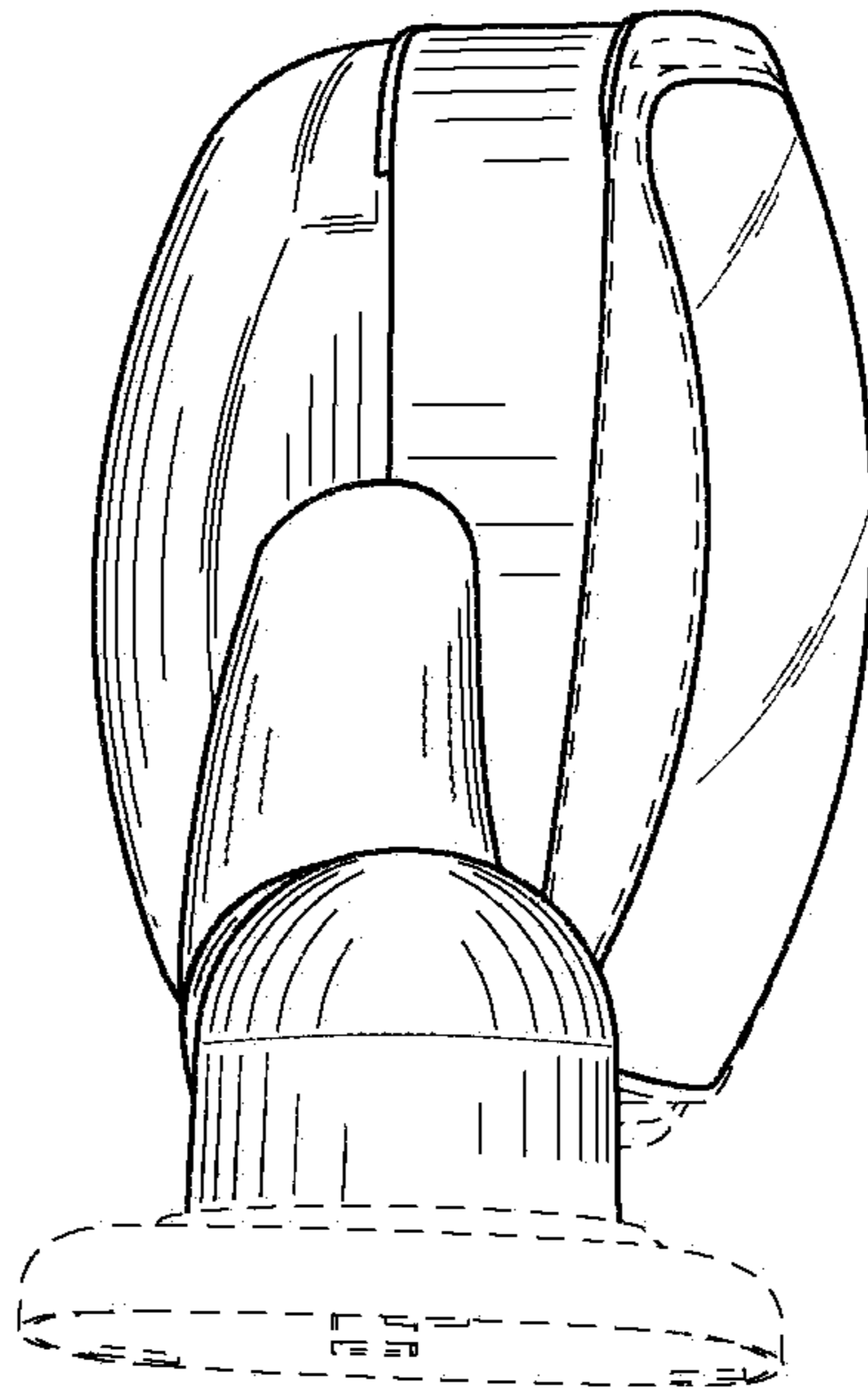

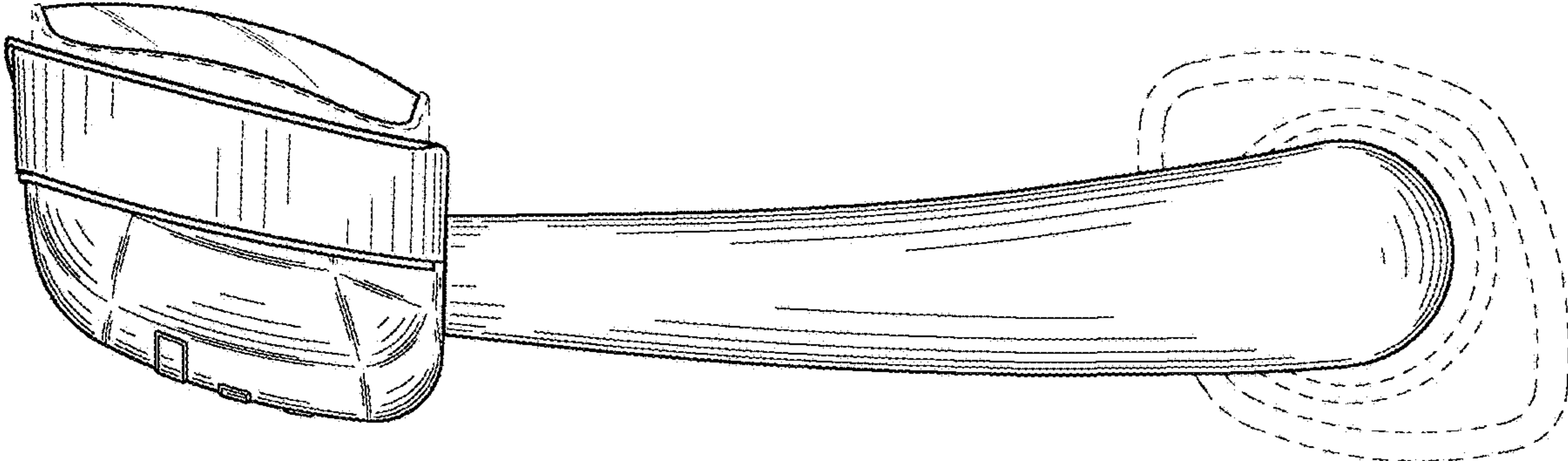

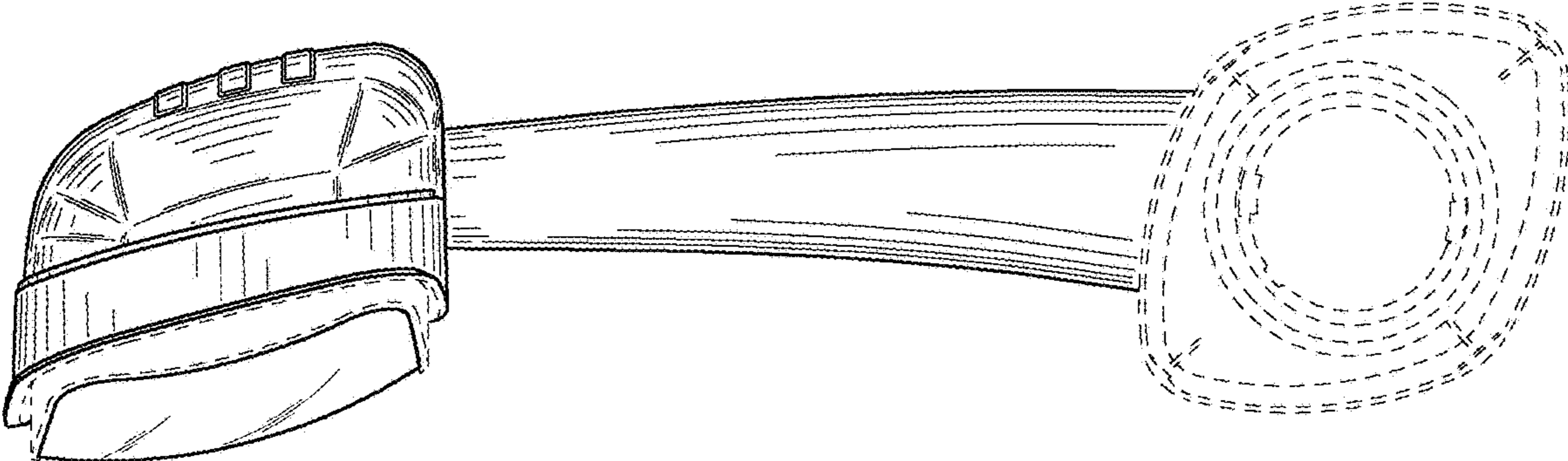
