FIG. 1 is a top, front and left side perspective view of a vehicle door showing our new design;

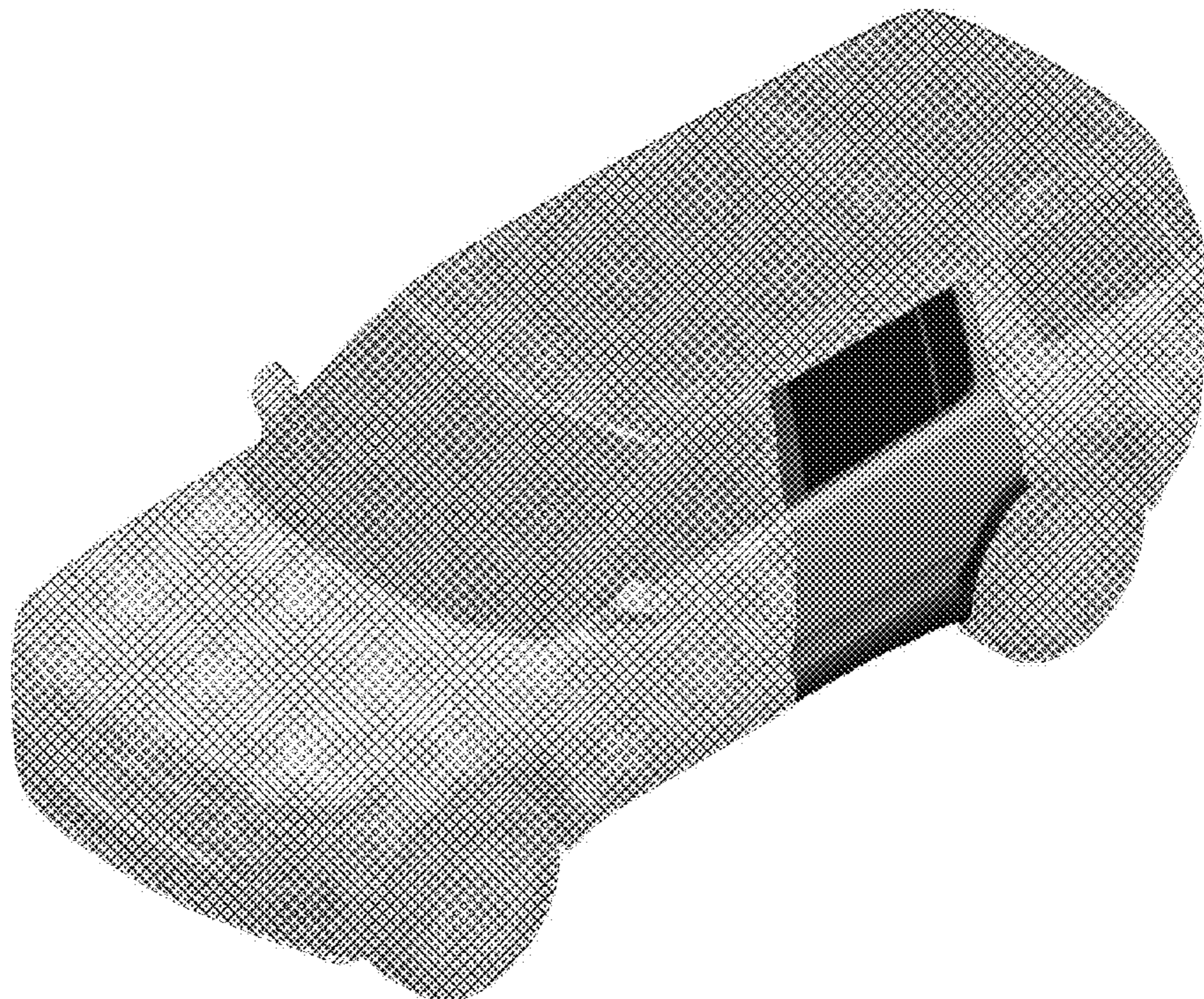
FIG. 2 is a rear elevational view thereof;

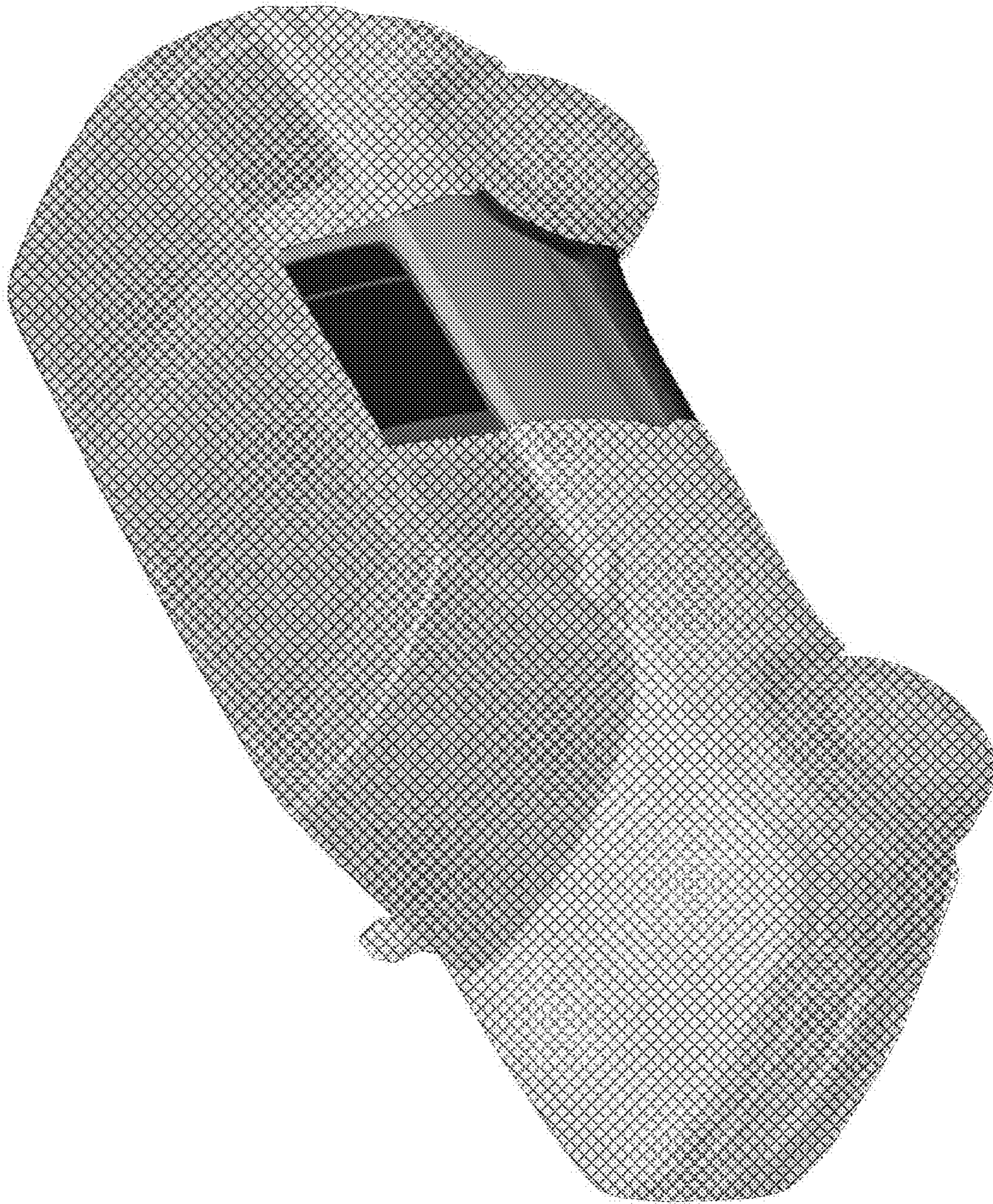

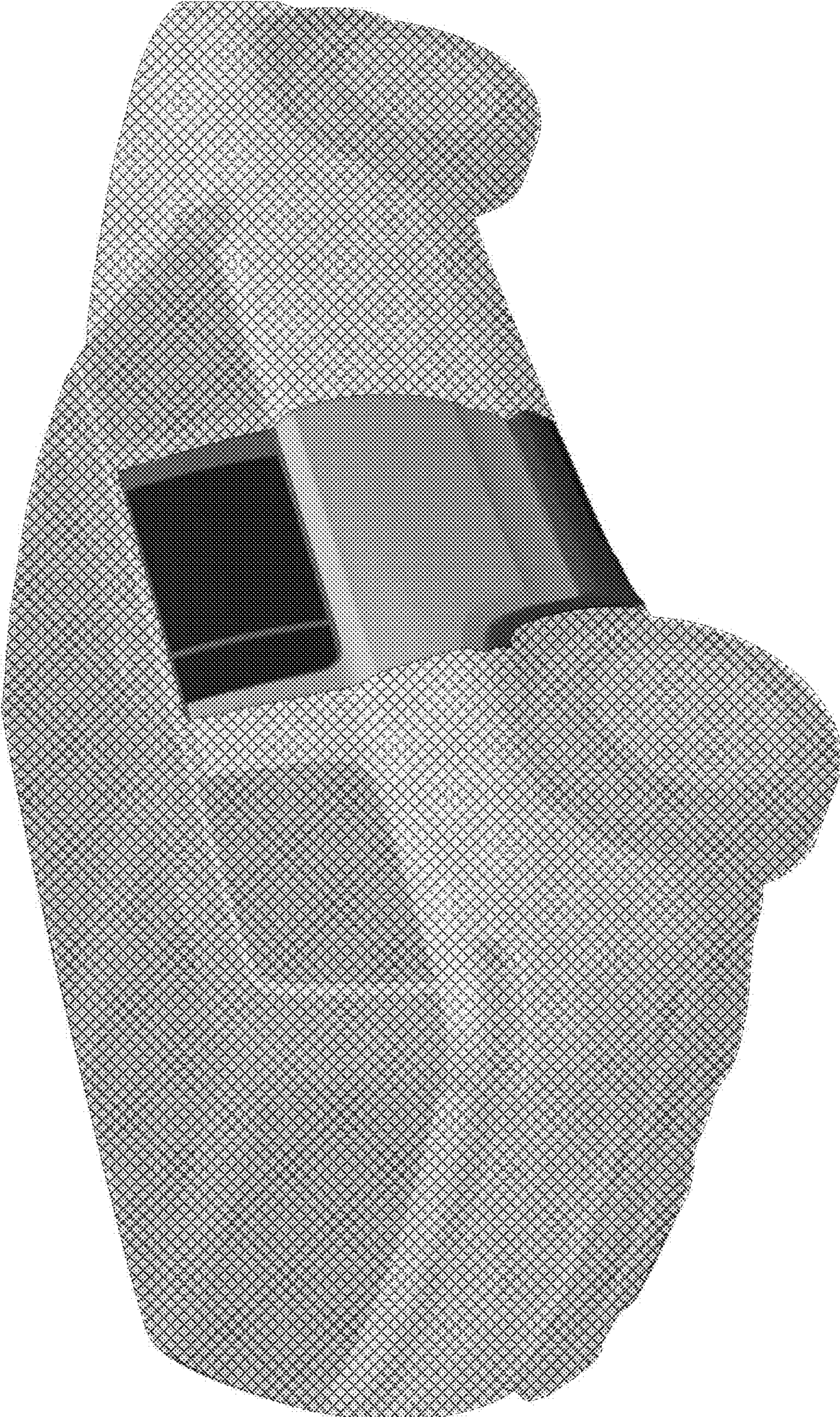

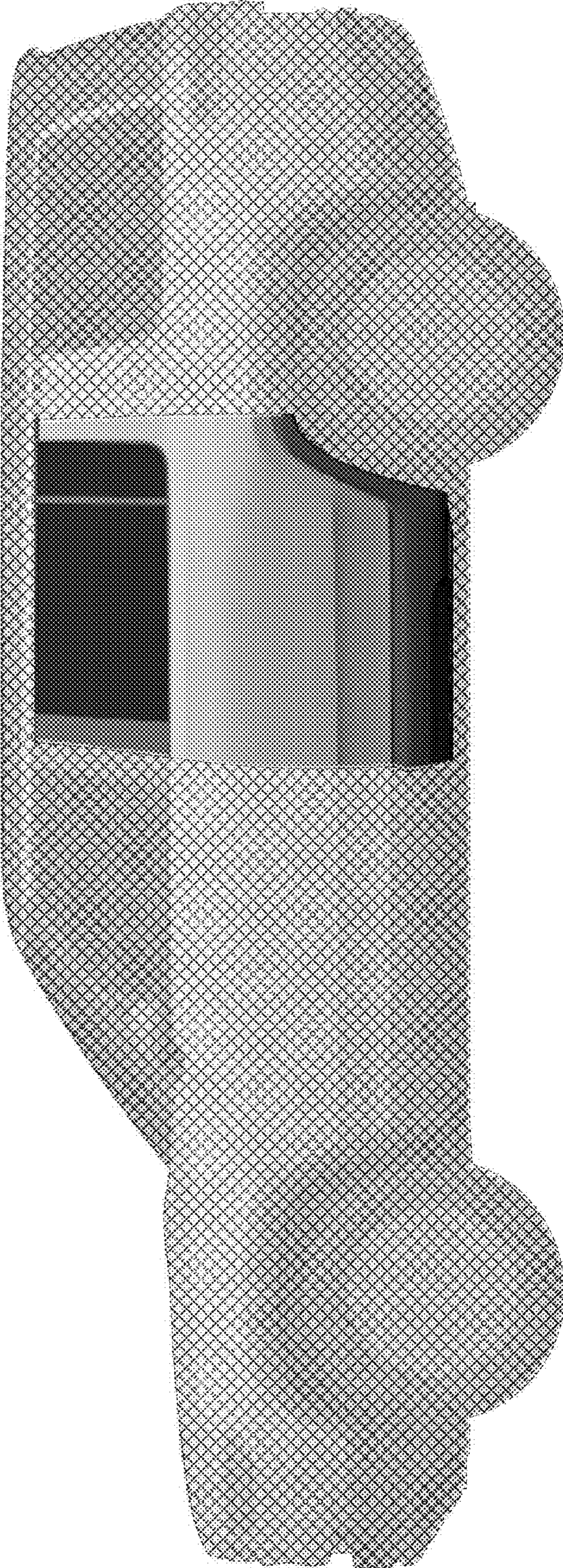

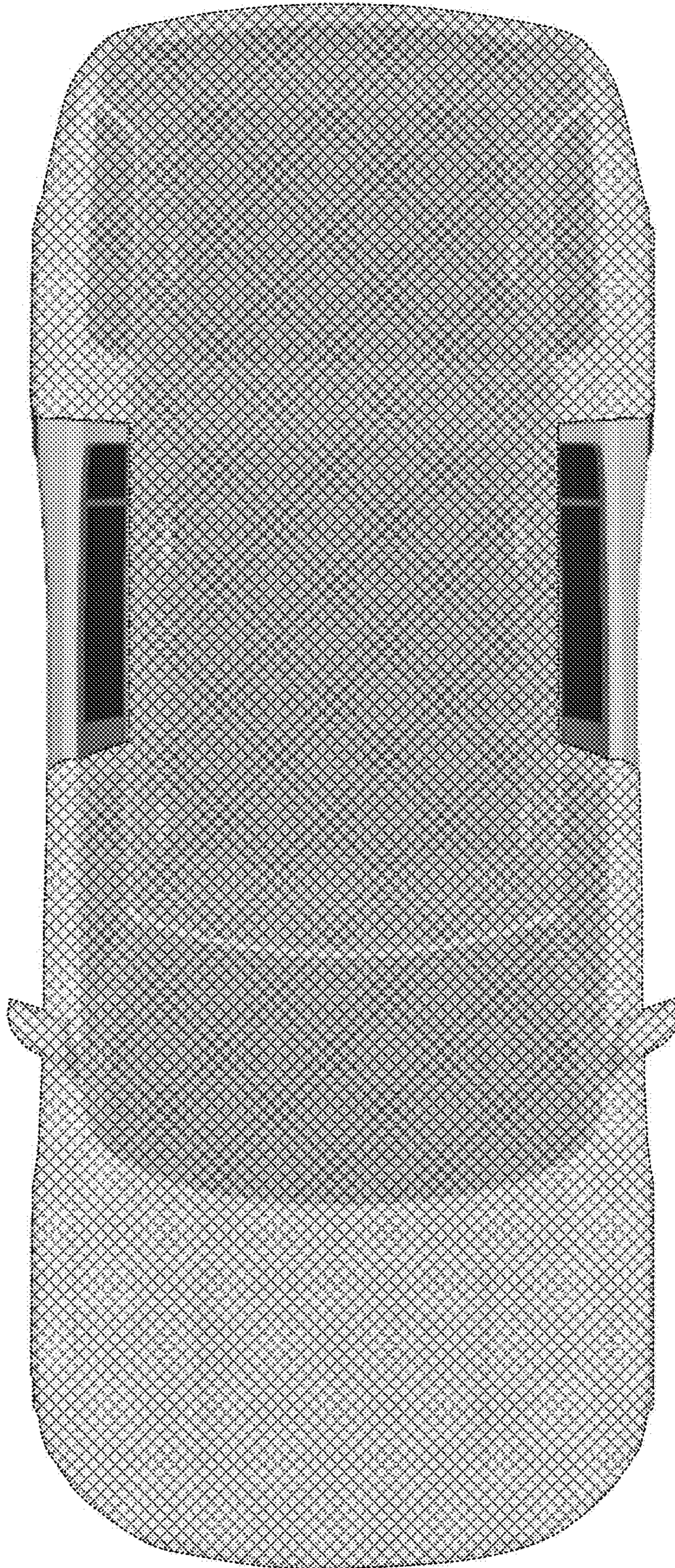
