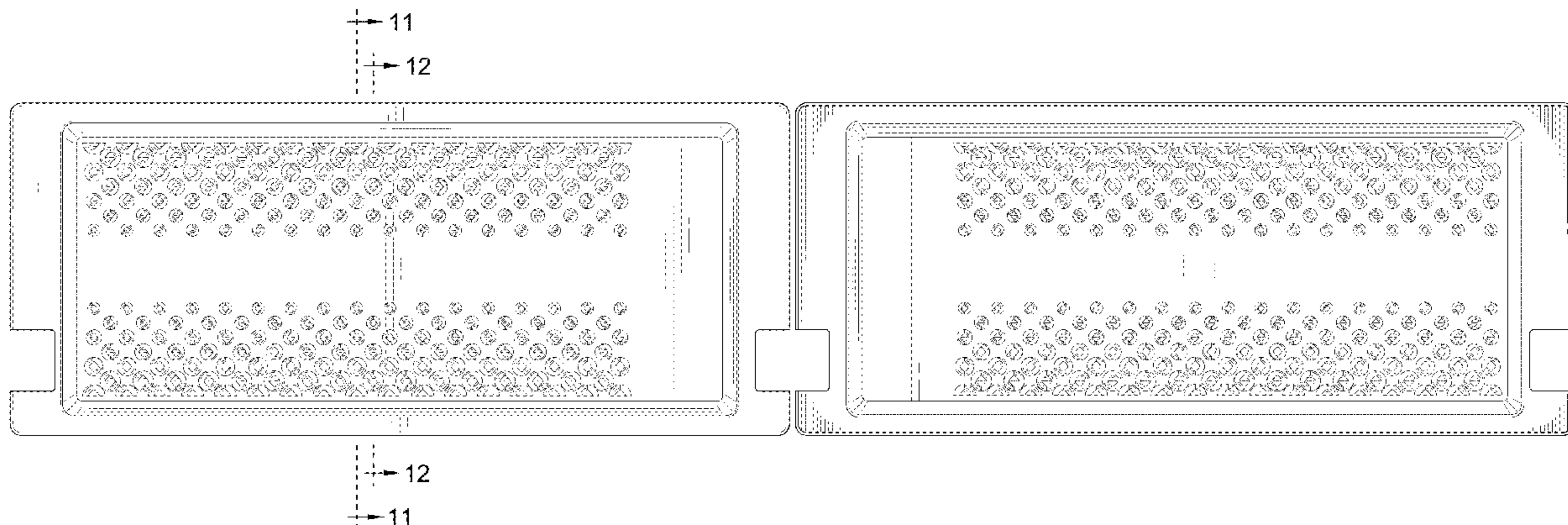
The ornamental design for a battery module case, as shown and described.

**DESCRIPTION**

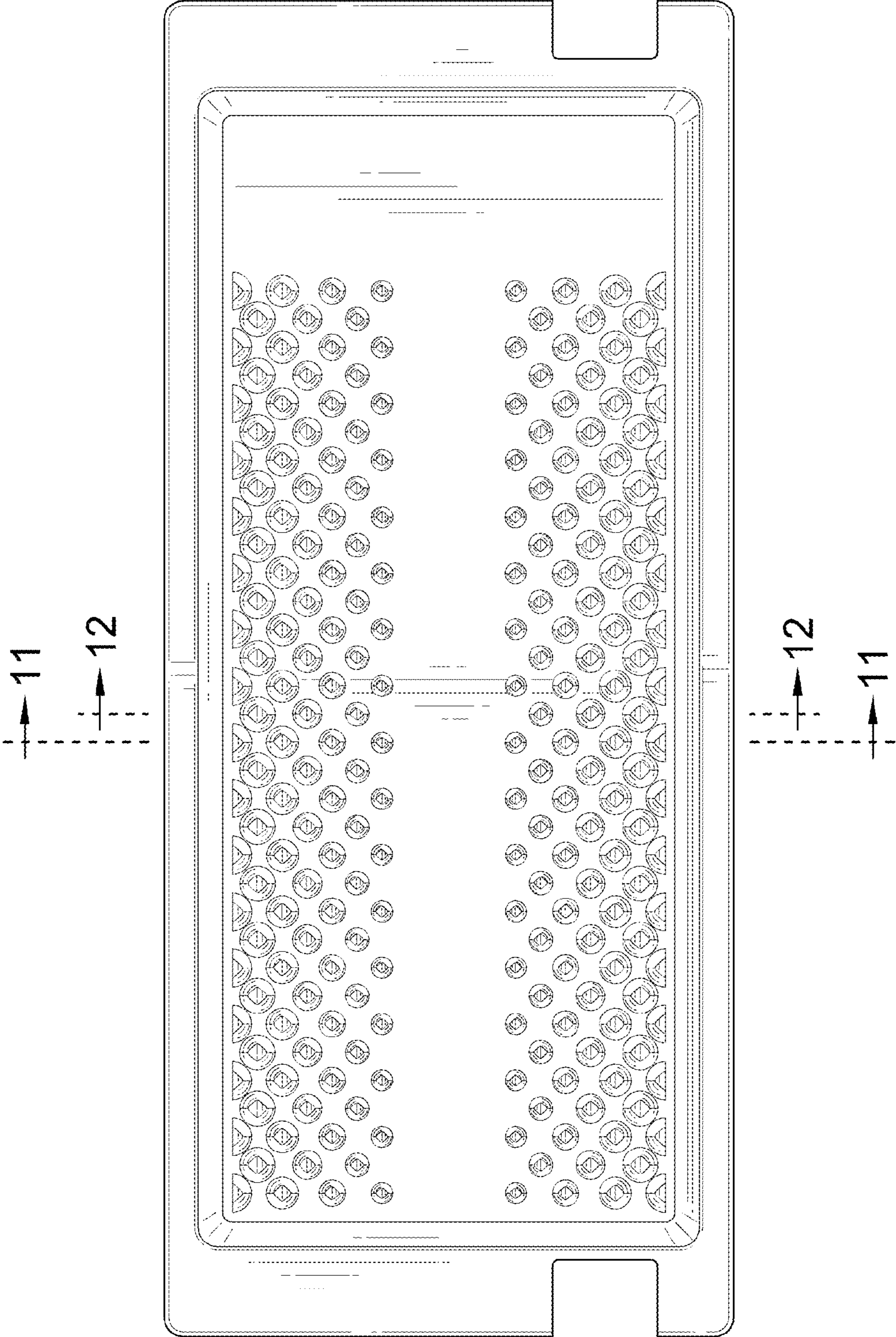

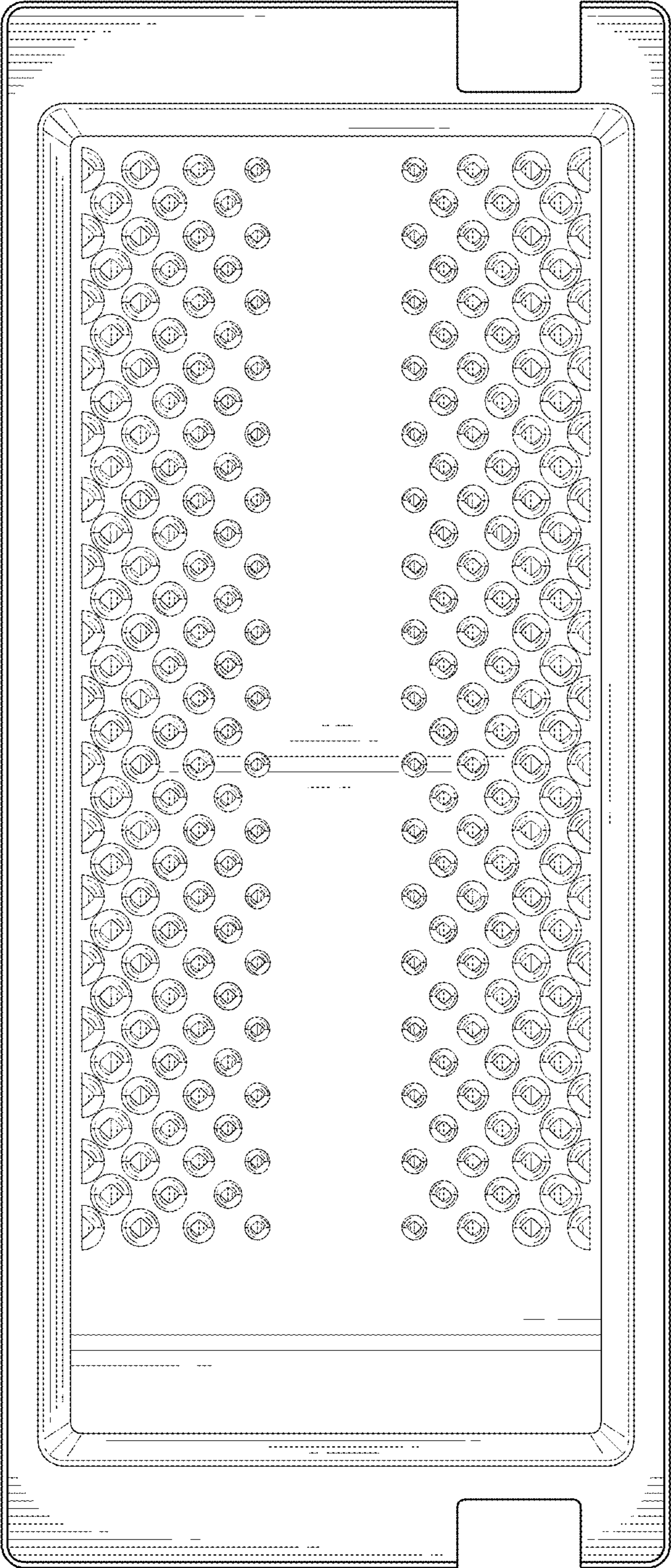

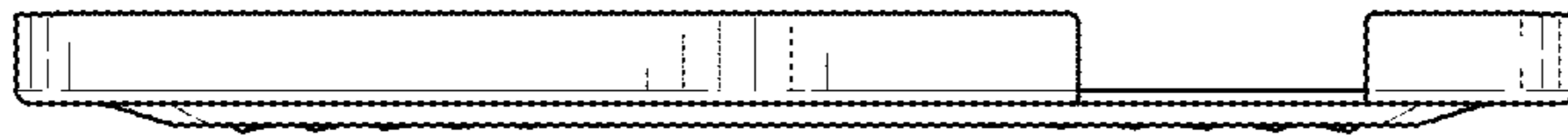

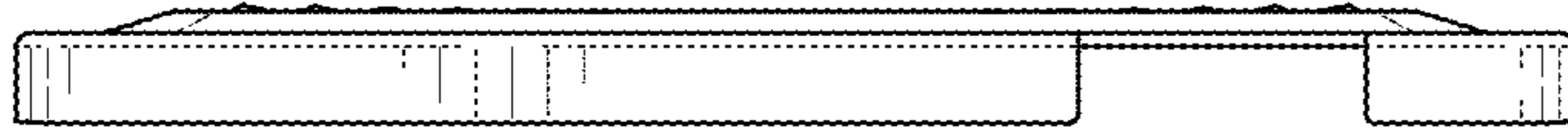

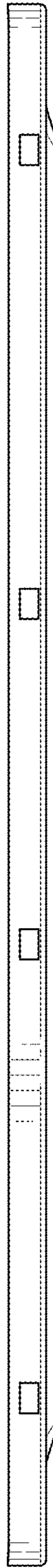

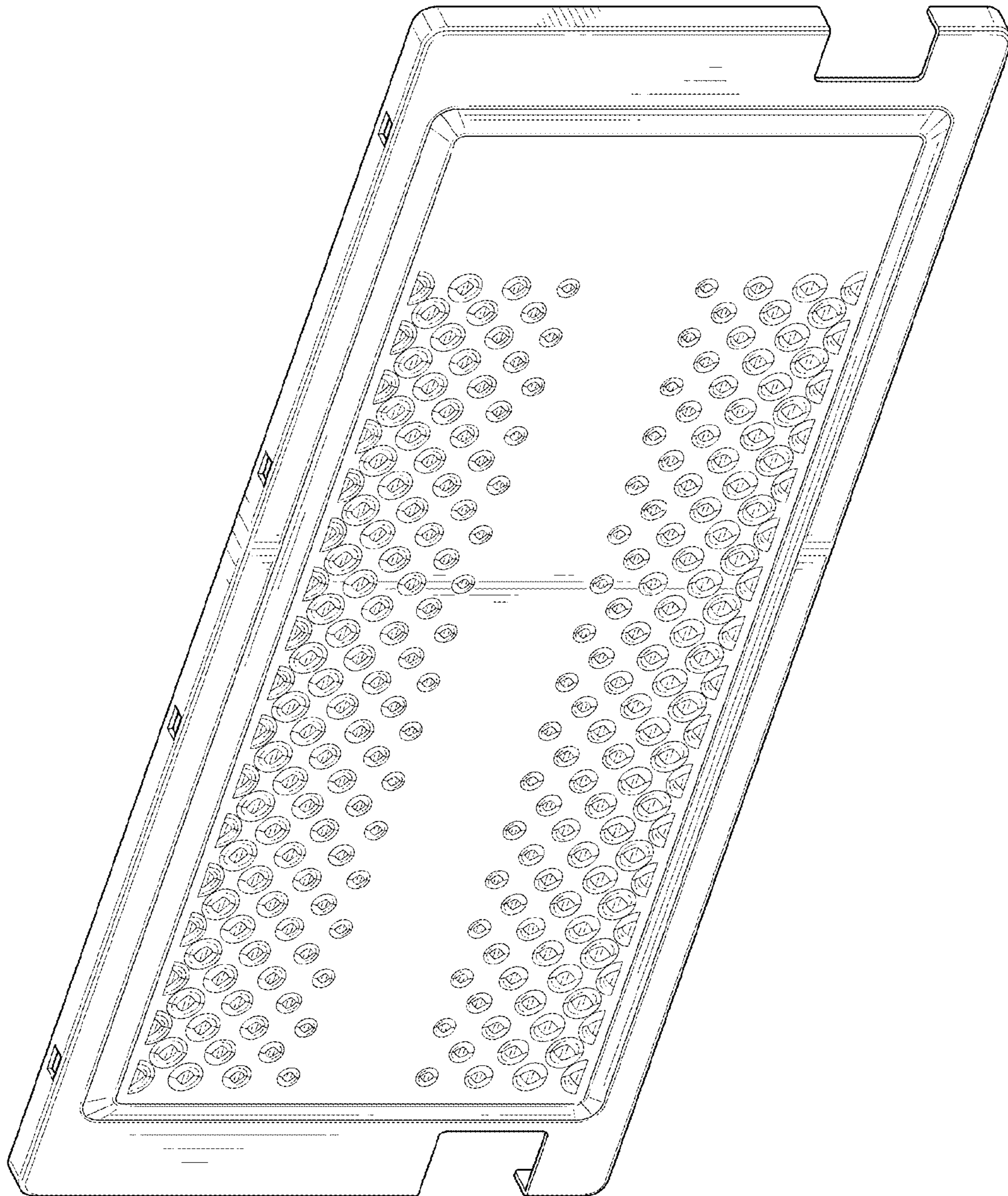

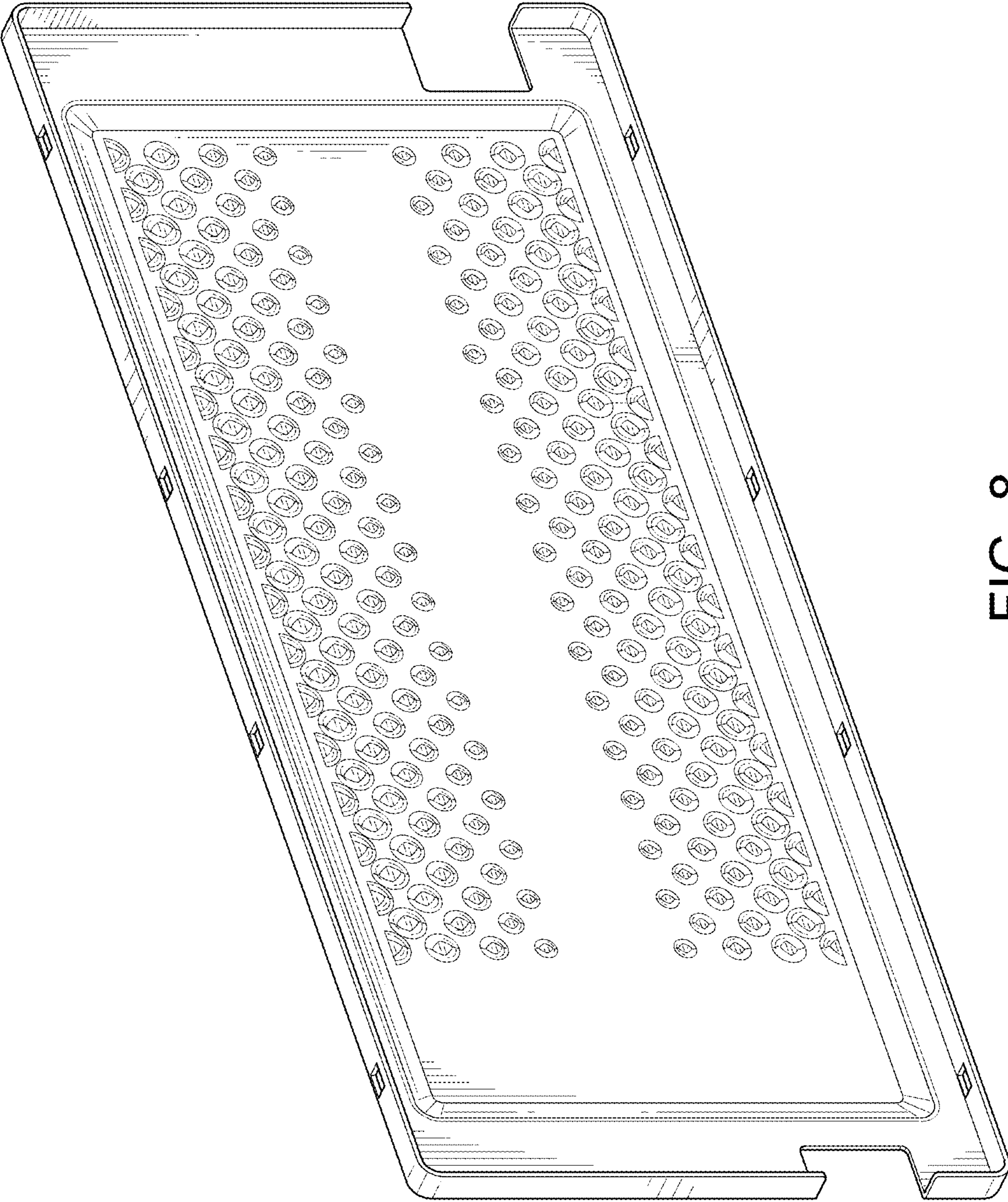

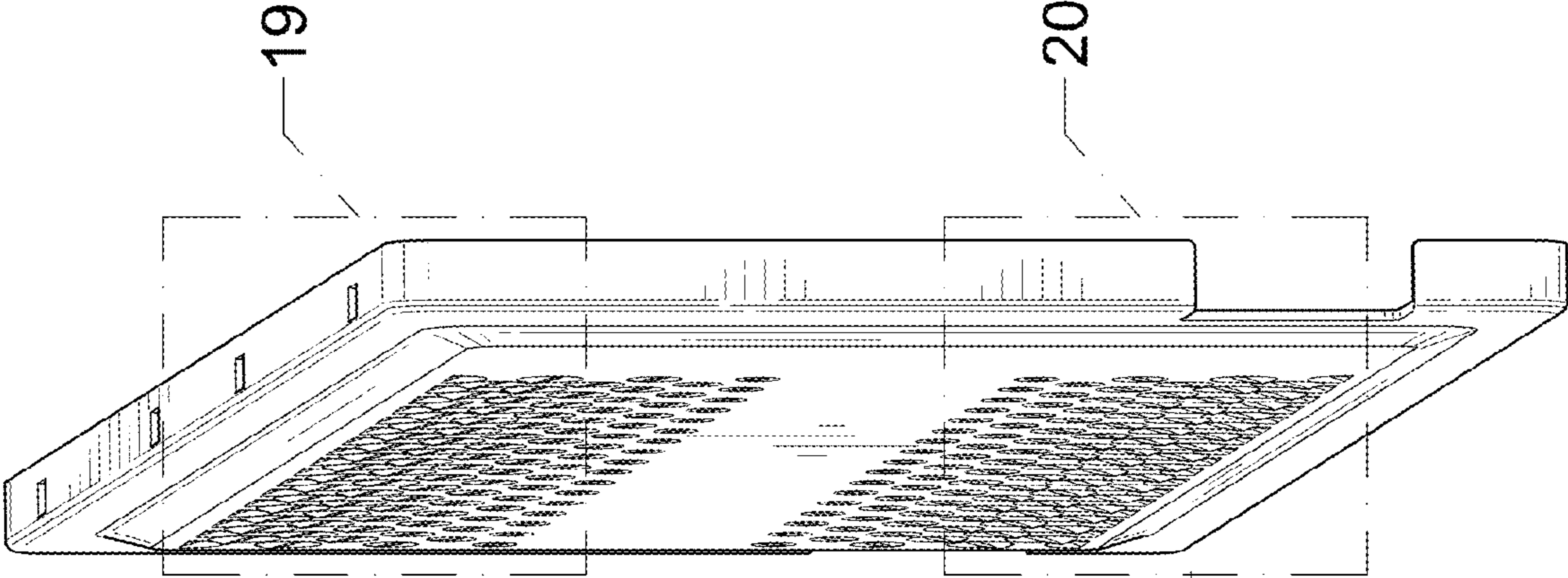

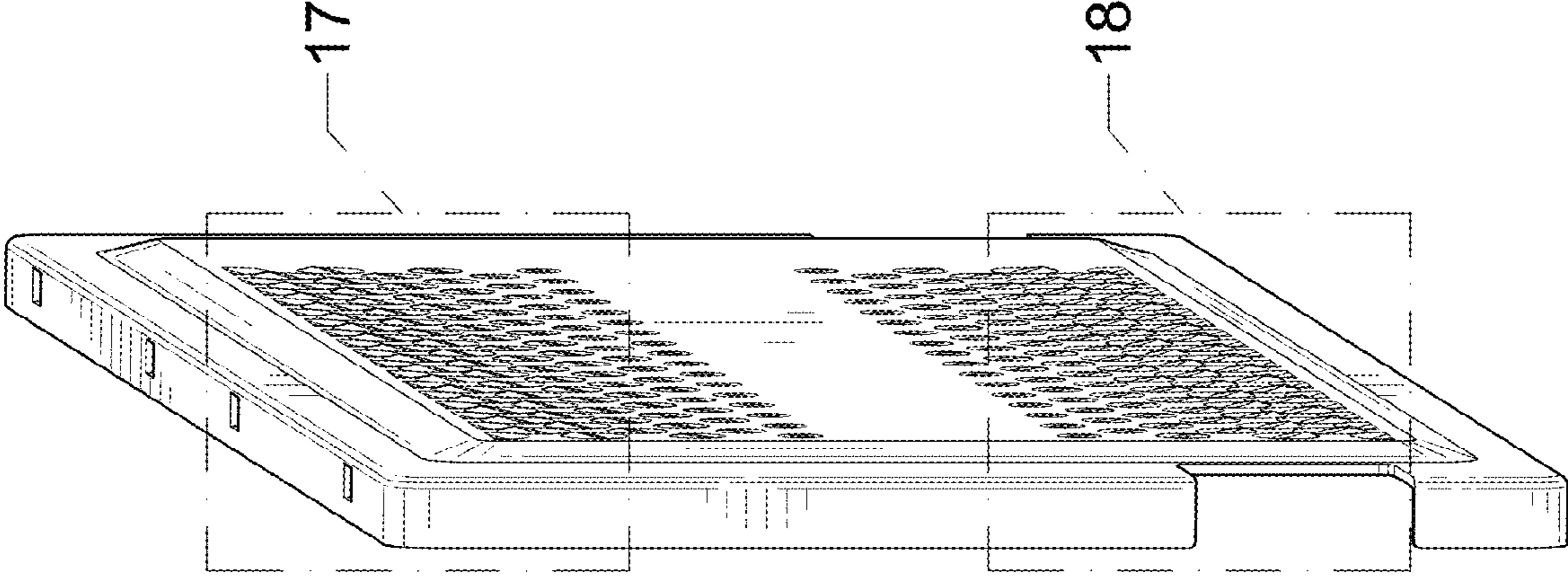

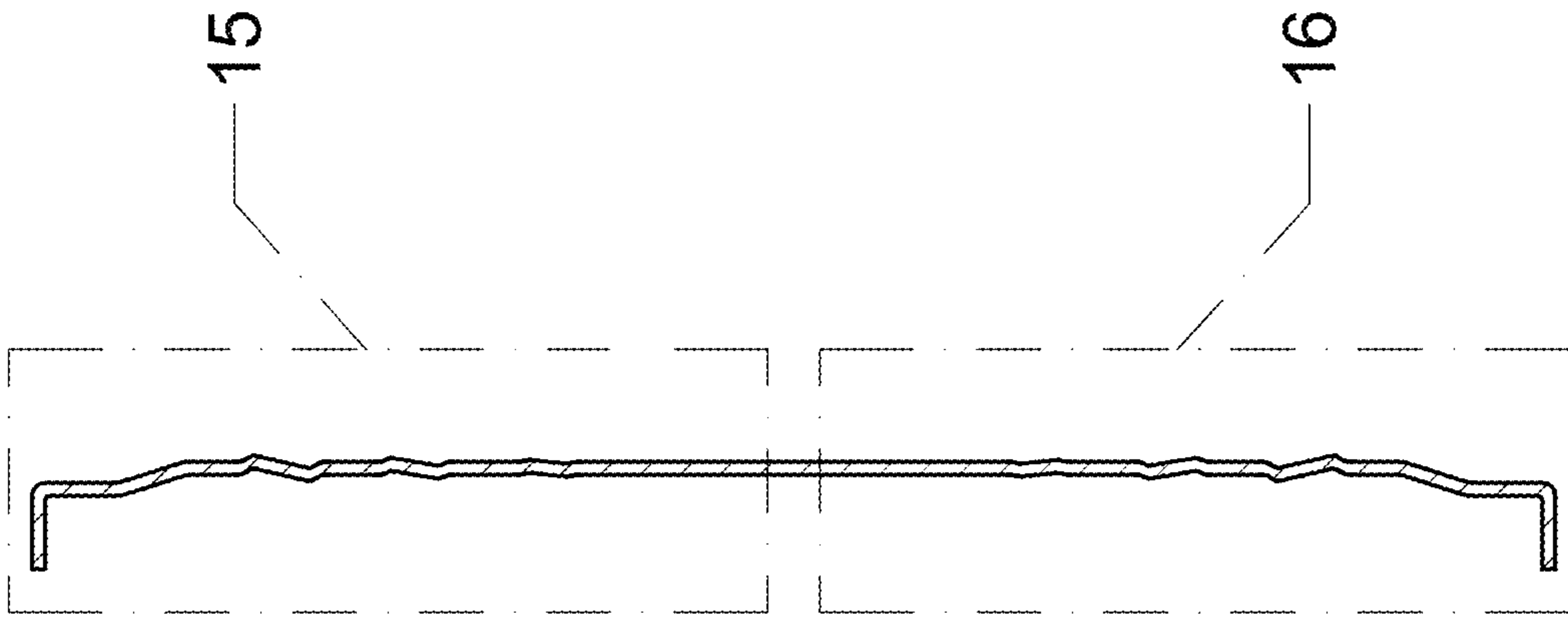

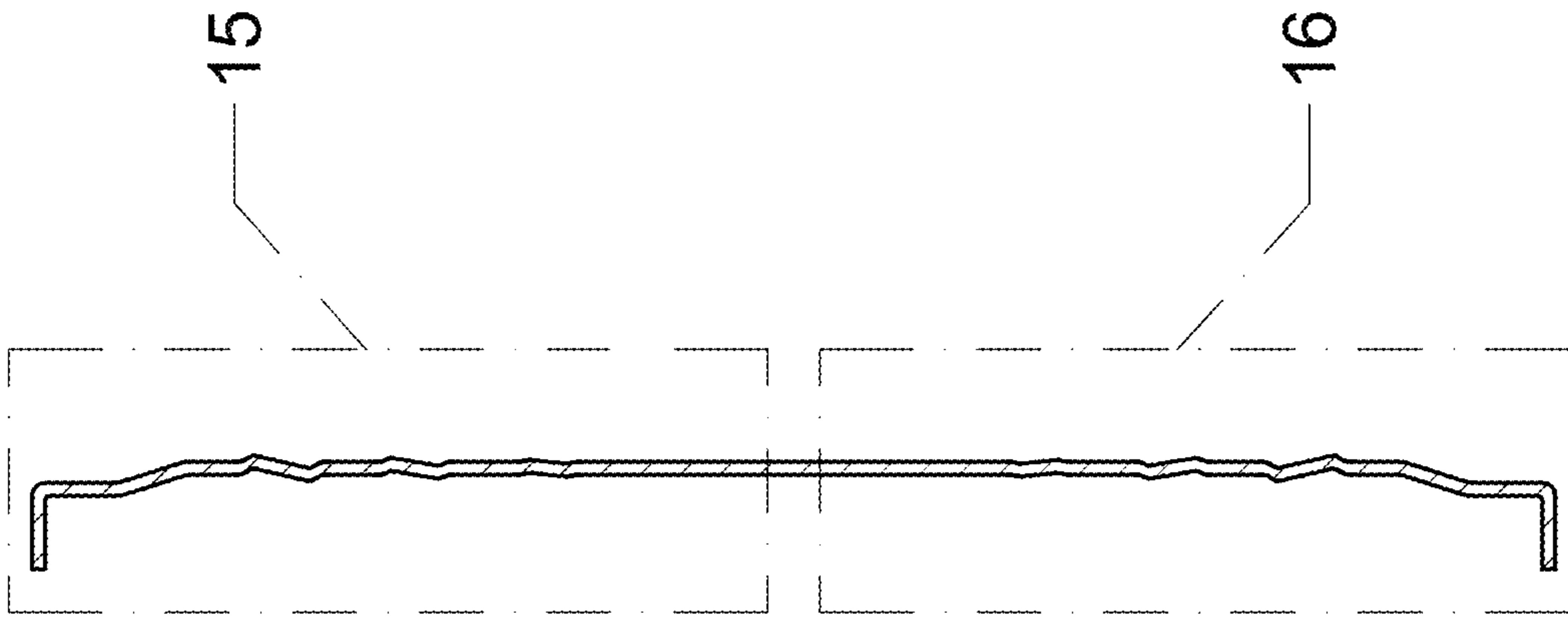

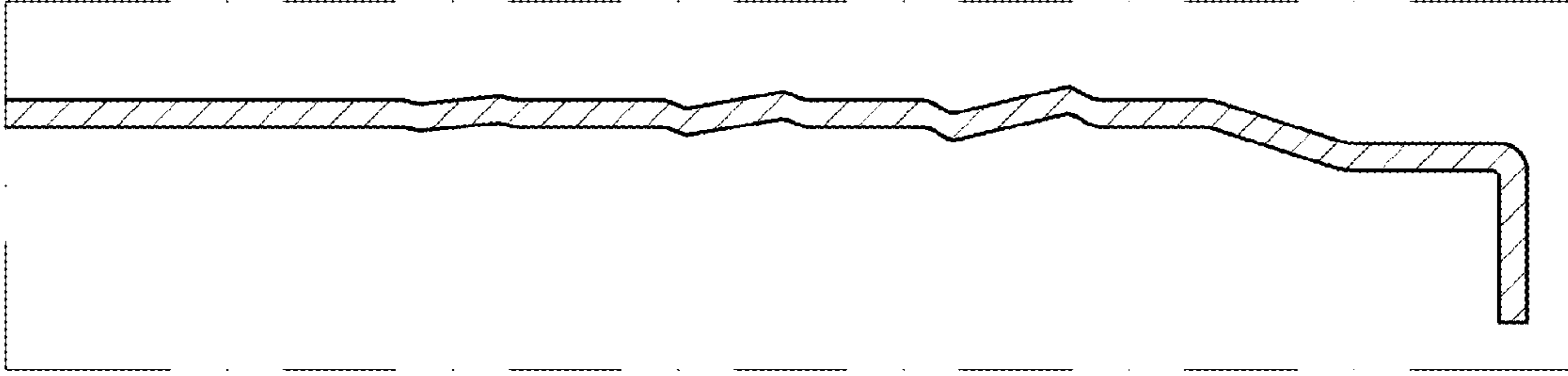

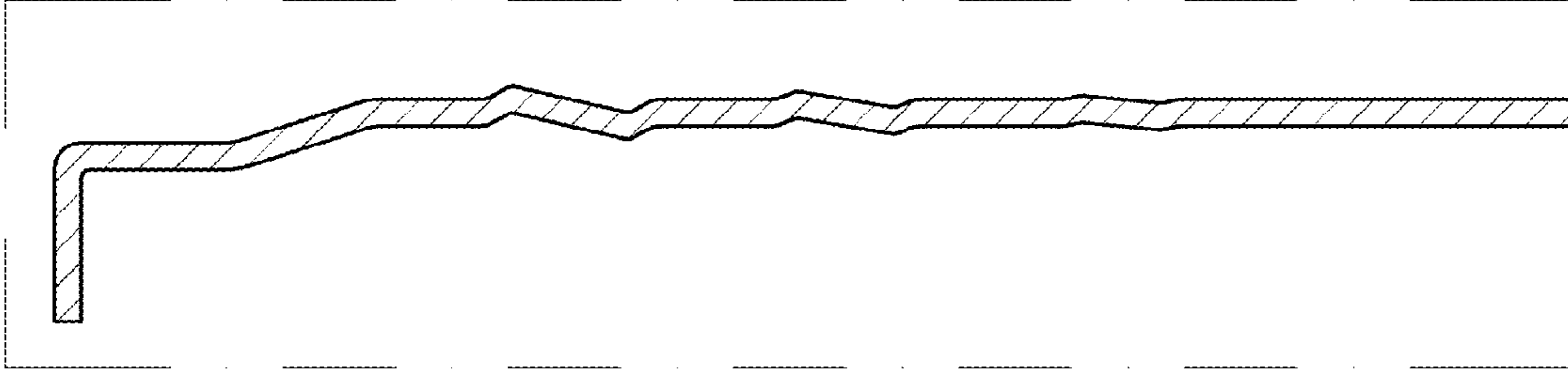

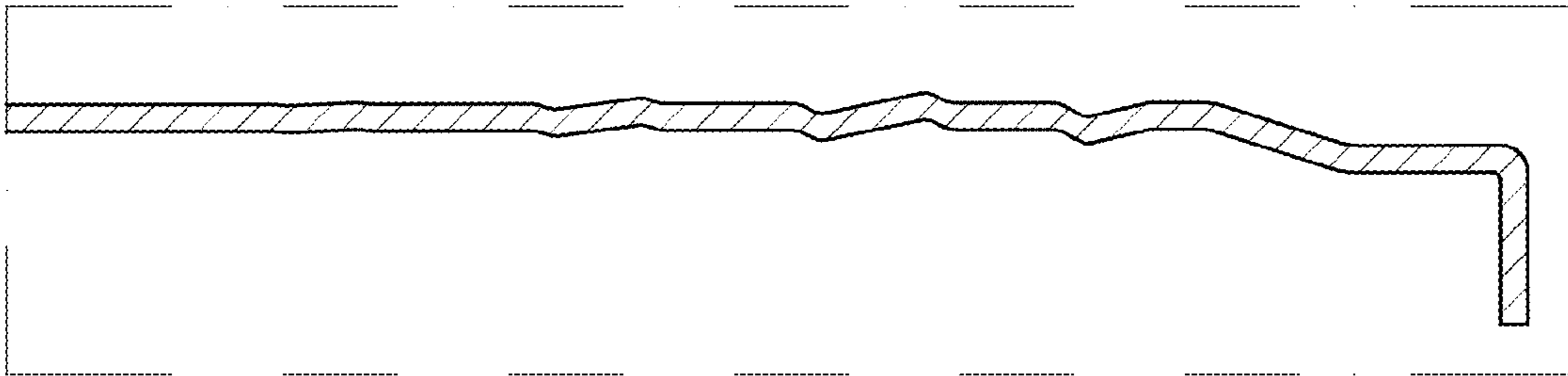

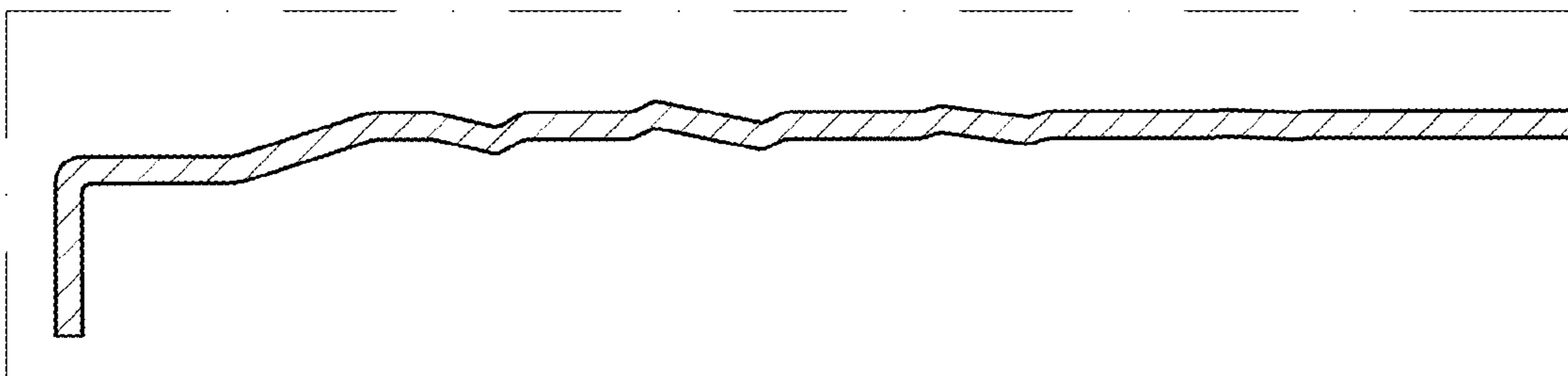

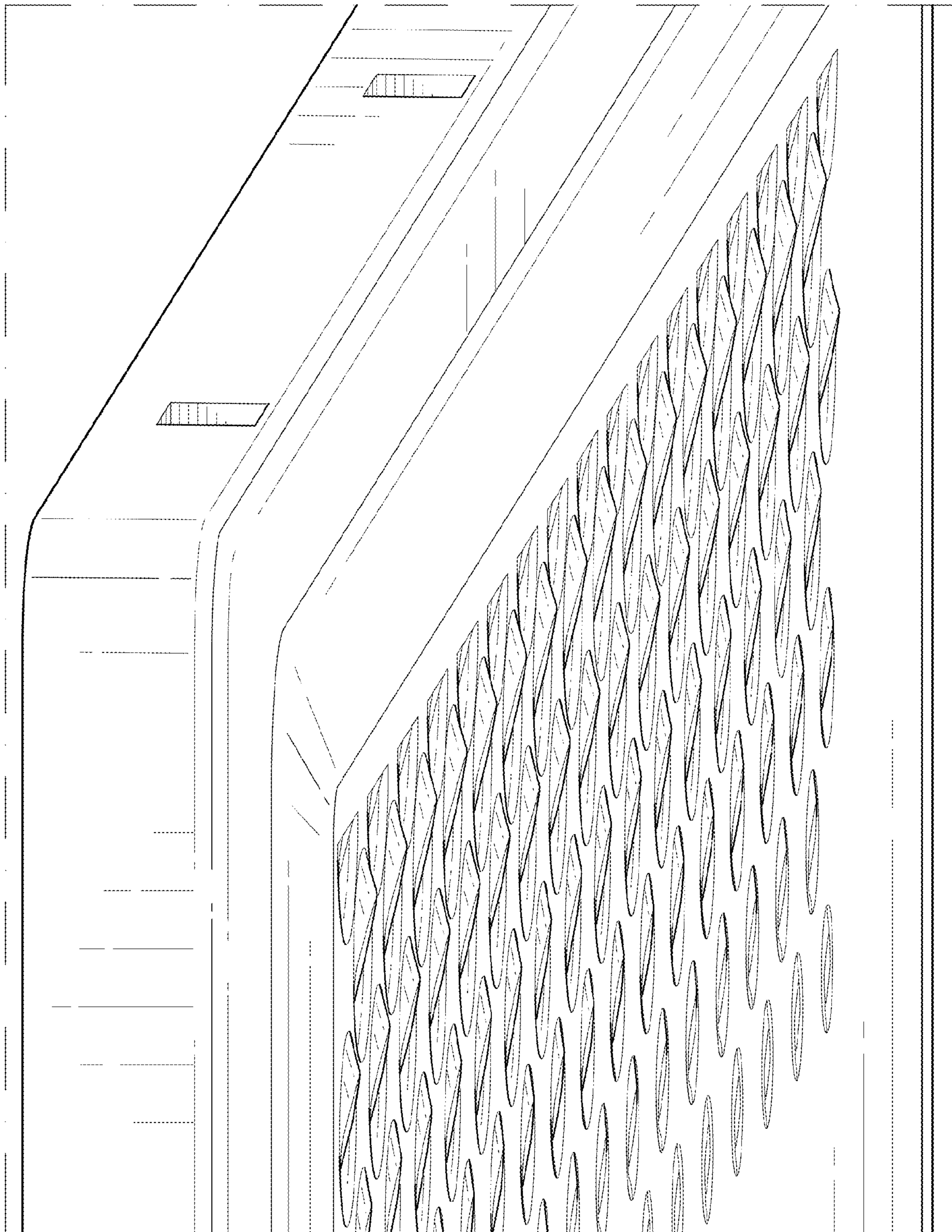

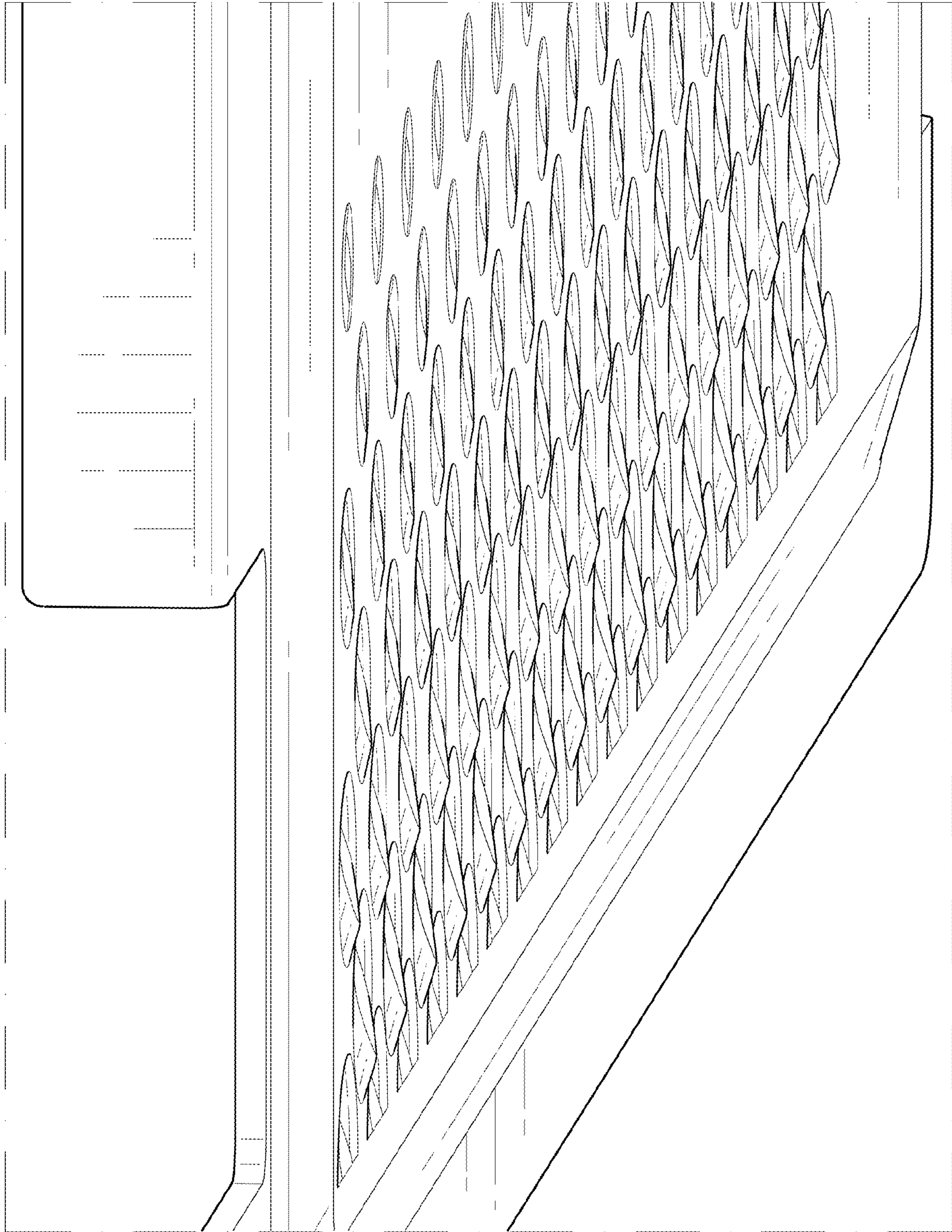

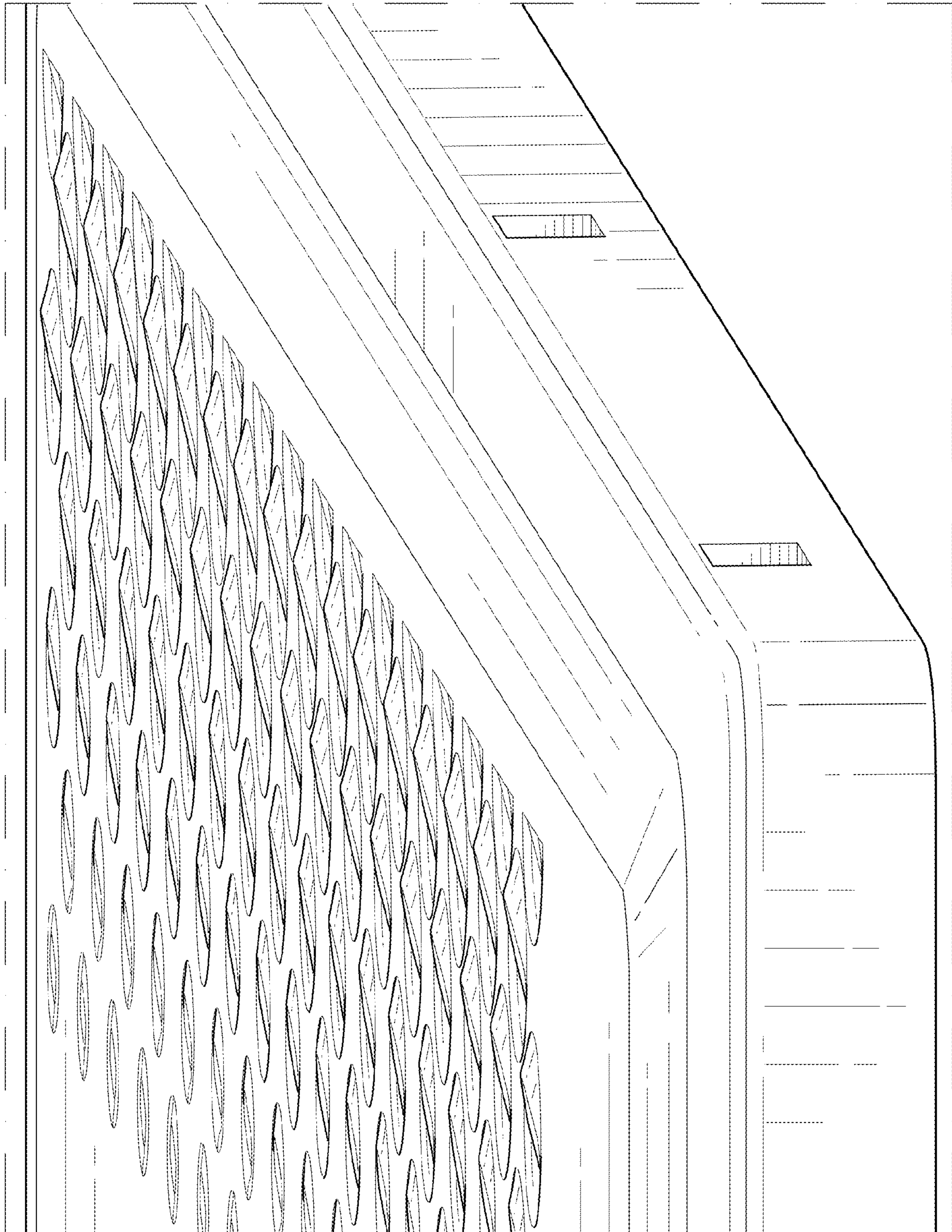

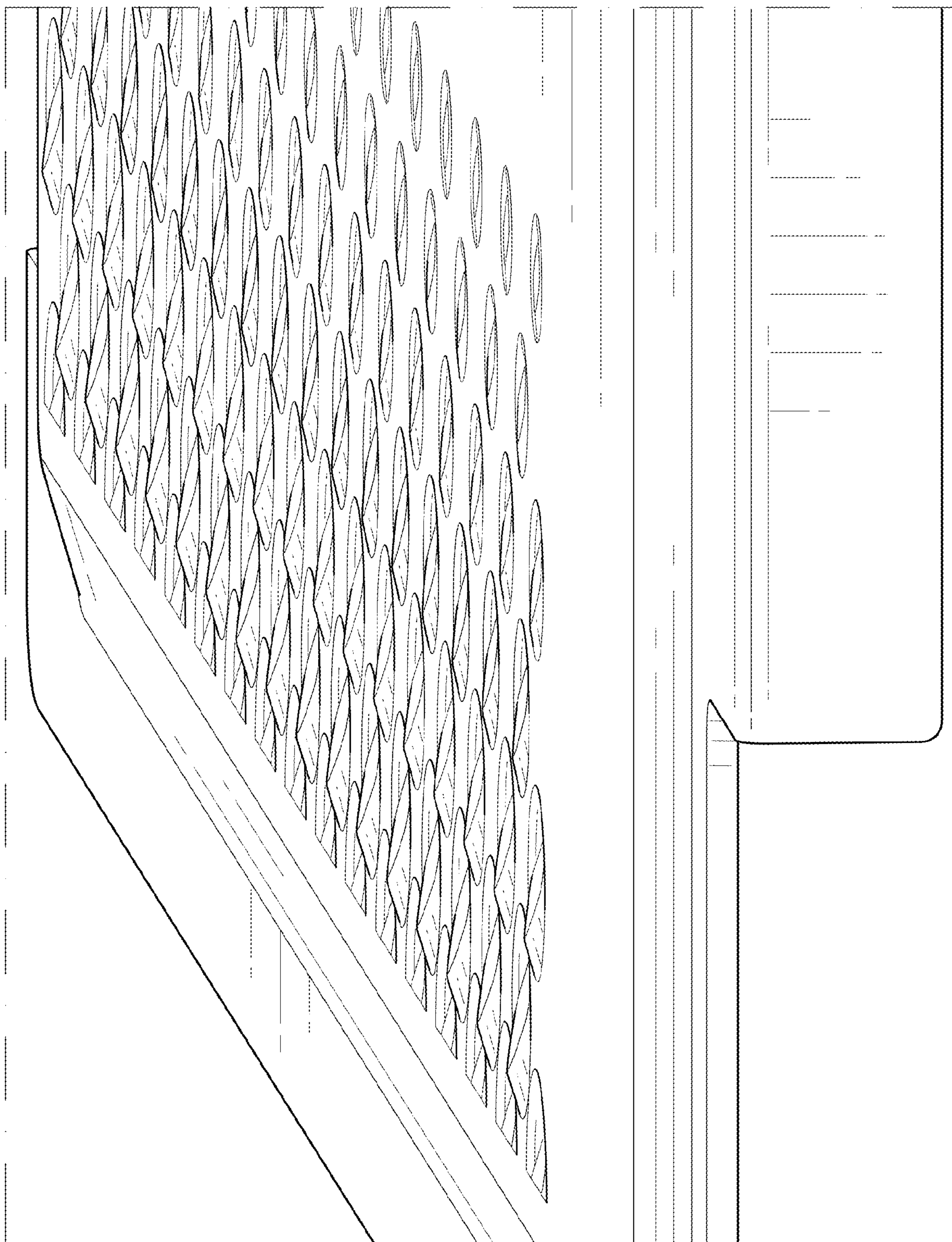
