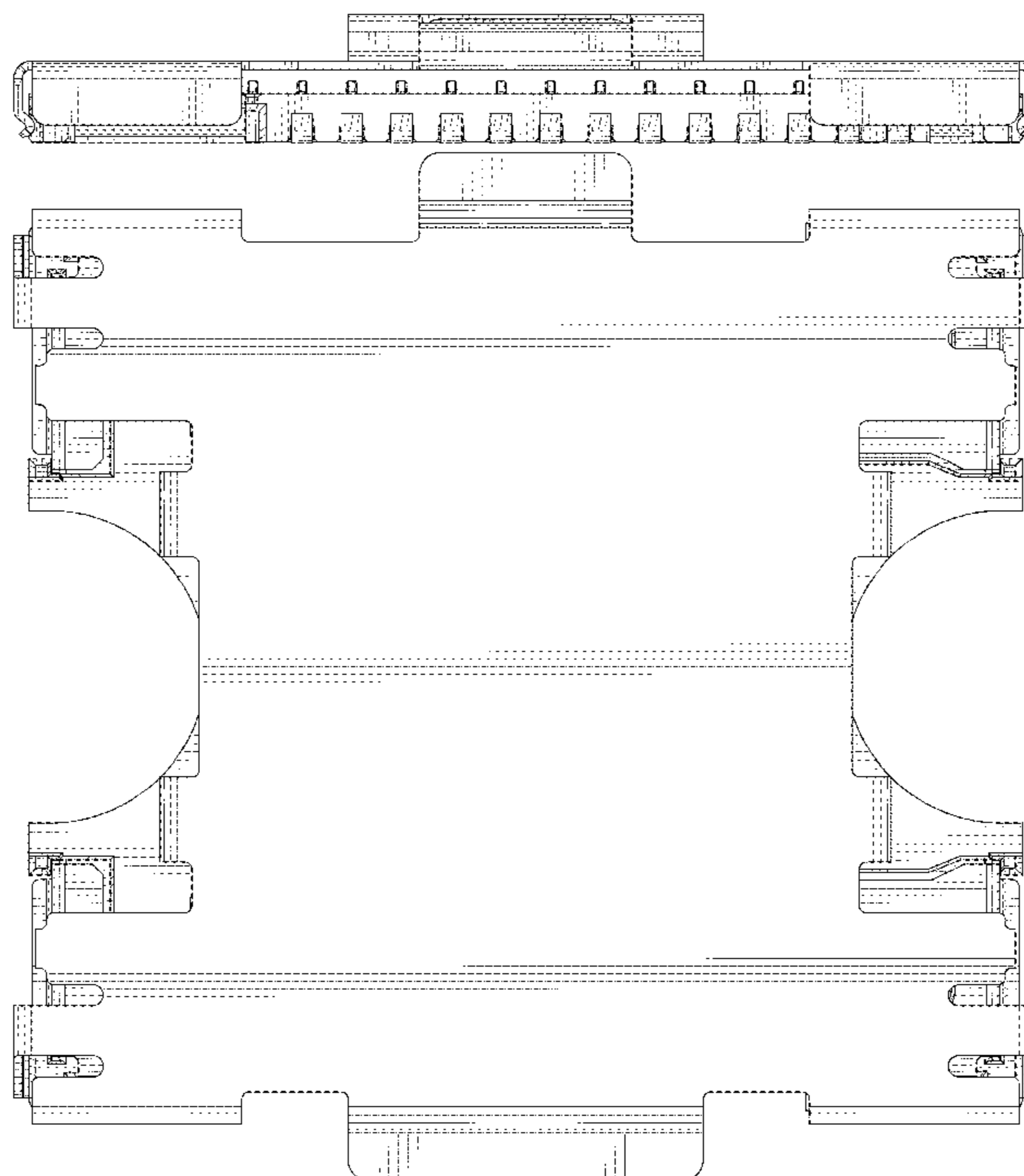
(57) **CLAIM**

The ornamental design for a combination connector with cap, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a combination connector with cap showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a perspective view showing a front, top and right side thereof;

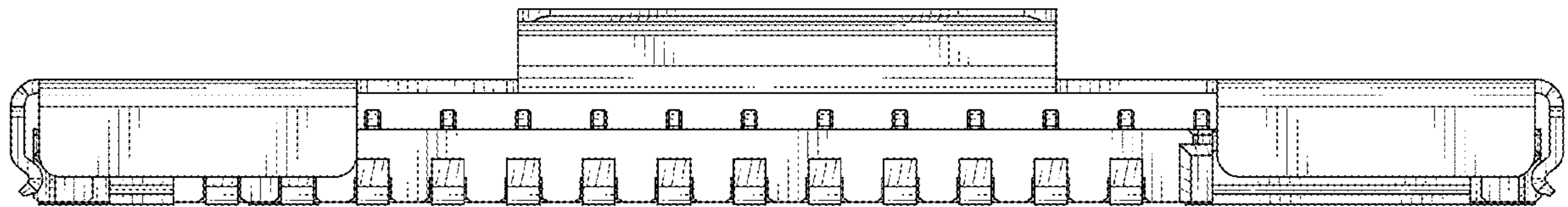

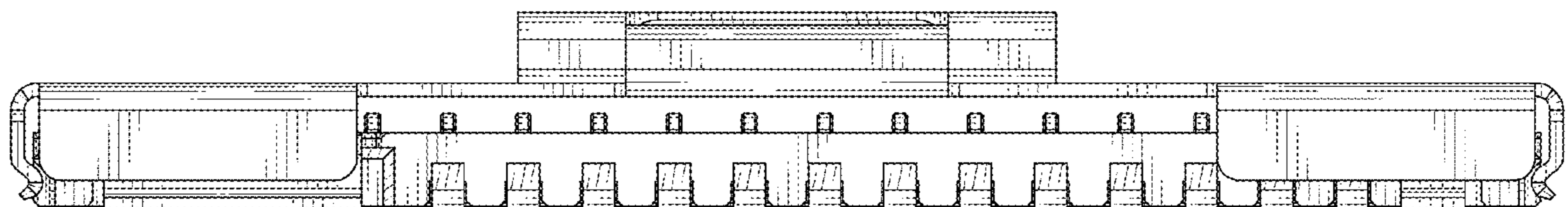

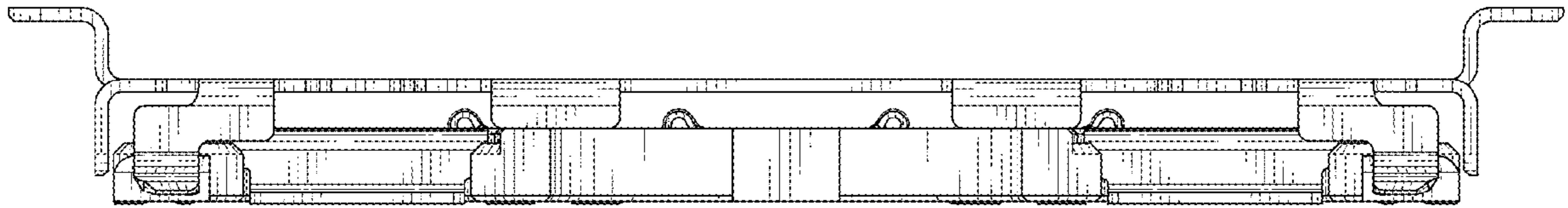

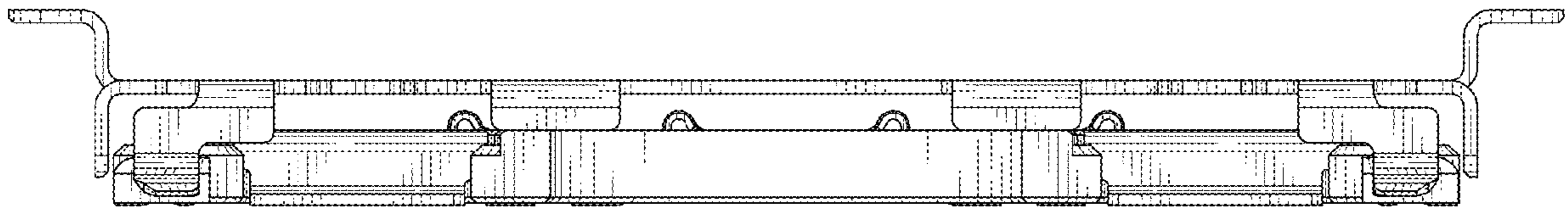

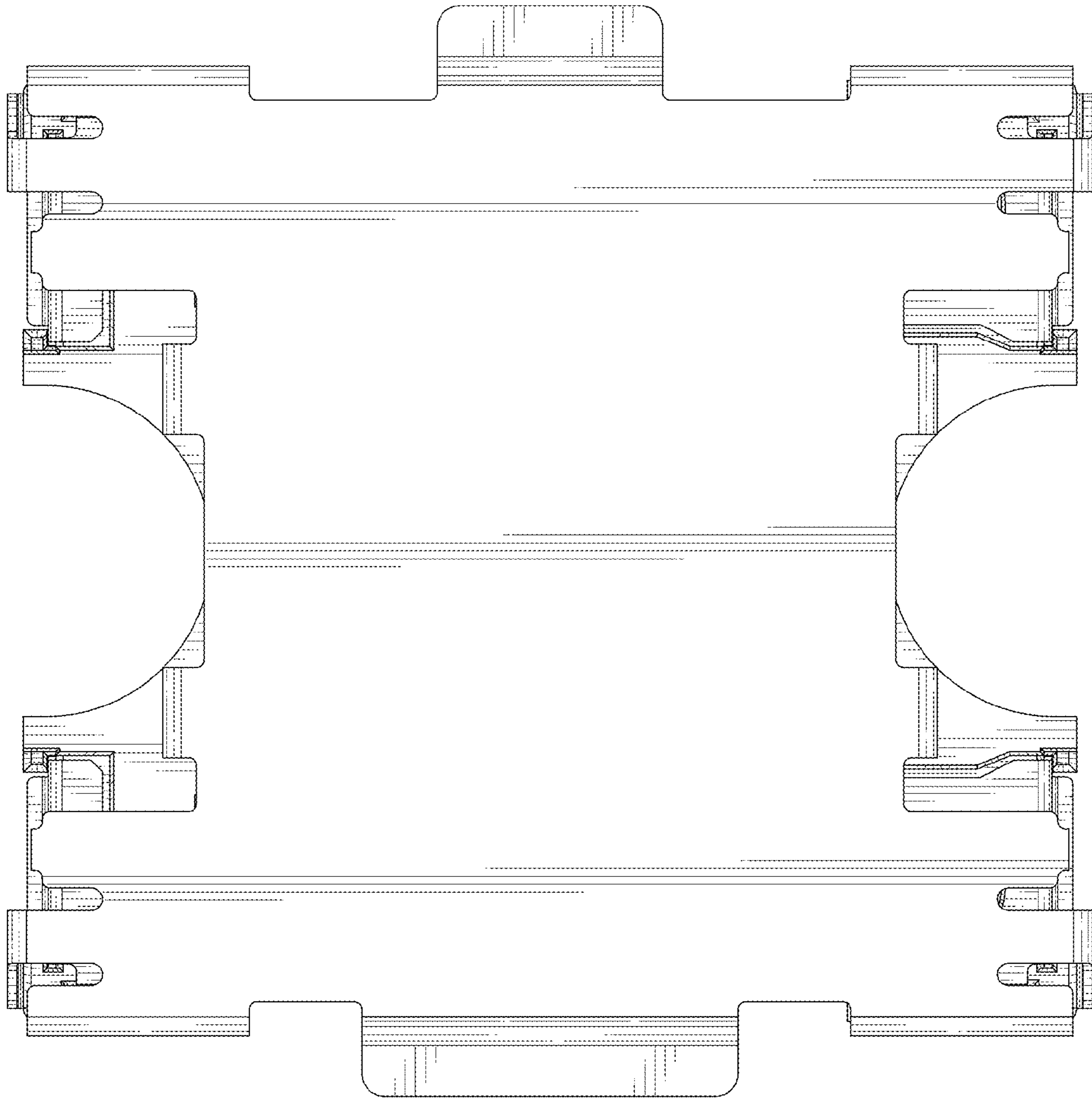

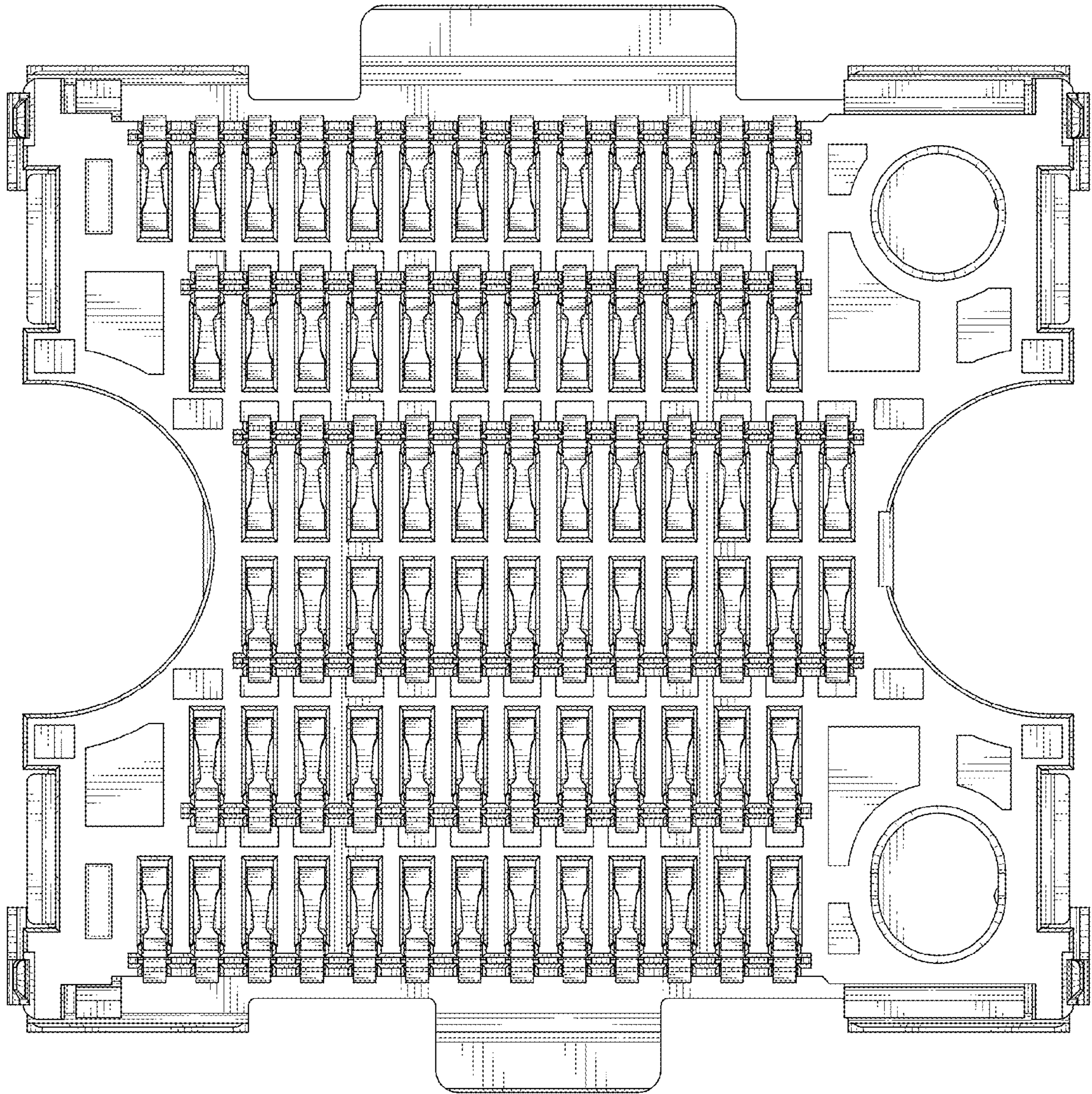

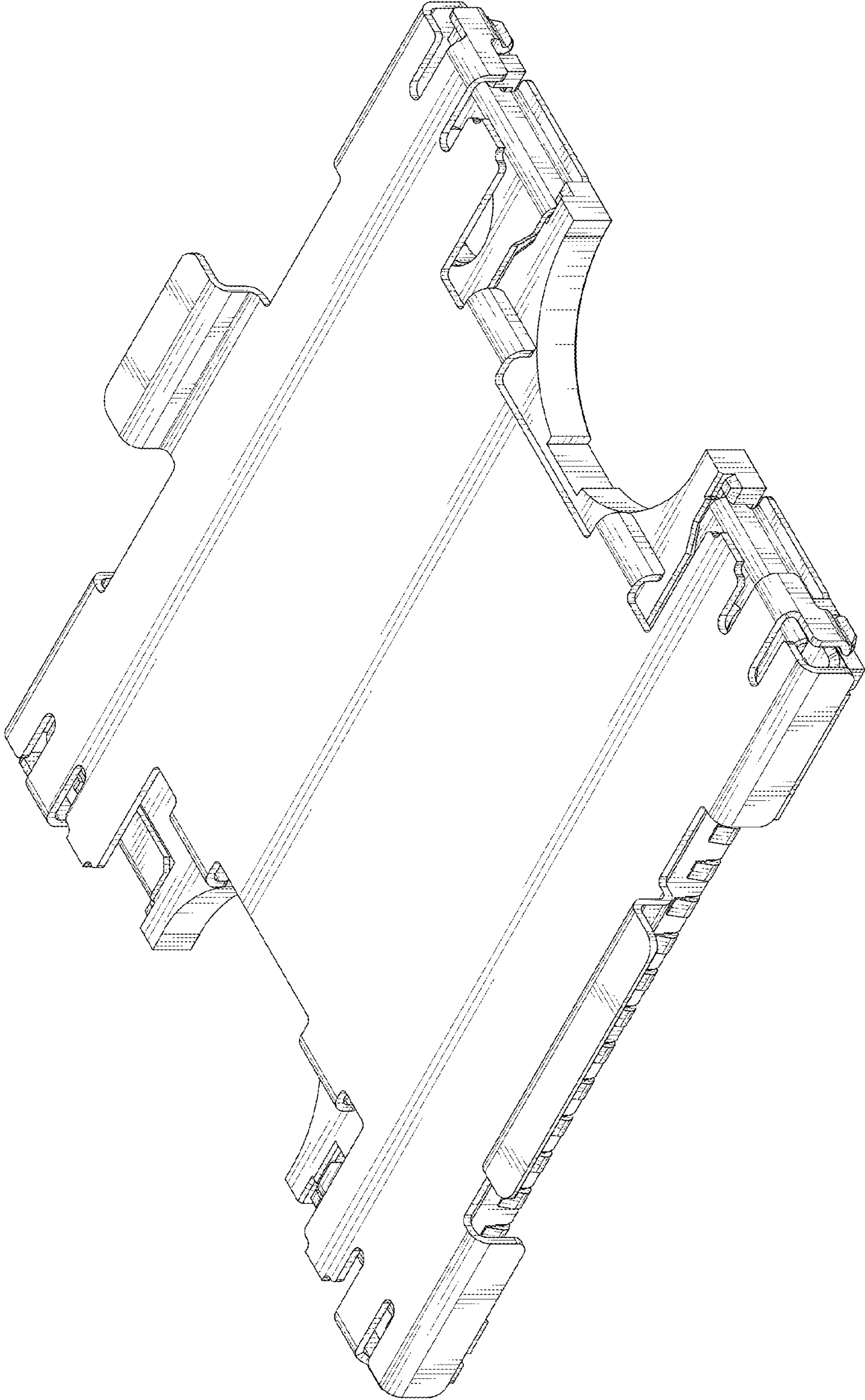

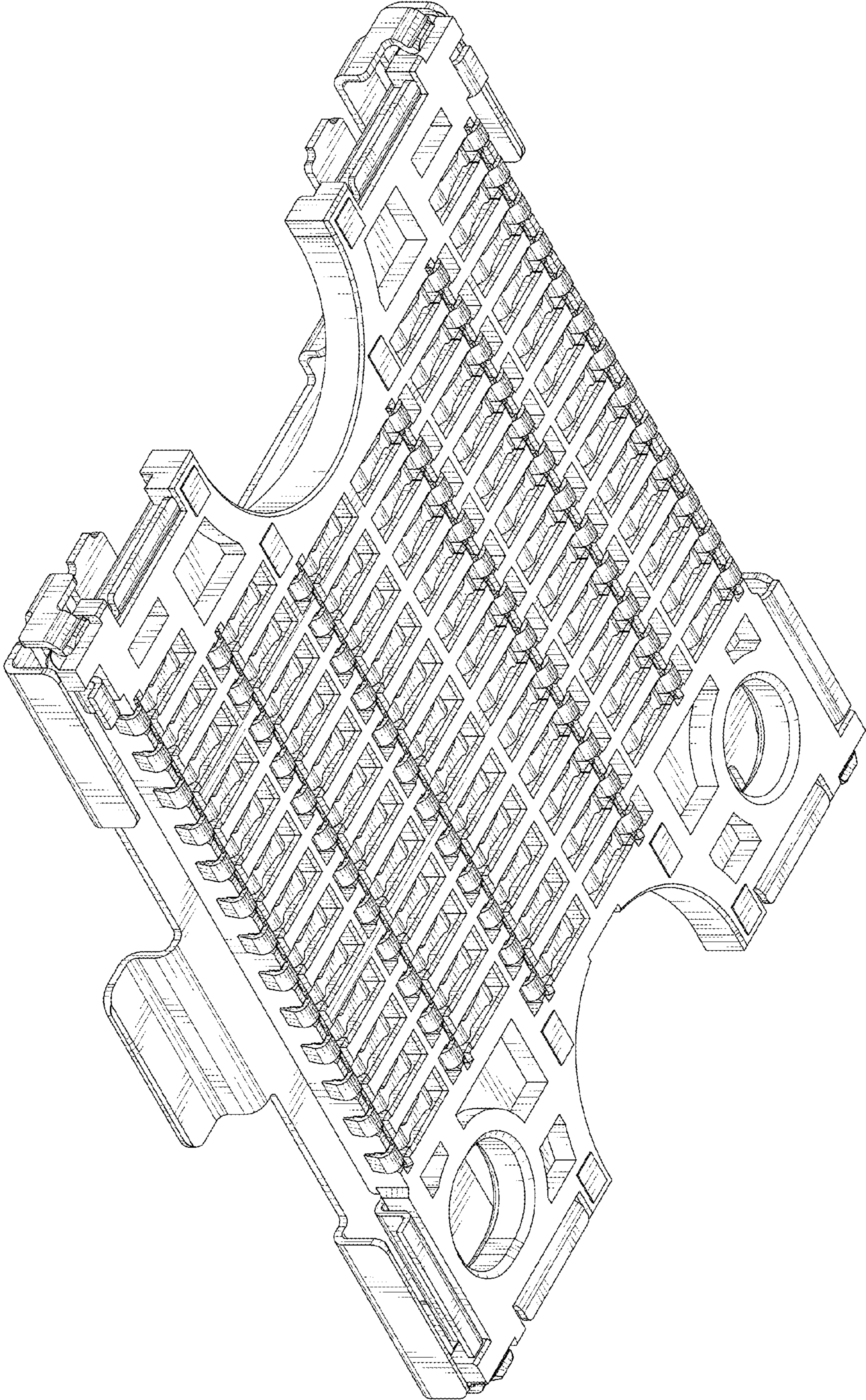

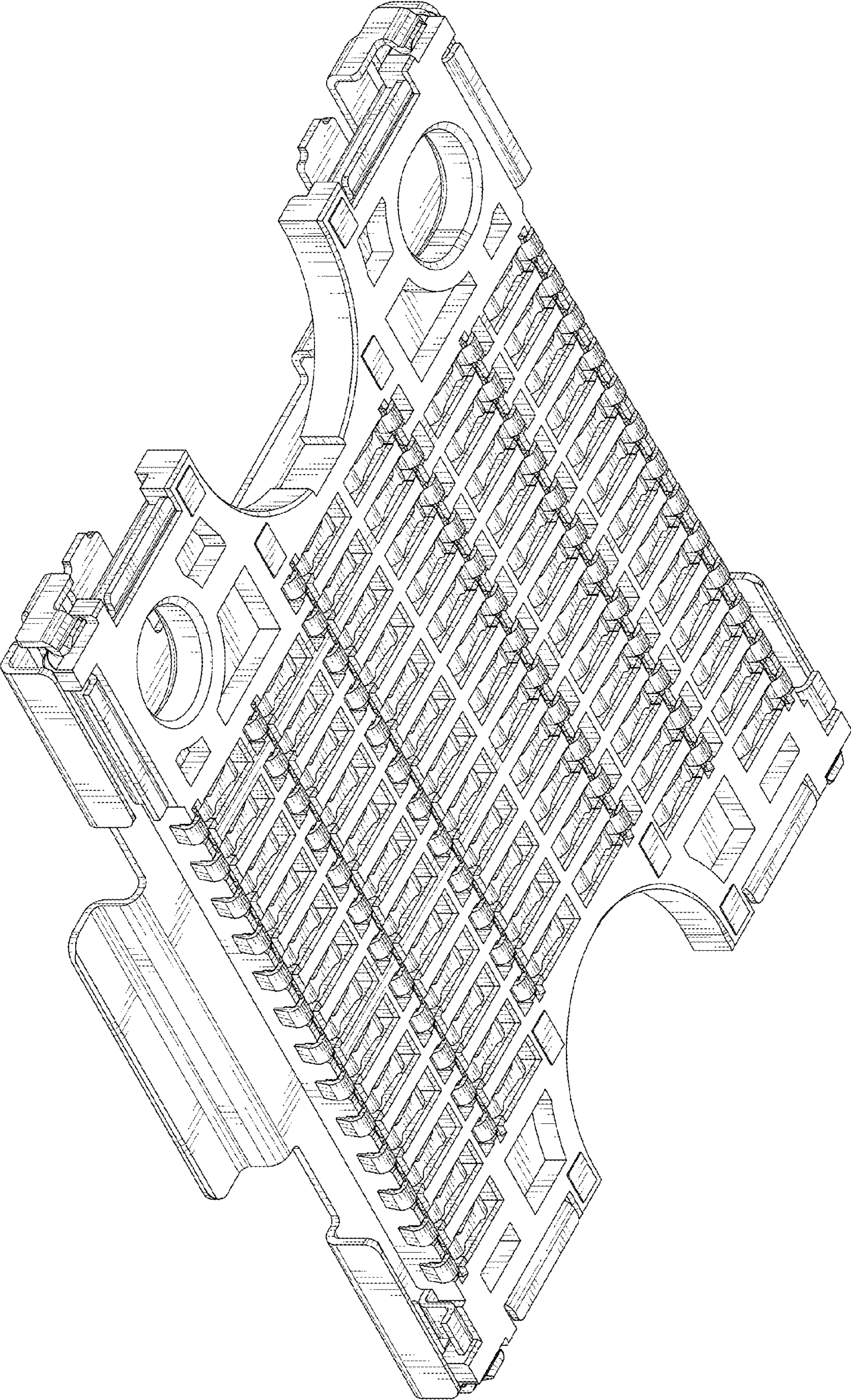

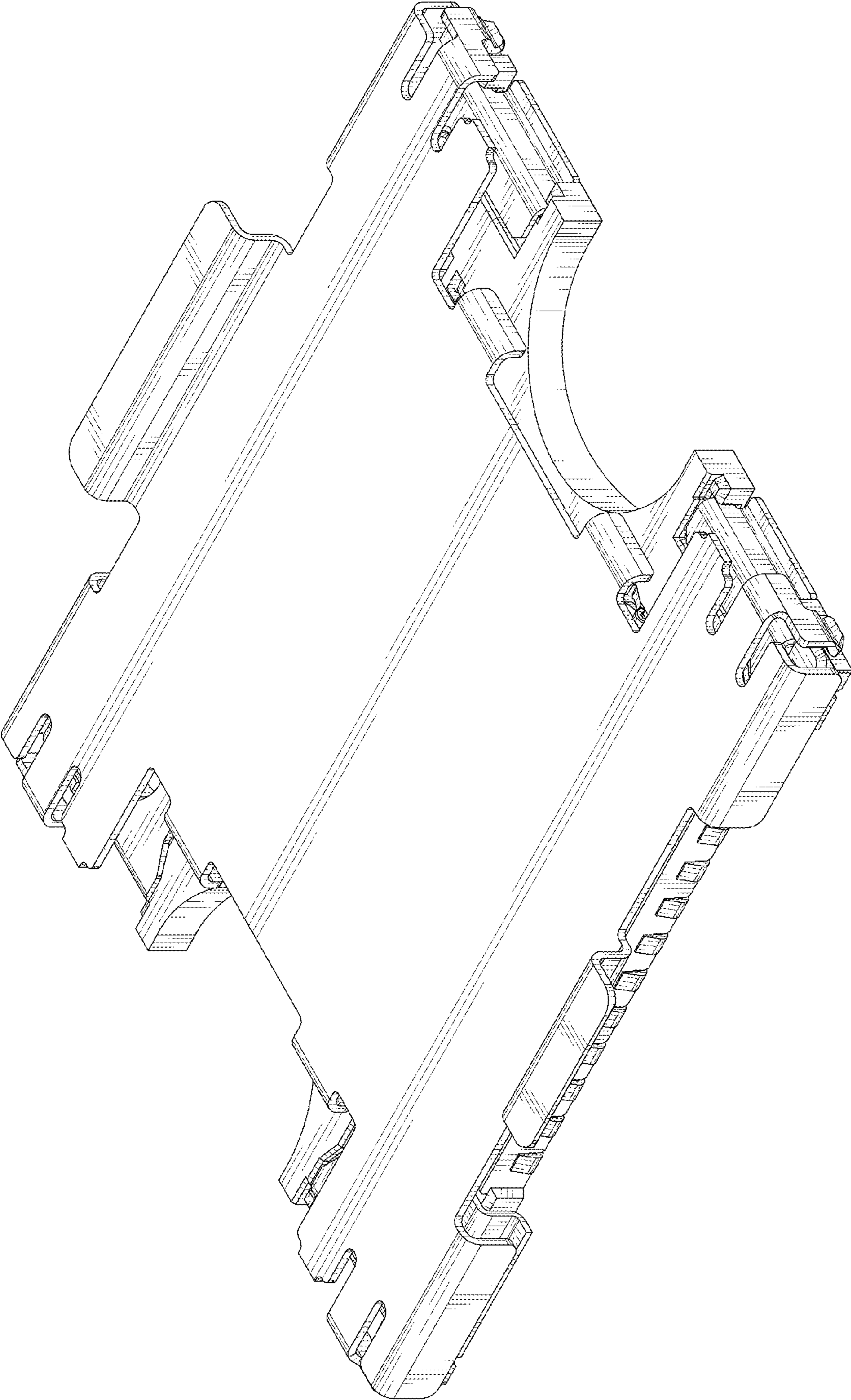
