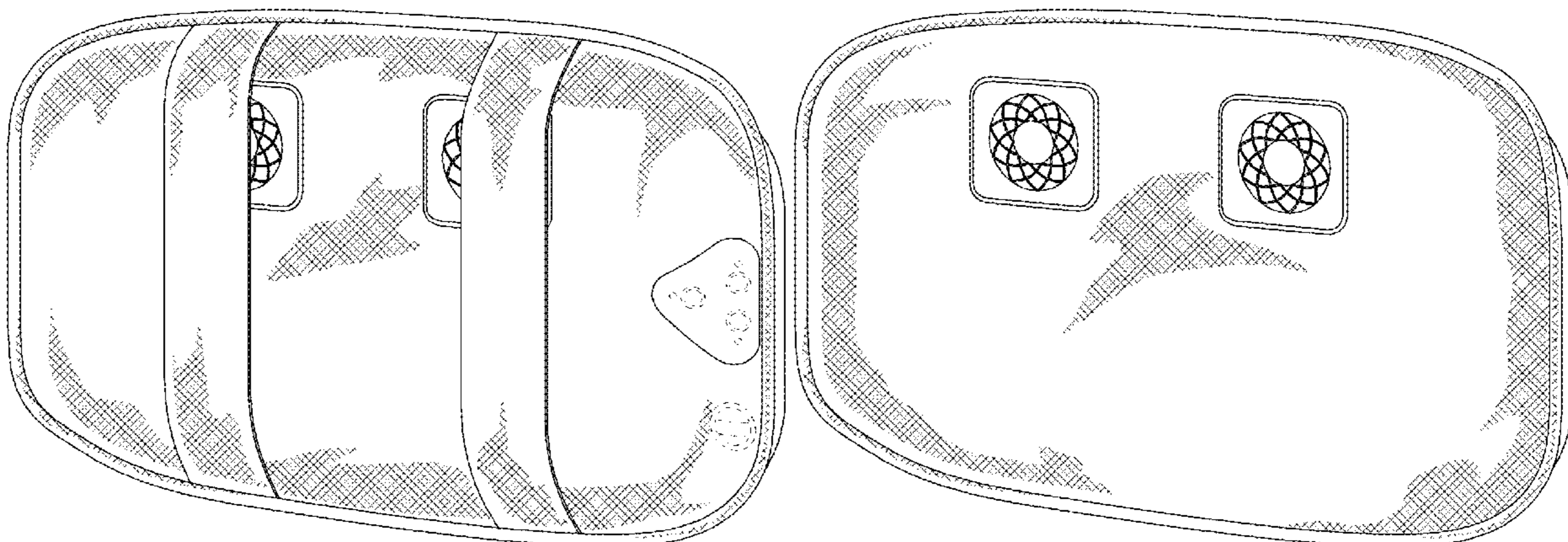
The ornamental design for an electronic assembly, as shown and described.

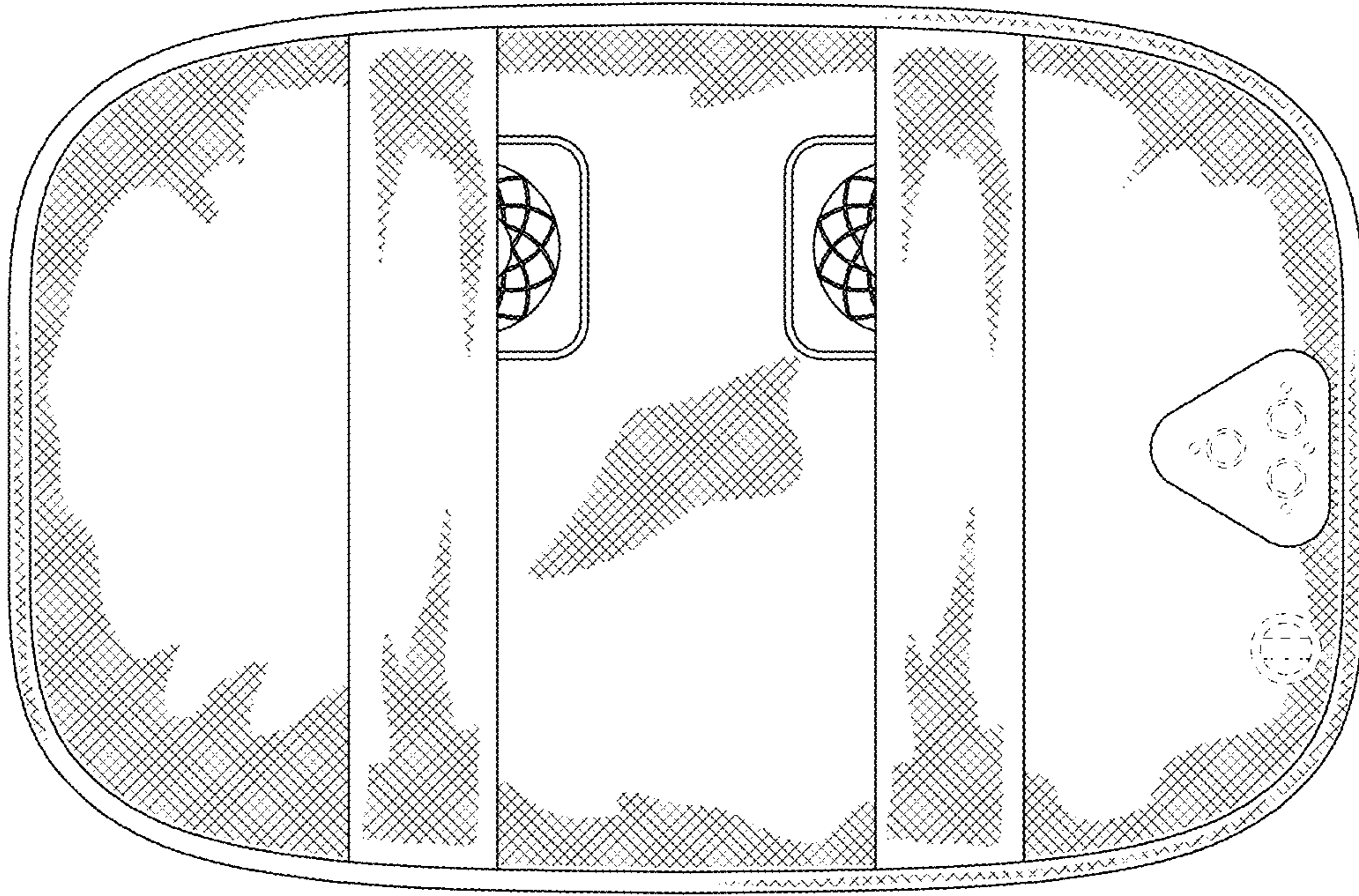

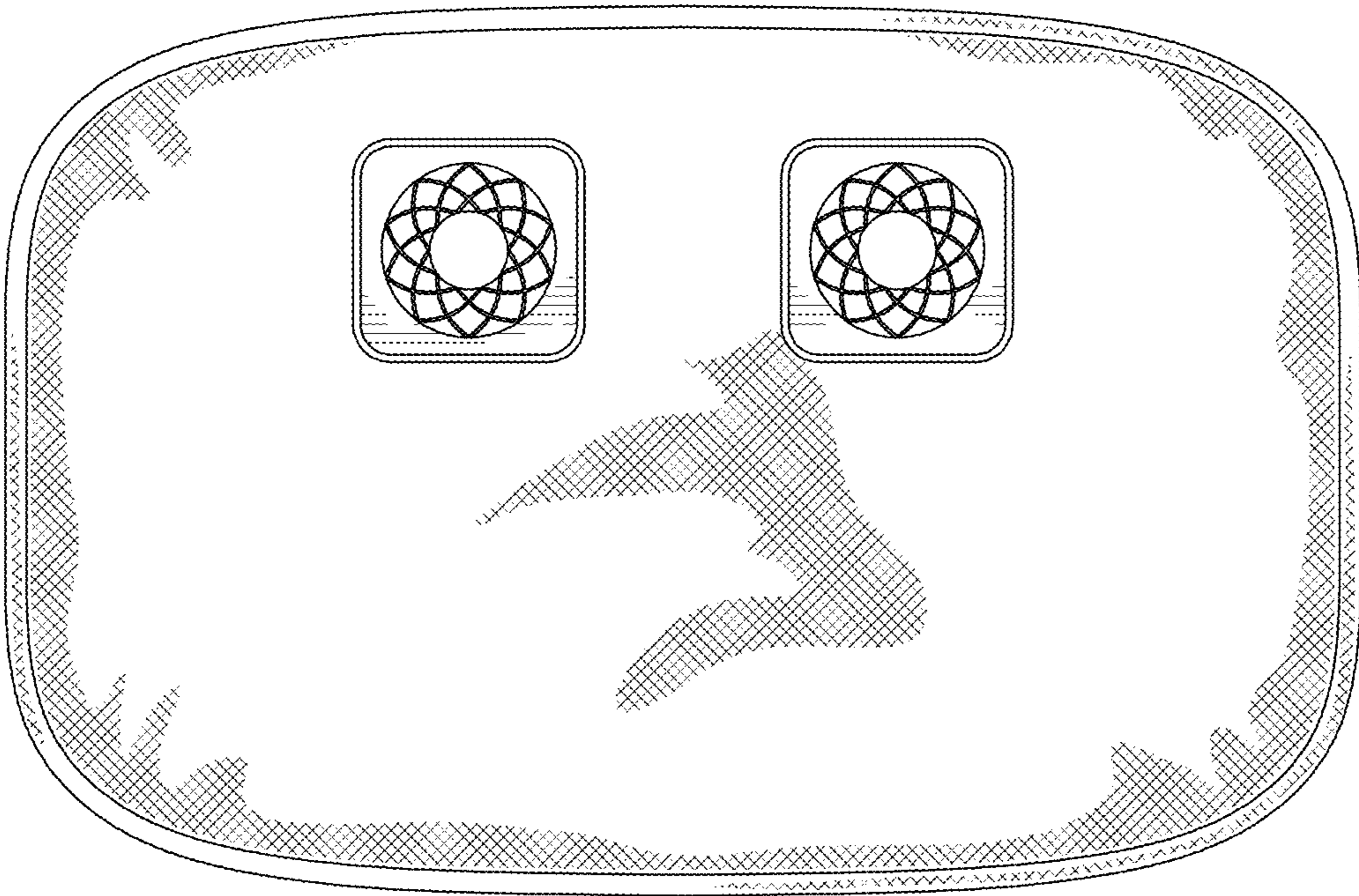

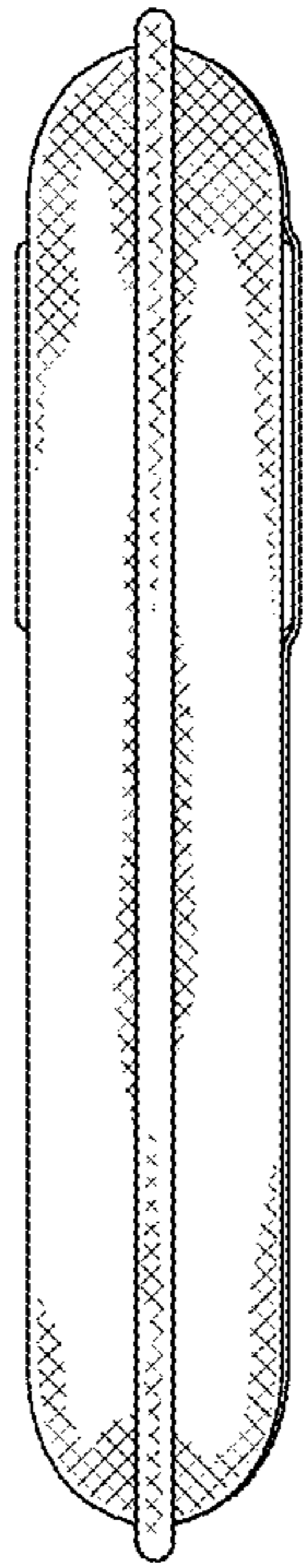

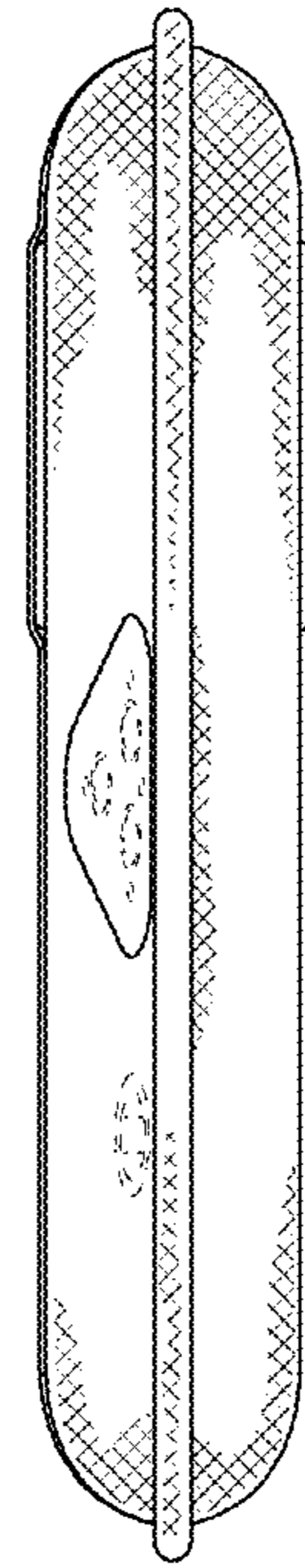

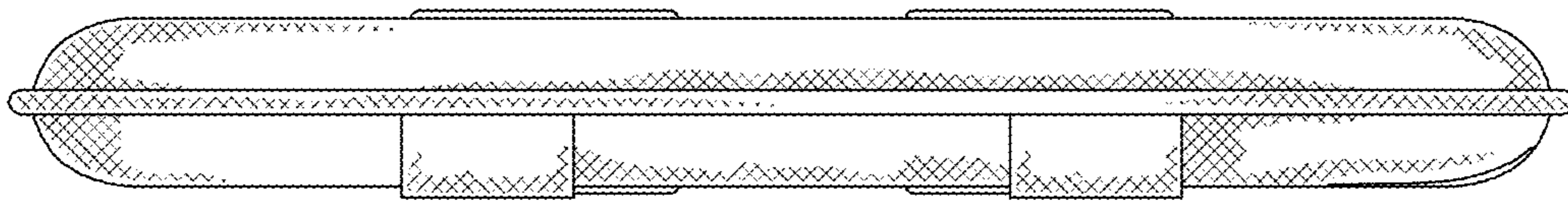

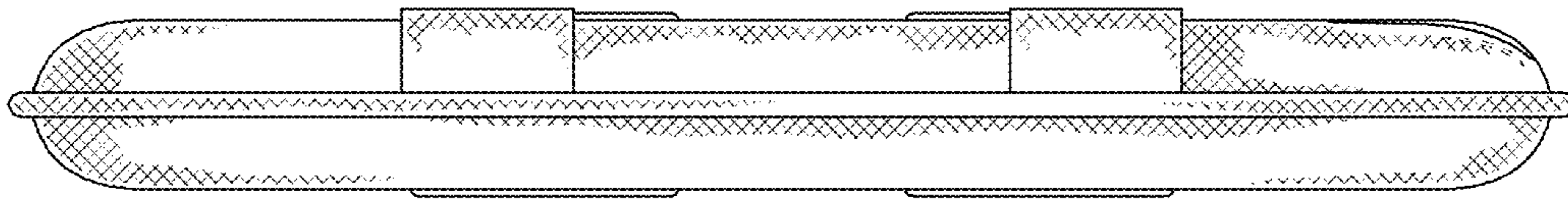

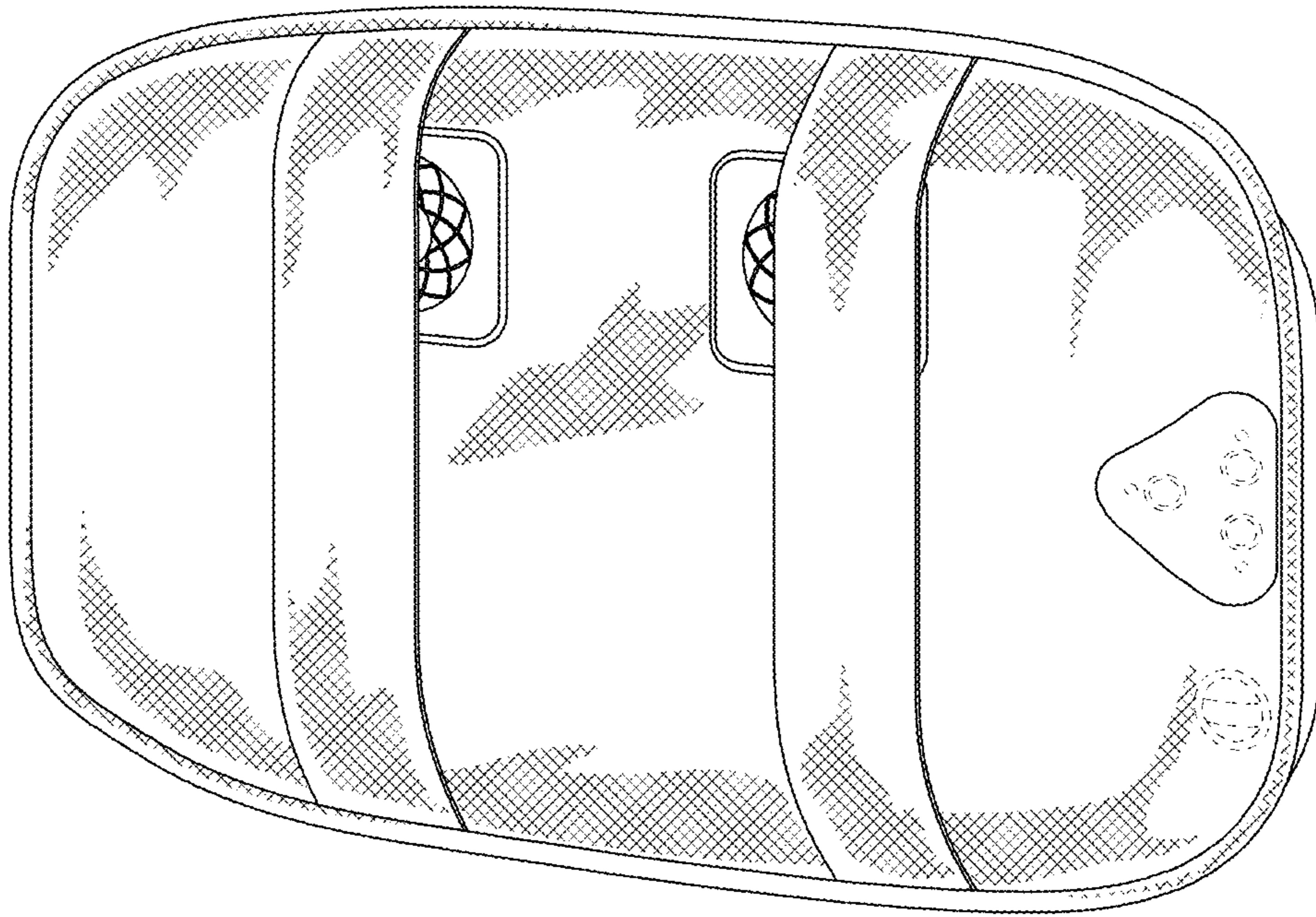

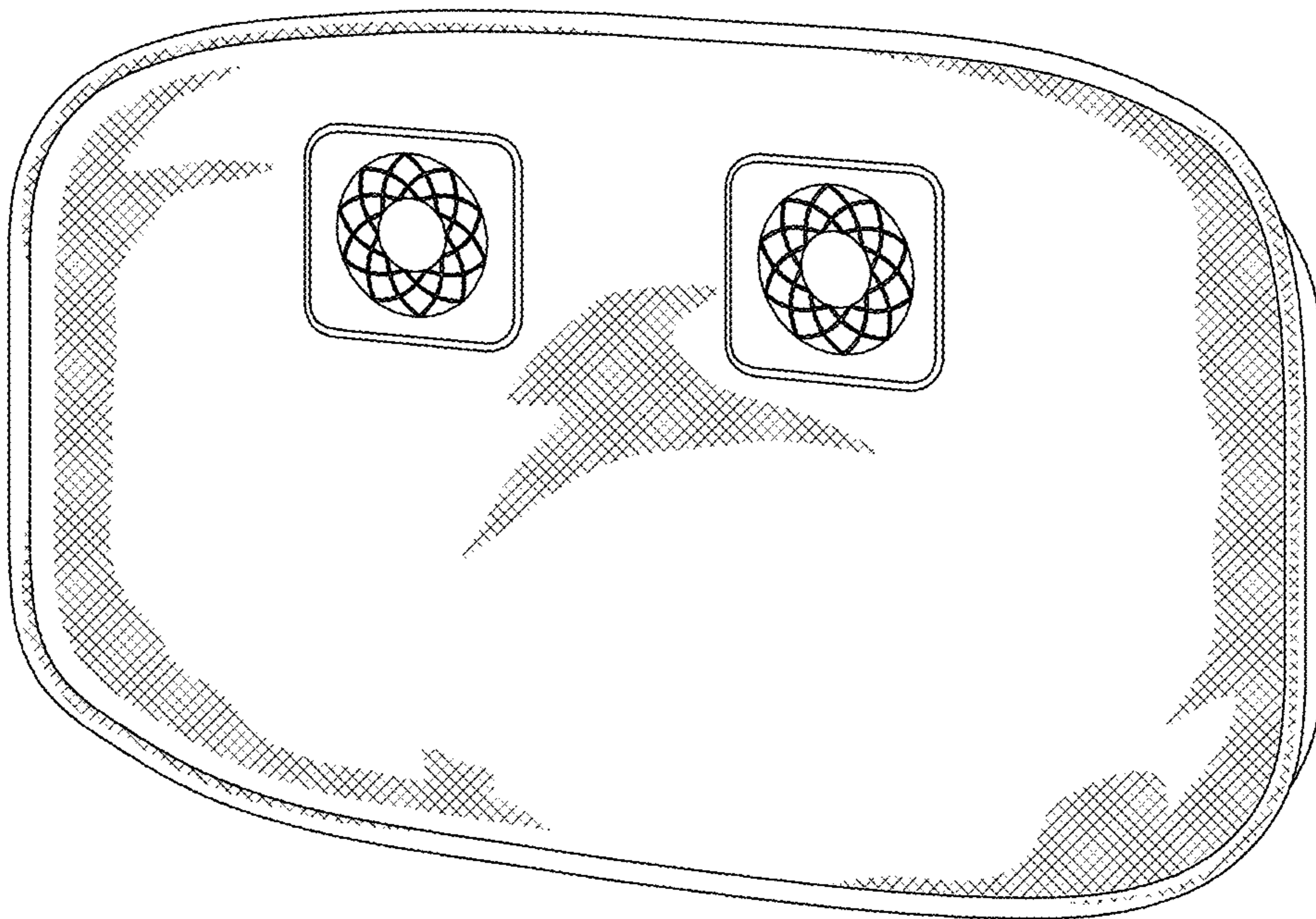

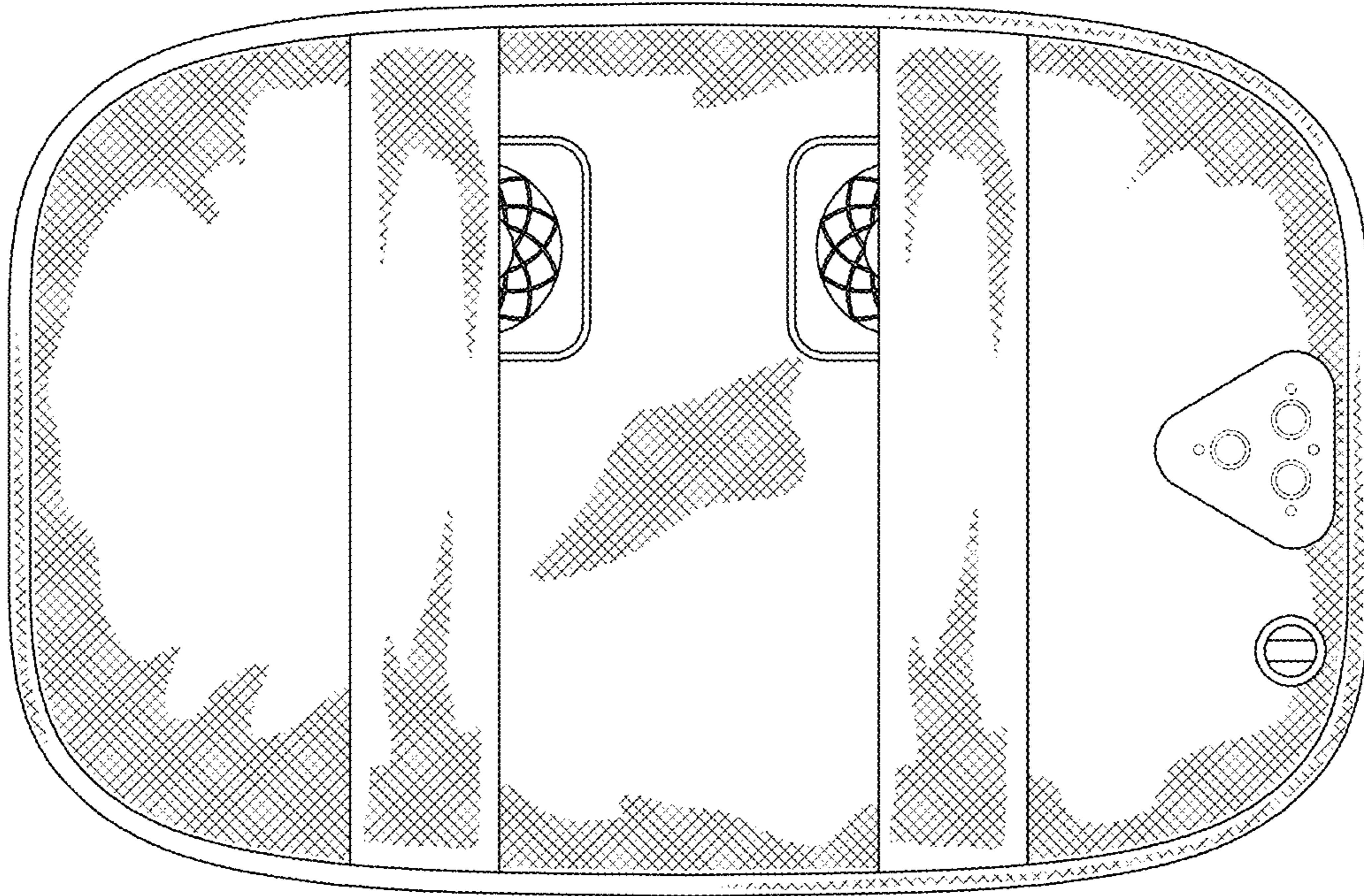

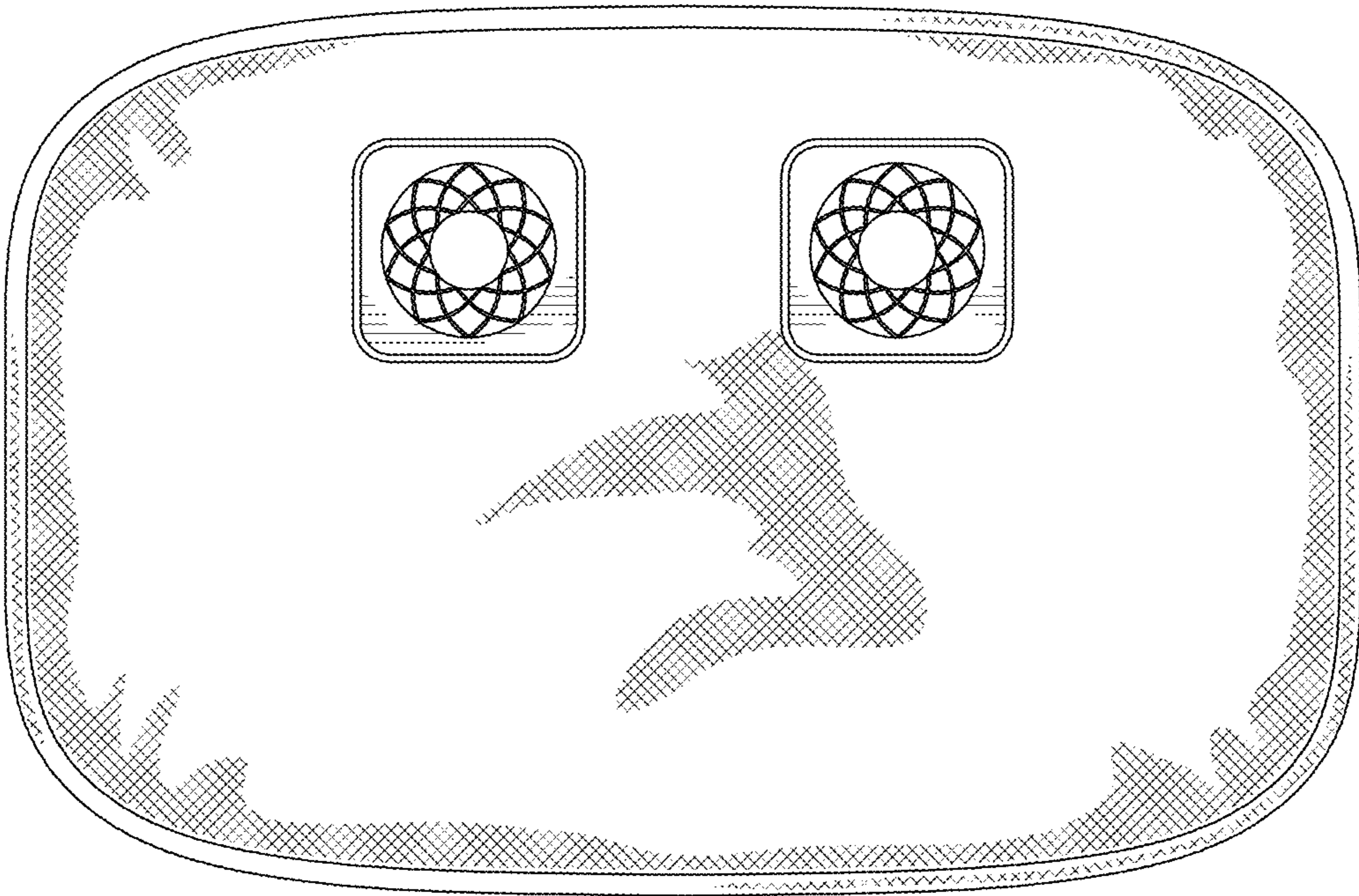

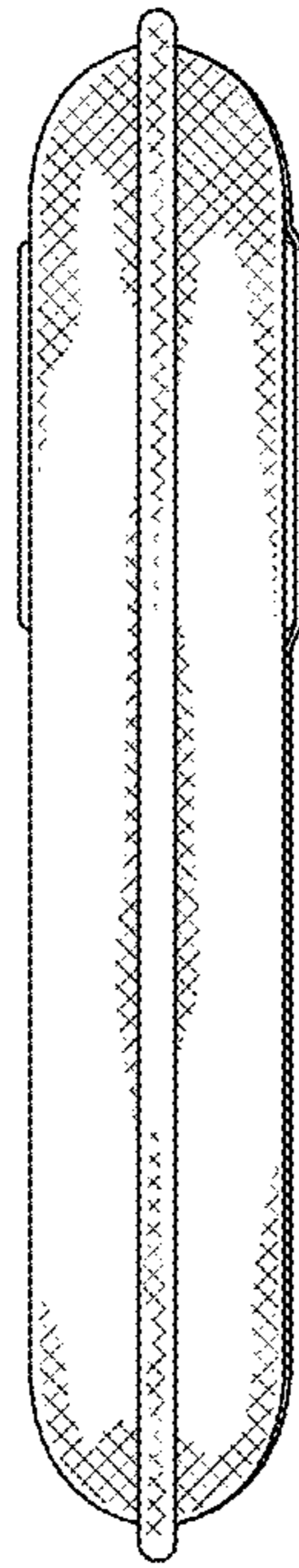

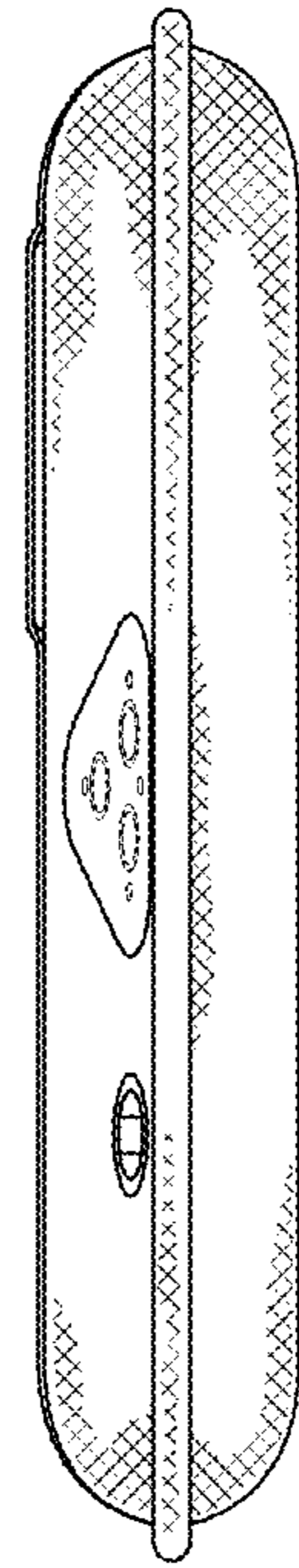

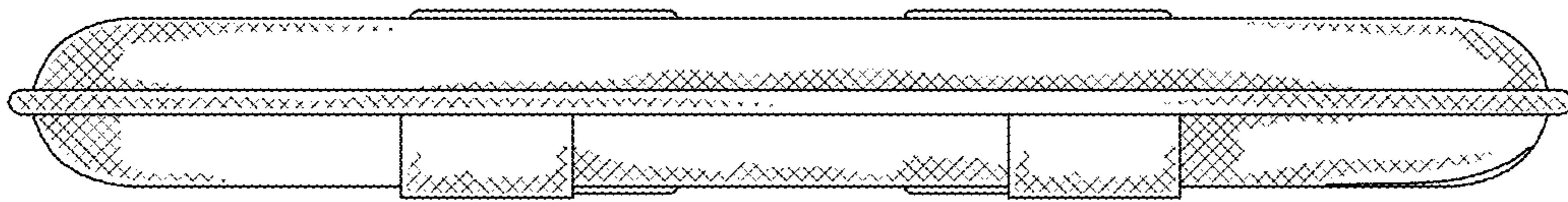

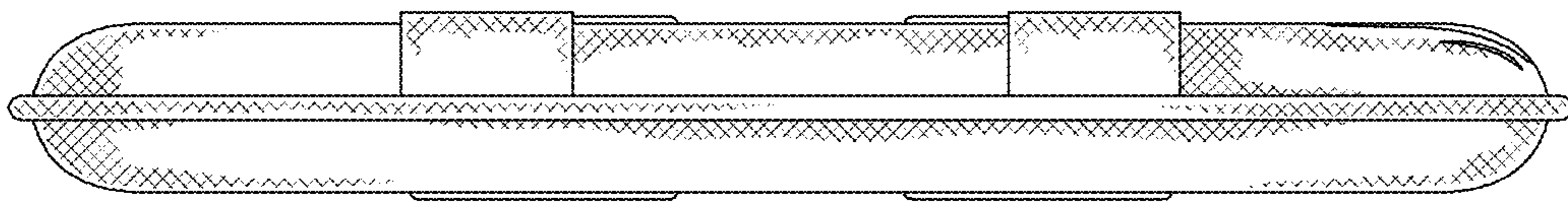

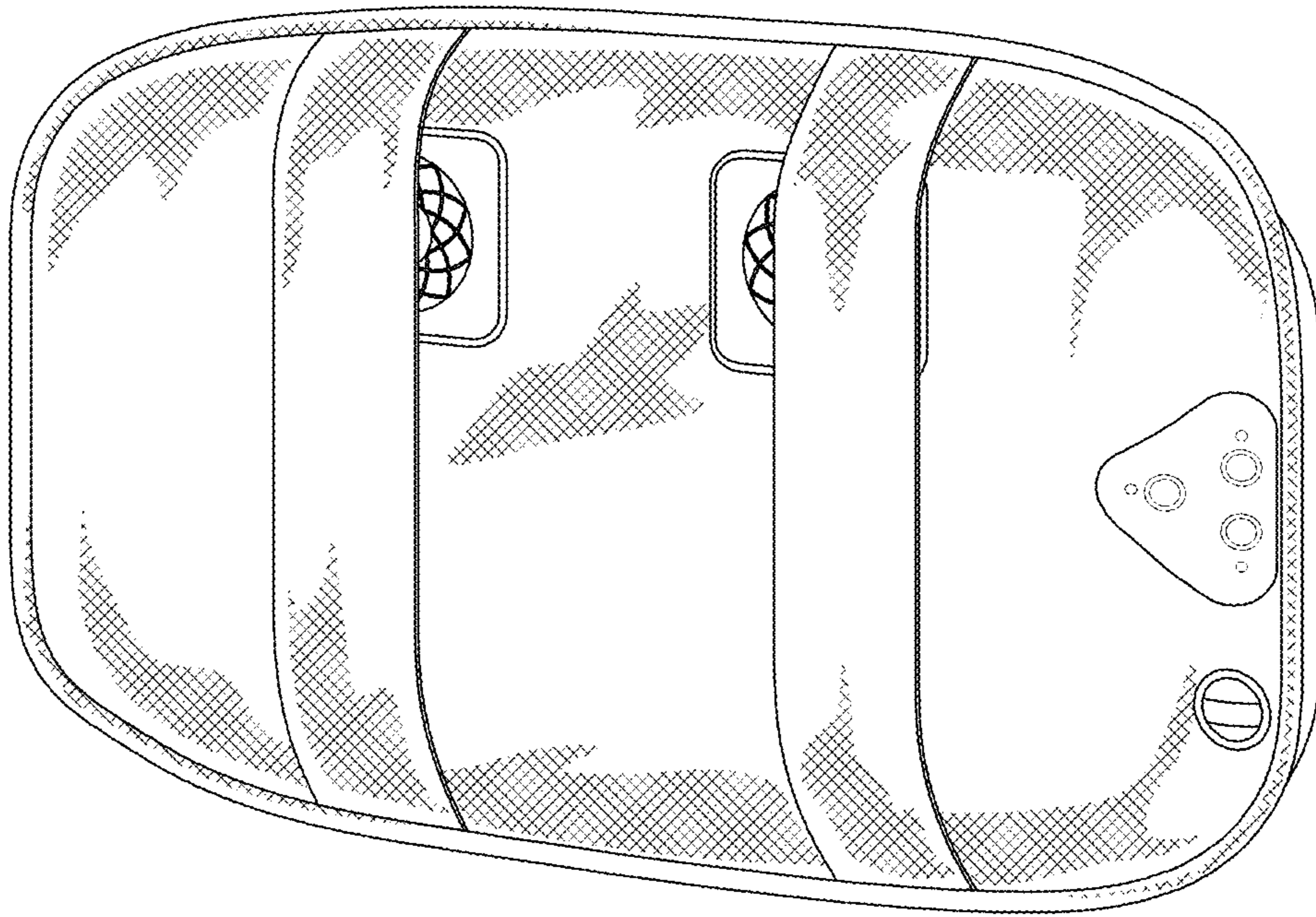

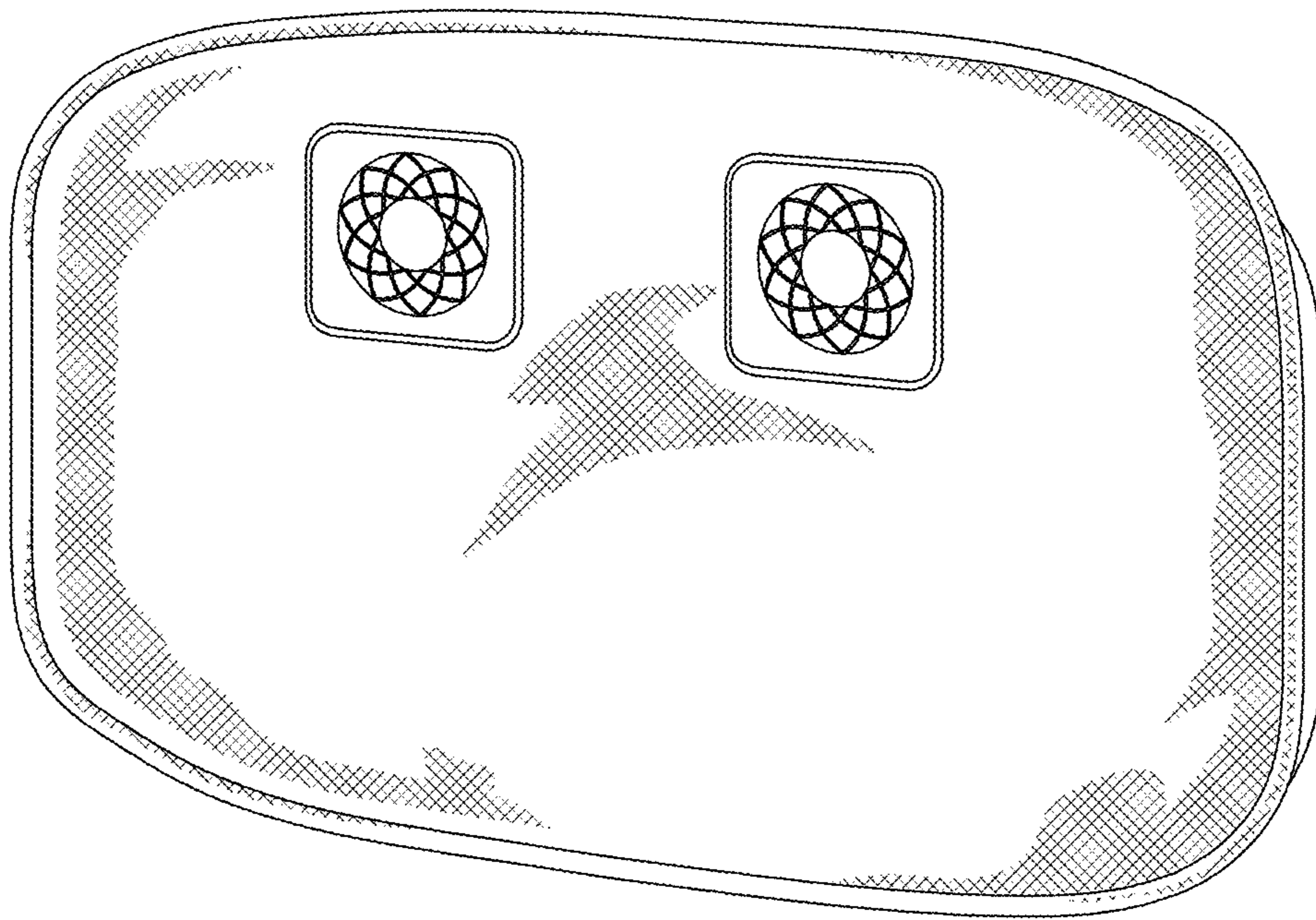
