FIG. 6 is a front perspective view of my new design in its environment of use.

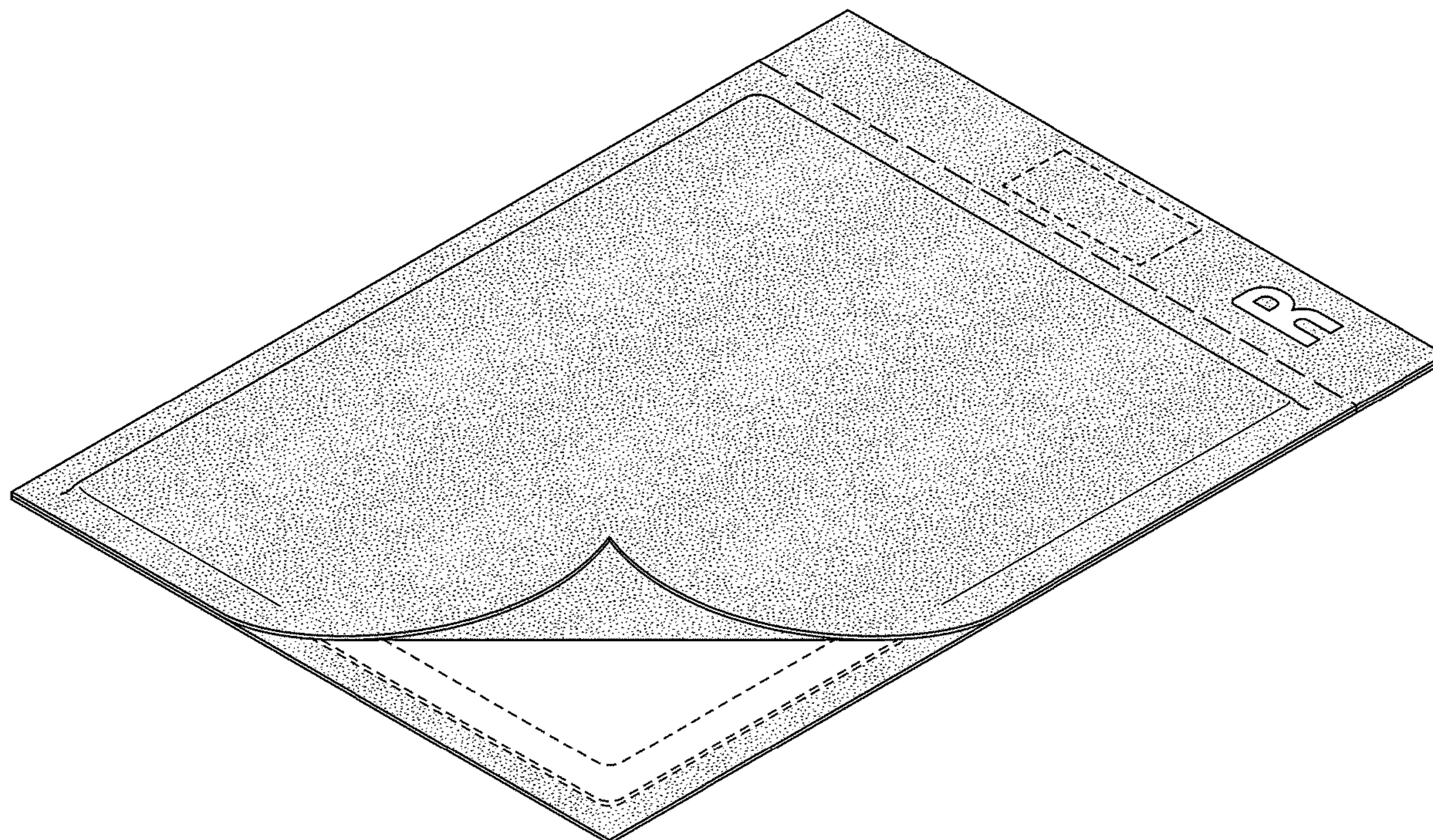

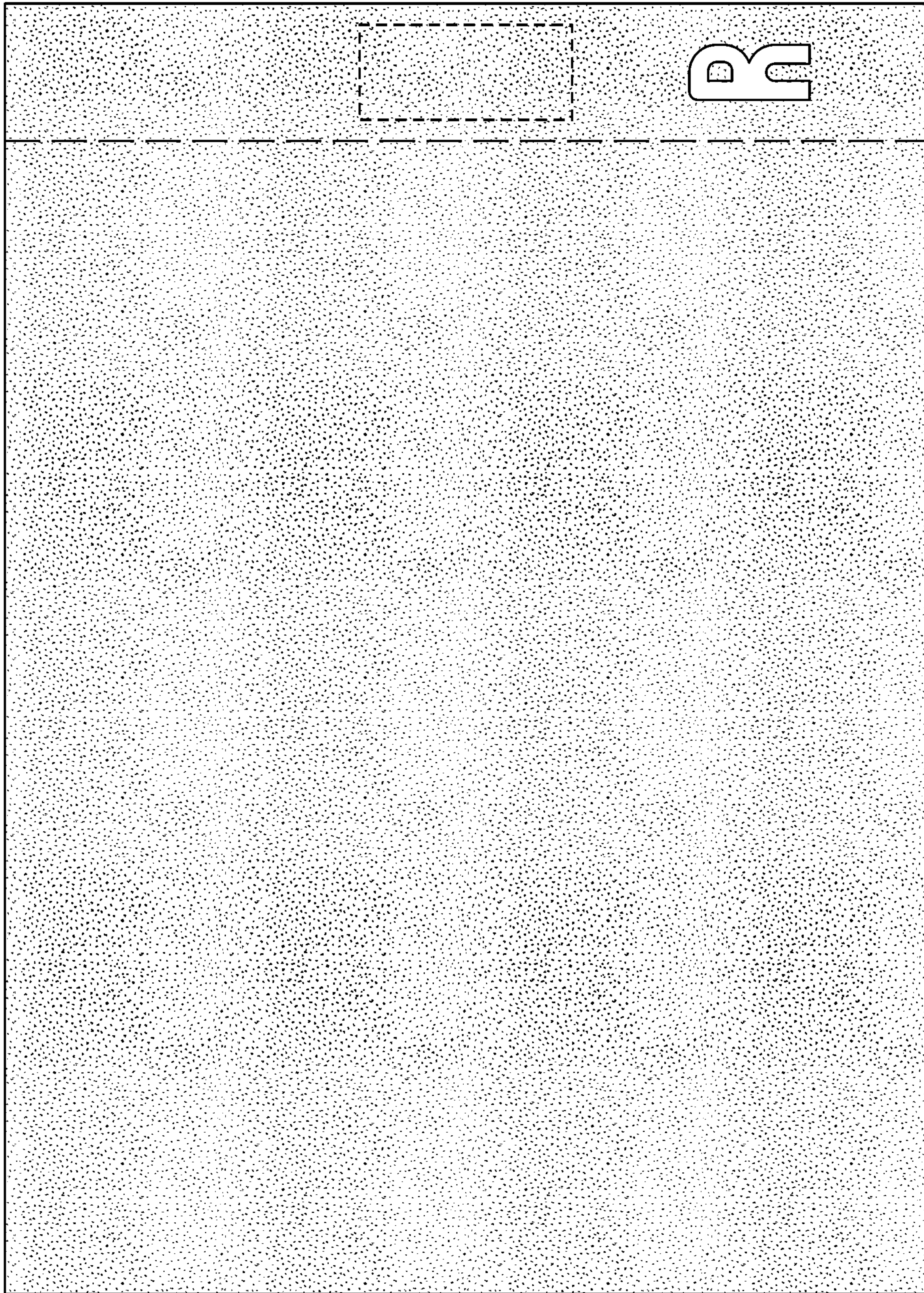

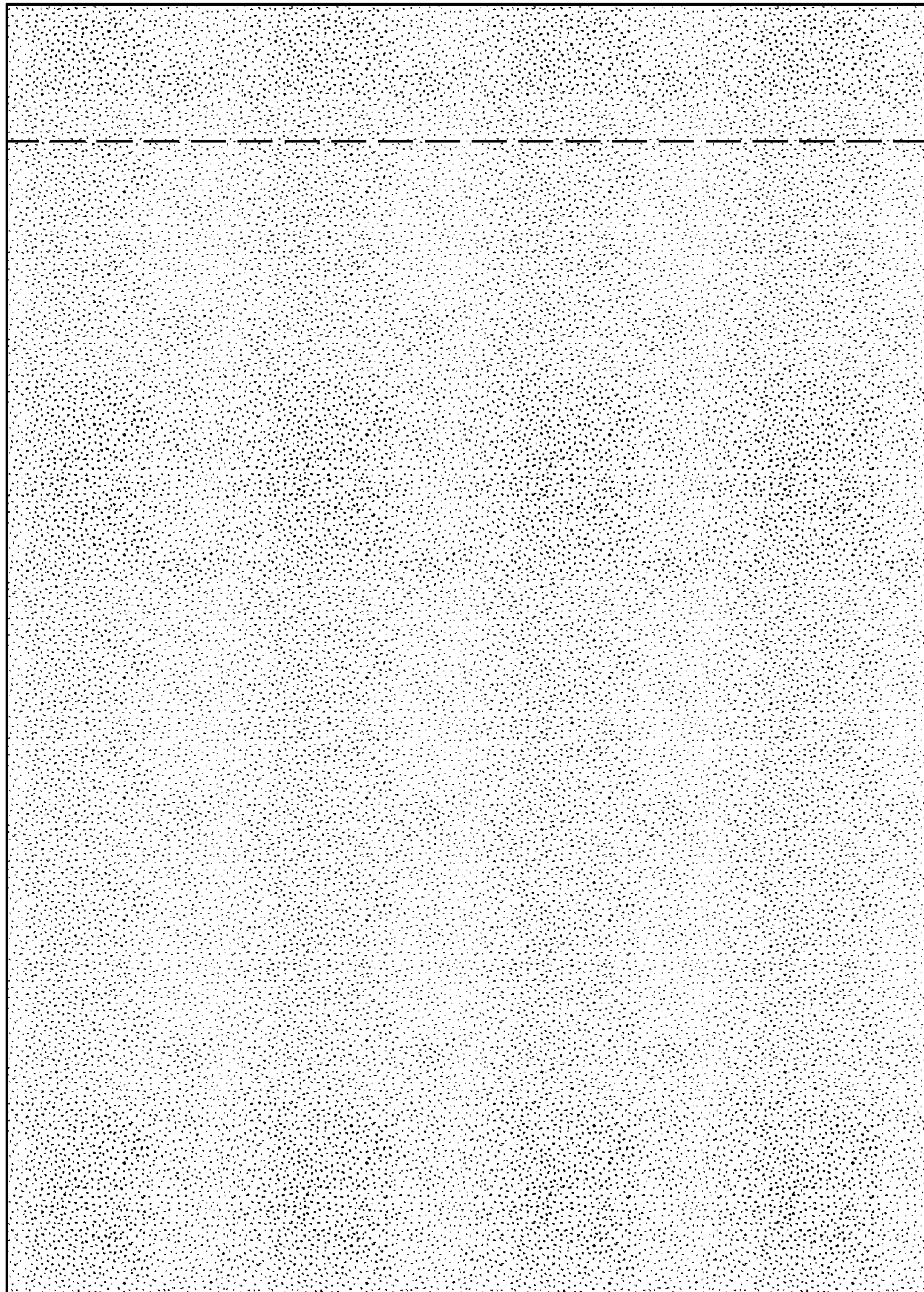

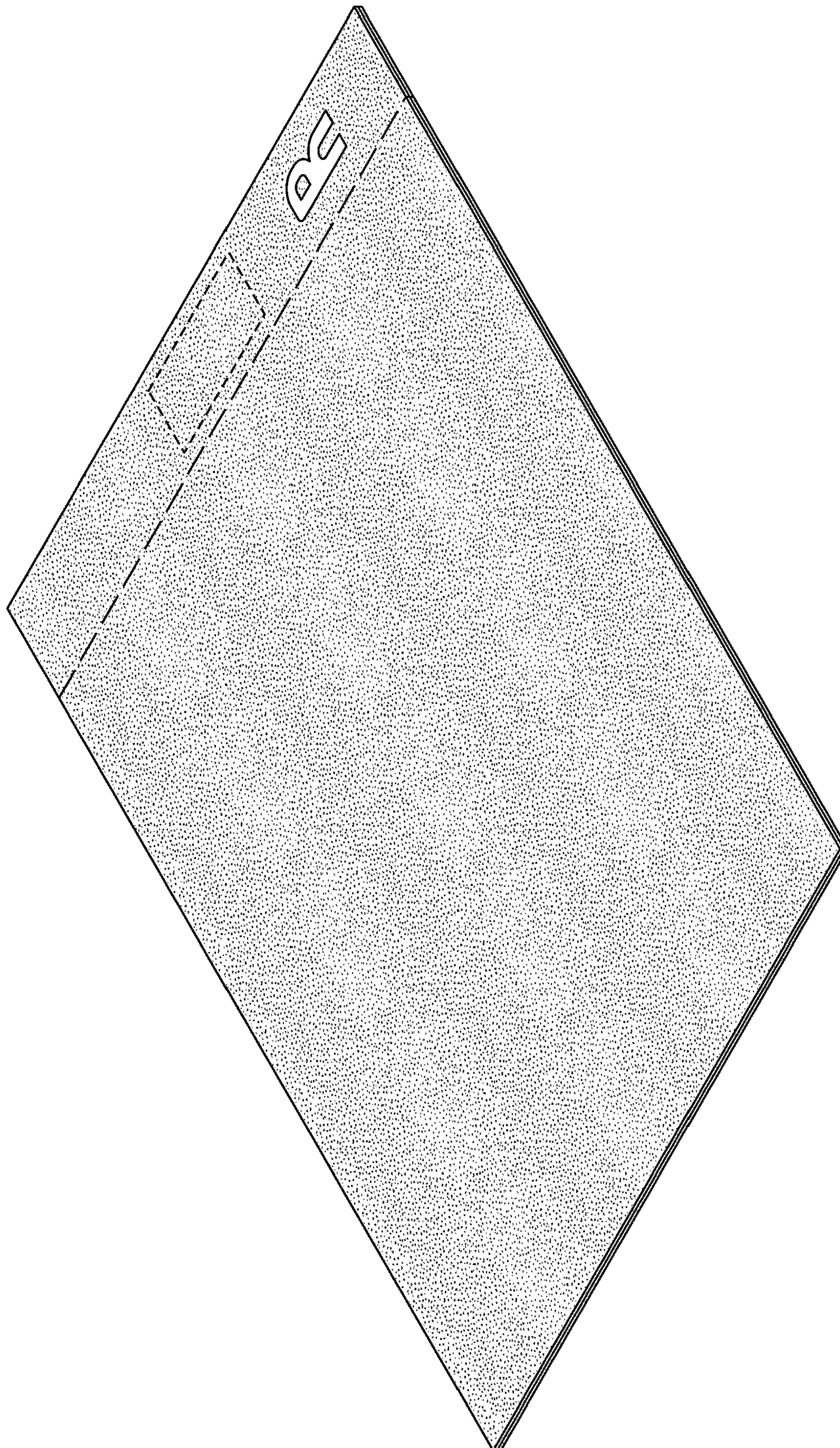

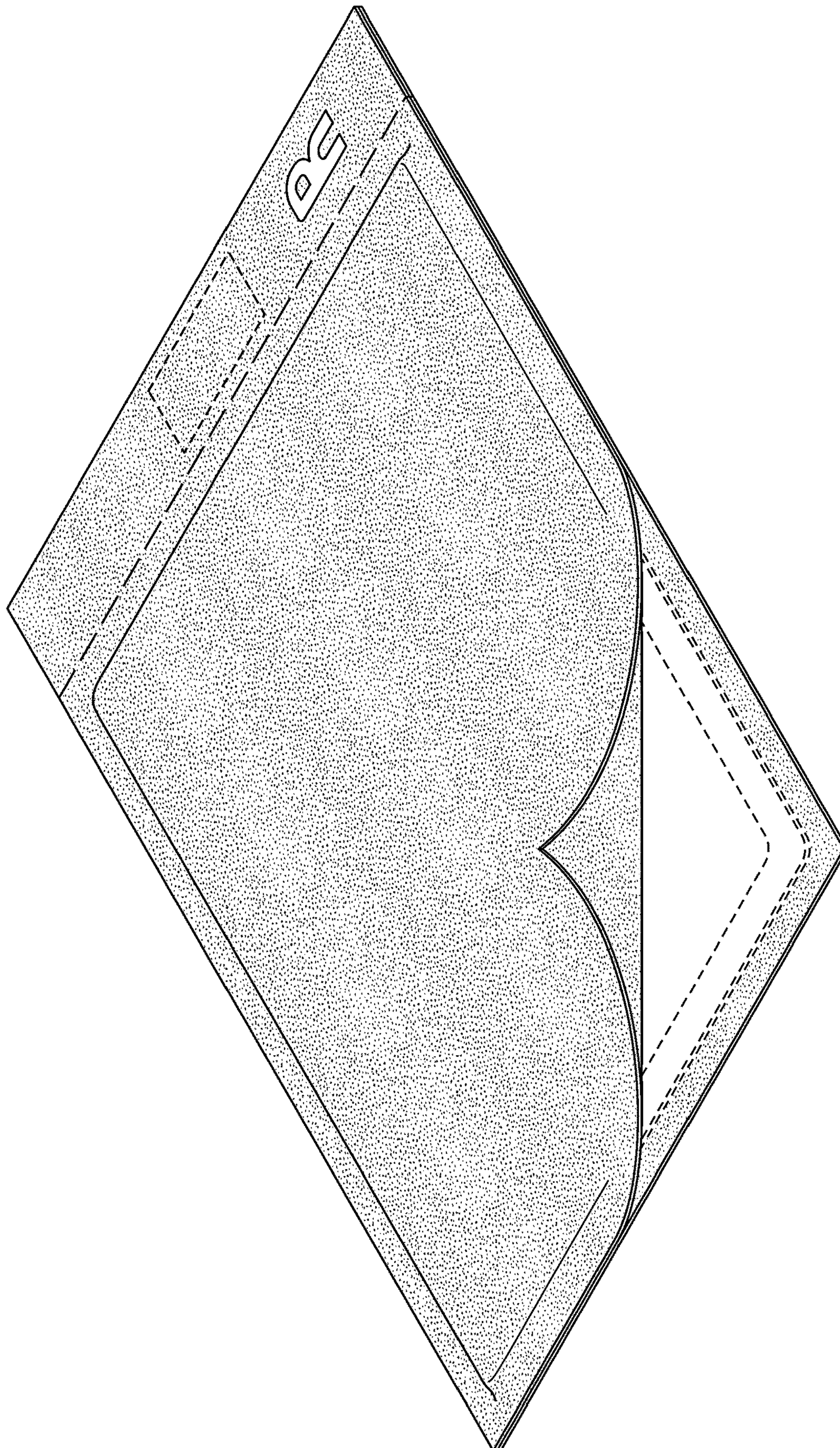
