FIG. 1 is a front view of a display screen or portion thereof with icon showing the claimed design; and,

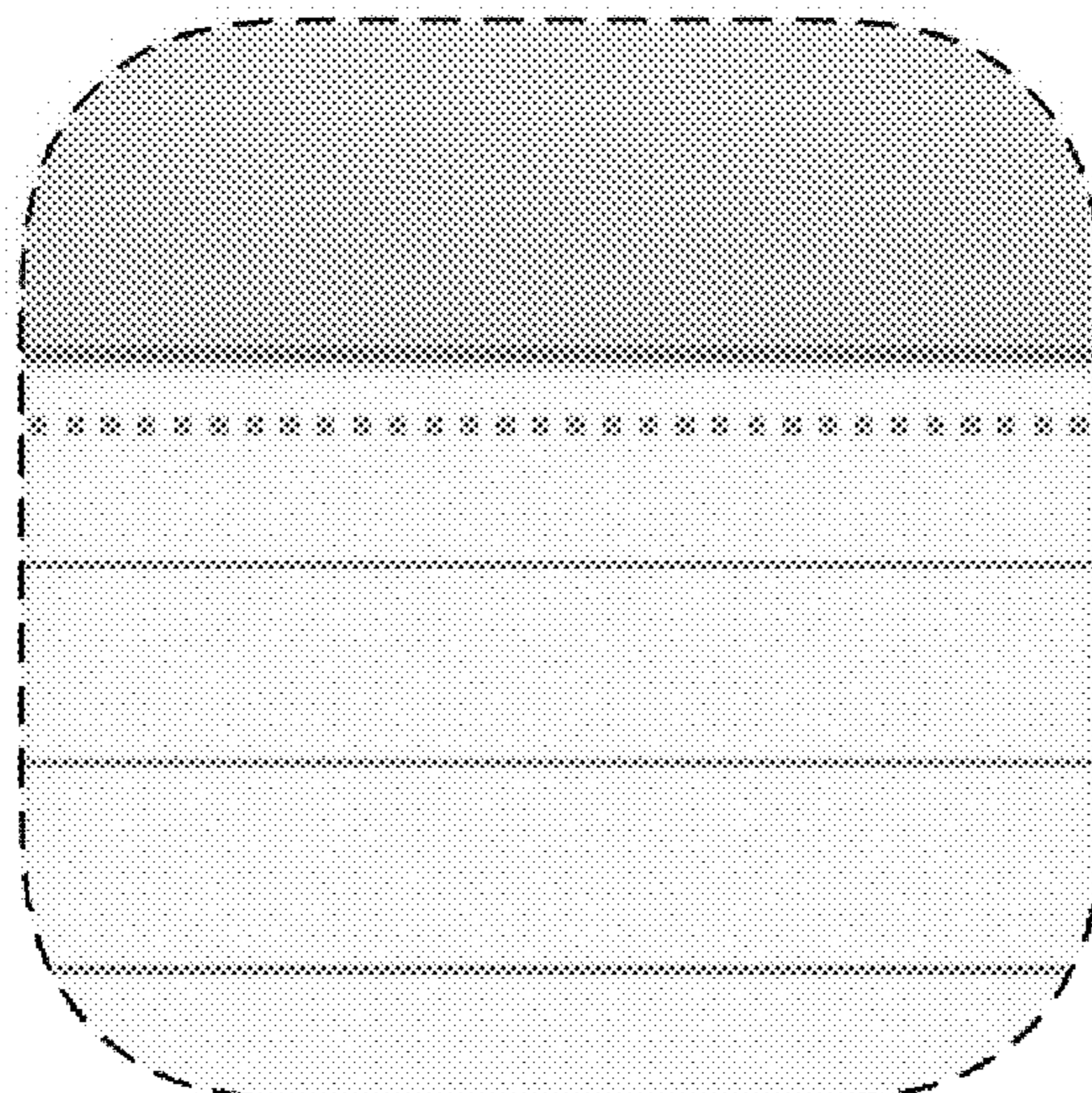
FIG. 2 is a front view of another embodiment thereof.

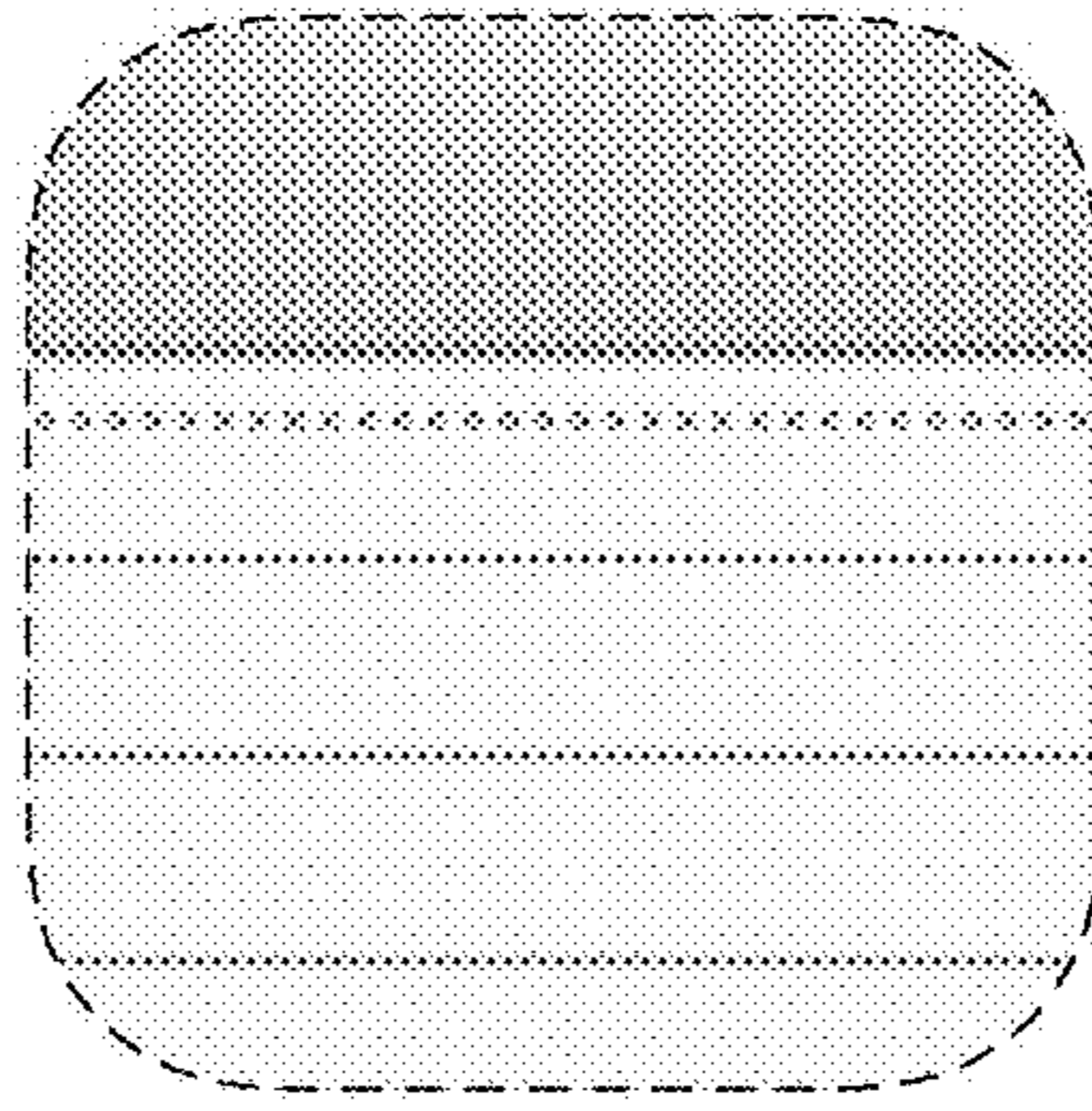

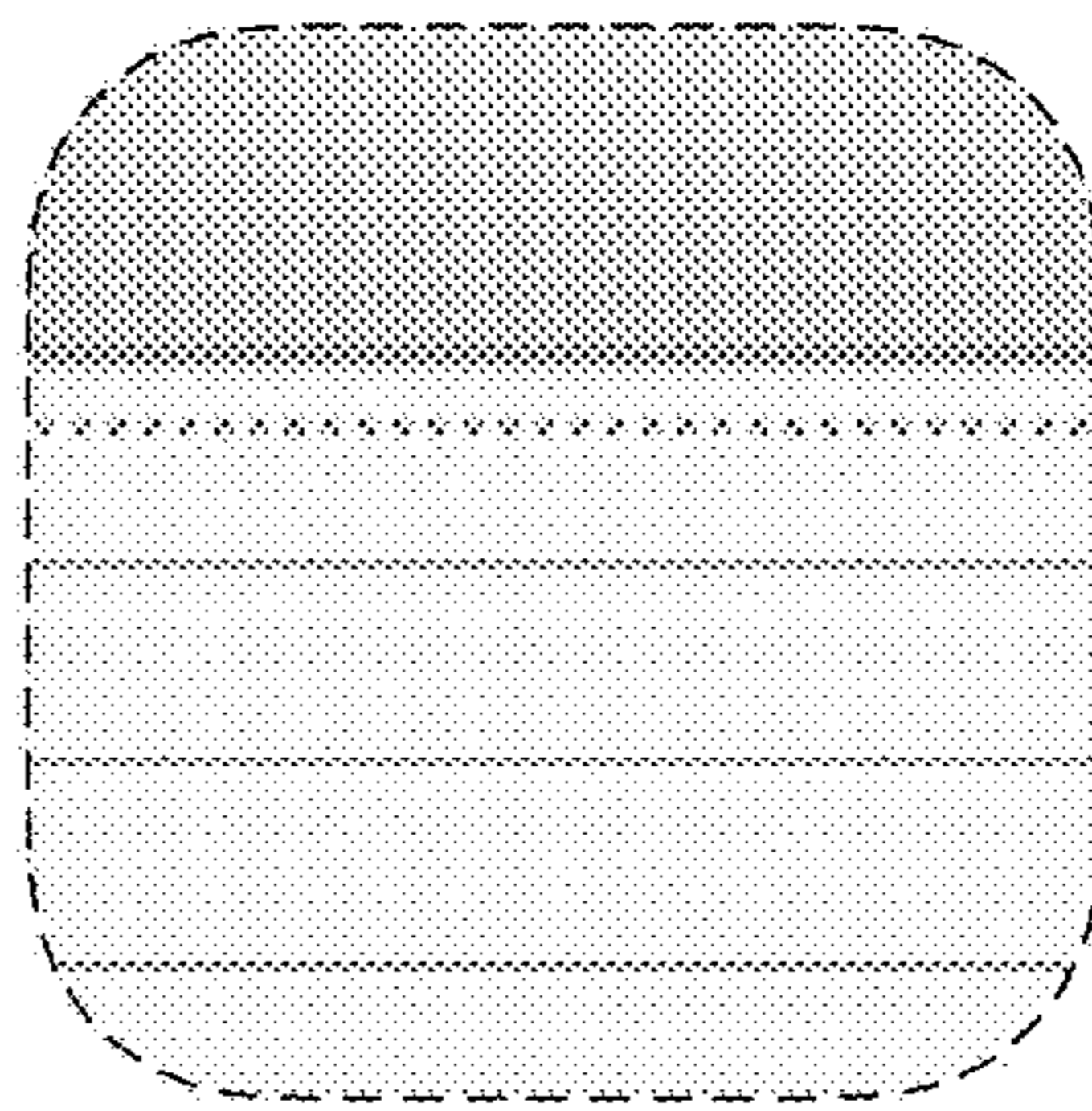
