The ornamental design for a belt for a printer, as shown and described.

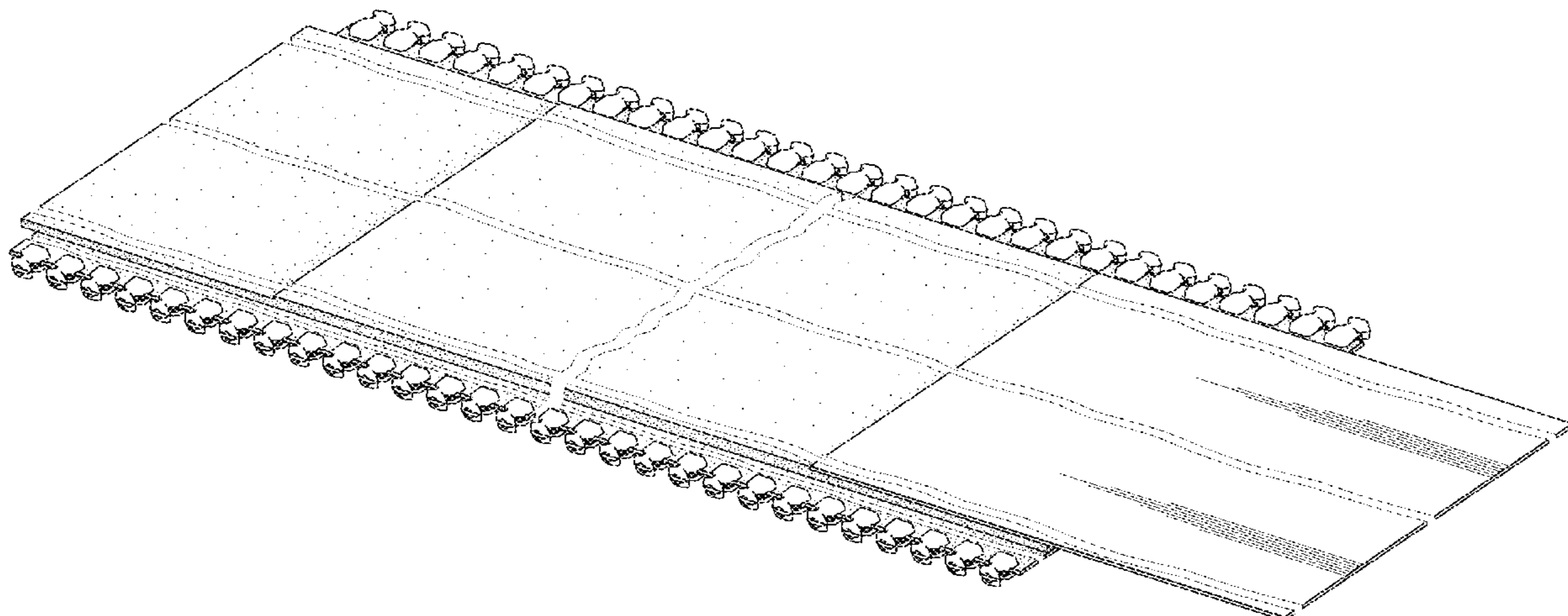
DESCRIPTION

FIG. 1 is a perspective view of a belt for a printer showing the new design;
FIG. 2 is a right view thereof;

FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

Broken lines shown in the drawings depict portions of the belt for a printer that form no part of the claimed design. The belt for a printer is shown with symbolic breaks in its length and width. The symbolic breaks are indicated by dot-dash boundary lines, which indicate the boundaries of the claimed design. The appearance of any portion of the article between the boundary lines forms no part of the claimed design.

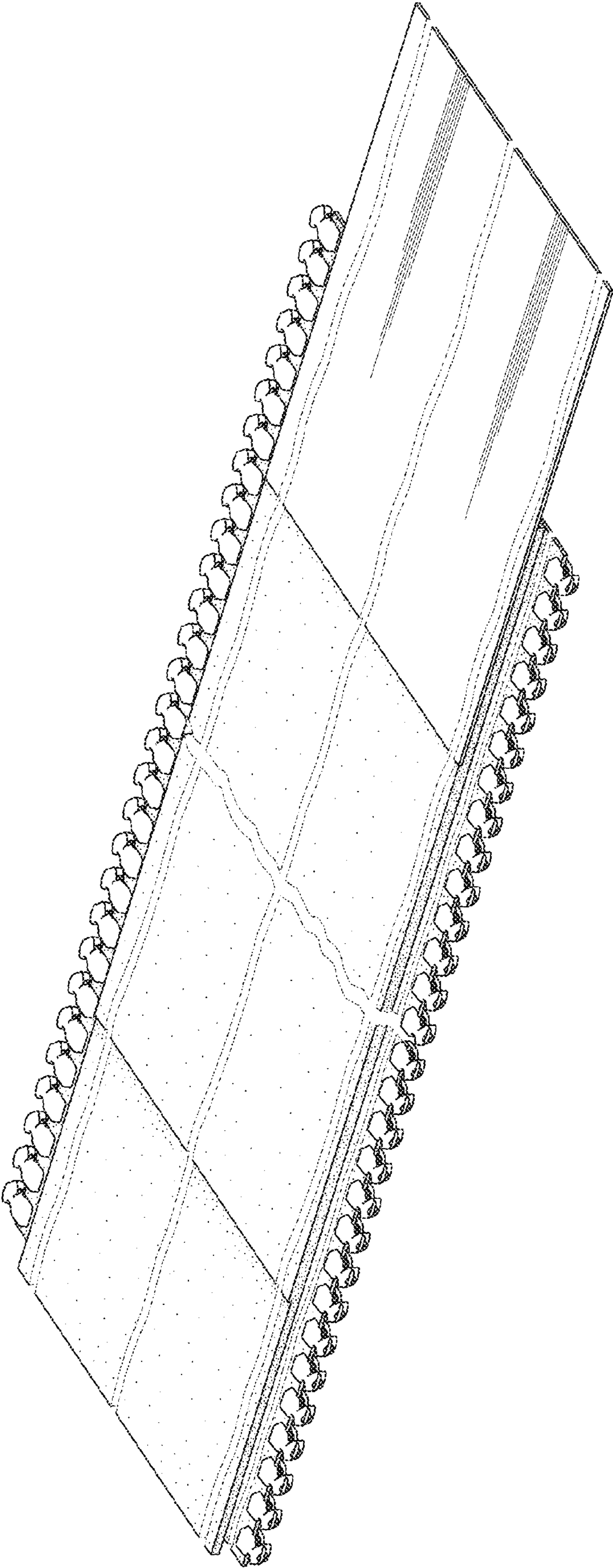

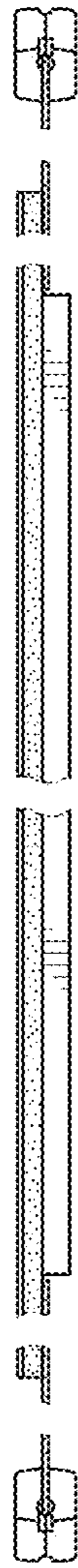

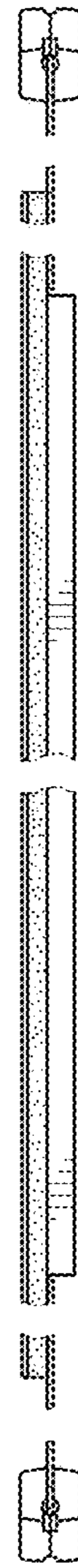

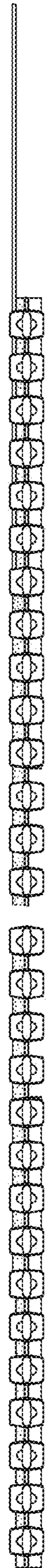

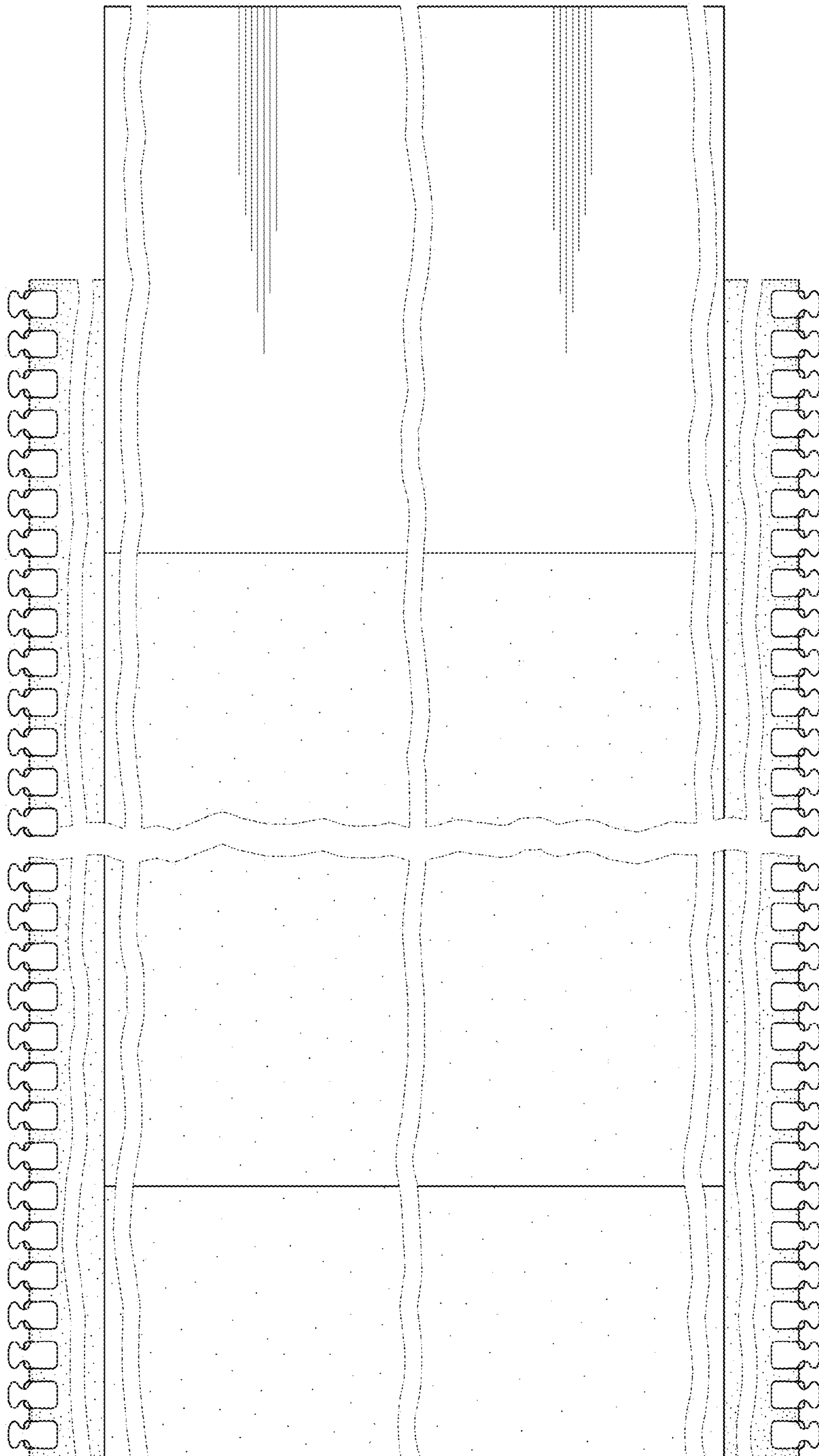

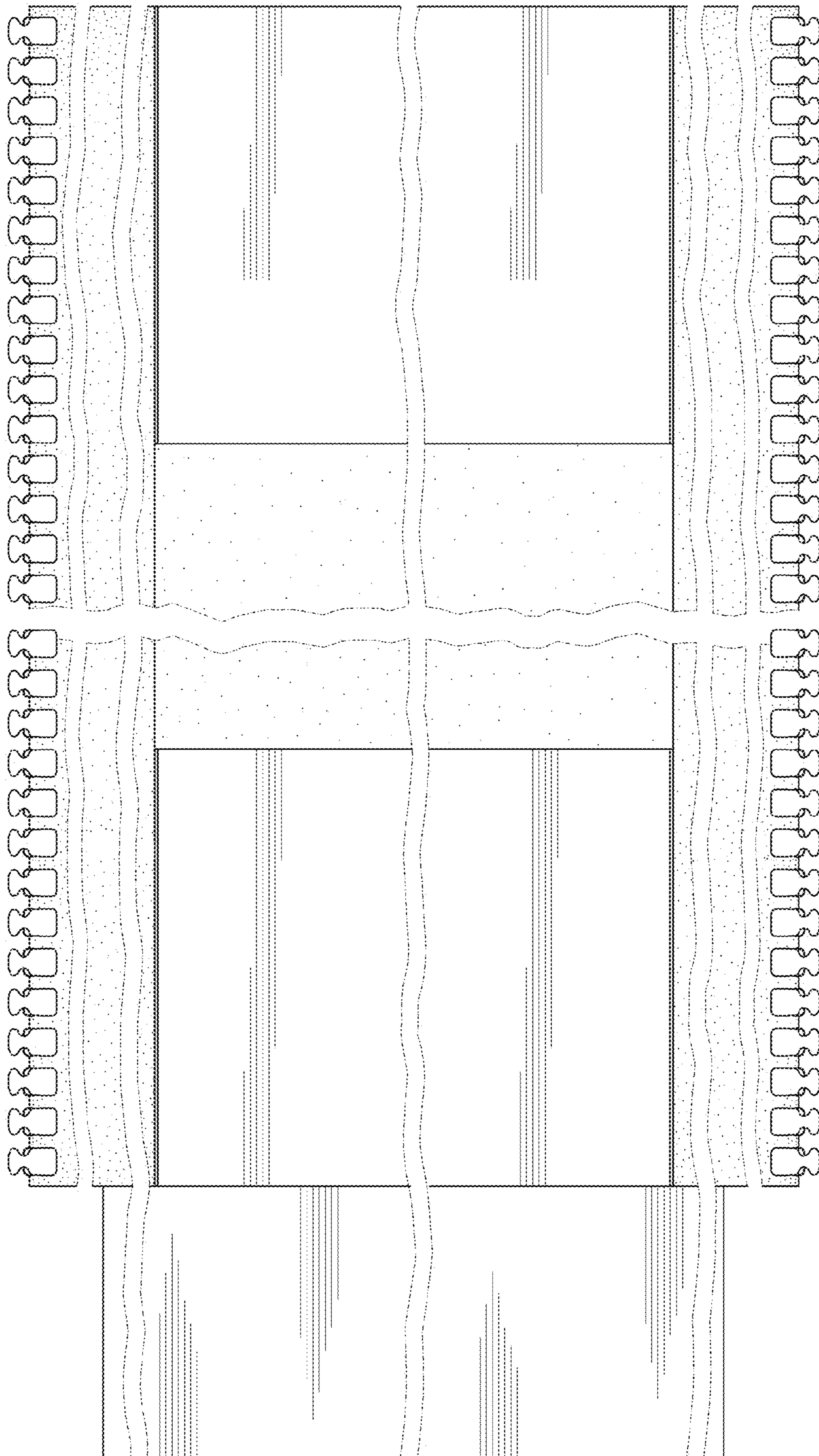
