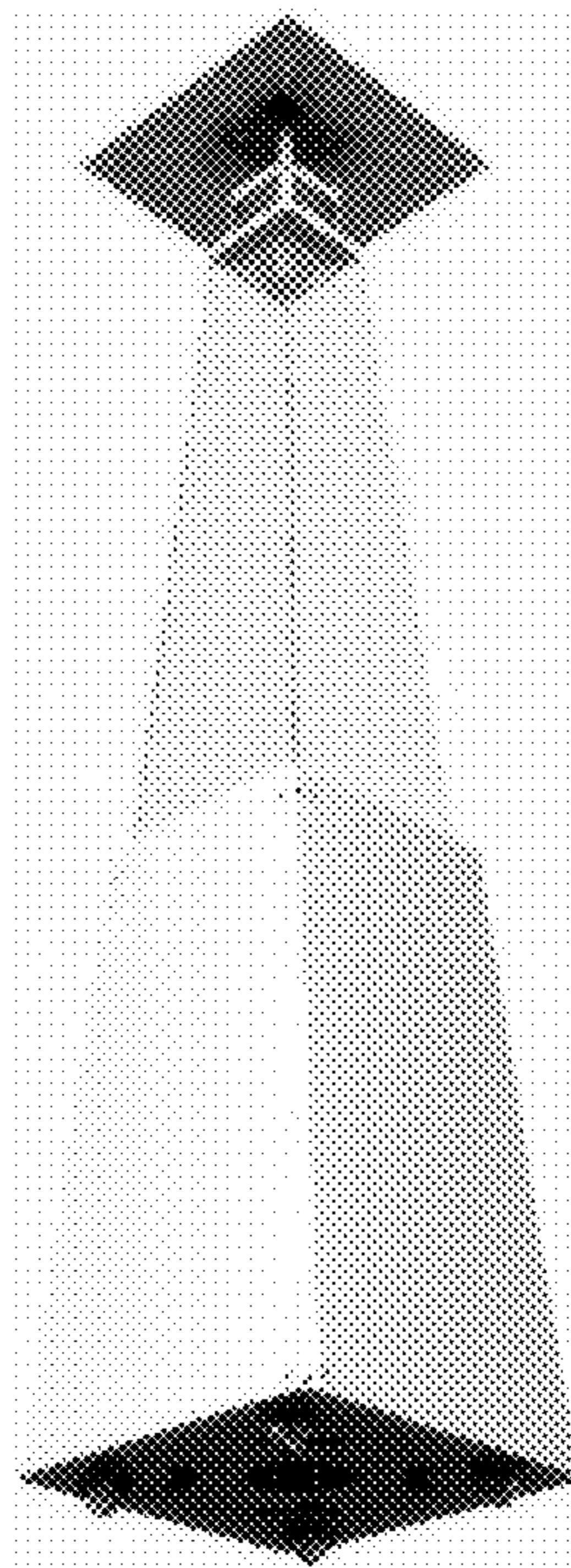
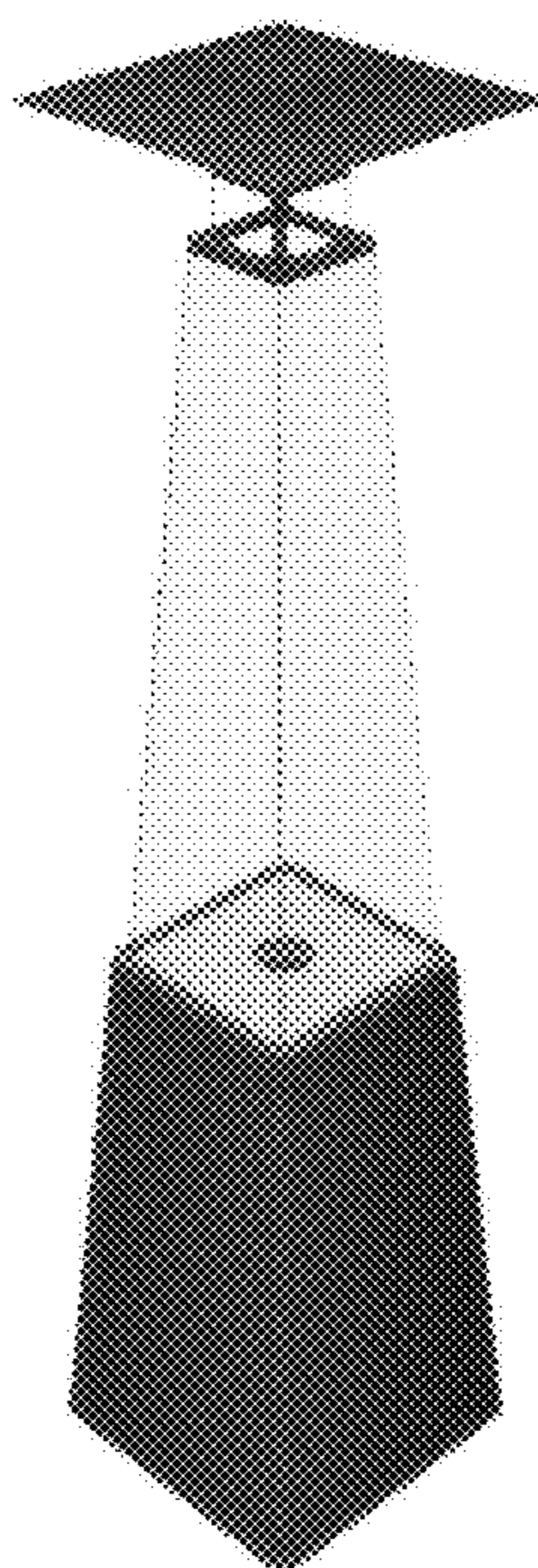
The ornamental design for an outdoor heater, as shown and described.

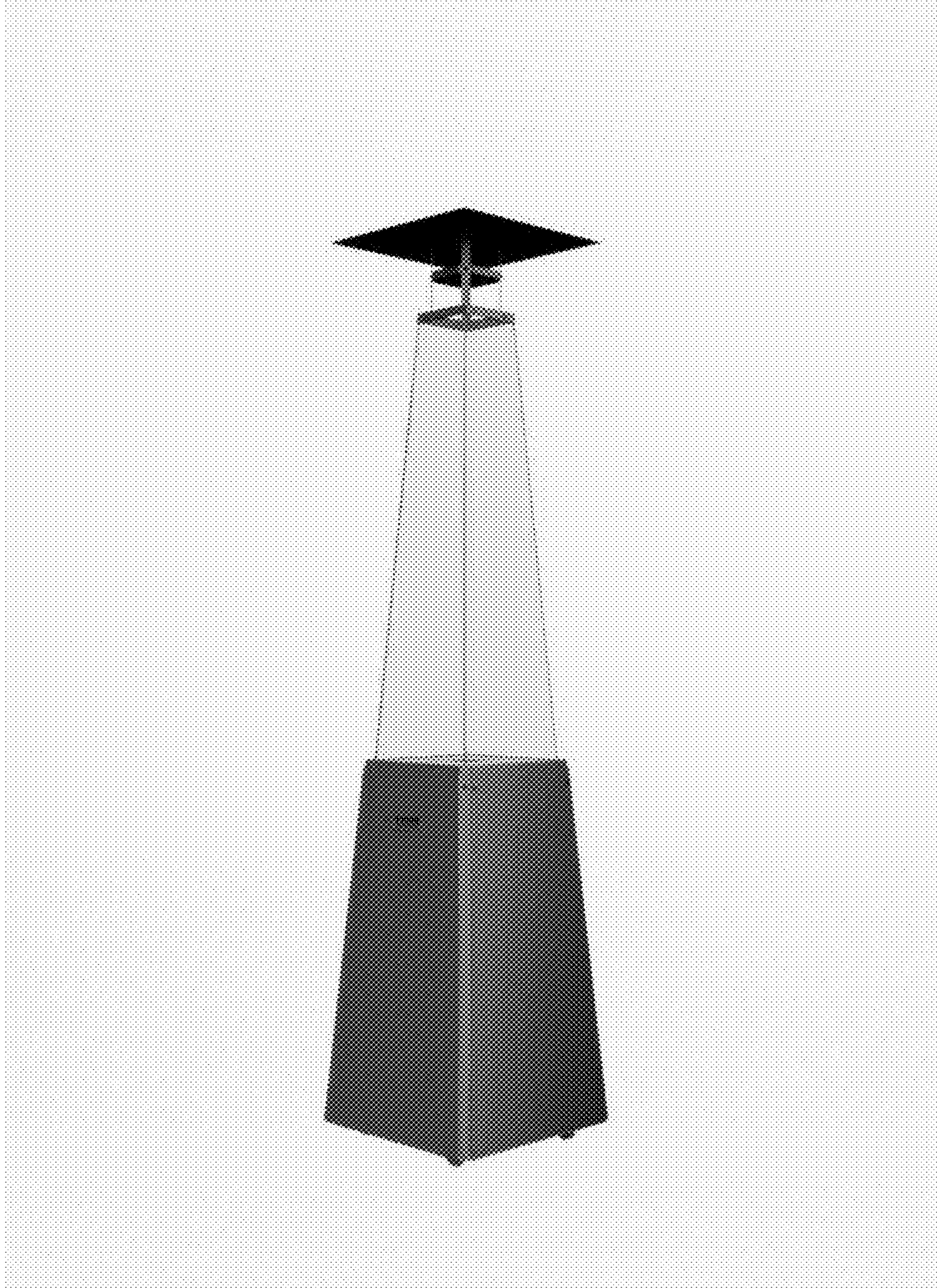

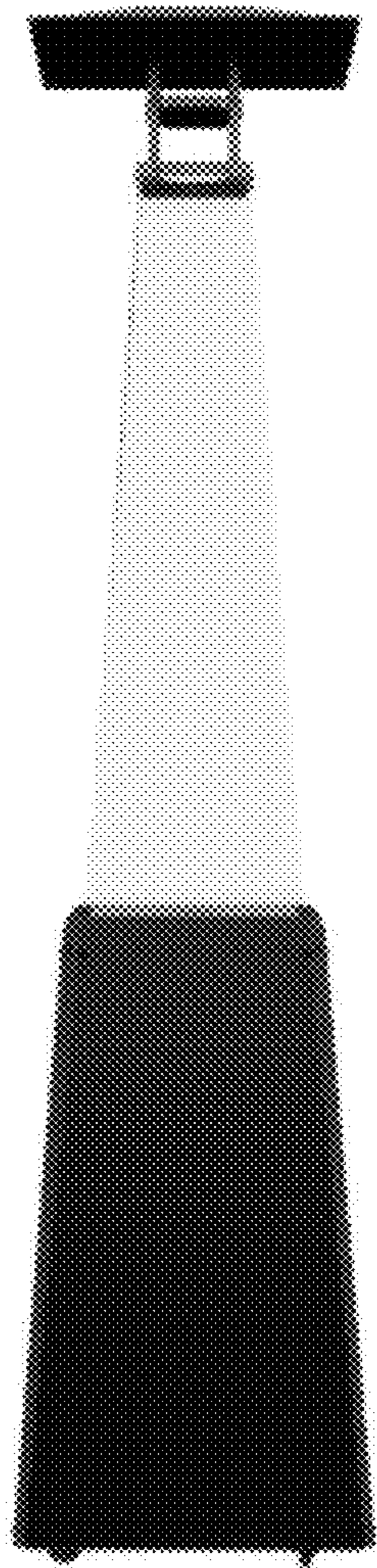

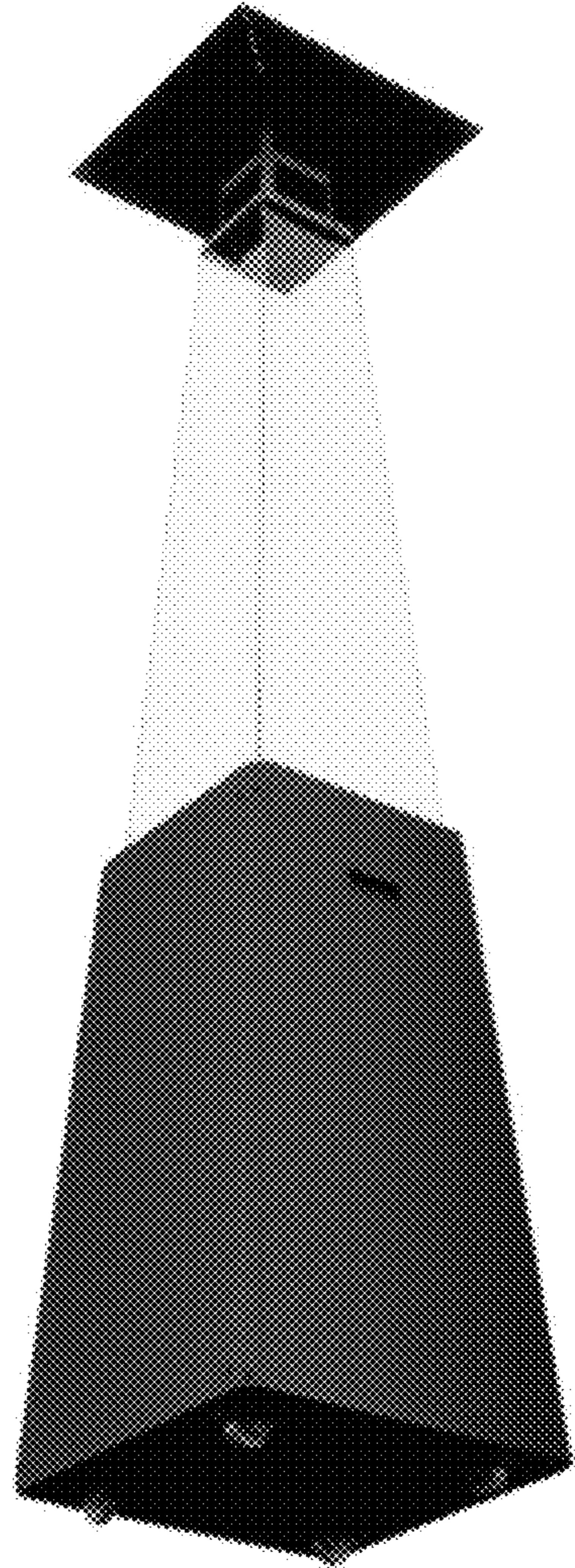

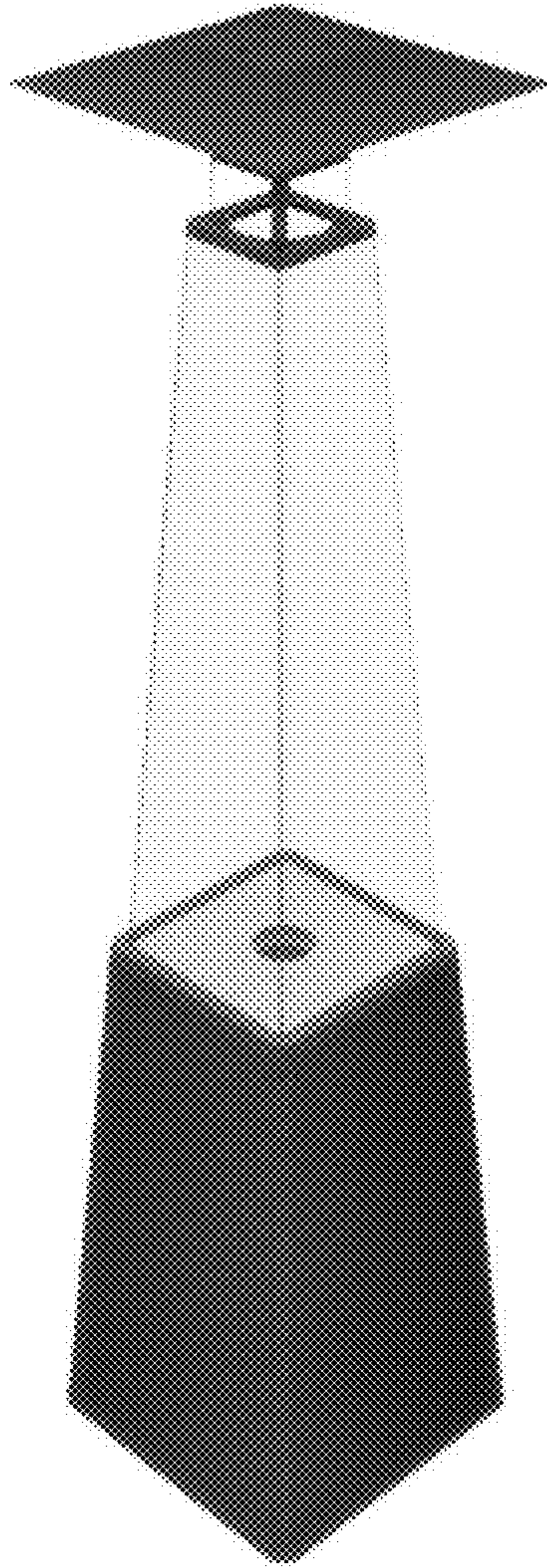

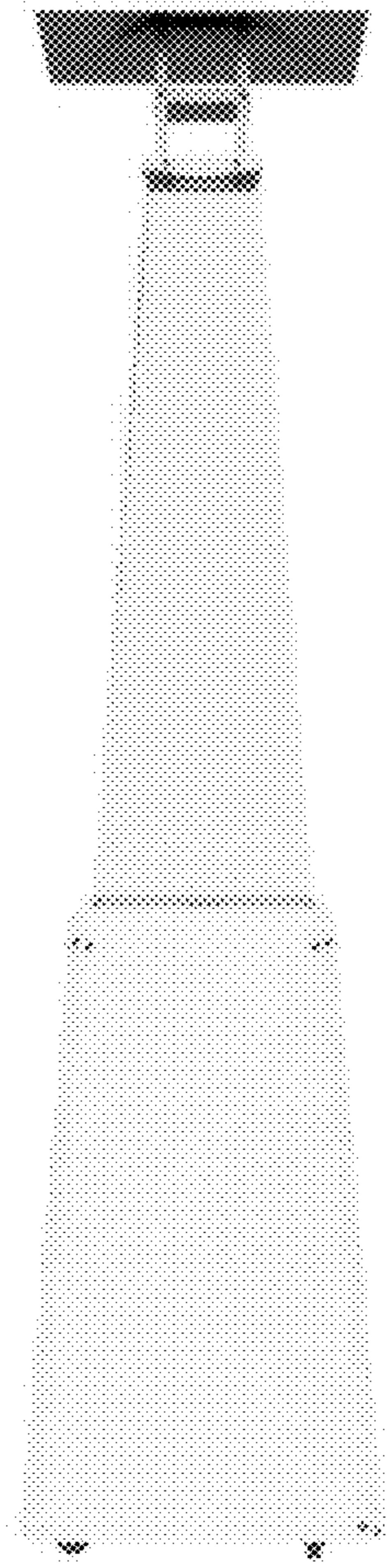

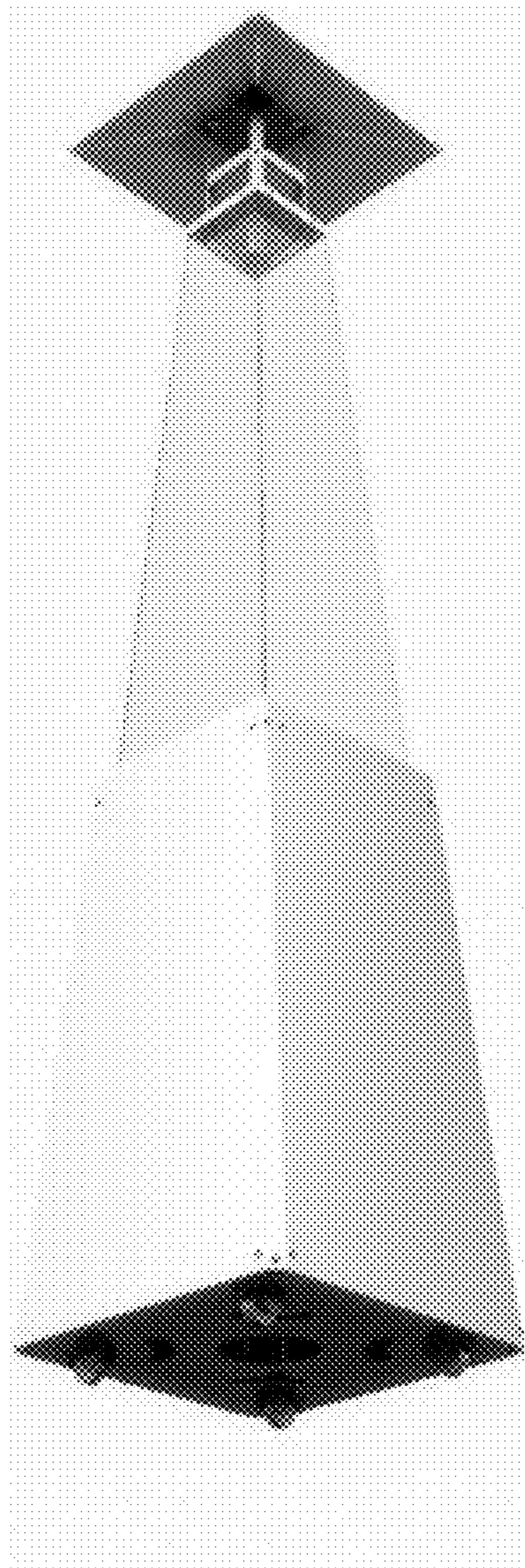

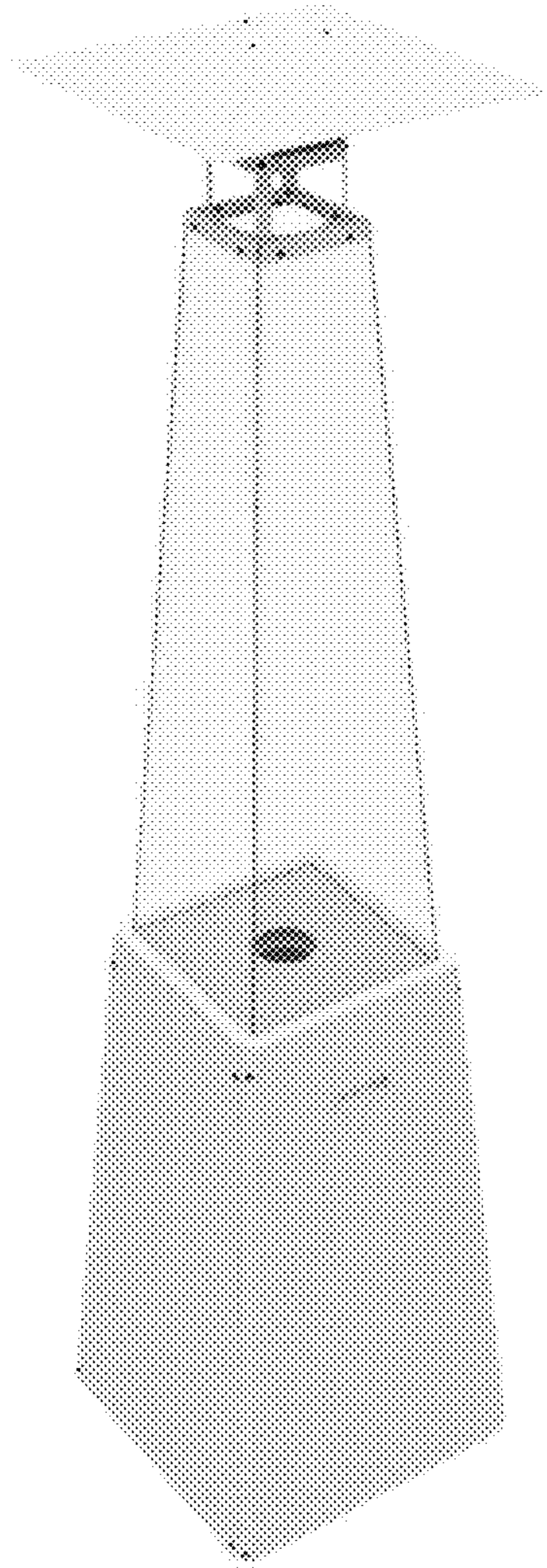
