**DESCRIPTION**

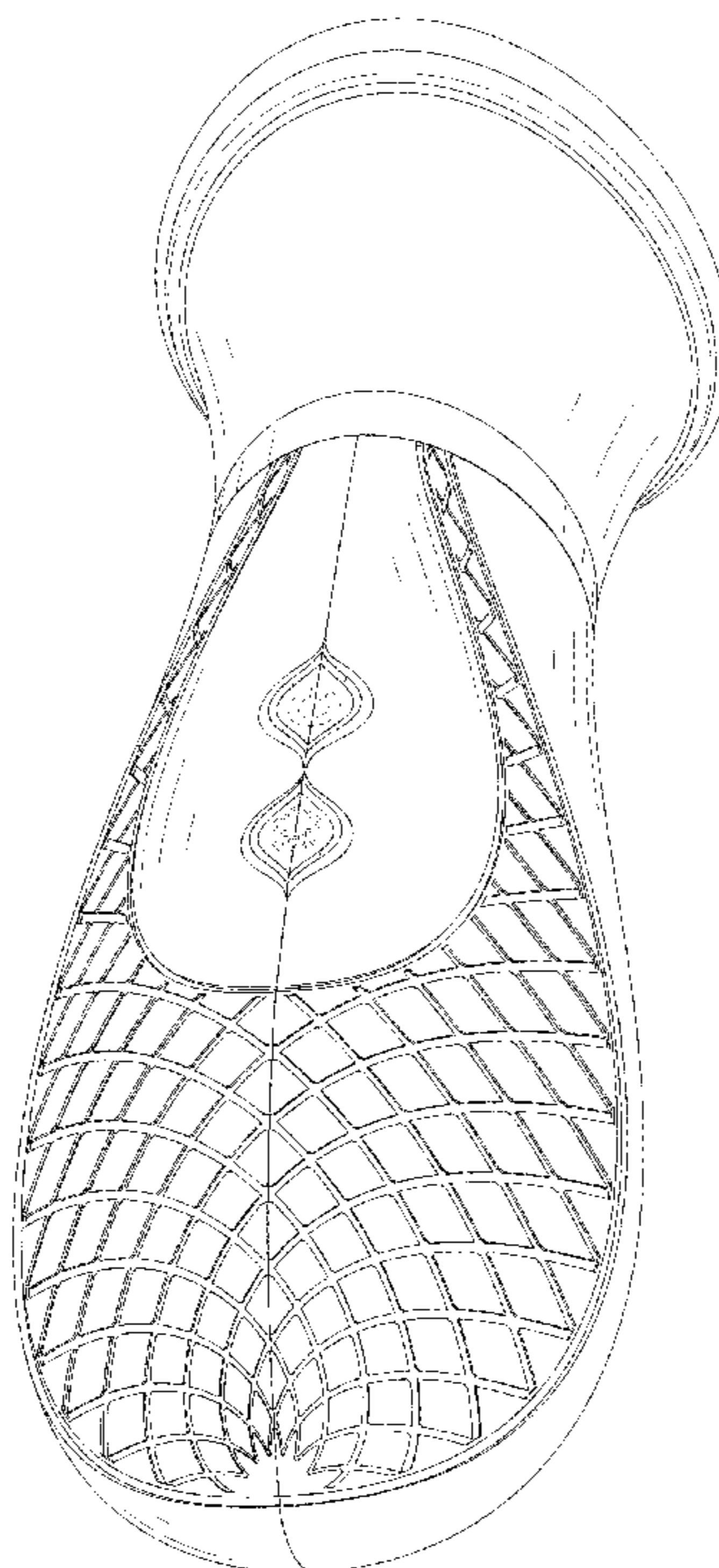
FIG. 1 is a perspective view of a massager showing my new design;

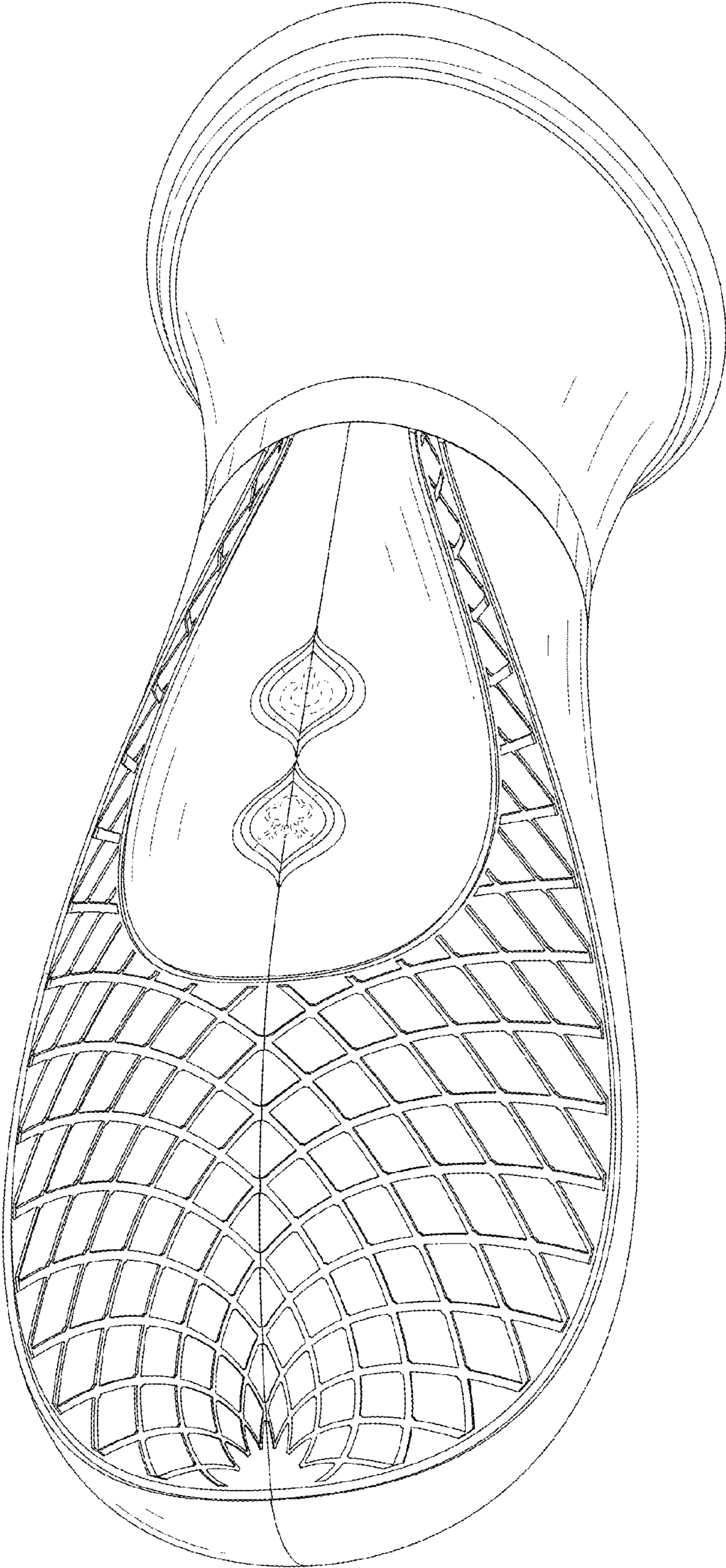

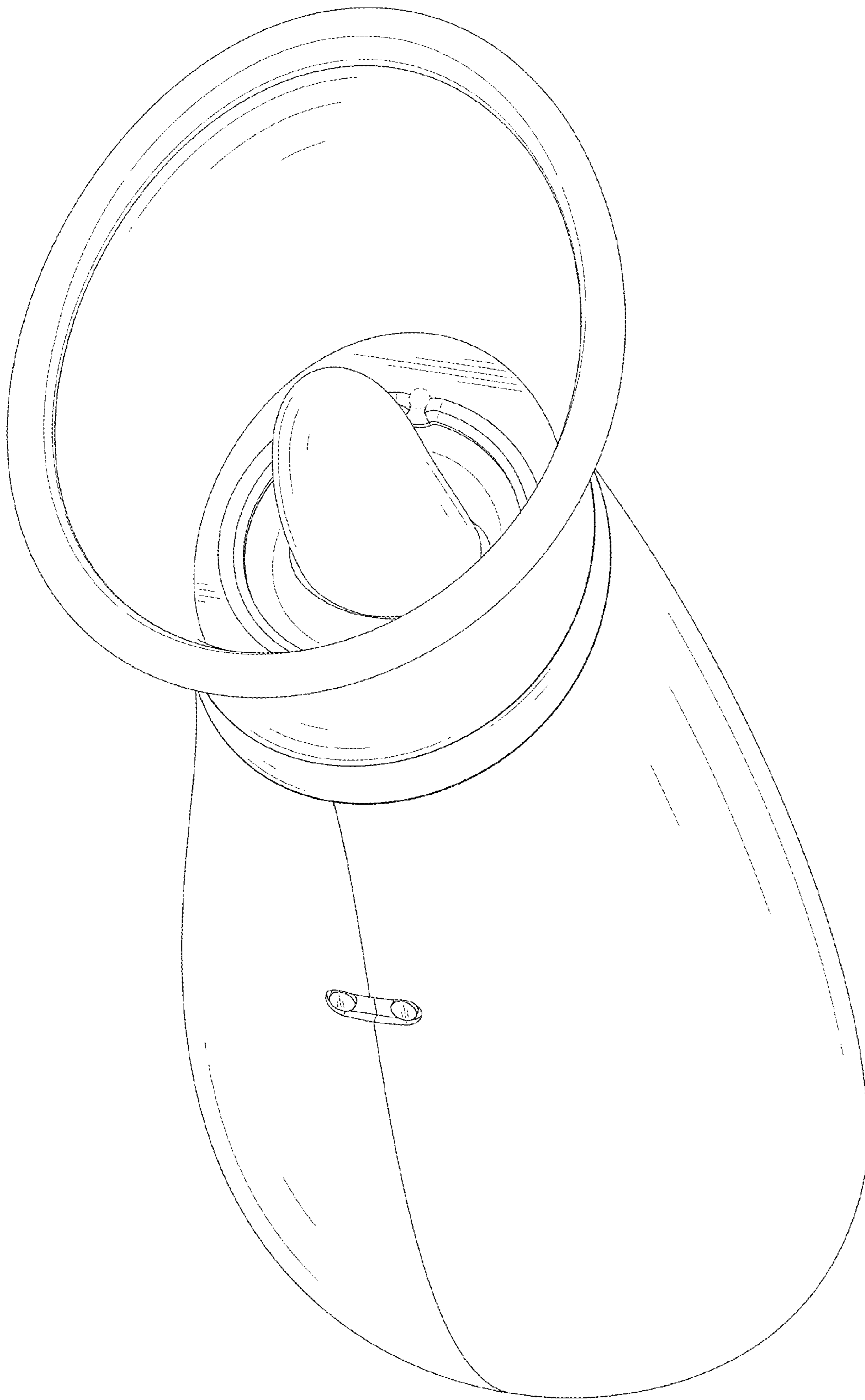

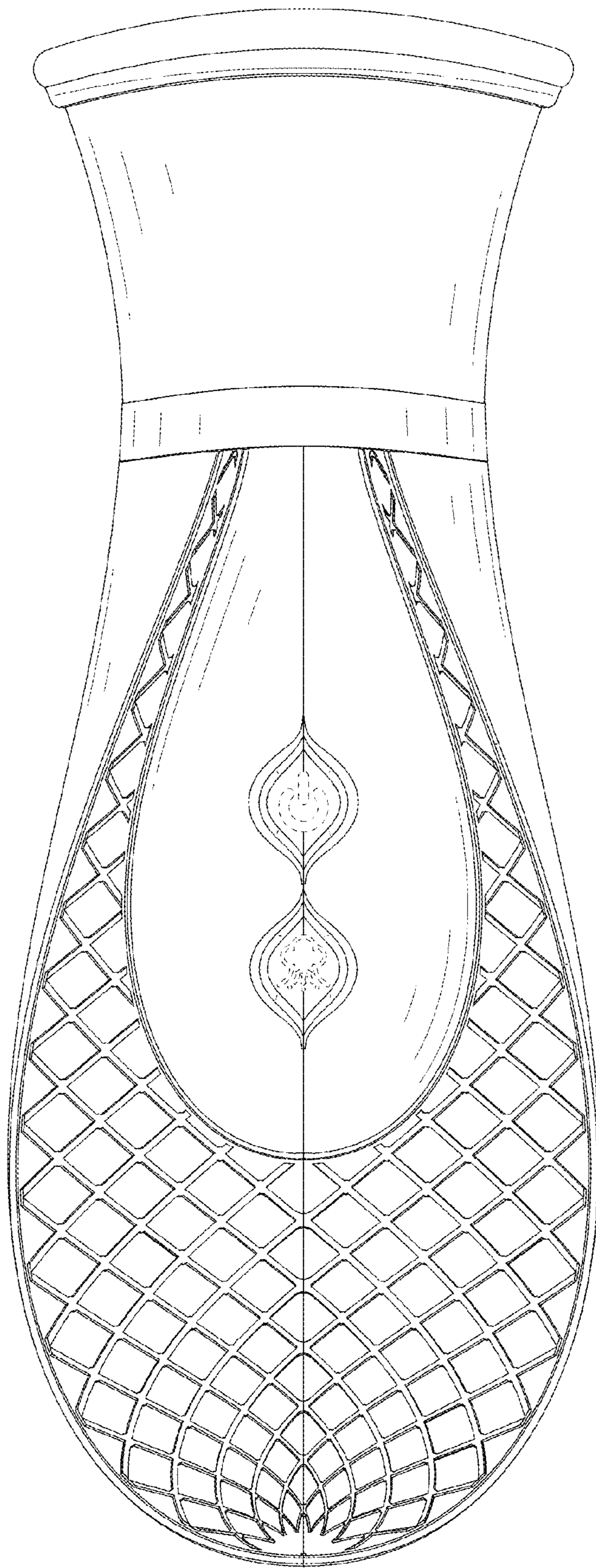

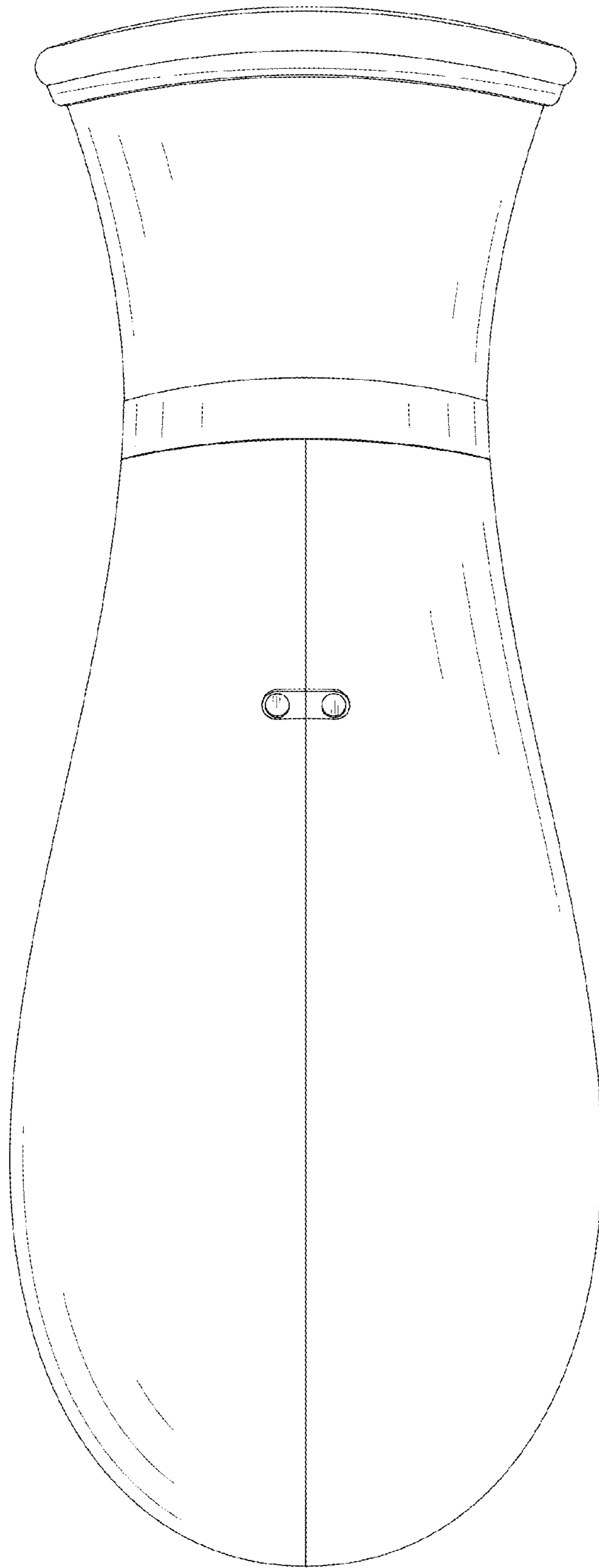

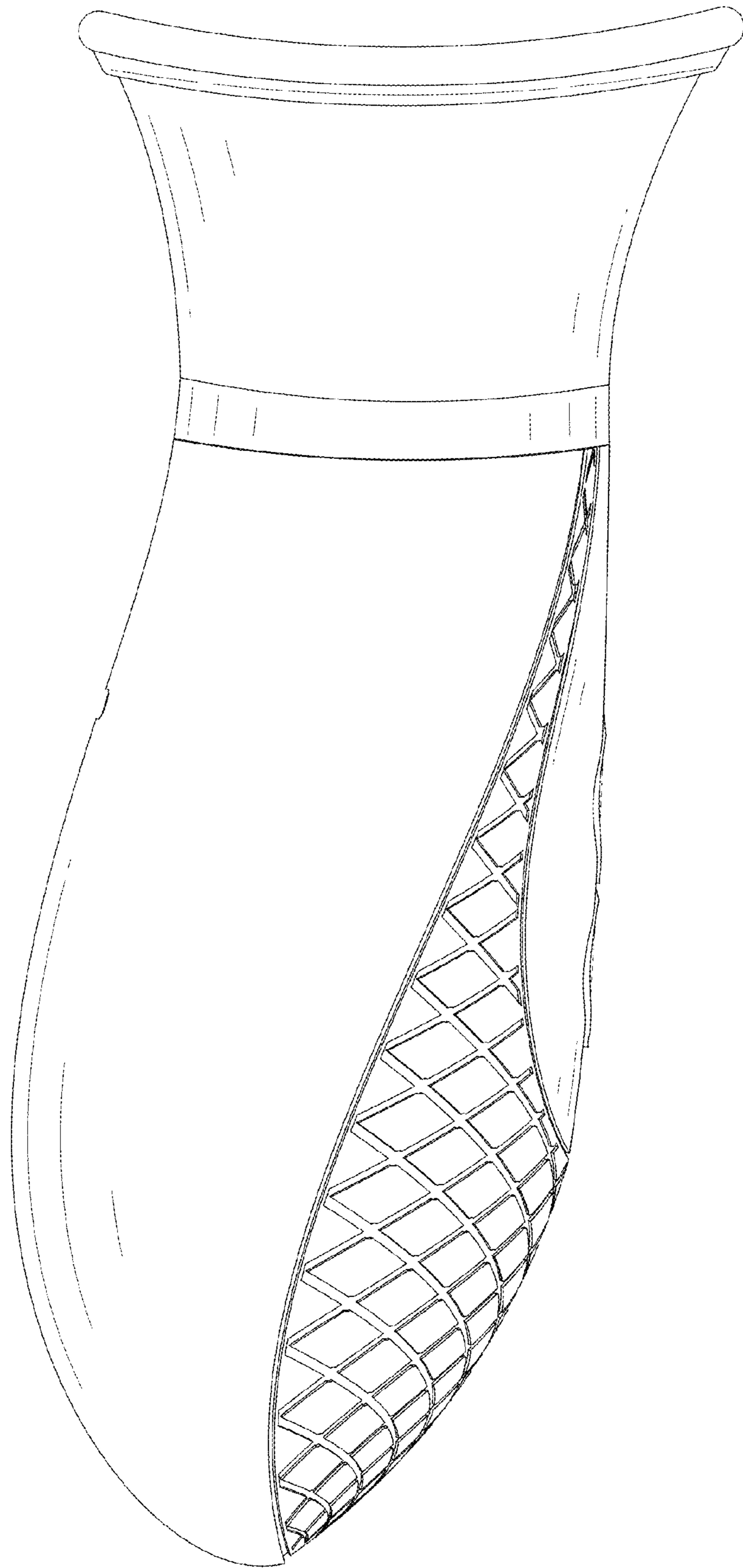

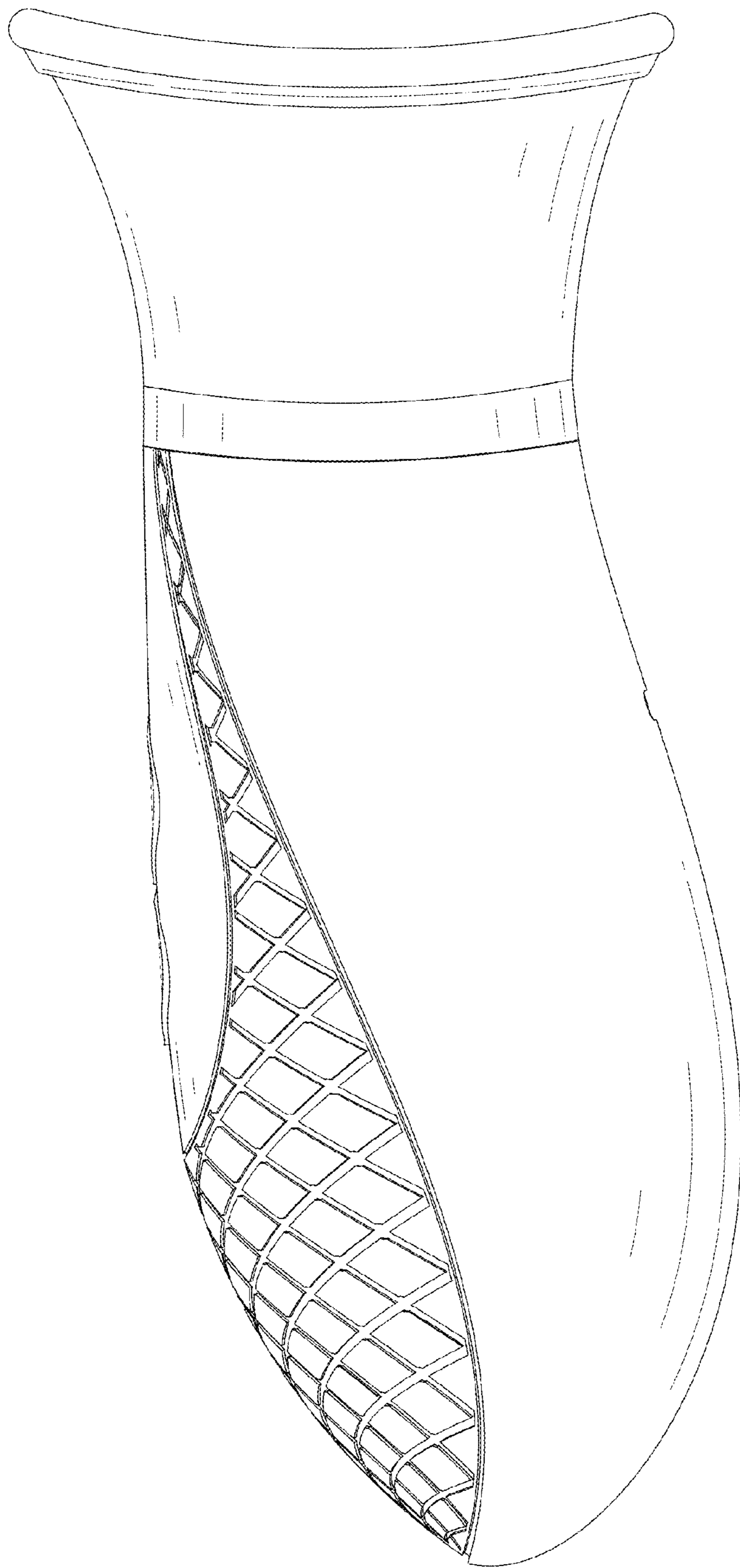

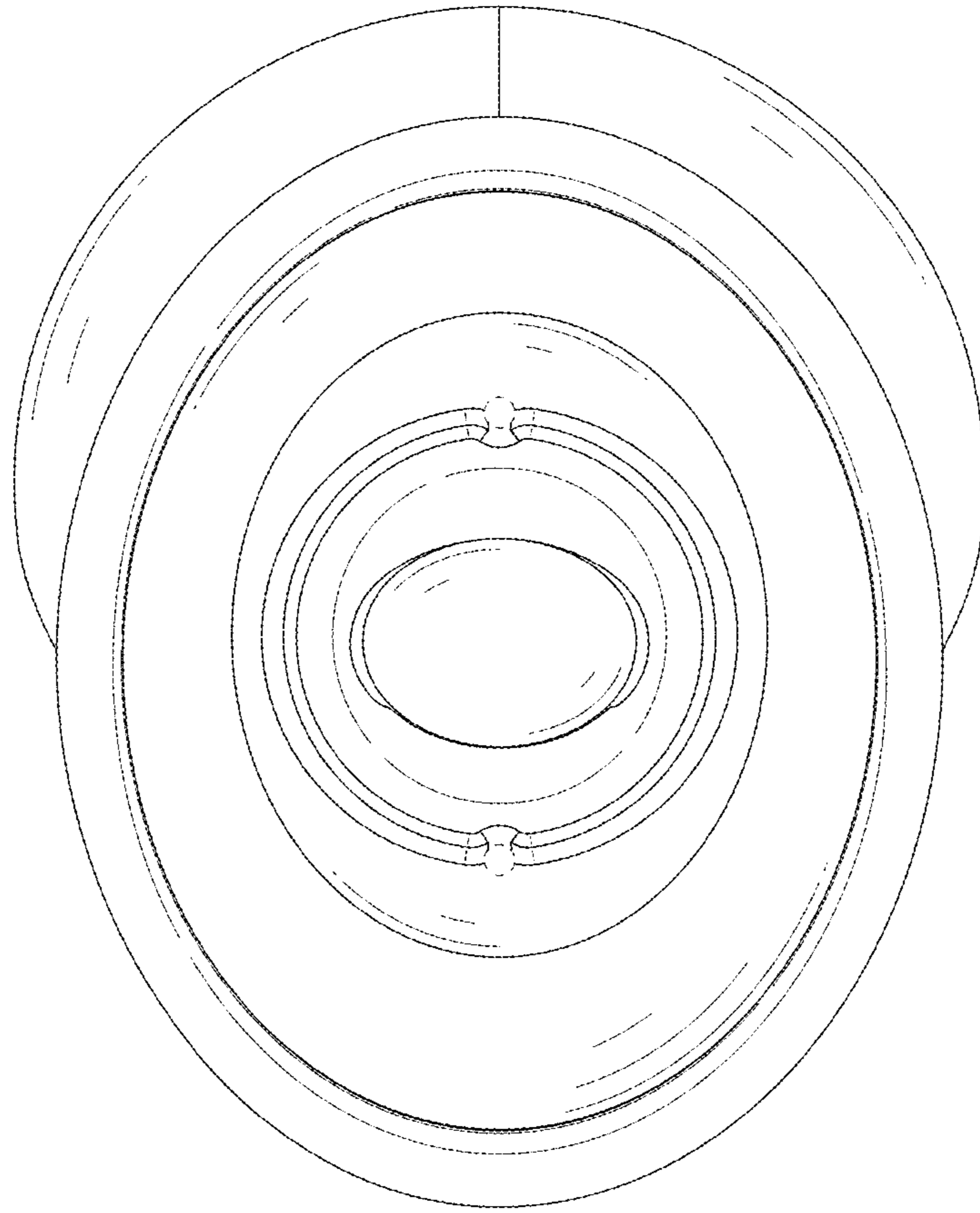

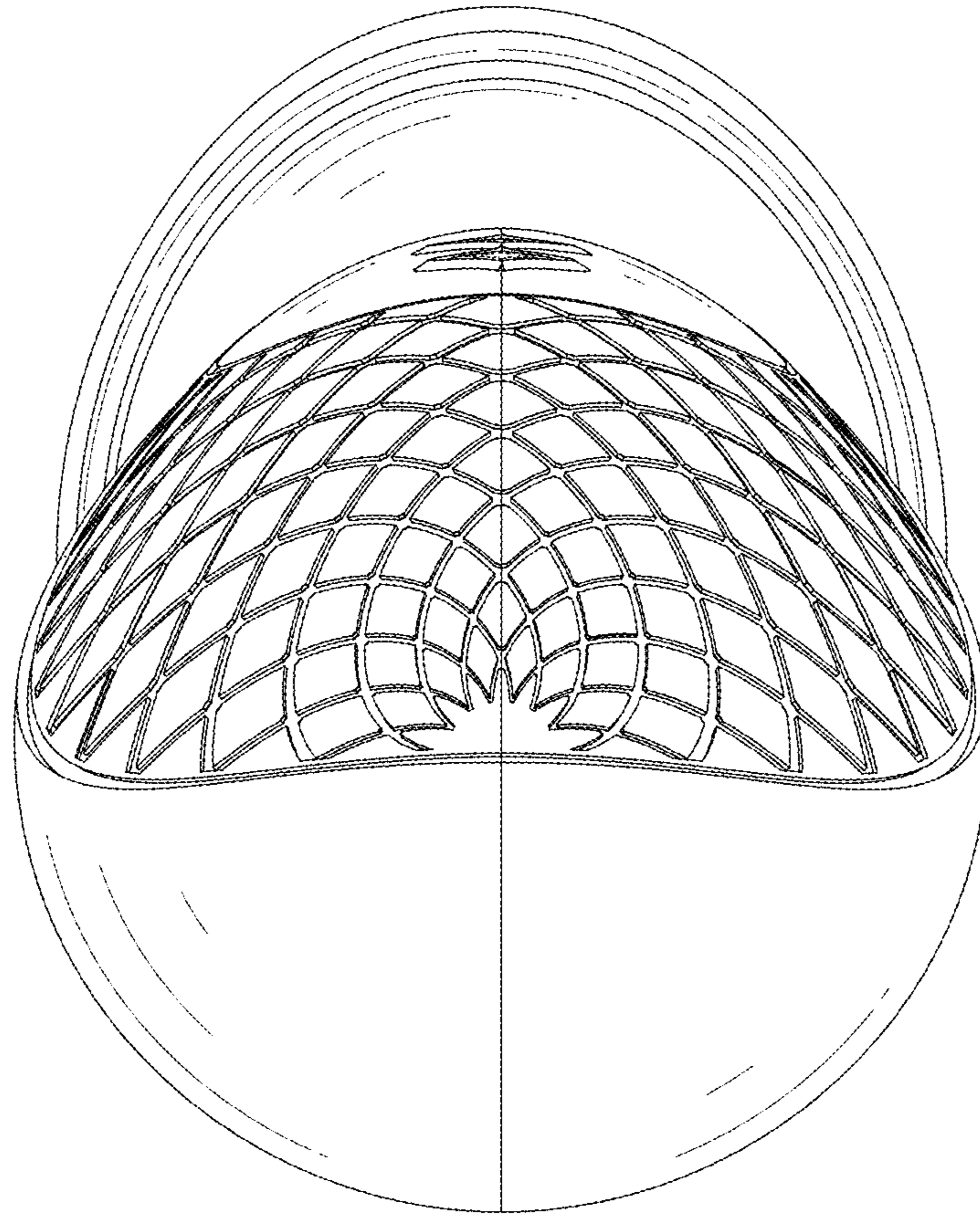
