(57) **CLAIM**

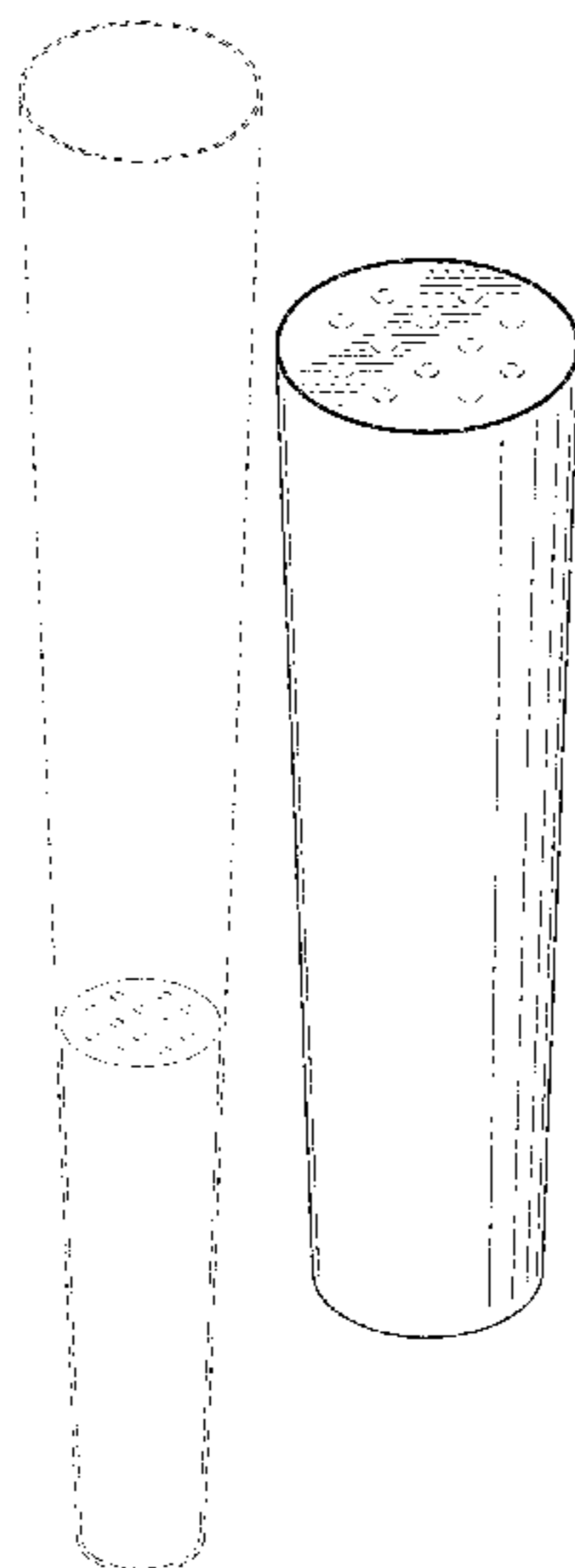
The ornamental design of the filter, as shown and described.

DESCRIPTION

FIG. 1 is a top isometric view showing the front and top of a filter;
 FIG. 2 is a bottom isometric view showing the front and bottom of the filter;
 FIG. 3 is a front elevation view, with all sides having a mirror image, of the filter;
 FIG. 4 is a top plan view of the filter;
 FIG. 5 is a bottom plan view the filter;
 FIG. 6 is an enlarged detailed view of the portion of the filter encircled as 12 in FIG. 2;
 FIG. 7 is a bottom isometric view showing the front and bottom of an alternative embodiment of the filter;
 FIG. 8 is a top isometric view showing the front and top of the alternative embodiment of the filter;
 FIG. 9 is a front elevation view, with all sides having a mirror image, of the alternative embodiment of the filter;
 FIG. 10 is a bottom plan view of the alternative embodiment of the filter; and,
 FIG. 11 is a top plan view of the alternative embodiment of the filter.

The broken lines in the drawings represent portions of the filter that form no part of the claimed design.

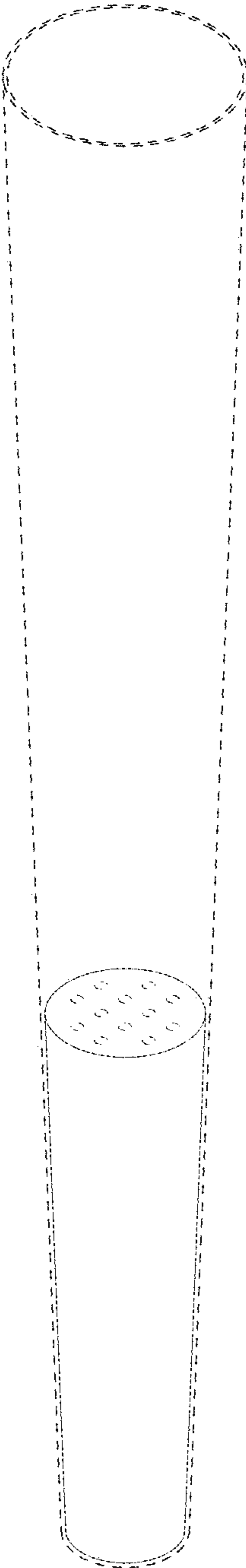

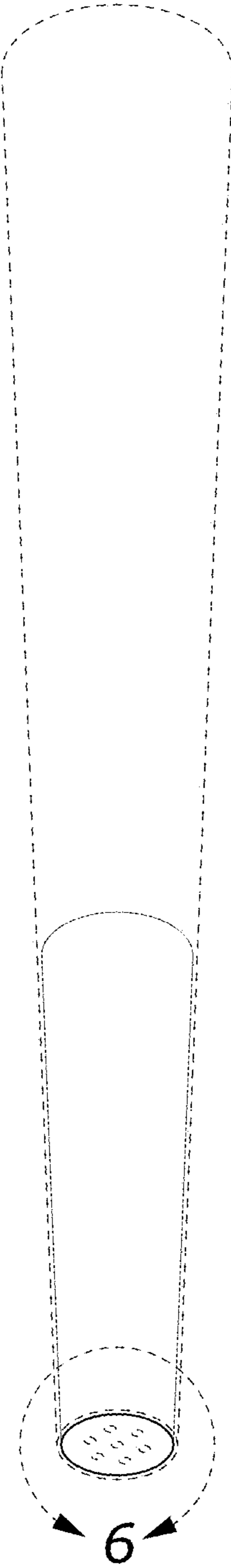

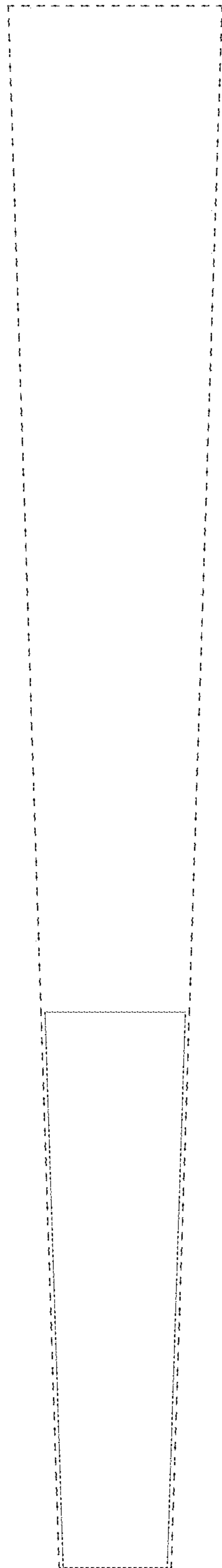

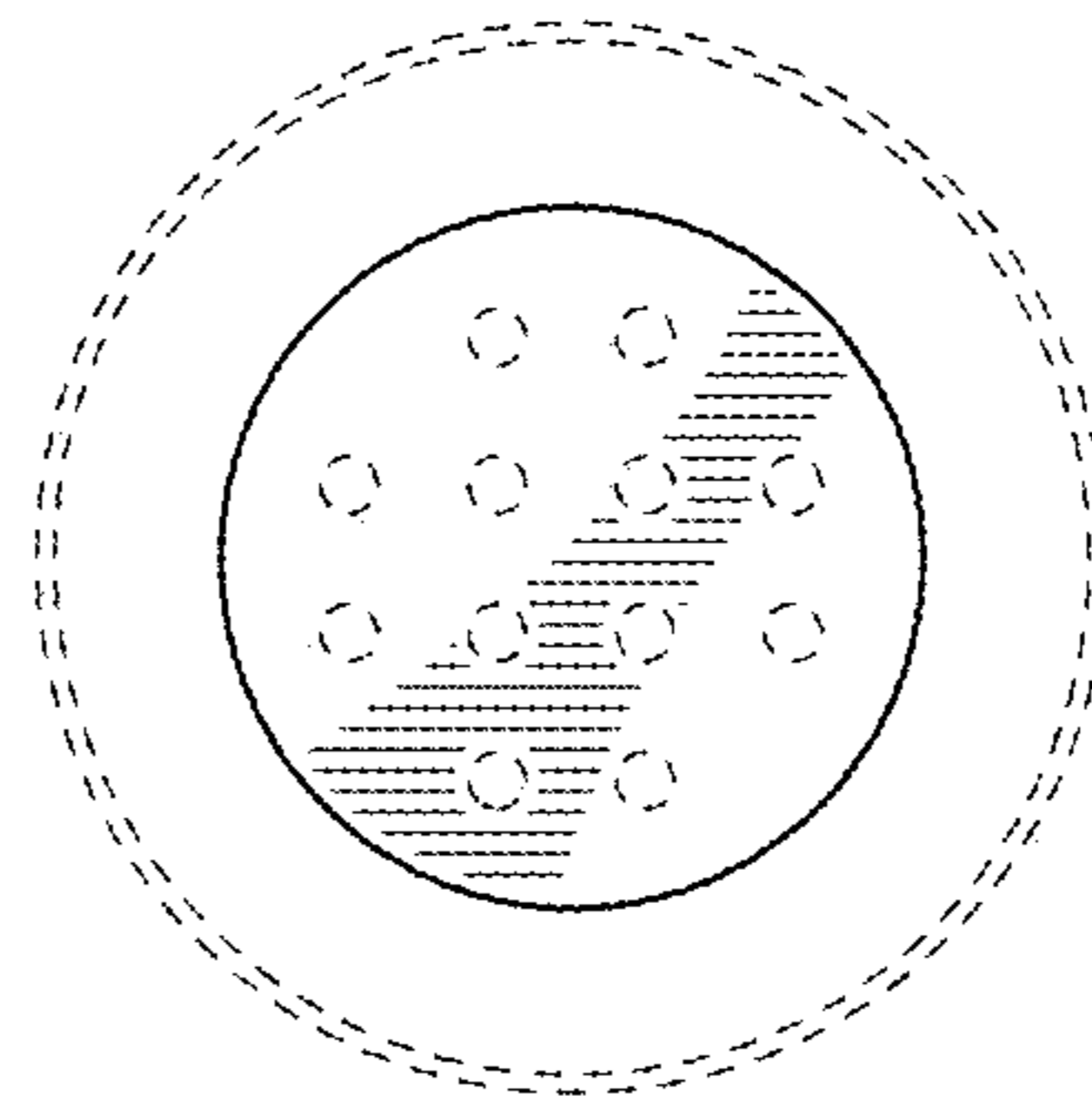

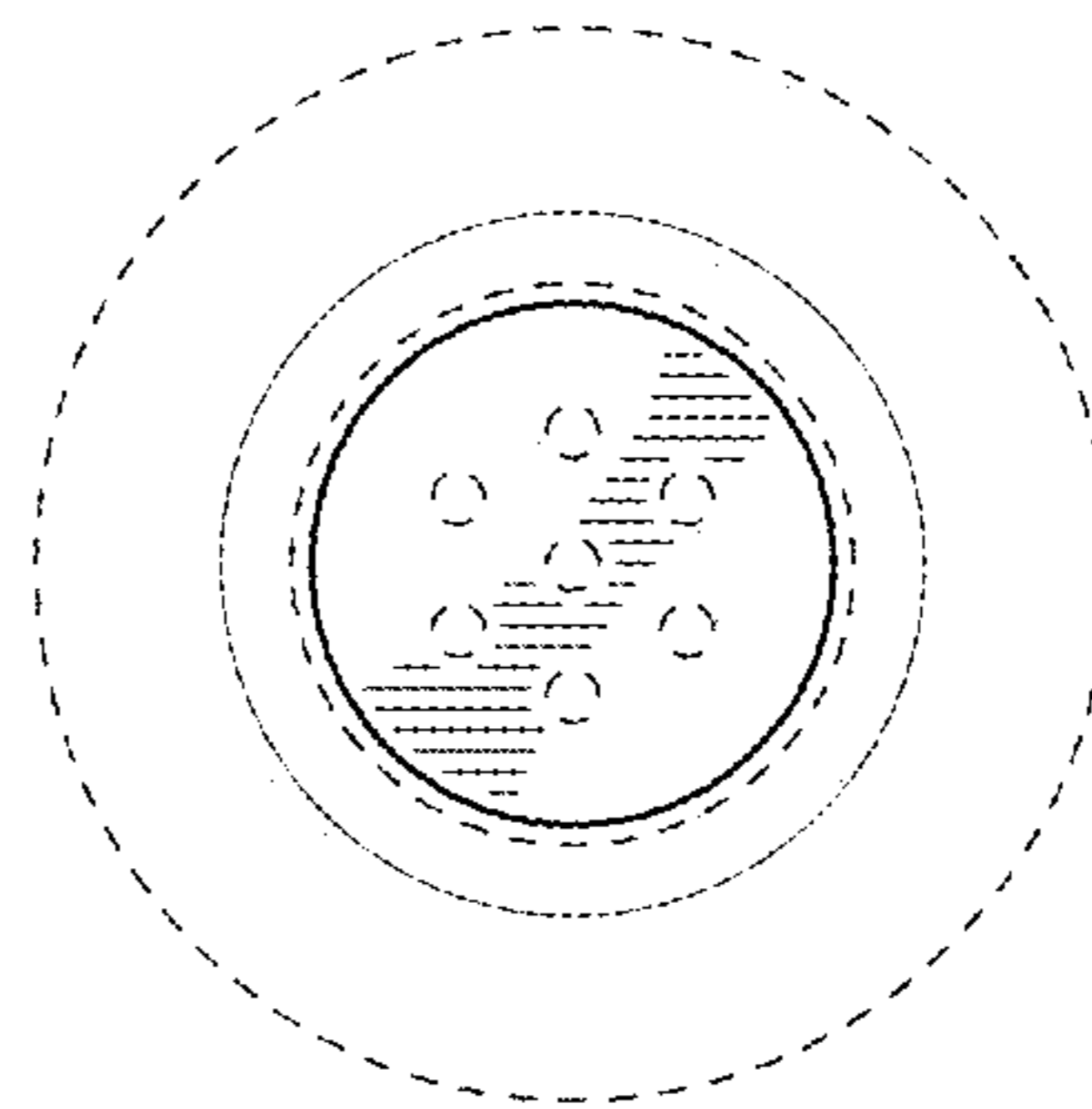

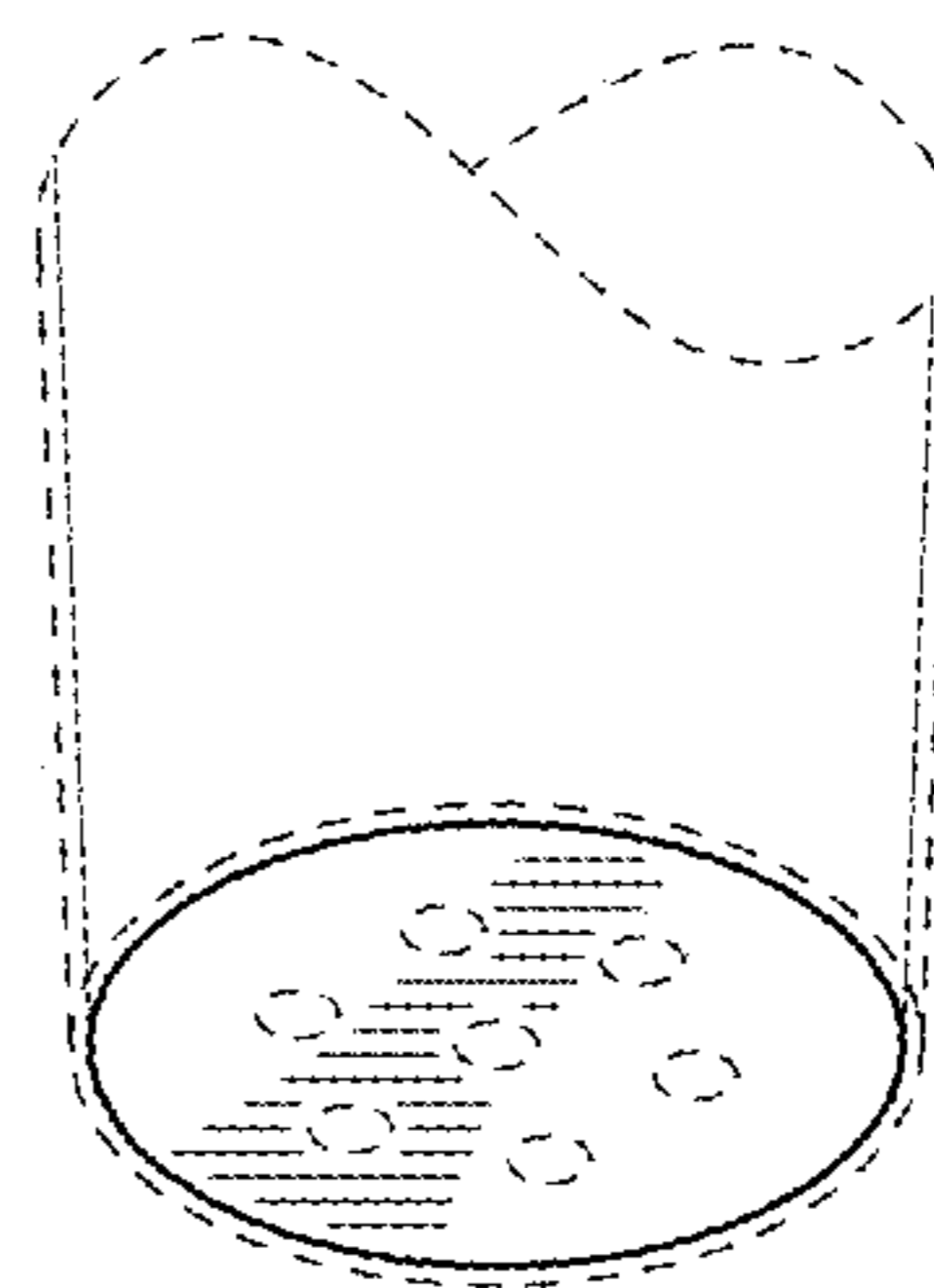

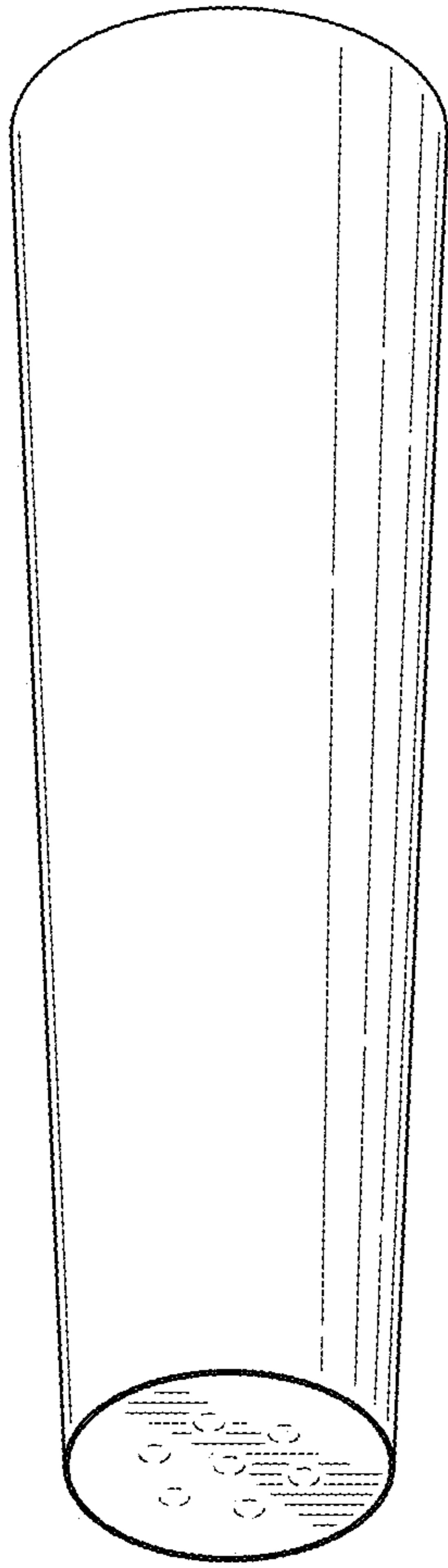

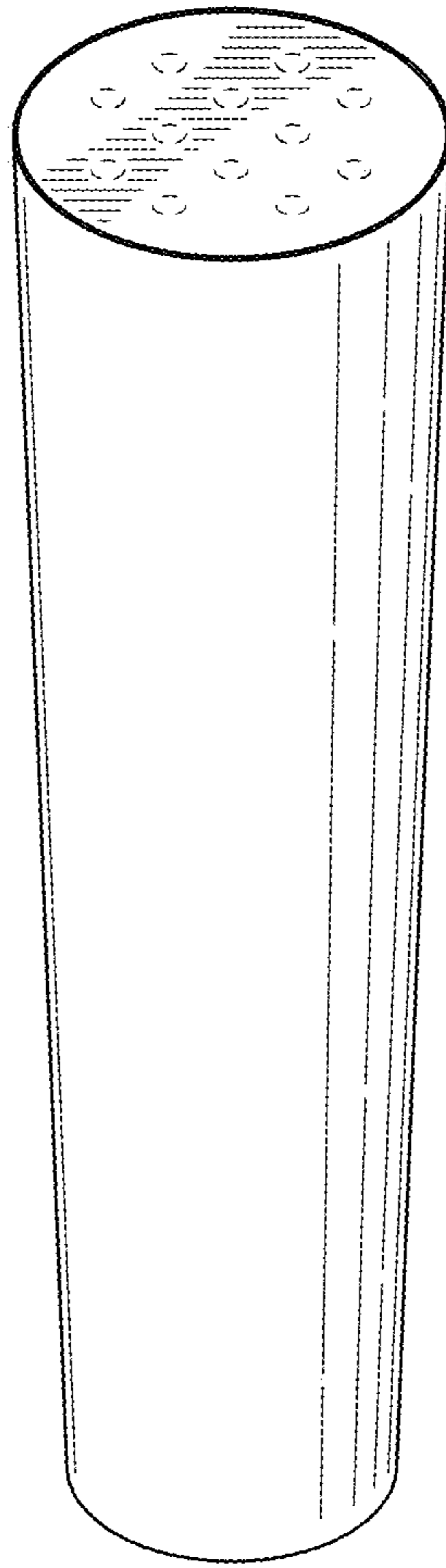

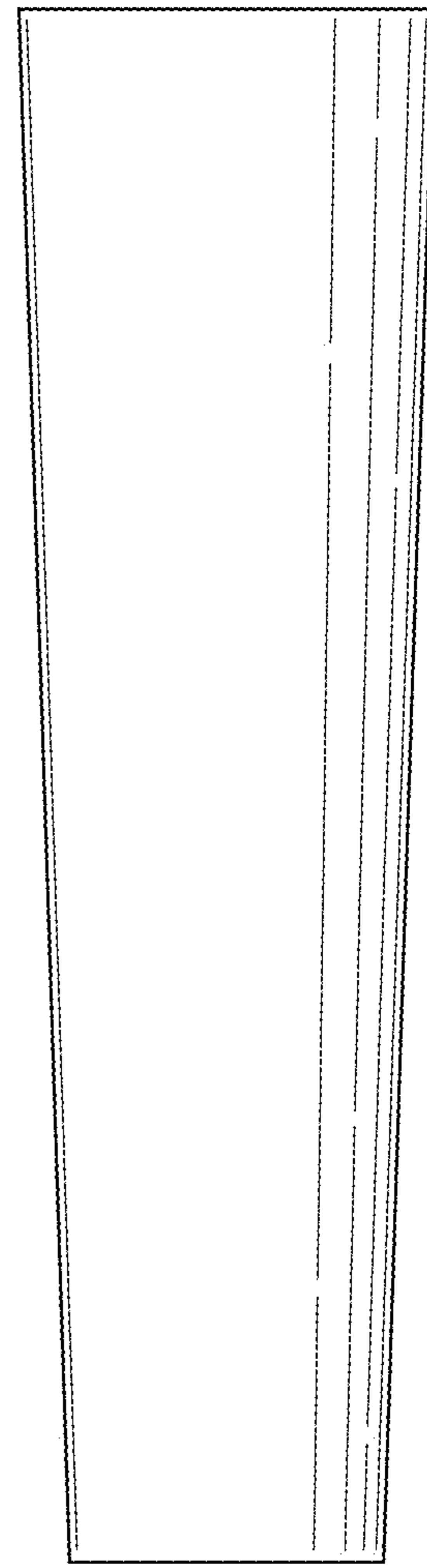

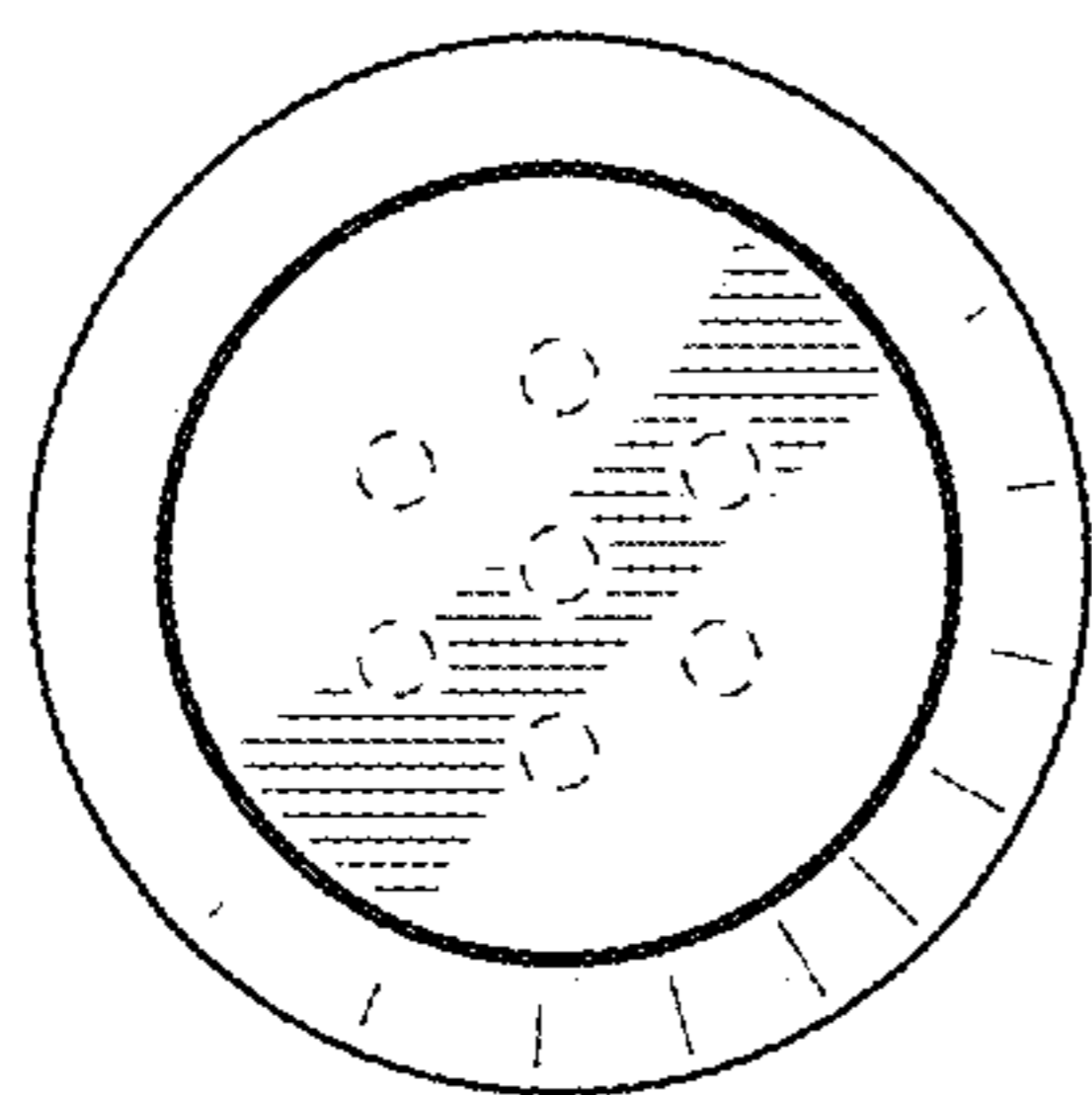

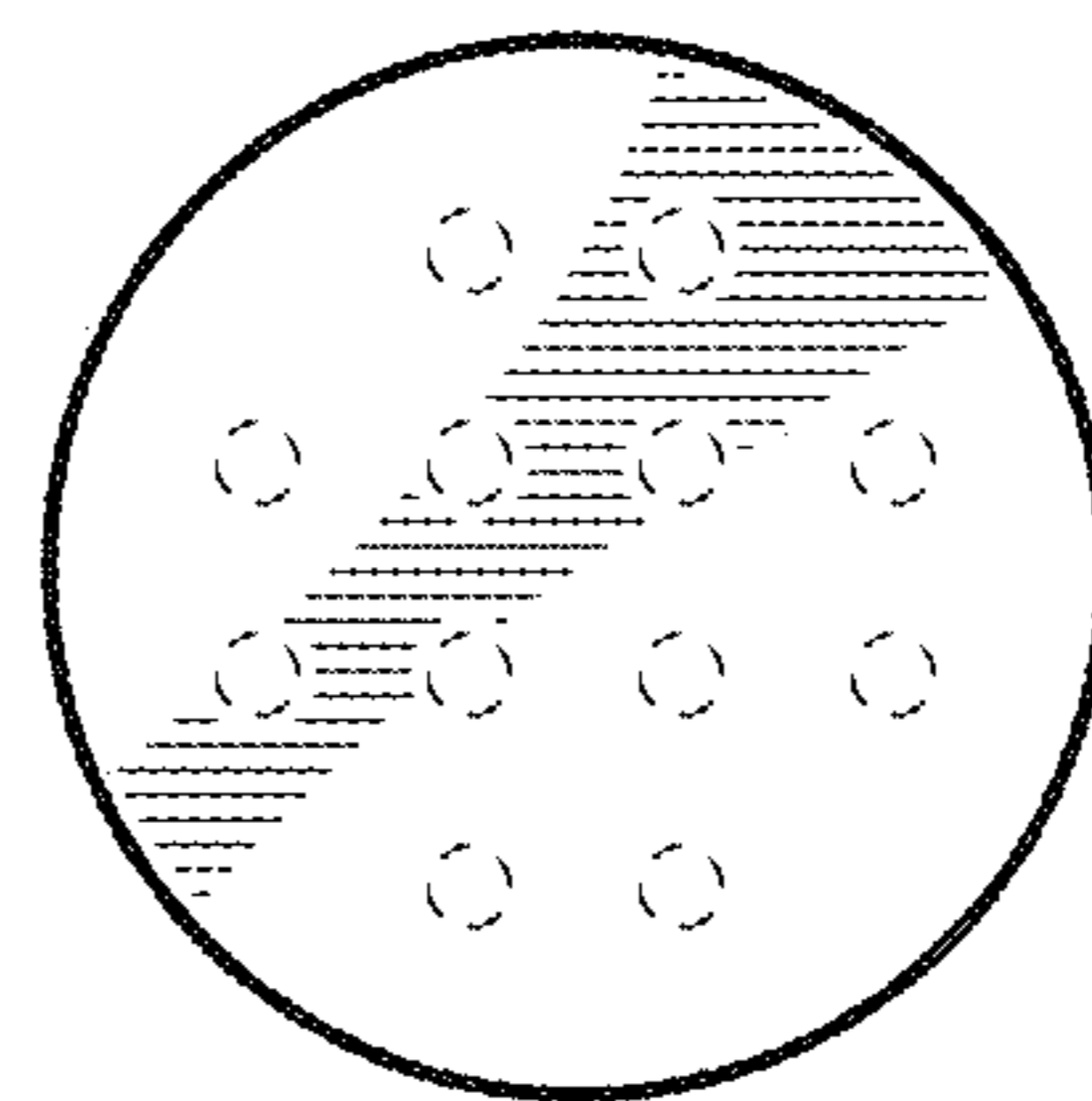
