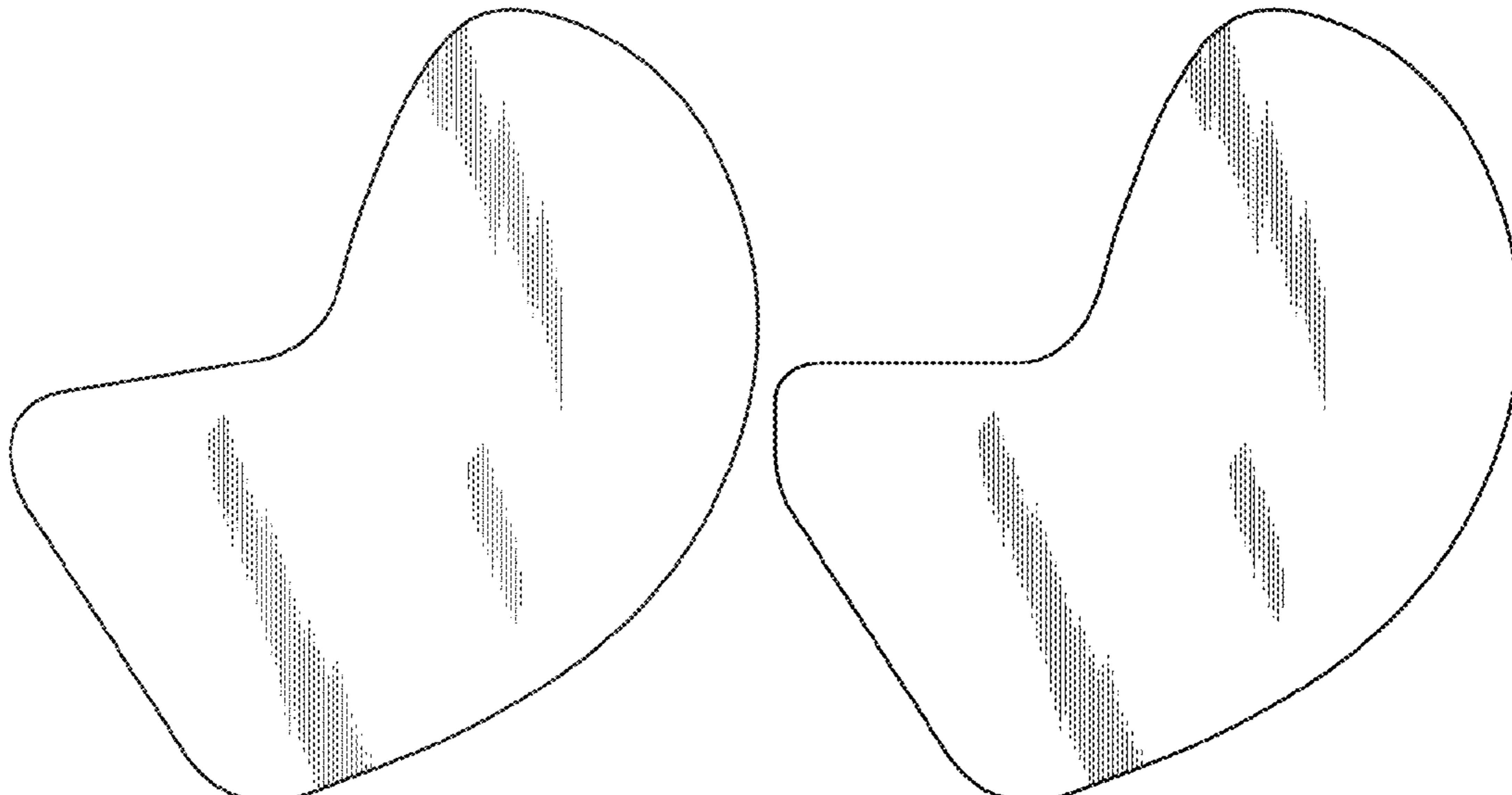
(57) **CLAIM**

The ornamental design for a cosmetic sheet, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a cosmetic sheet in accordance with a first embodiment of the present design;

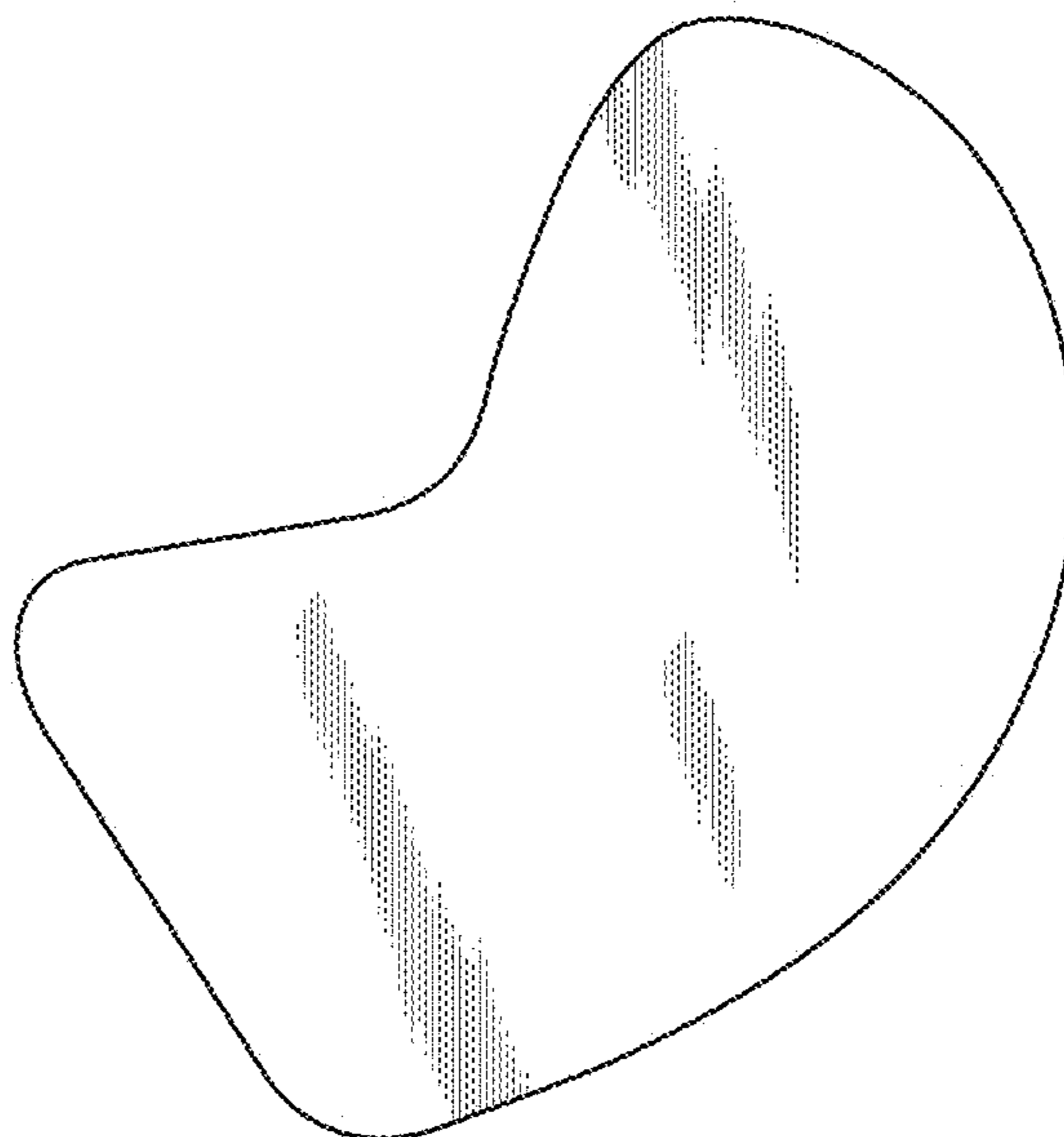

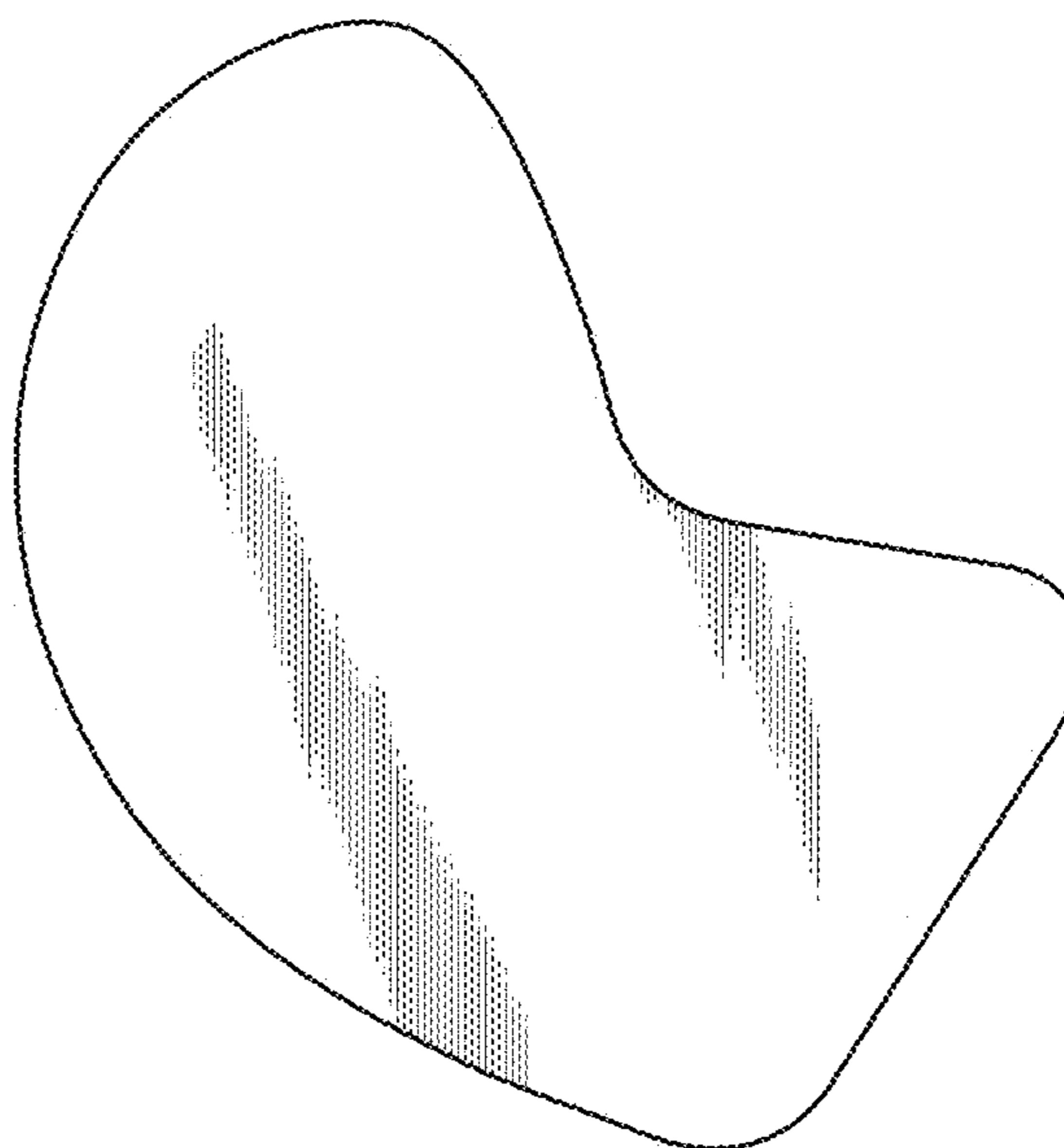

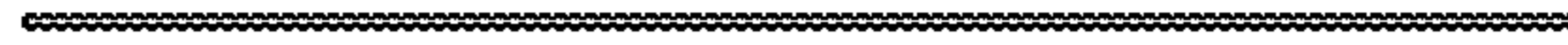

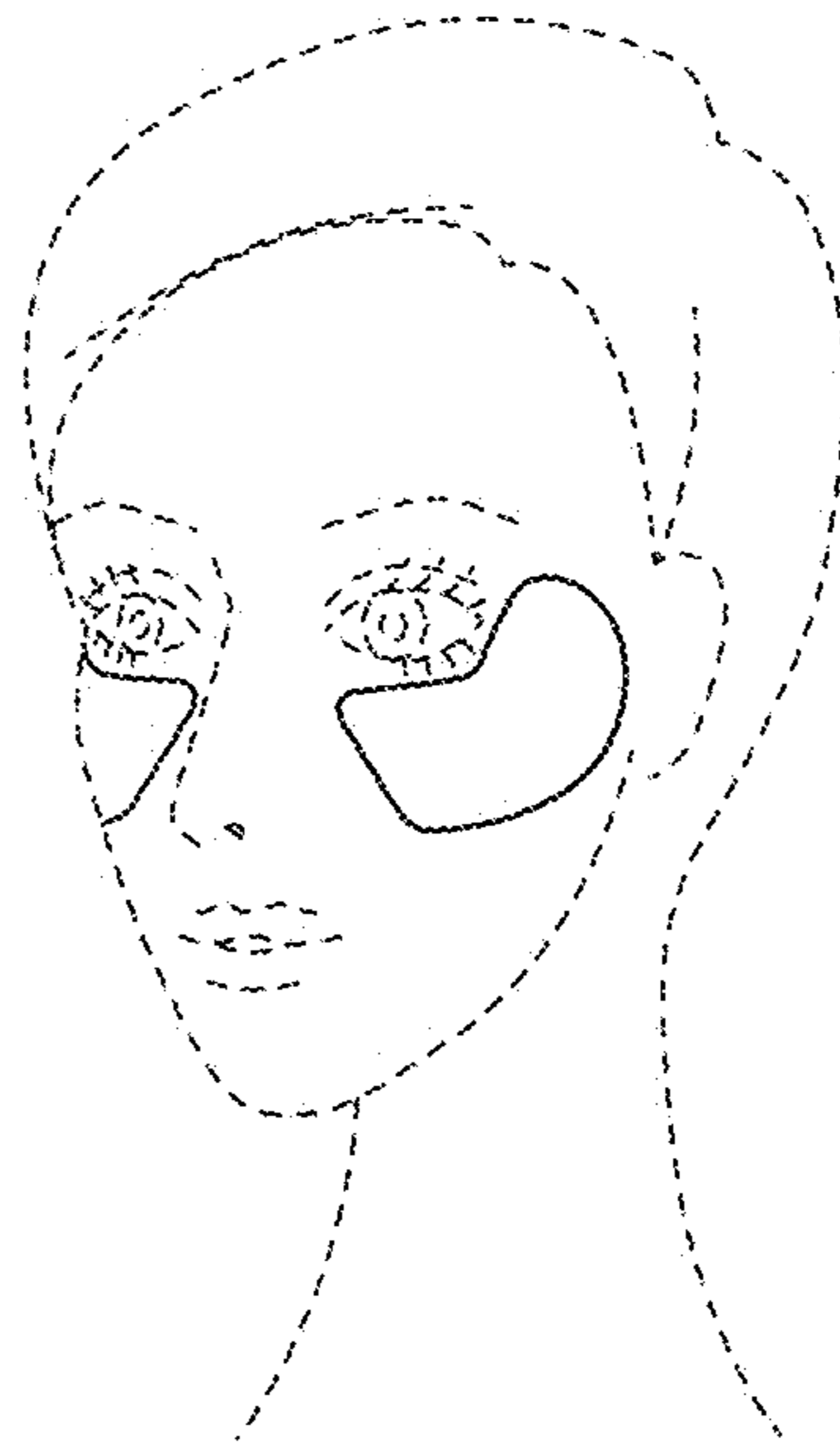

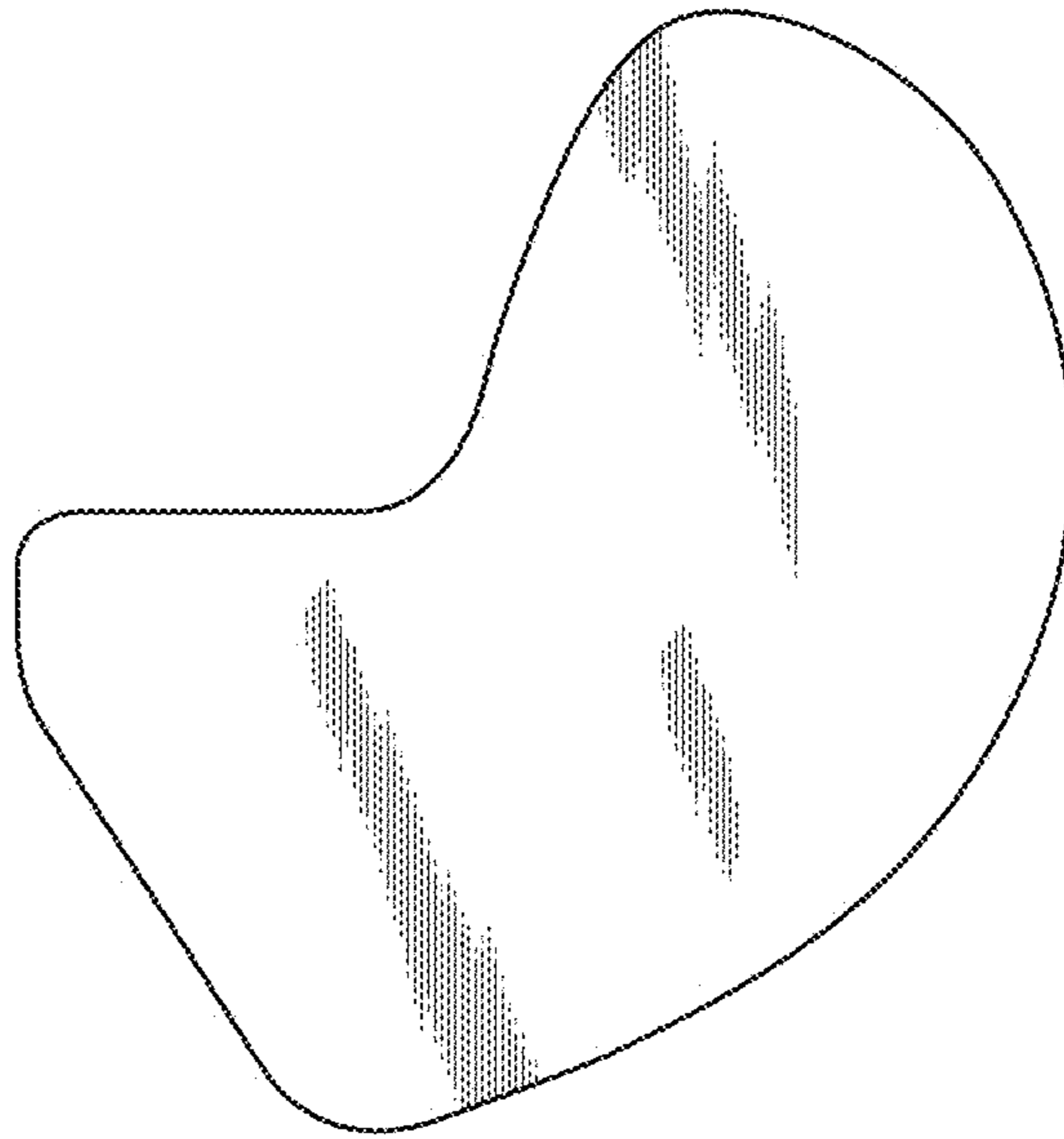

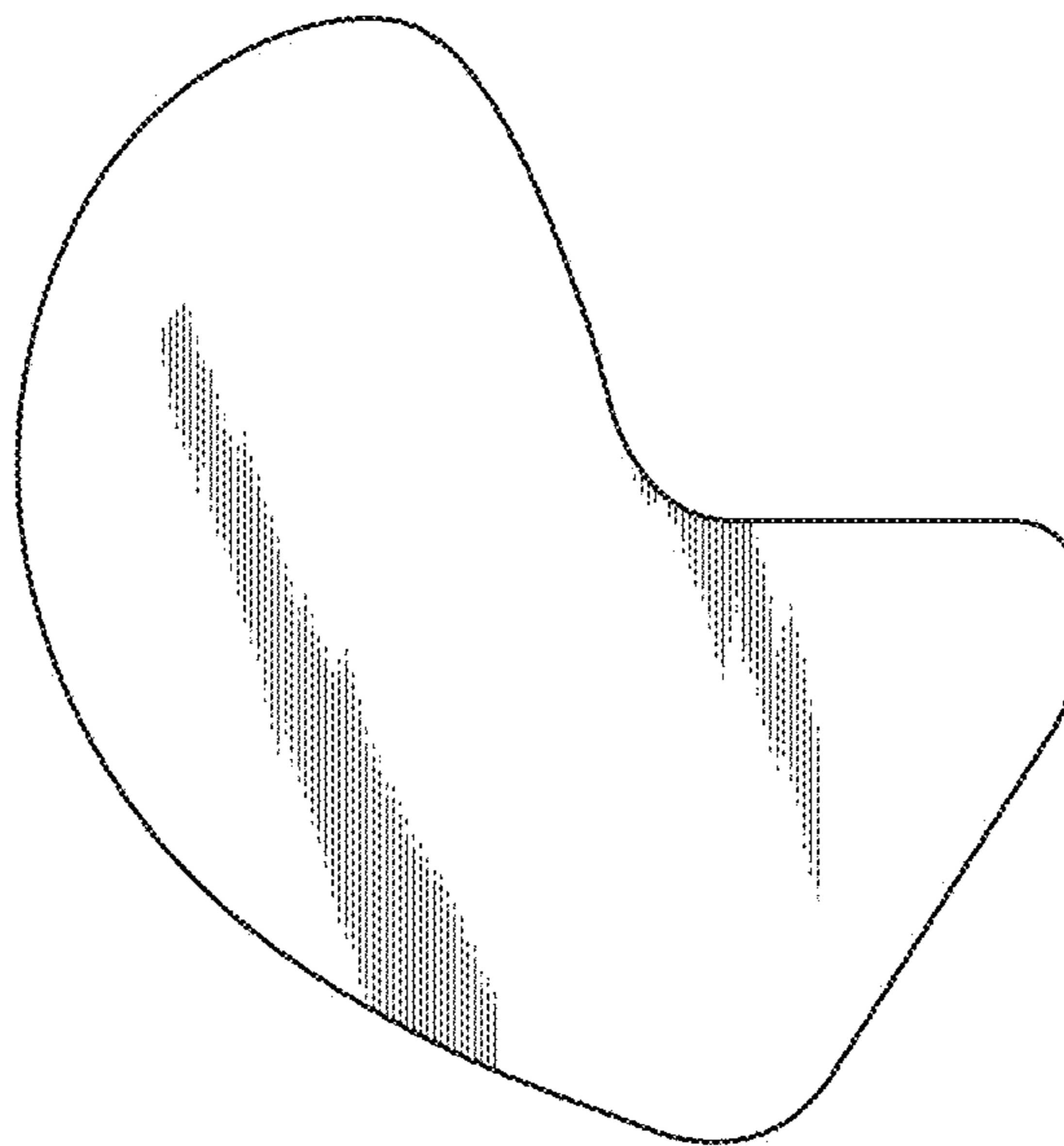
