FIG. 4 is a left side view of the footwear article.

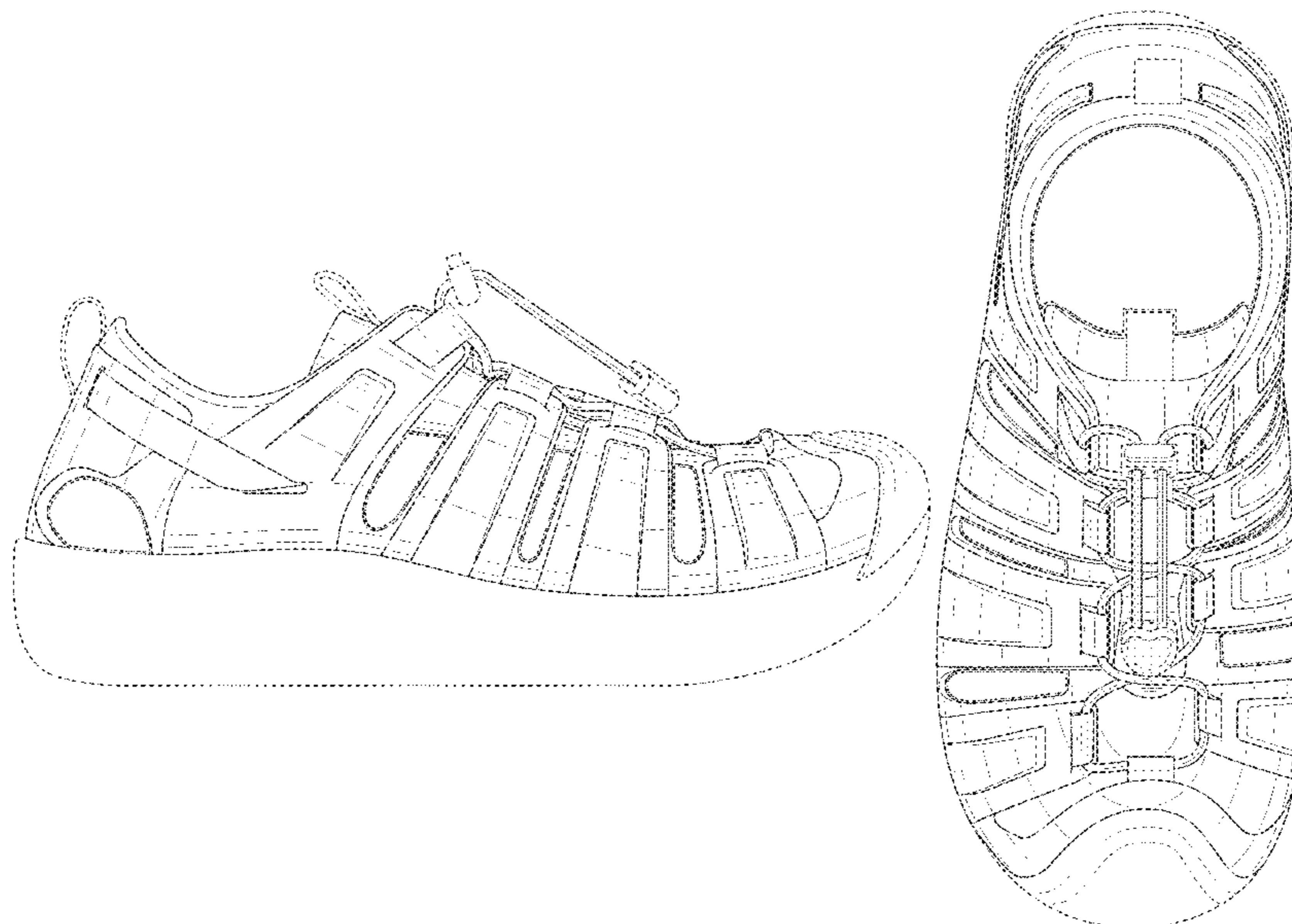
FIG. 5 is a top view of the footwear article; and,

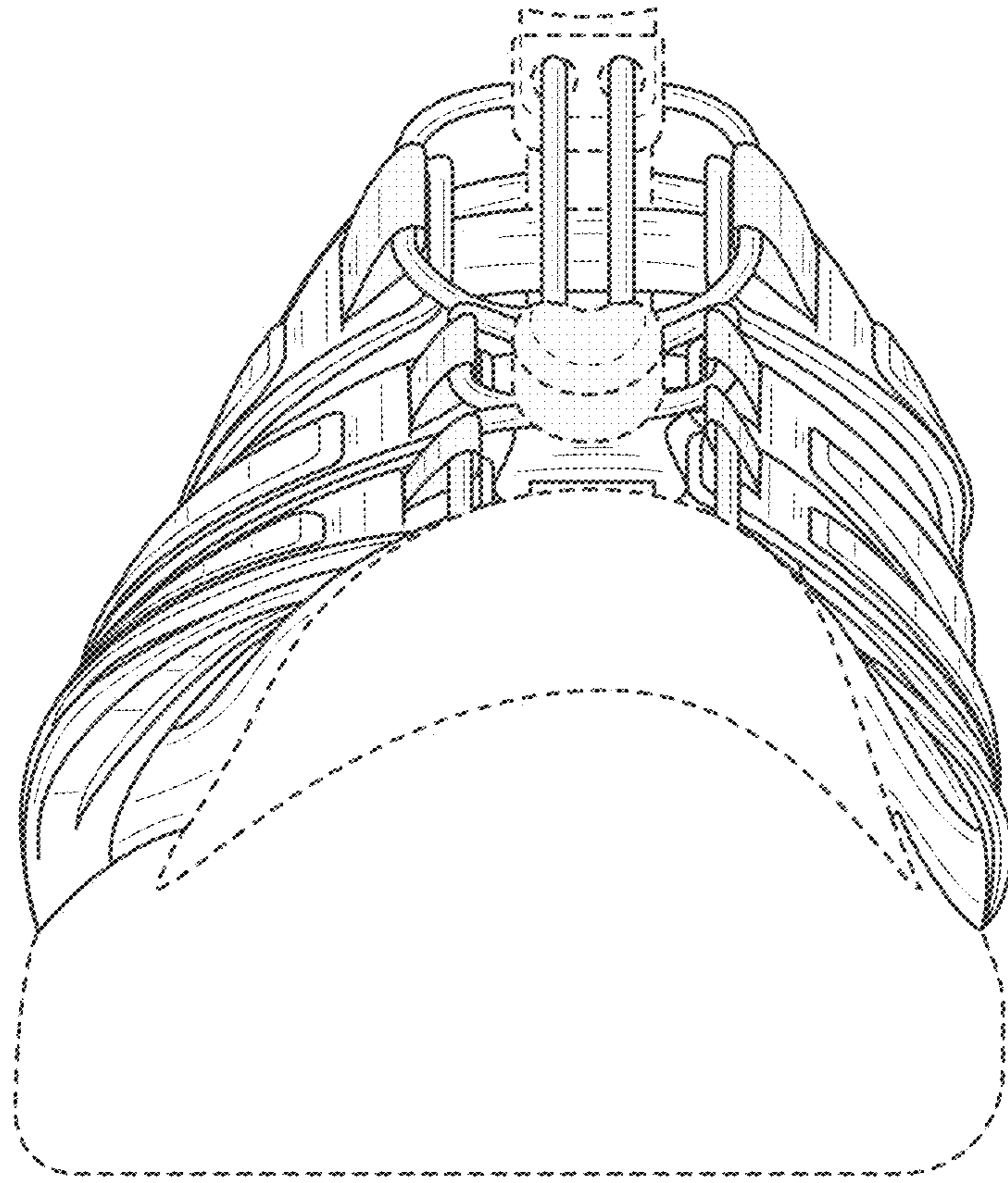

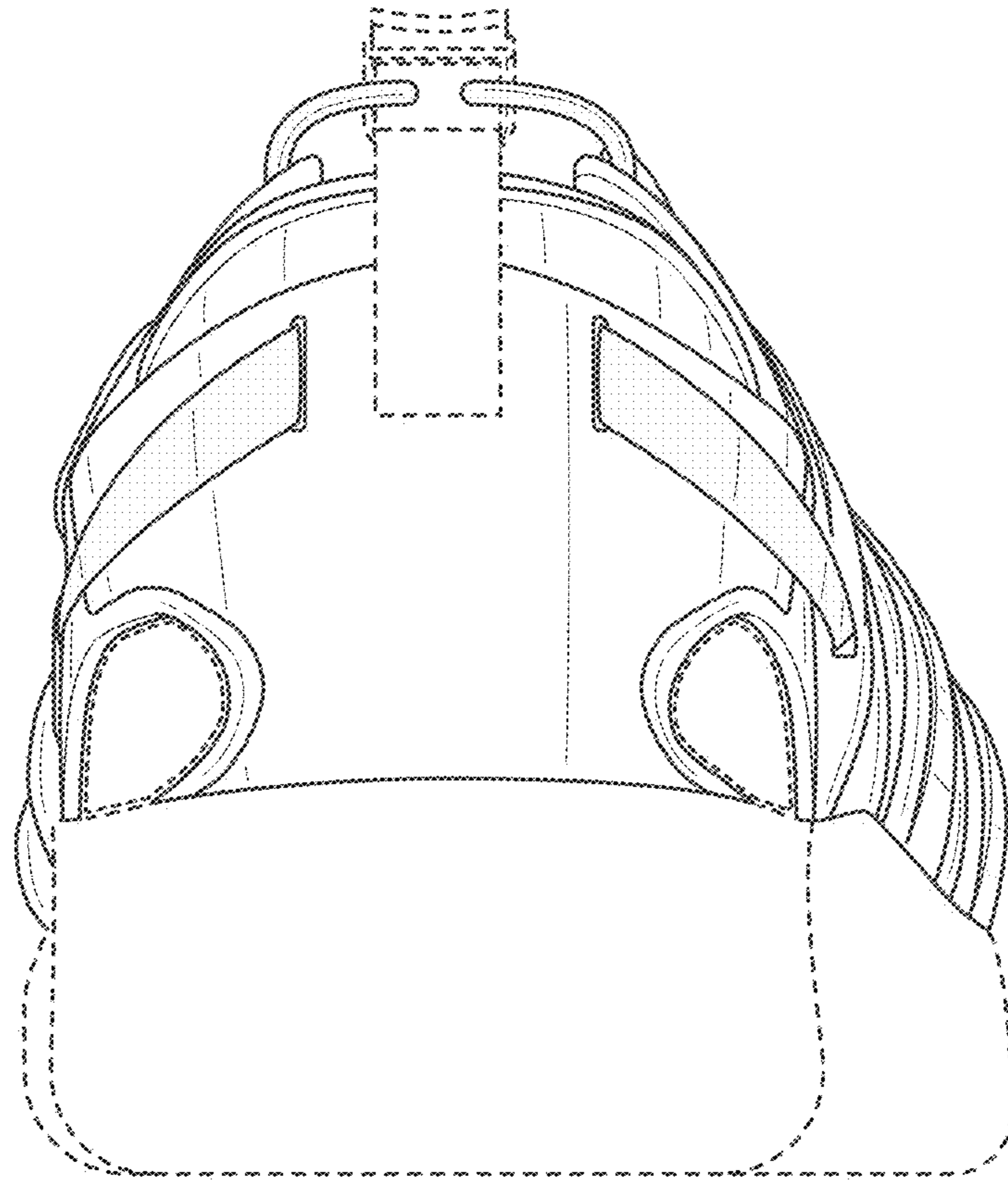

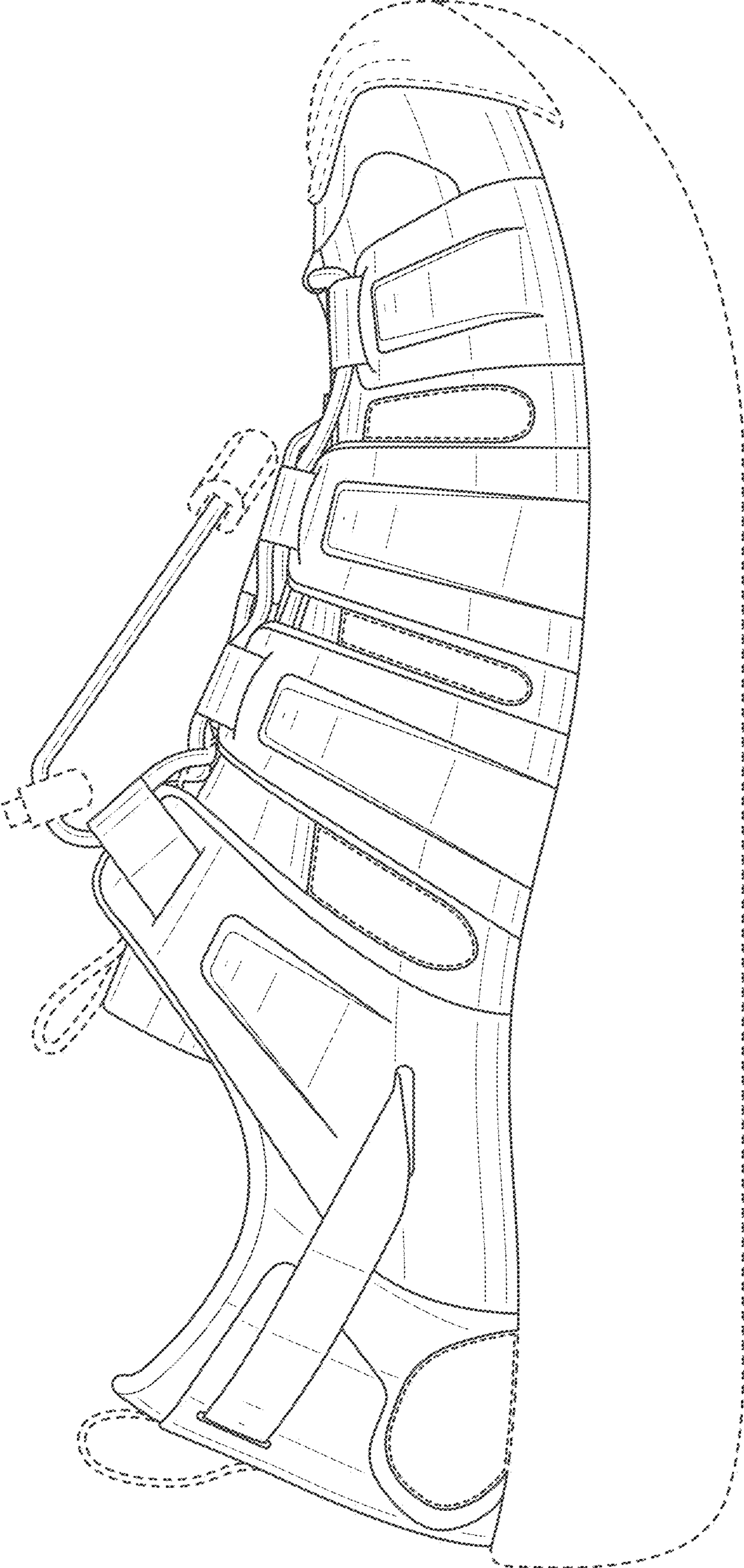

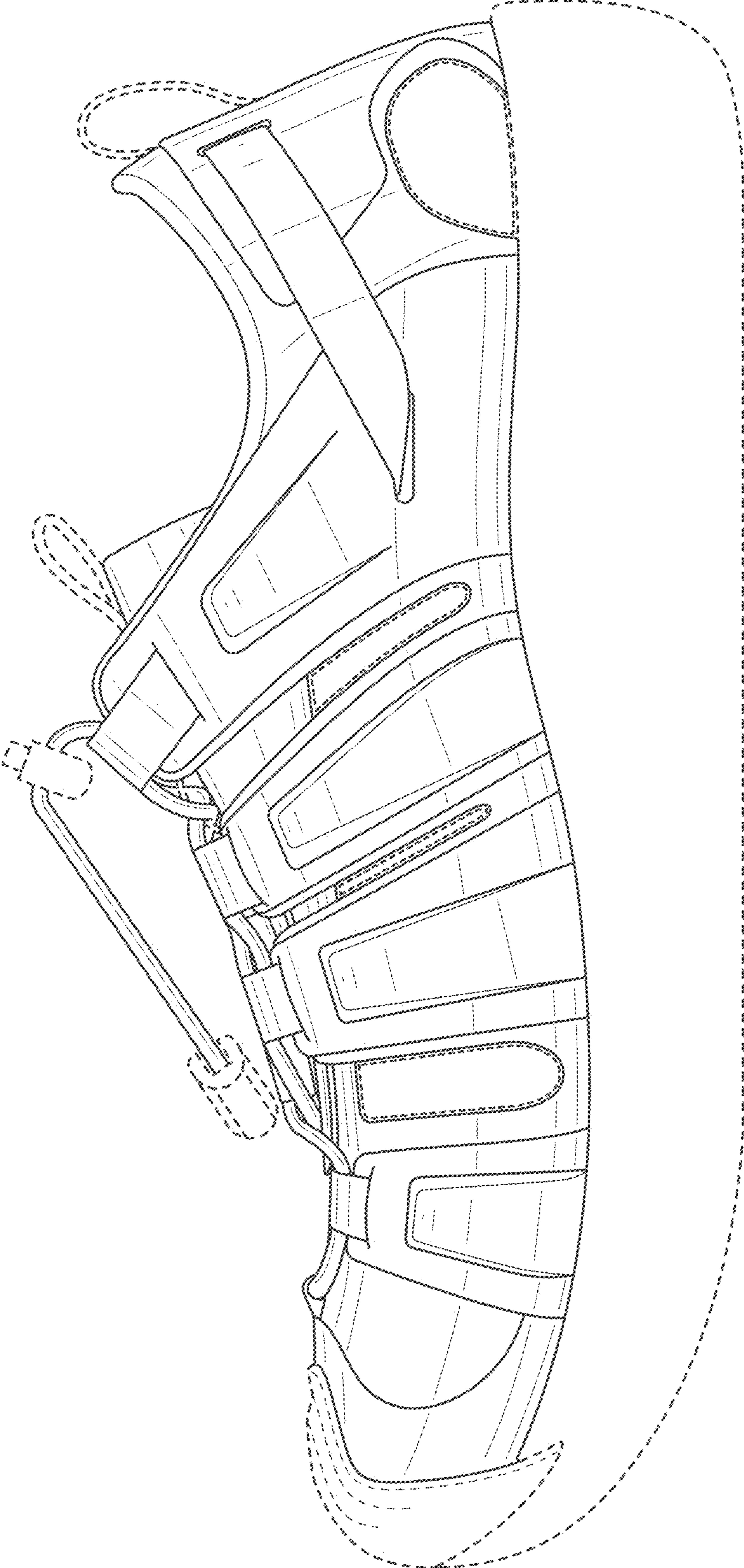

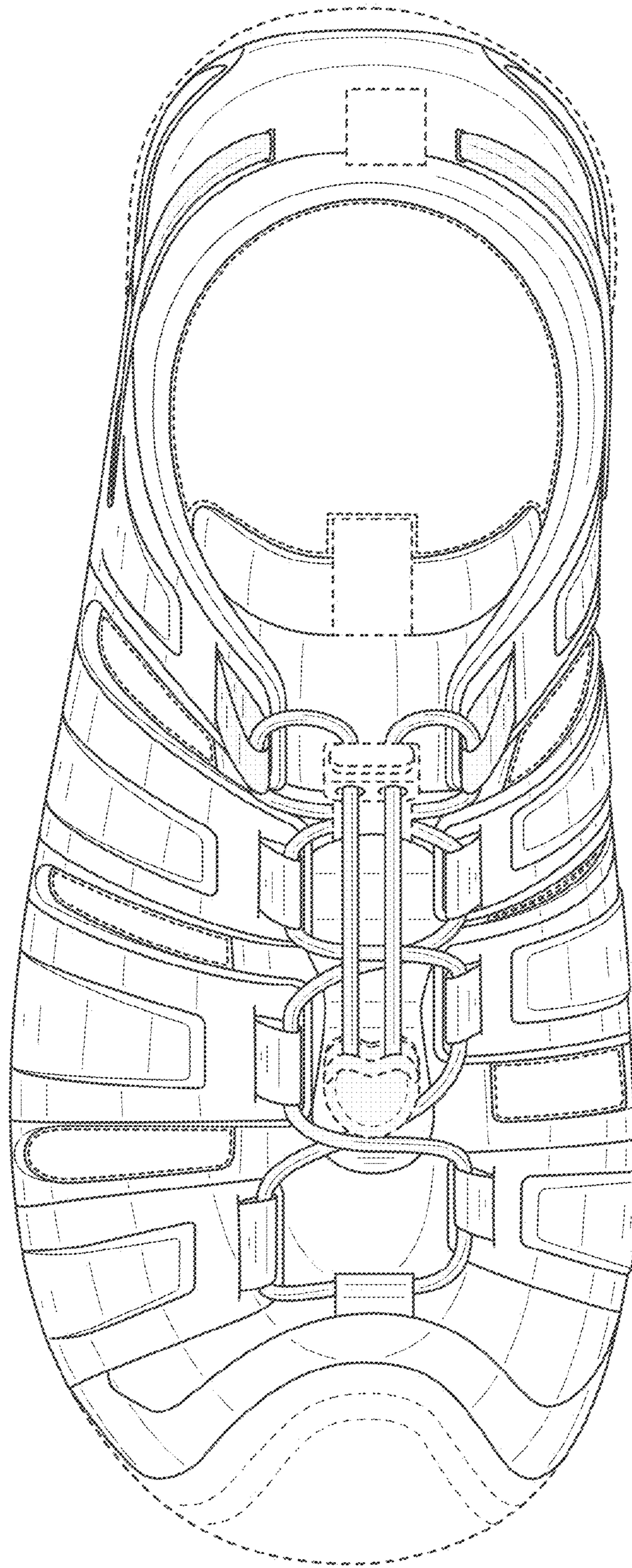

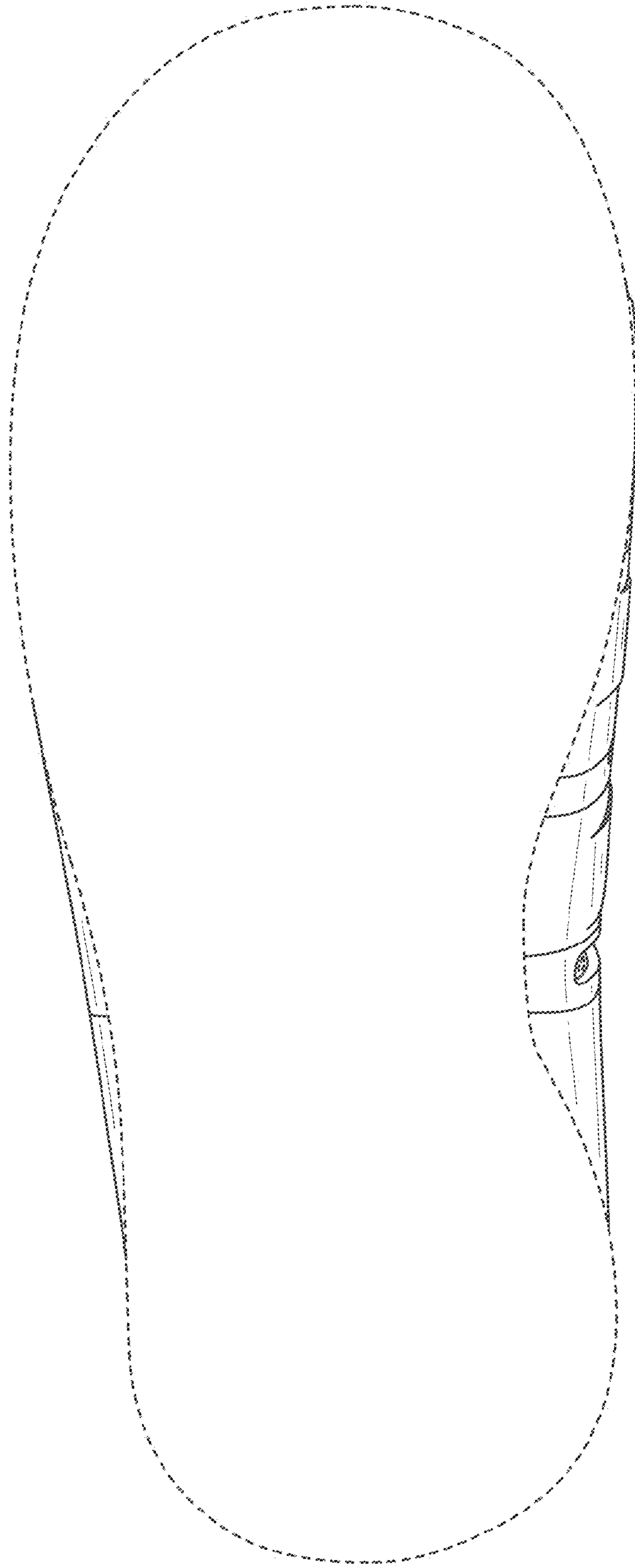
