(57) **CLAIM**

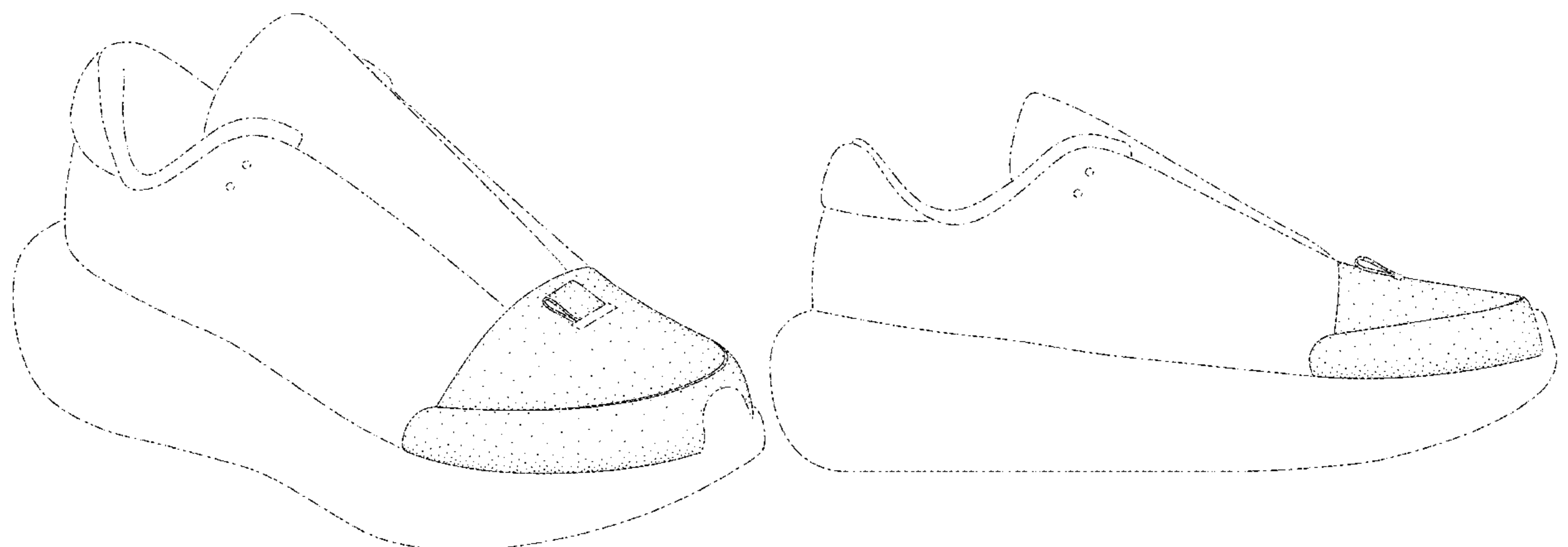
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is an opposite side view thereof; and,
FIG. 4 is an opposite side front perspective view thereof.
The broken lines immediately adjacent to the front of the shaded area define the bounds of the claimed design and form no part thereof. The broken line showing of the rectangular region within the shaded area forms no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

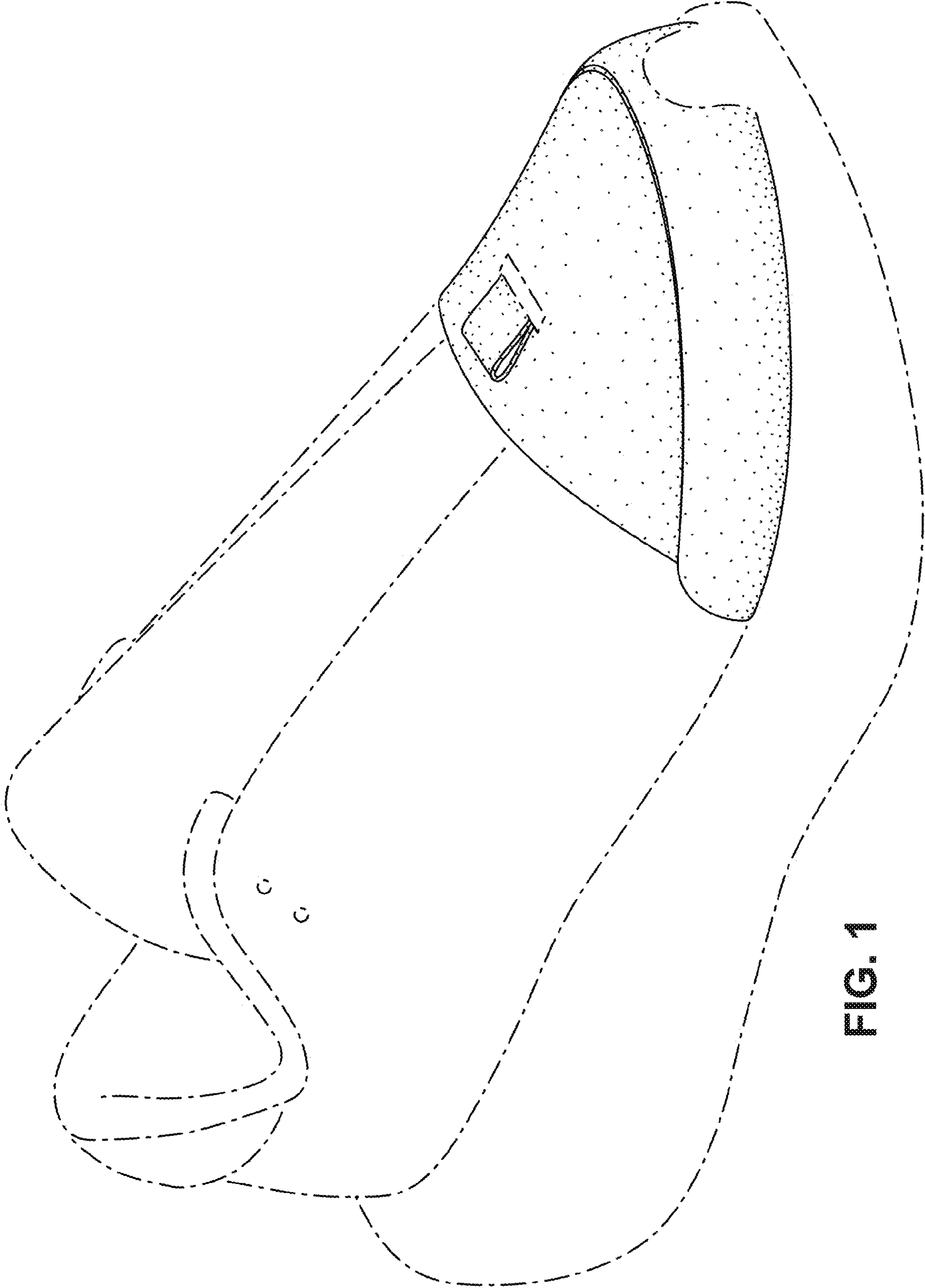

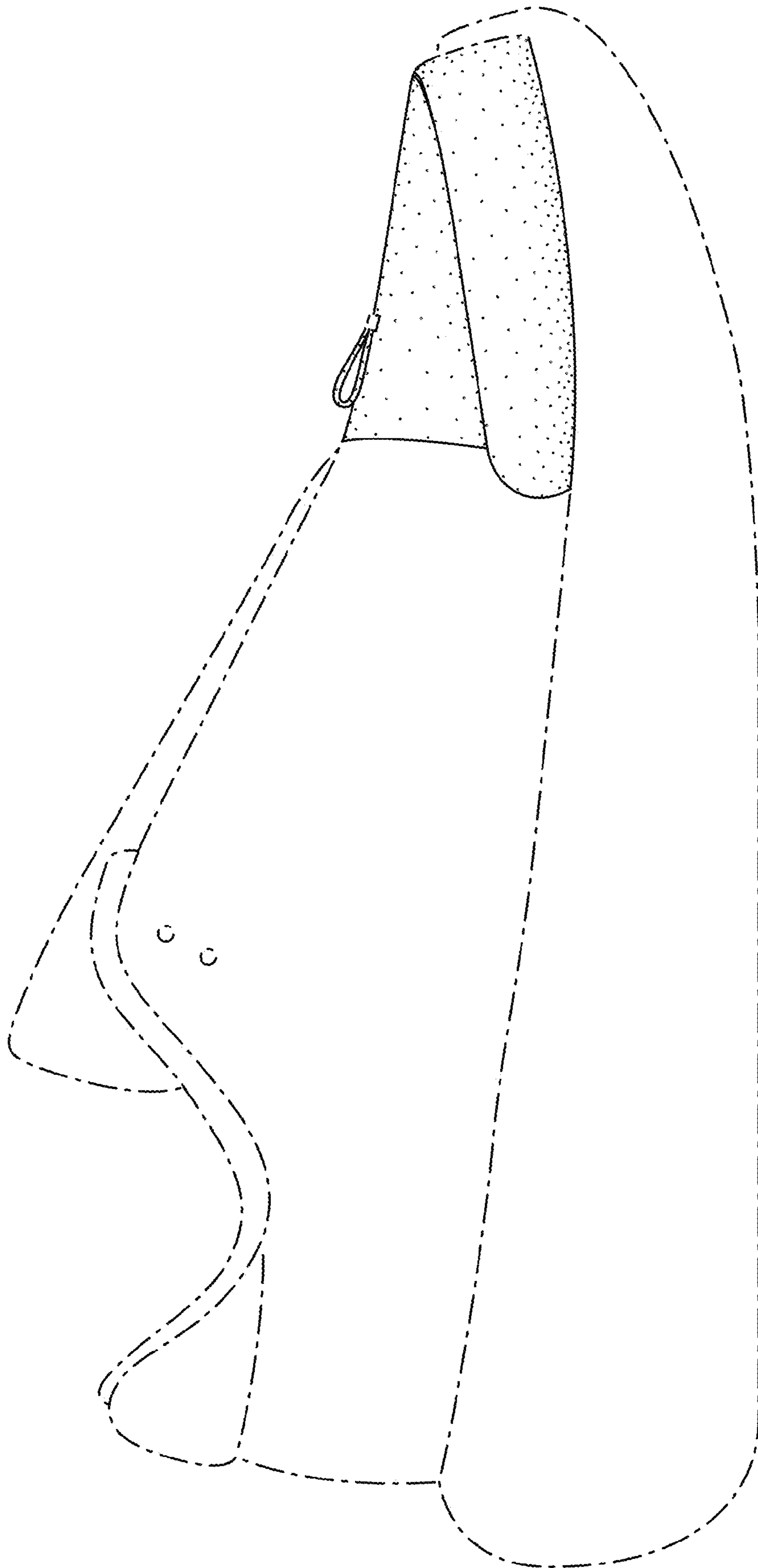

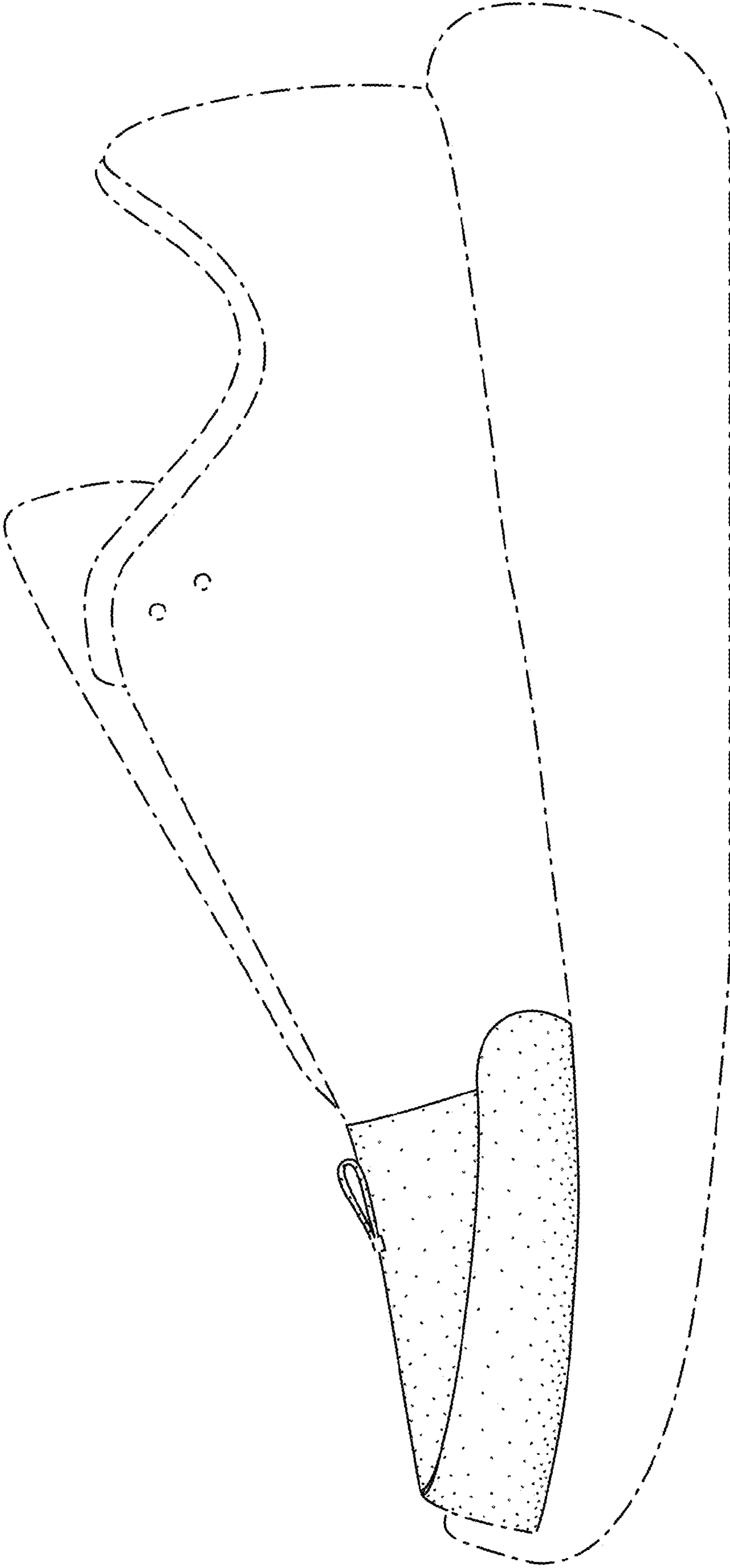

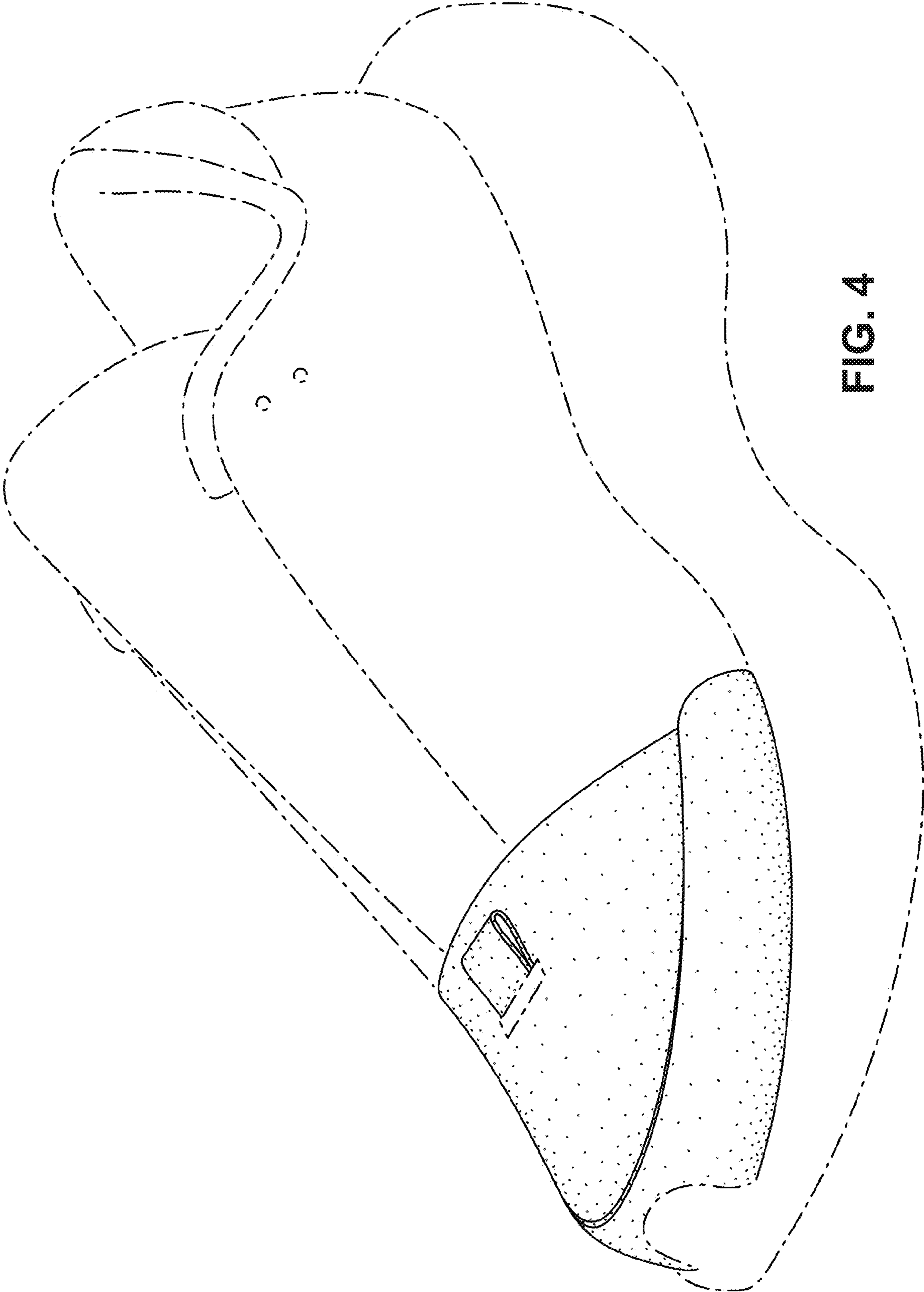
