FIG. 14 is a bottom view thereof.

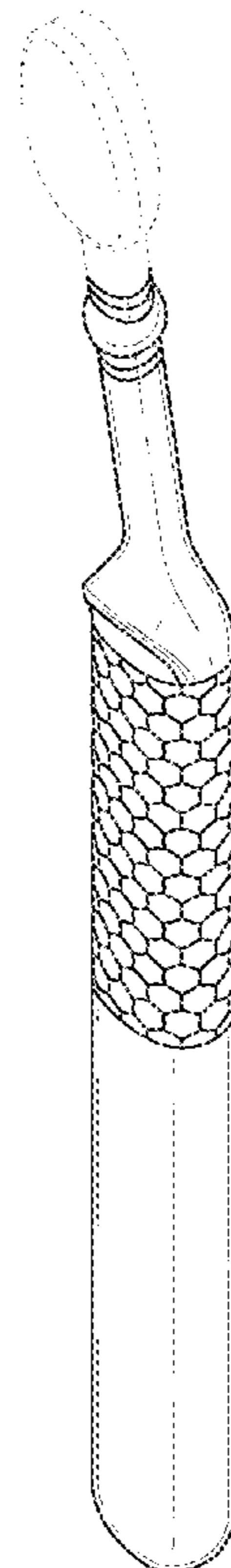
The broken lines shown in the drawings depict portions of the toothbrush handle that form no part of the claimed design.

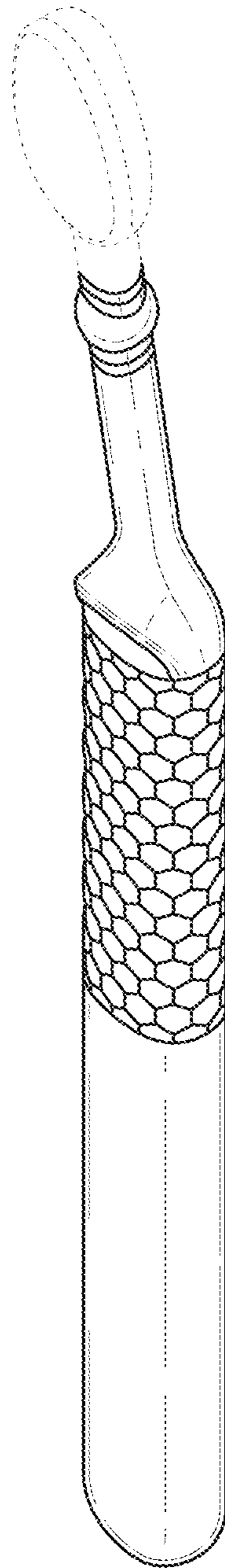

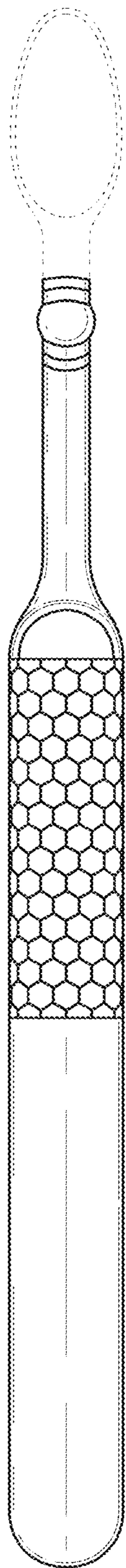

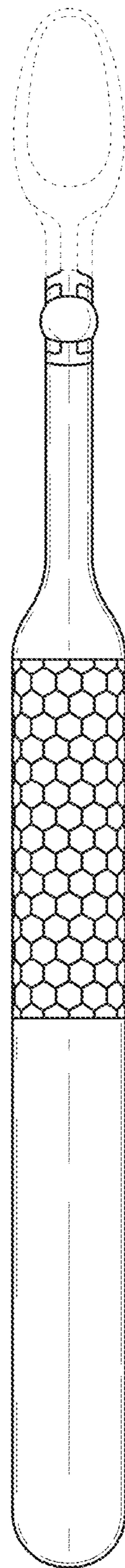

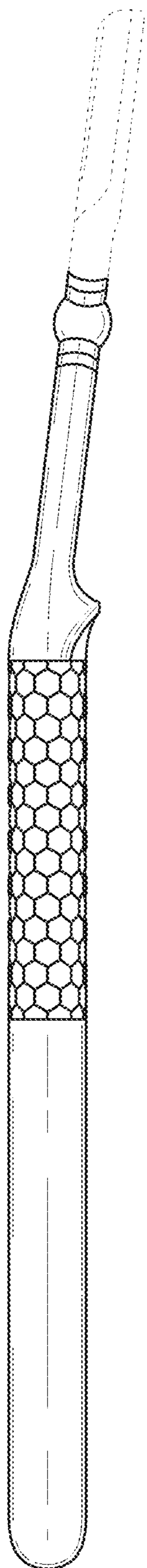

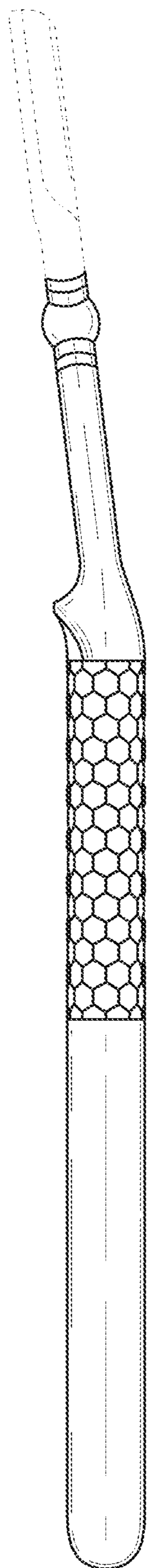

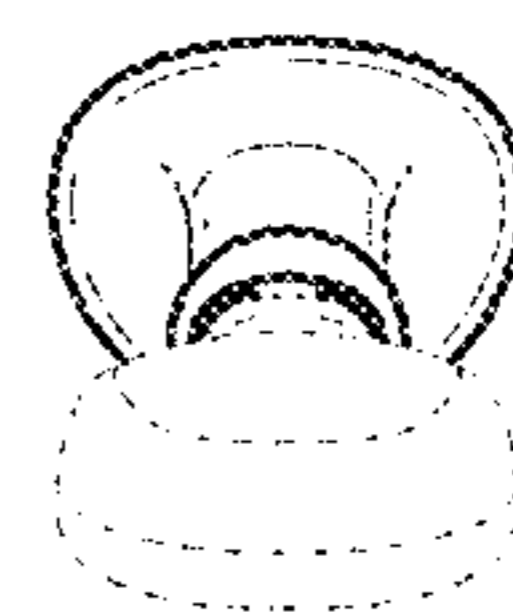

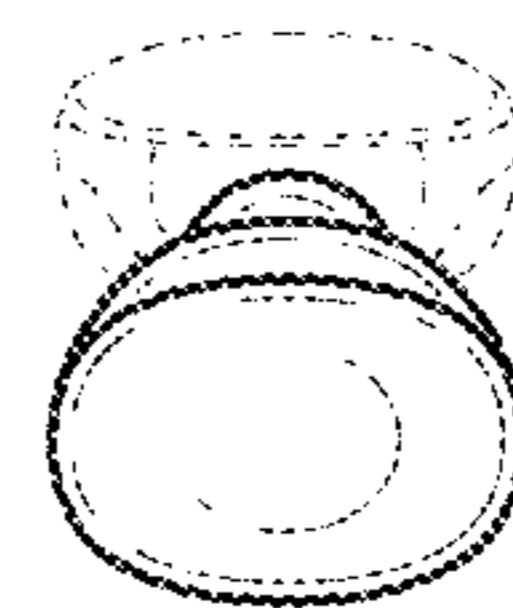

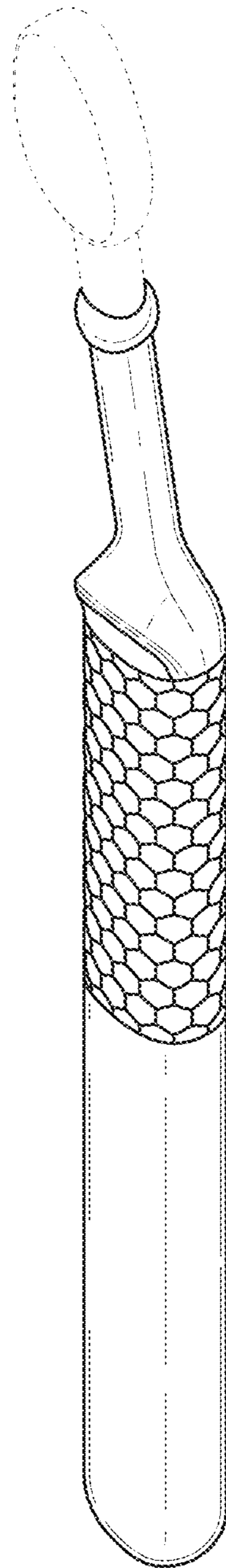

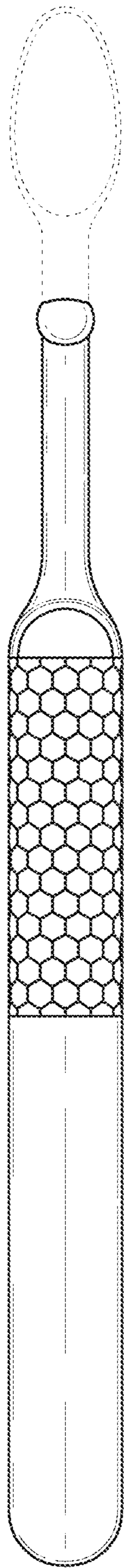

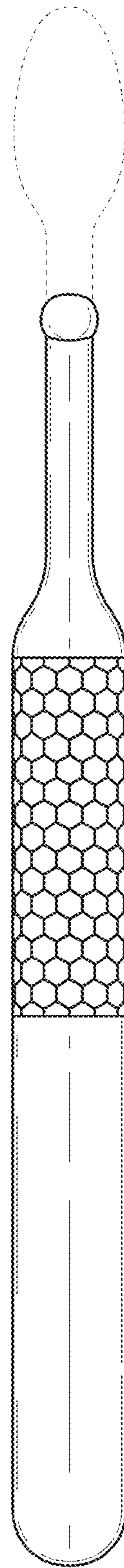

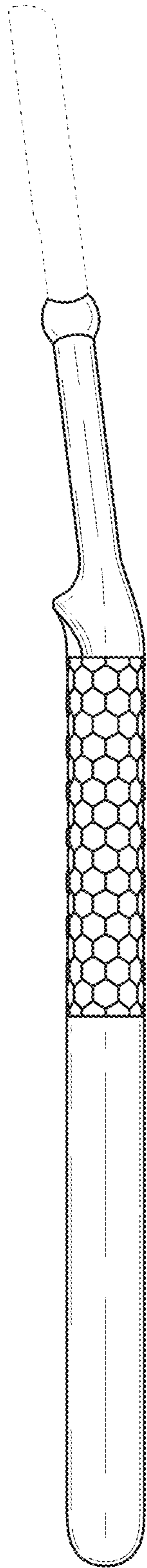

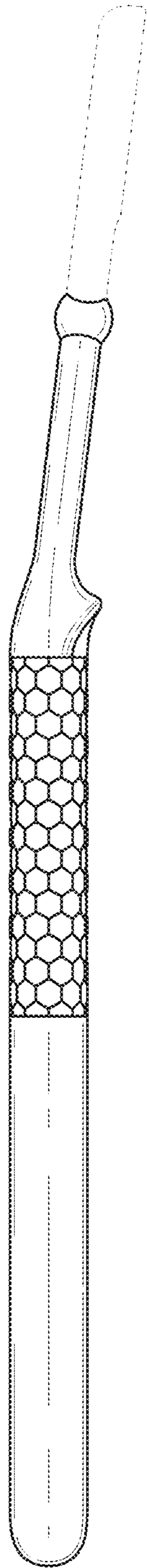
