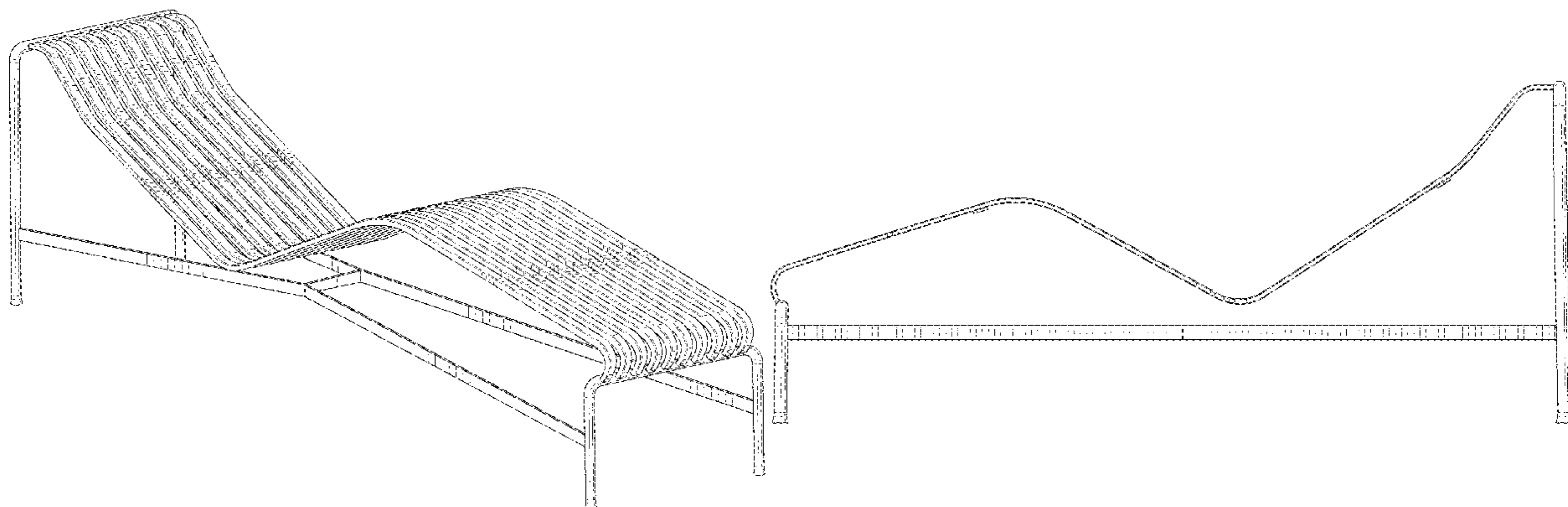
(57) **CLAIM**

We claim, the ornamental design for a lounge chair, as shown and described.

**DESCRIPTION**

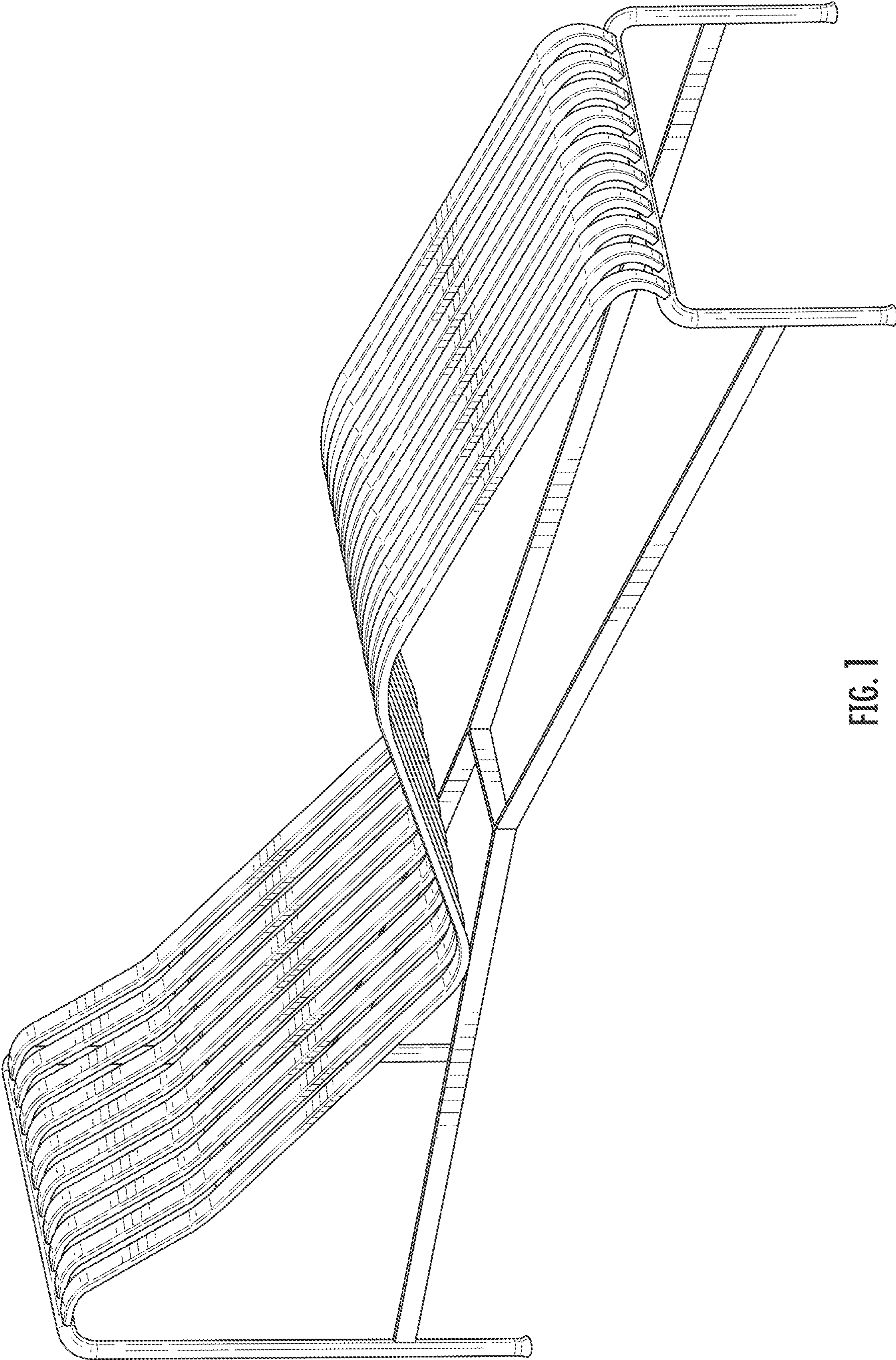

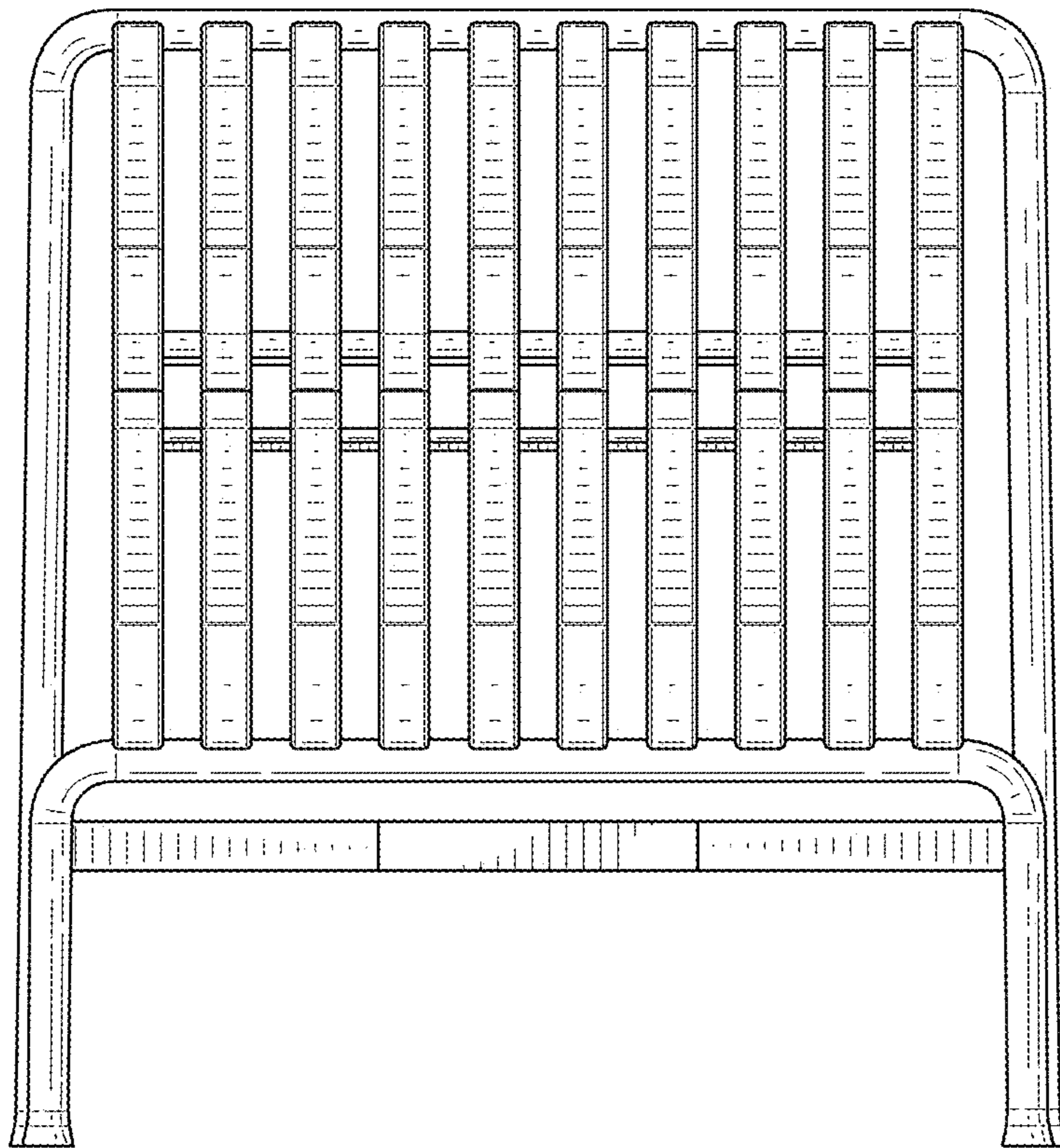

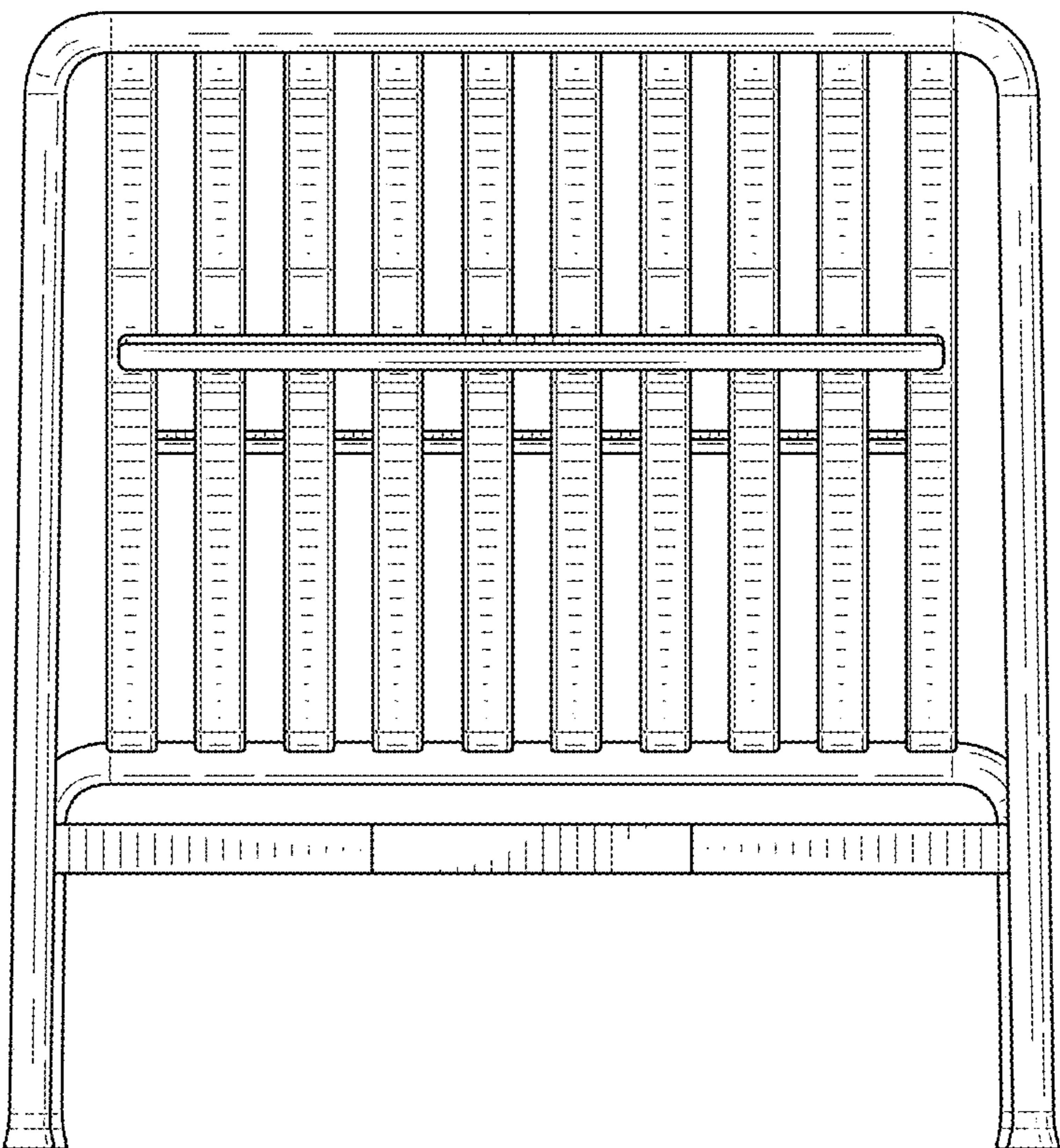

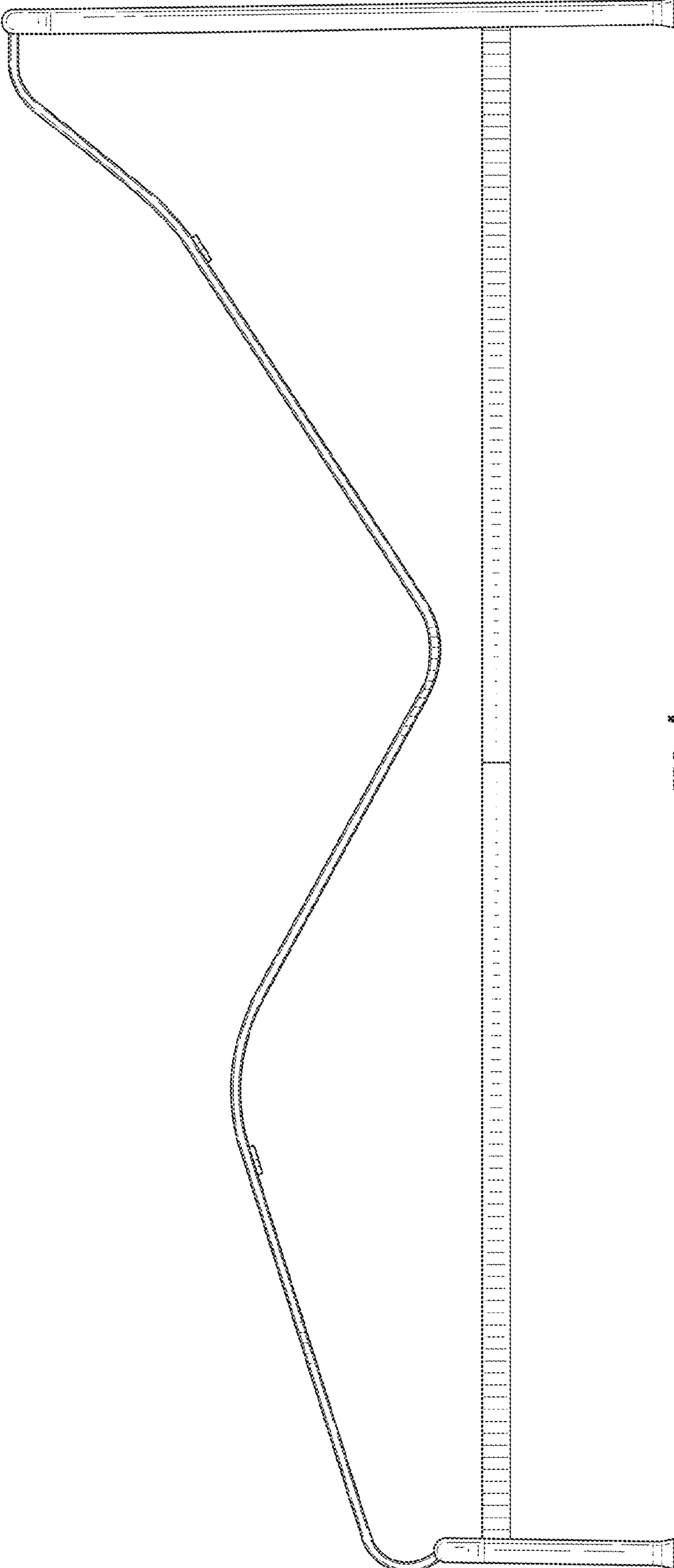

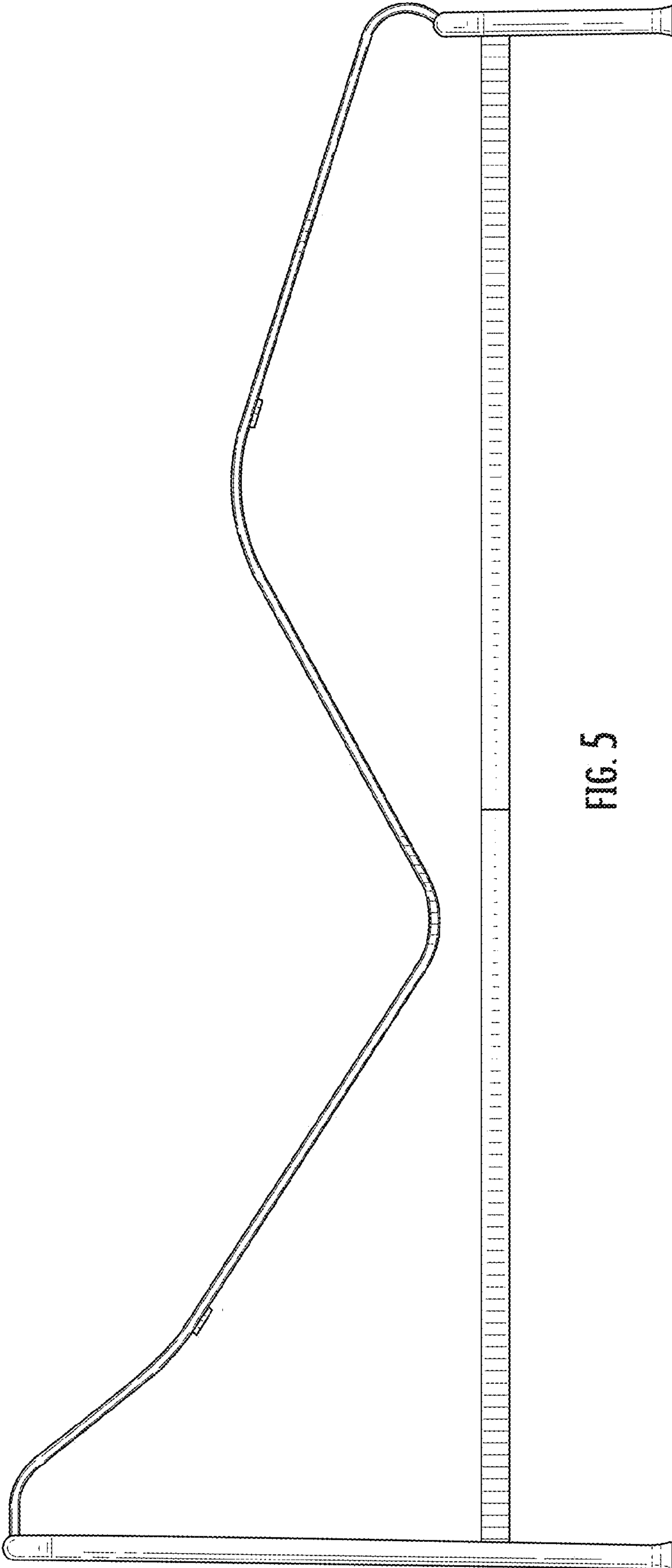

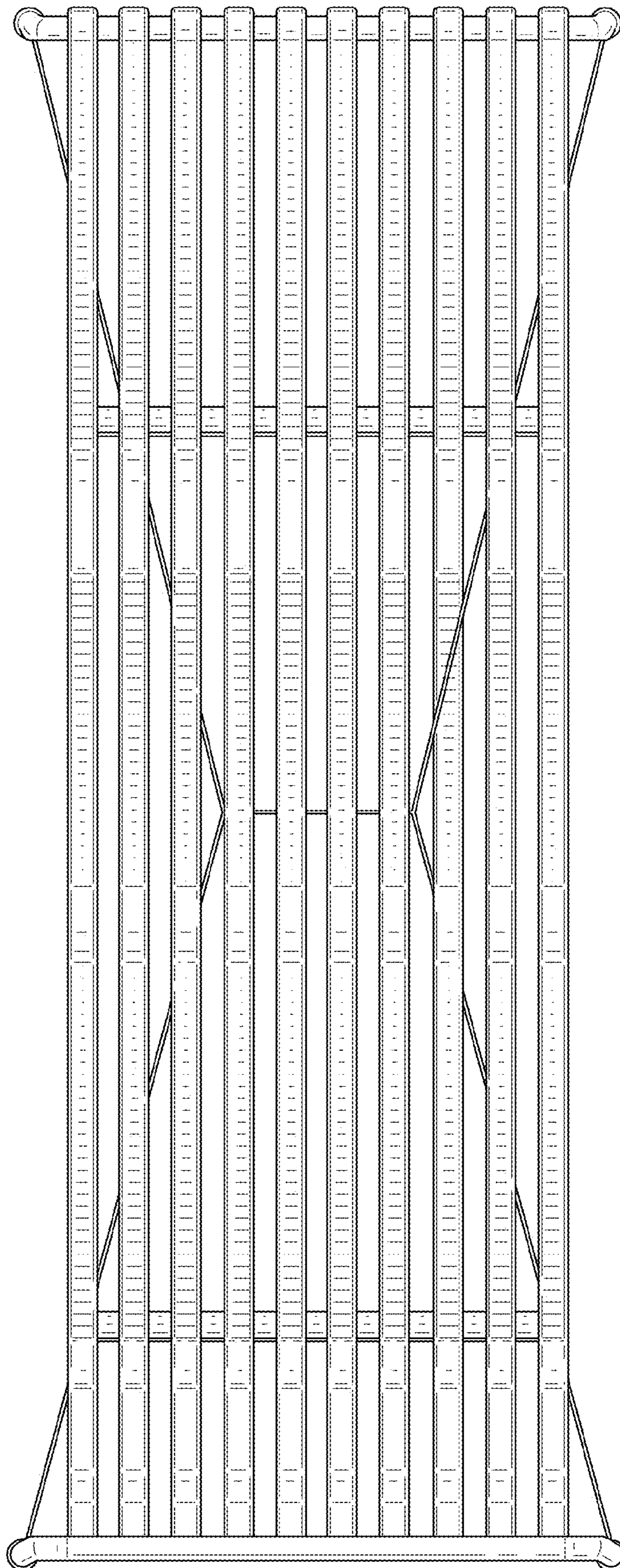

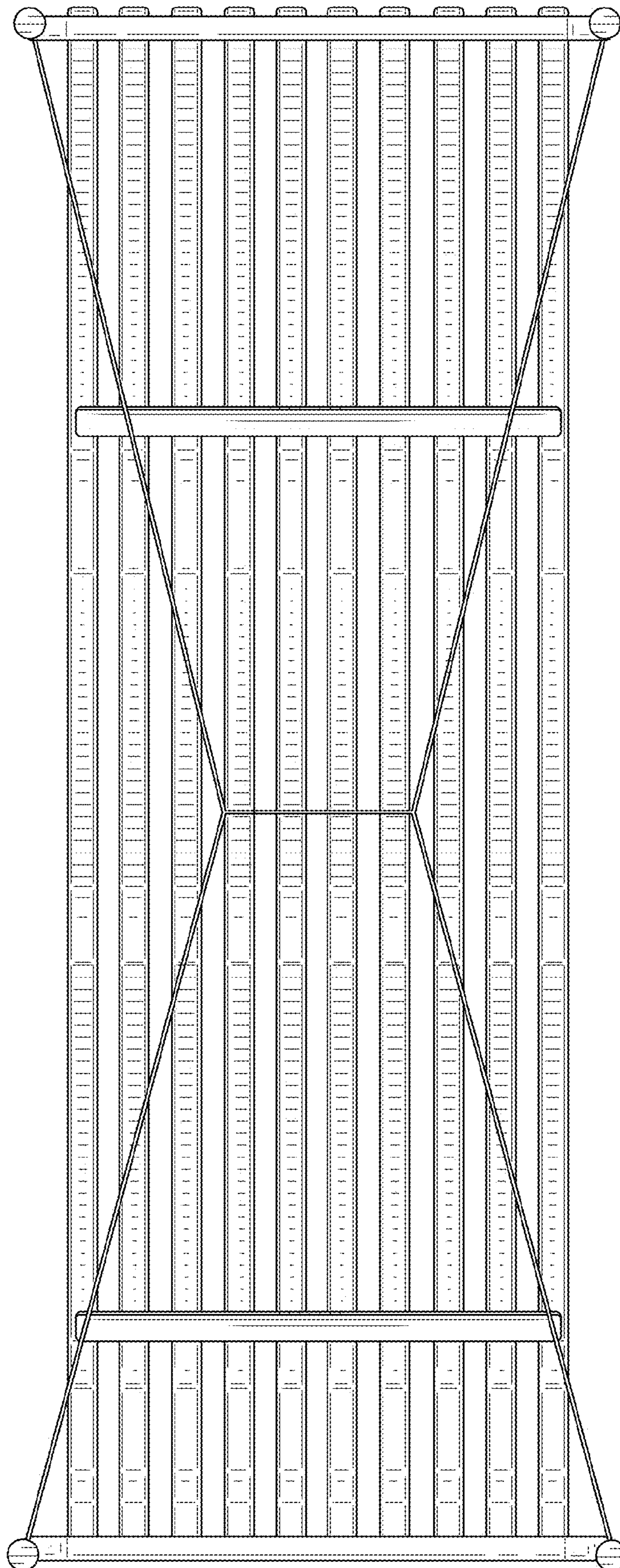
