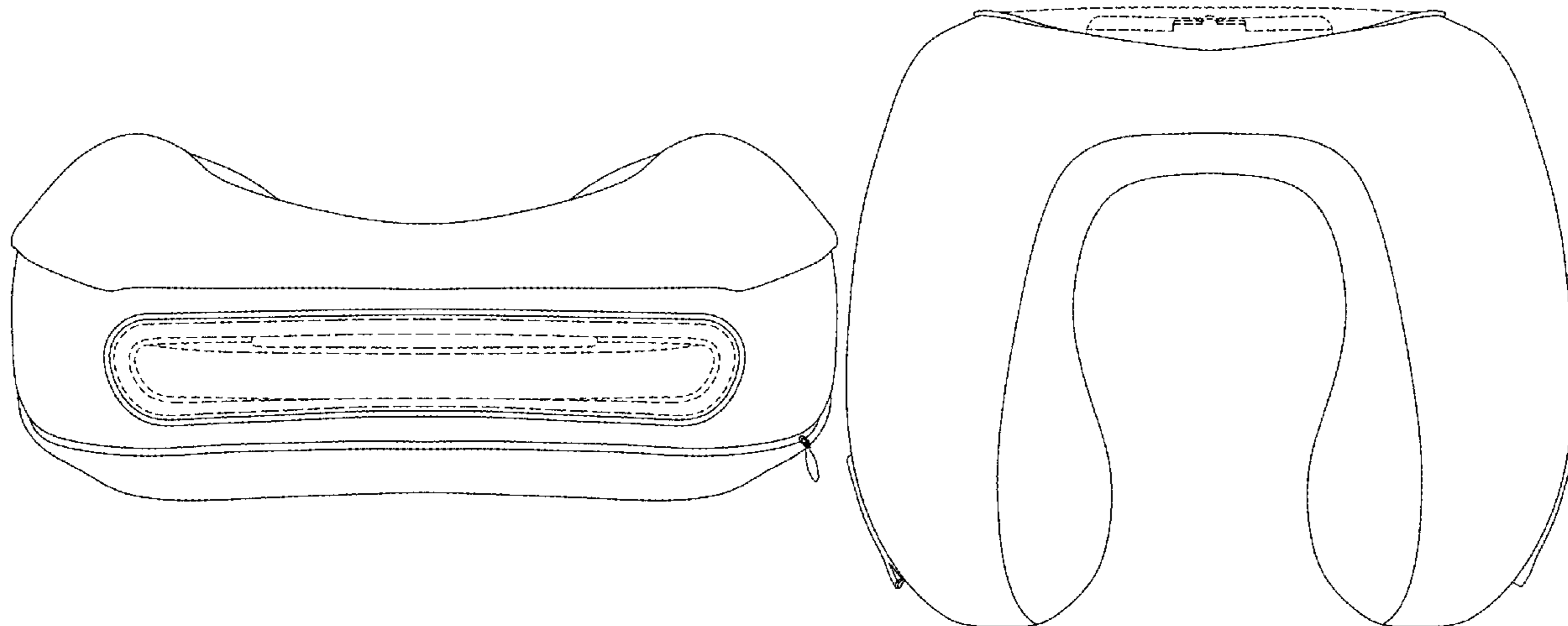
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a pillow;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

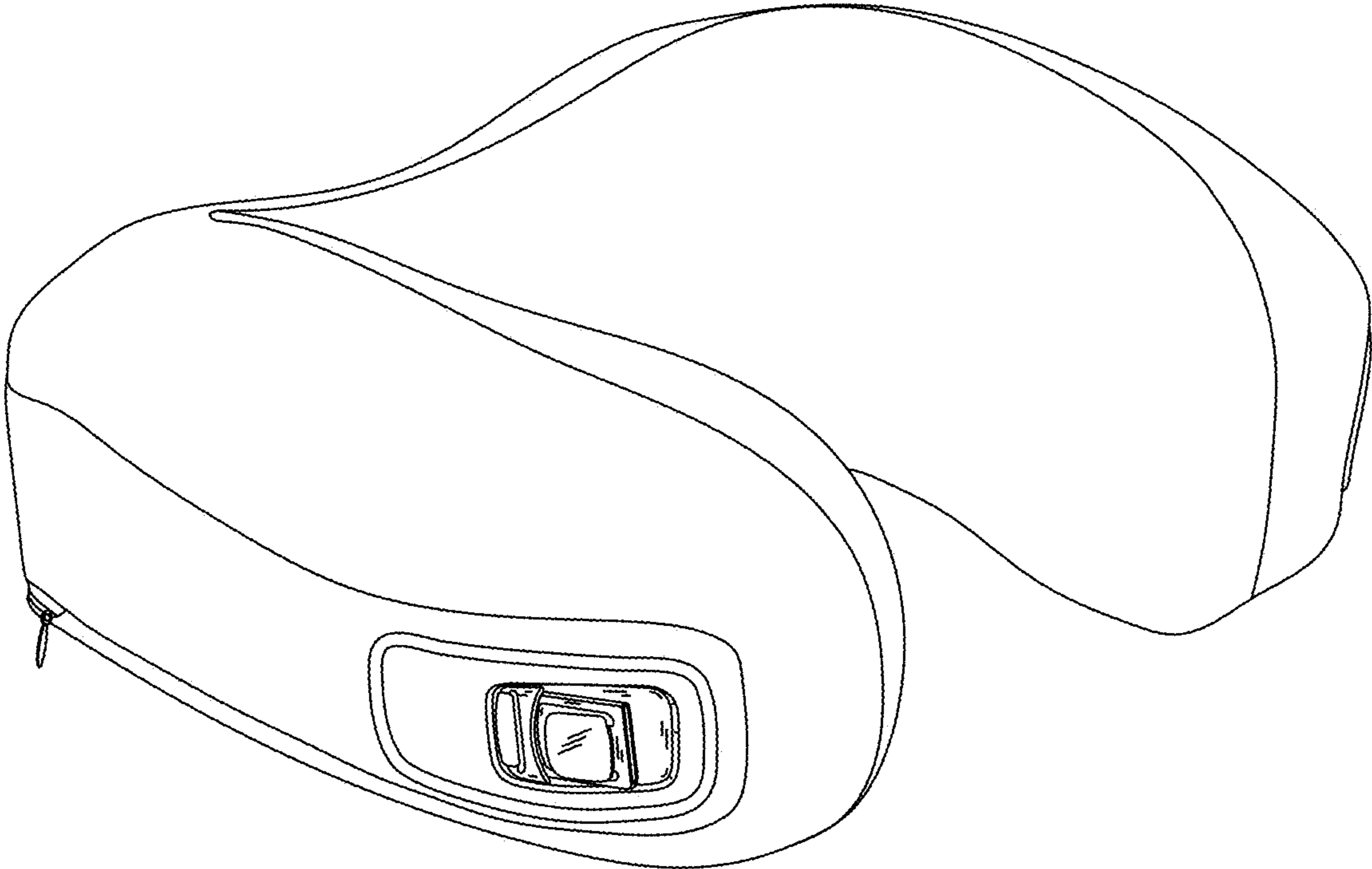

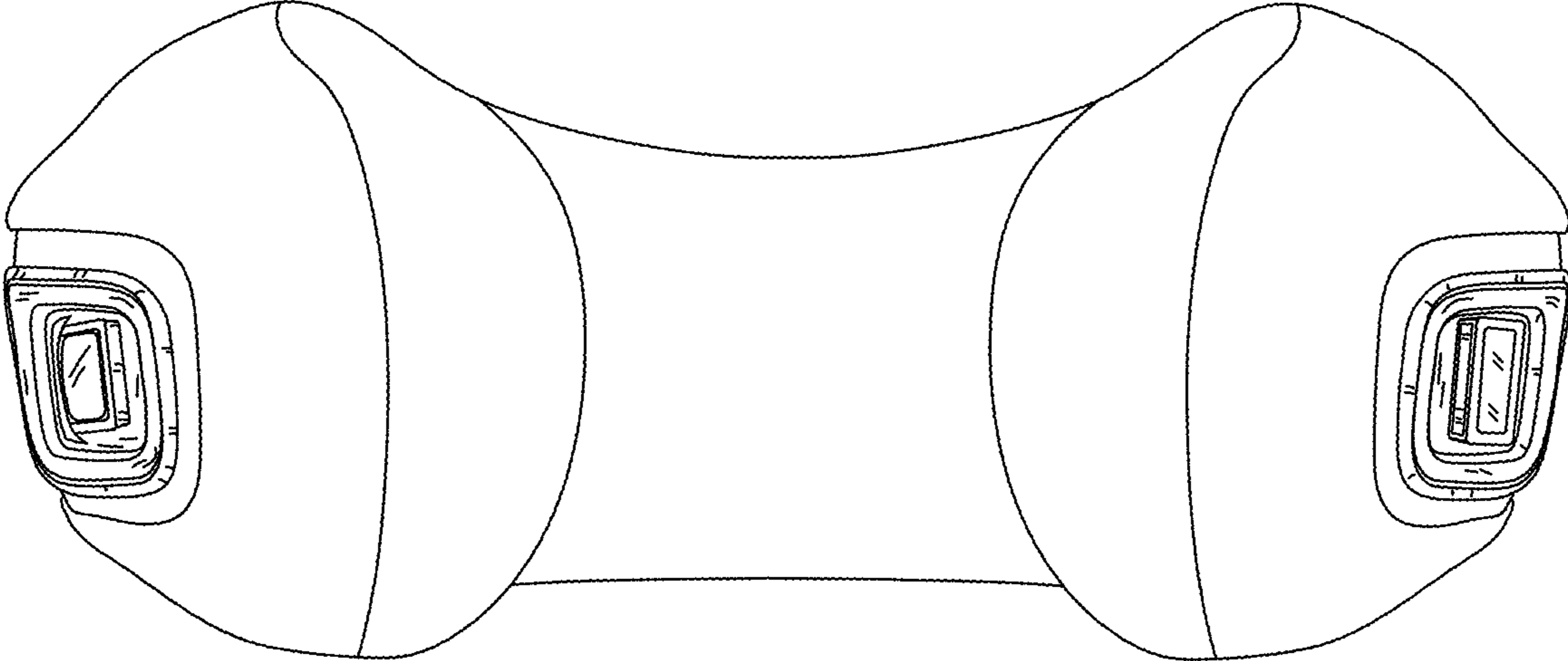

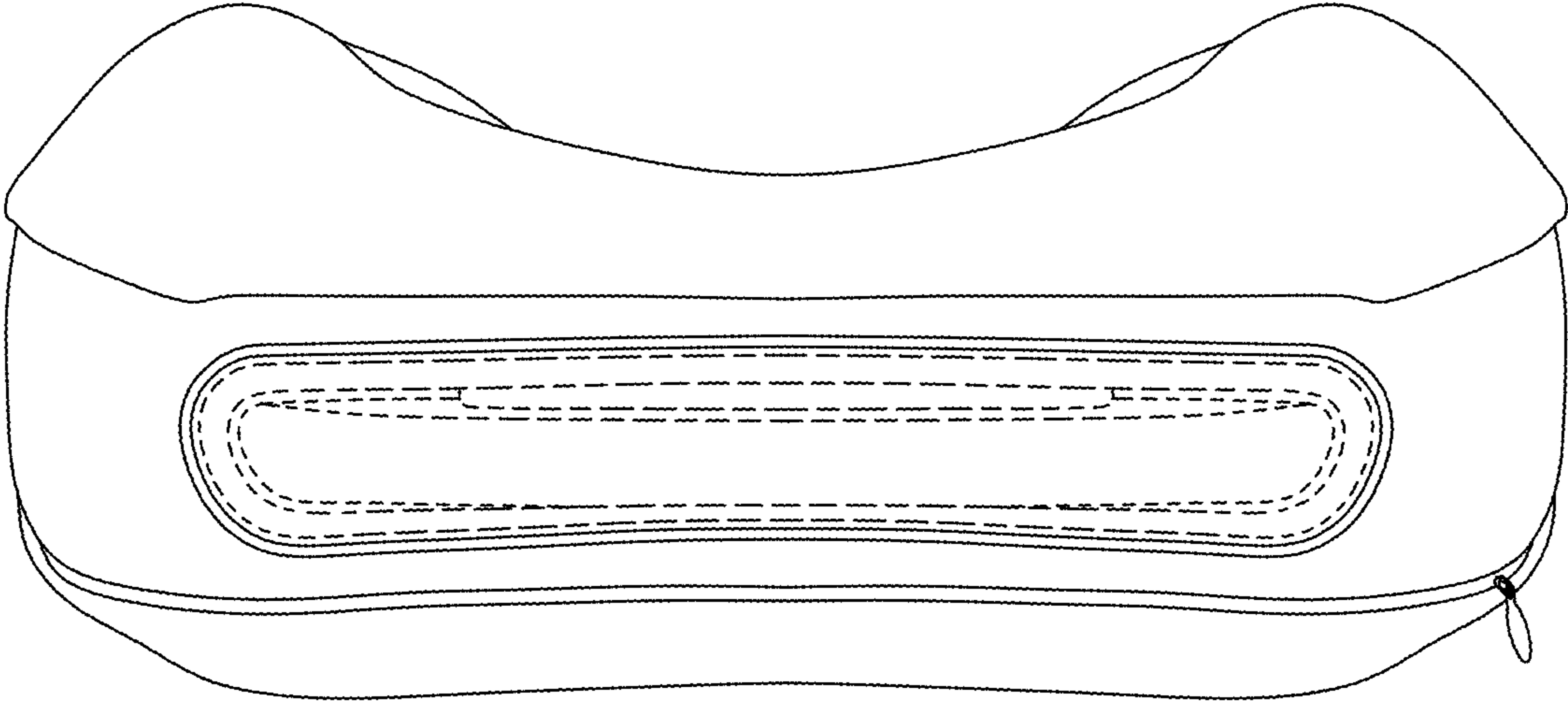

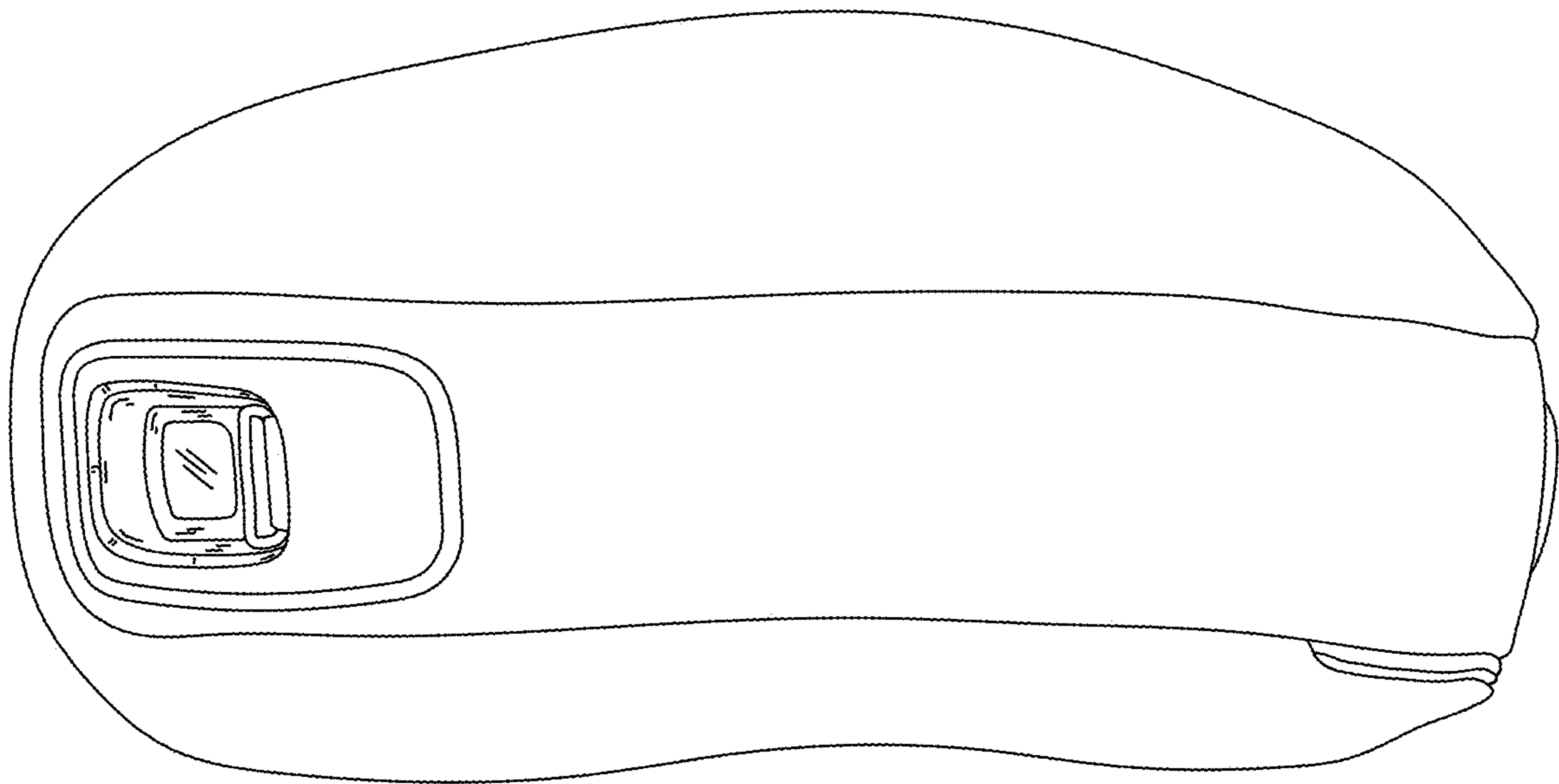

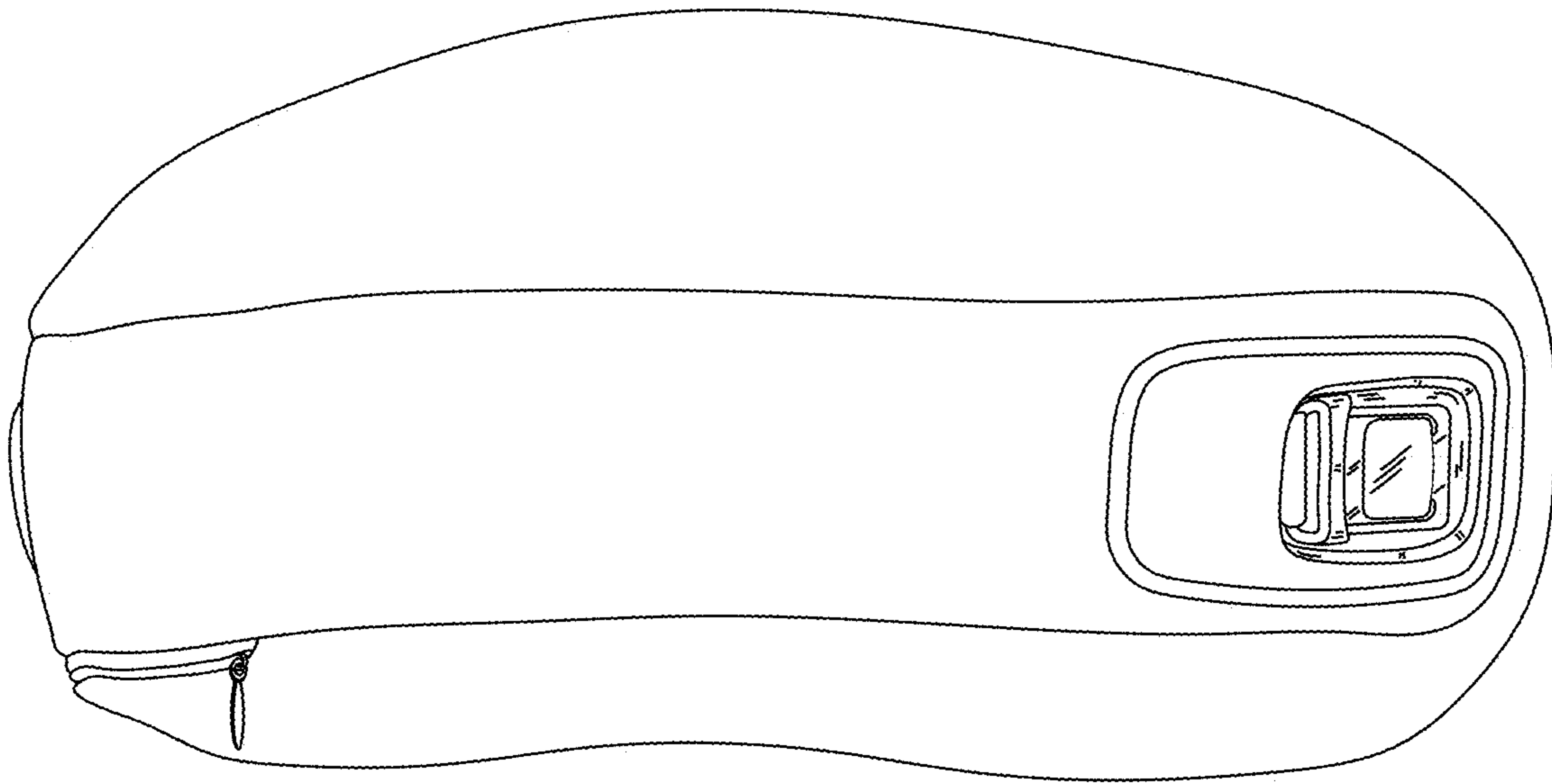

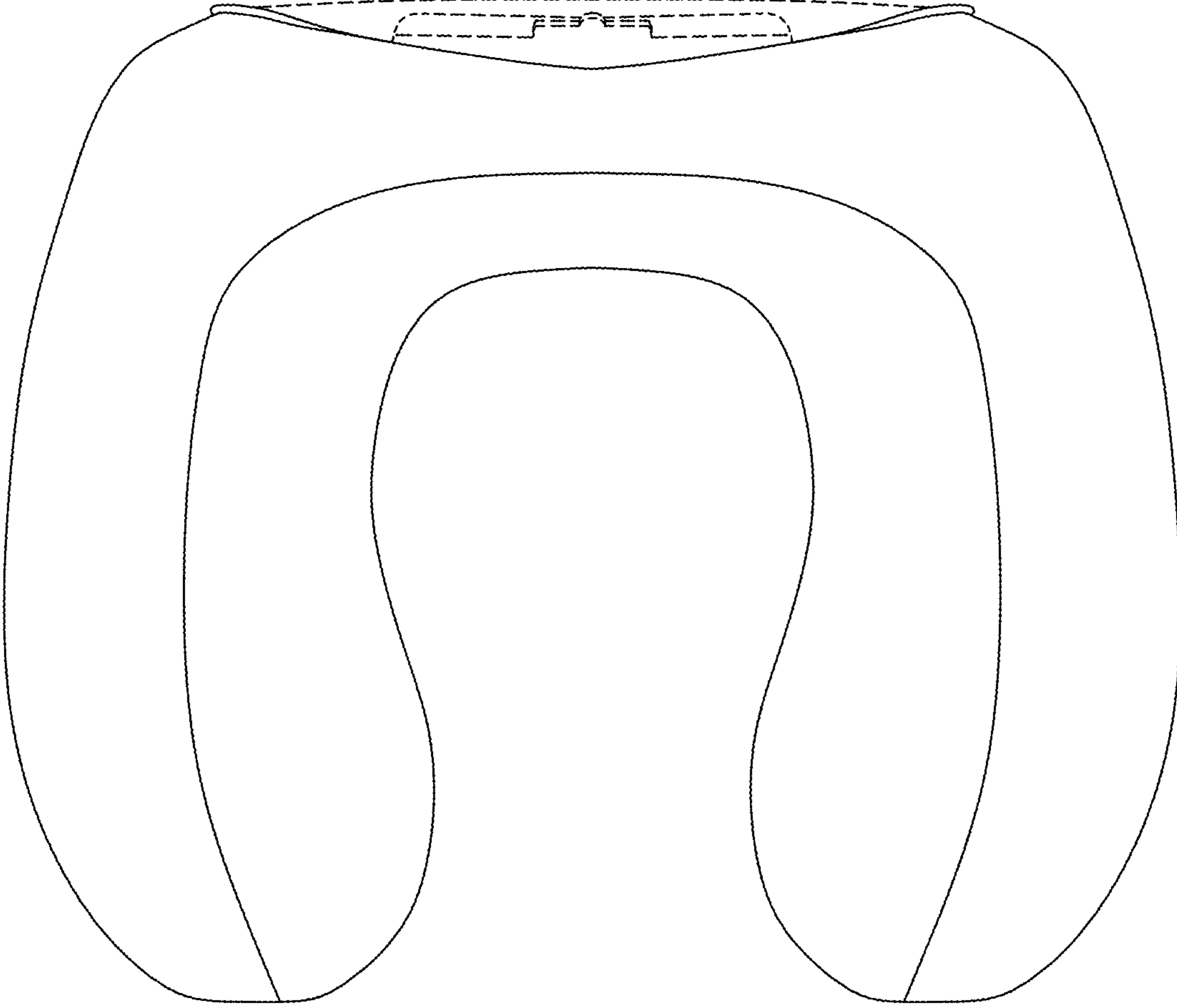

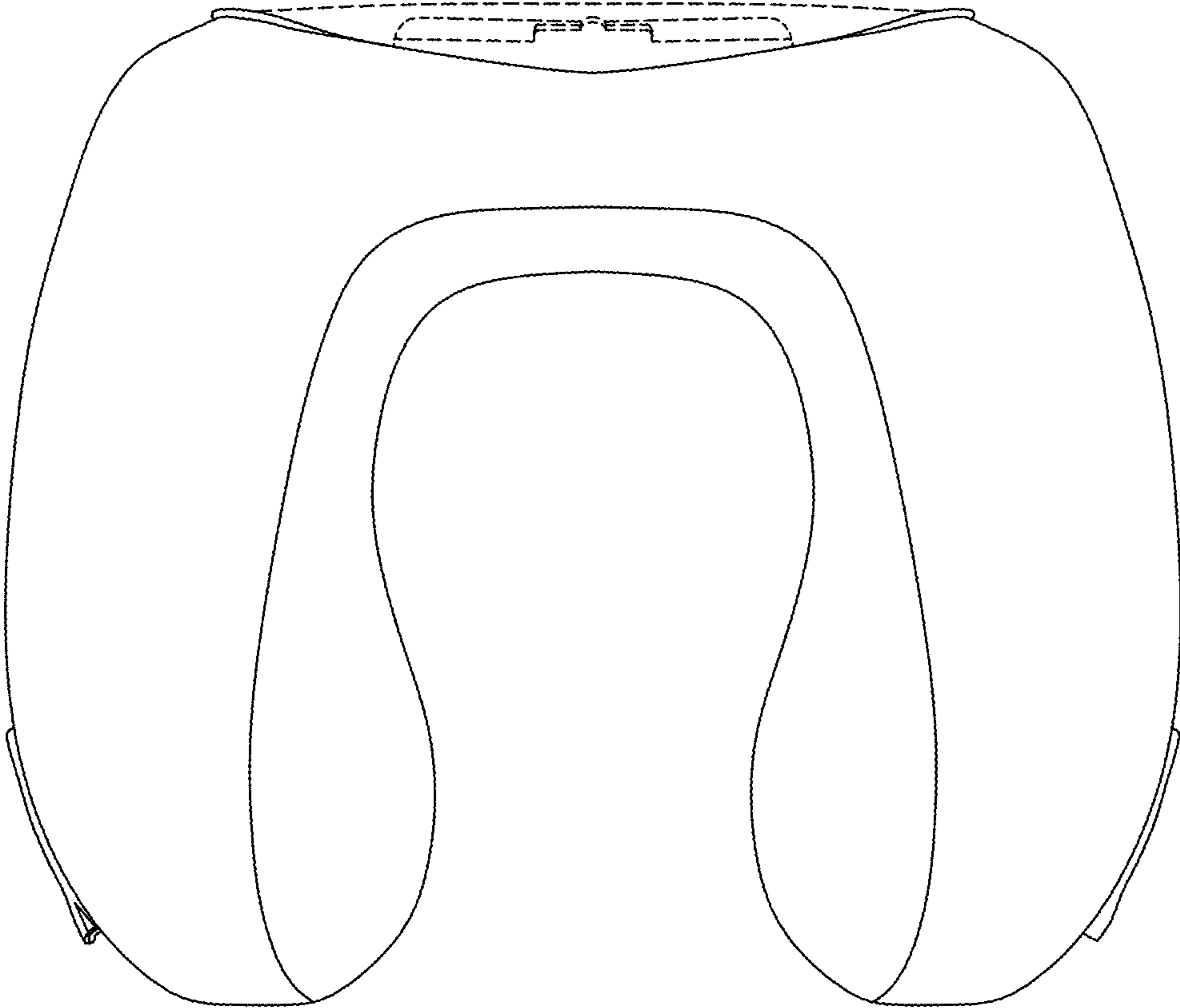
