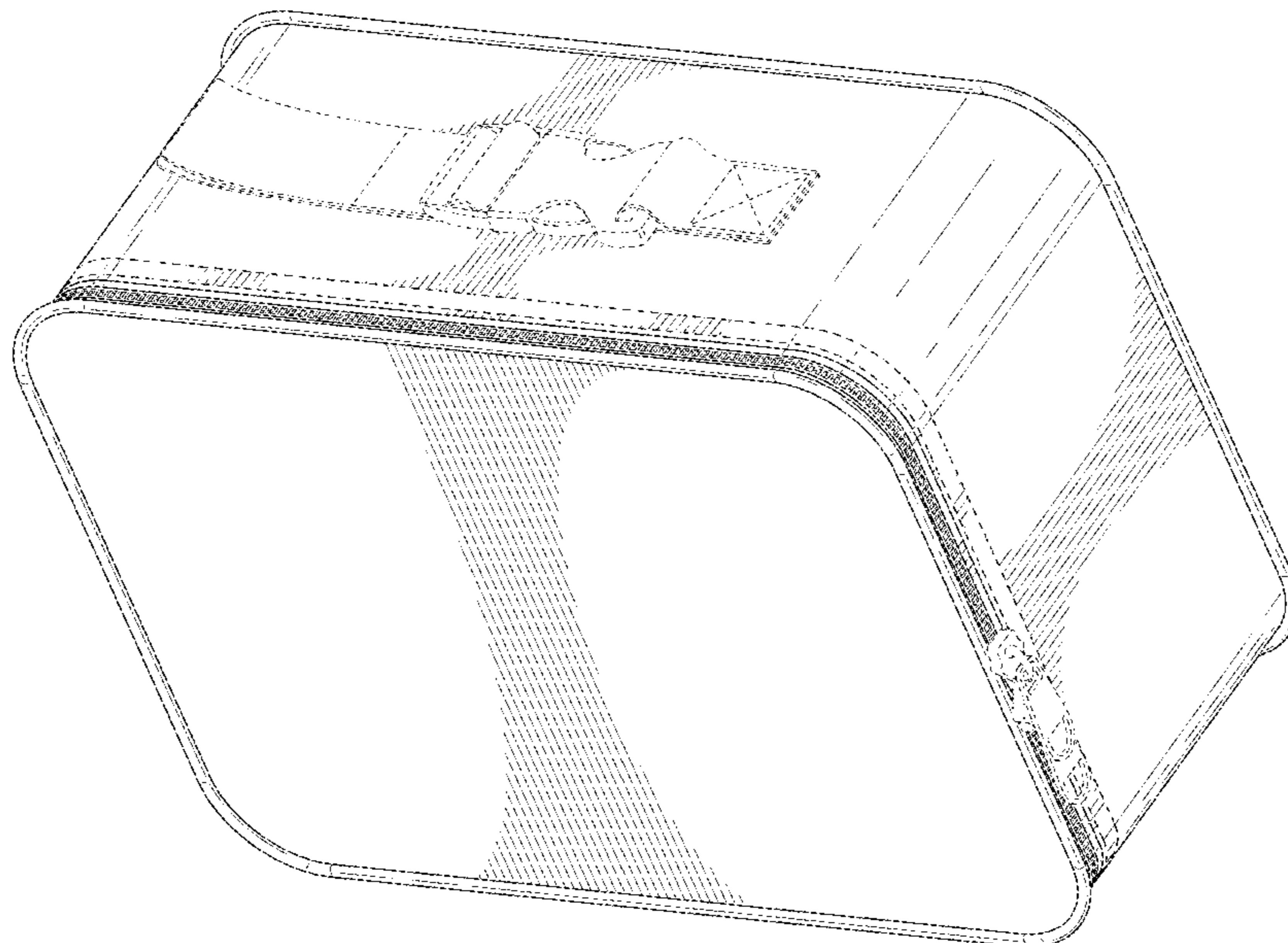
(57) **CLAIM**

The ornamental design for a lunch bag, as shown and described.

DESCRIPTION

FIG. 1 is a side, perspective view of a lunch bag, showing my new design.
FIG. 2 is a front view of the lunch bag of FIG. 1.
FIG. 3 is a back view of the lunch bag of FIG. 1.
FIG. 4 is a left side view of the lunch bag of FIG. 1.
FIG. 5 is a right side view of the lunch bag of FIG. 1.
FIG. 6 is a top view of the lunch bag of FIG. 1; and,
FIG. 7 is a bottom view of the lunch bag of FIG. 1.
The evenly spaced broken lines on the lunch bag in FIGS. 1 and 3-7 represent stitching. The remainder of the broken lines in the drawing views depict portions that form no part of the claimed design.

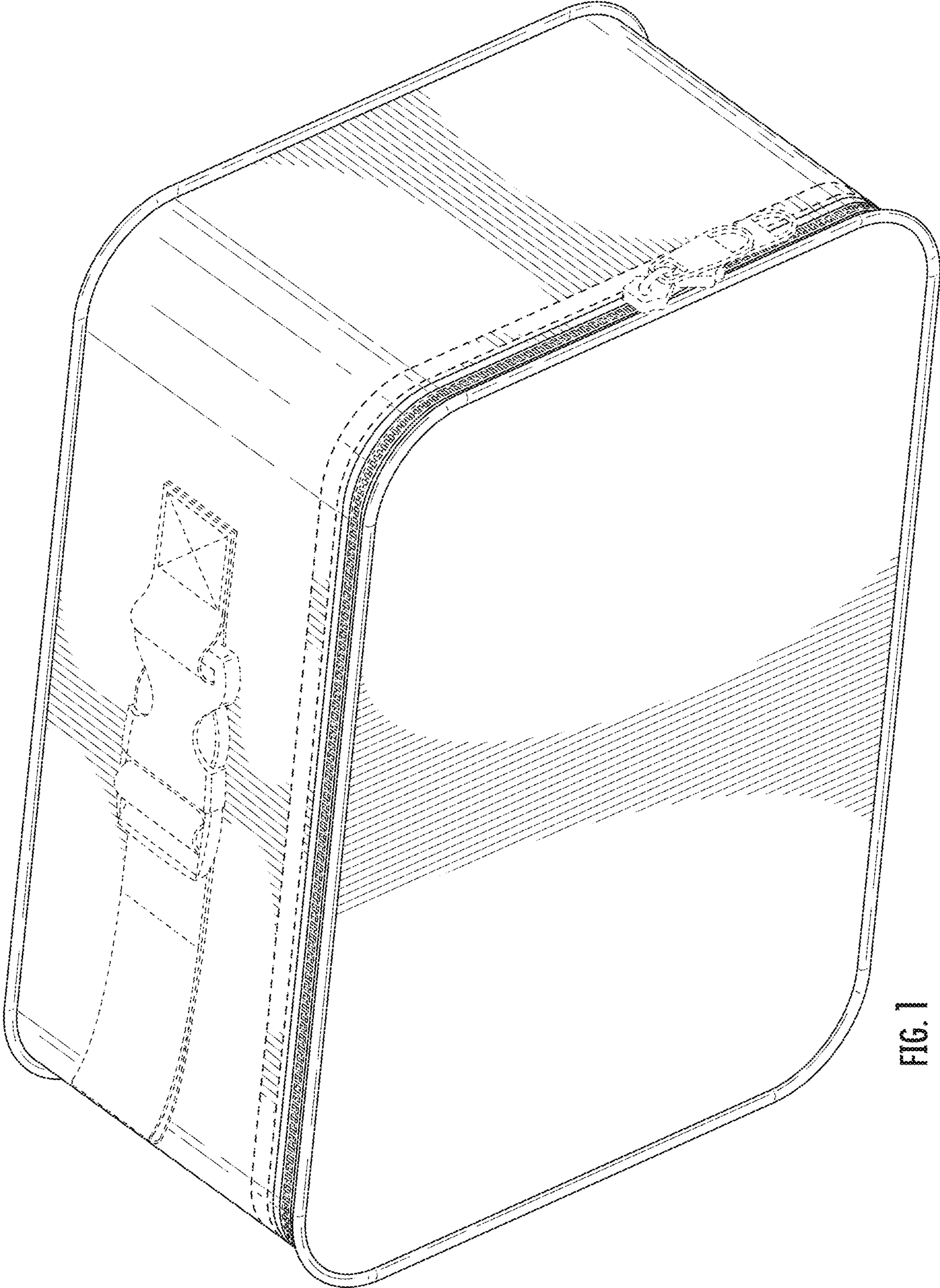

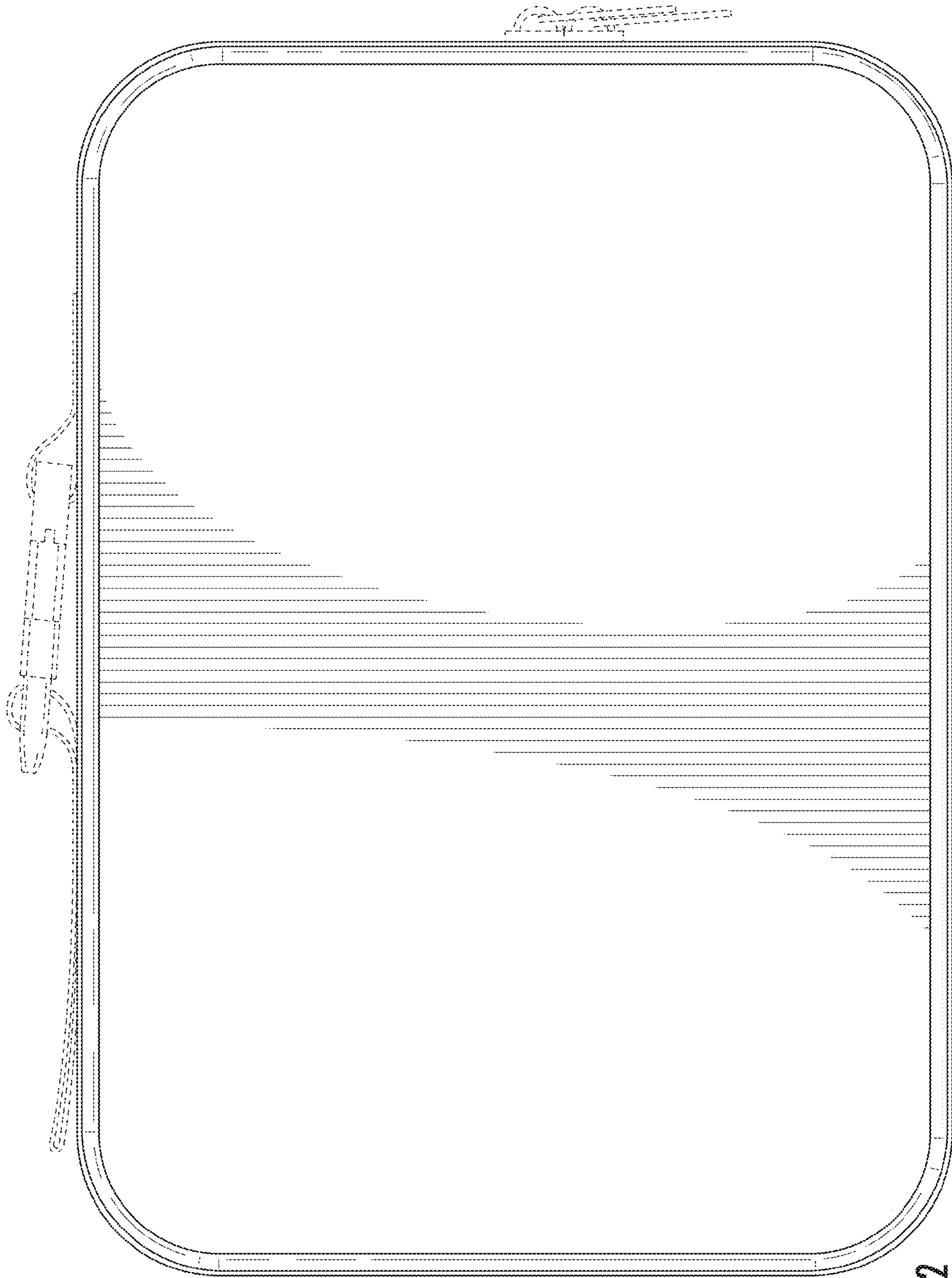

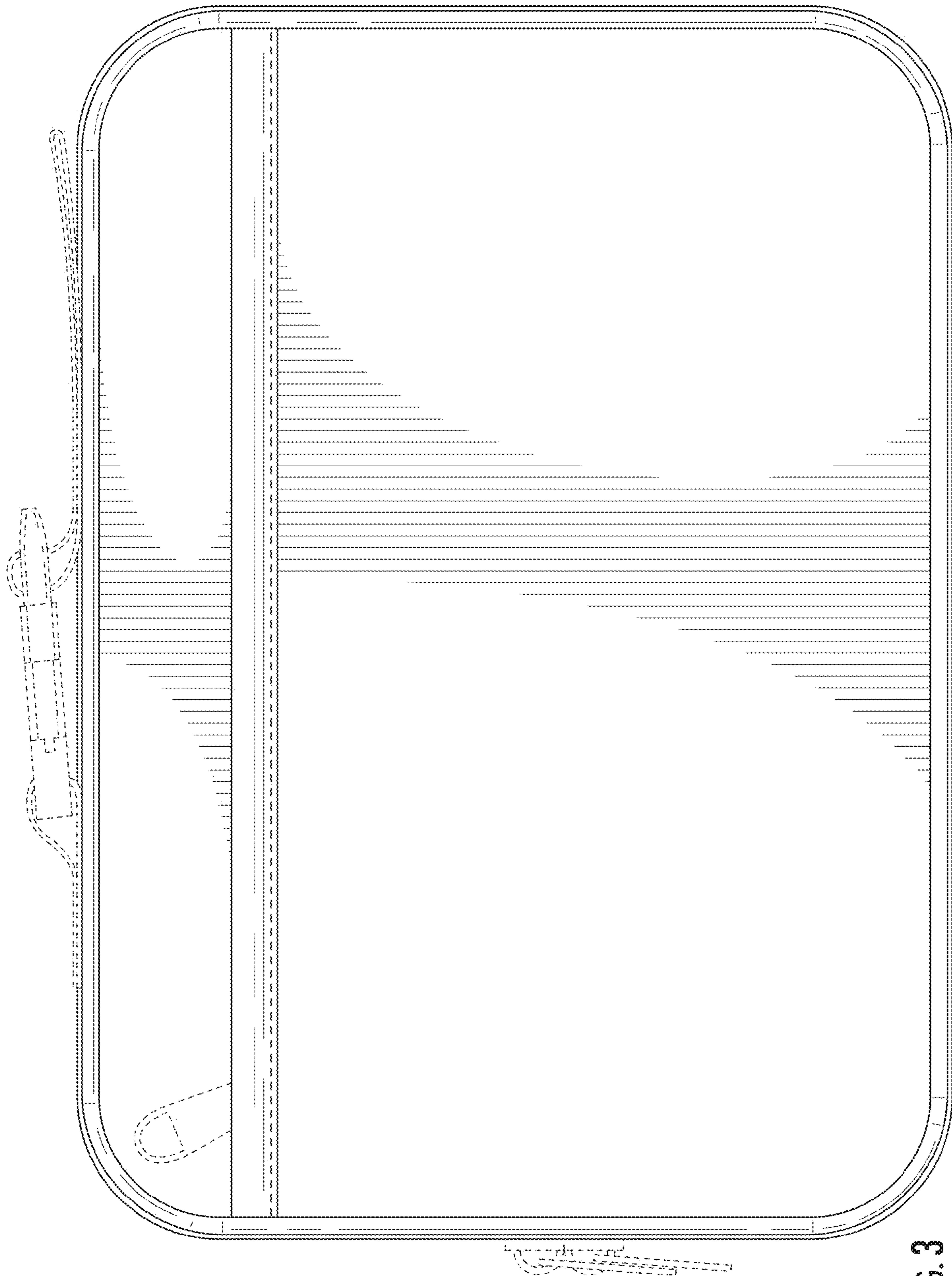

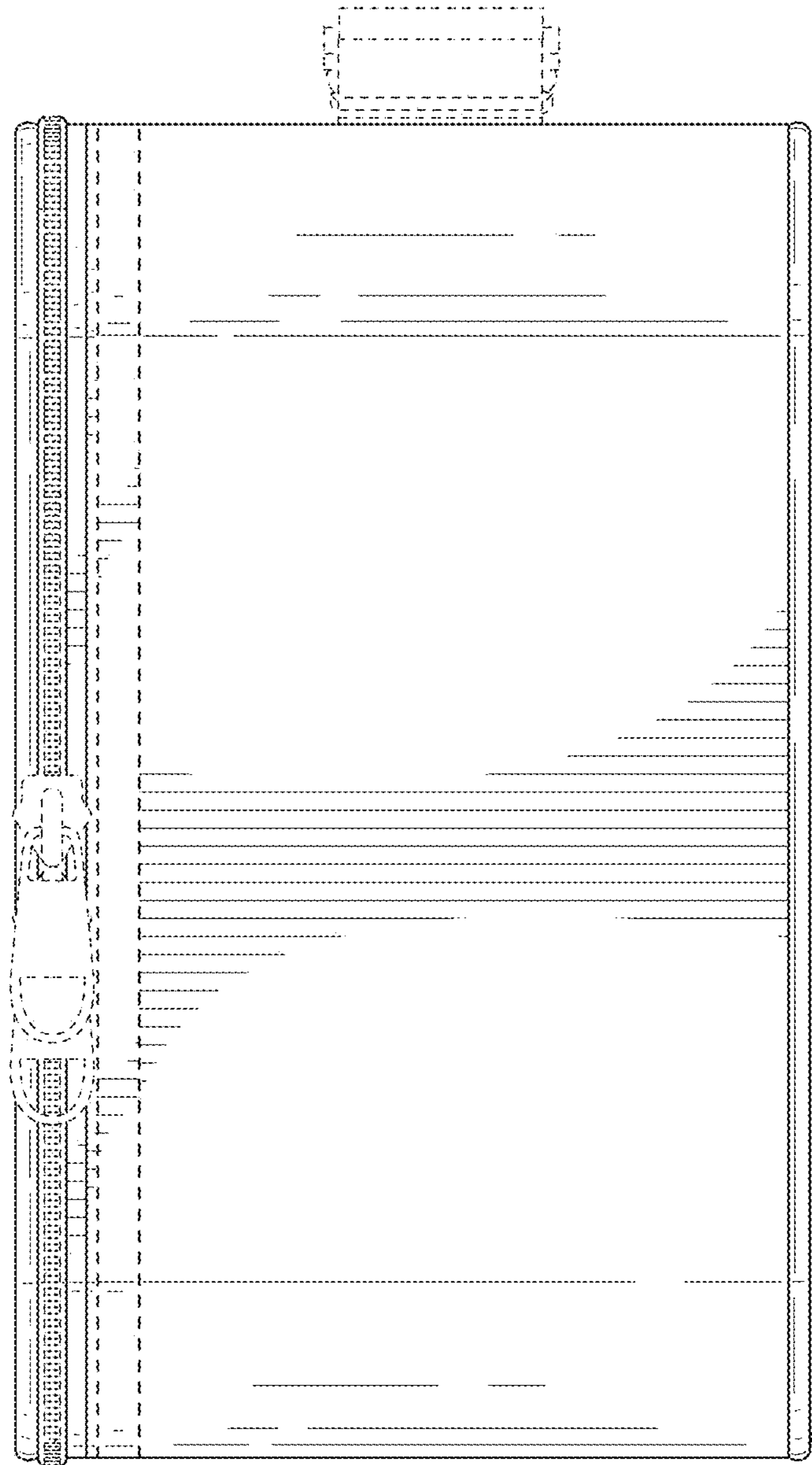

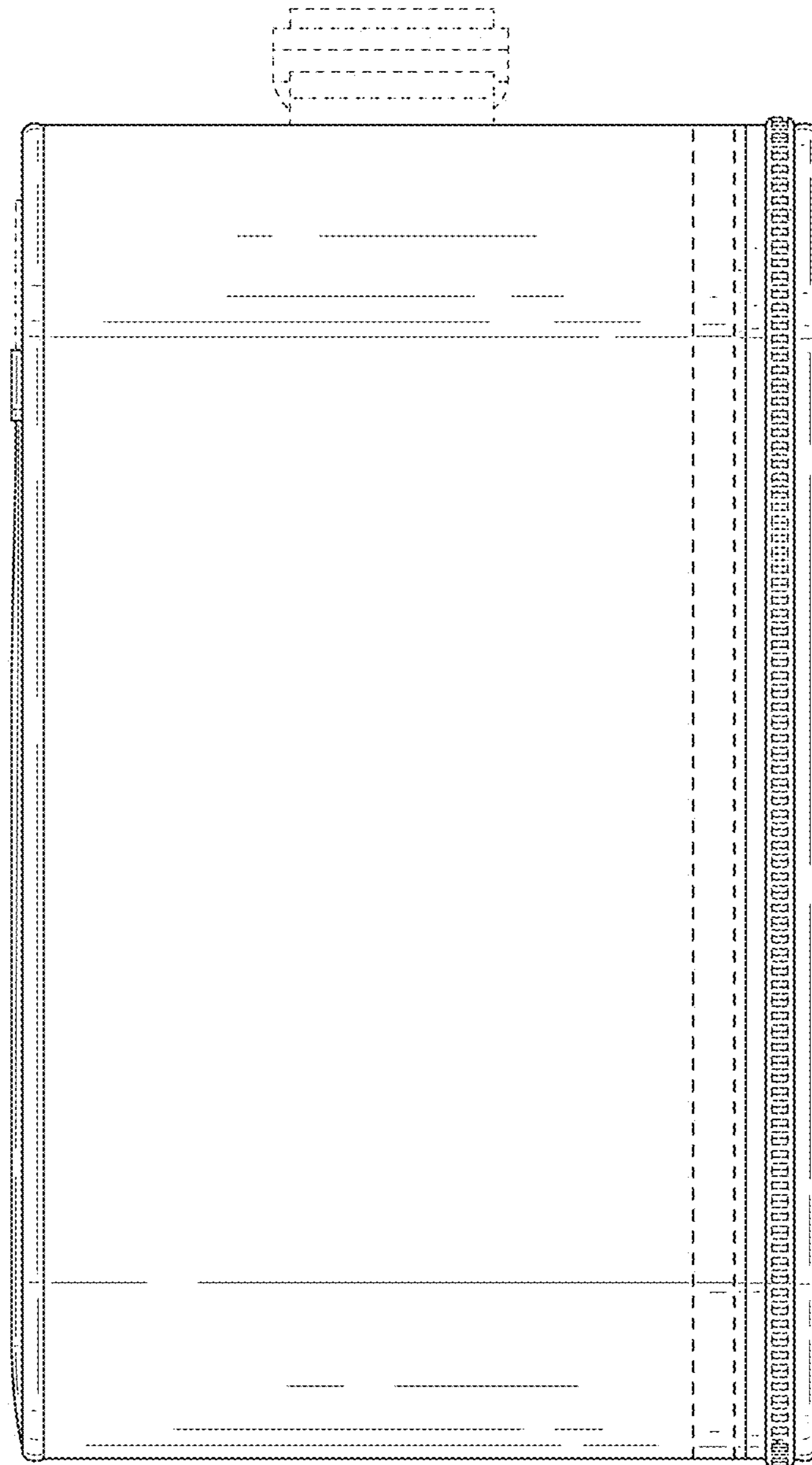

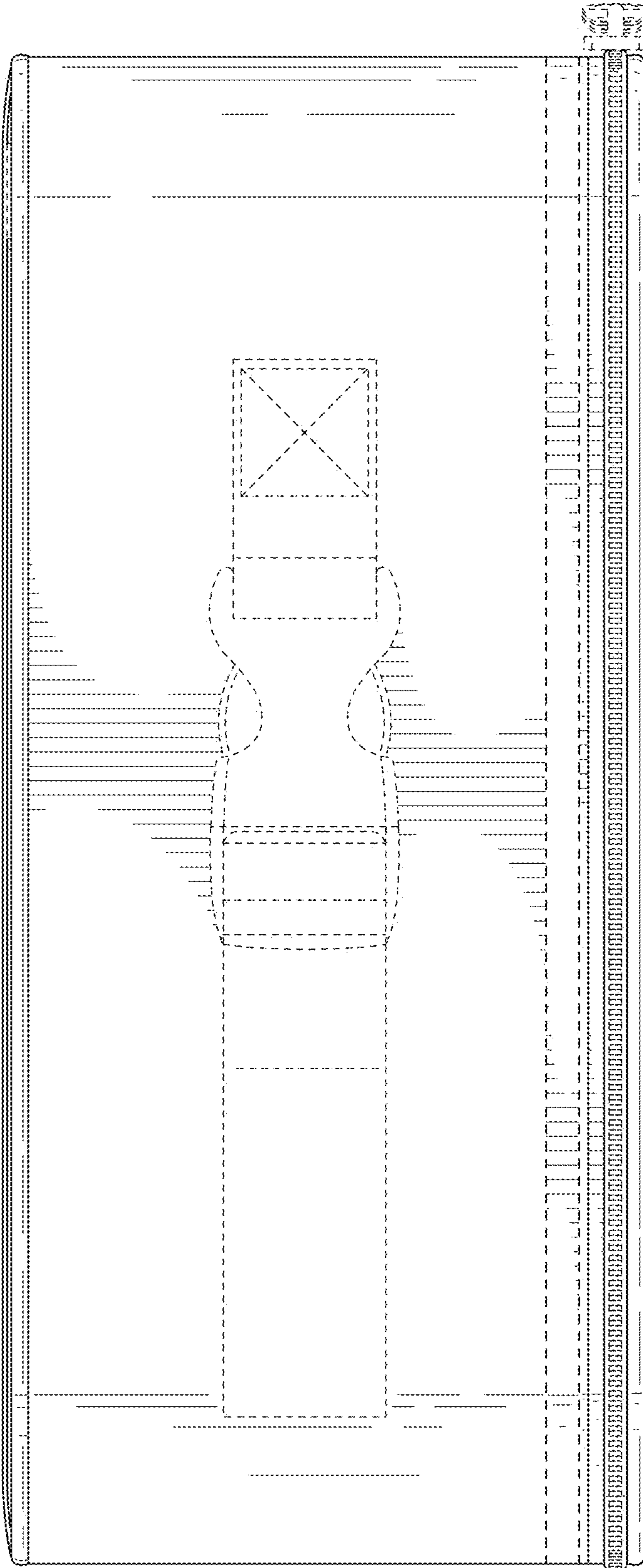

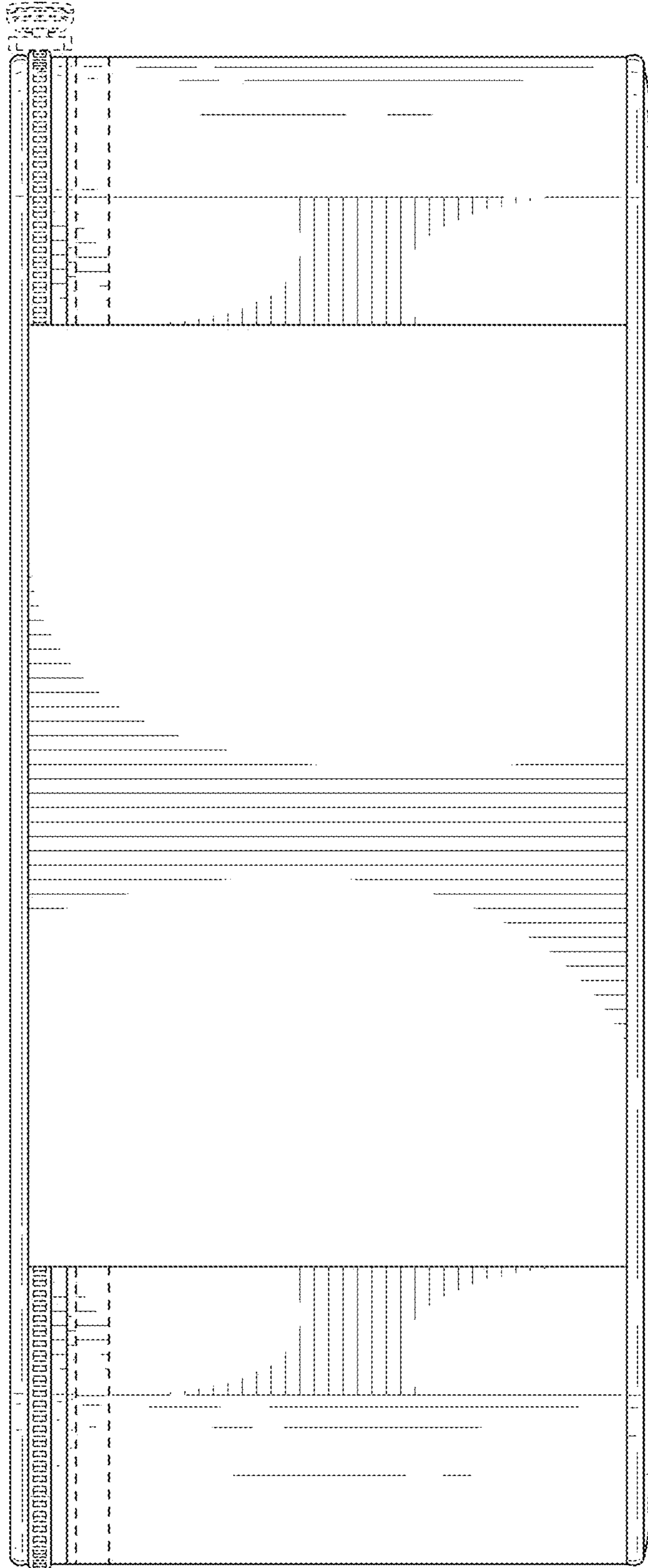
