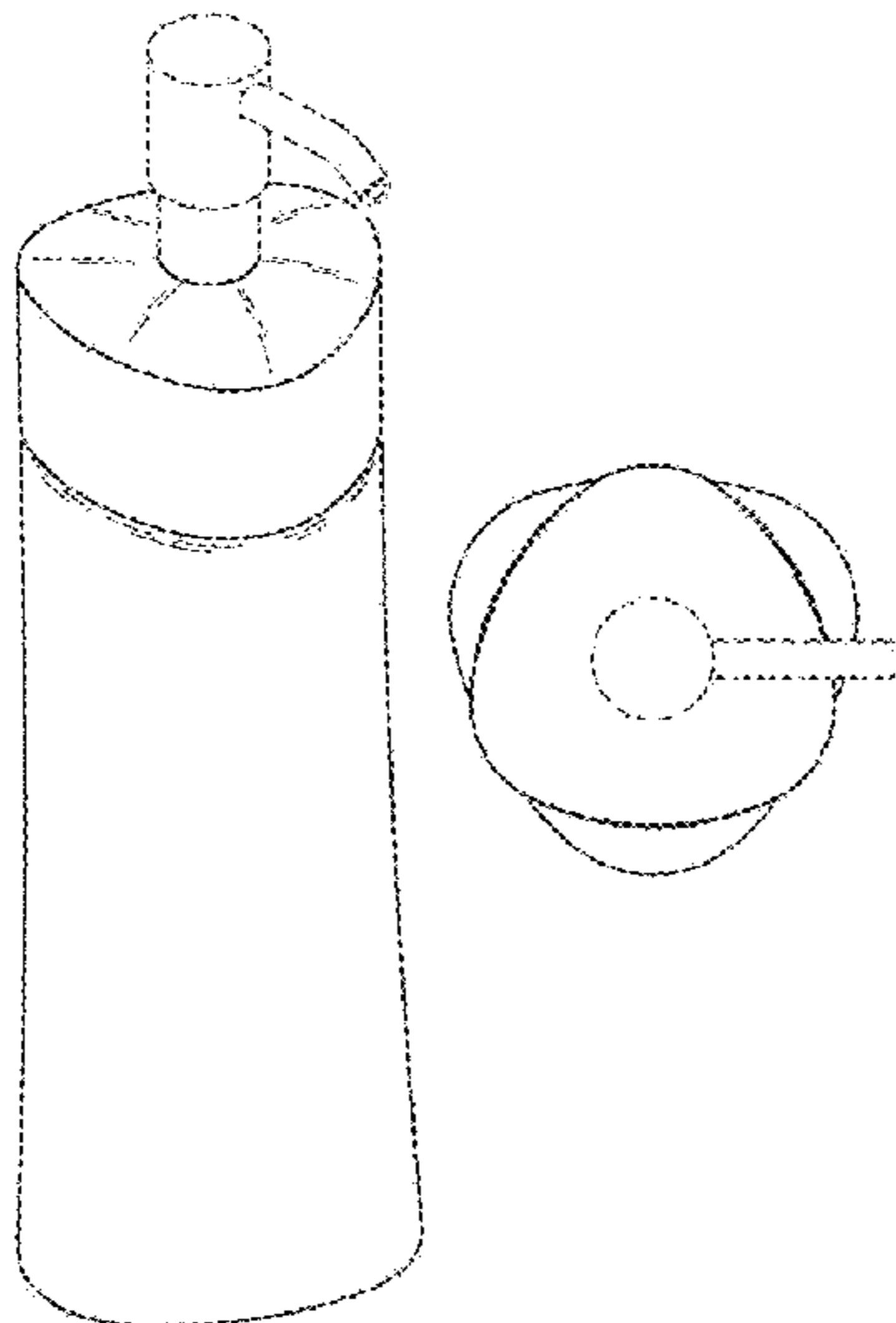
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a packaging container, showing our new design.

FIG. 5 is a bottom plan view thereof.

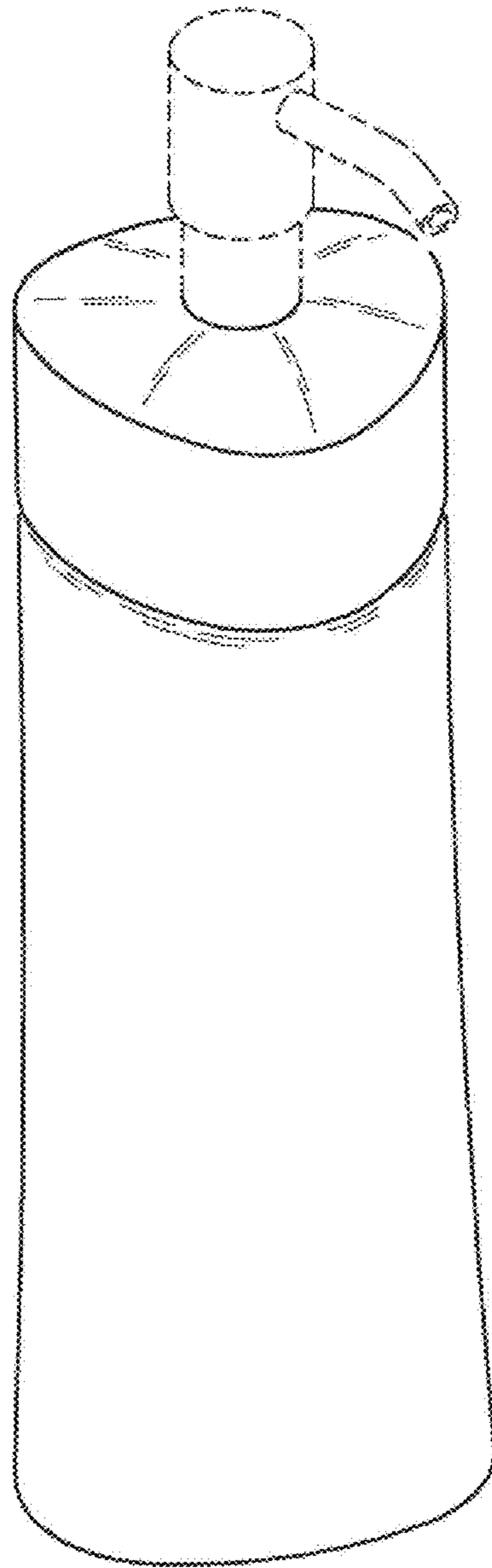

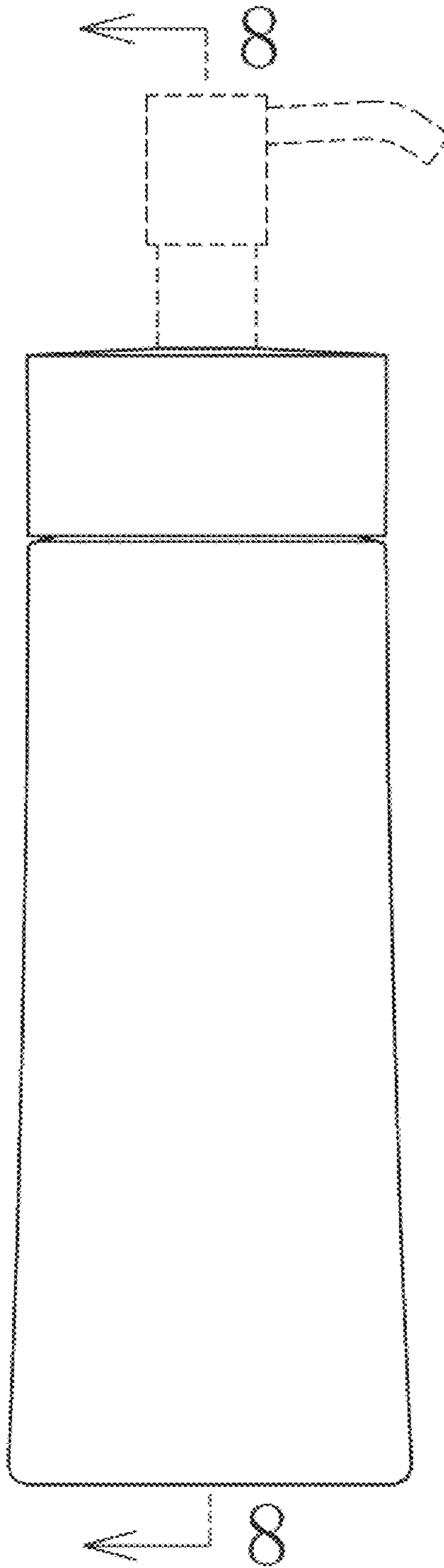

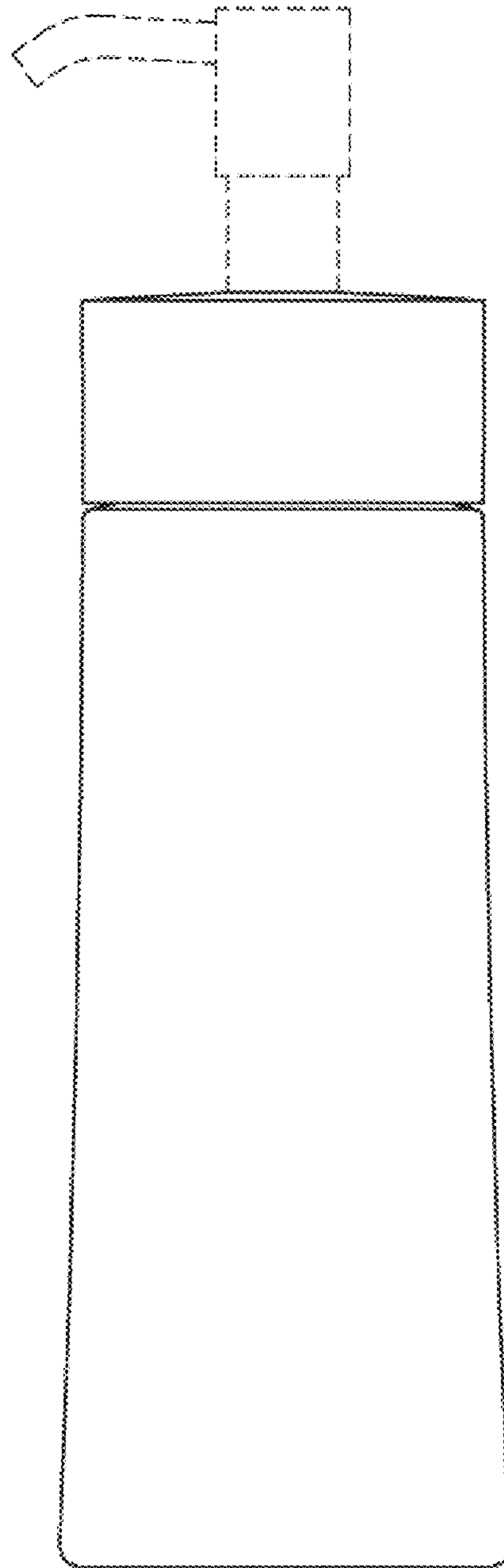

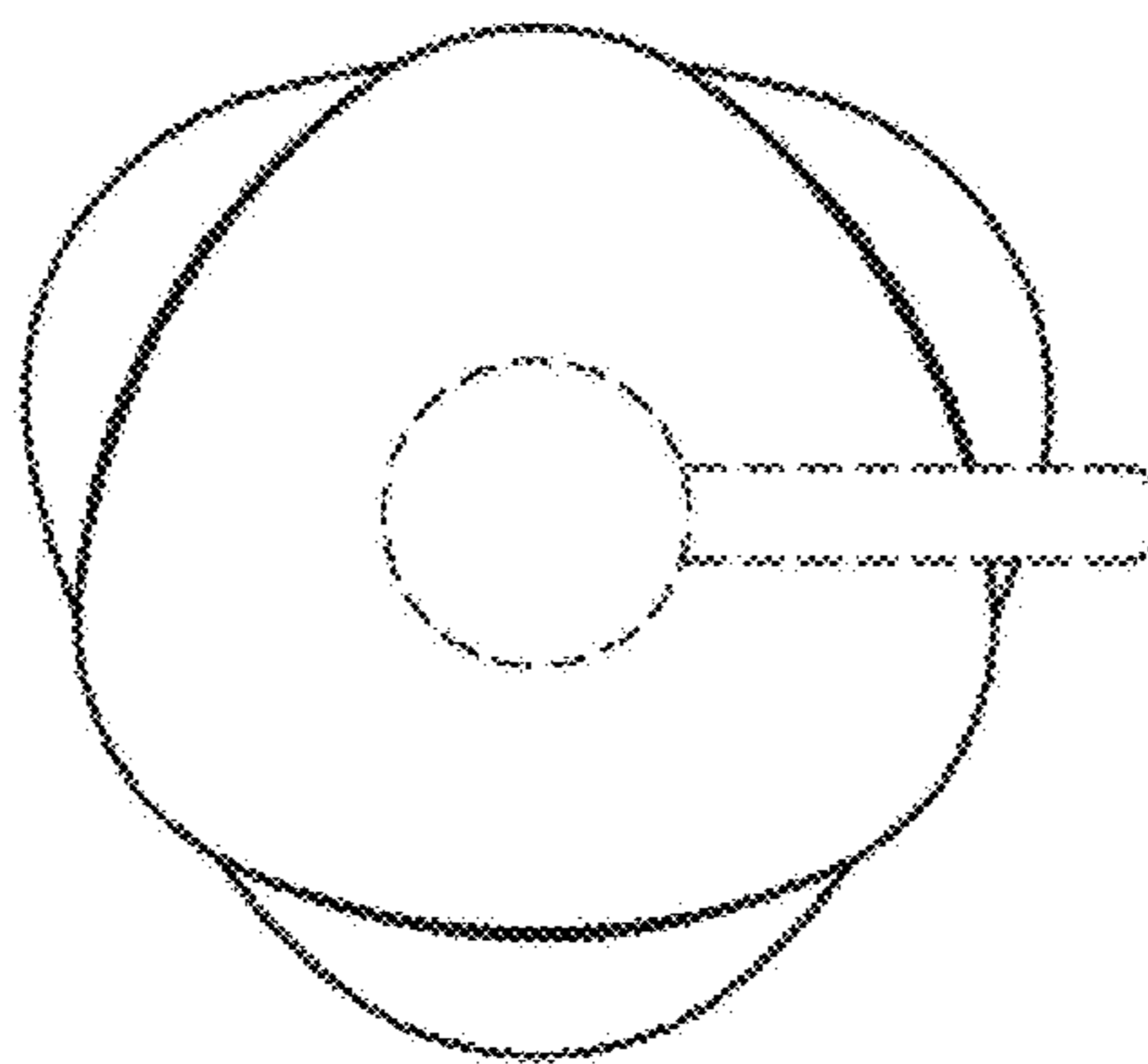

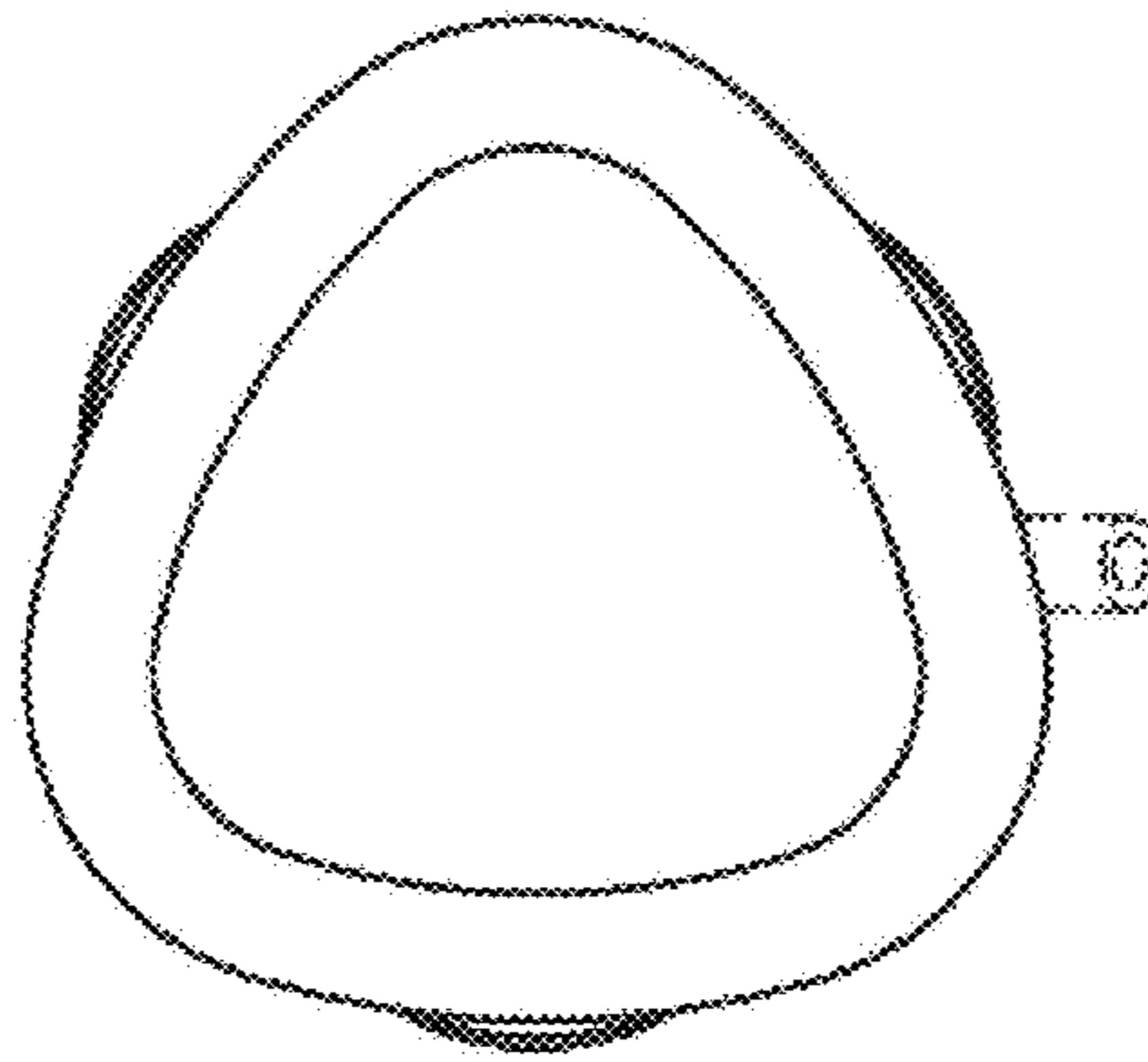

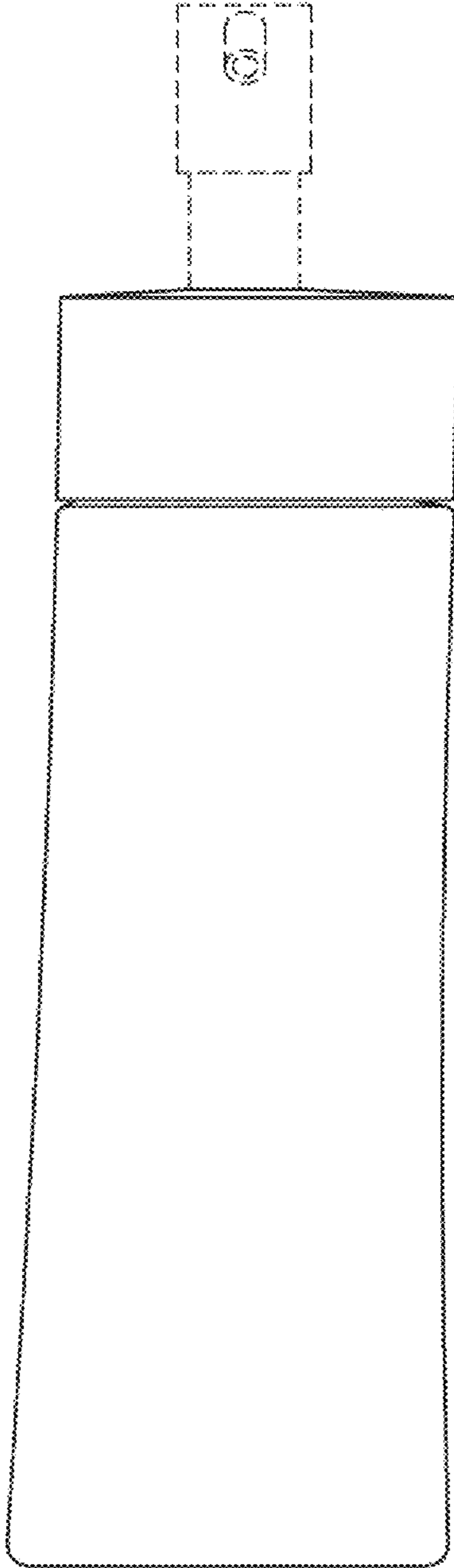

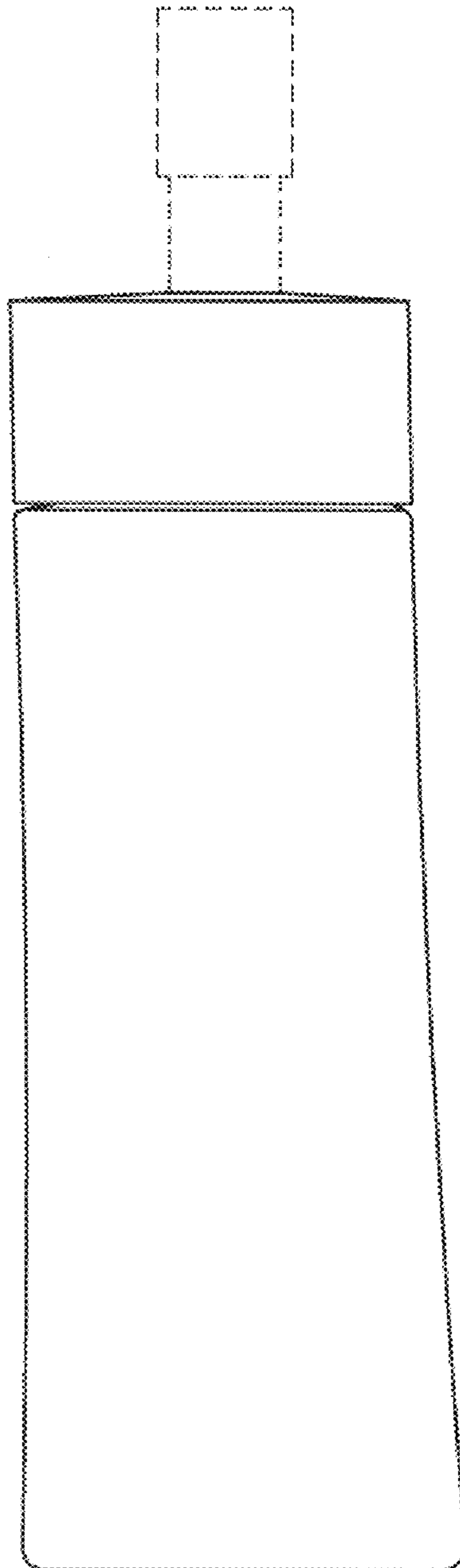
