(57) **CLAIM**

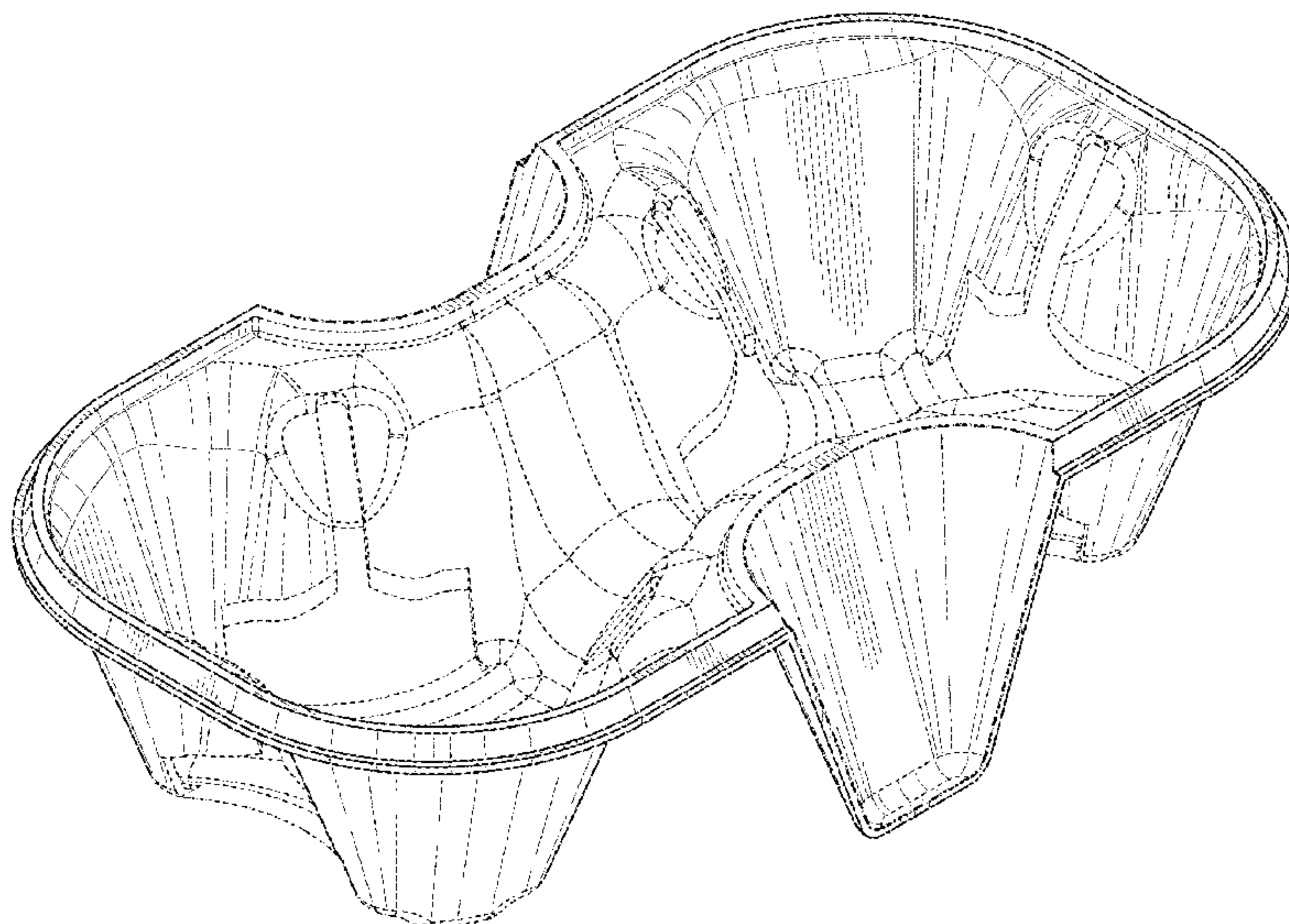
The ornamental design for a cup carrier, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cup carrier showing the new design;

FIG. 5 is a rear elevation view thereof;  
FIG. 6 is a top plan view thereof; and,

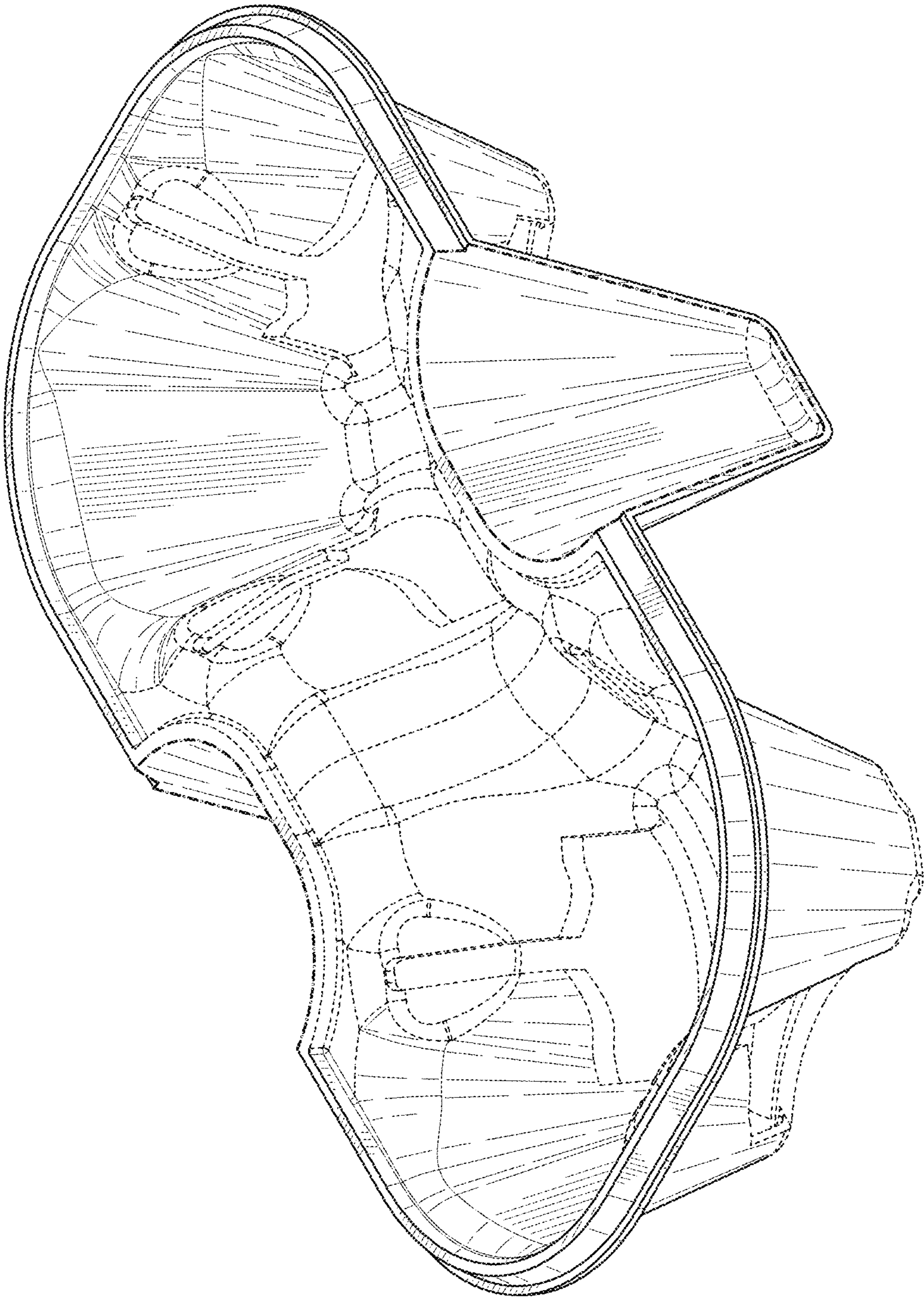

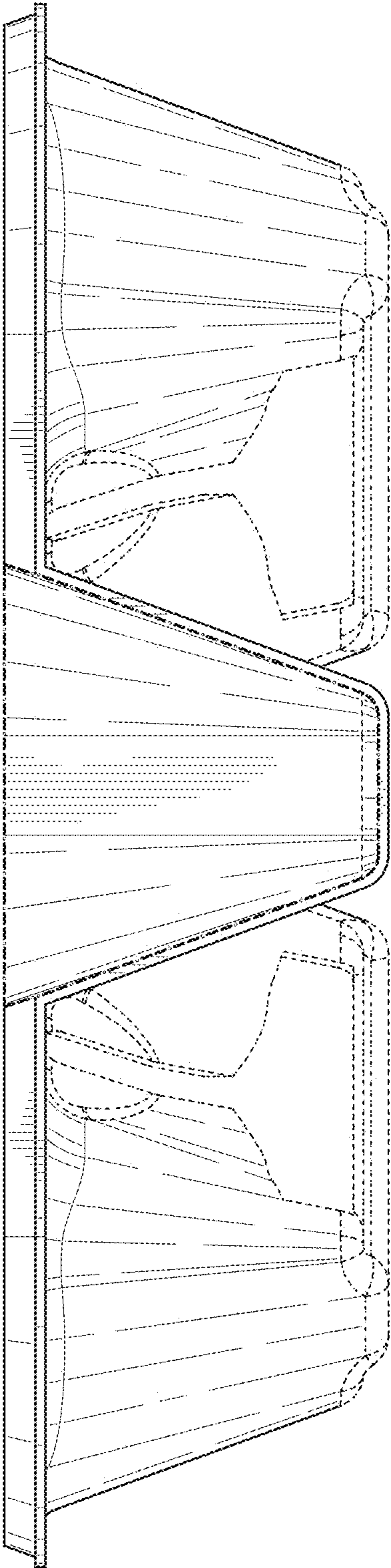

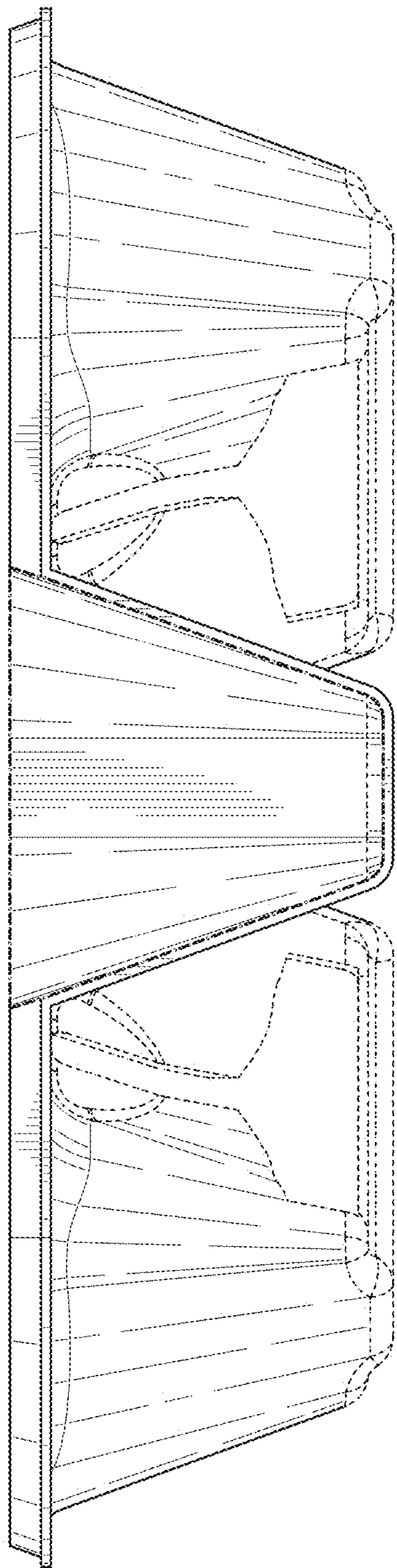

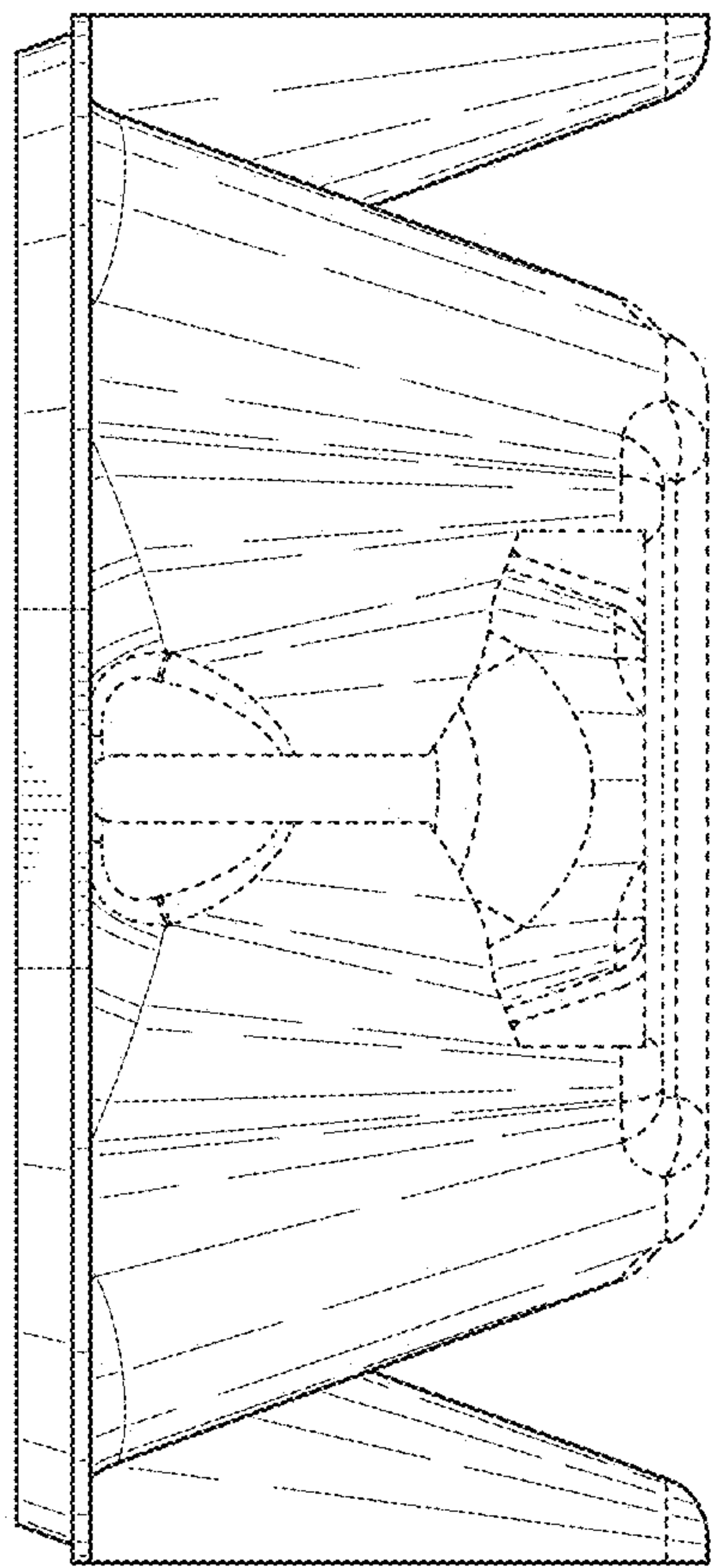

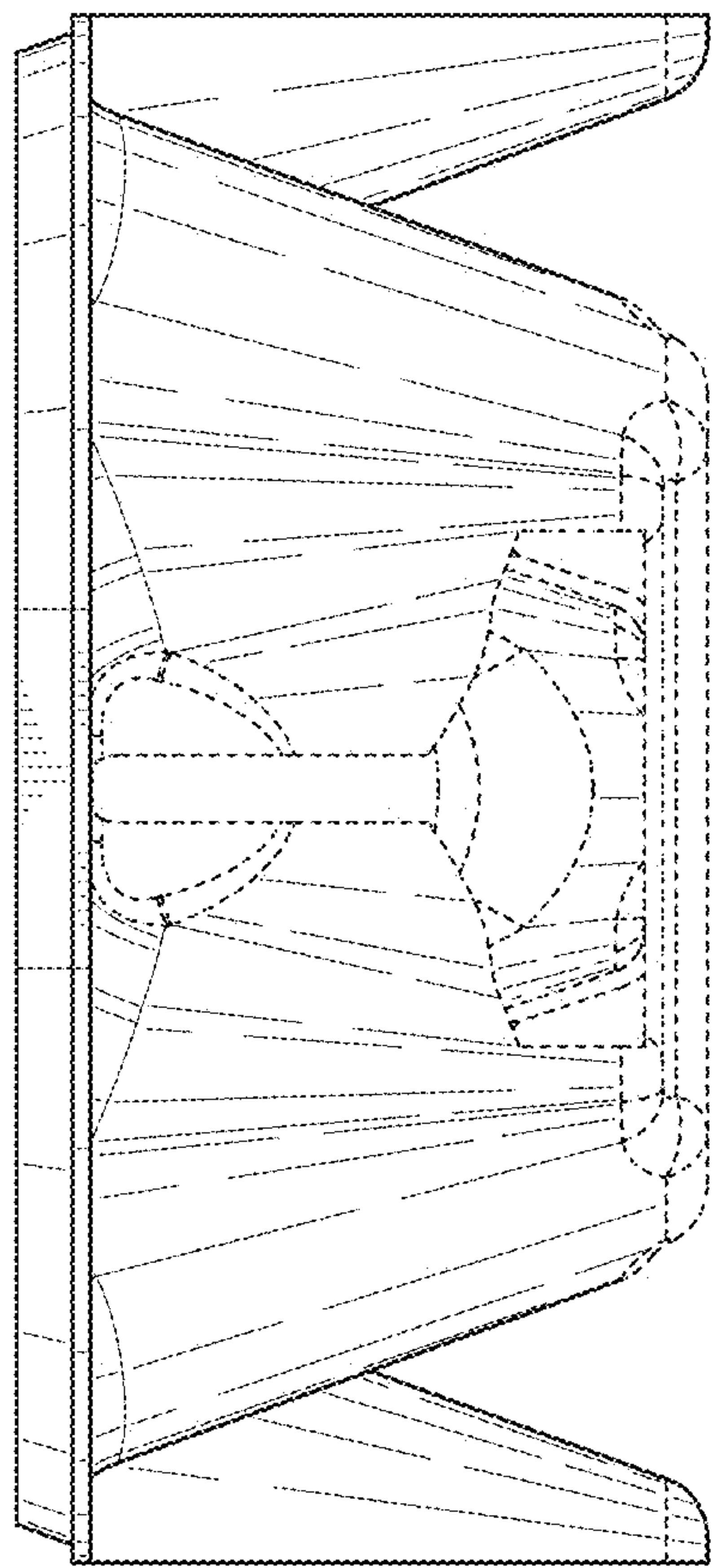

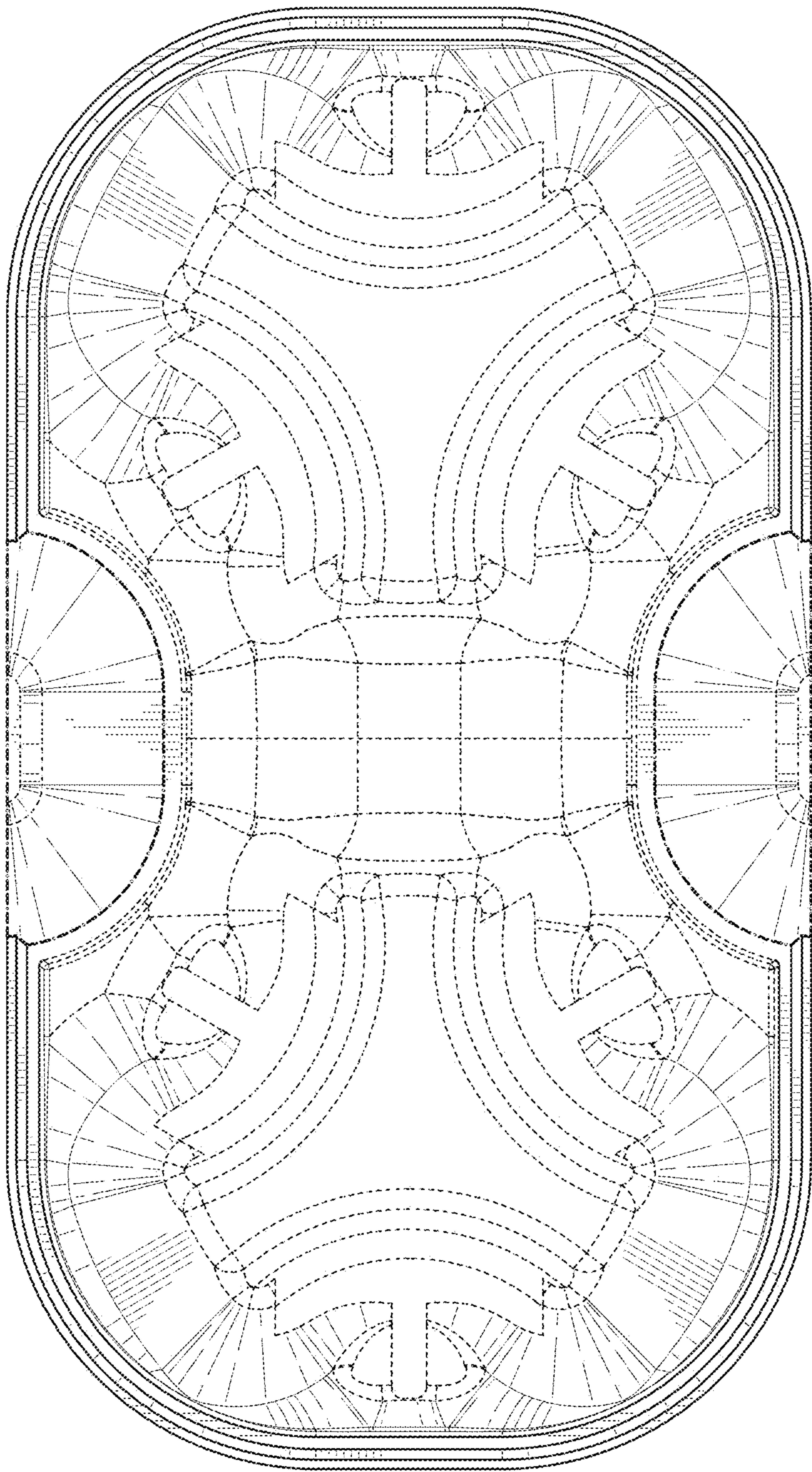

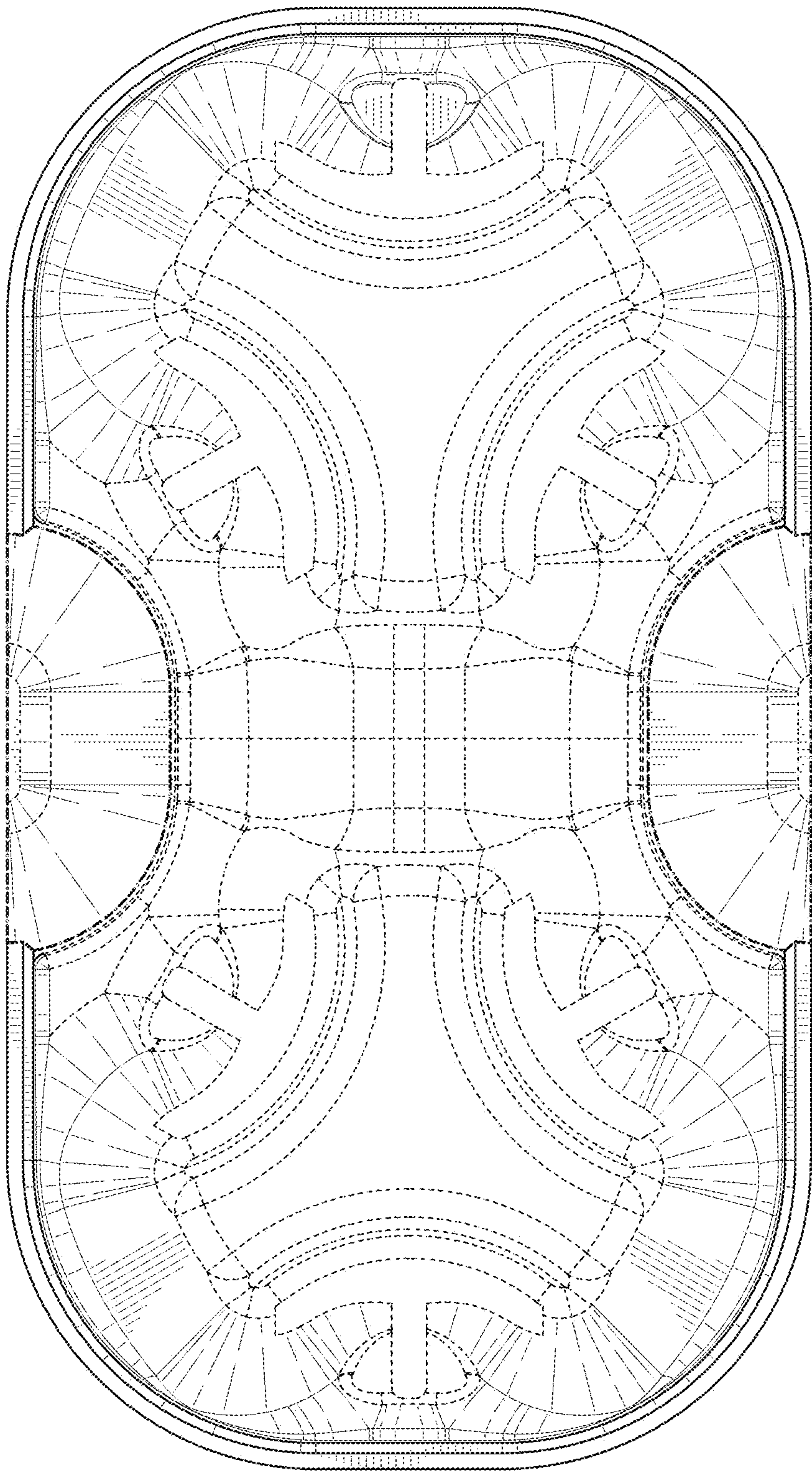
