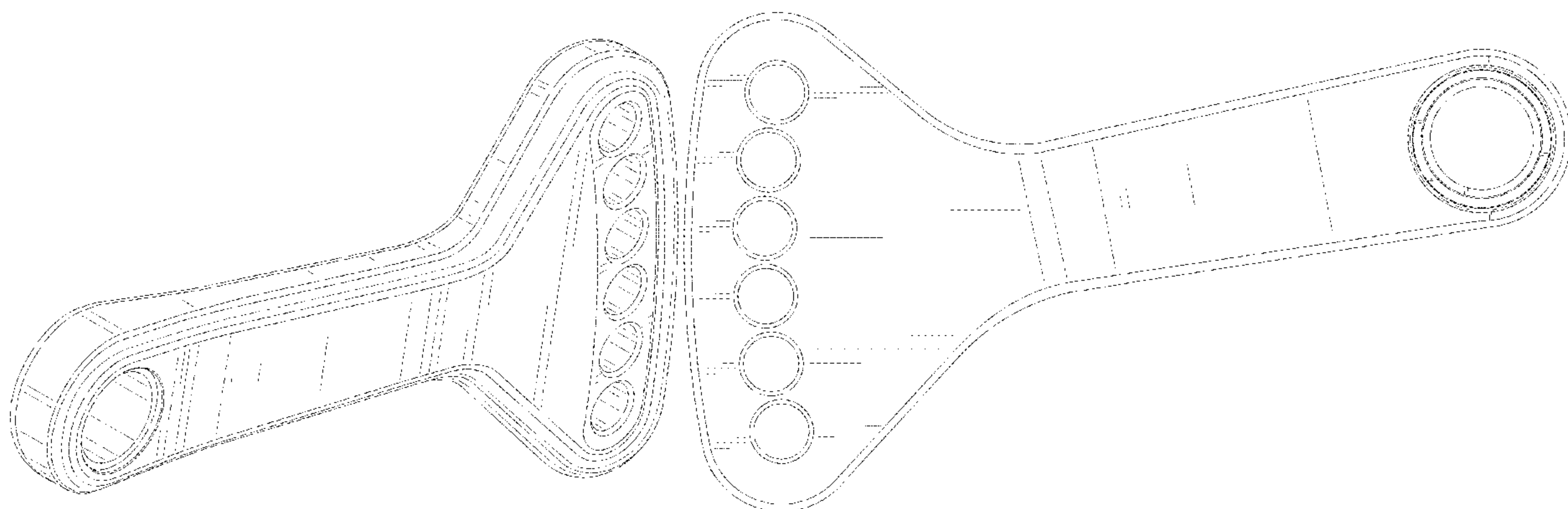
The ornamental design for an adjustable crank arm, as shown and described.

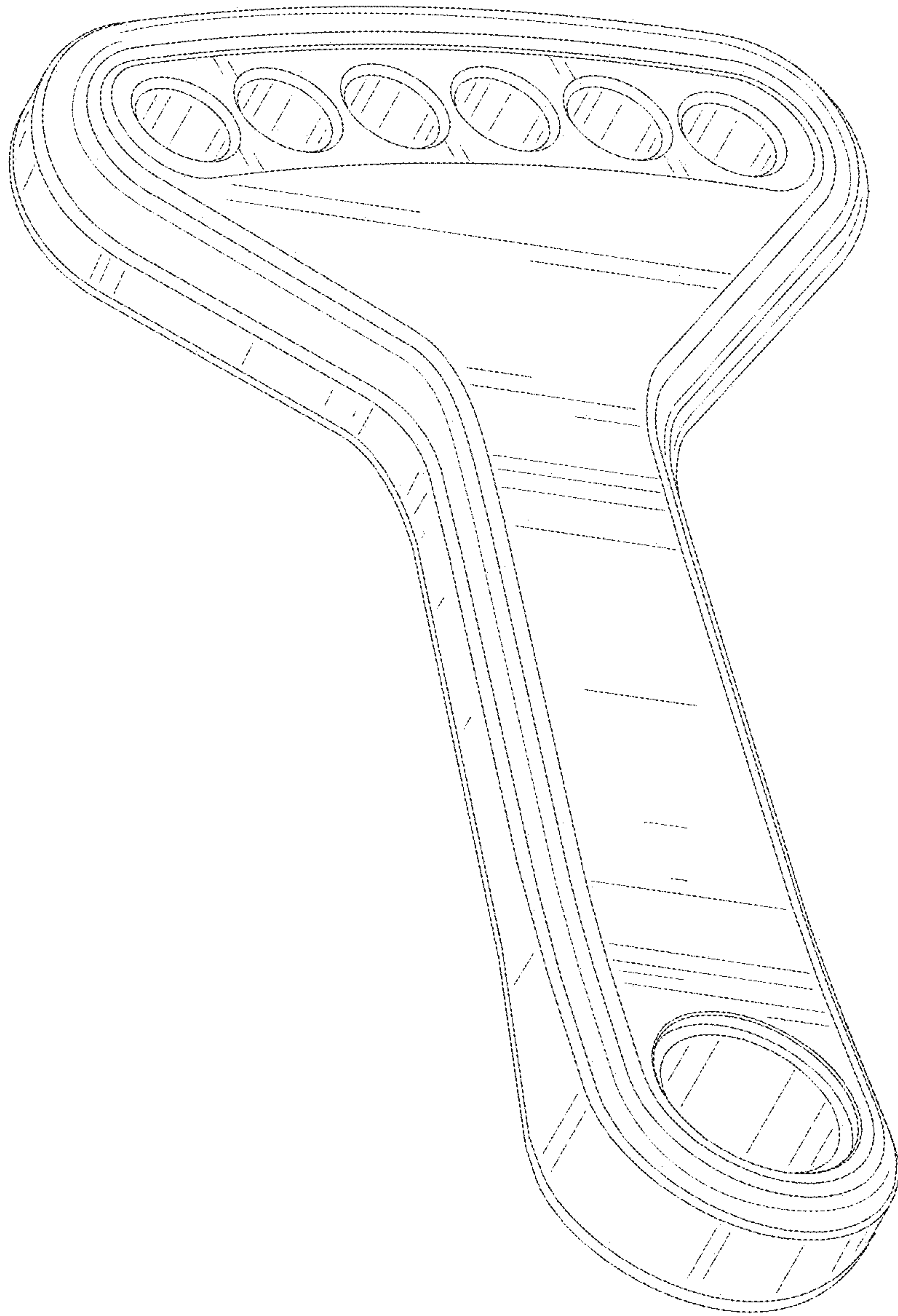

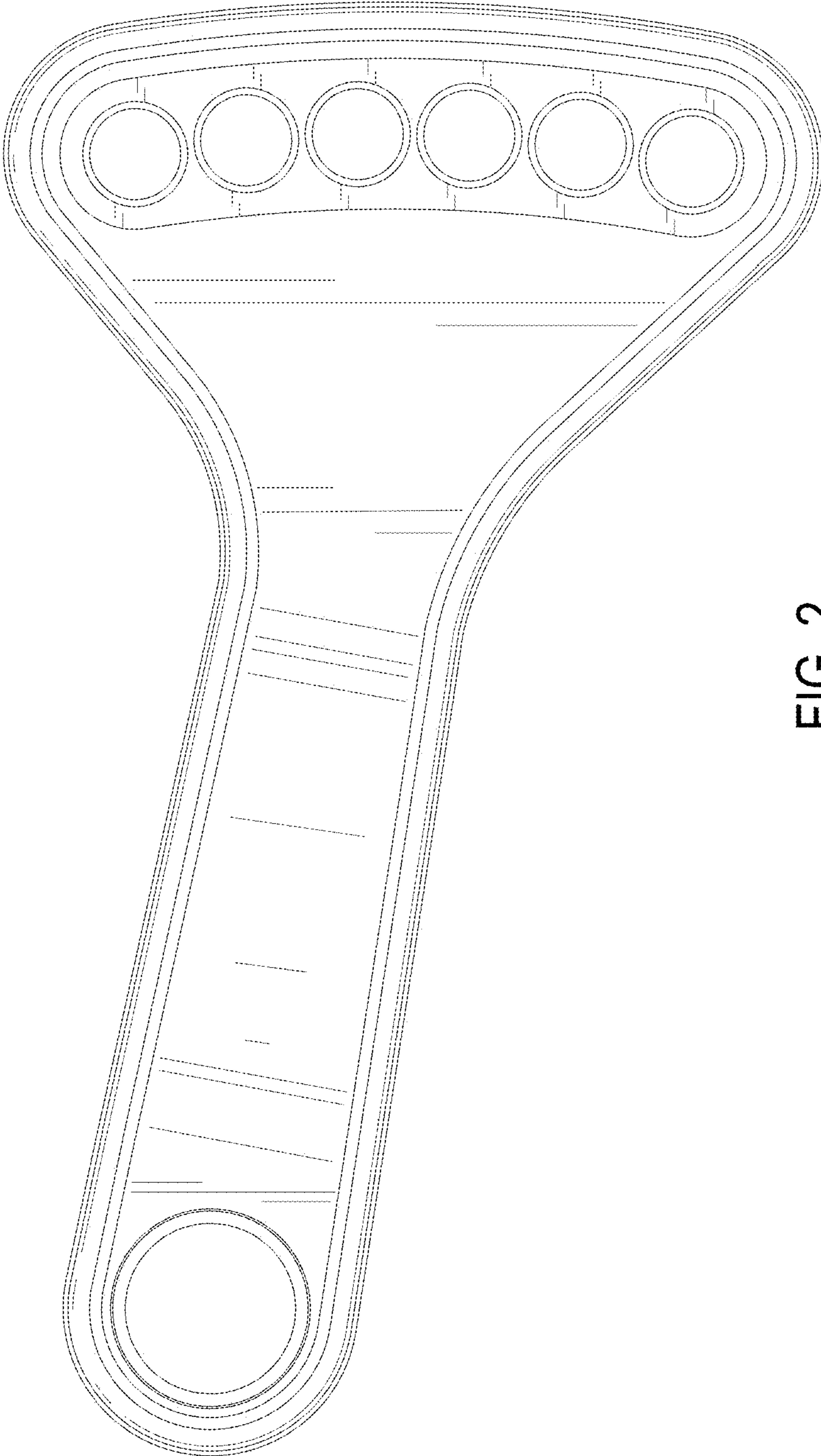

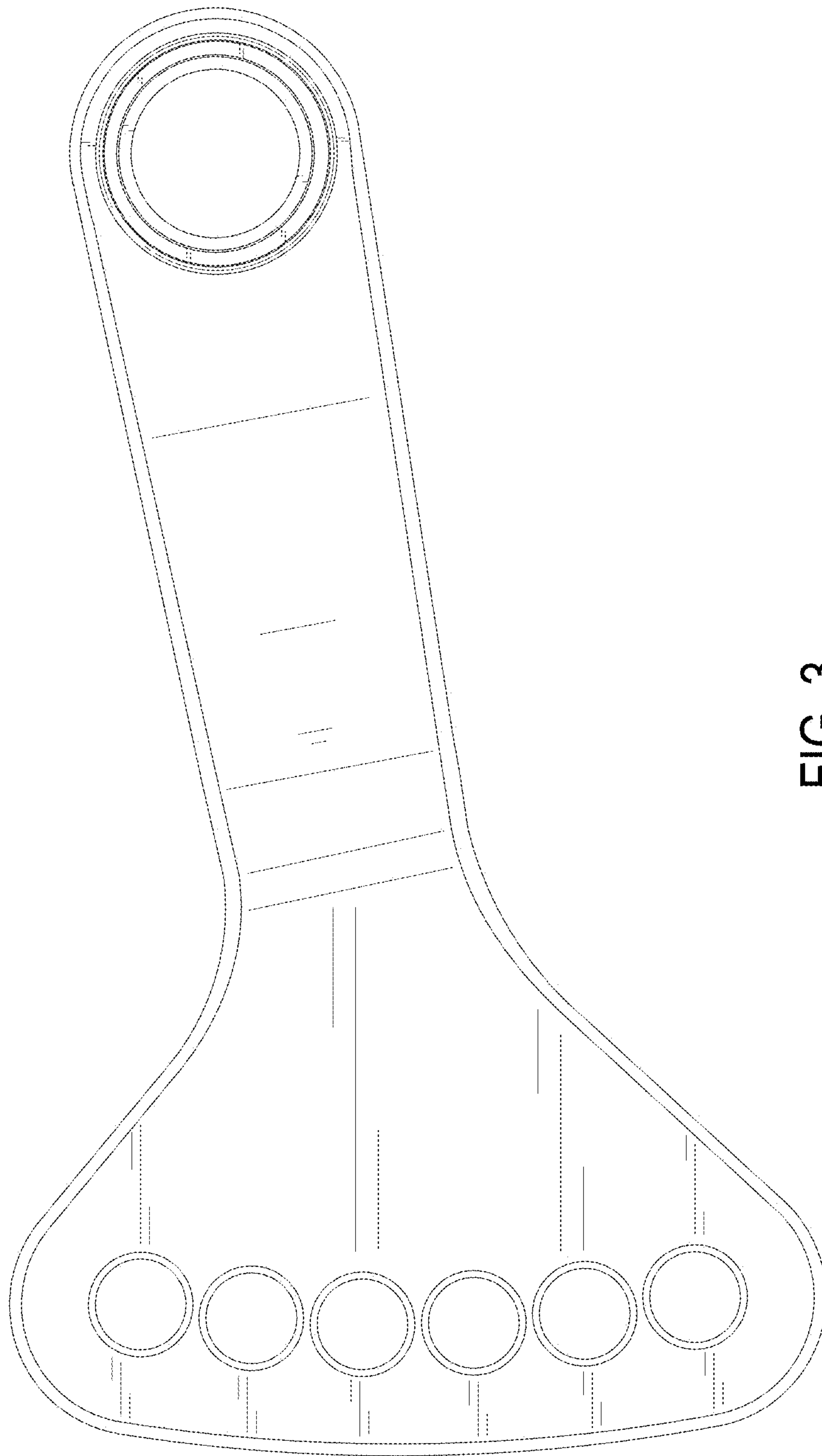

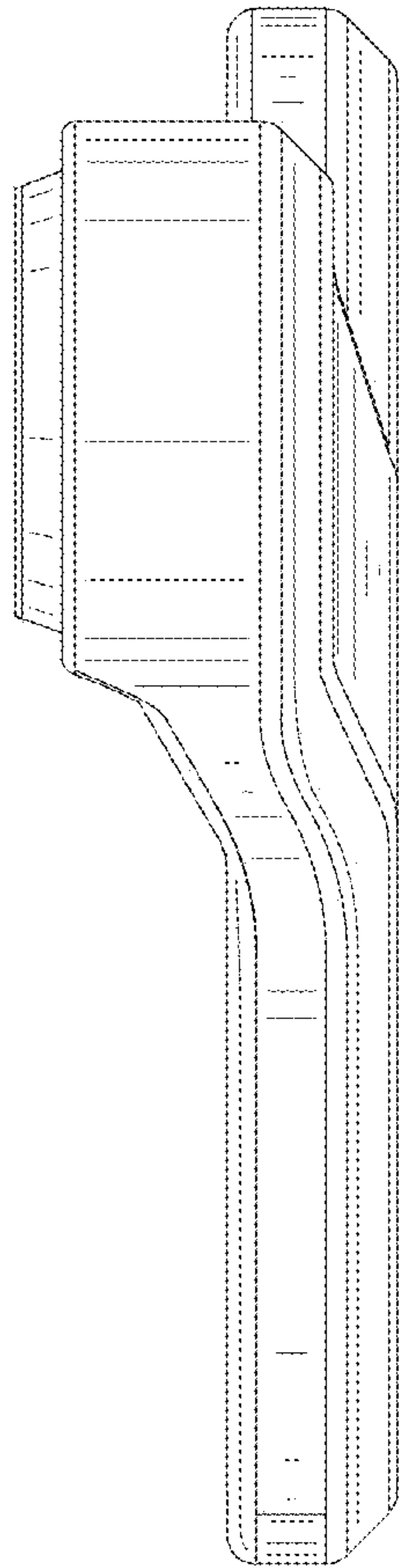

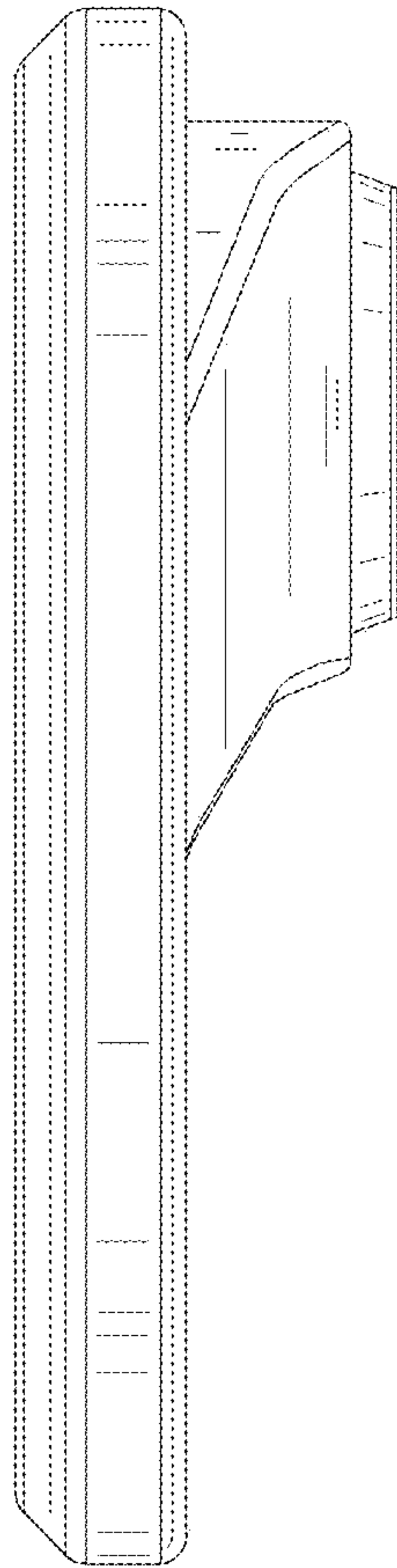

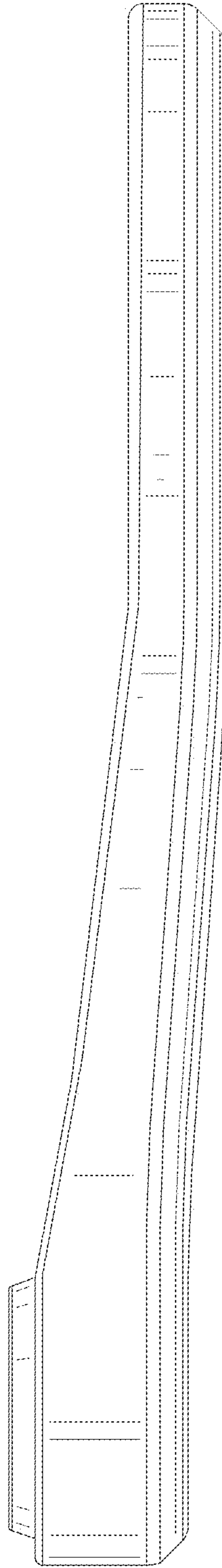

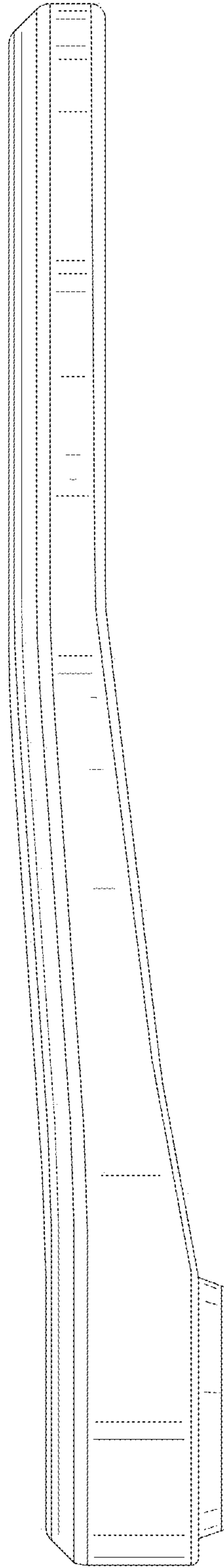
