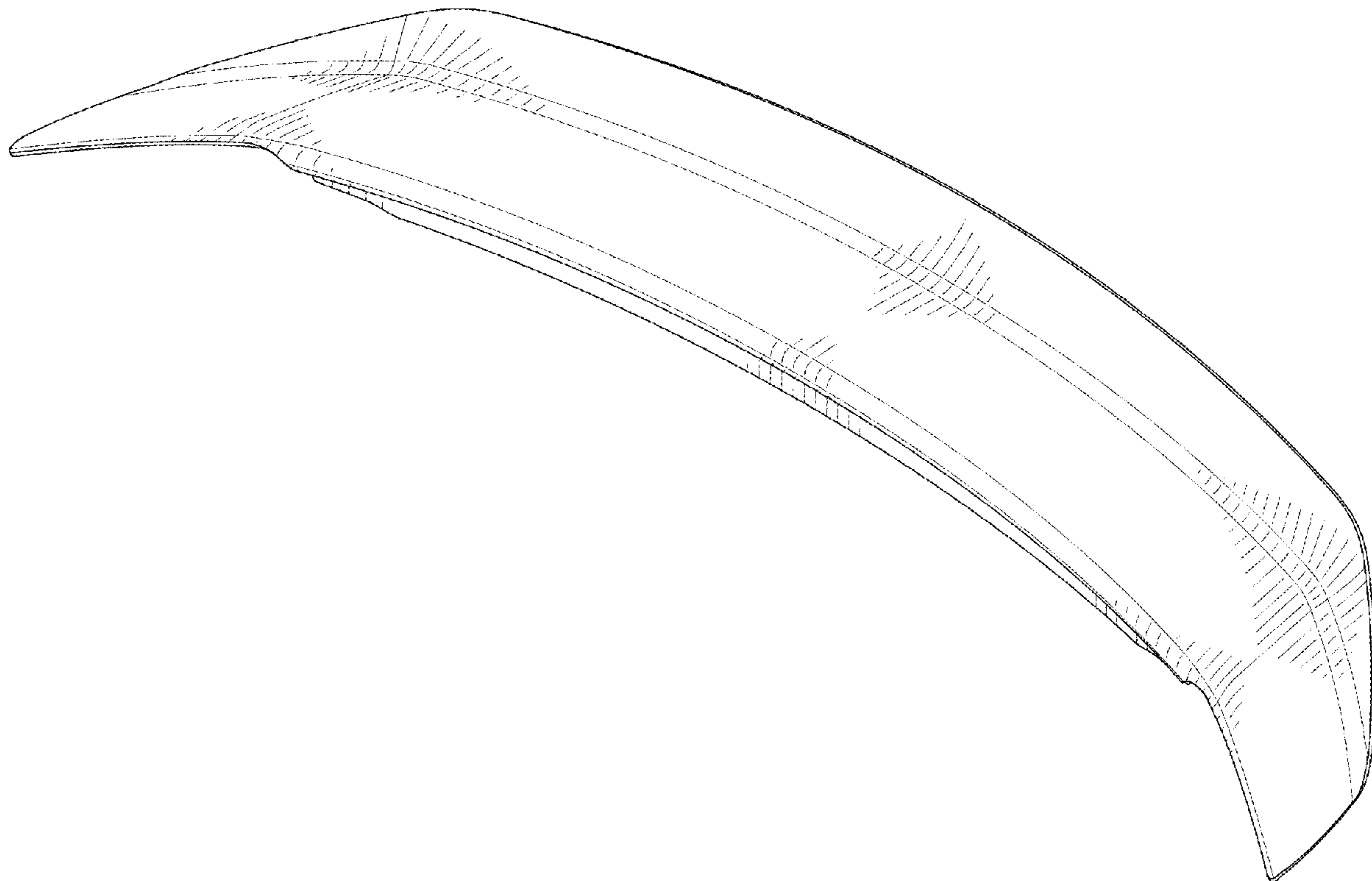
The ornamental design for a vehicle rear spoiler, as shown and described.

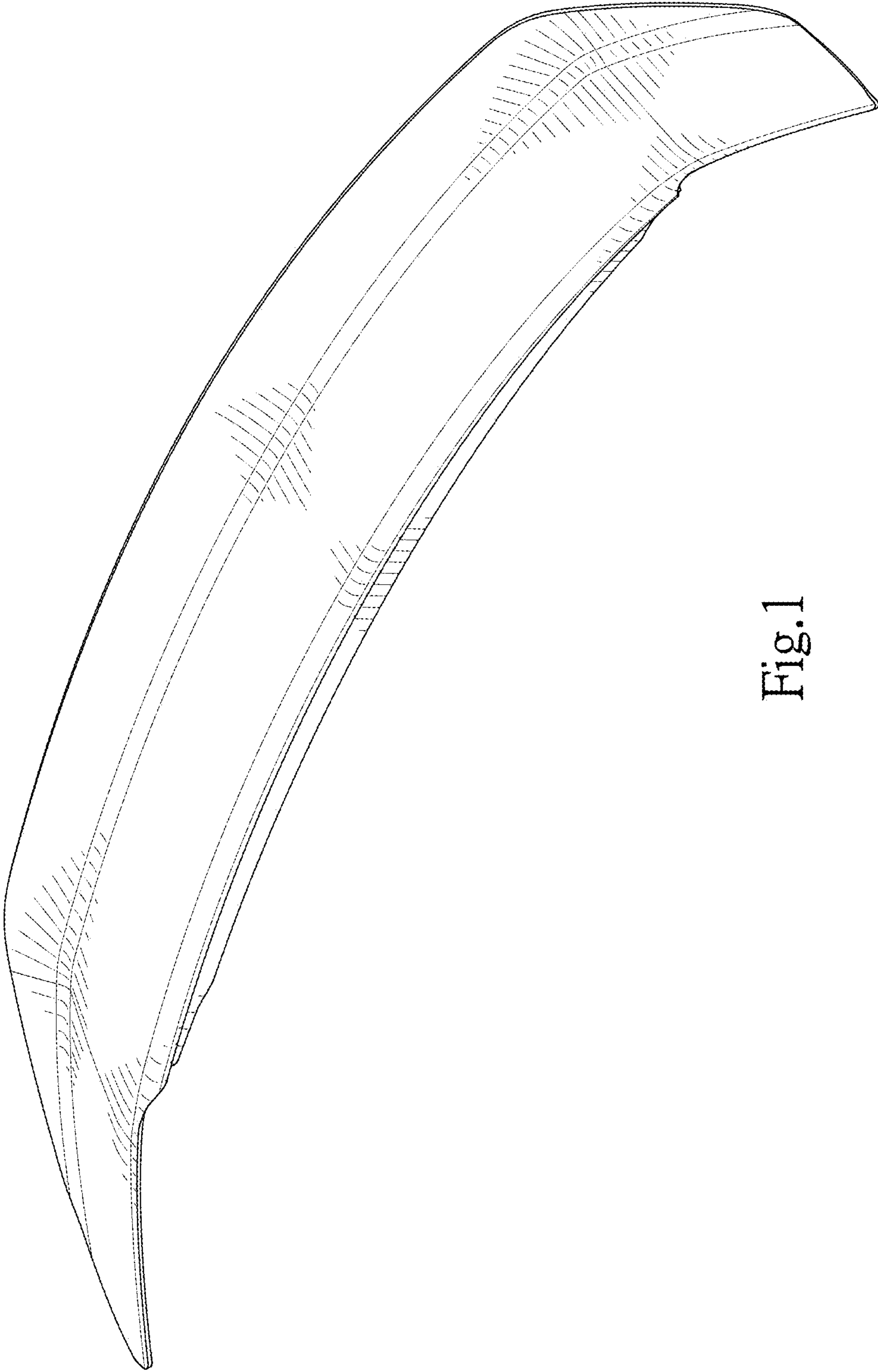

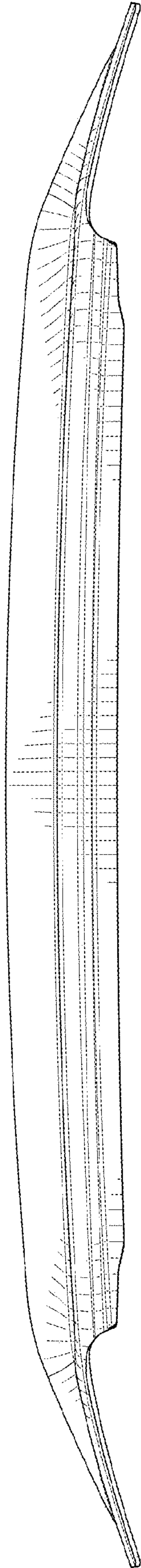

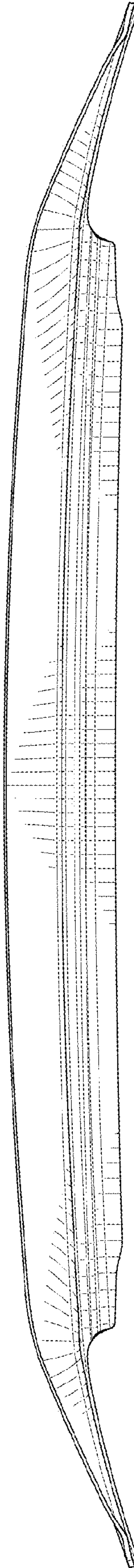

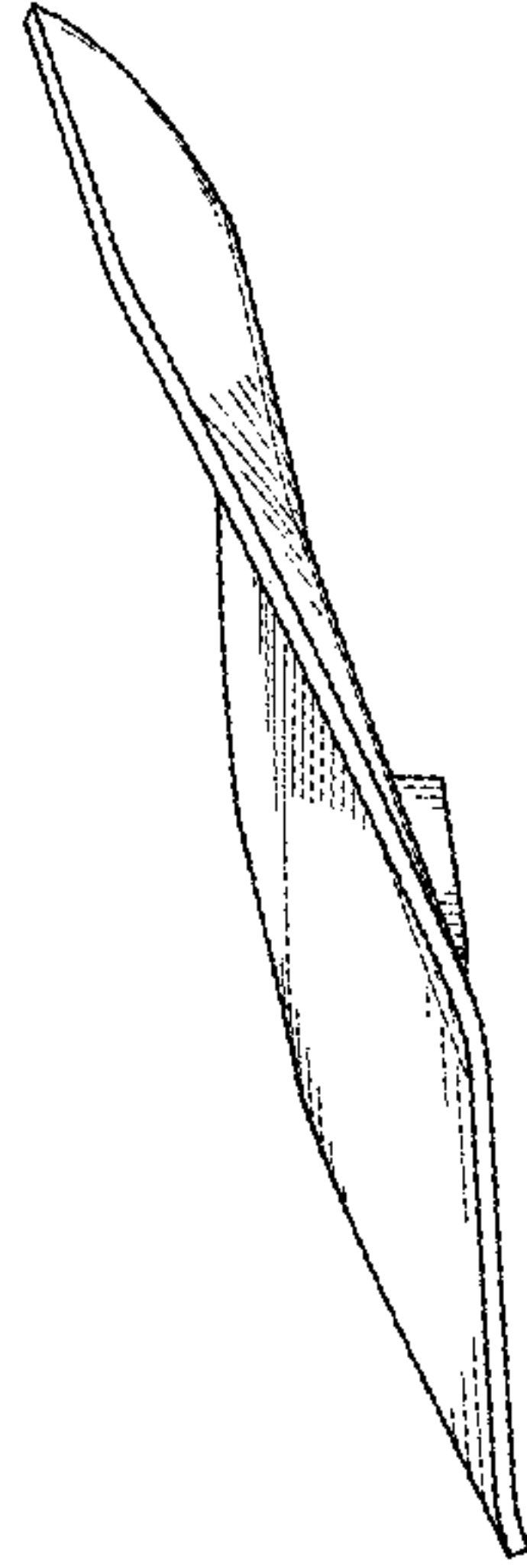

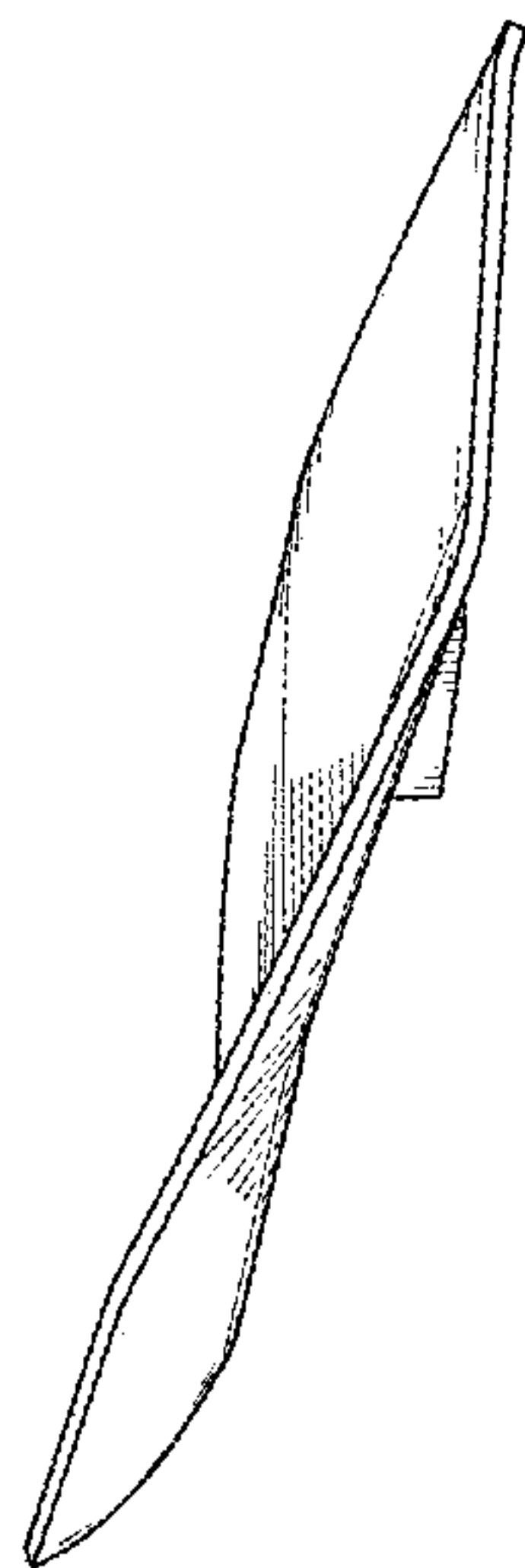

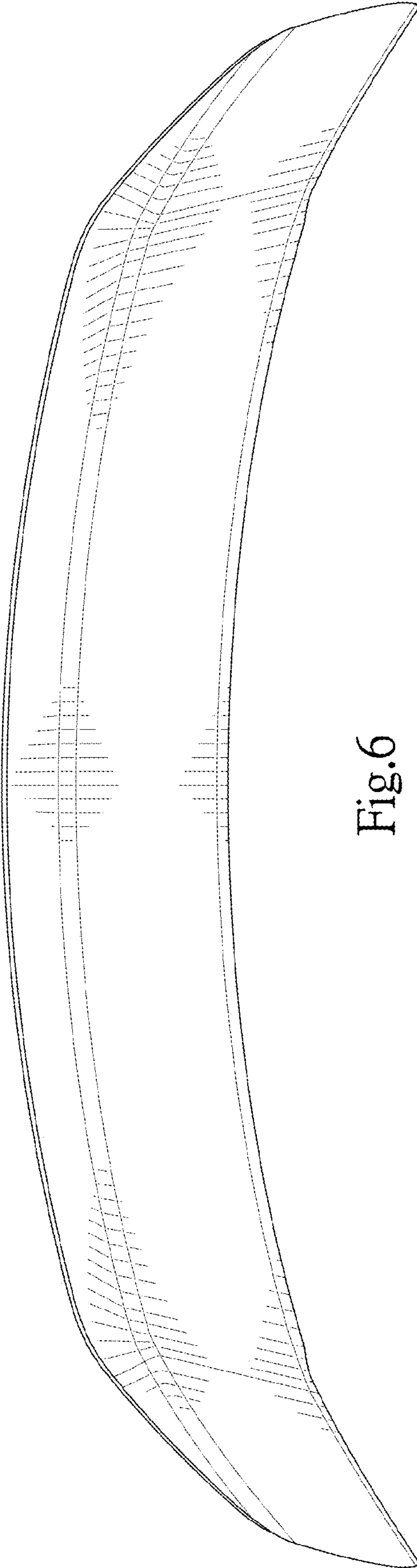

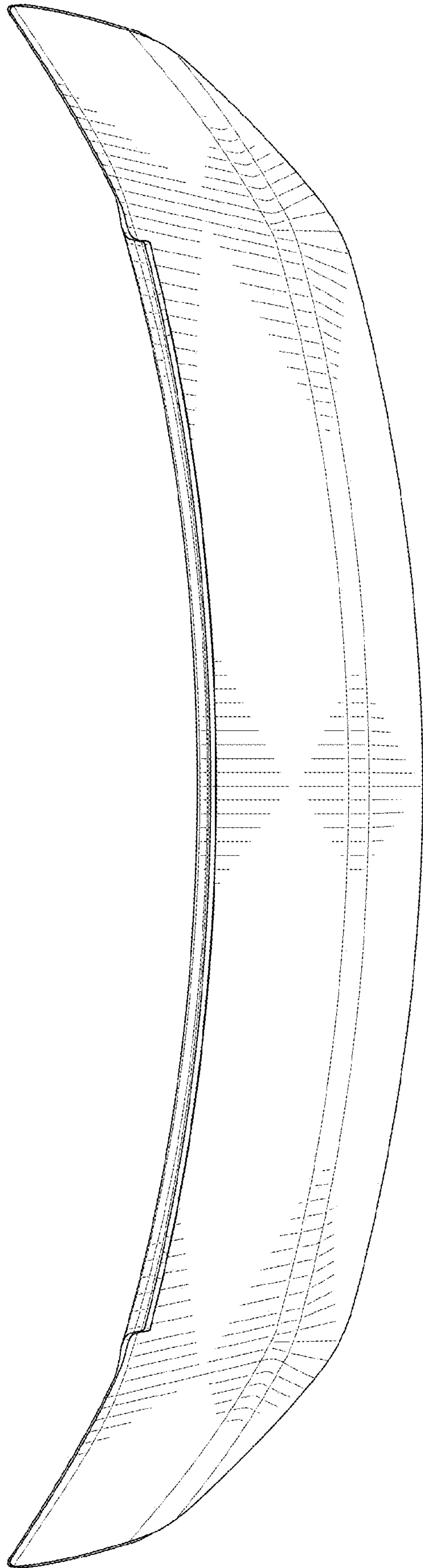

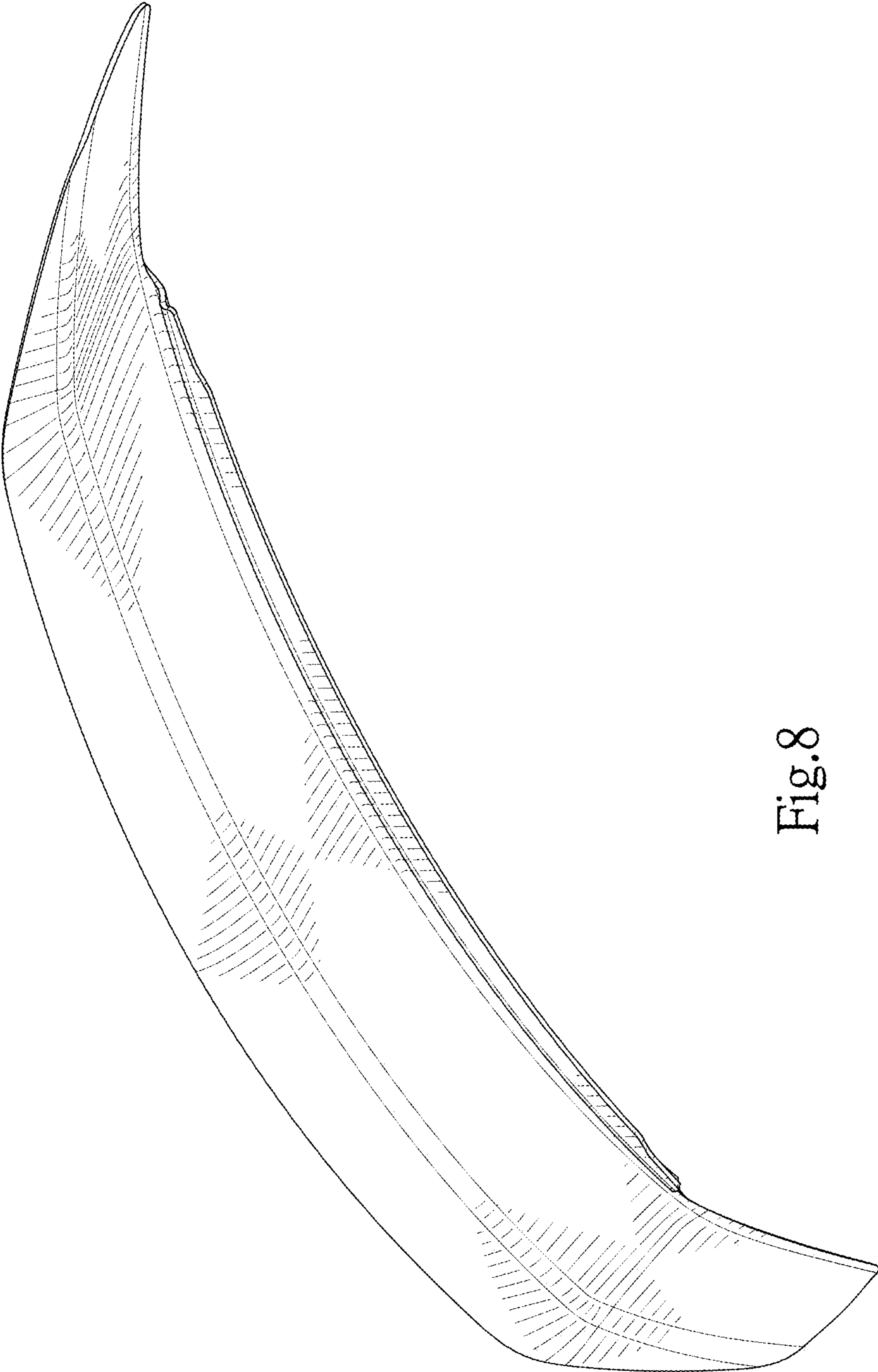
