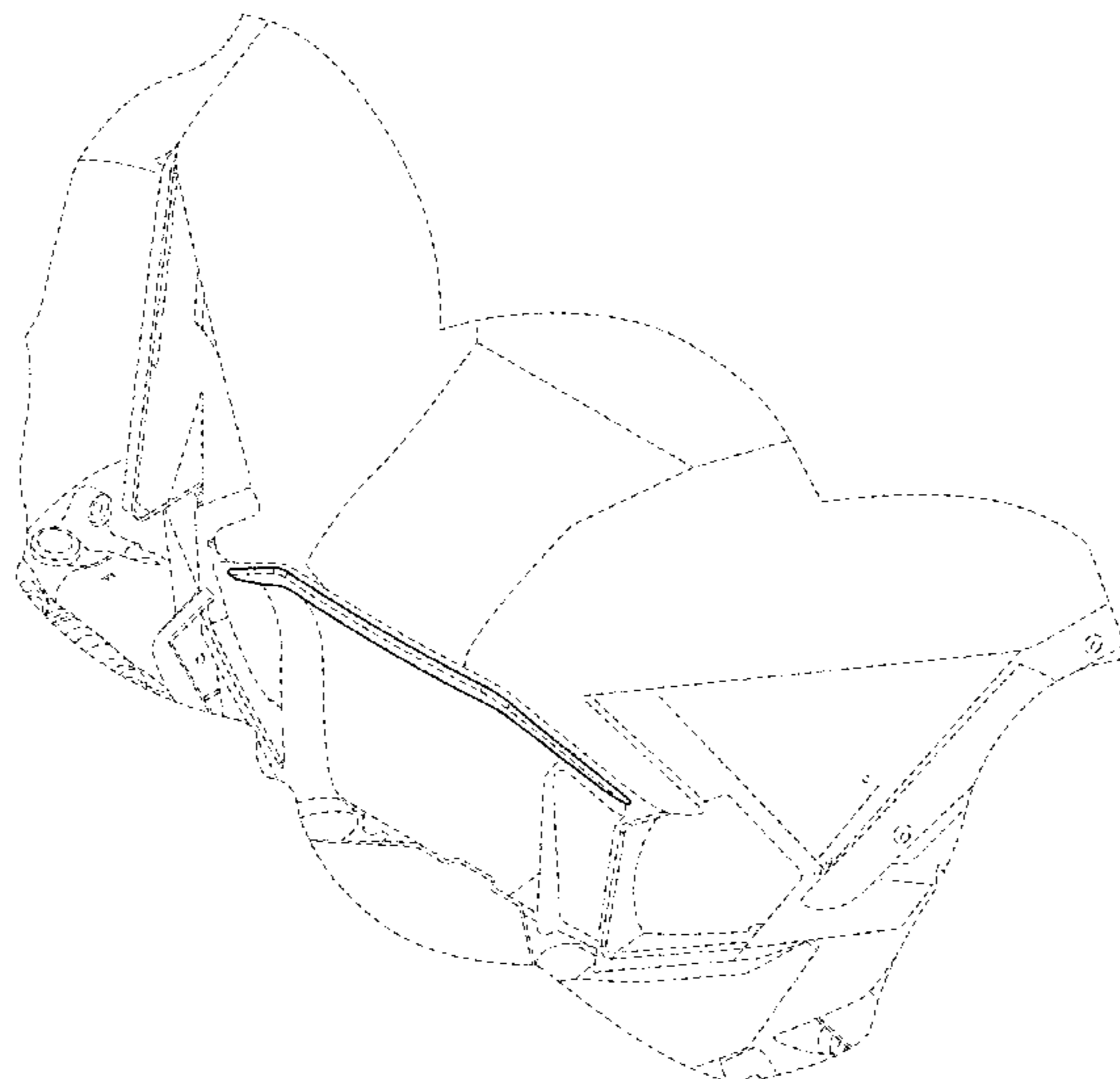
(57) **CLAIM**

We claim the ornamental design for the vehicle light, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of a vehicle light showing our new design, the front right perspective view being a mirror image thereof; FIG. 2 is a front view thereof; and, FIG. 3 is a left side view thereof, the right-side view being a mirror image thereof. The portions of the vehicle and the vehicle components shown in broken lines form no part of the claimed design.

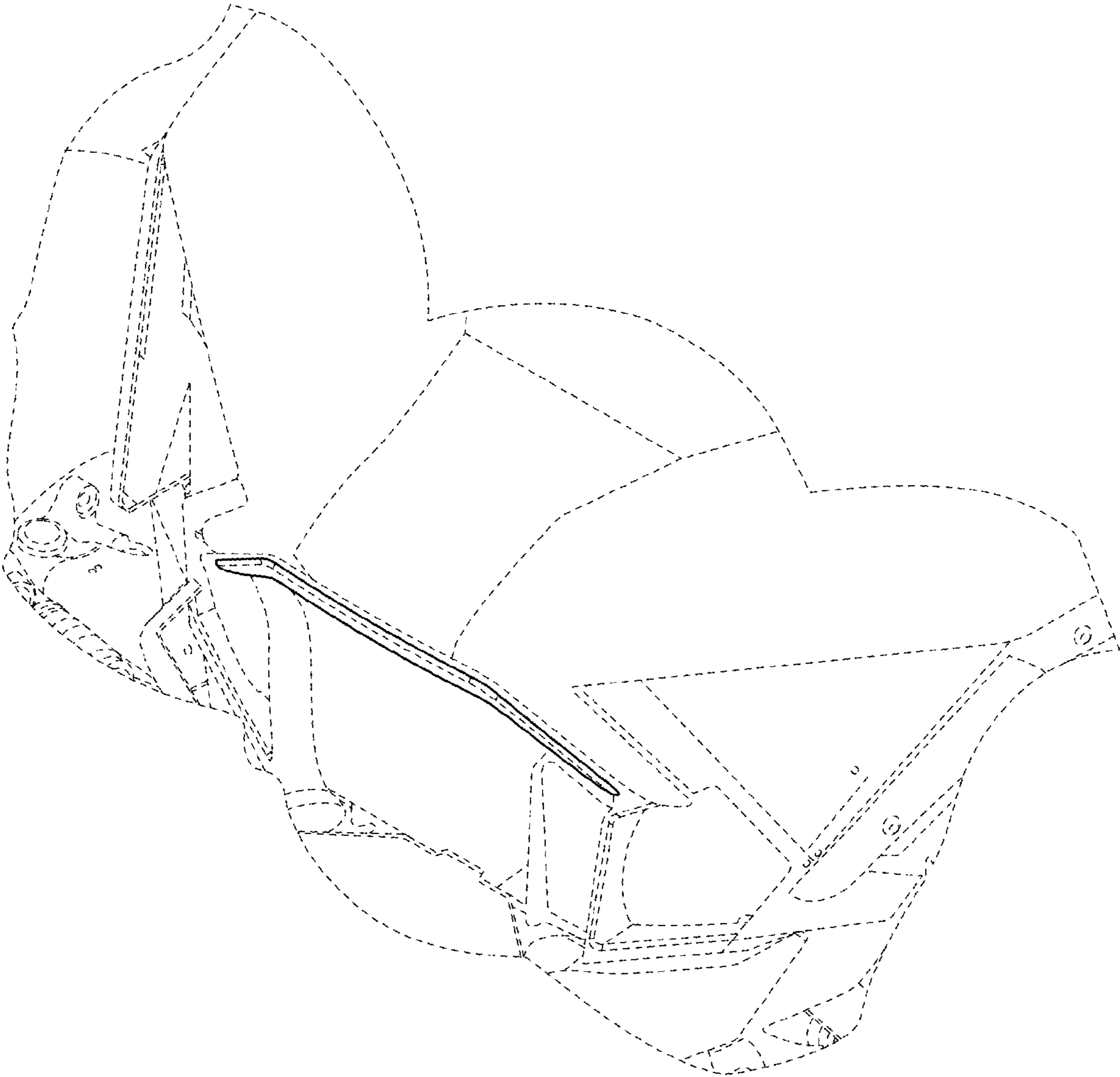

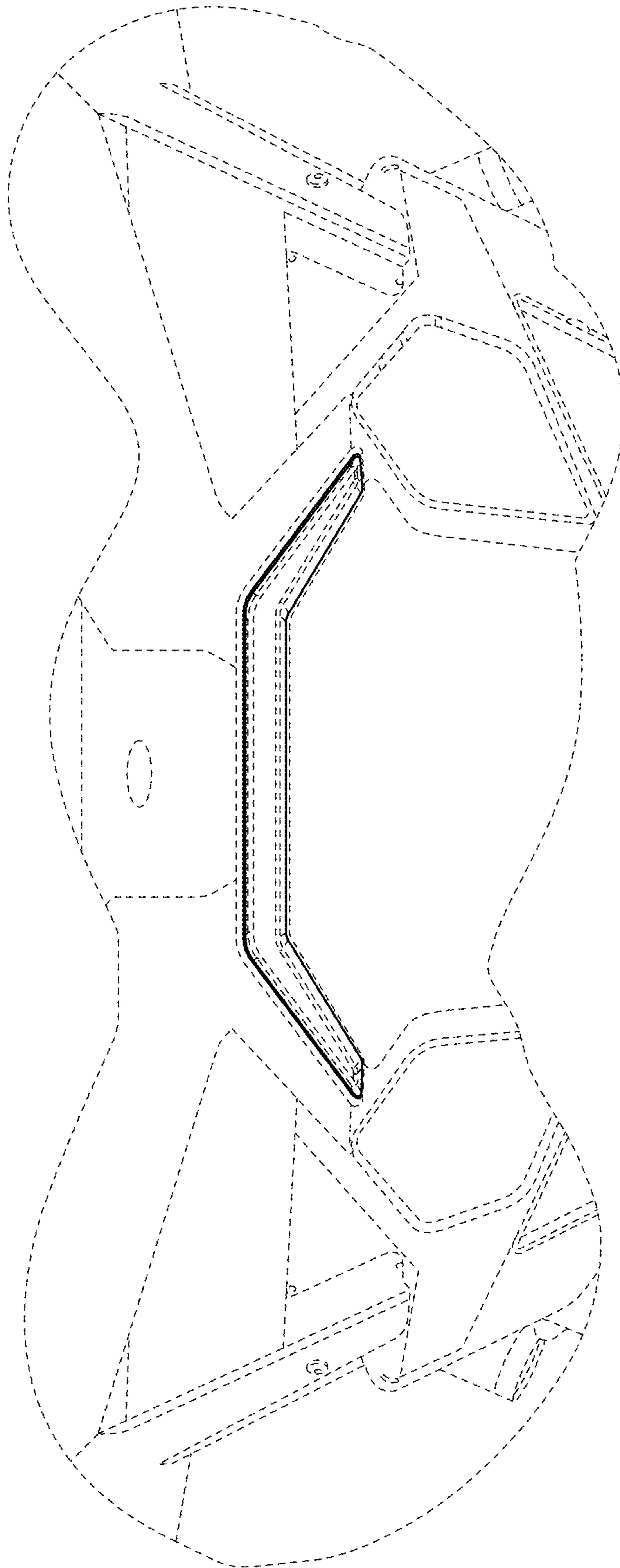

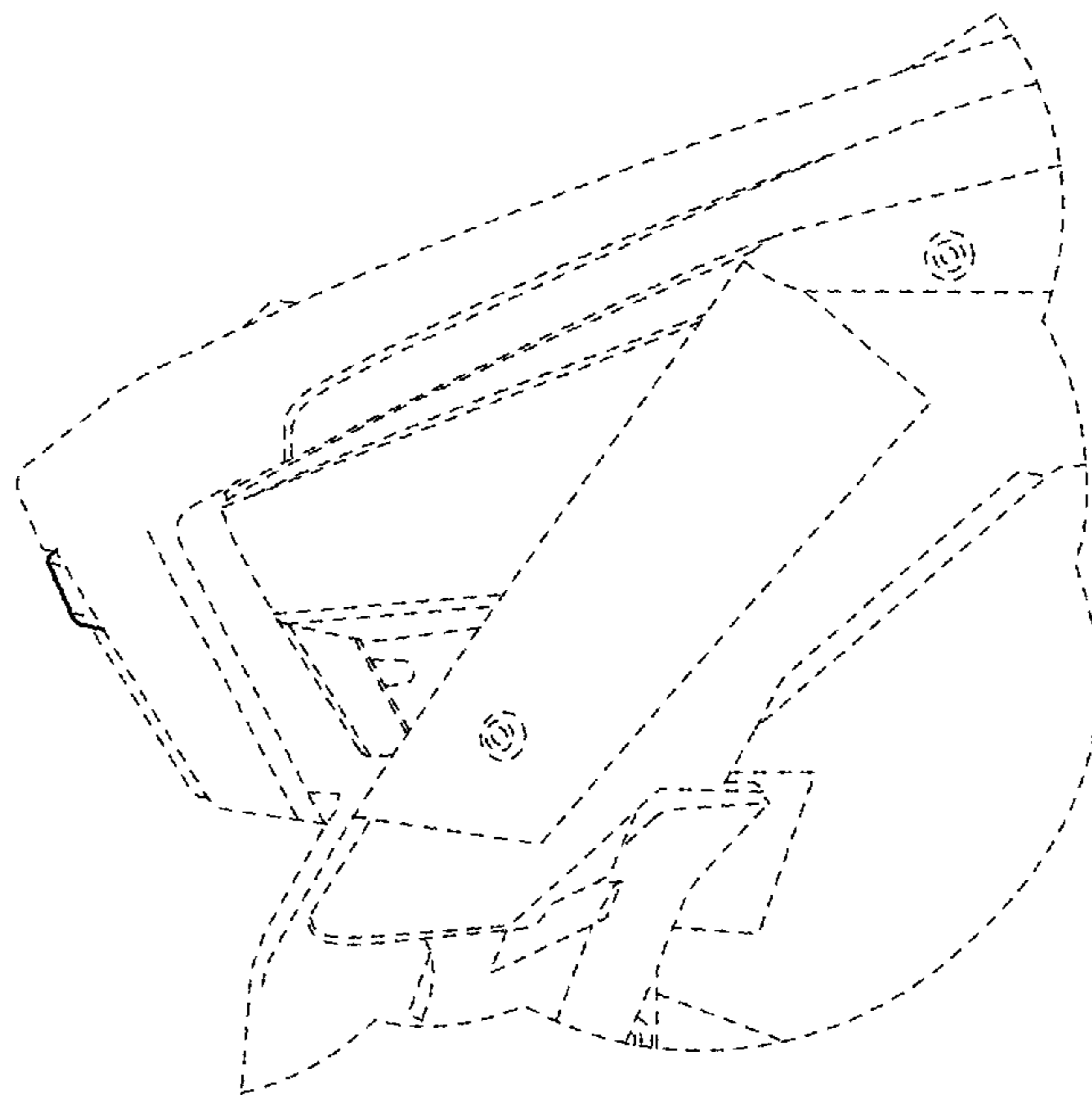
