**DESCRIPTION**

FIG. 1 is a left side elevation view of the tire showing my new invention;

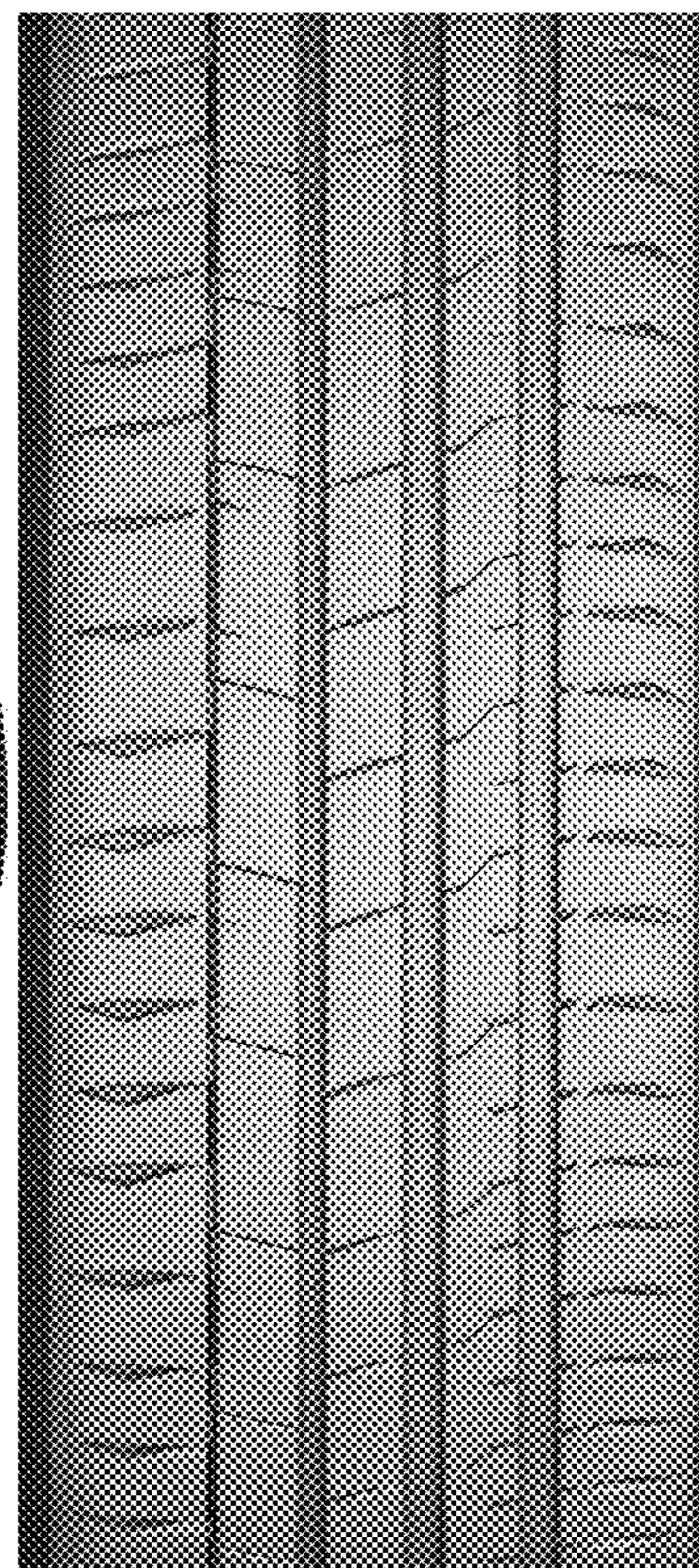

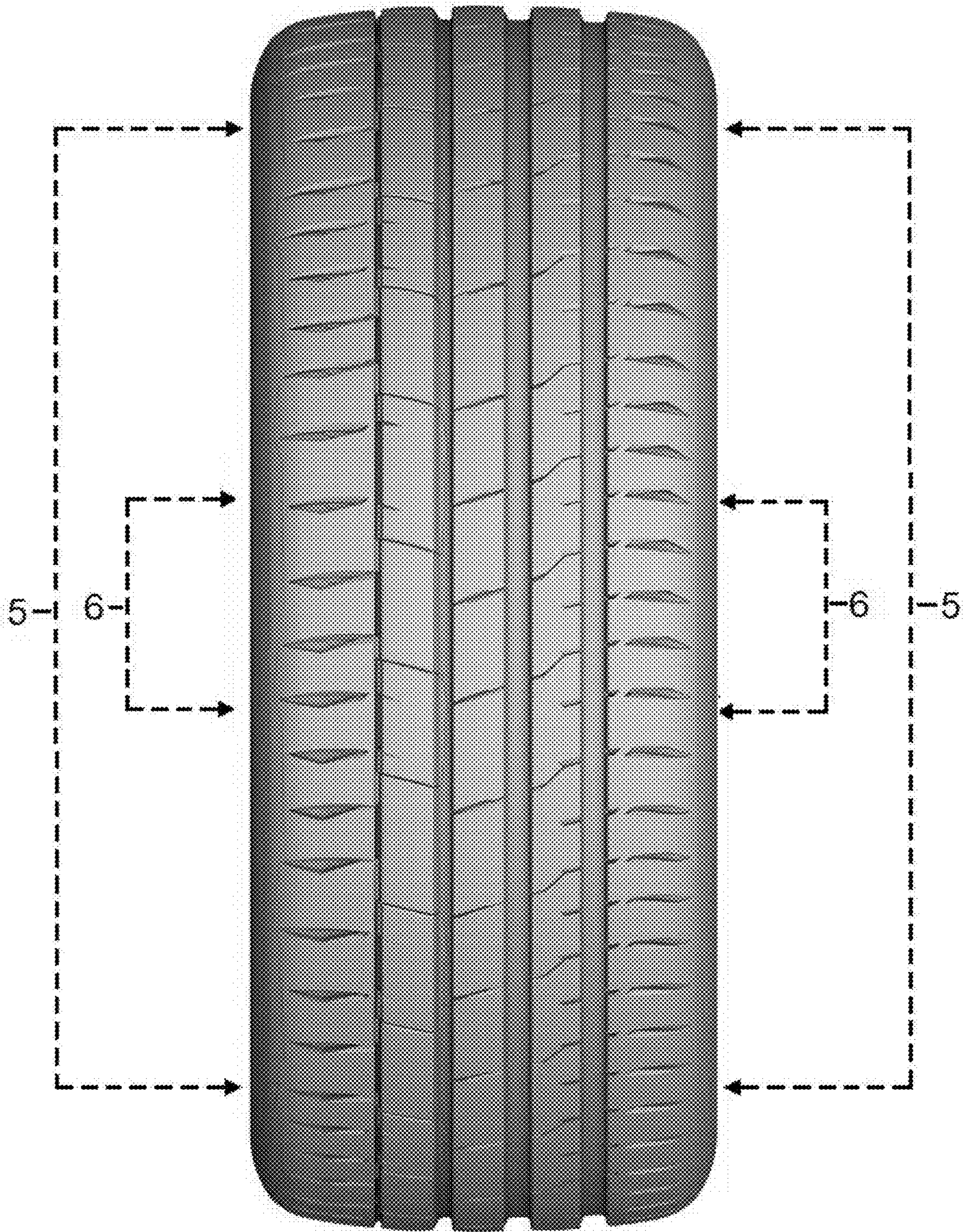

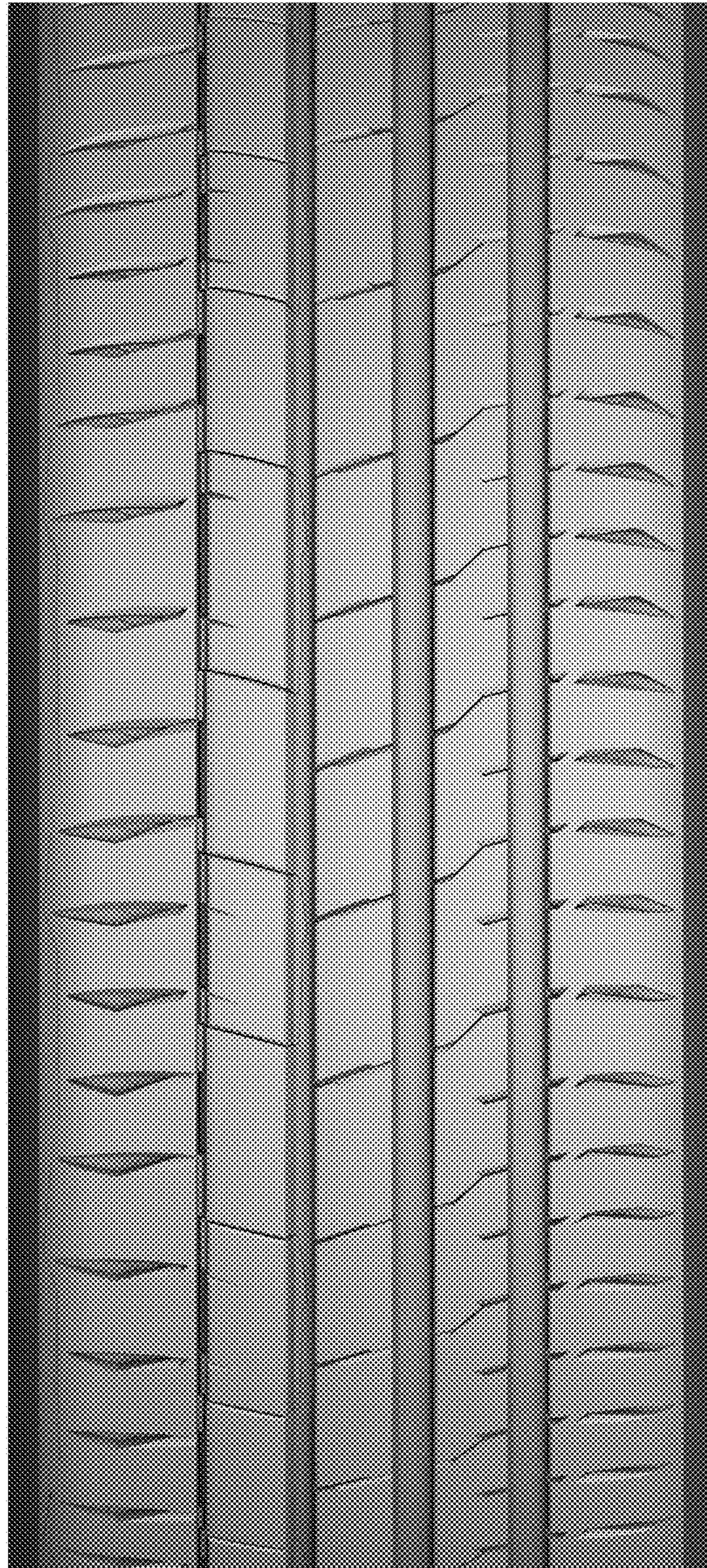

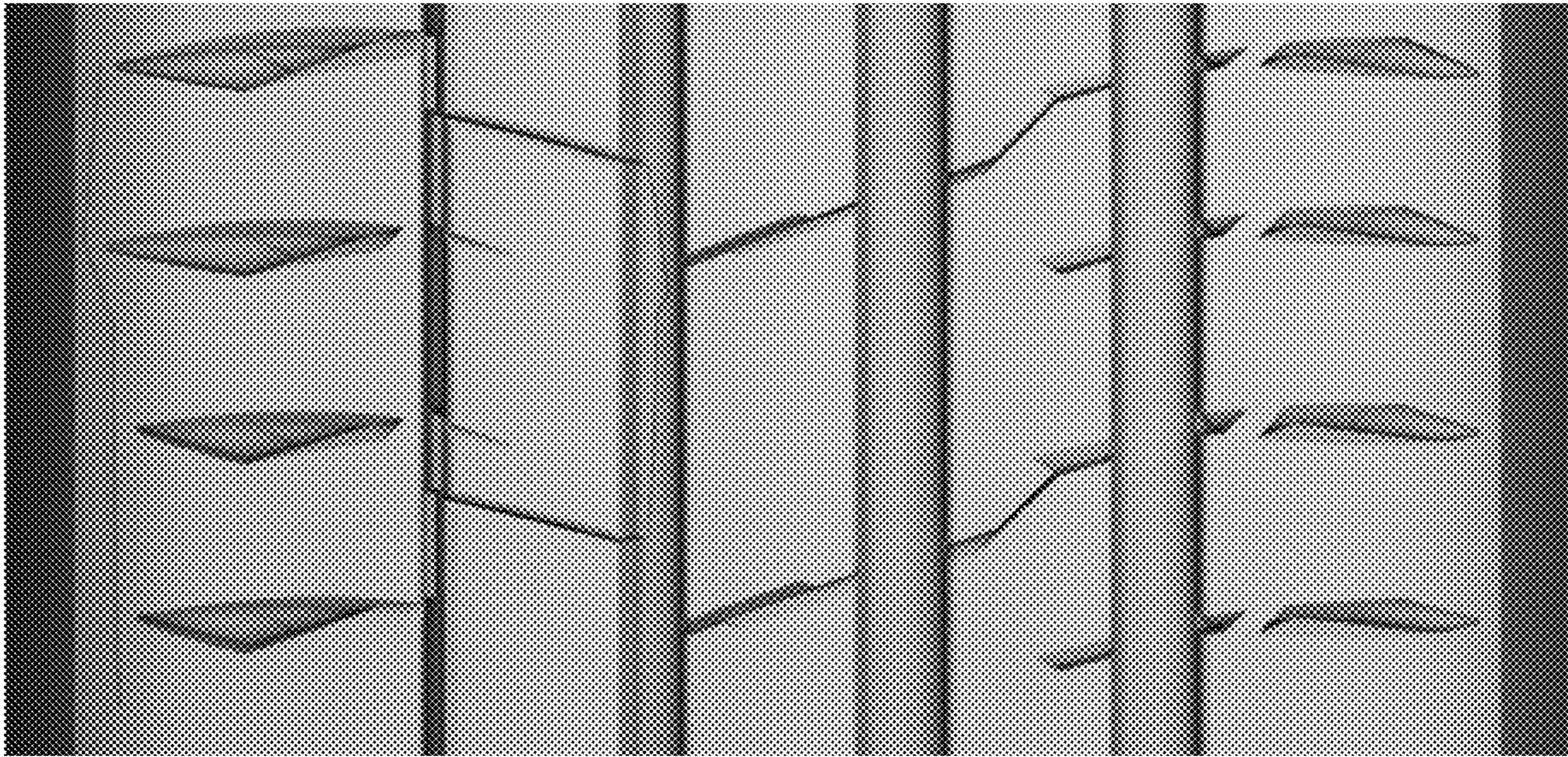
