**DESCRIPTION**  
FIG. 1 is a front elevation view of the tire showing our new invention;  
FIG. 2 is a front perspective view thereof;  
FIG. 3 is a right side elevation view thereof;  
FIG. 4 is a left side elevation view thereof; and,  
FIG. 5 is an enlarged partial front elevation view thereof.

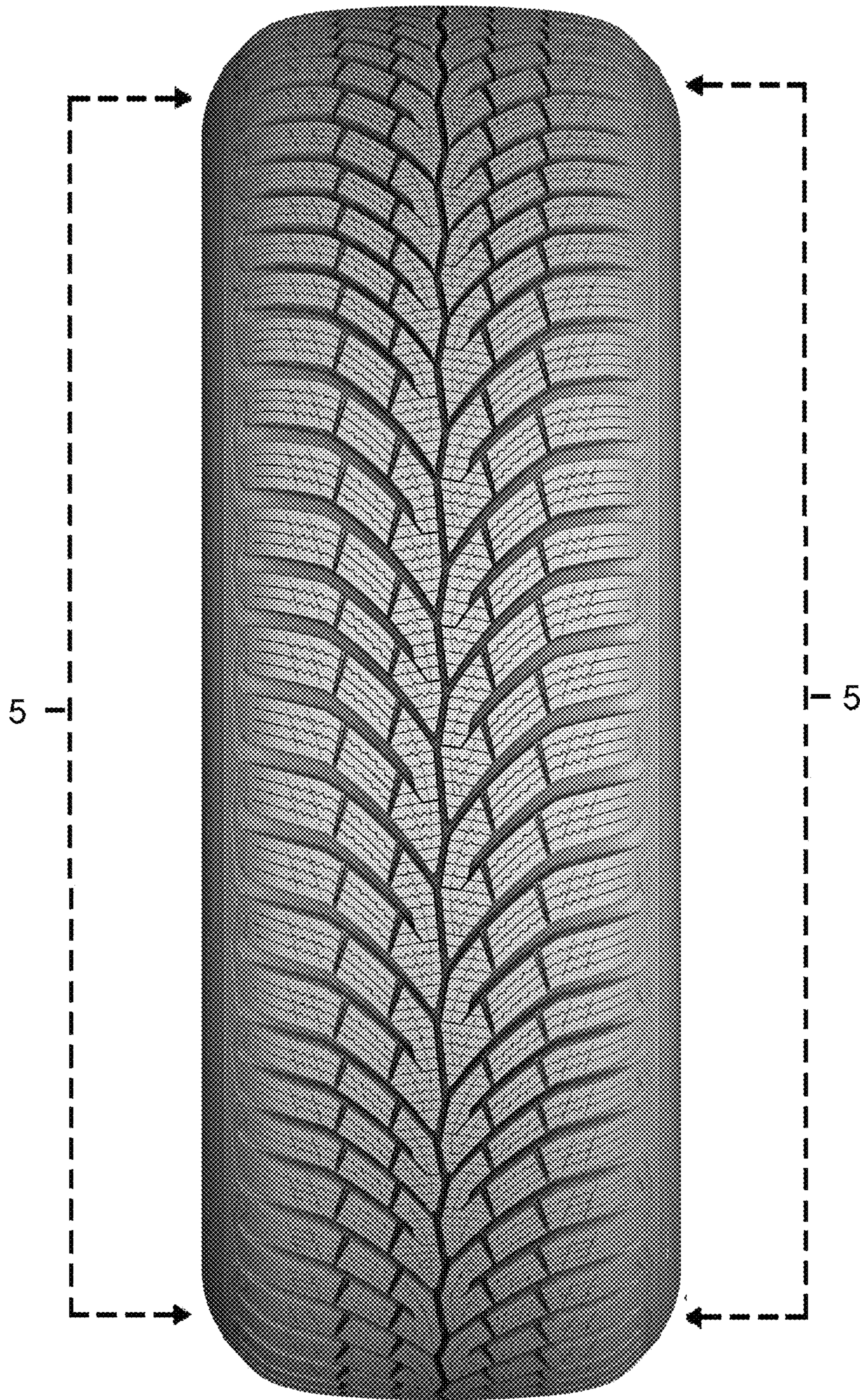

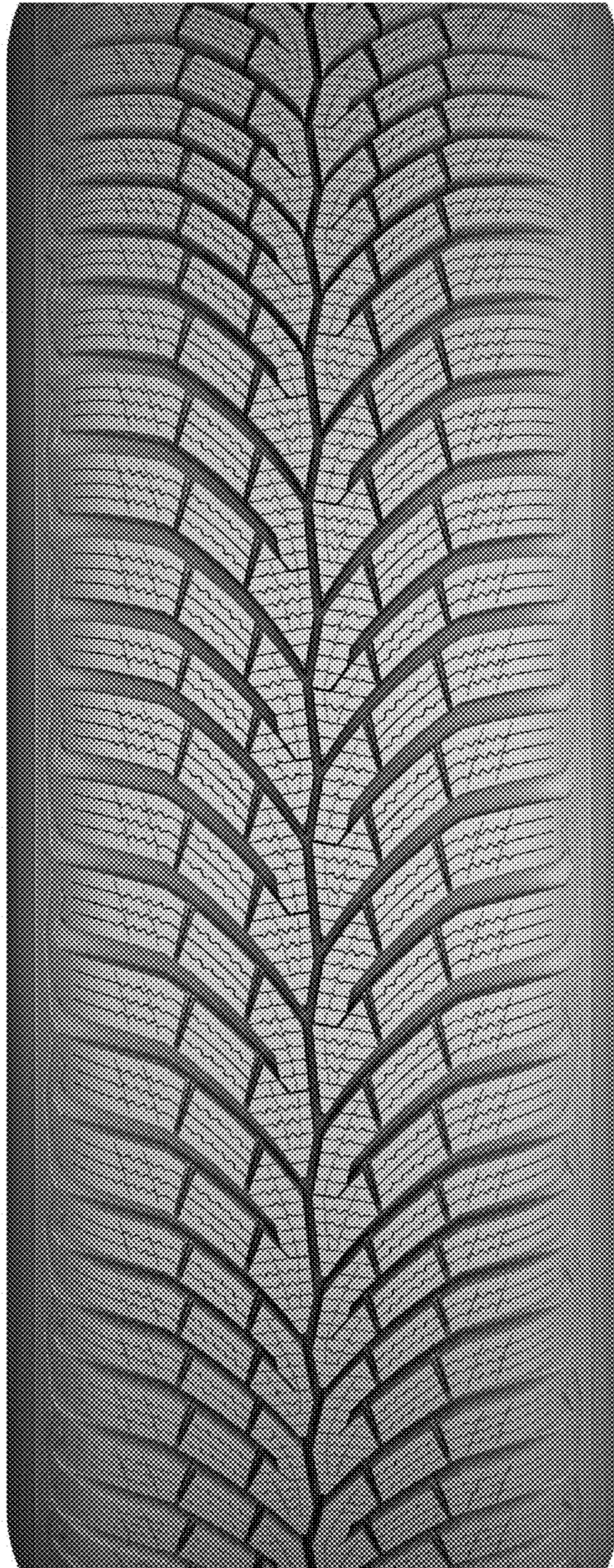
